(57) **CLAIM**

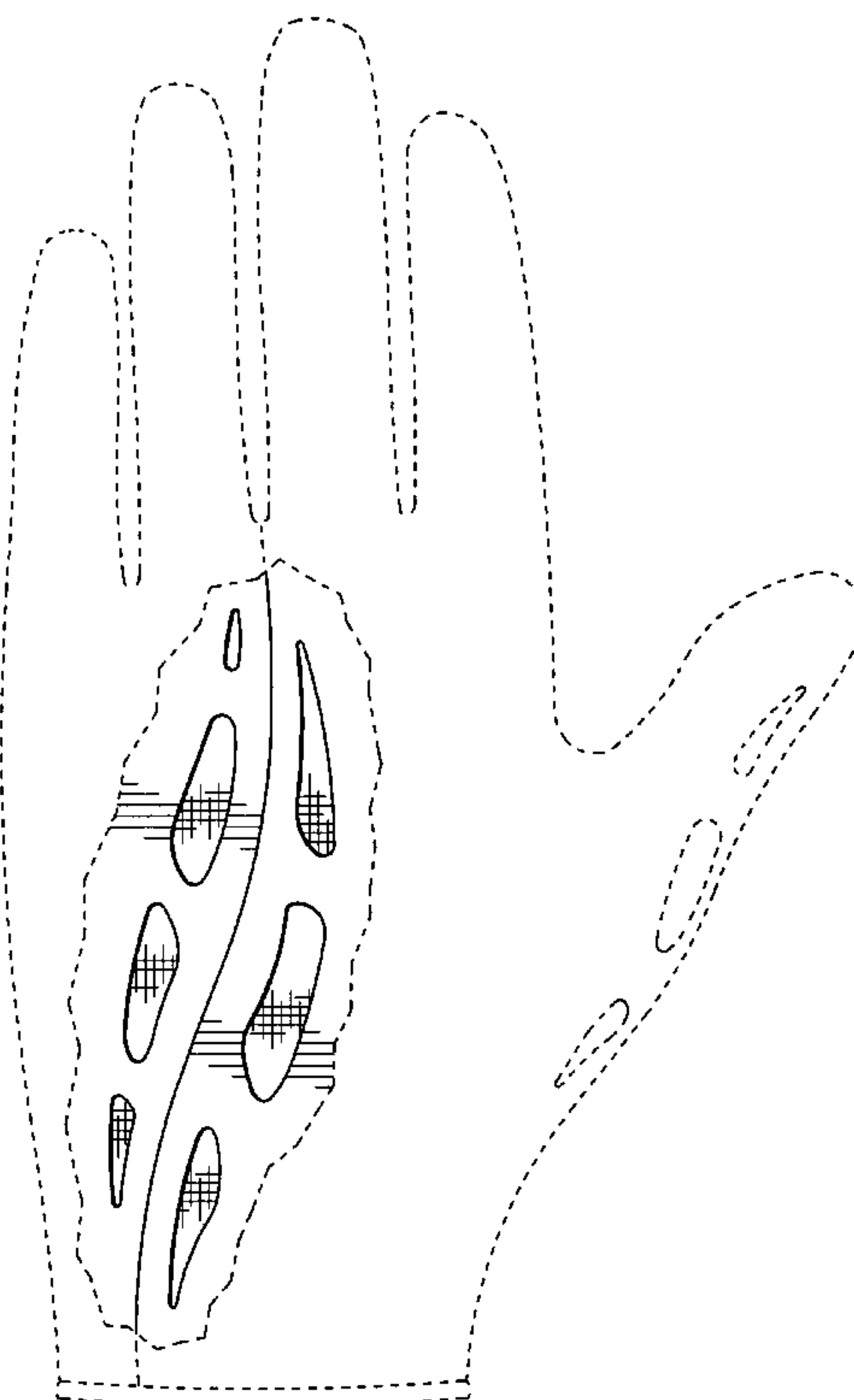
The ornamental design for a portion of a back side of a glove, as shown and described.

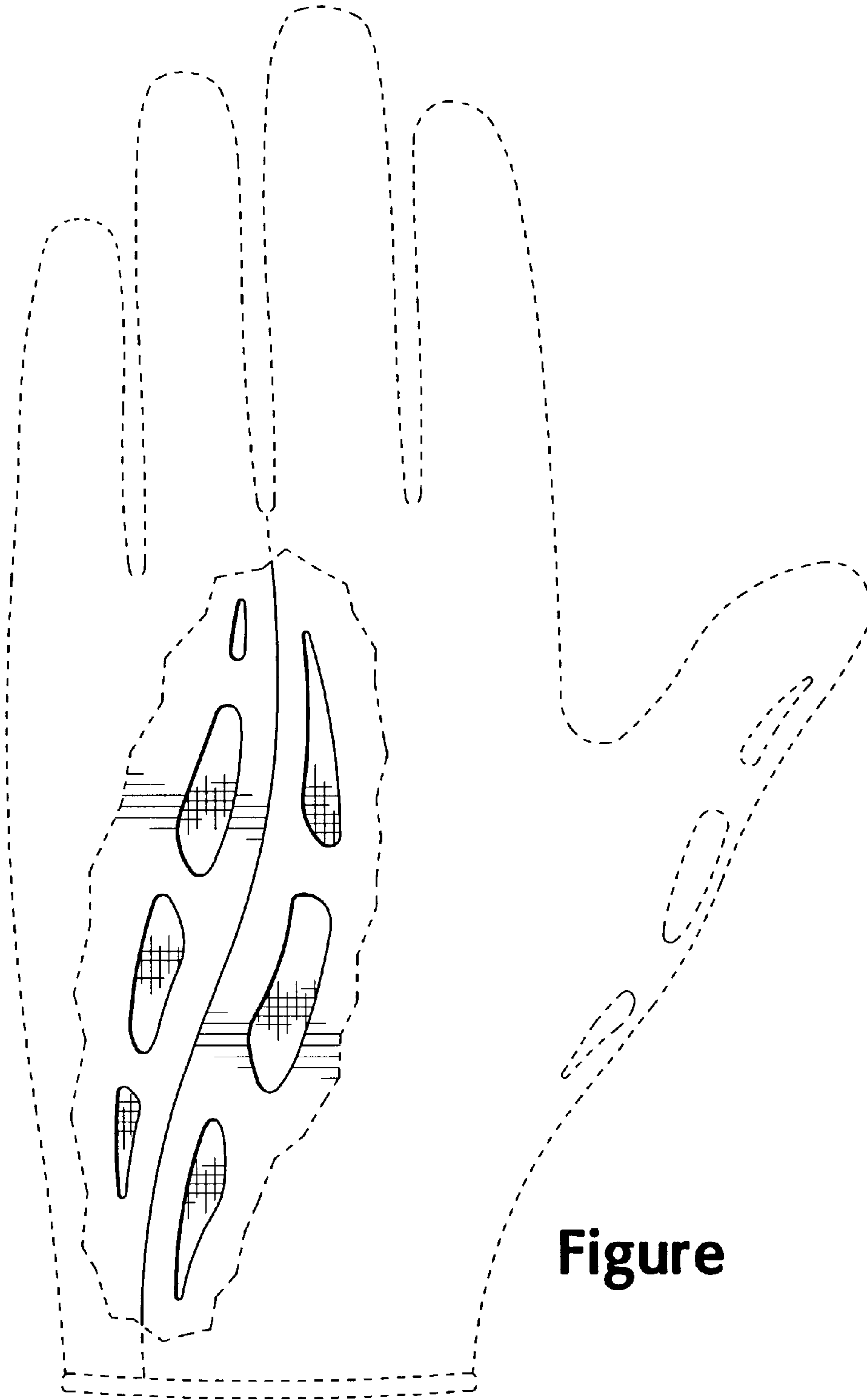
**DESCRIPTION**
