The ornamental design for an X shaped breast covering section of a woman's bathing suit, as shown and described.

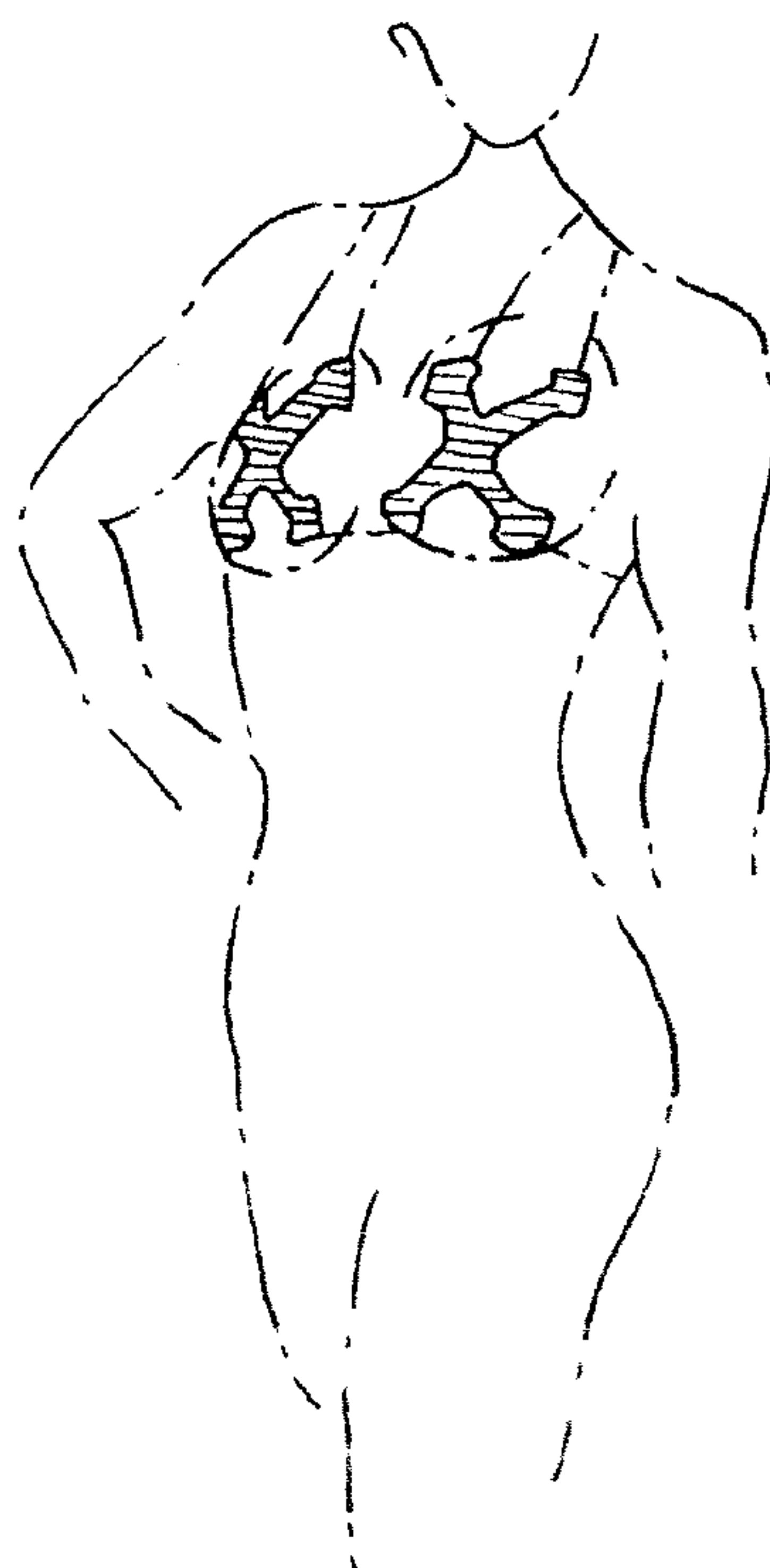
DESCRIPTION

FIG. 1 a perspective view of the X shaped breast covering section of a woman's bathing suit of the instant invention, the broken lines illustrating the female figure as well as portions of the bathing suit are for illustrative purposes only and form no part of the claimed design; and,

FIG. 2 is a perspective view of an alternative embodiment of the X shaped breast covering section of a woman's bathing suit of the instant invention, the broken lines illustrating the female figure and portions of the bathing suit are for illustrative purposes only and form no part of the claimed design.

The ornamental design for a woman's bathing suit described herein has each breast covering section of the bathing suit shaped to resemble the letter X, whereby said ornamental breast covering sections are integral to a woman's bathing suit.

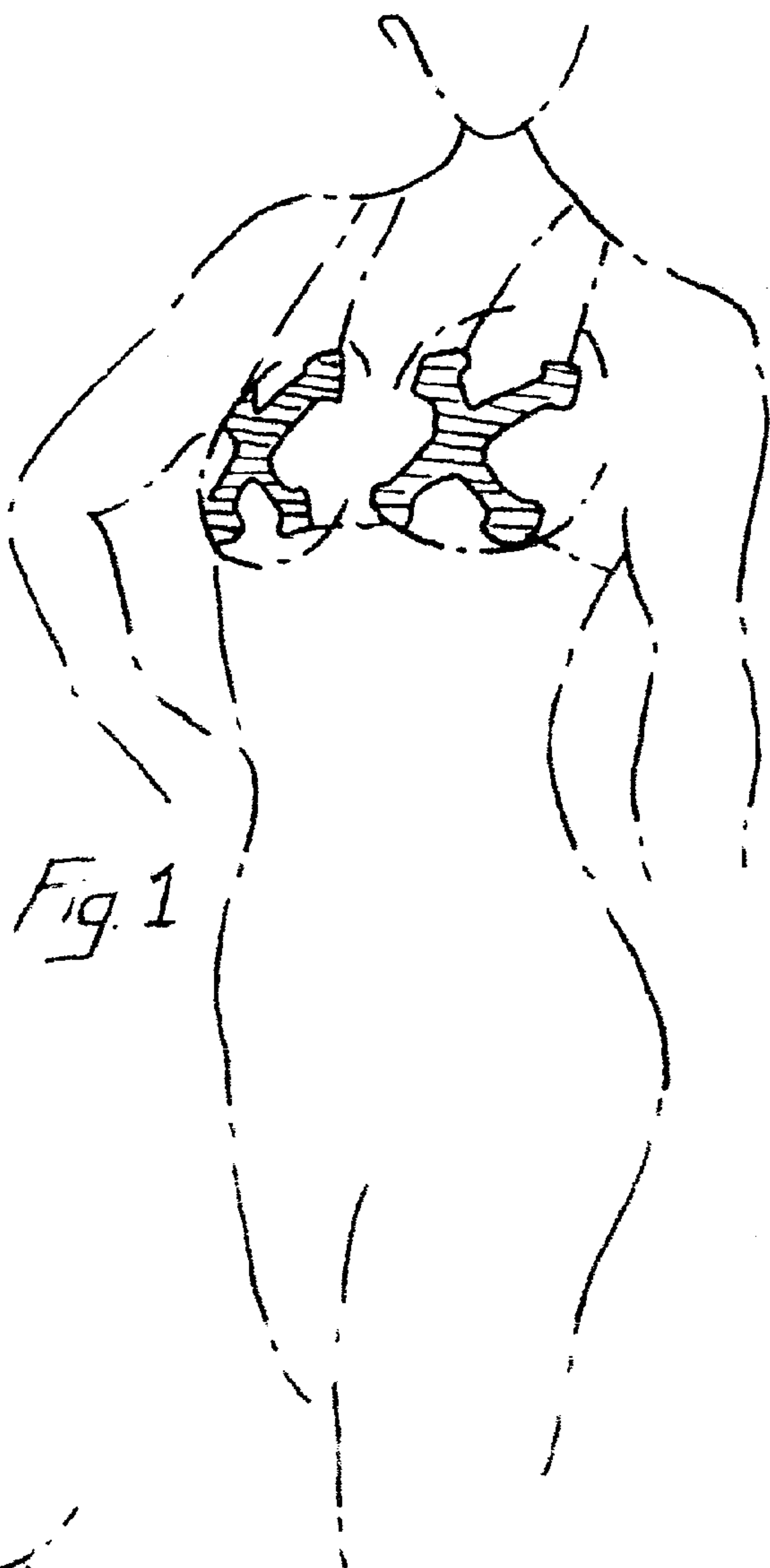

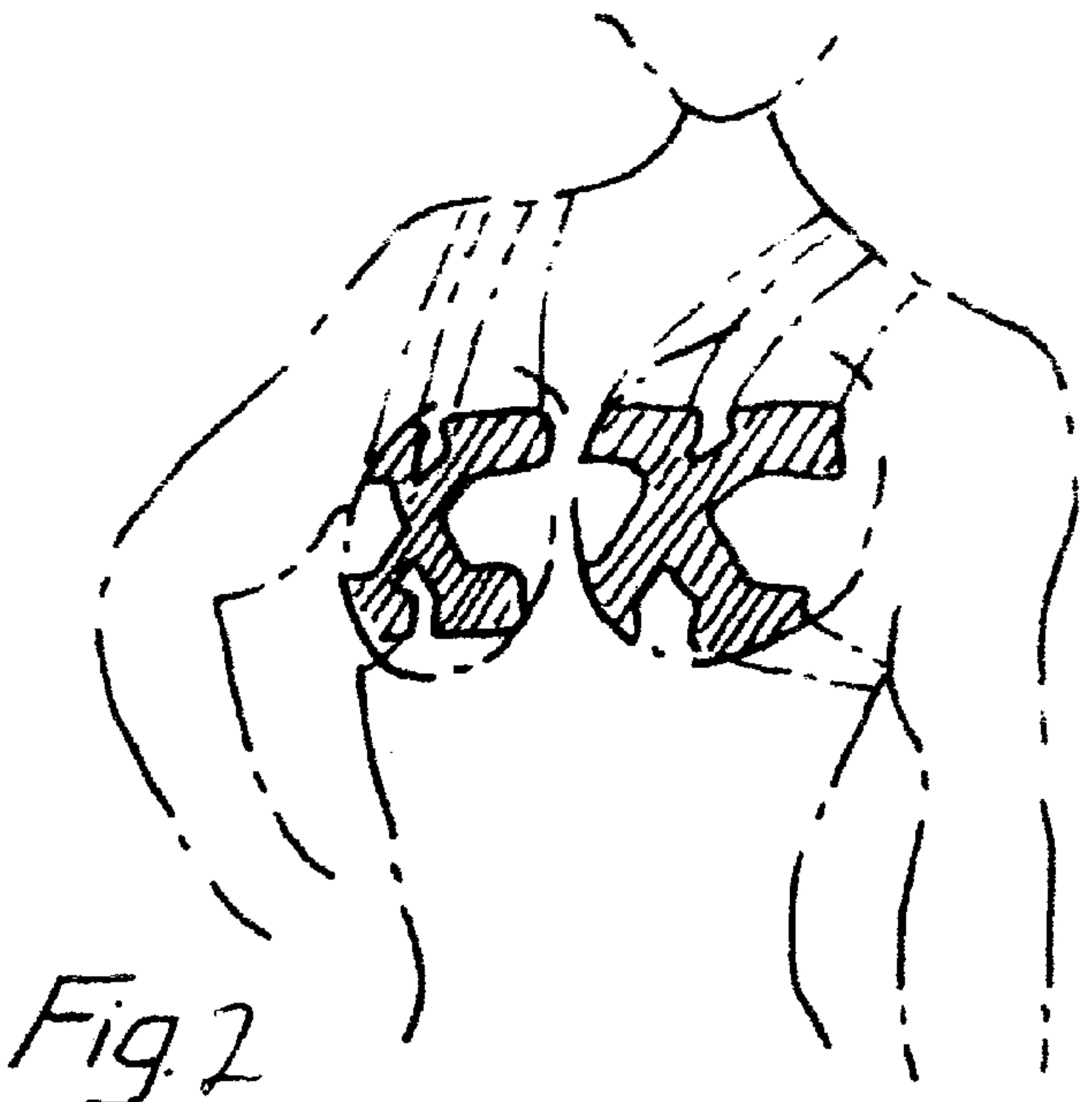
