The ornamental design for sport pants, as shown and described.

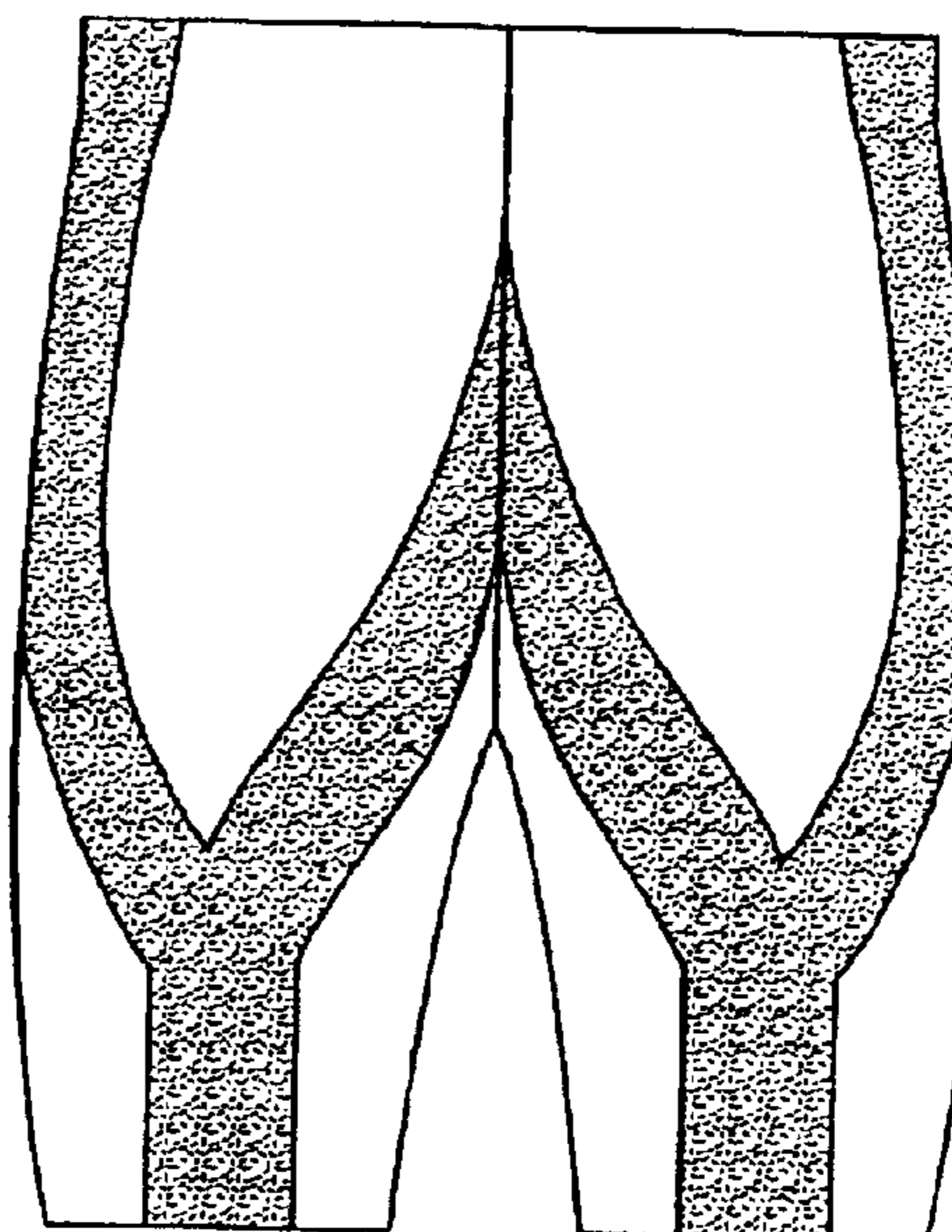
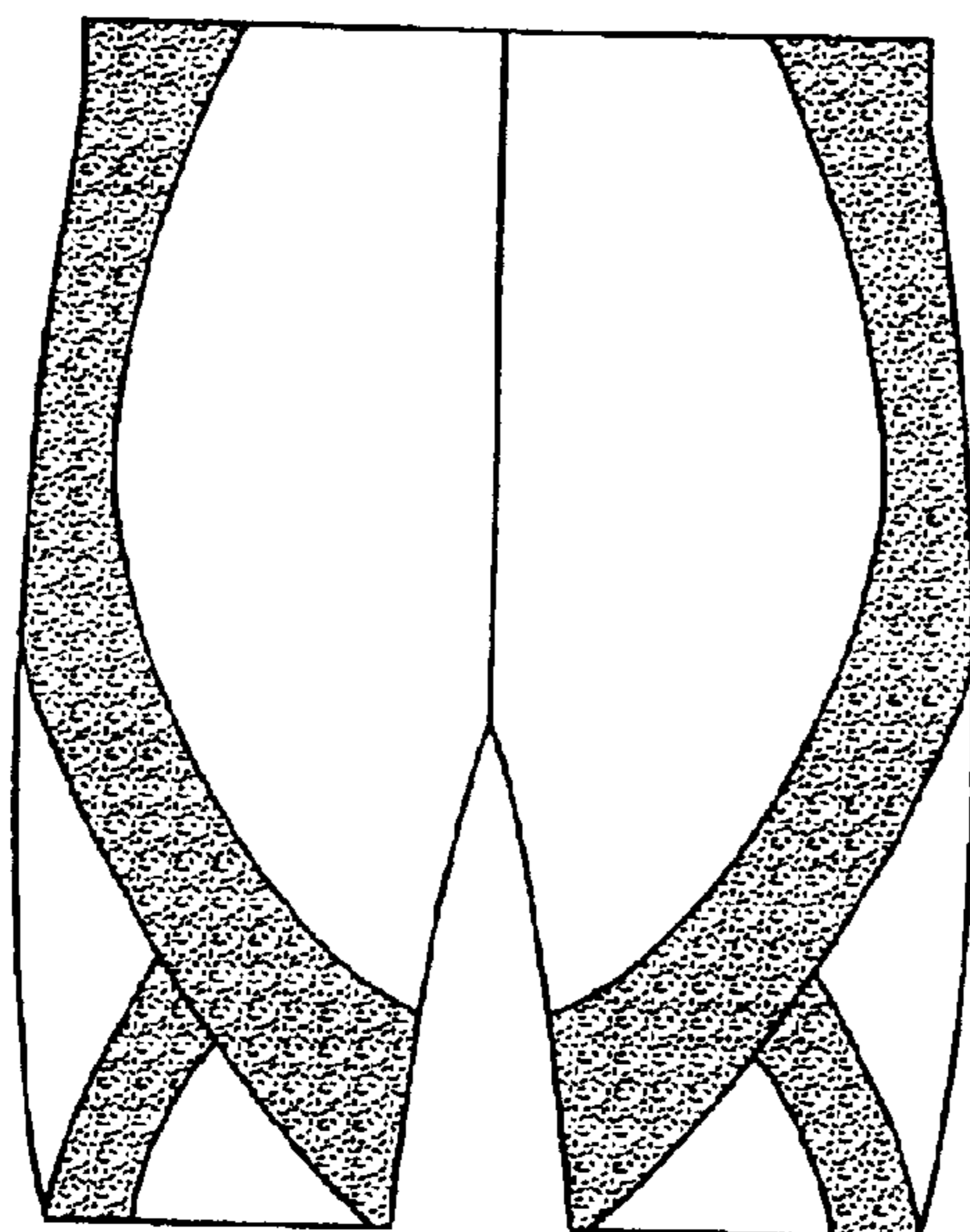
**DESCRIPTION**

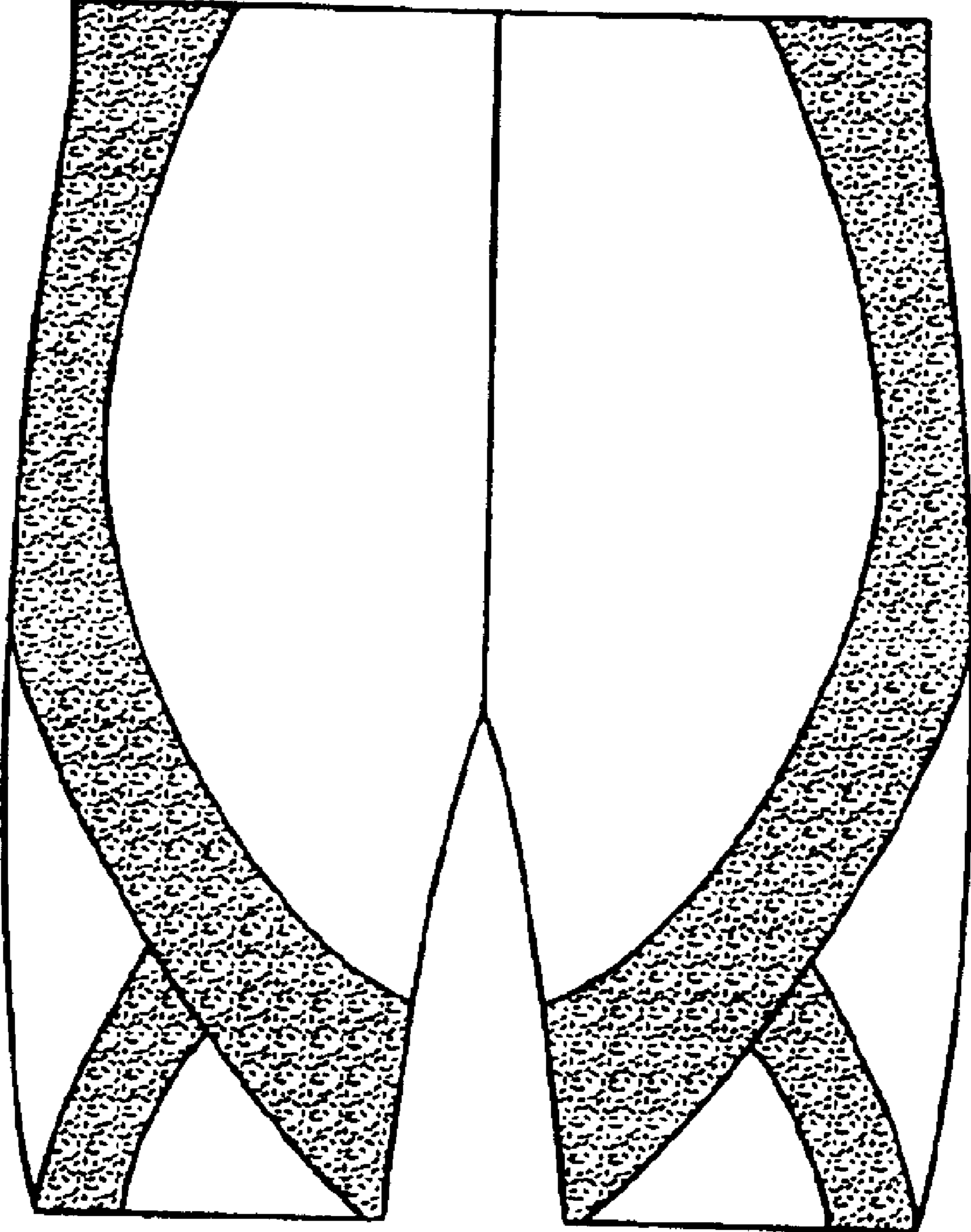
FIG. 1 is a front view of our new design for sport pants;

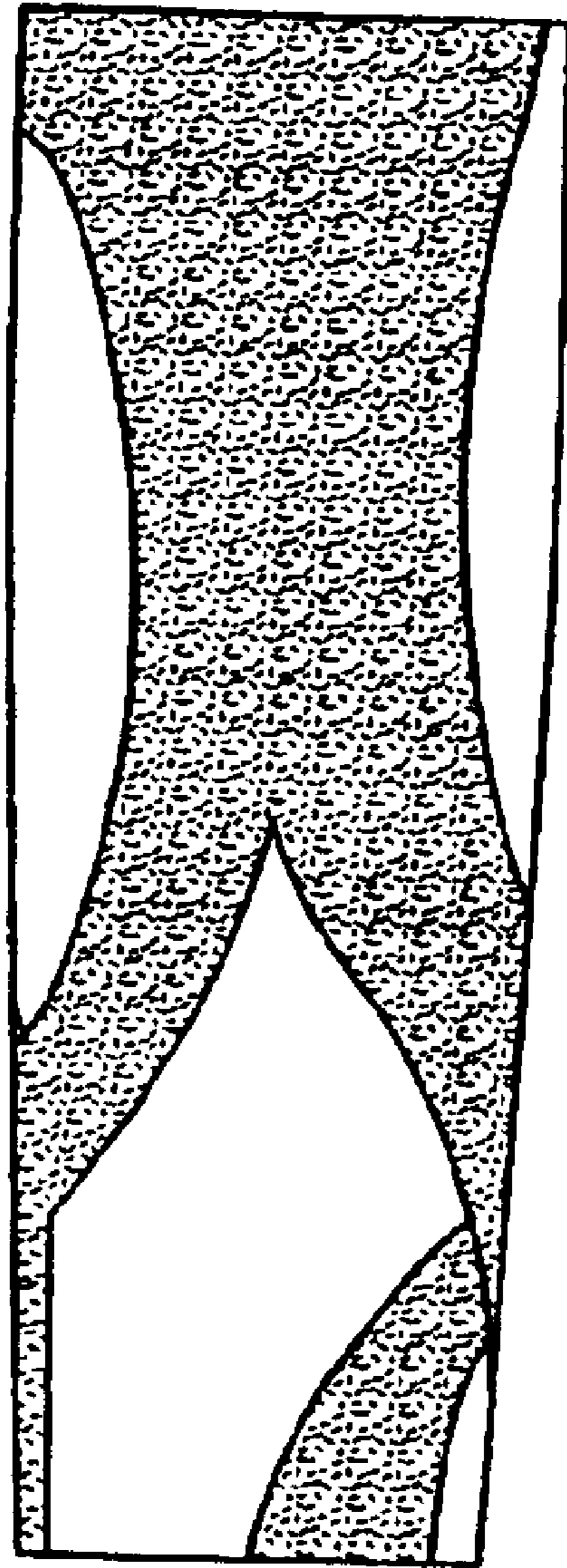

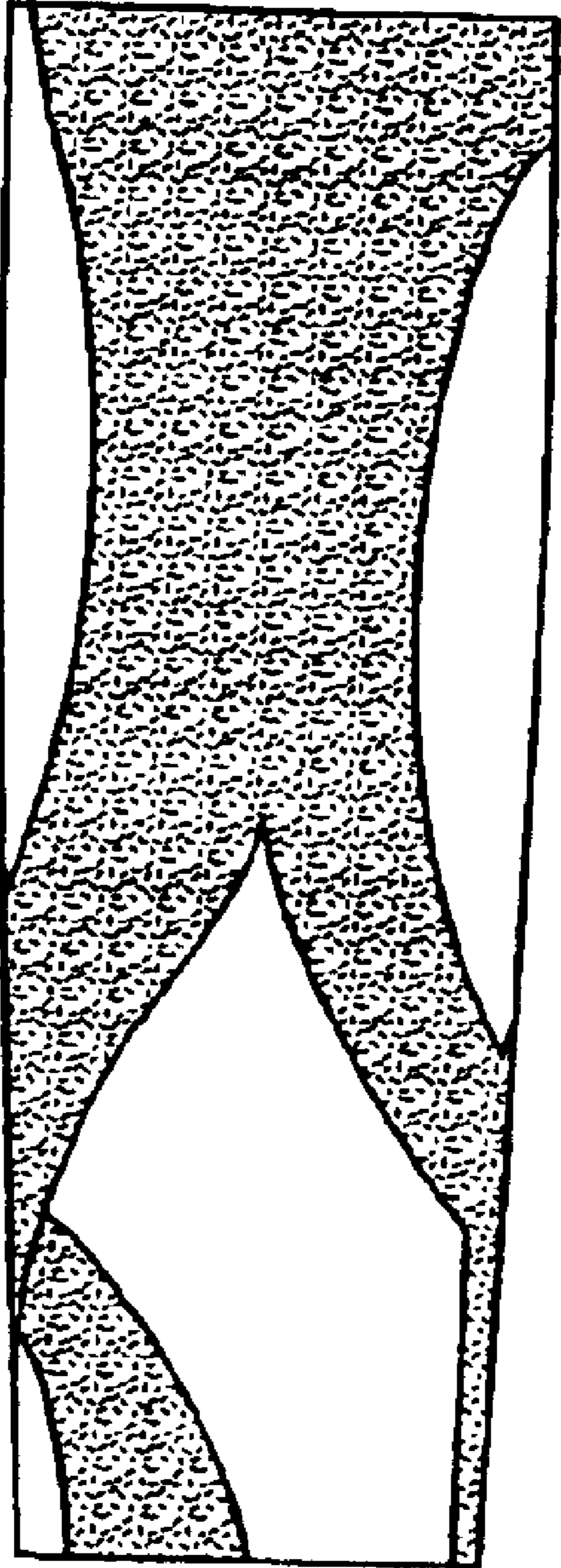




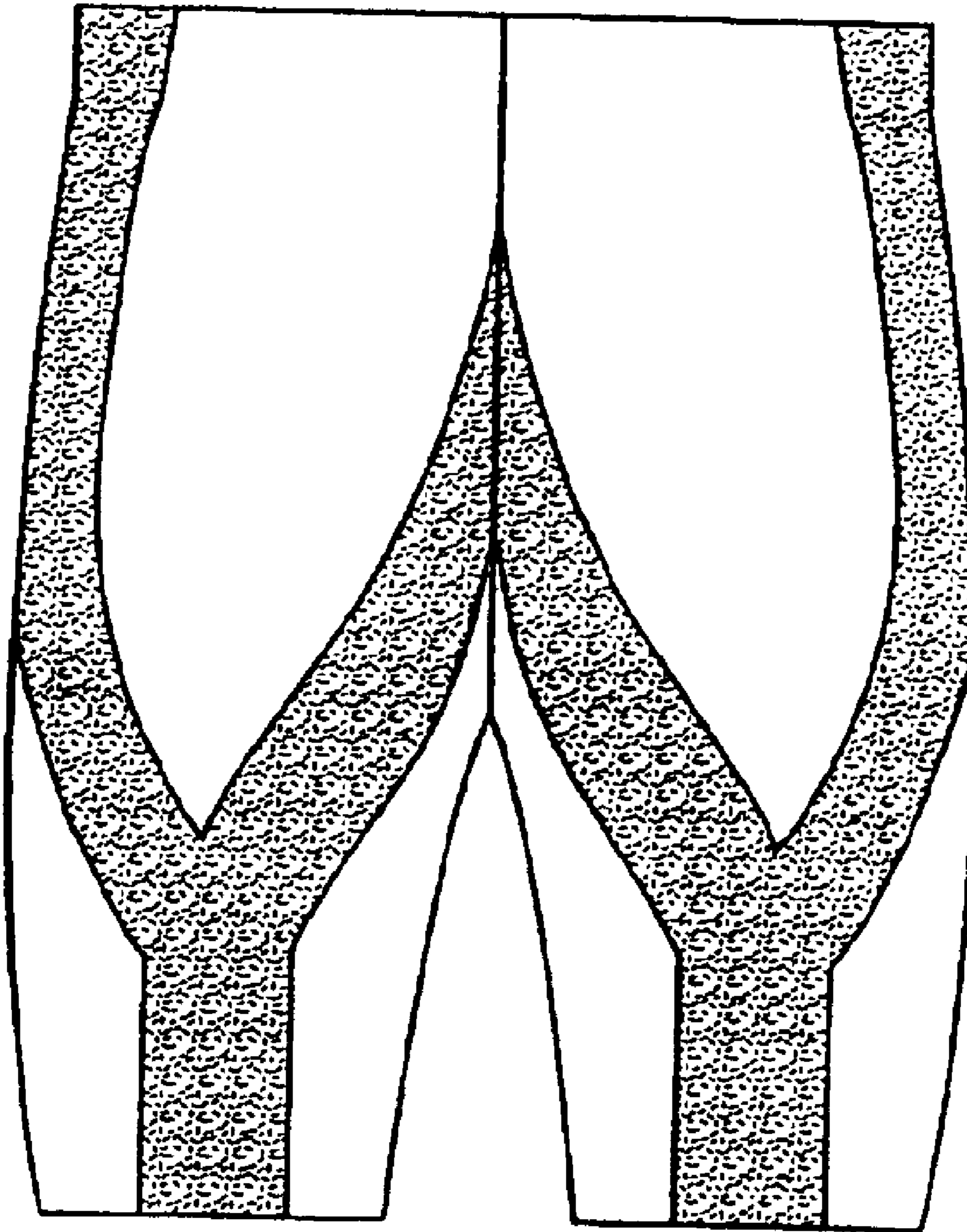

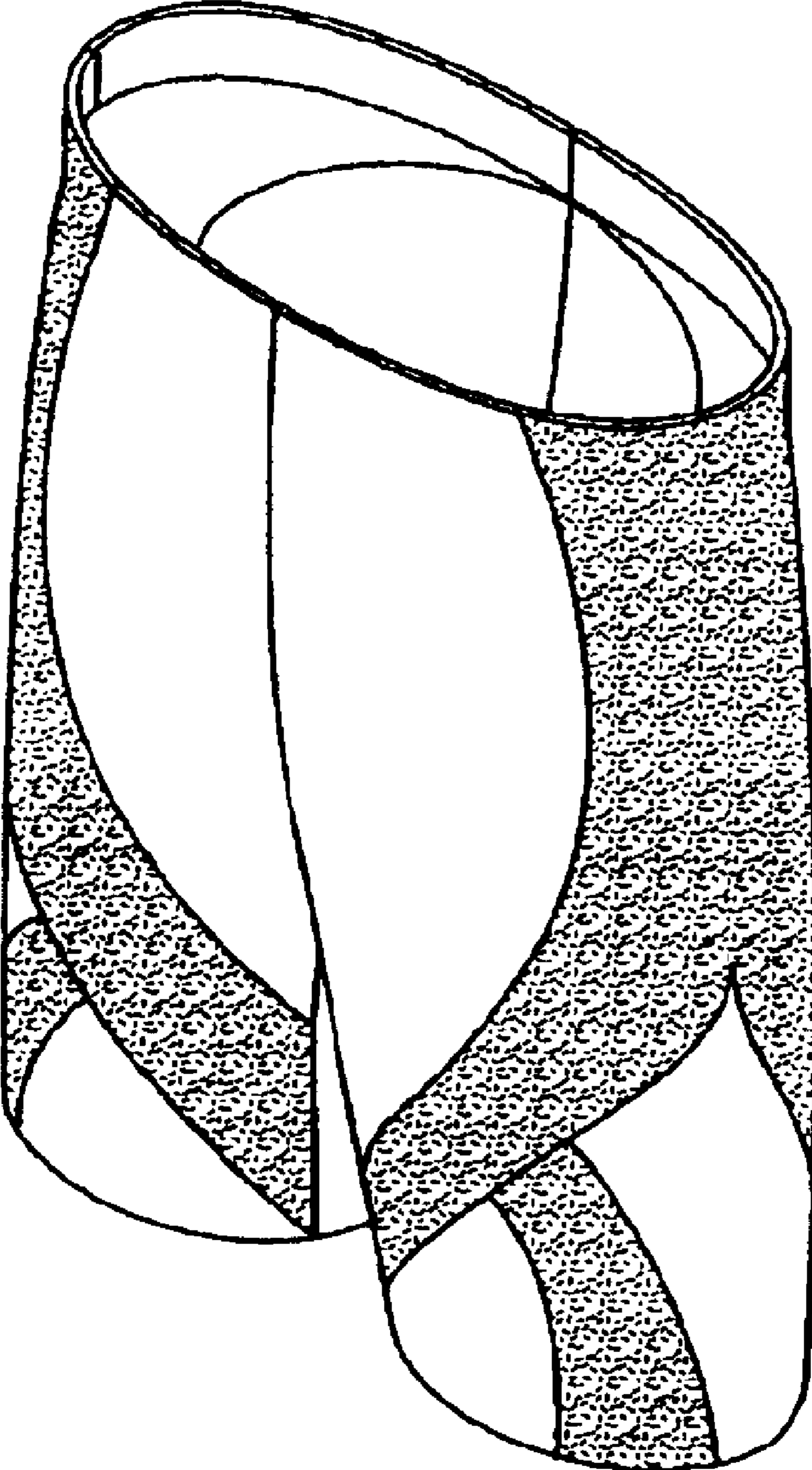

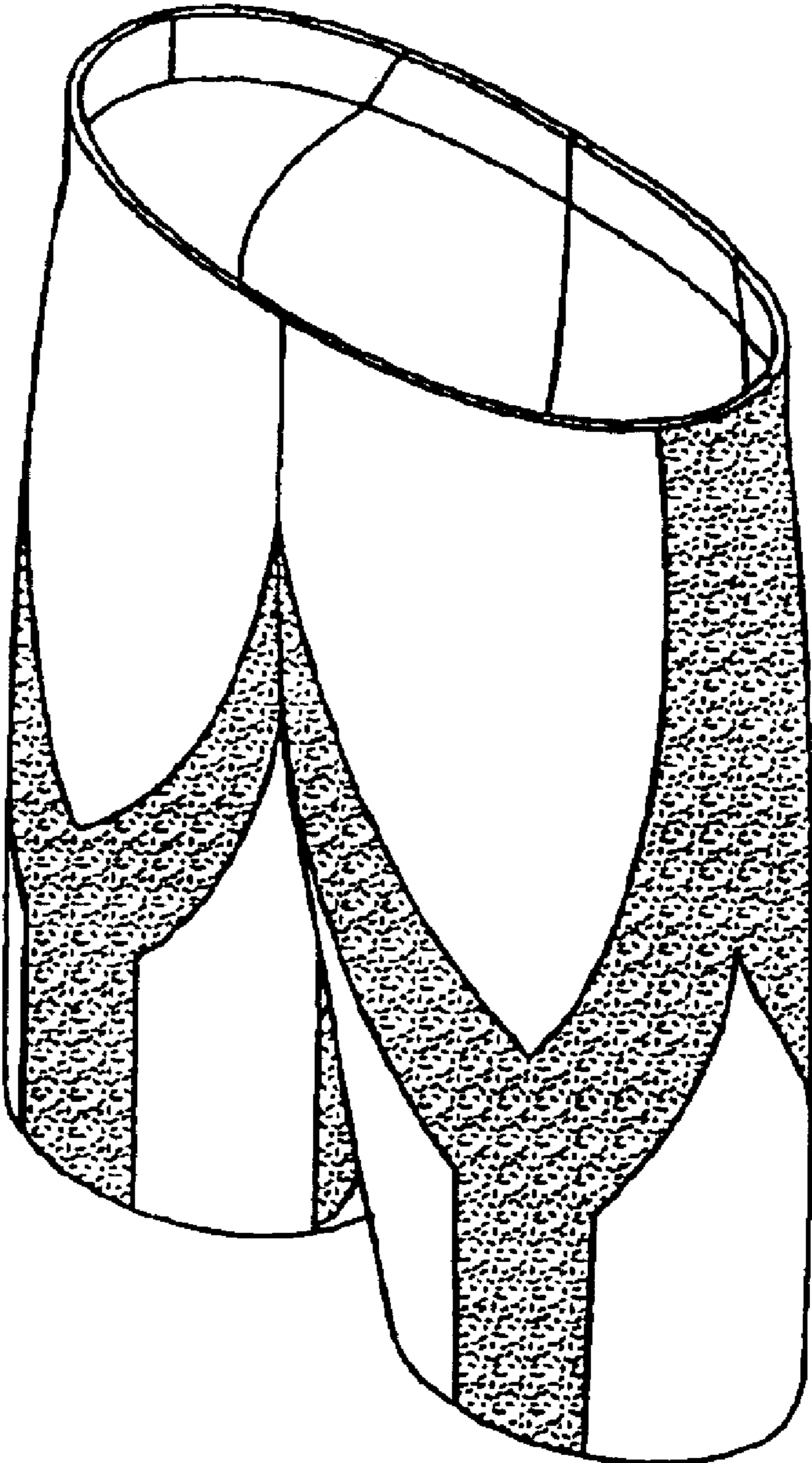

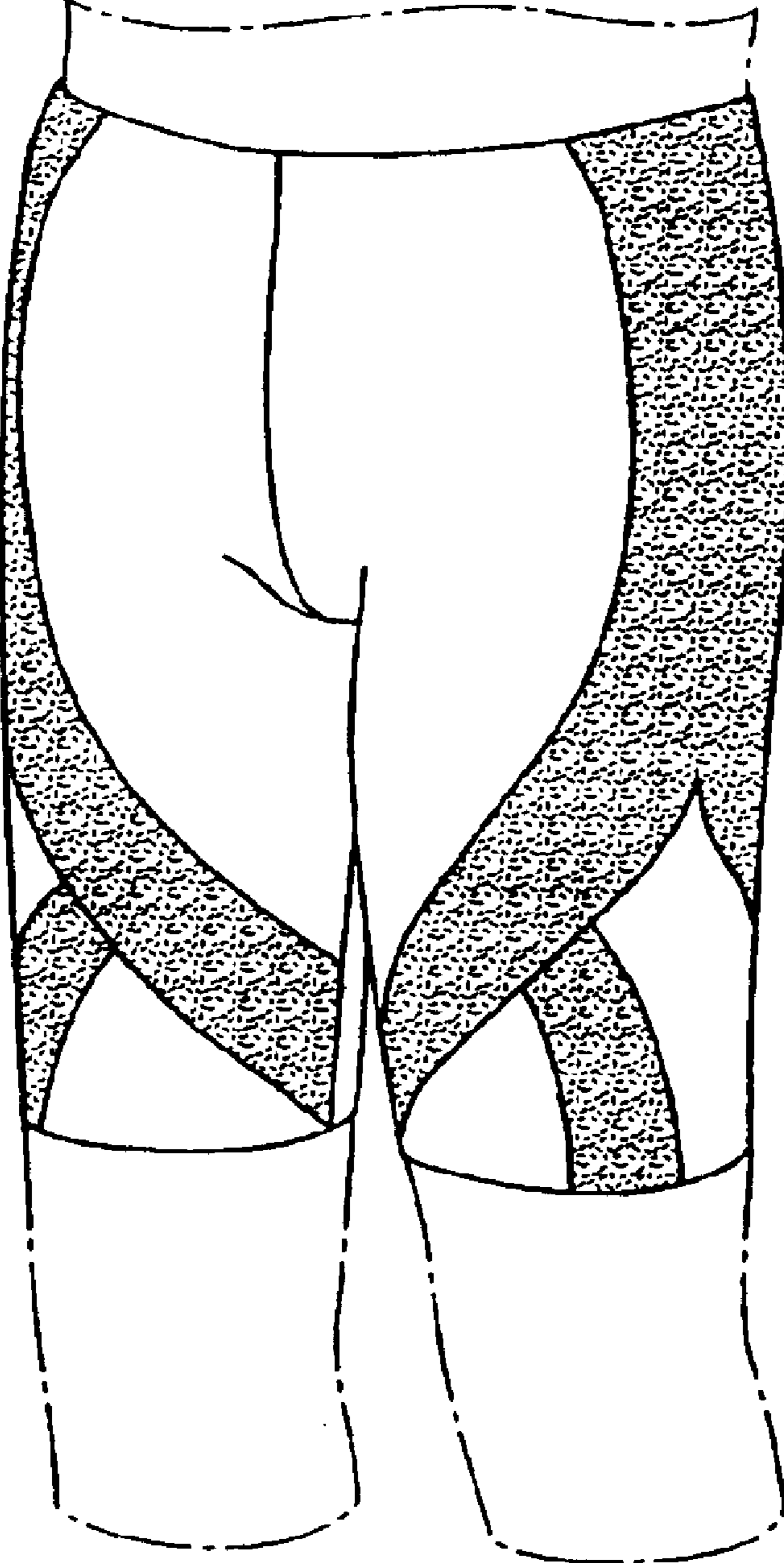
