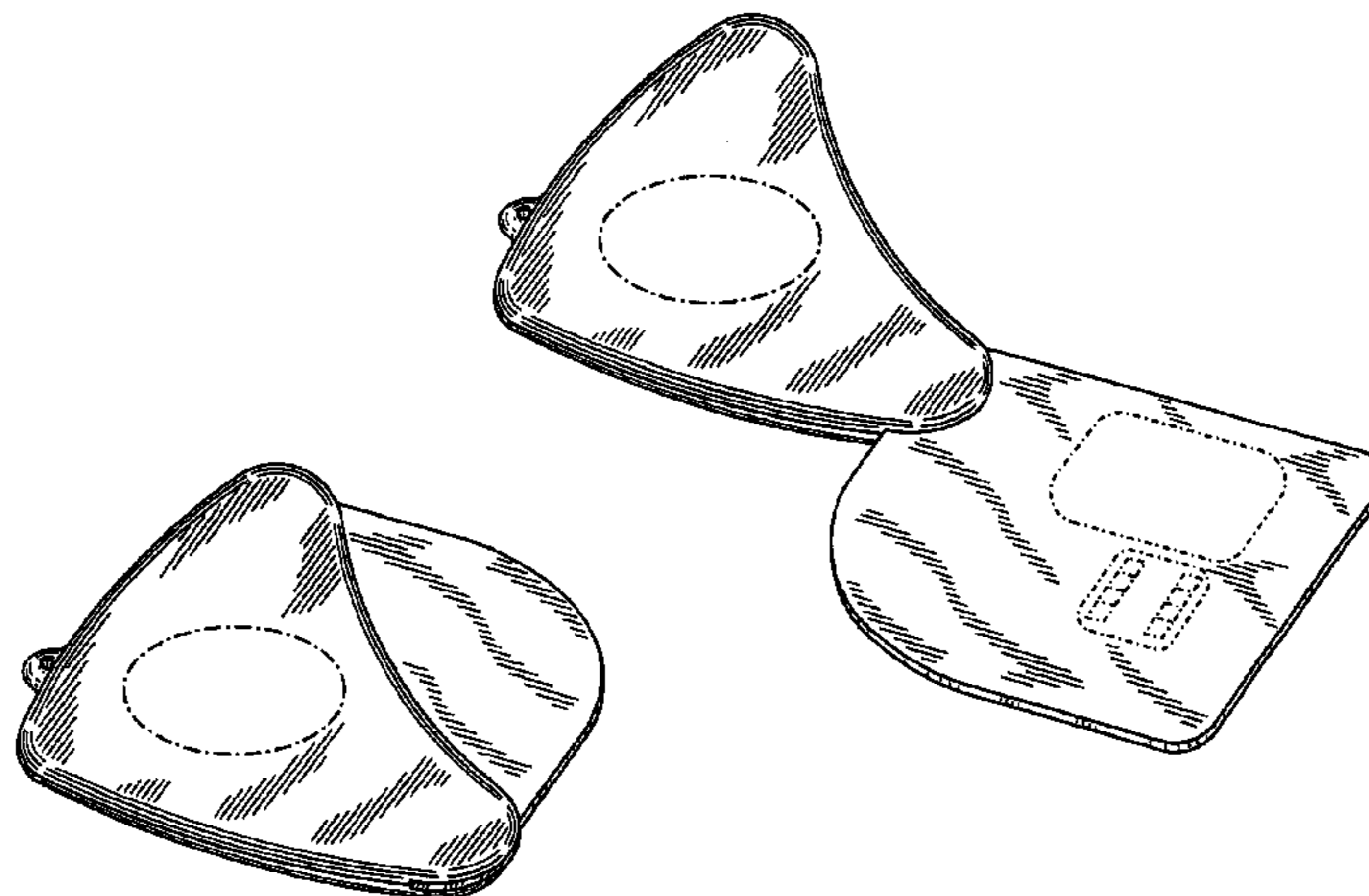
(57) **CLAIM**

The ornamental design of a combined card holder and card, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined card holder and card showing our new design; FIG. 2 is a perspective view in the open position thereof; FIG. 3 is a front elevational view in closed position thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is bottom plan view thereof; FIG. 7 is a left side elevational view thereof; and, FIG. 8 is a right side elevational view thereof. The broken line showing in FIGS. 1, 2, 3, 5, and 6, is for illustrative purposes only and forms no part of the claimed design.

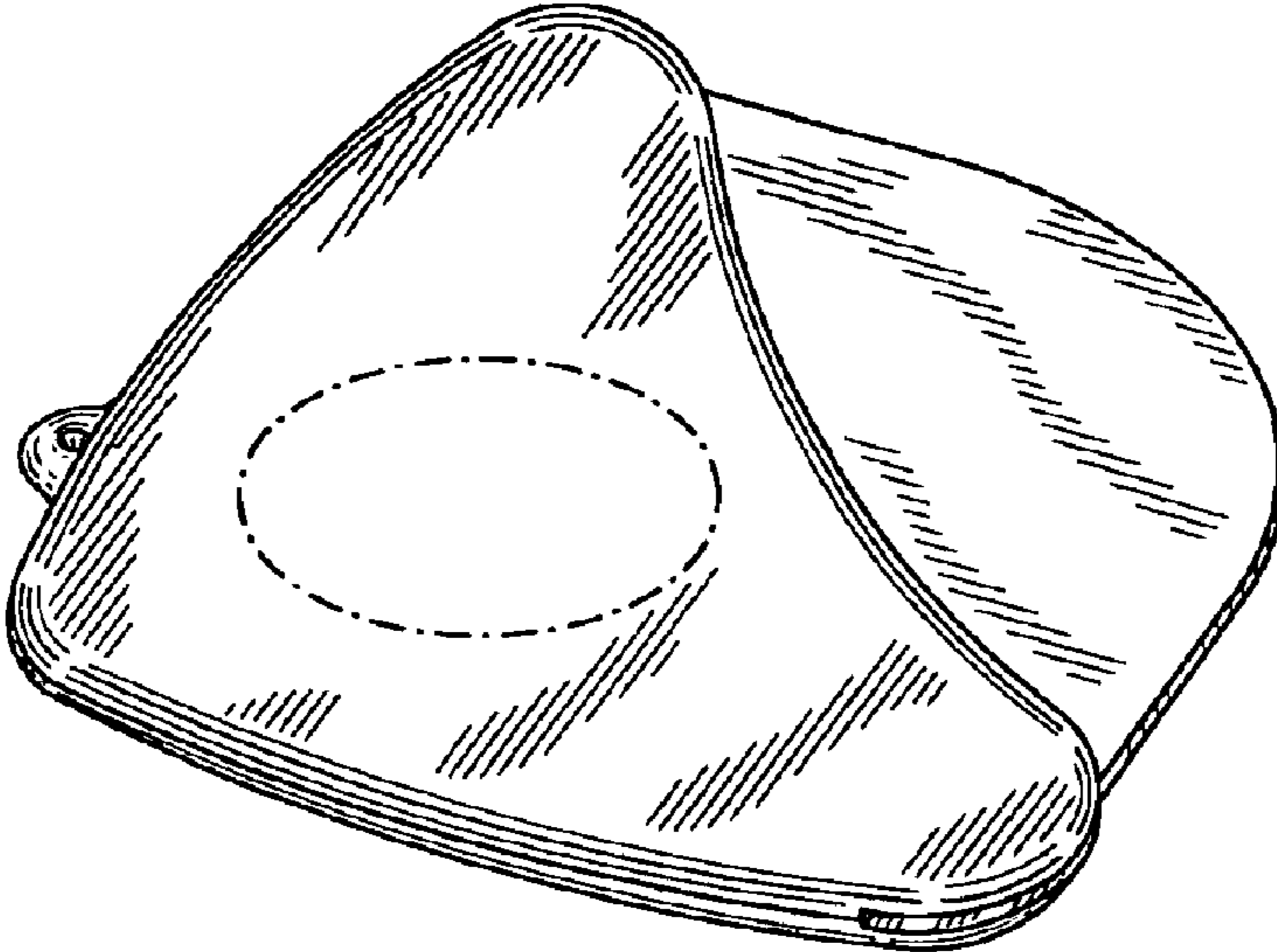

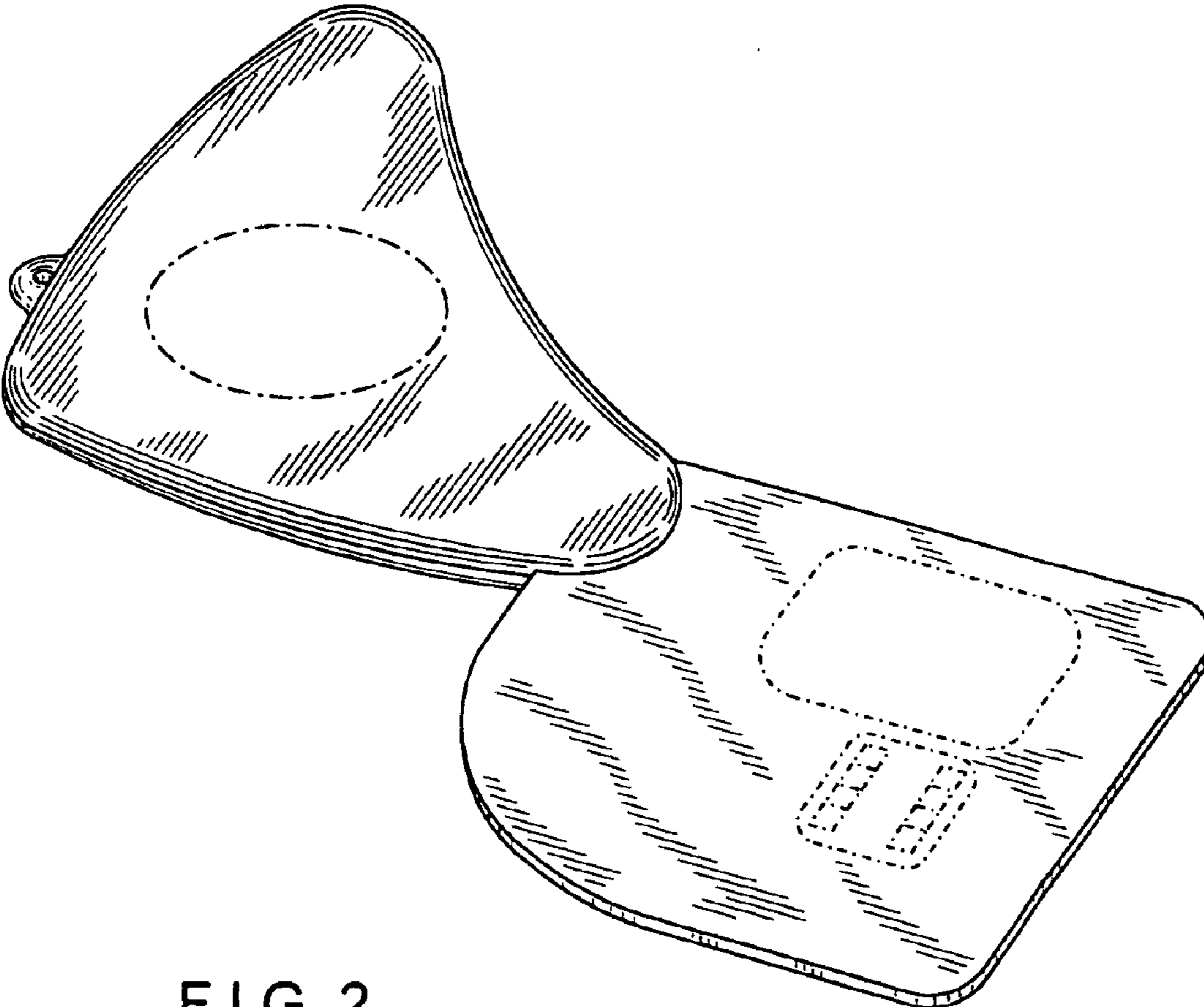

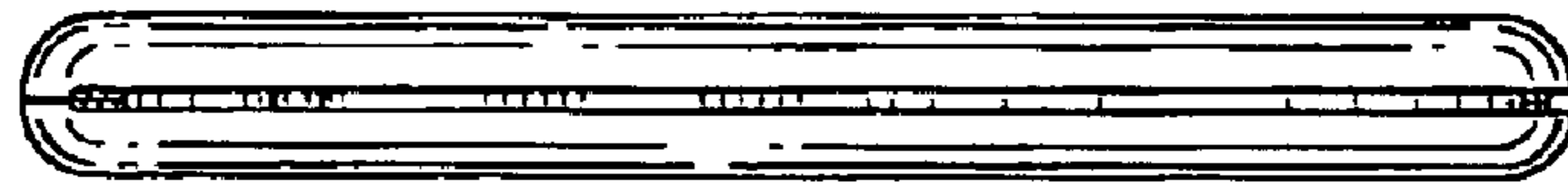

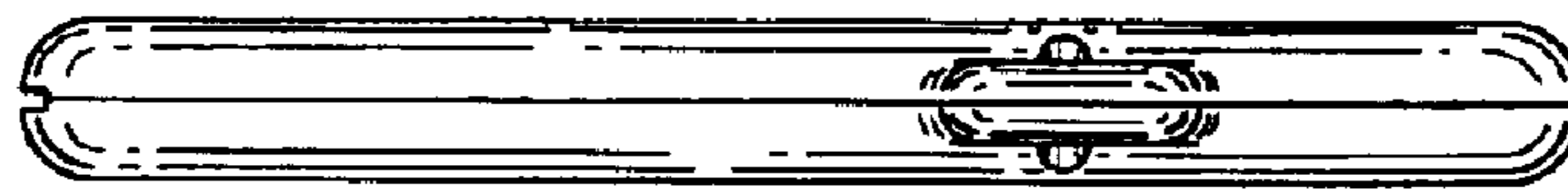

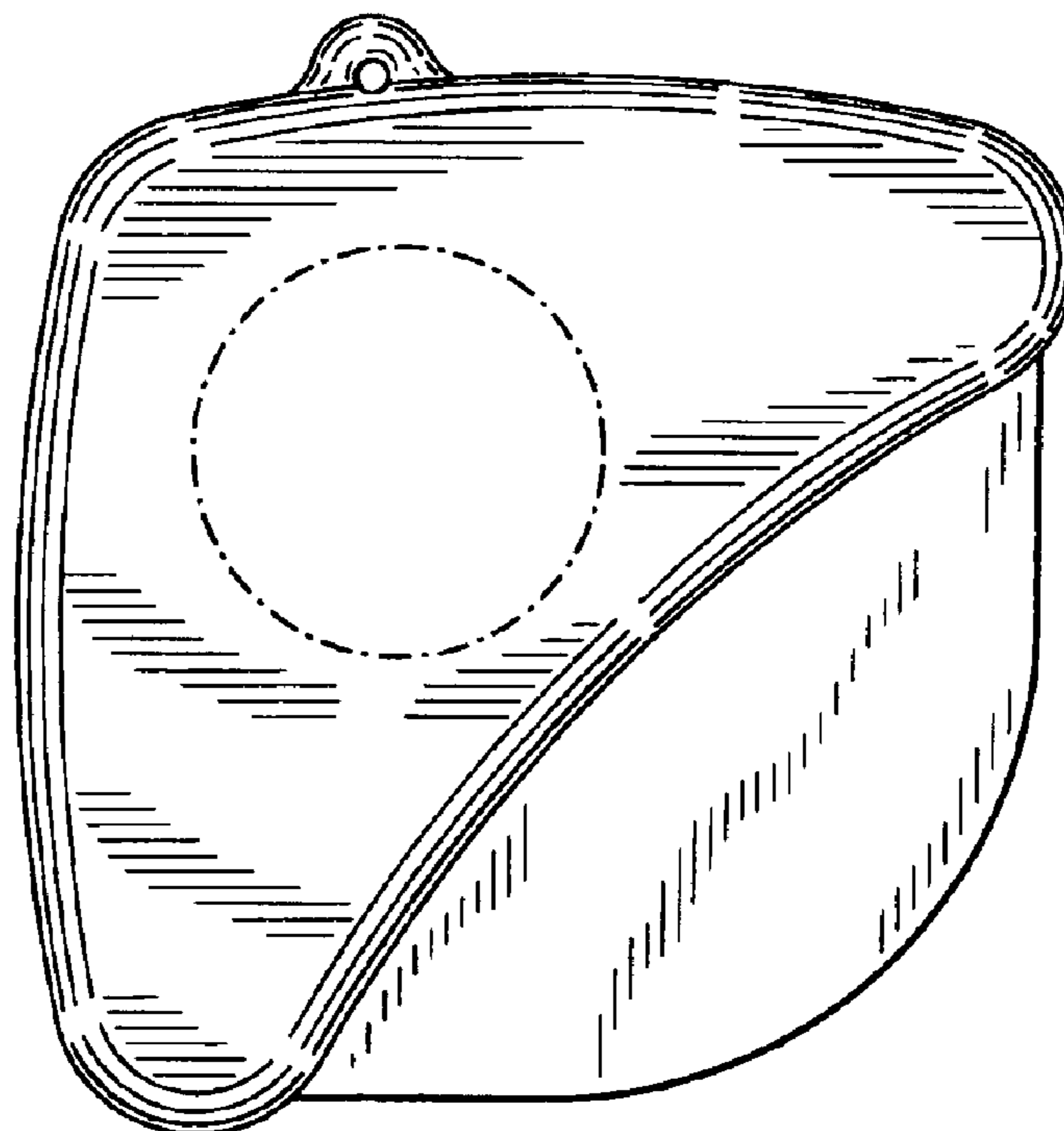

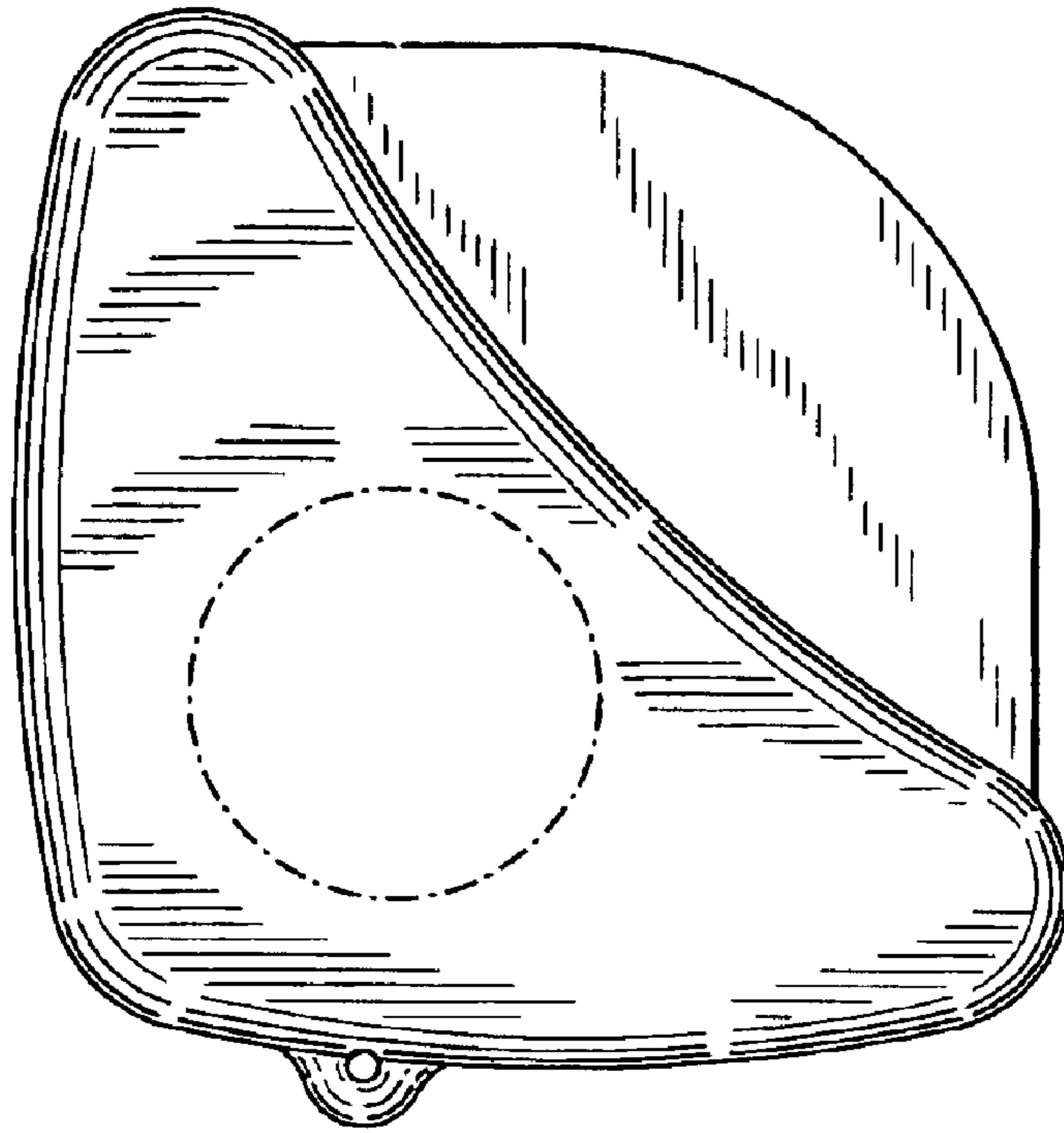

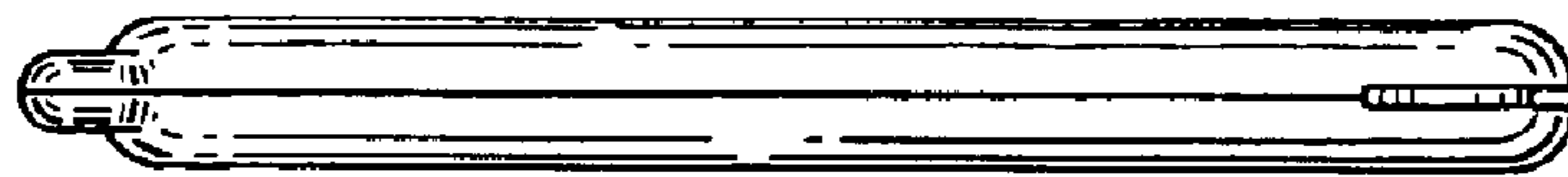

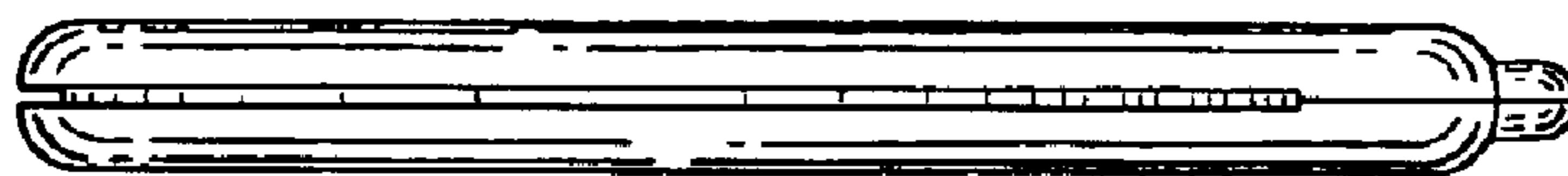
