FIG. 3 is a slightly reduced front elevational view of the lip sofa of FIG. 1.

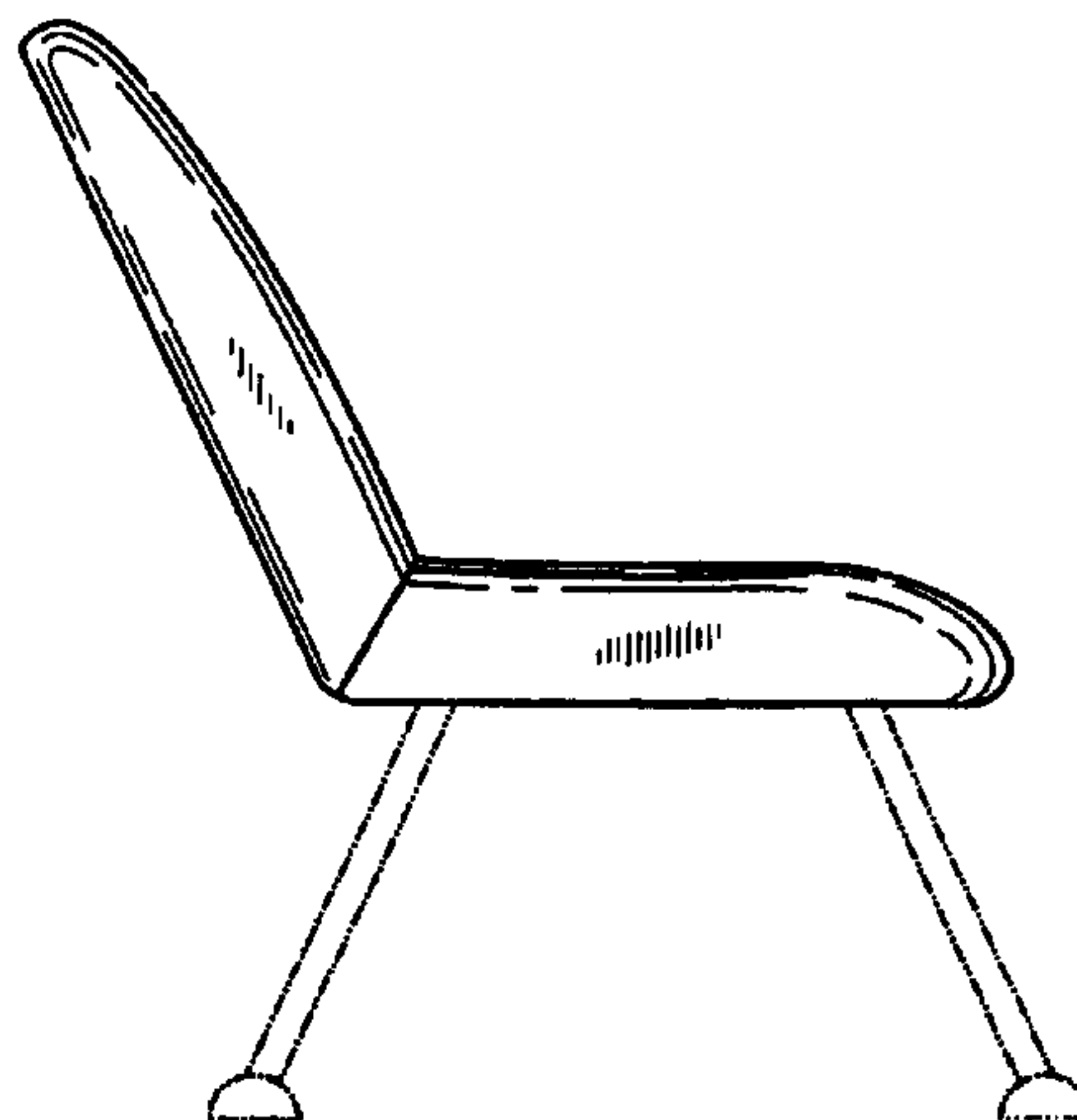
FIG. 4 is a slightly reduced rear elevational view of the lip sofa of FIG. 1.

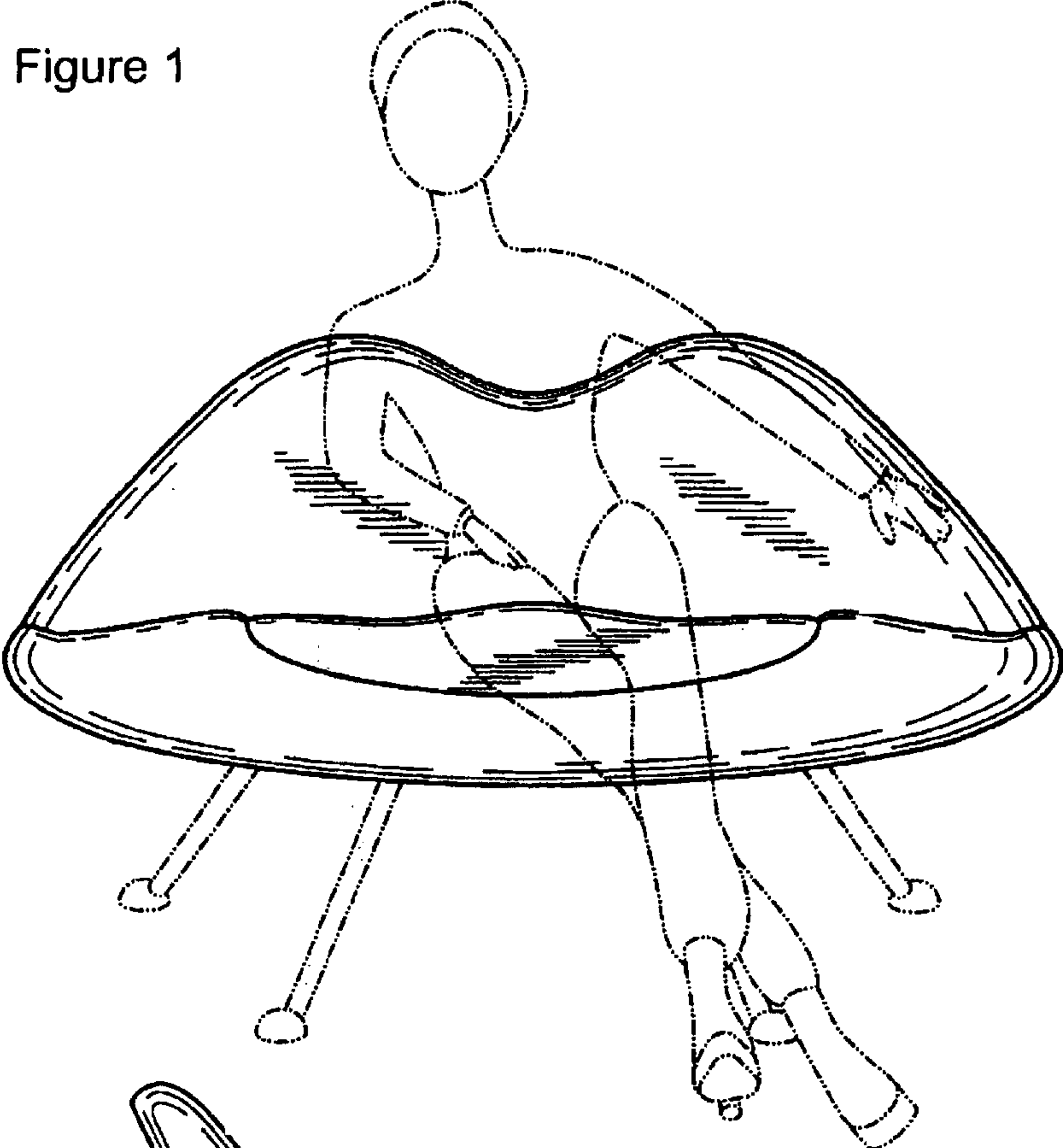
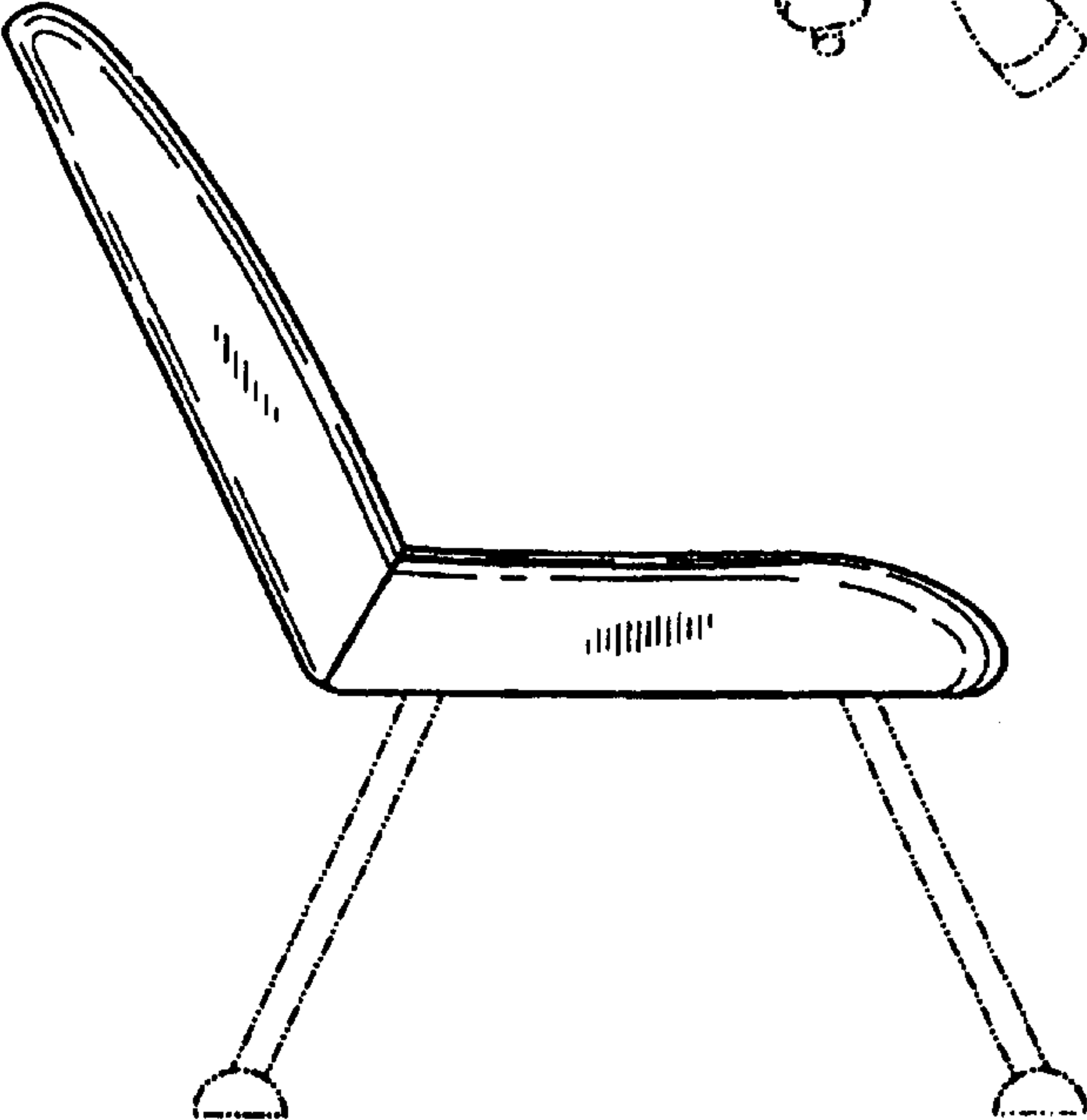

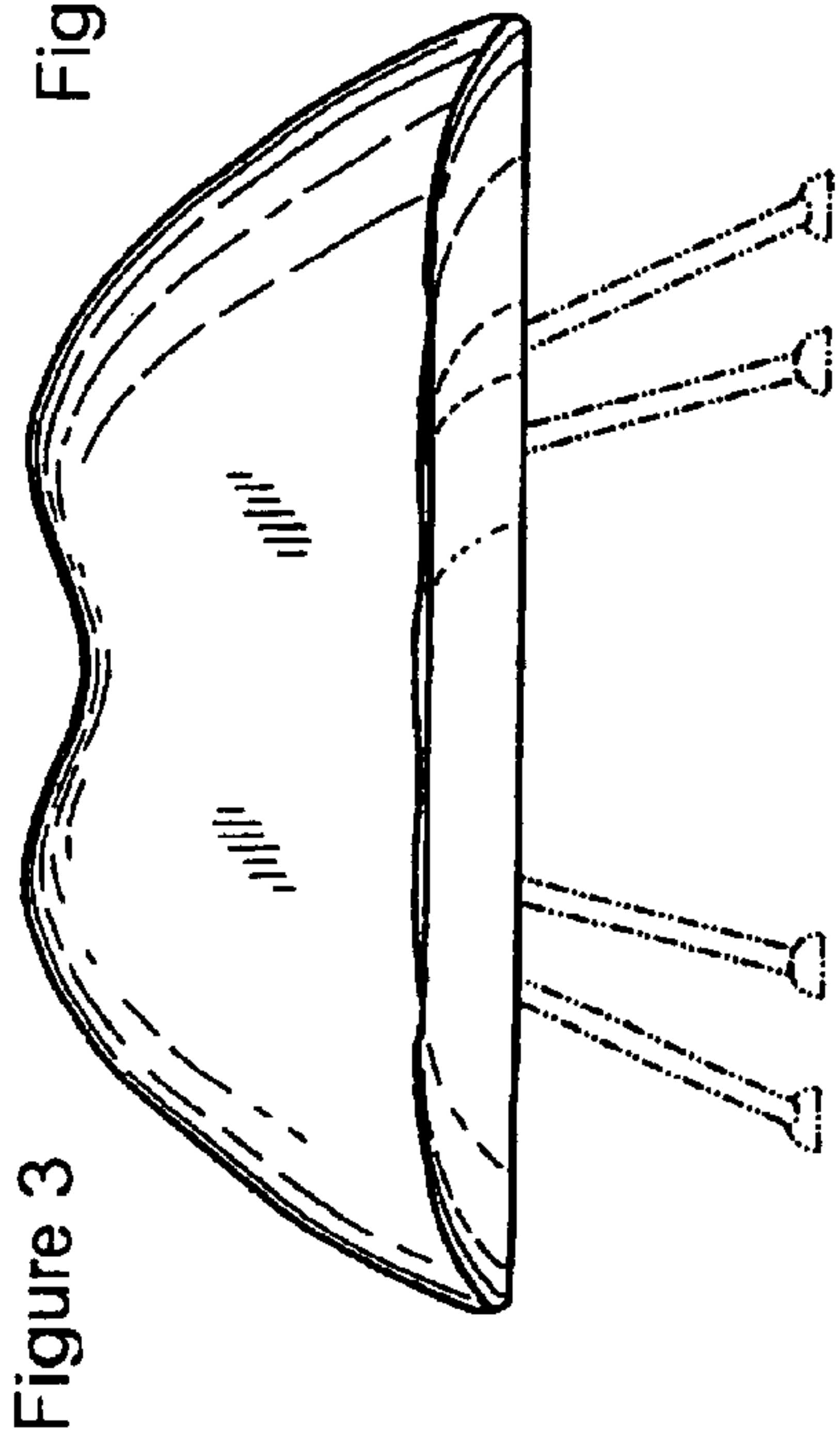

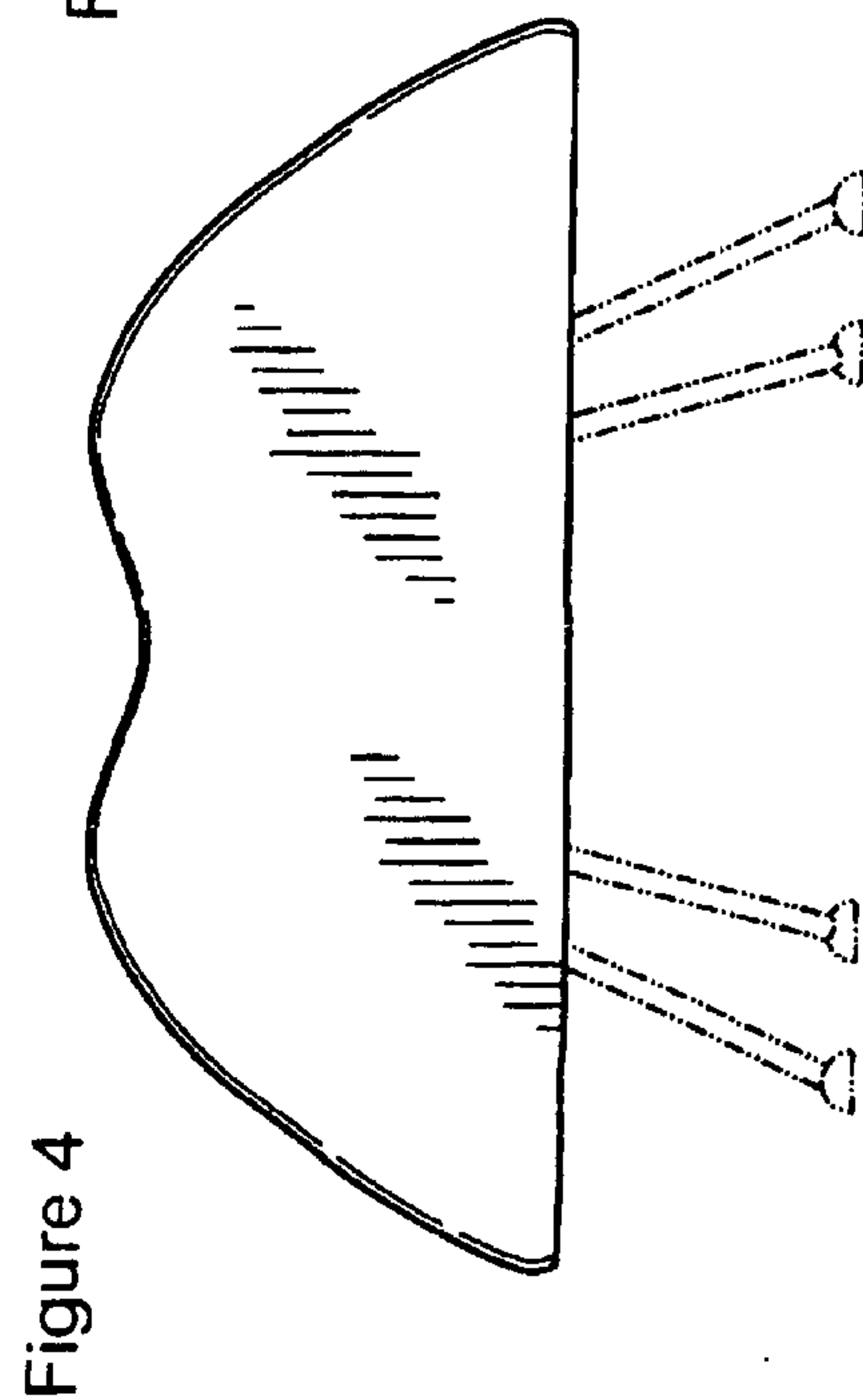
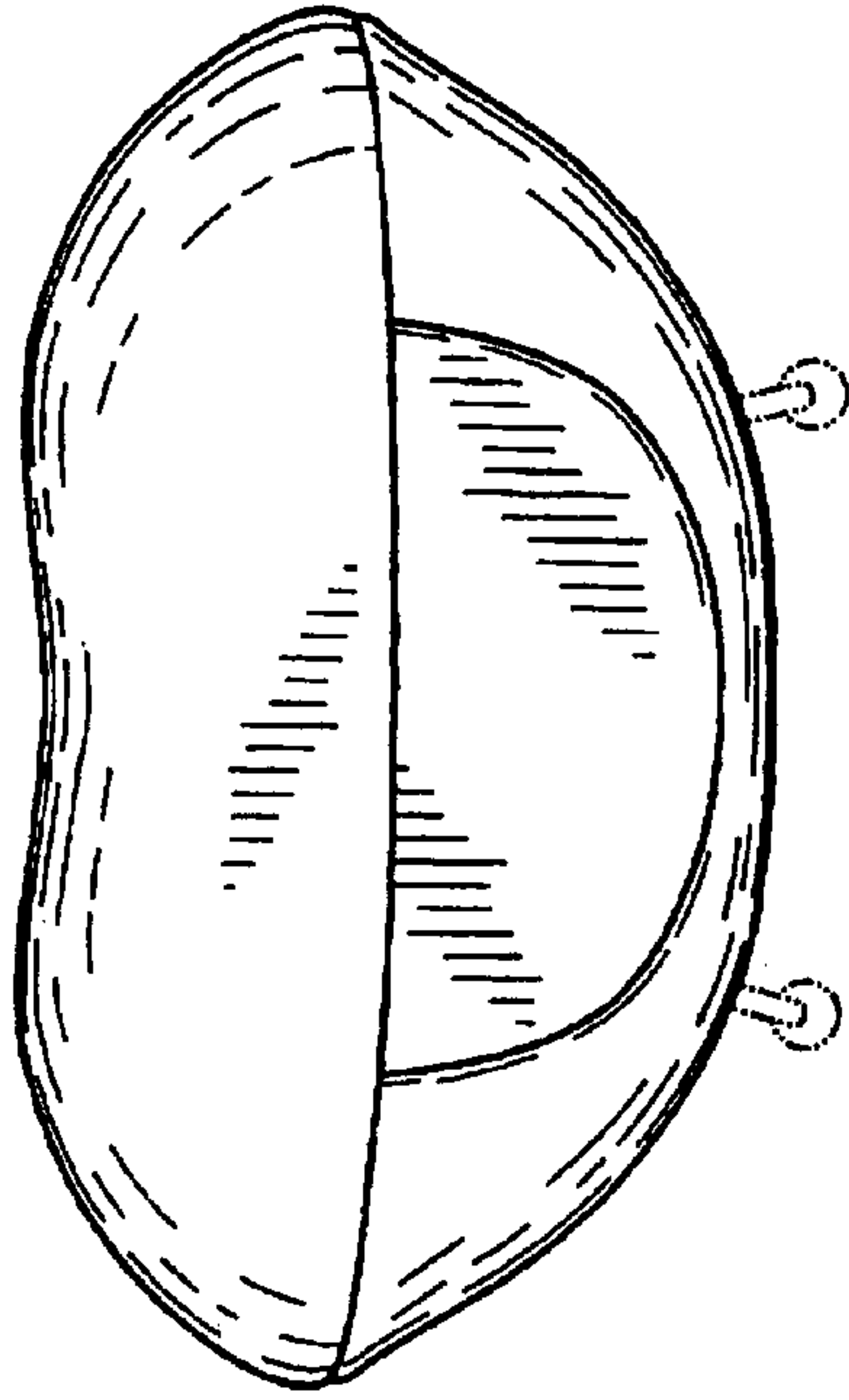

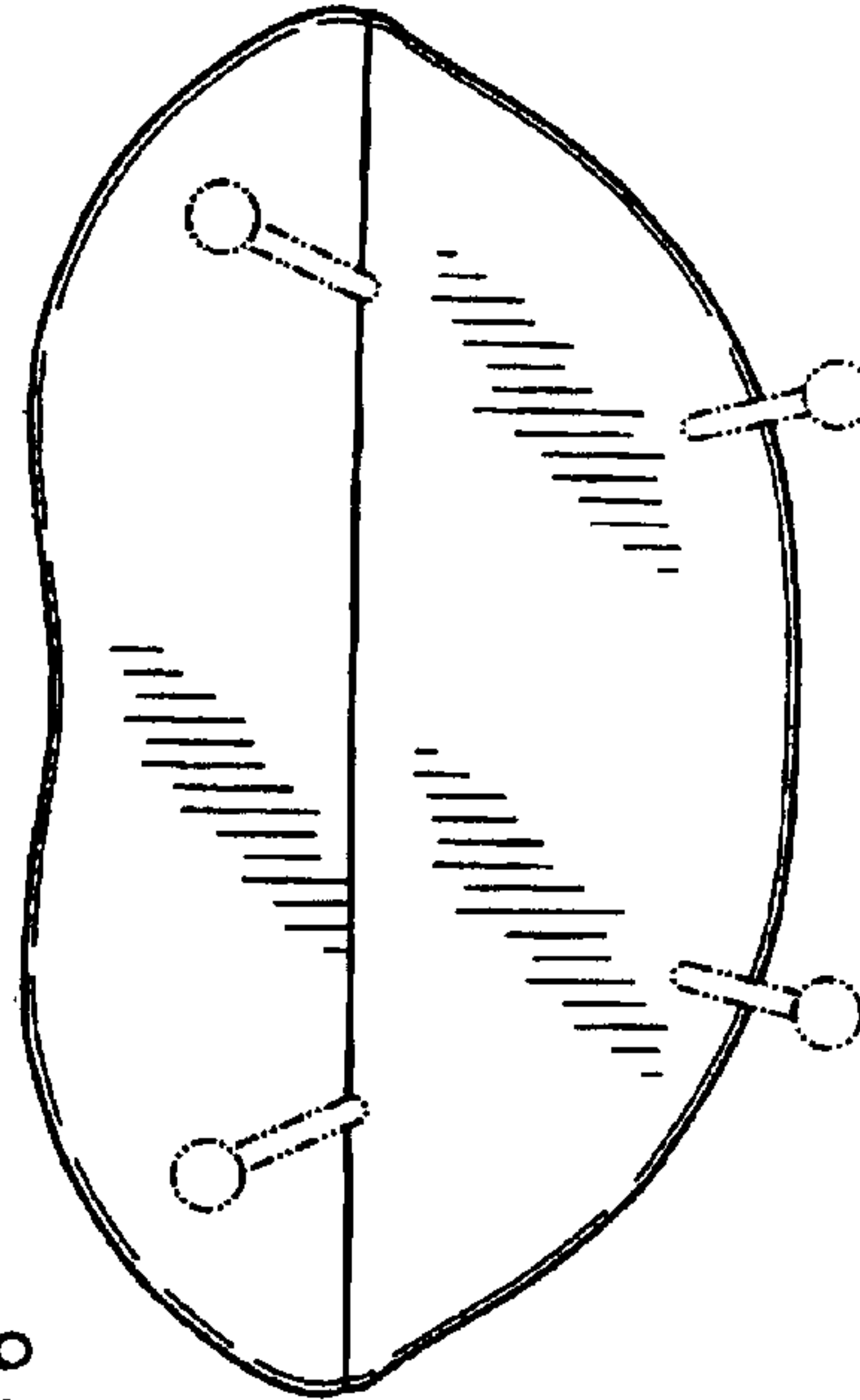
