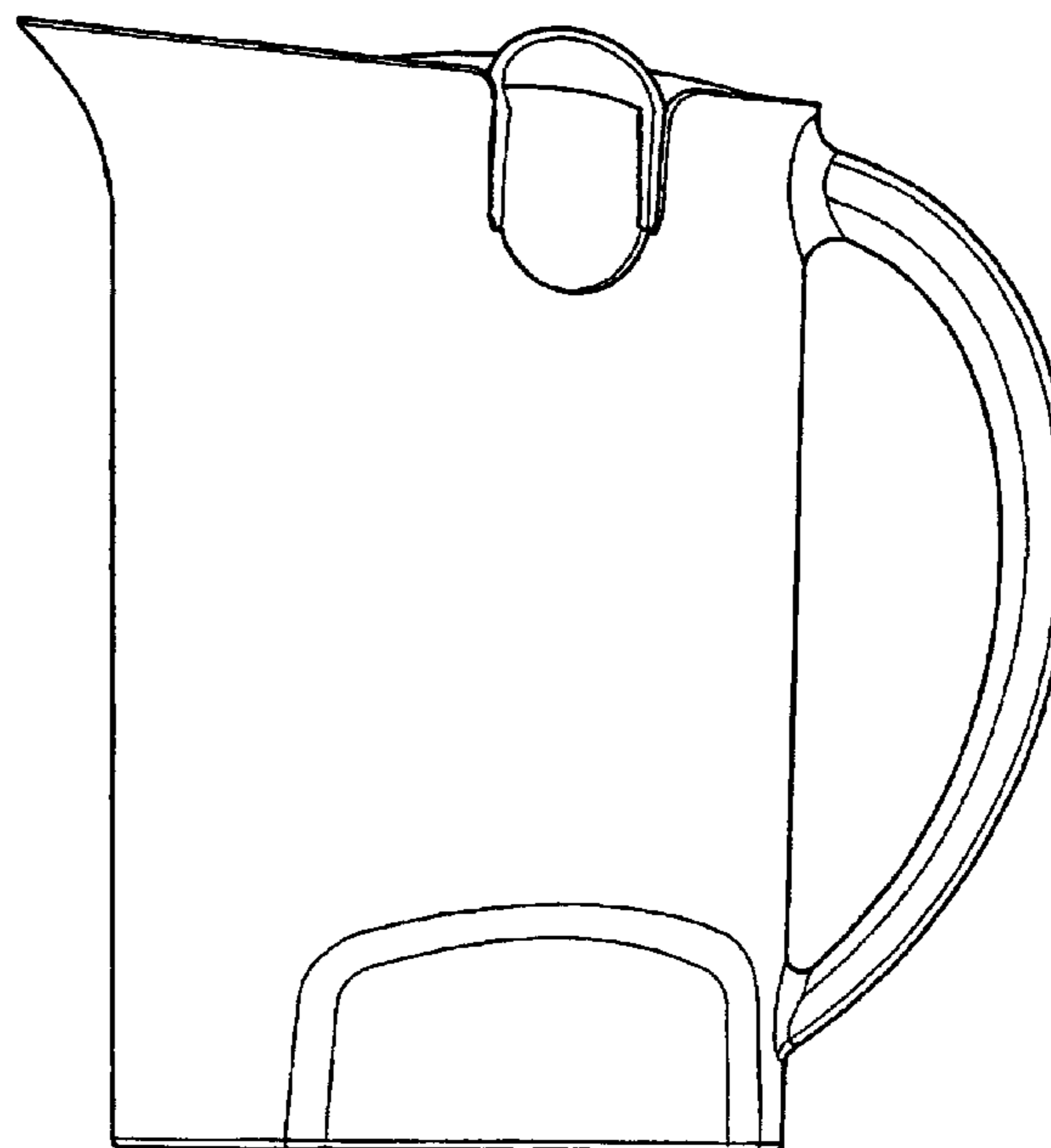
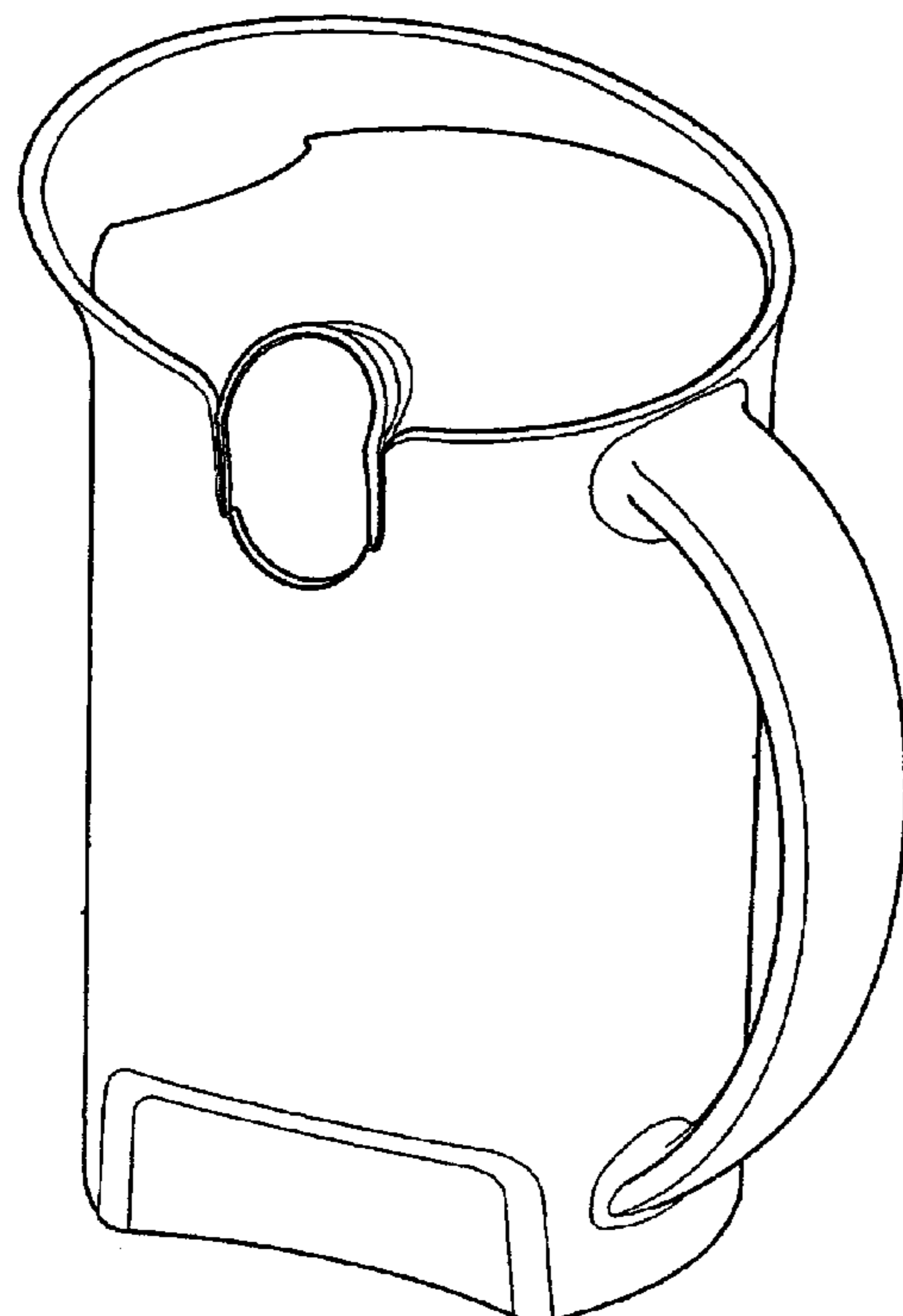
(57) **CLAIM**

The ornamental design for a jug for a juicer, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a jug for a juicer showing my new design;
FIG. 2 is a front perspective view thereof;

FIG. 4 is a left side elevation view thereof;

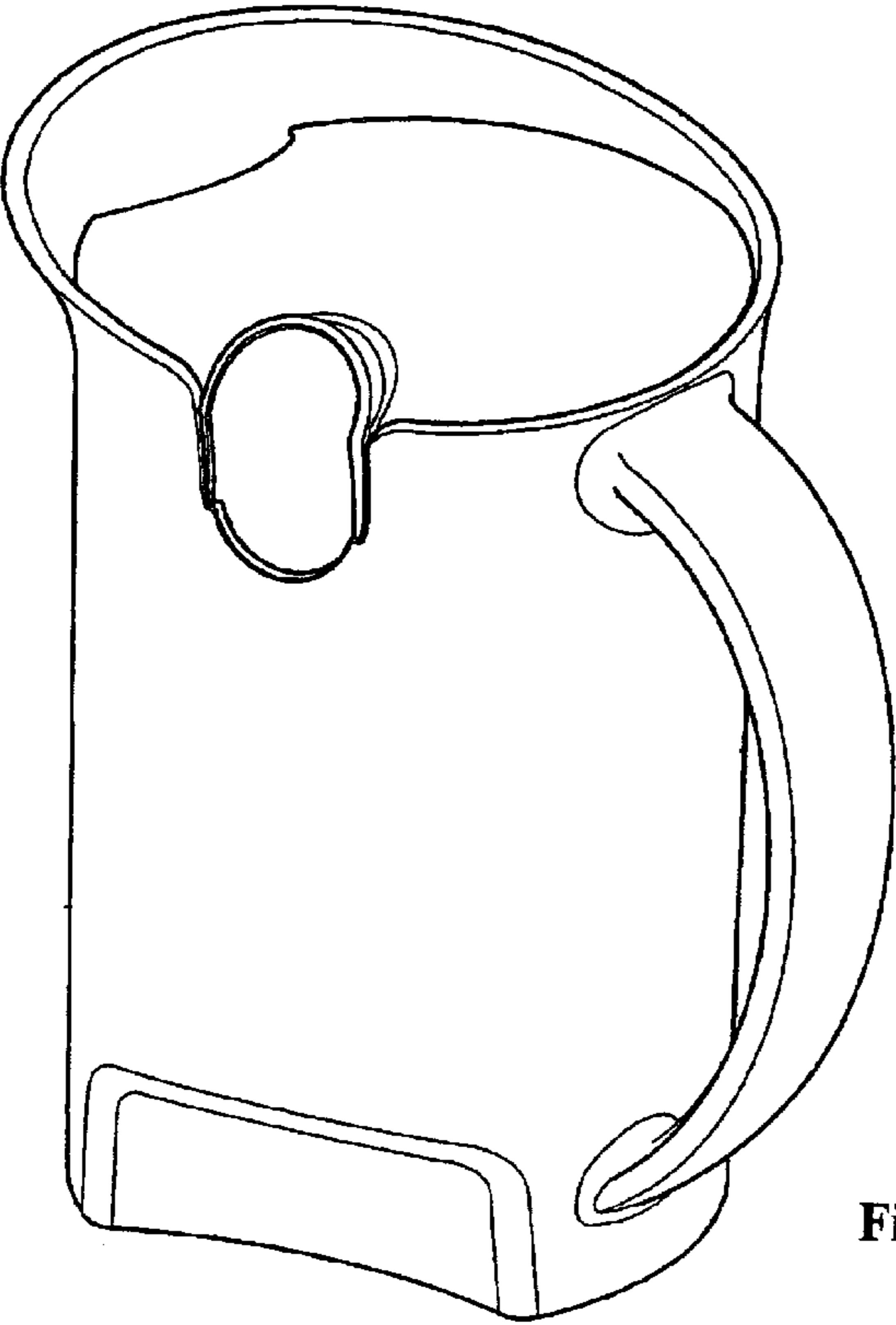

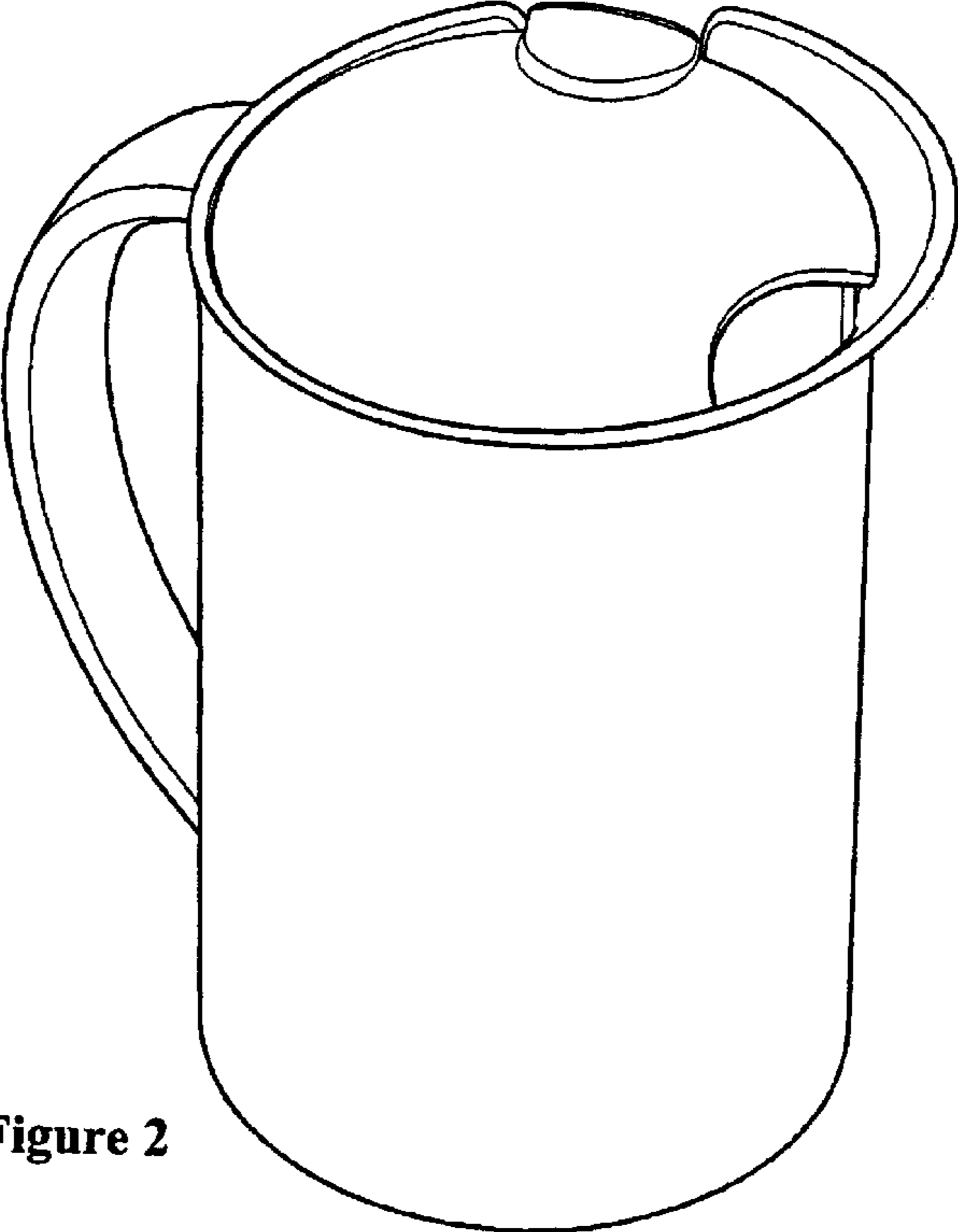

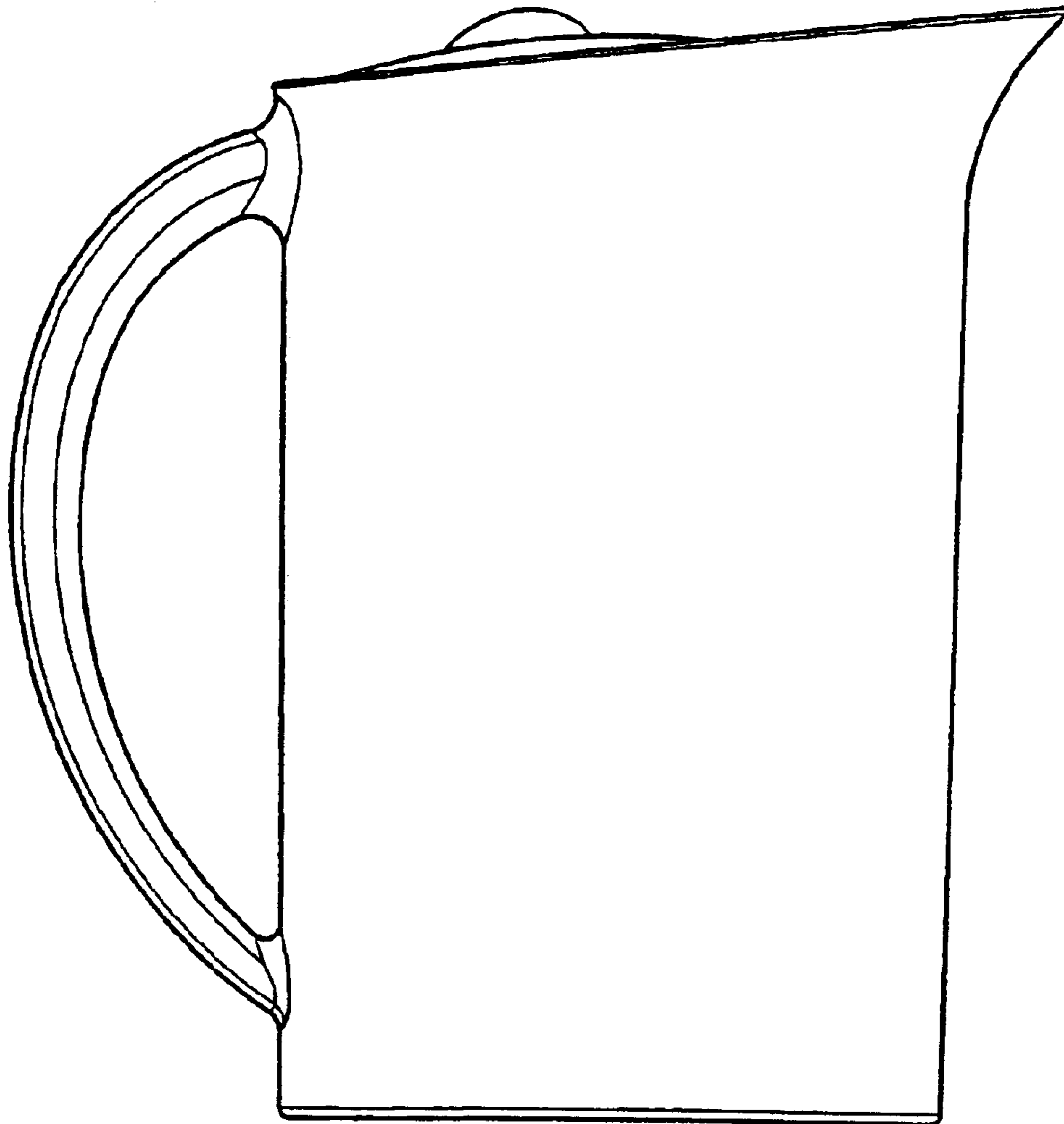

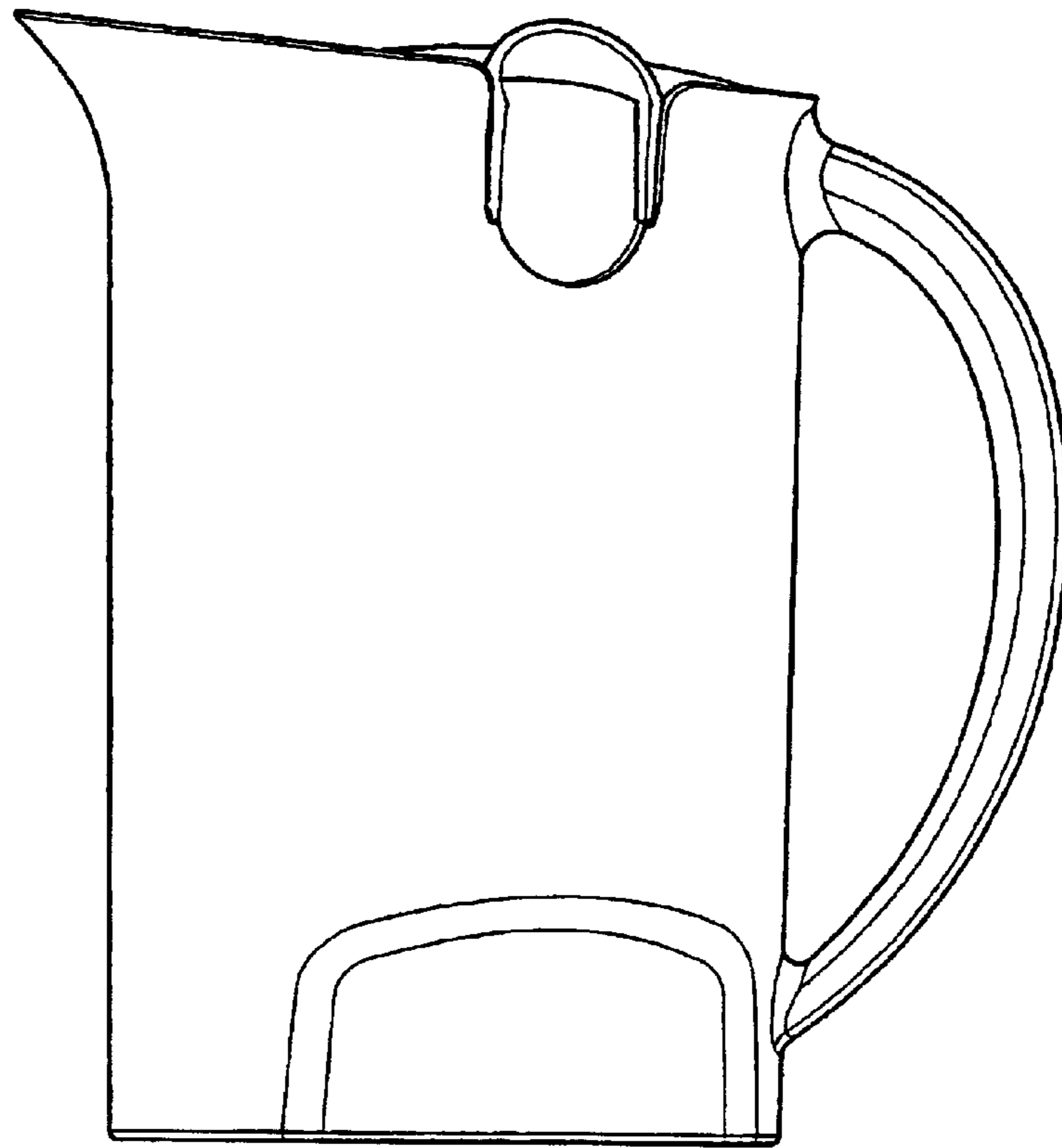
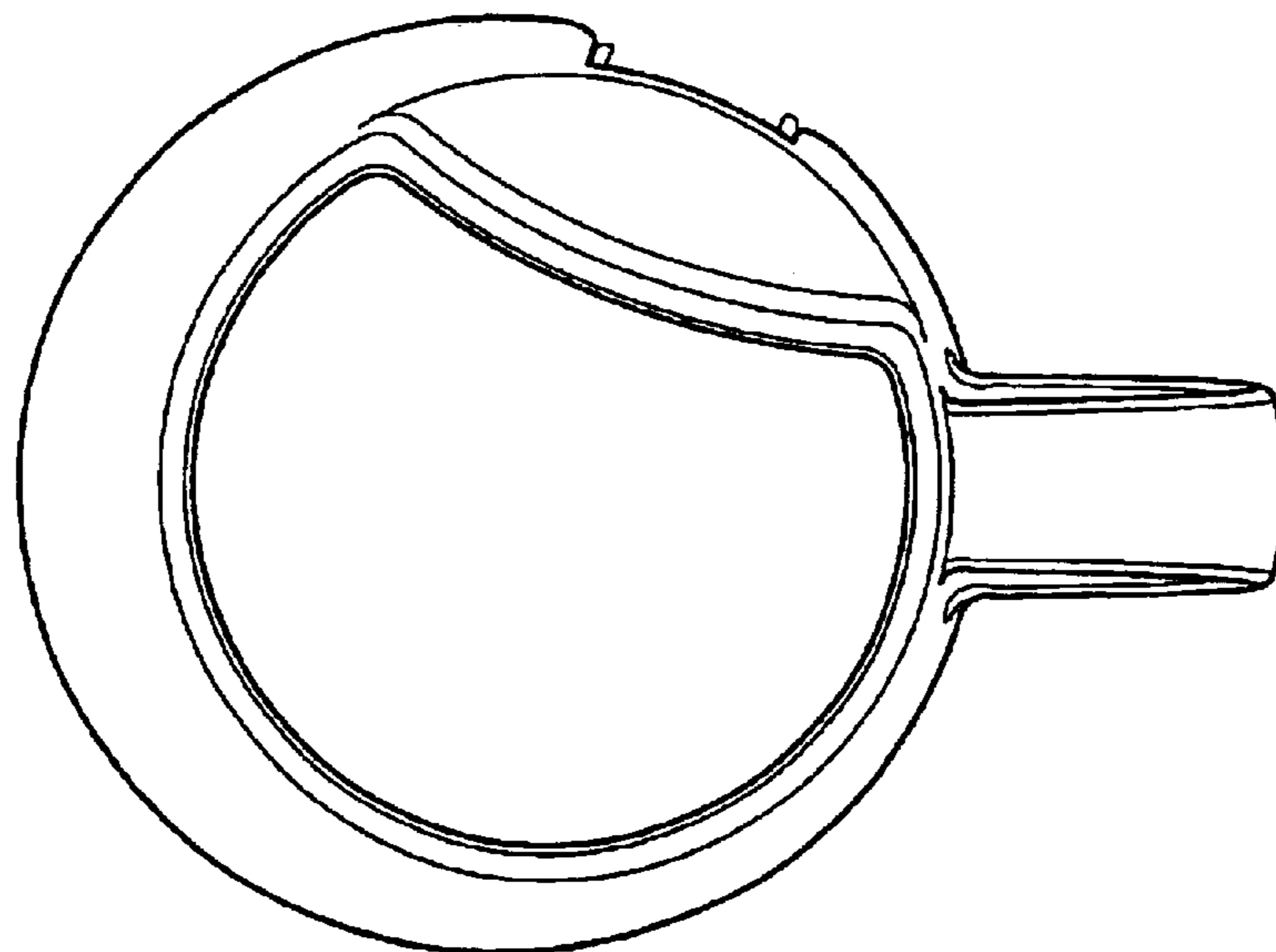

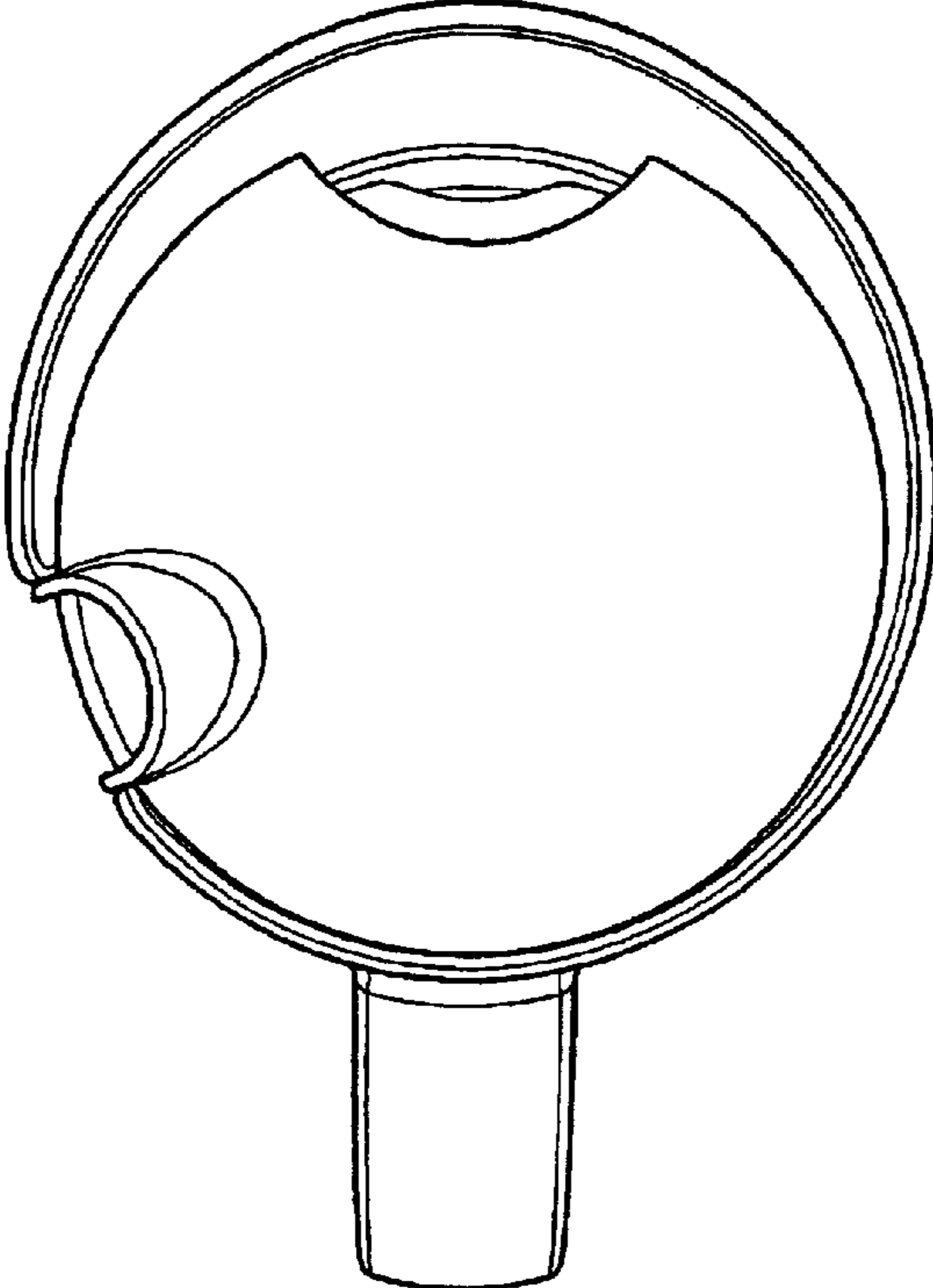

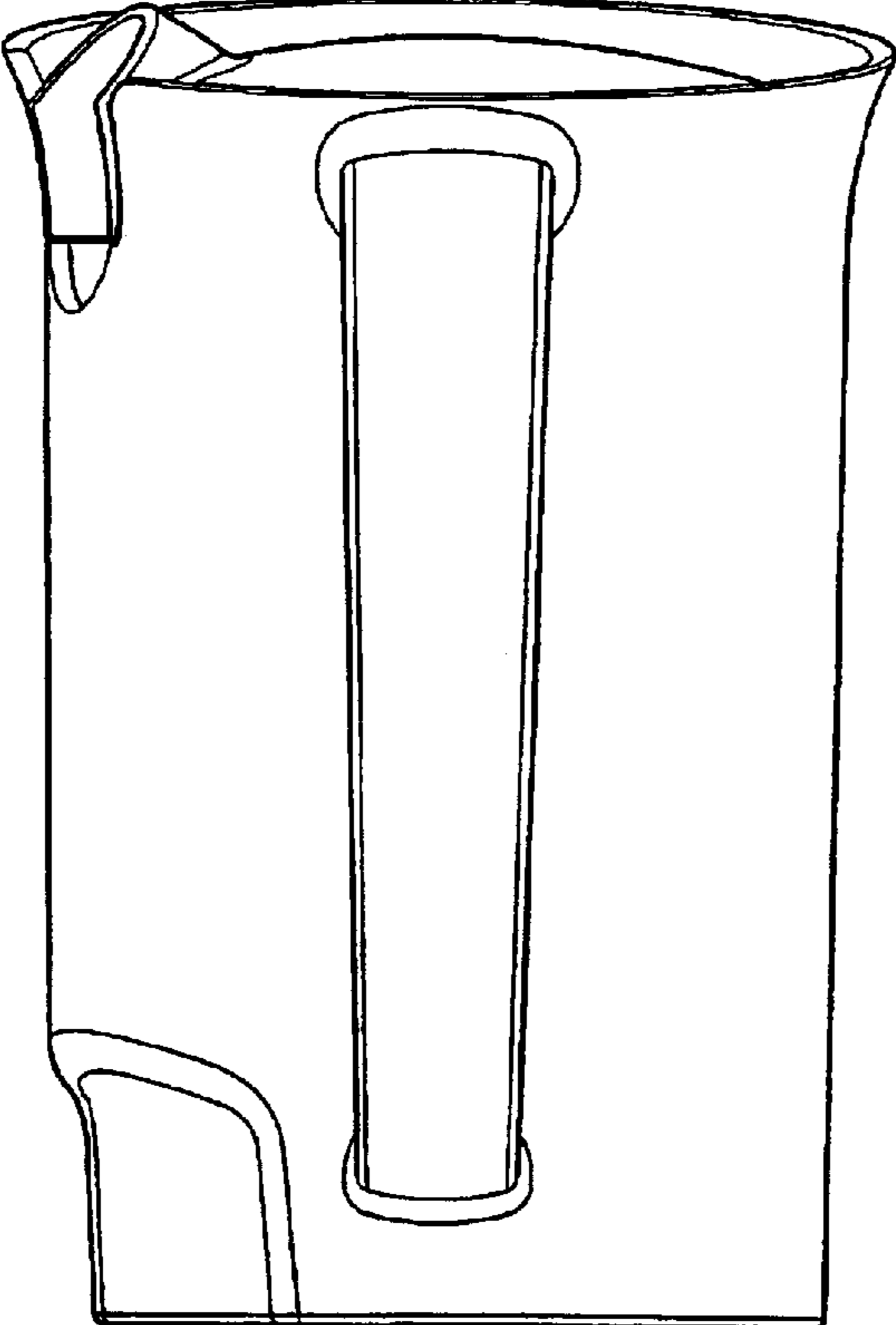
