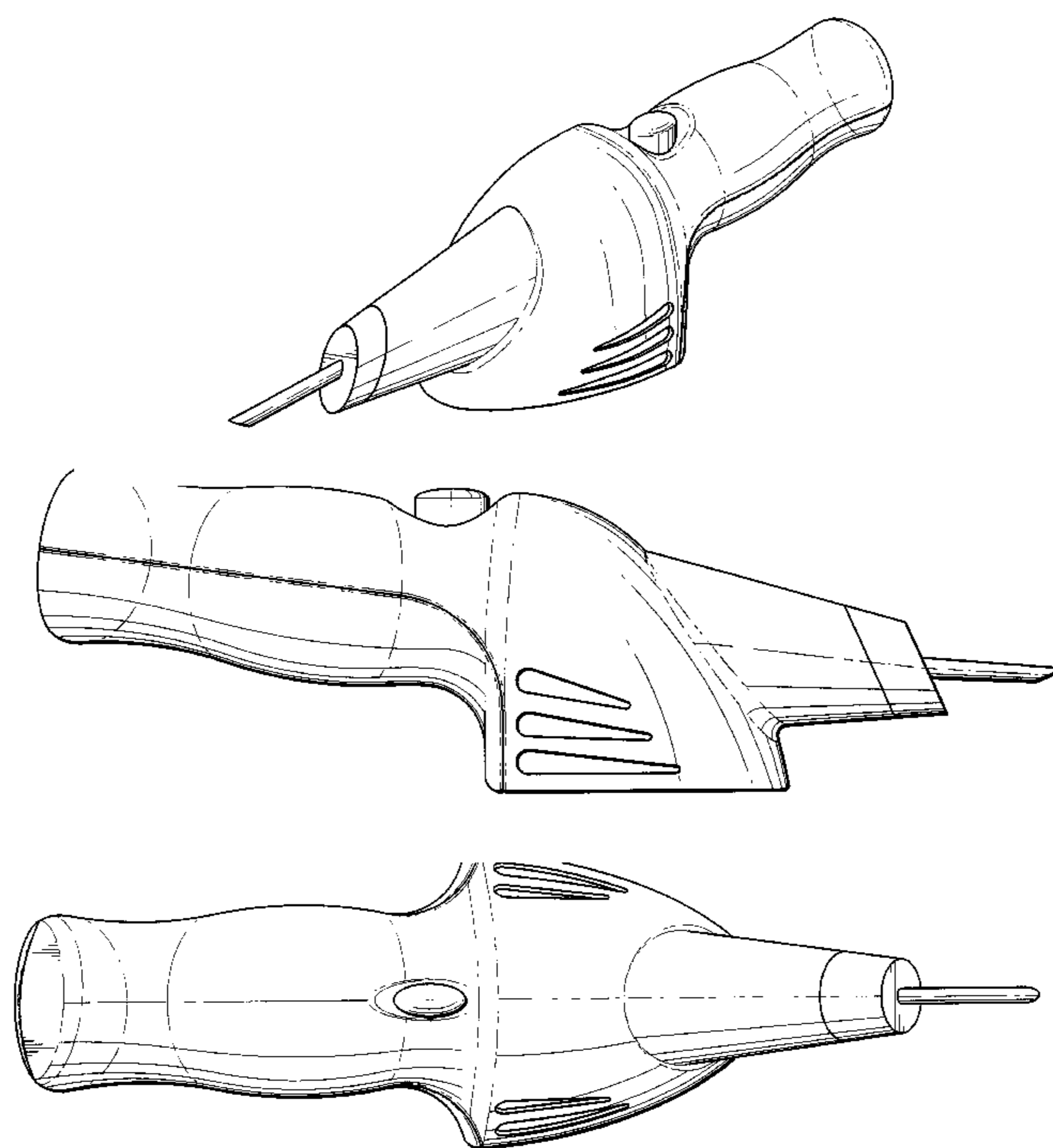
(57) **CLAIM**

I claim the ornamental design for a handheld vacuum apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handheld vacuum apparatus showing my new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.
The broken lines in the drawings represent surface shading.

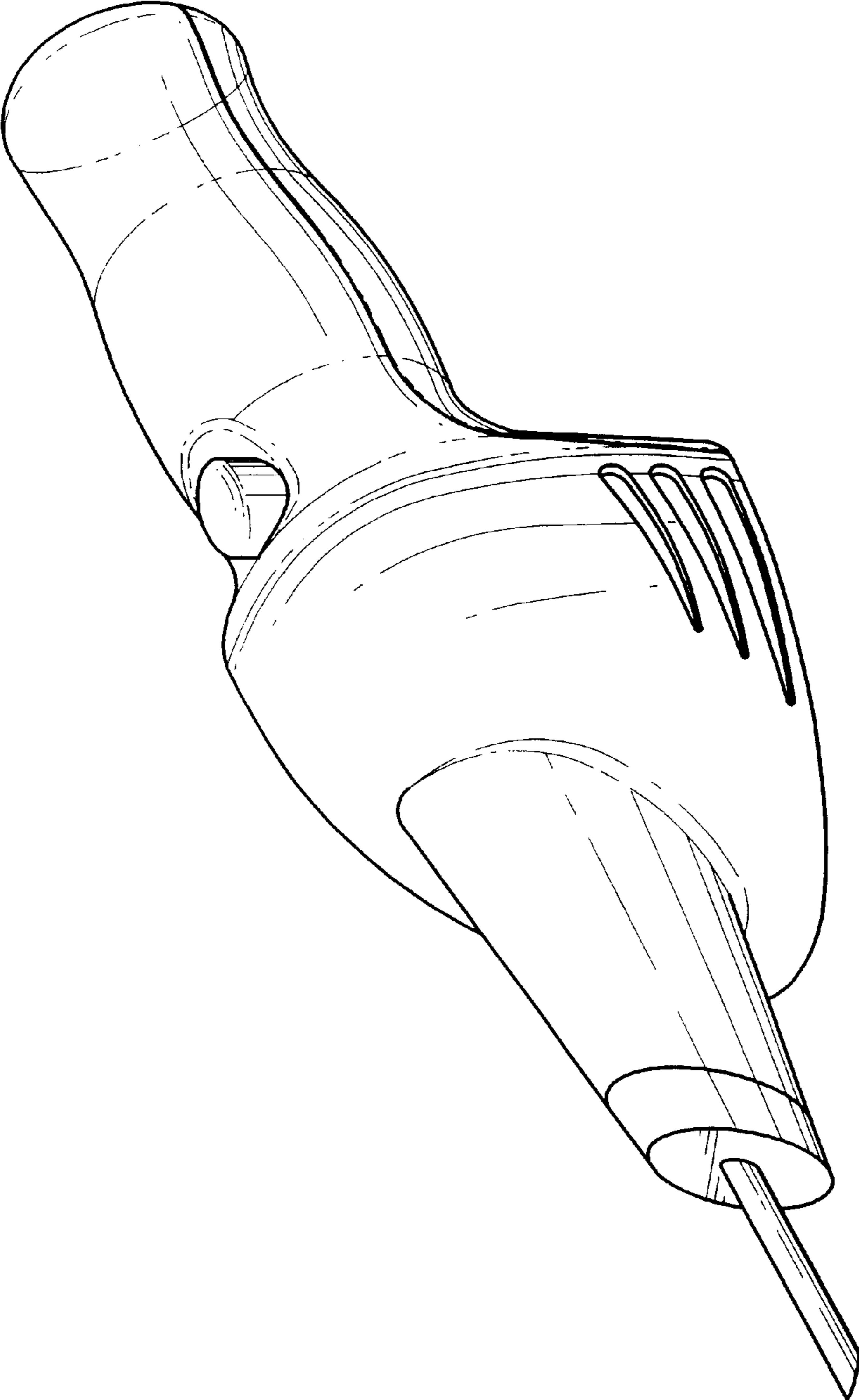

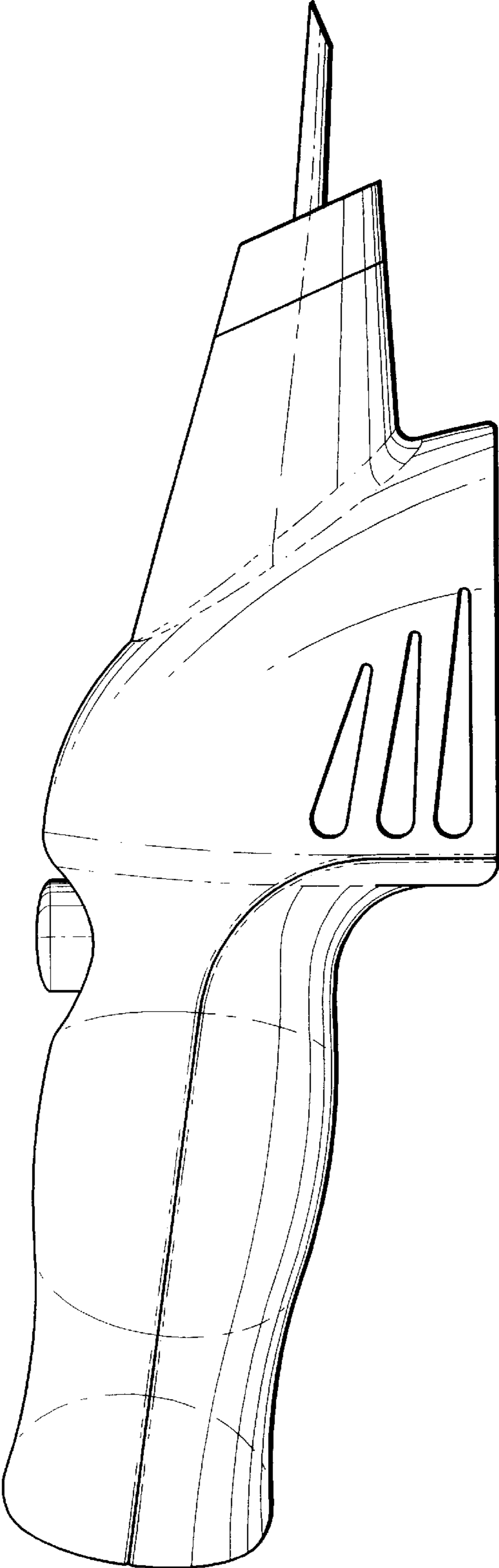

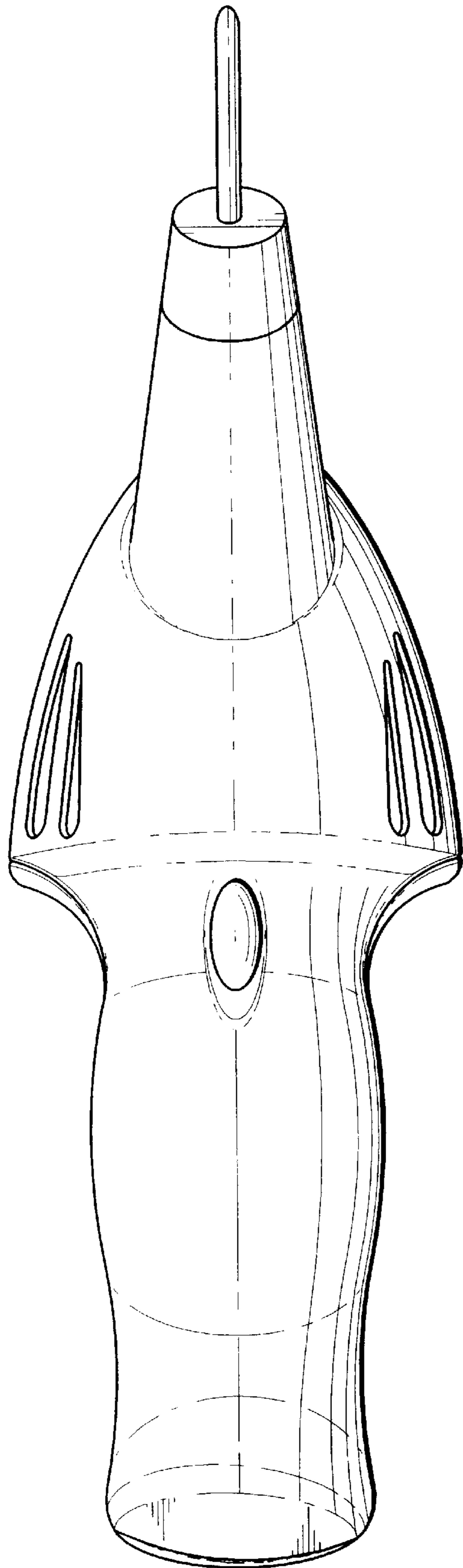

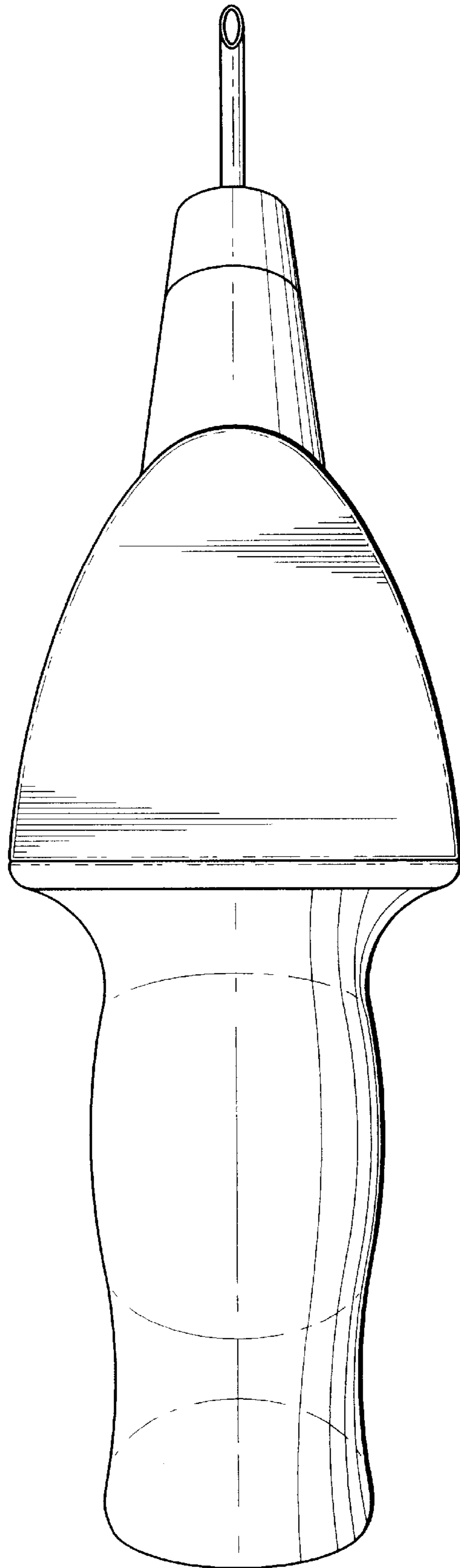

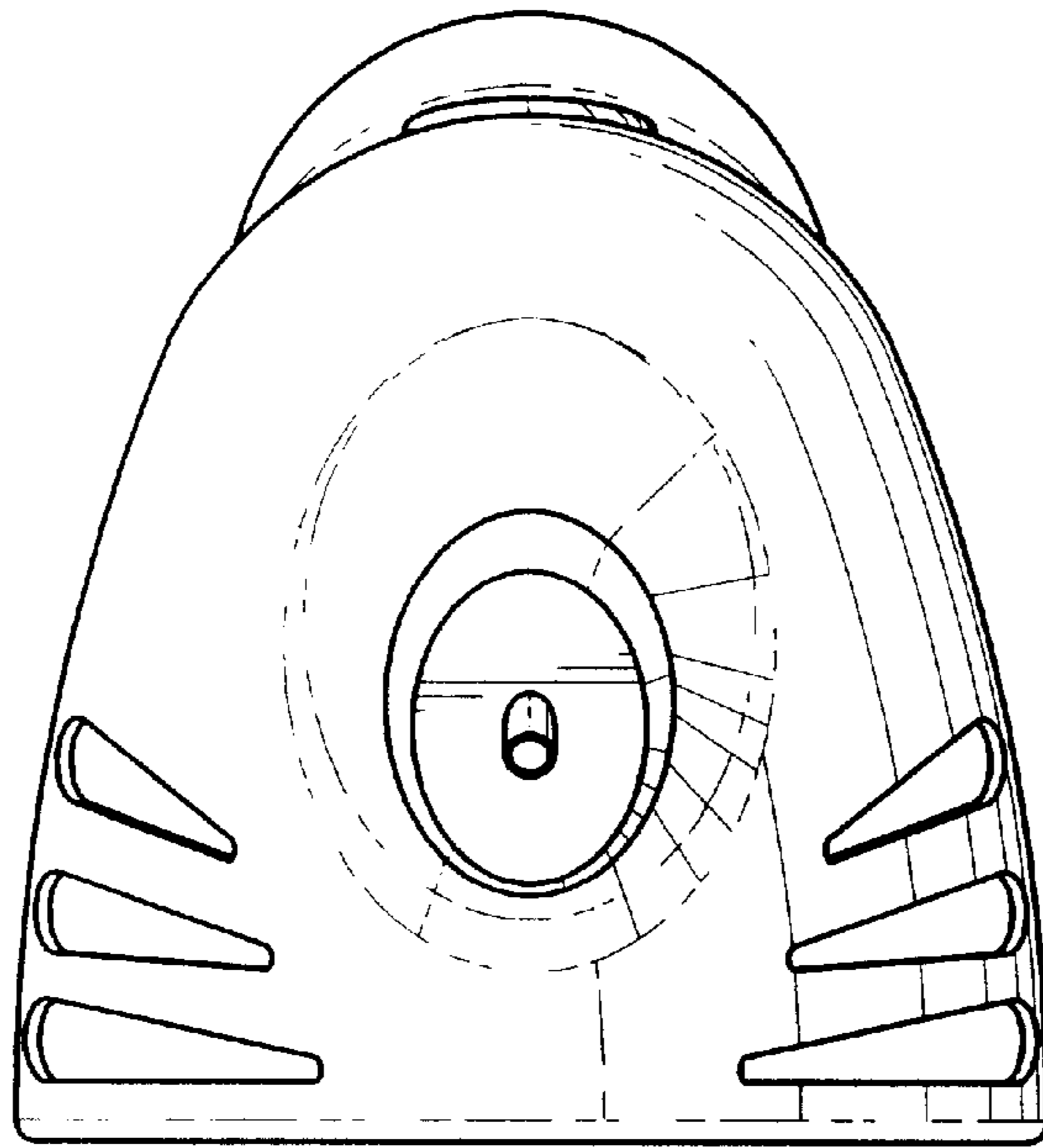

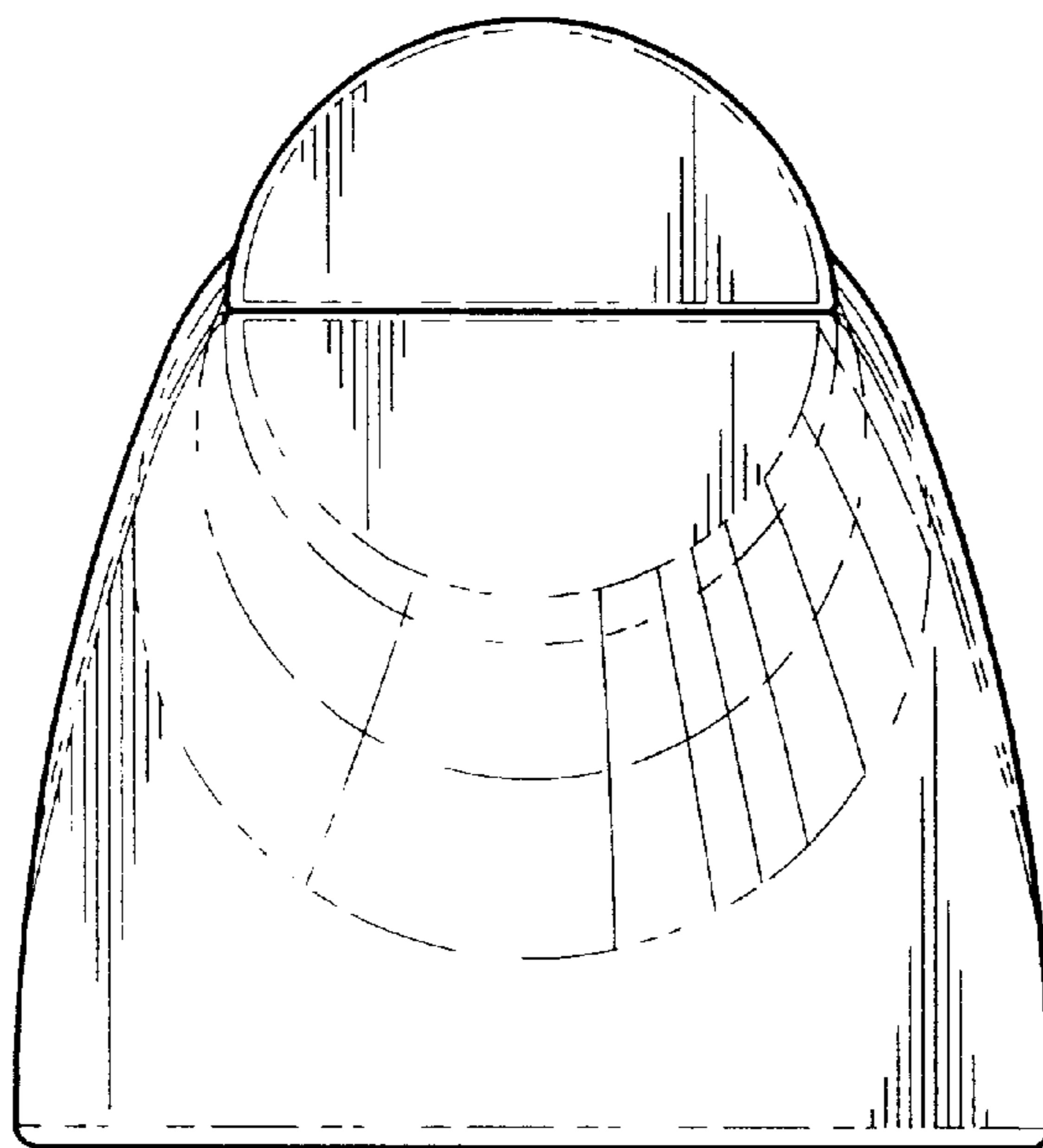
