(57) **CLAIM**

The ornamental design for a beveled handgrip for barbecue tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beveled handgrip for barbecue tool showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a top view thereof,

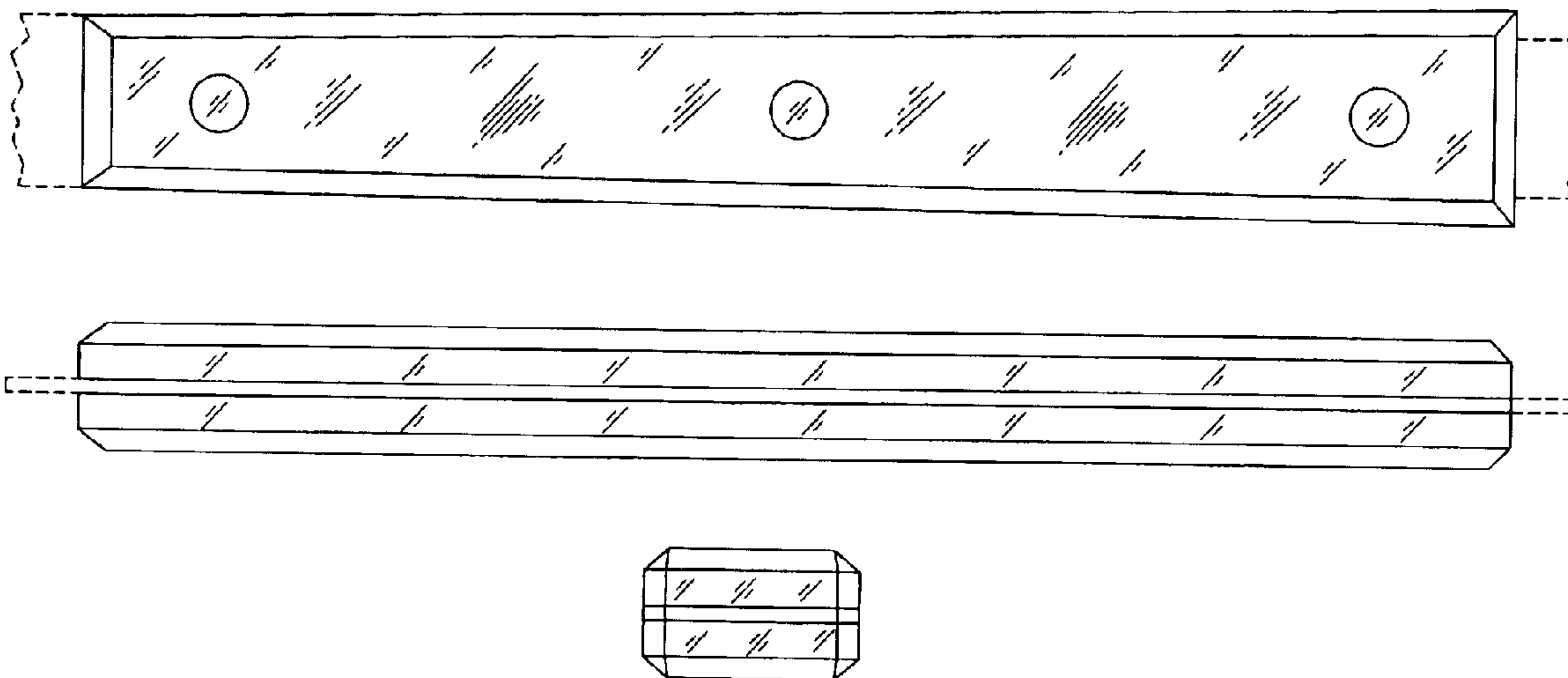
FIG. 6 is a front elevational view of an alternate embodiment; and,

FIG. 7 is a side view of the alternate embodiment.

The rear elevational views not illustrated are identical to the views illustrated in FIG. 1 and FIG. 6, the sides not illustrated are identical to the side views illustrated in FIG. 3 and FIG. 7 and the top and bottom view of the alternate embodiment are substantially identical to the top and bottom views illustrated in FIG. 5 and FIG. 4.

The broken line showings of a handle shank are for illustrated purposes only and form no part of the claimed design.

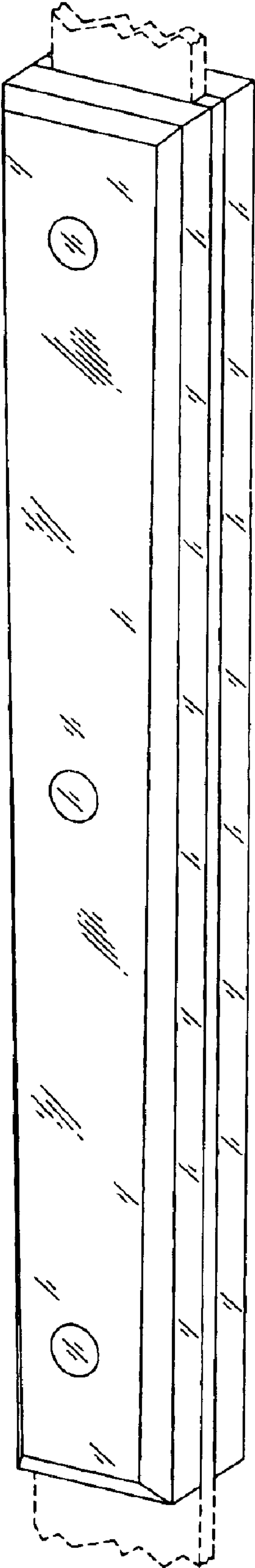

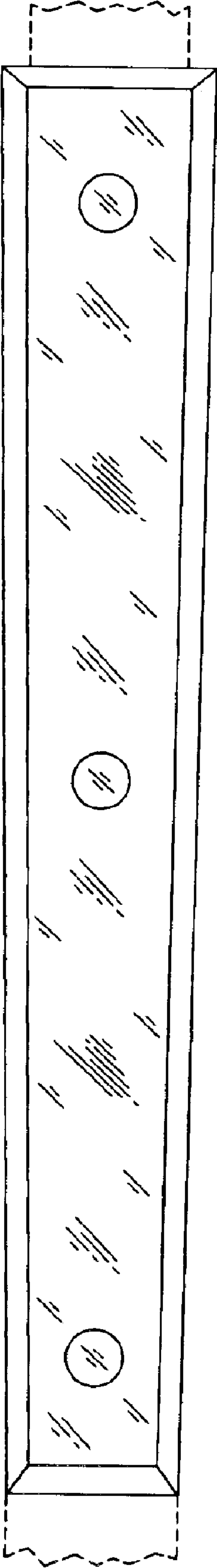

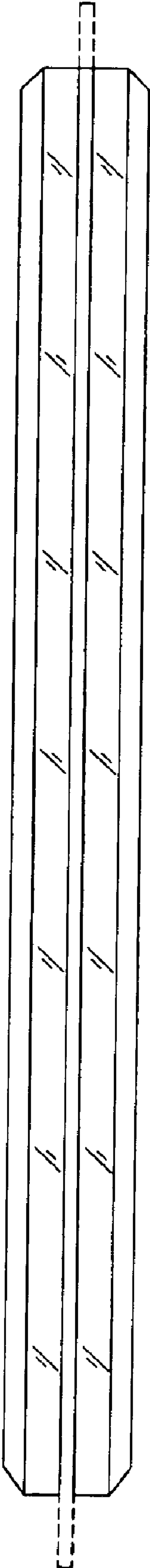

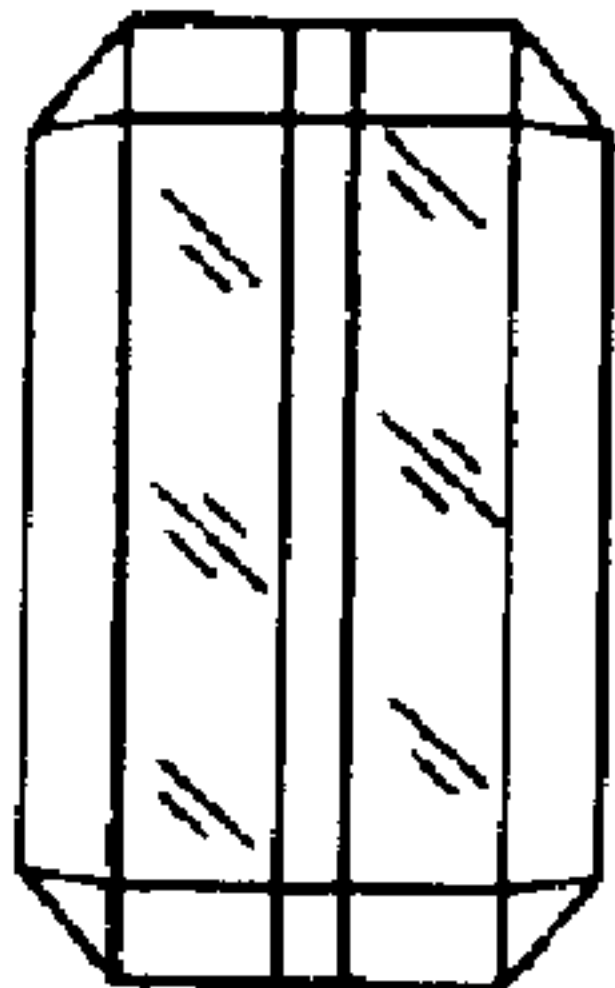

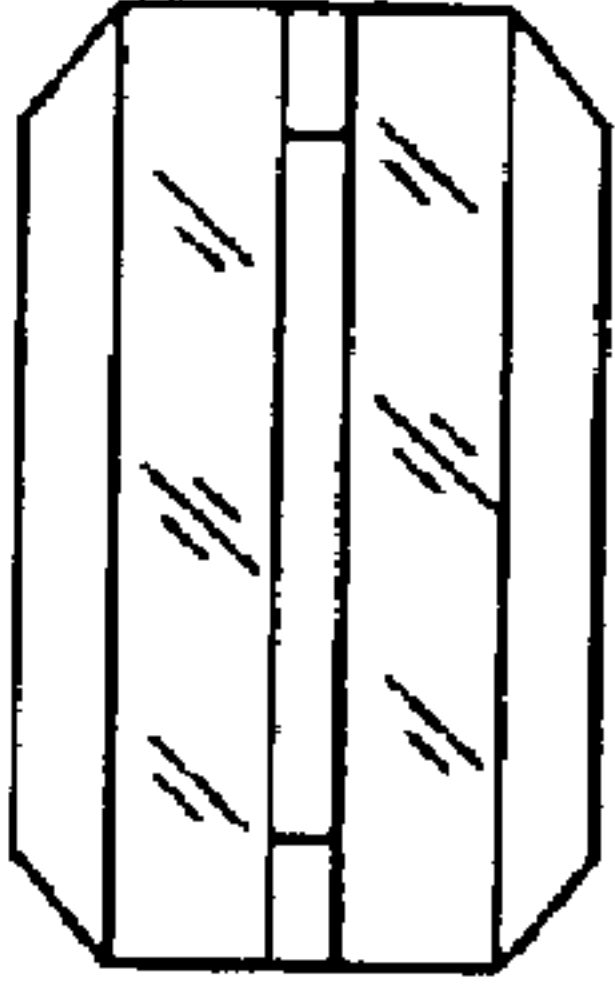

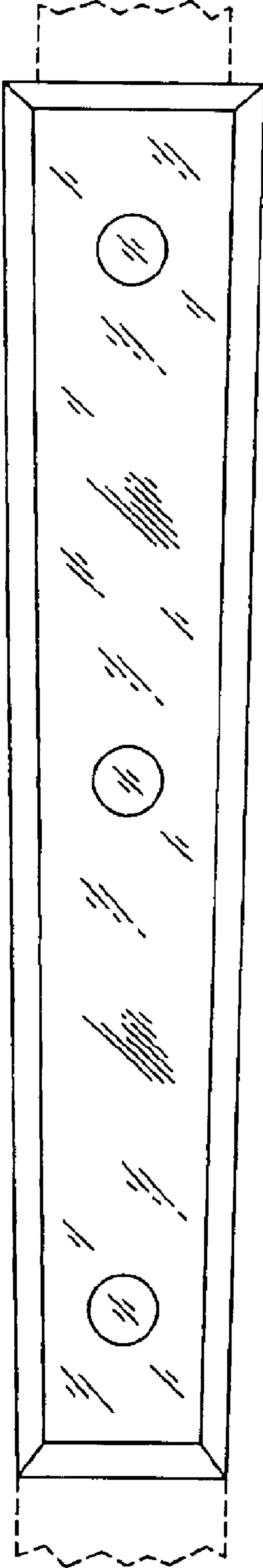

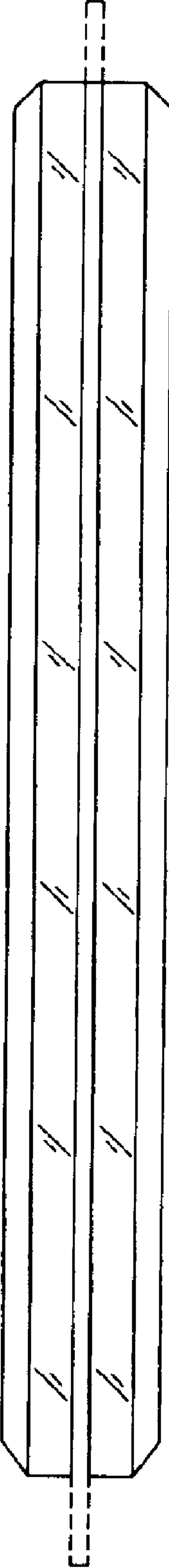
