(57) **CLAIM**

I claim the ornamental design design for a drinking vessel having surface protrusions, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a drinking vessel in accordance with the present invention;
FIG. 2 is a front view thereof, all sides being the same;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a bottom plan view thereof.

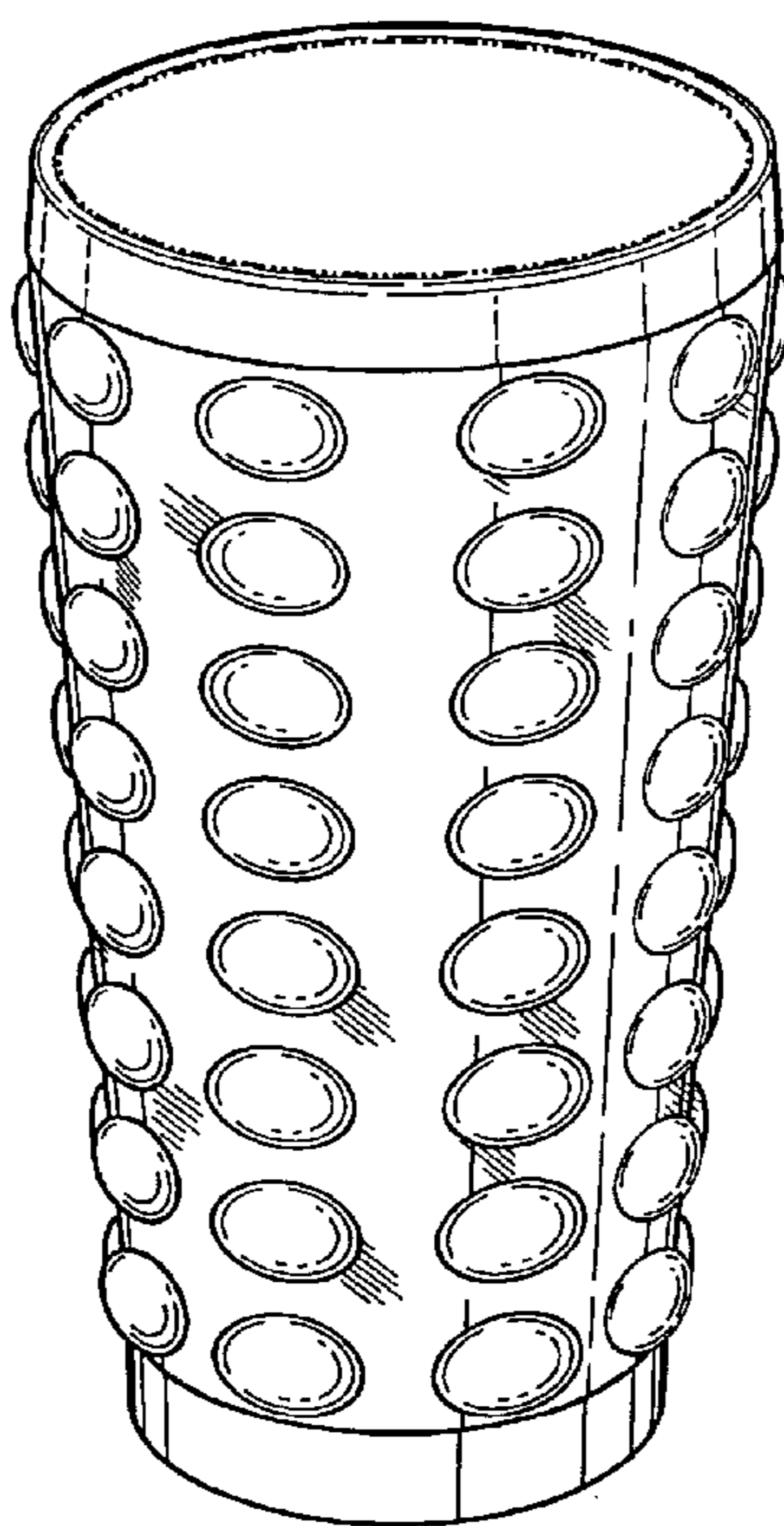

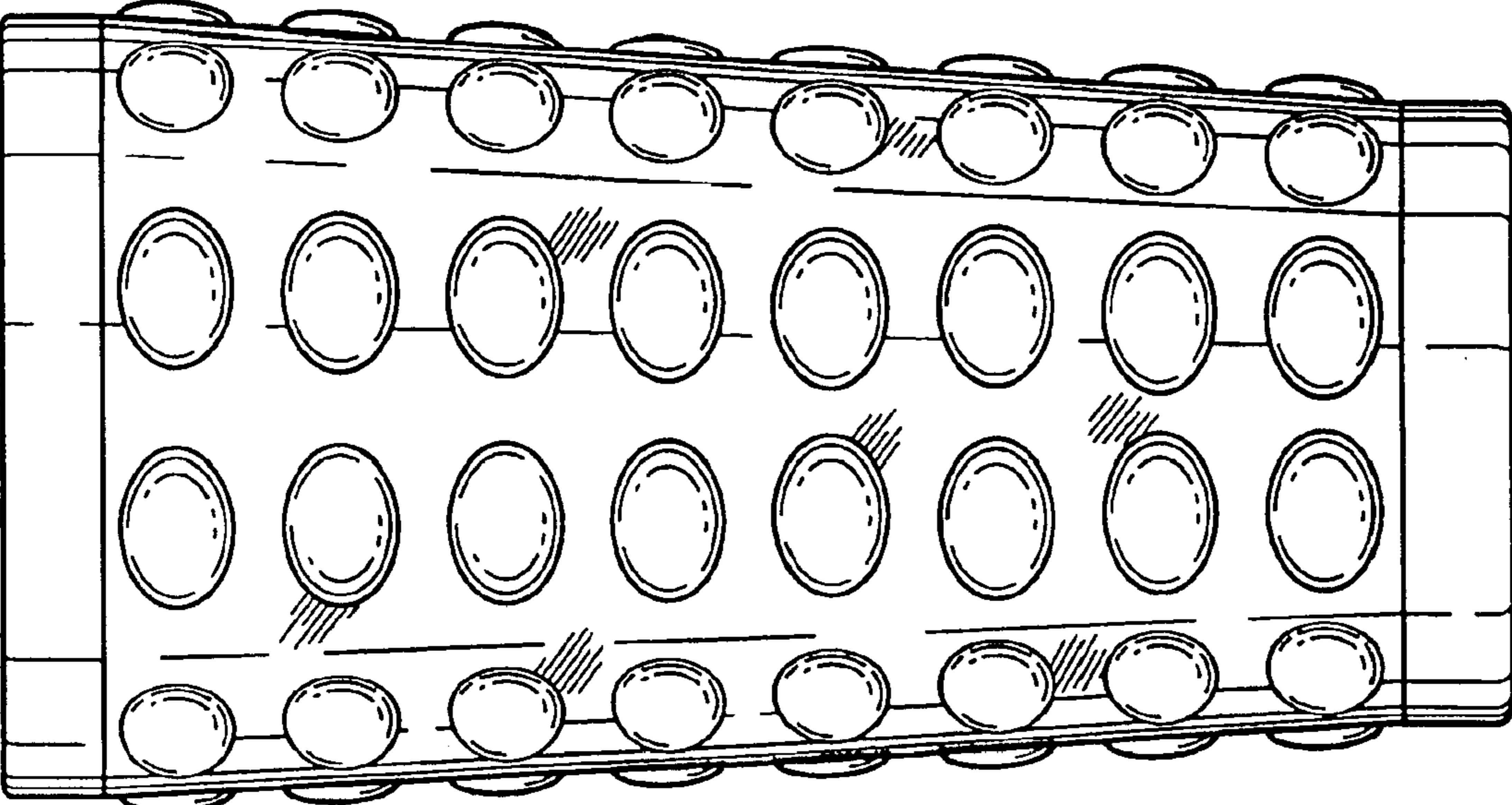

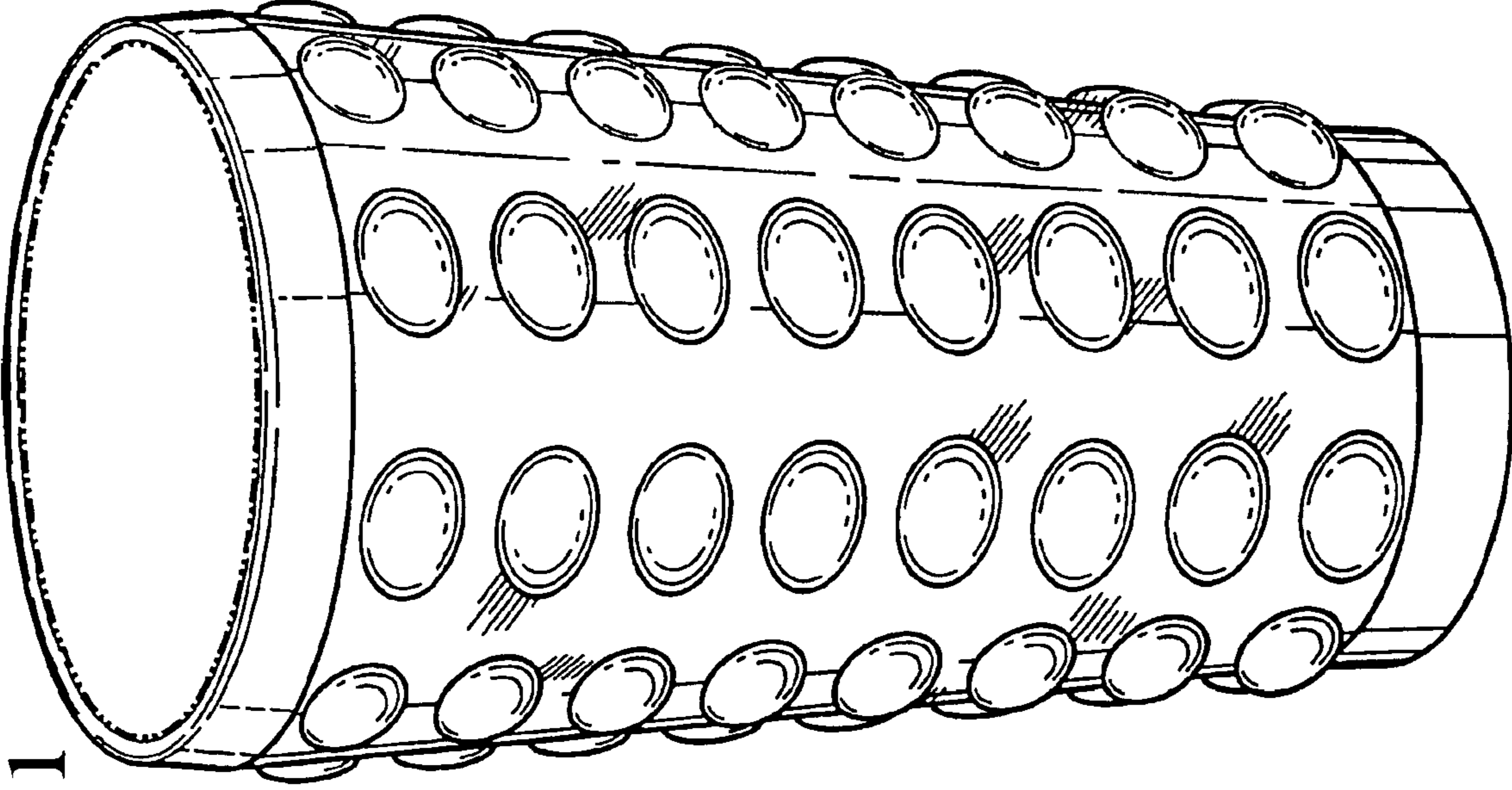

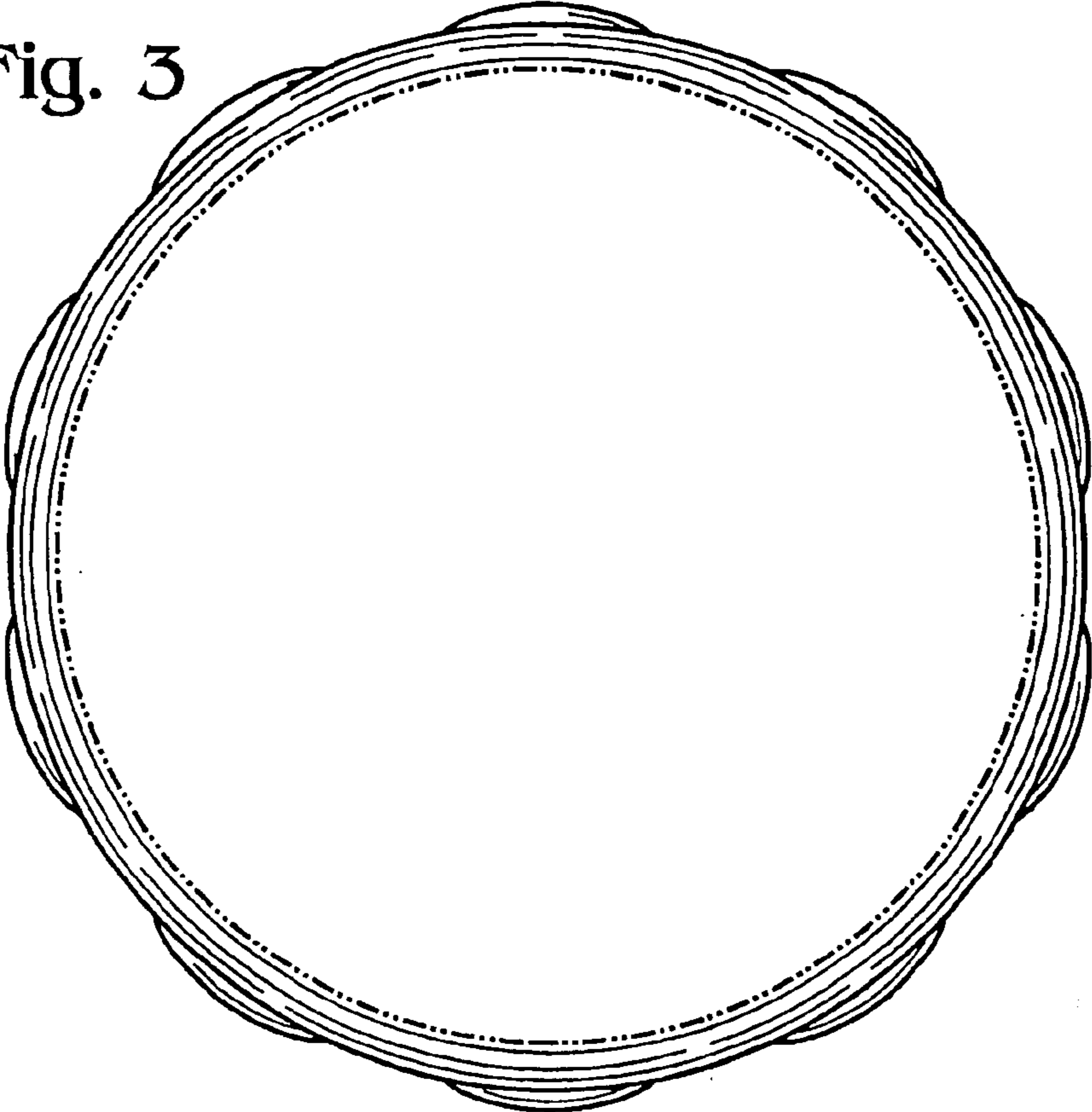
