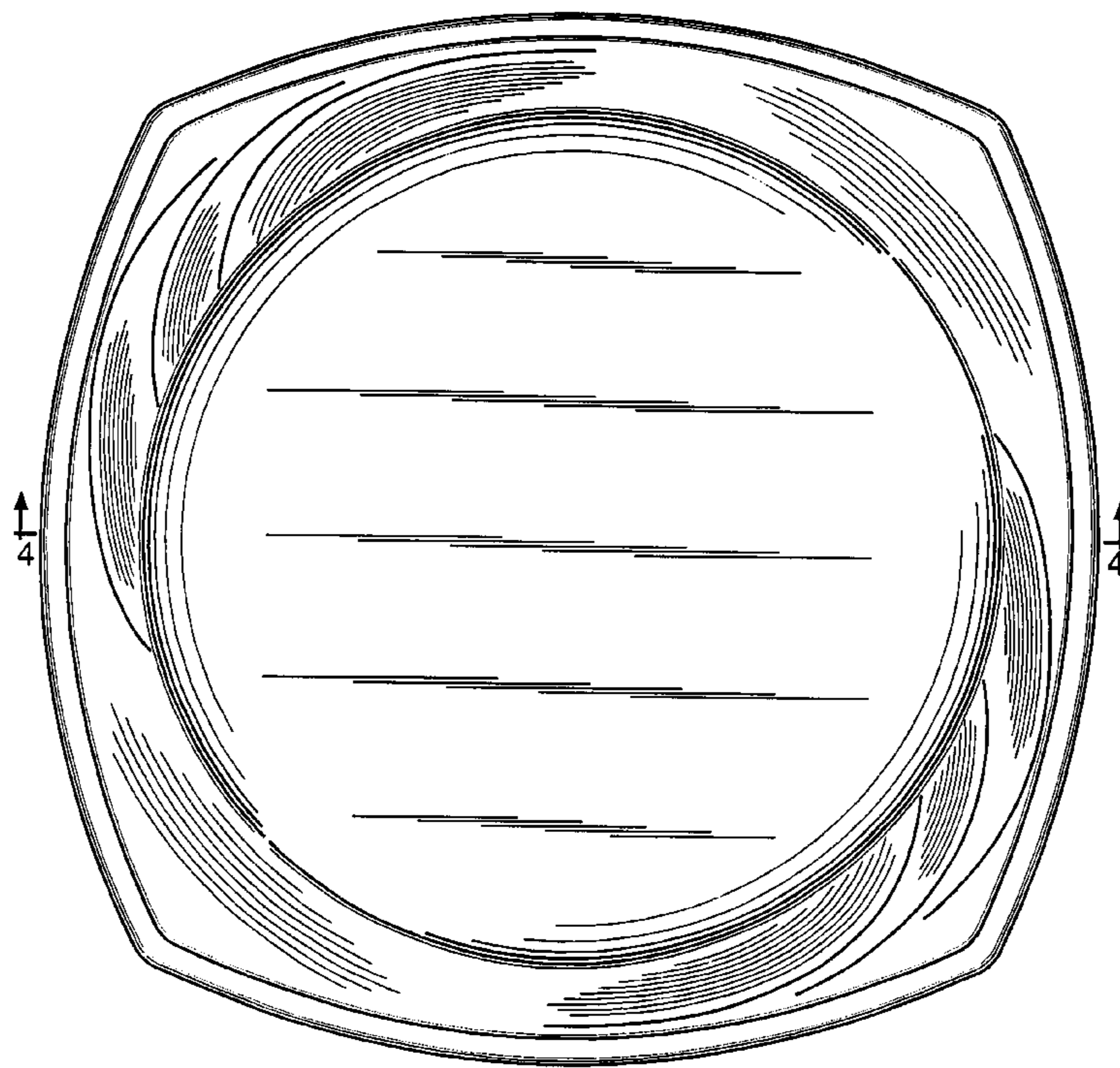

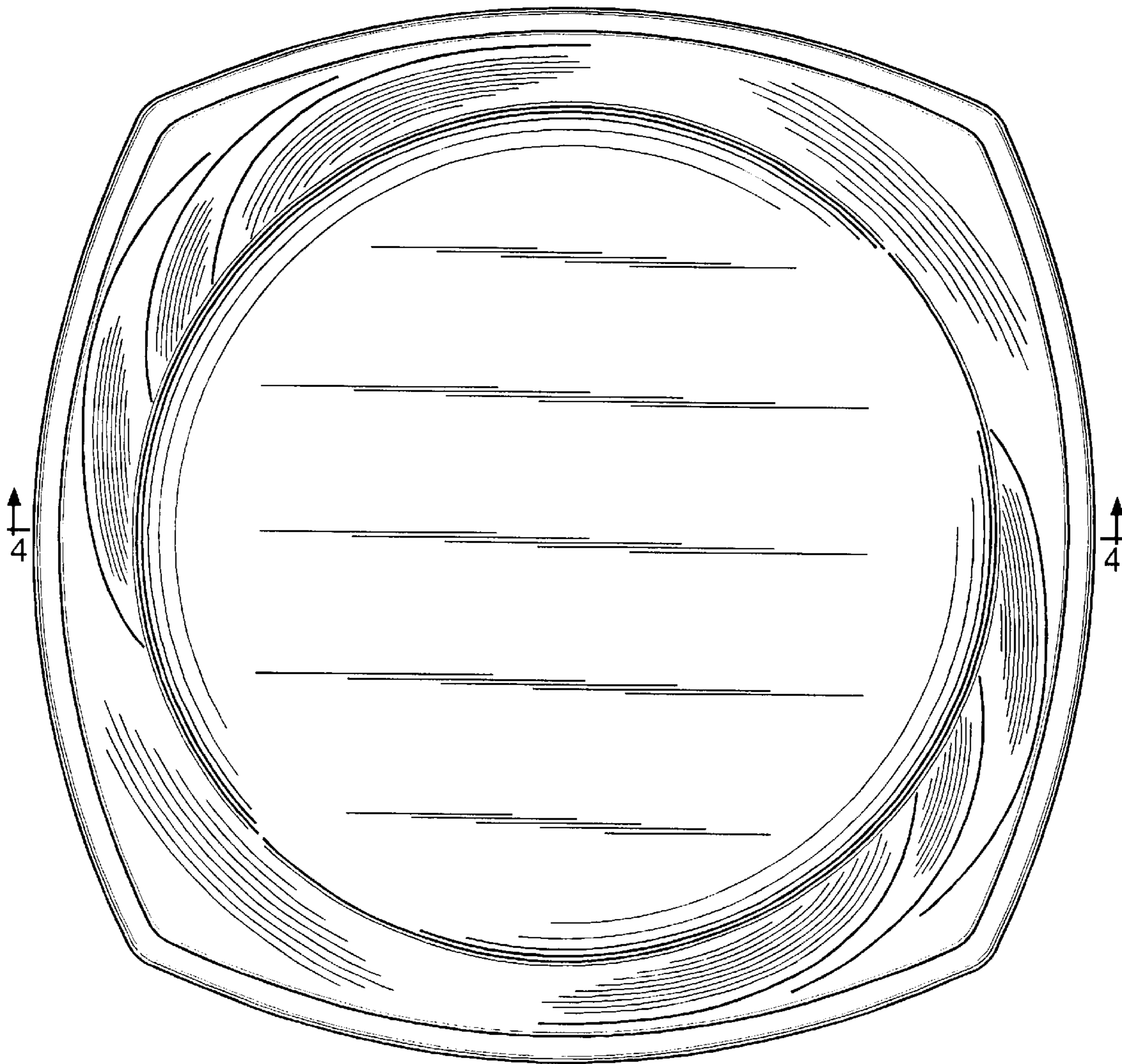
The ornamental design for a plate, as shown and described.

**DESCRIPTION**

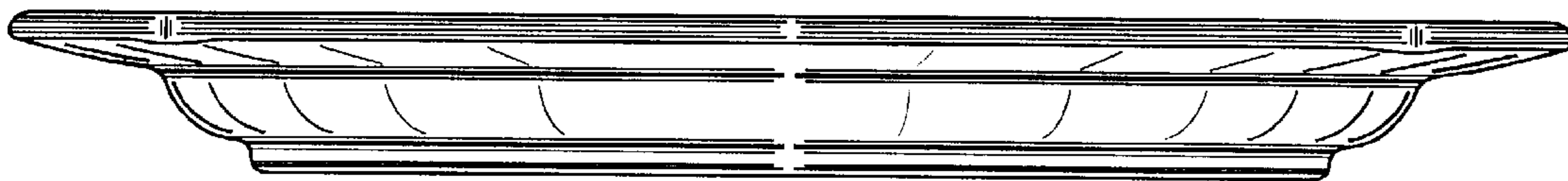
FIG. 1 is a top plan view of a plate according to the present design;

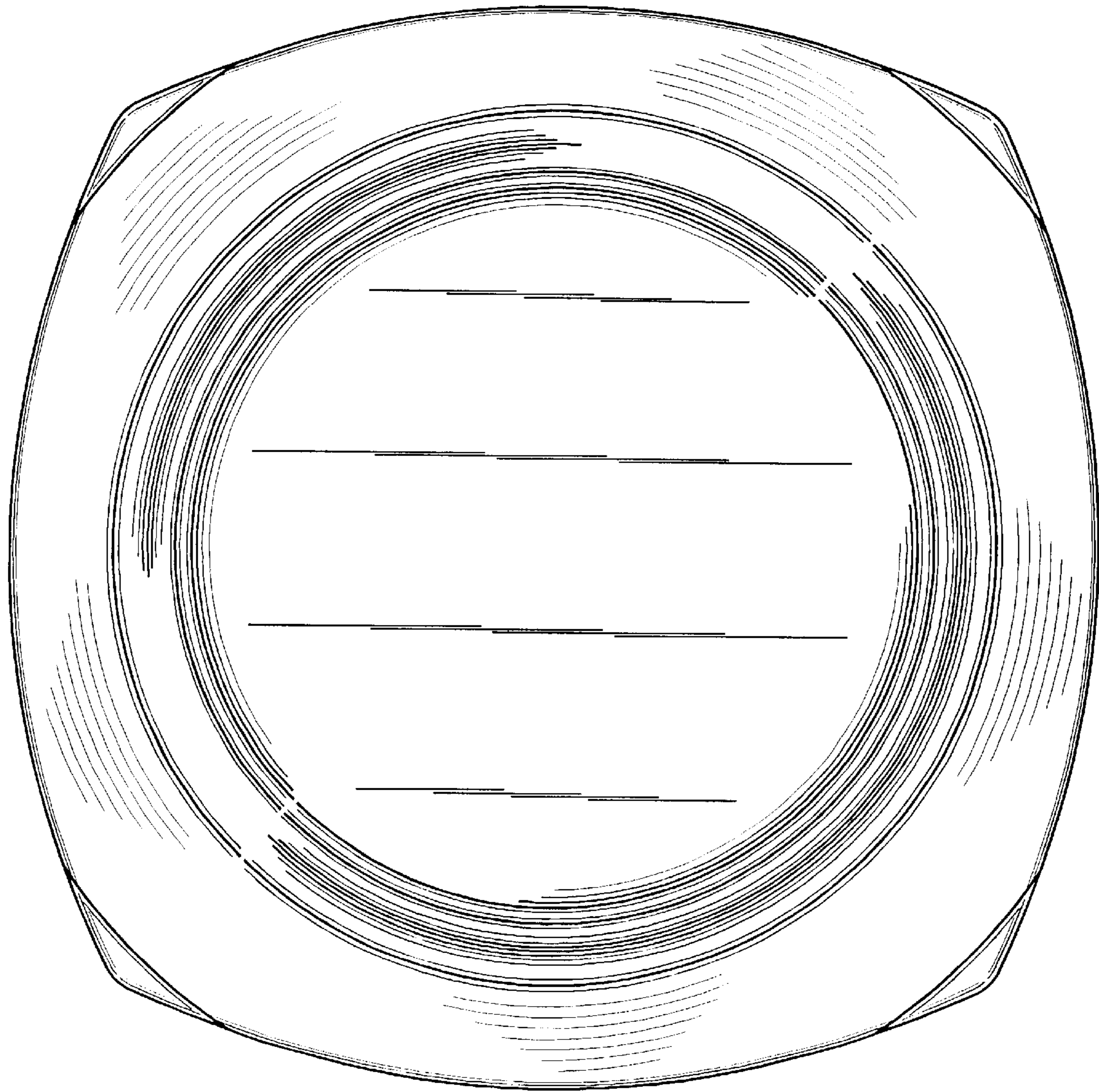




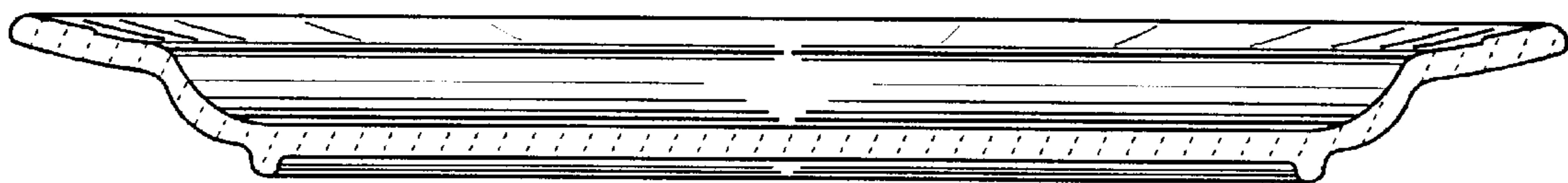
