The ornamental design for a combination grater and strainer, as shown and described.

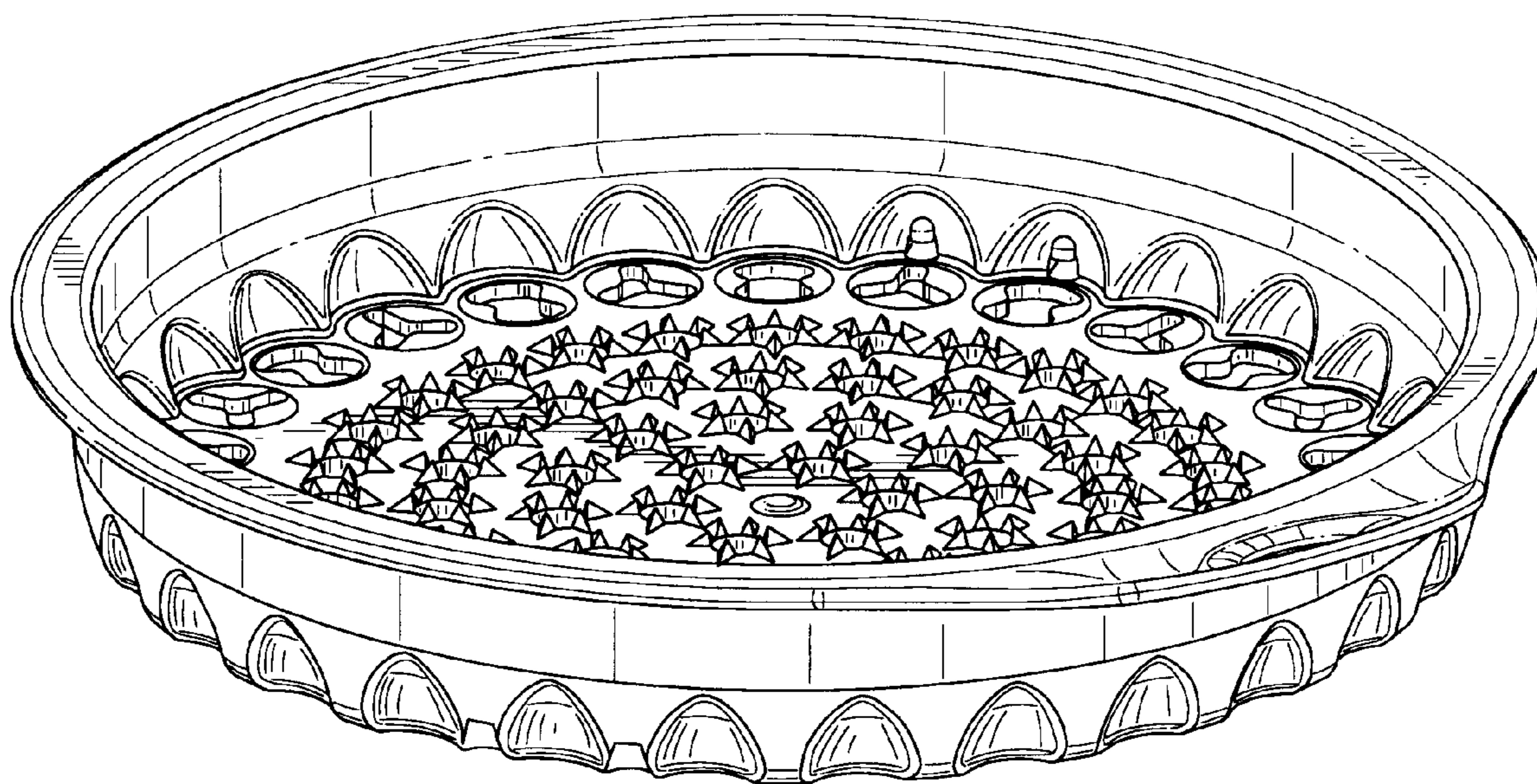
DESCRIPTION

FIG. 1 is a top perspective view of the combination grater and strainer showing my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevation view thereof, the opposite side being substantially a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a front elevation view thereof; and, FIG. 7 is a rear elevation view thereof.

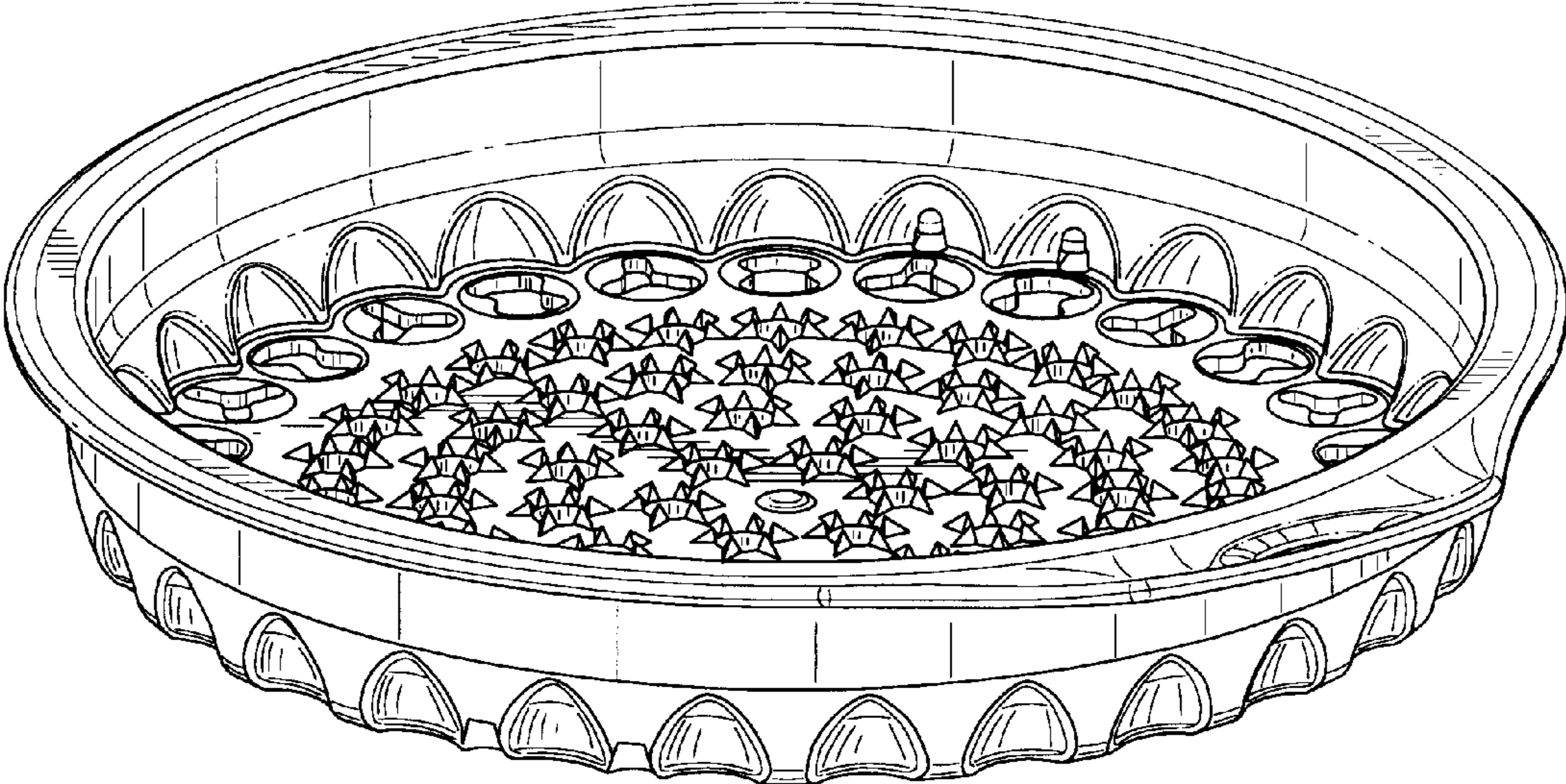

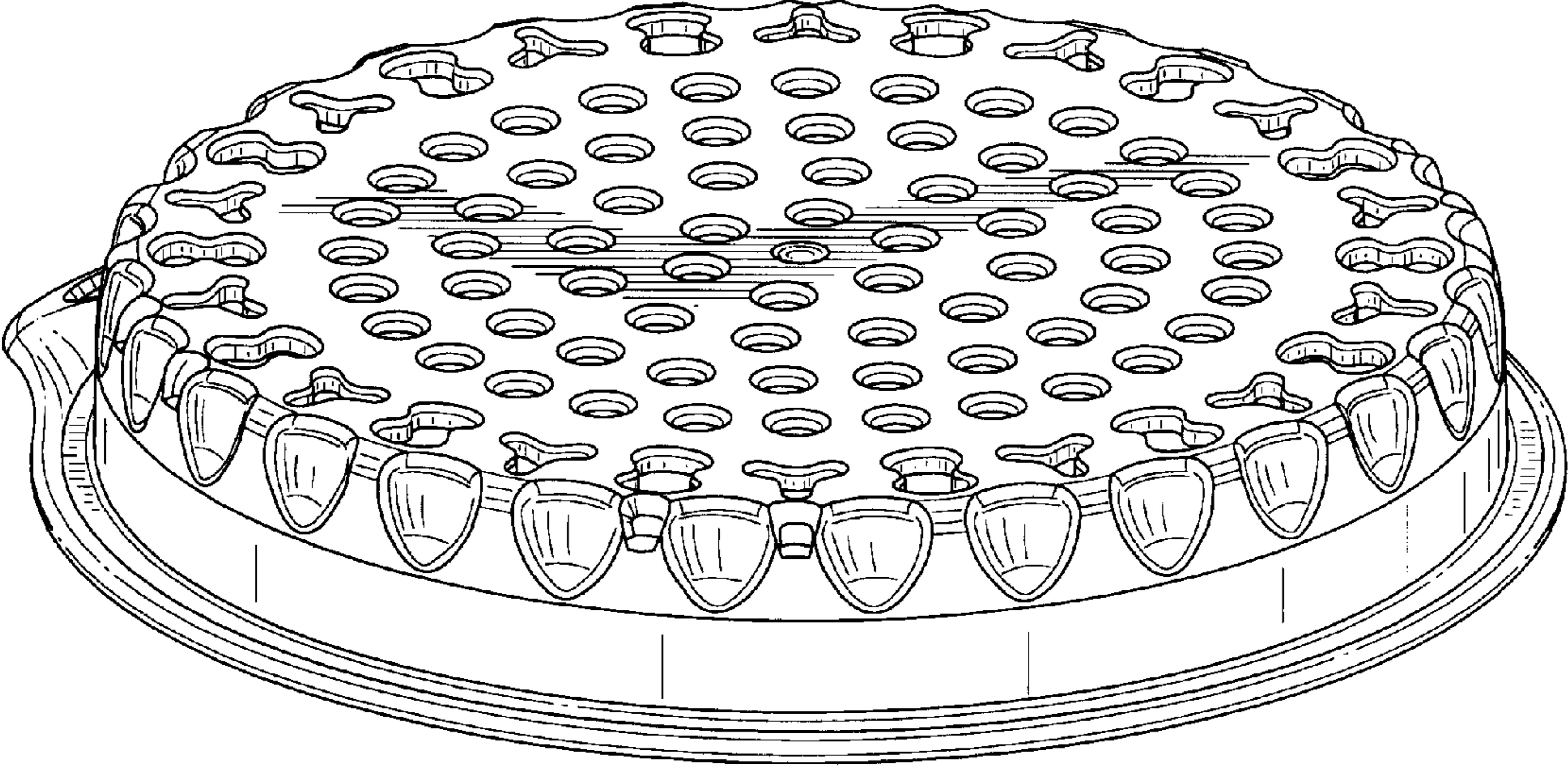

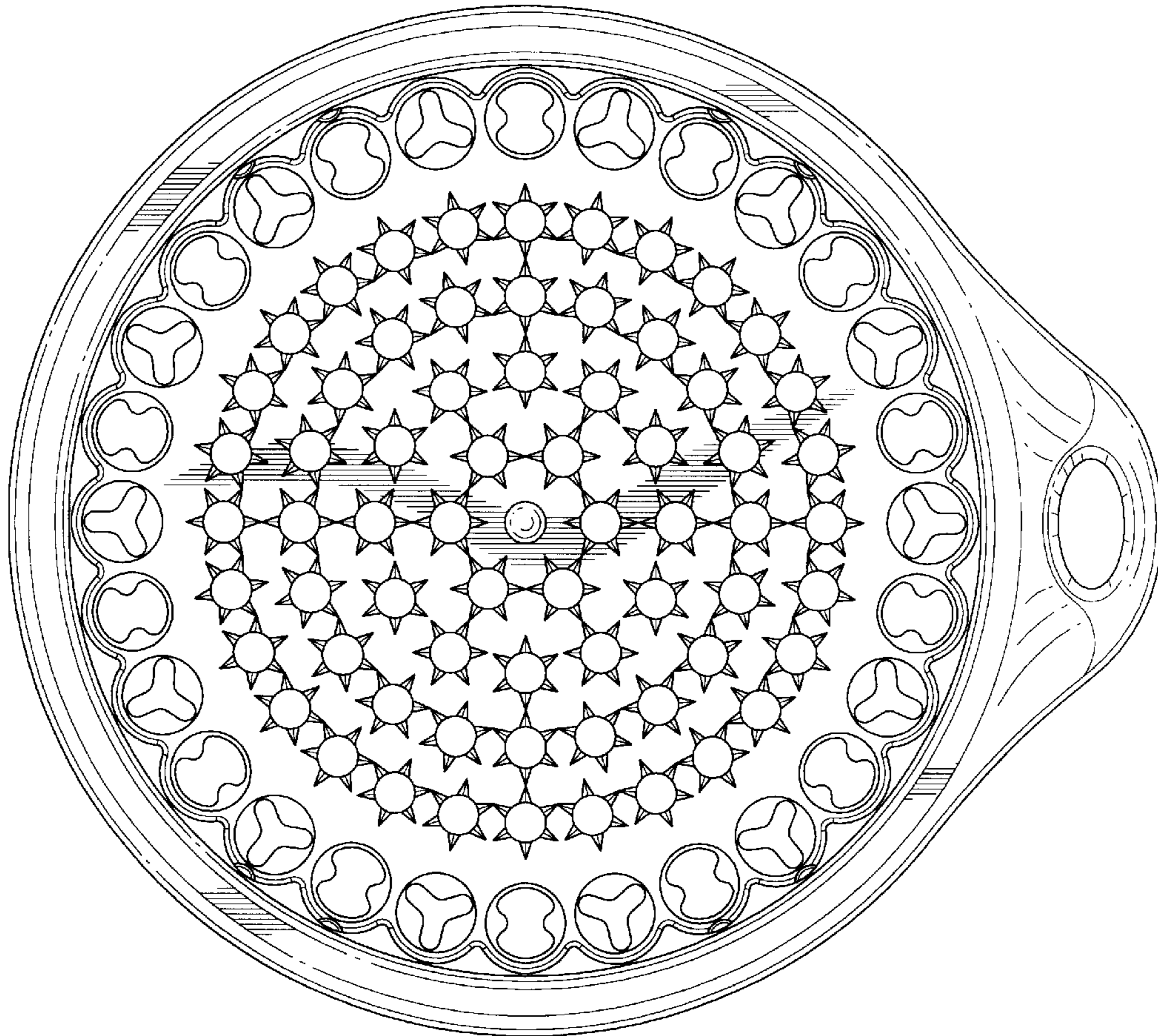

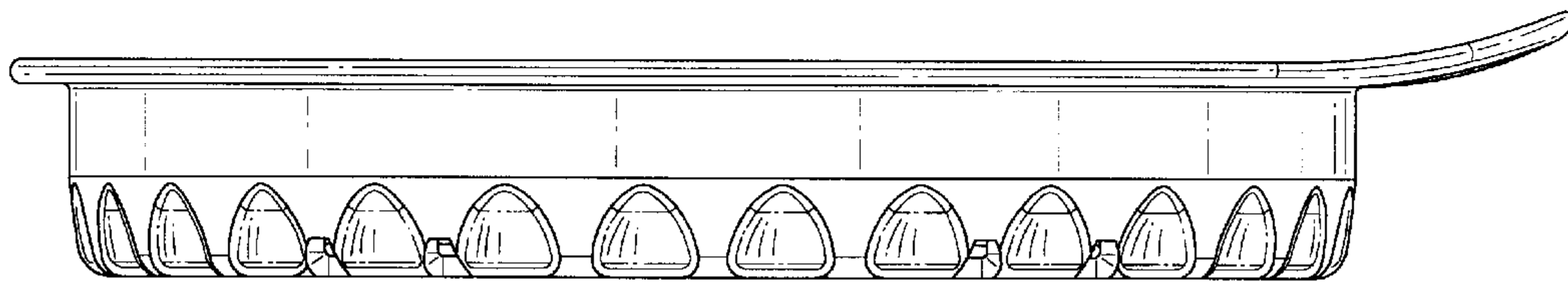

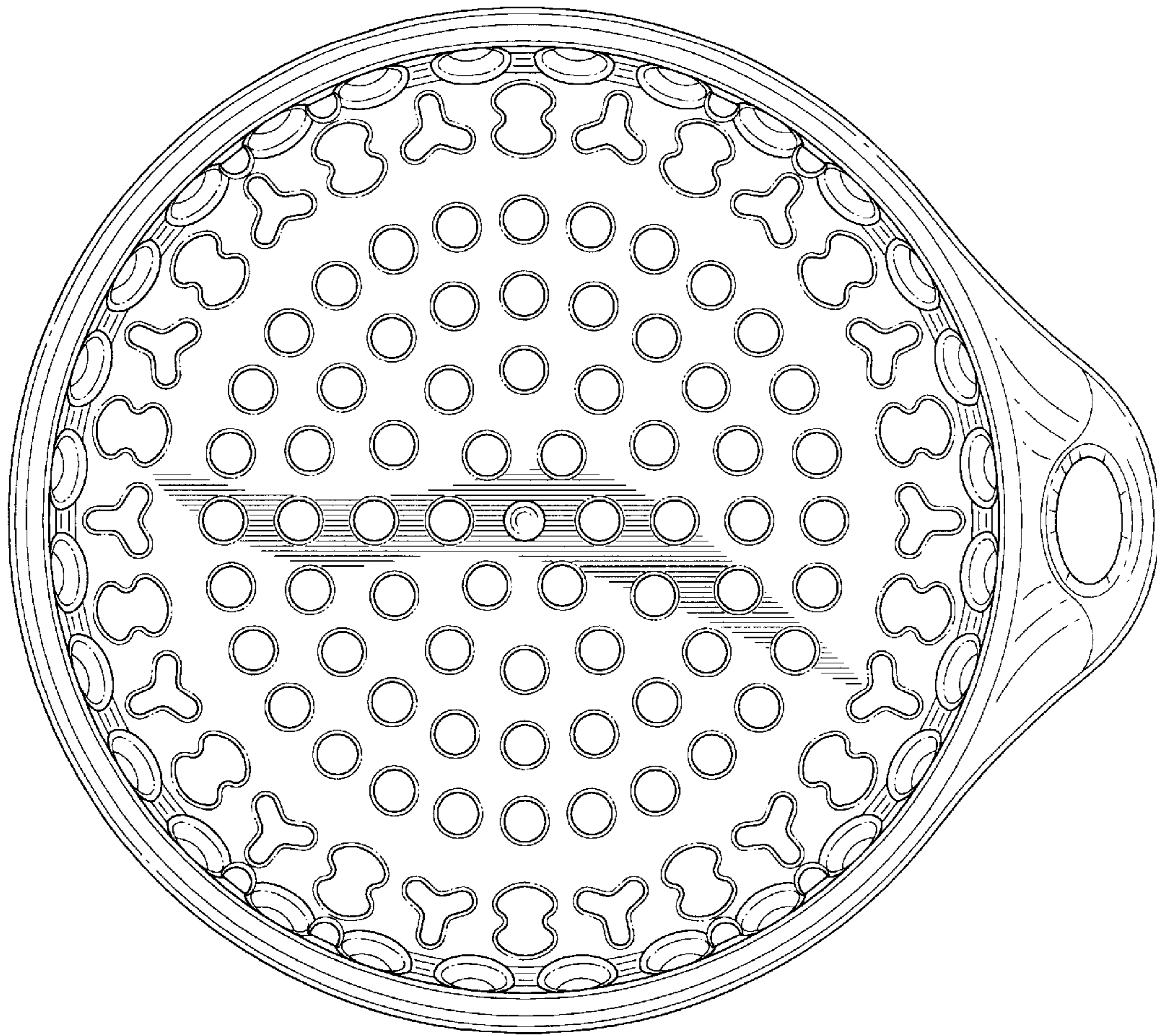

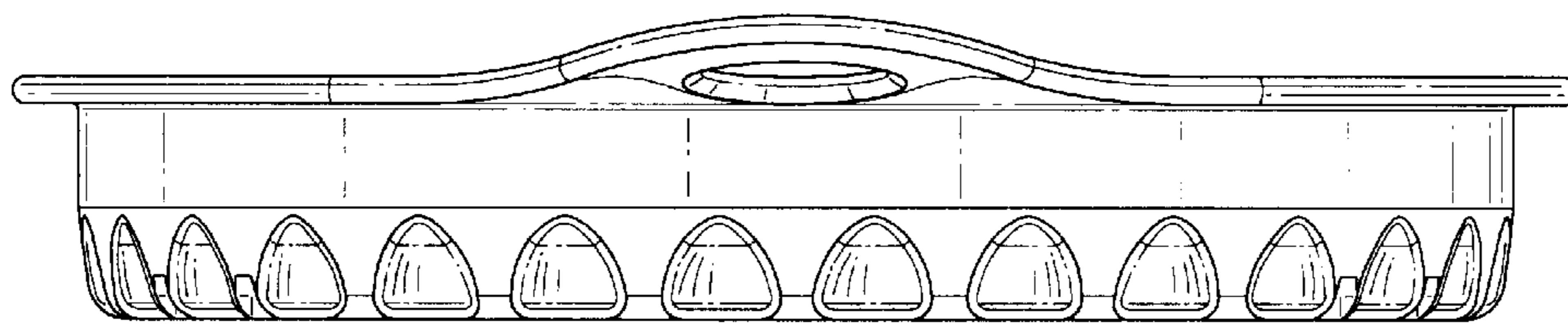

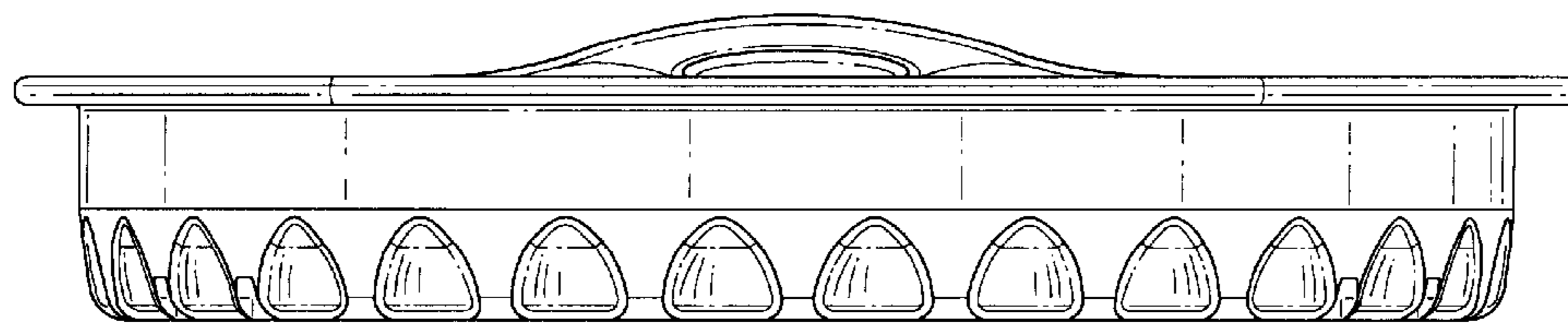
