FIG. 3 is a right side view of the clip of FIG. 1;

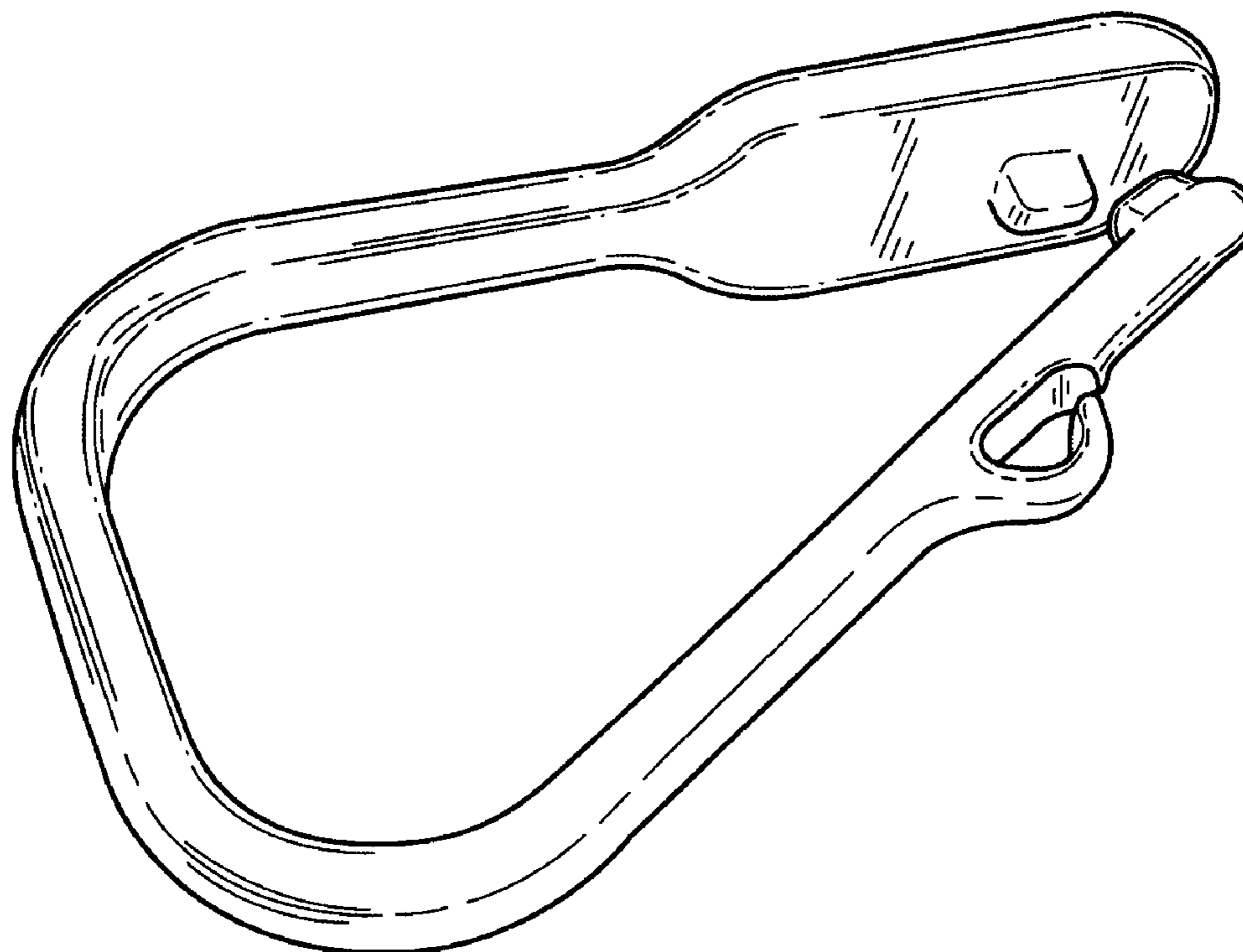
FIG. 4 is a back view of the clip of FIG. 1;

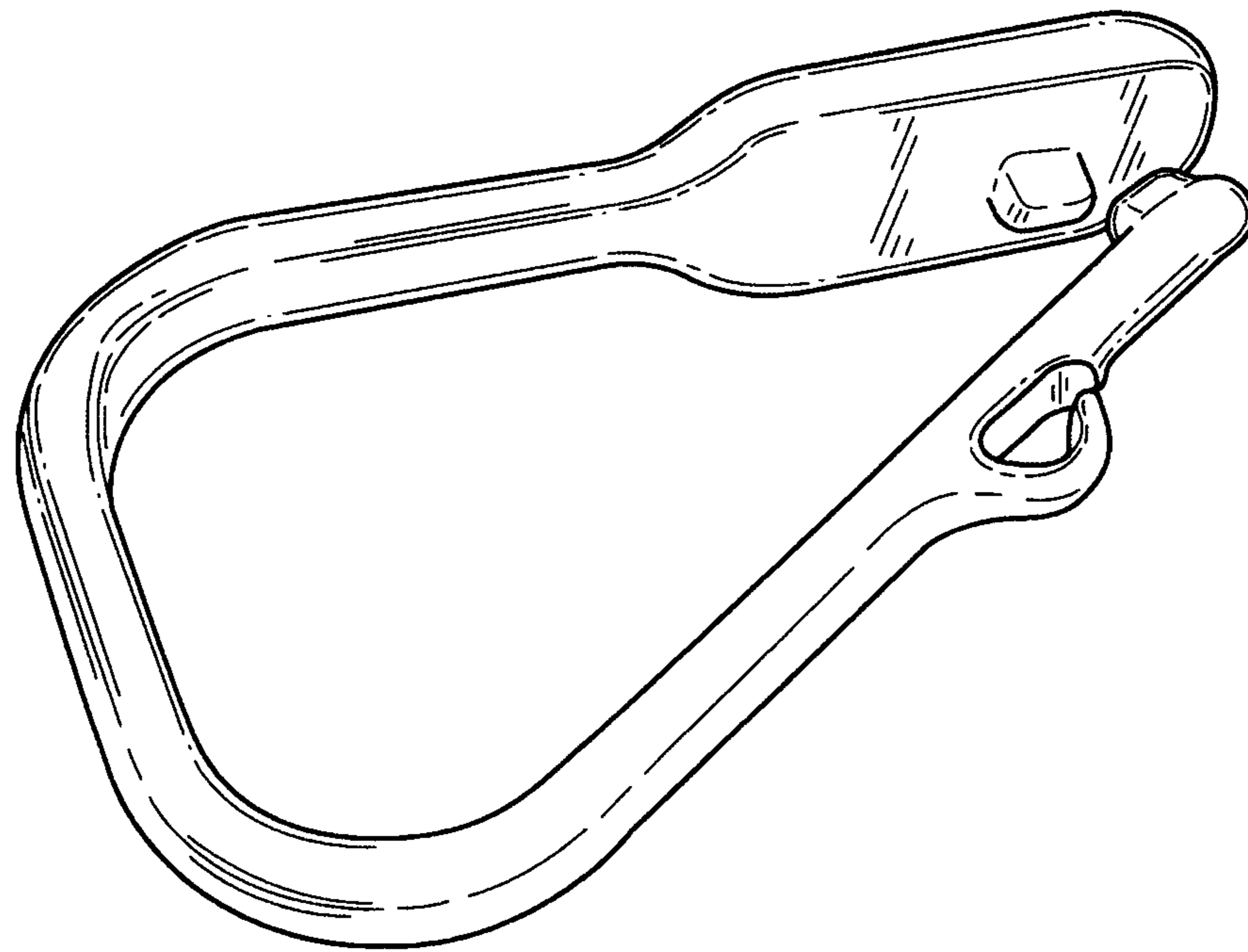

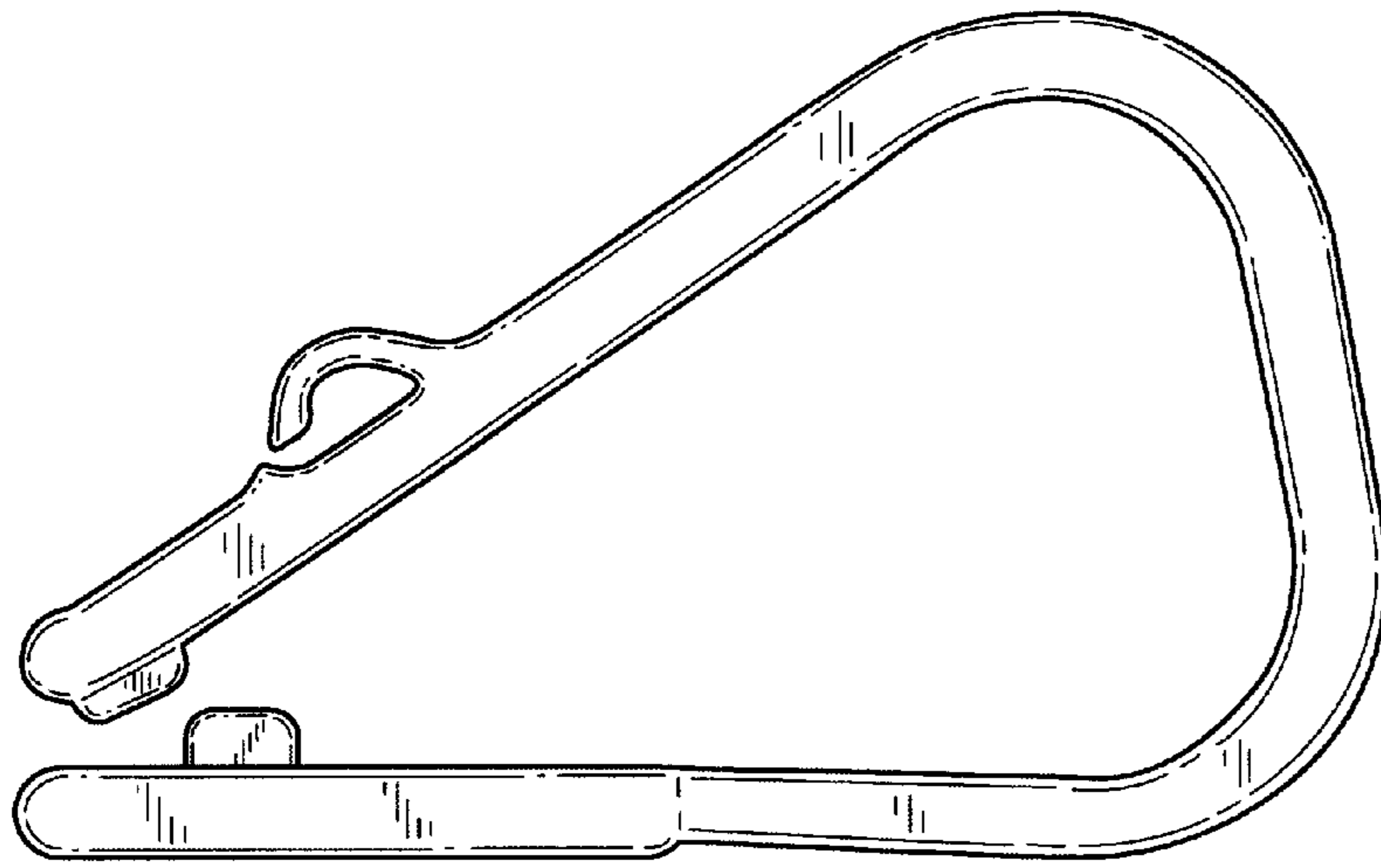

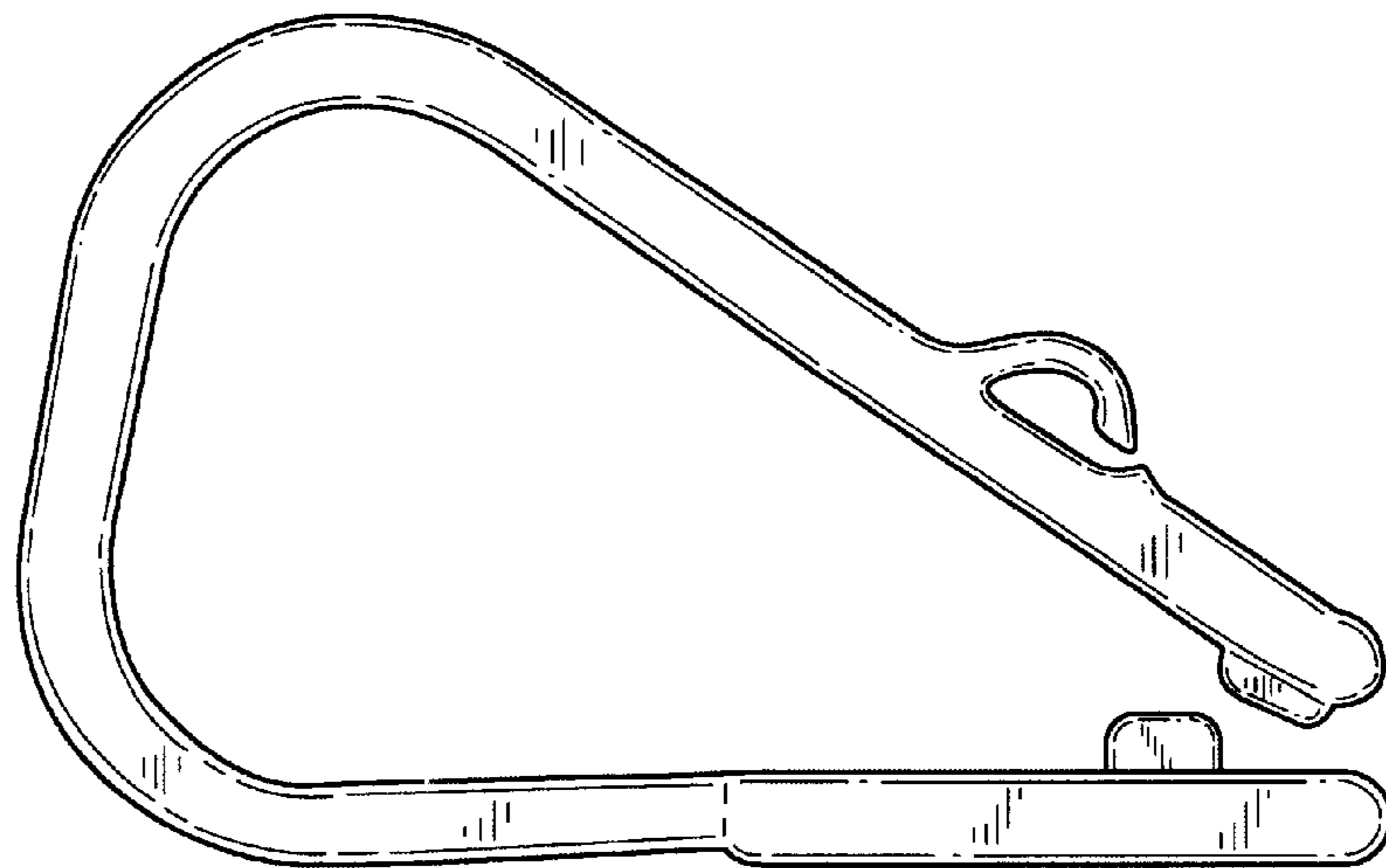

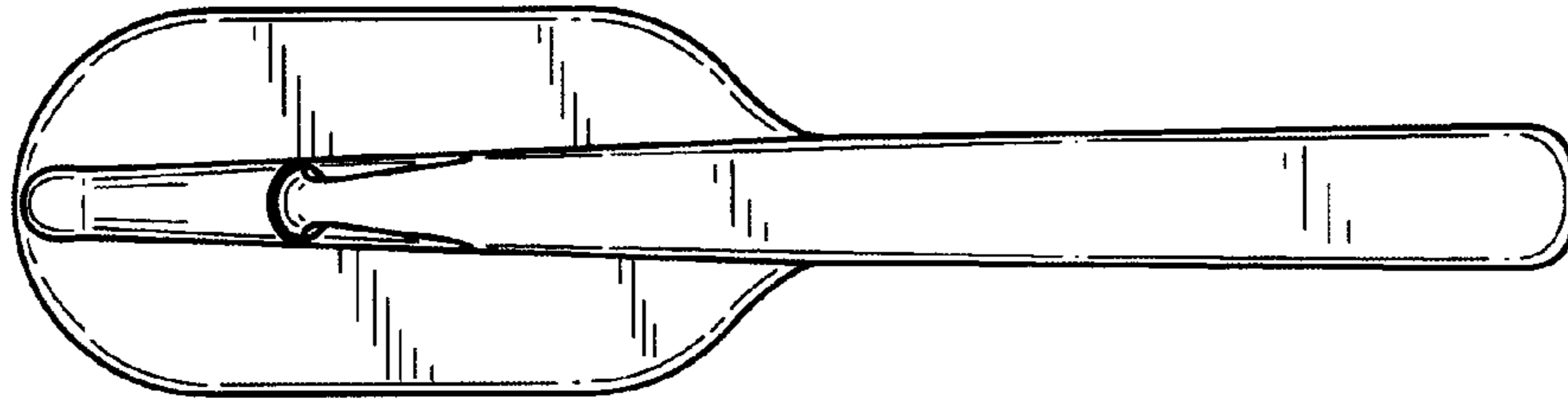

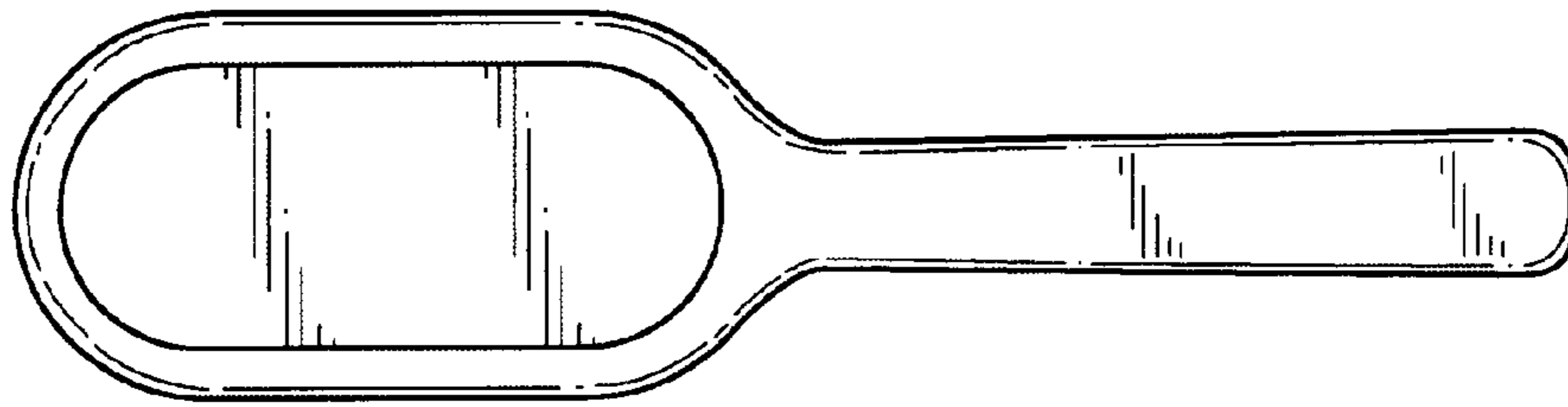

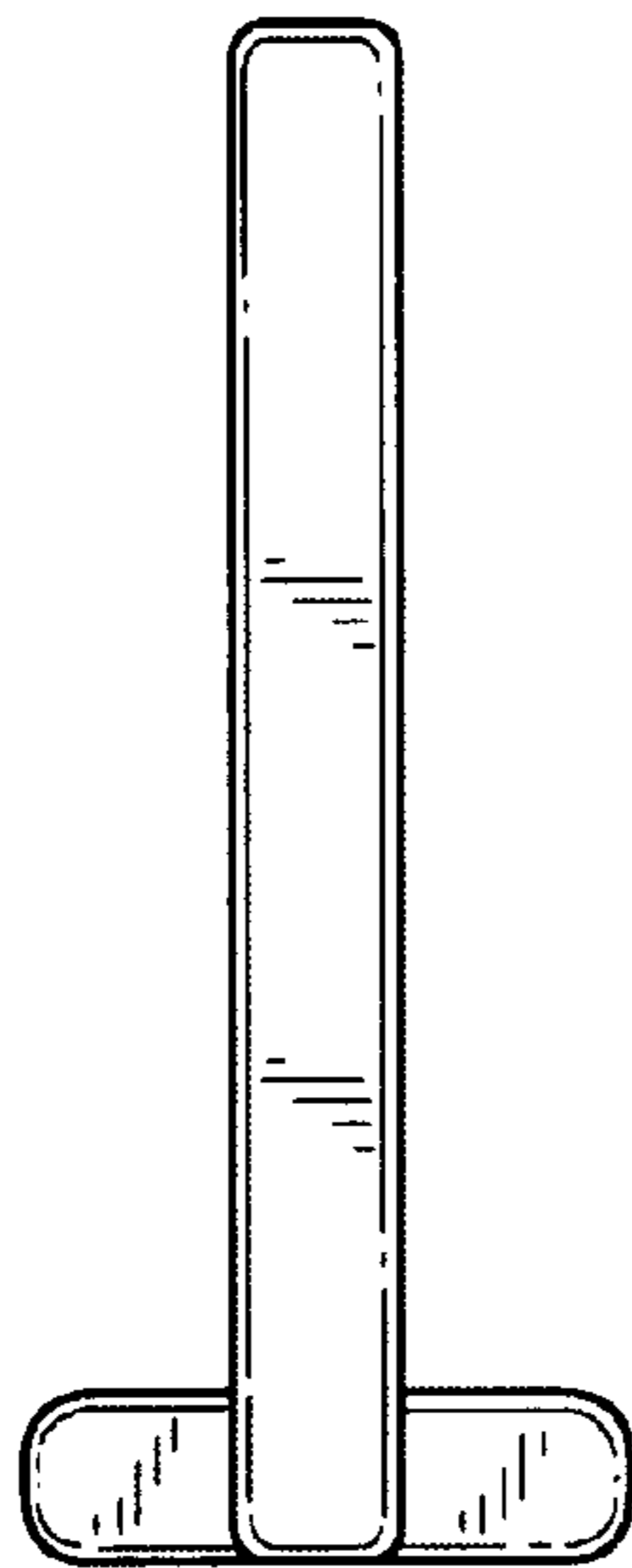

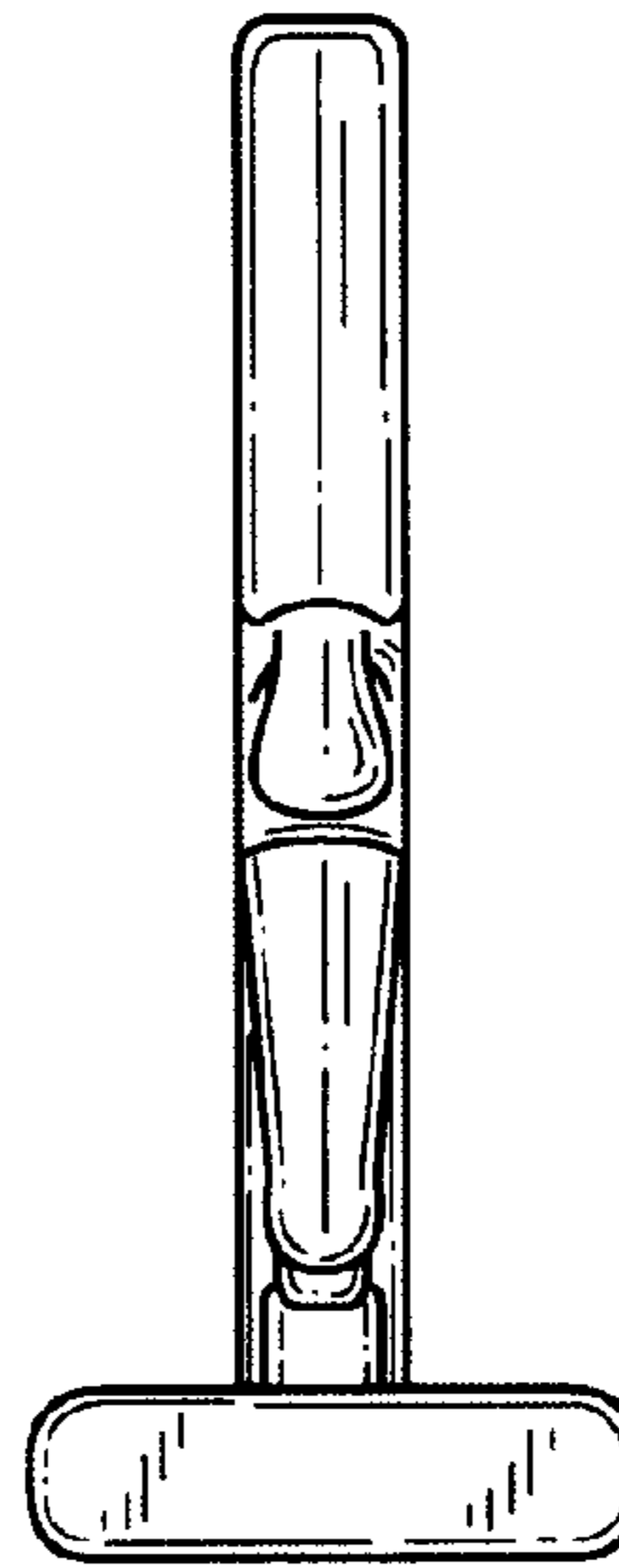
