(57) **CLAIM**

An ornamental design for a package cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a package cap in accordance with our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view, the right side elevational view being a mirror image thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a perspective view of the package cap in an open position.
The broken line showing further details of the package cap are for illustrative purposes only and form no part of the claimed design.

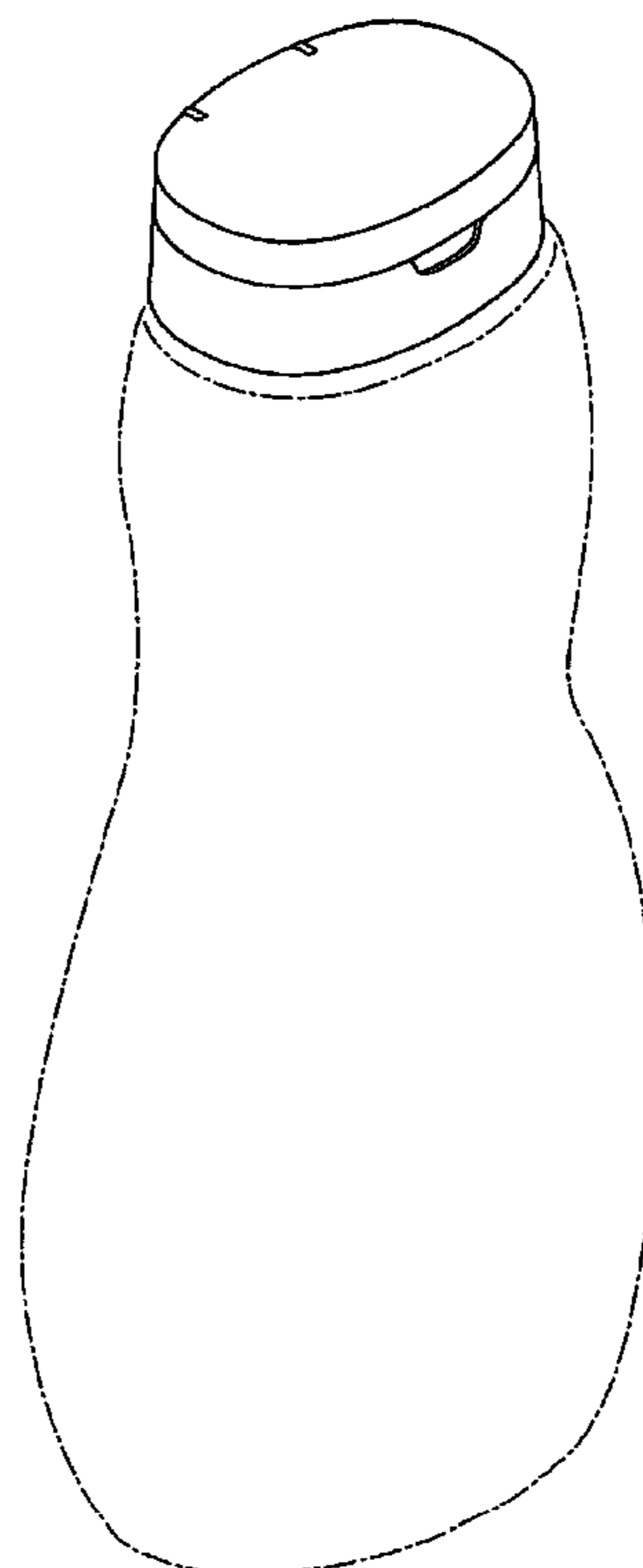

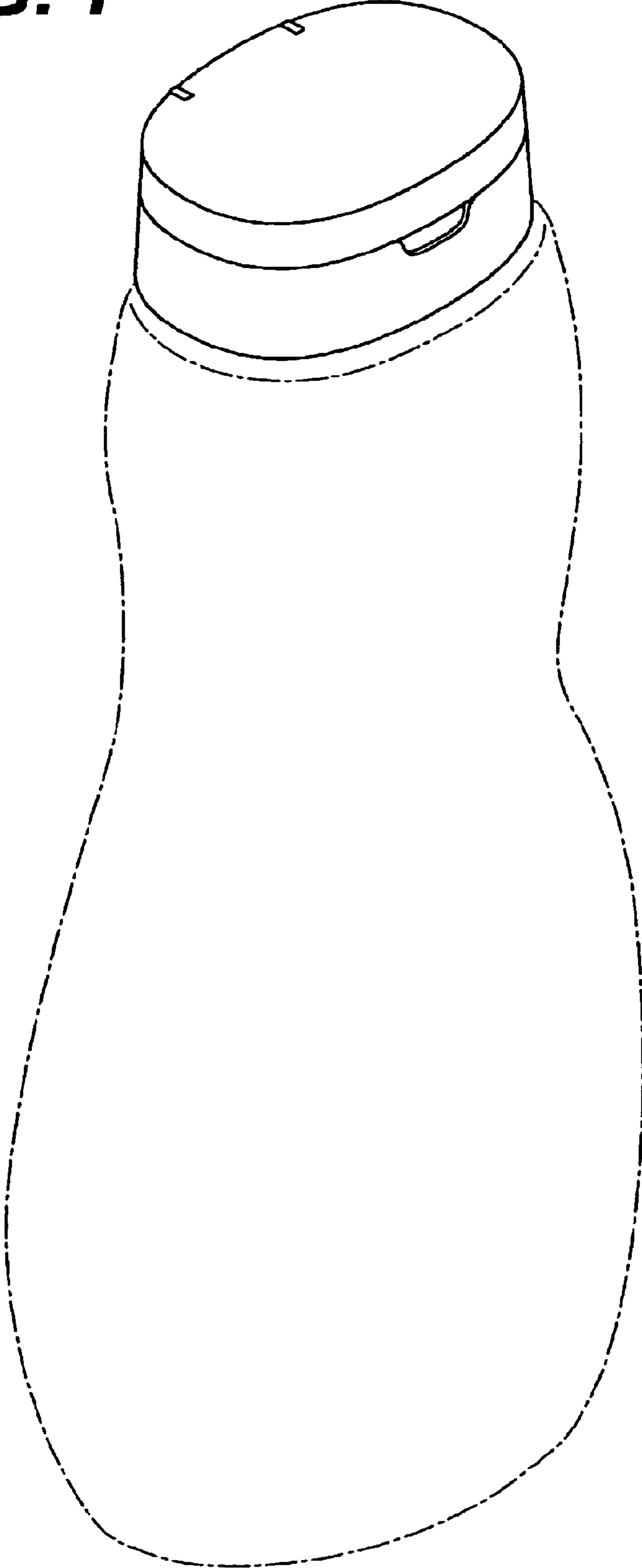

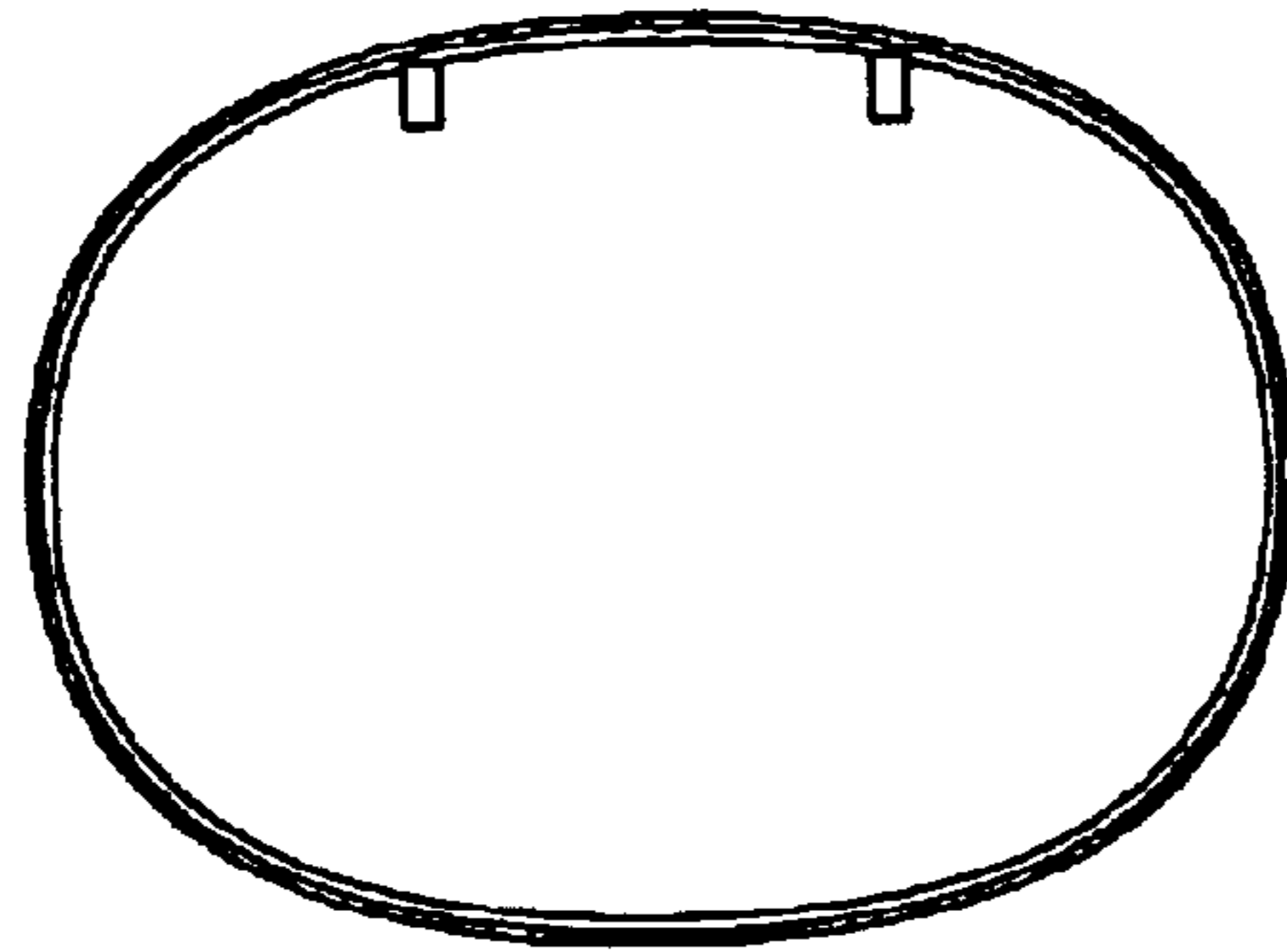

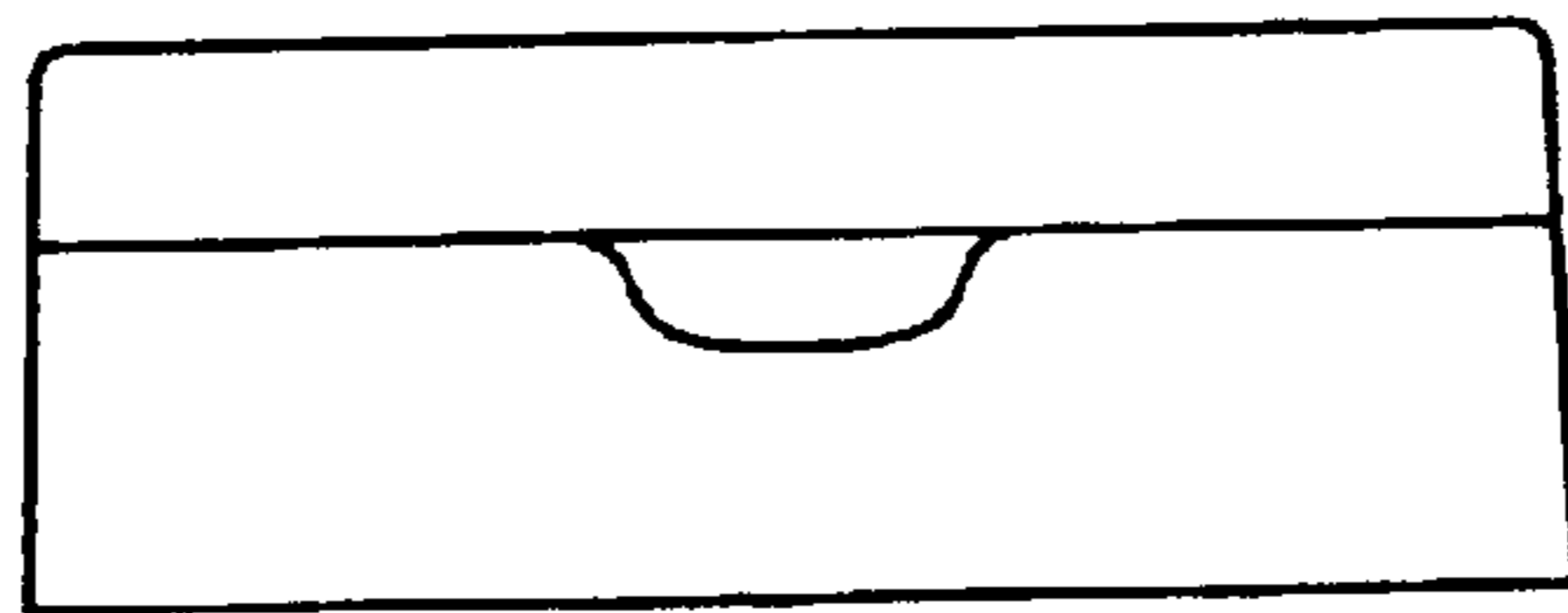

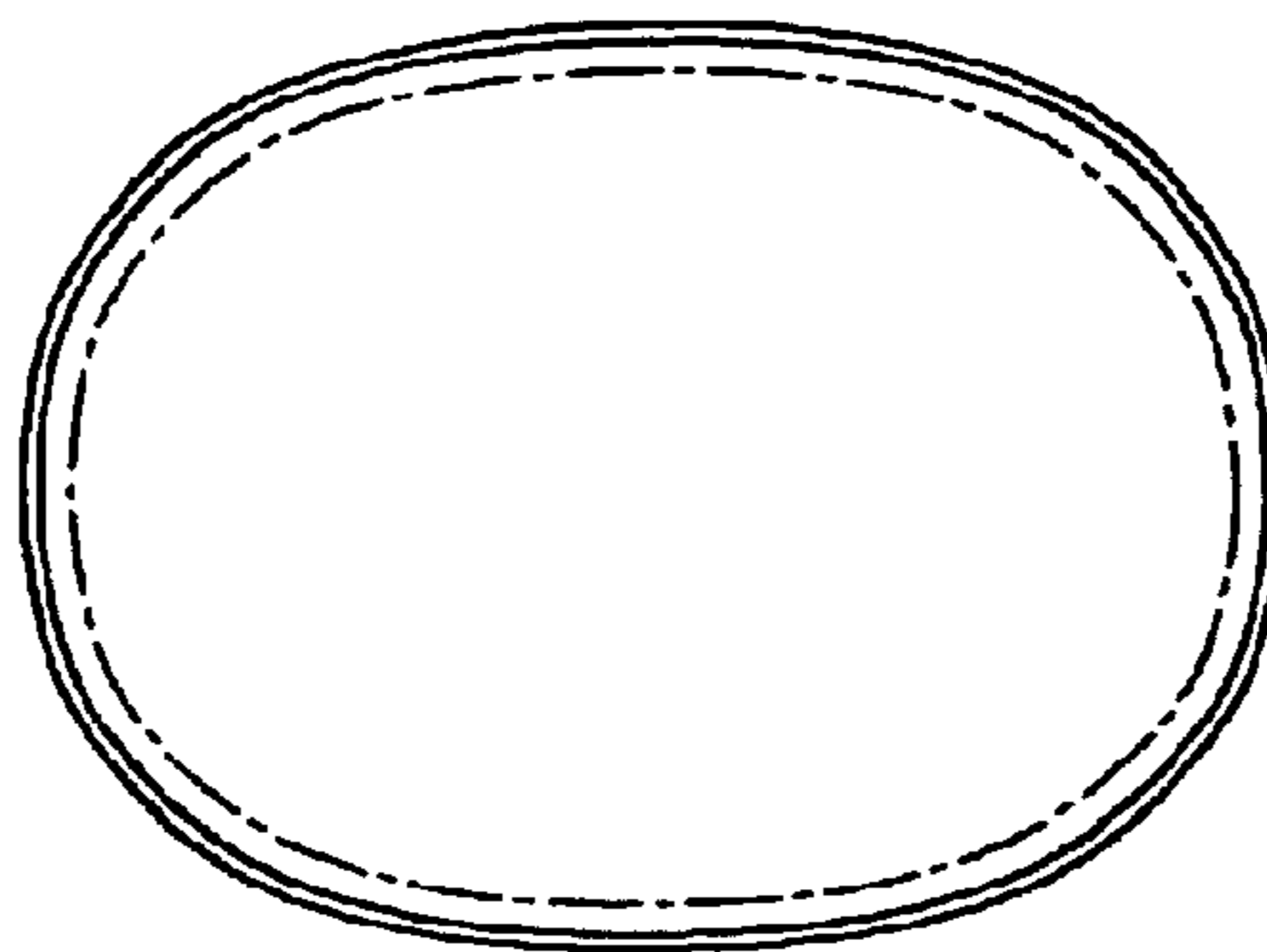
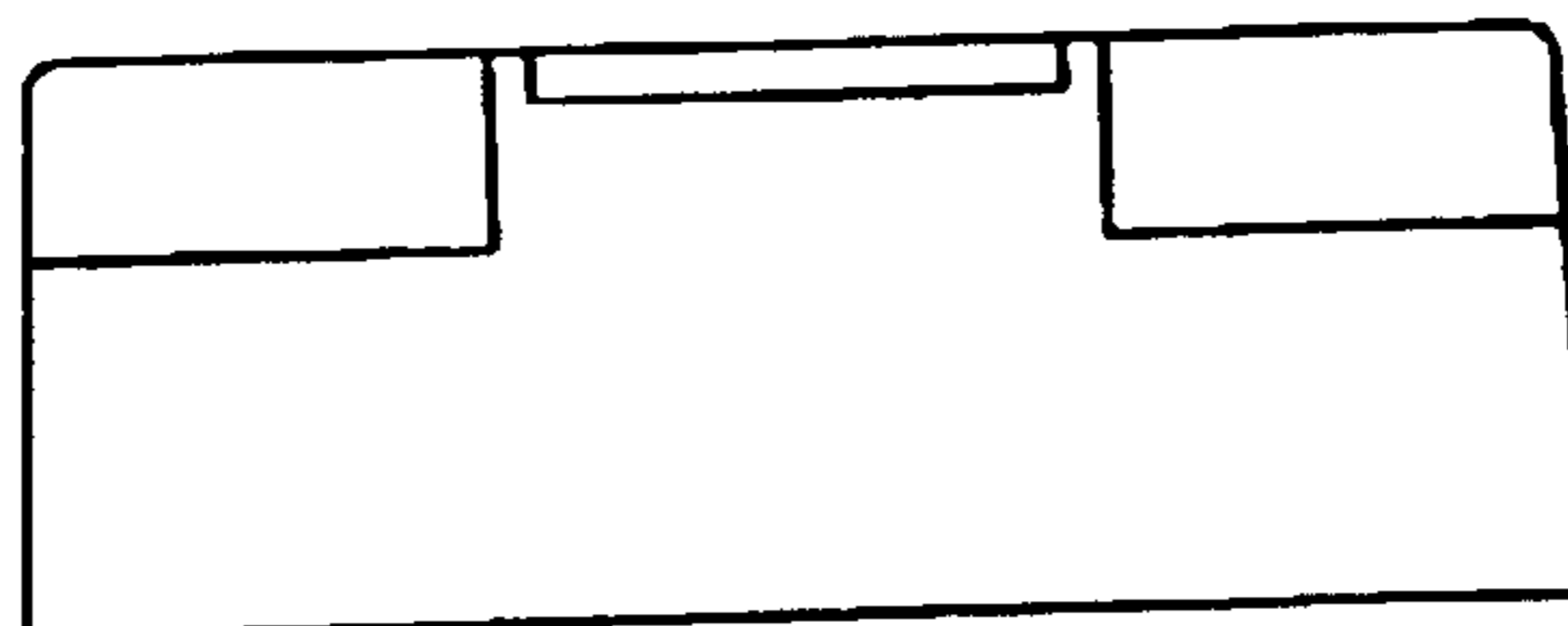

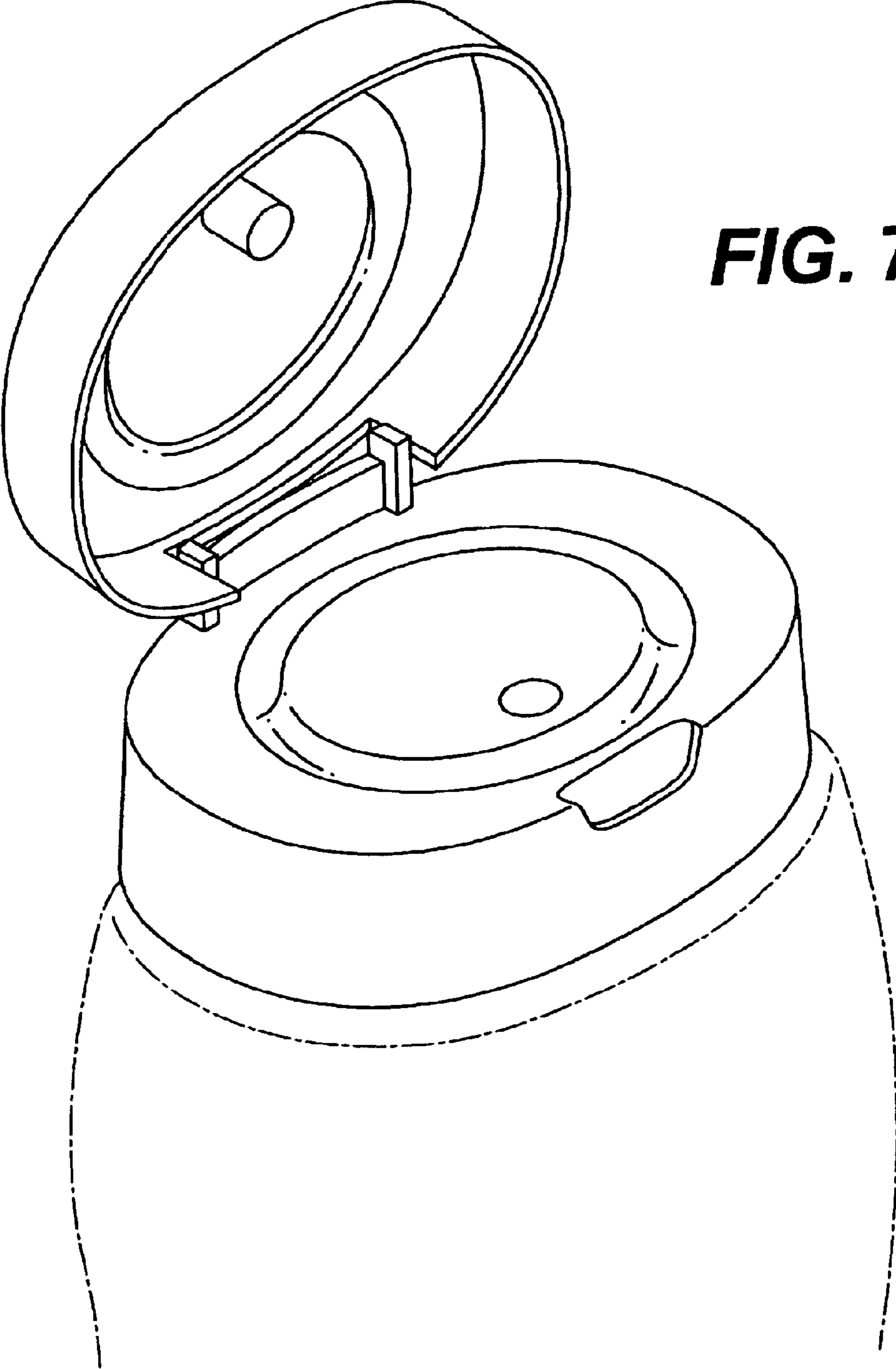
