the bottle showing the new design;

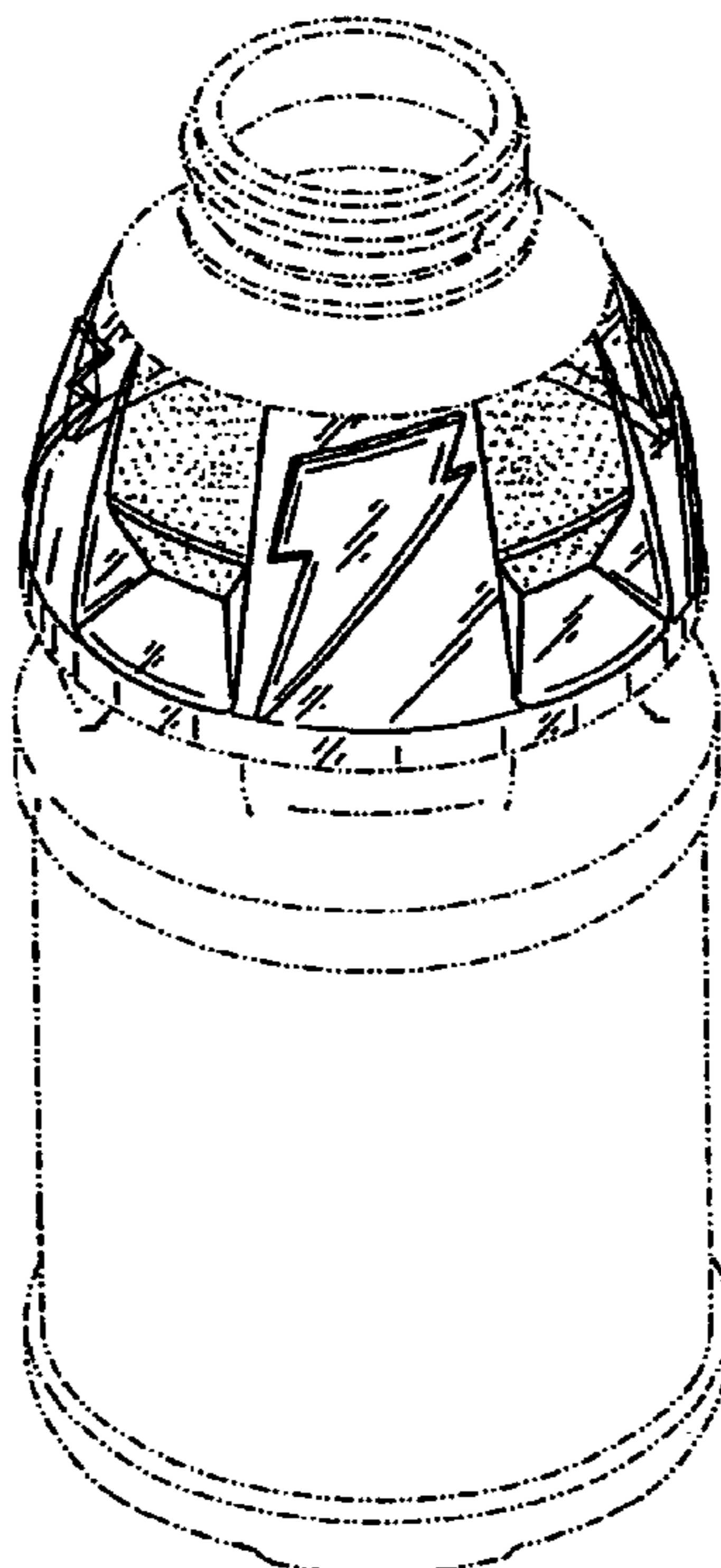
FIG. 6 is an elevational view of the FIG. 5 embodiment;

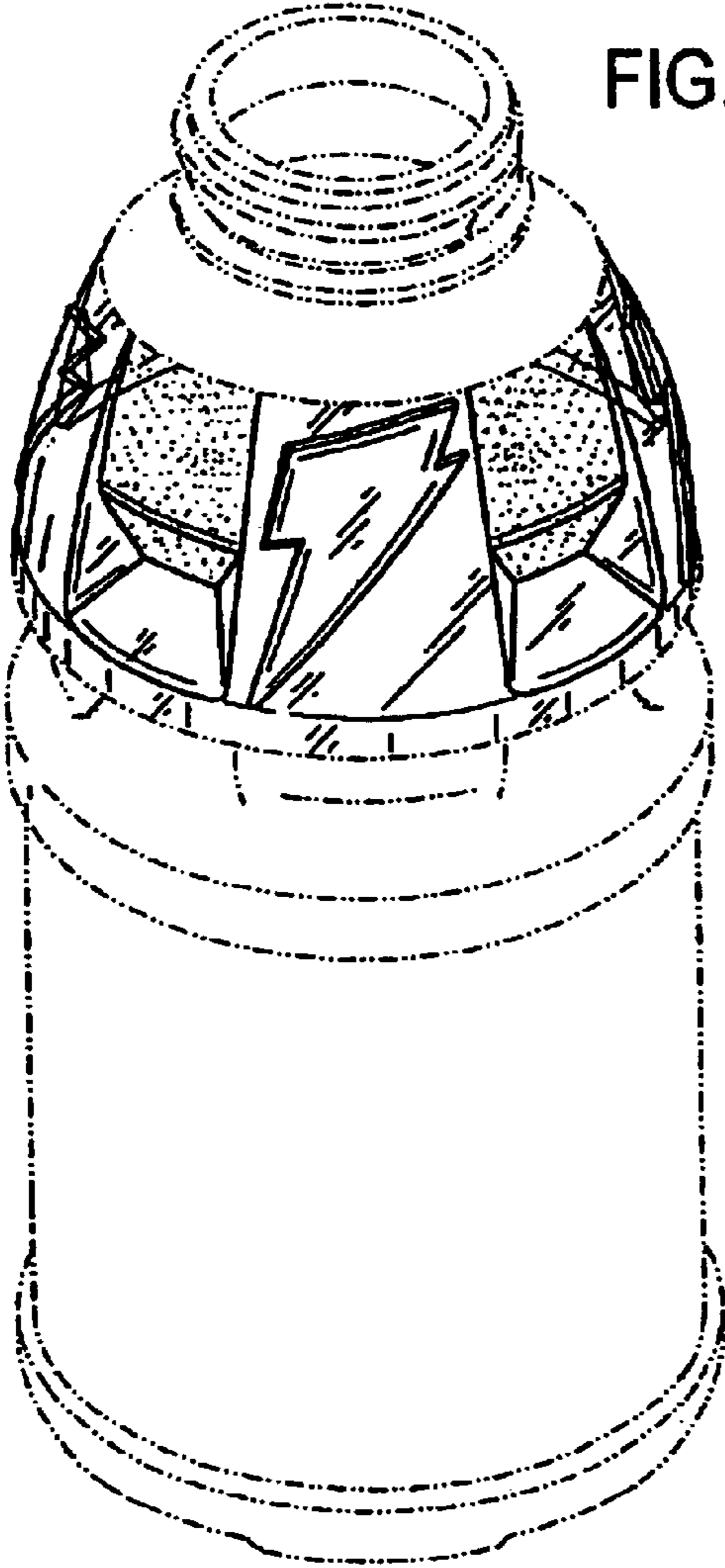

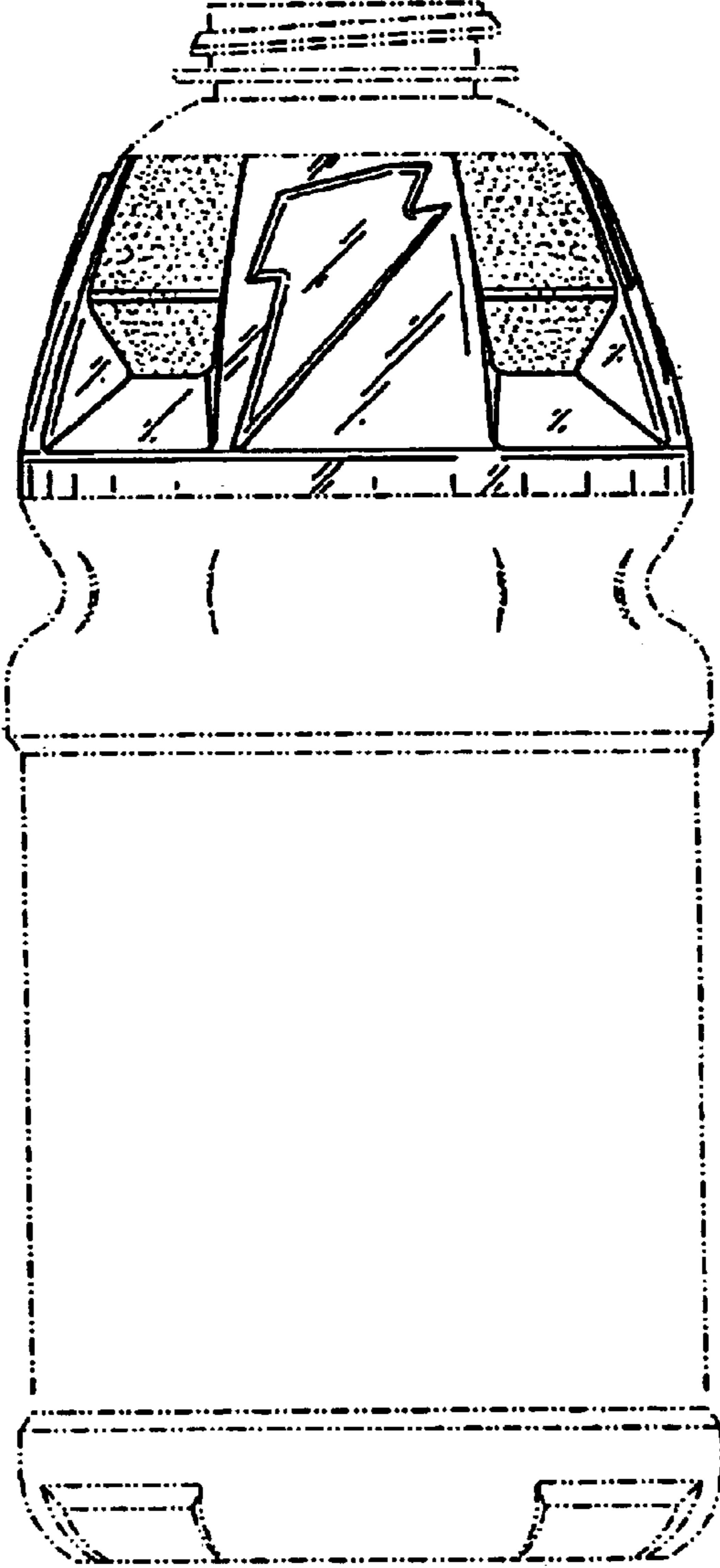

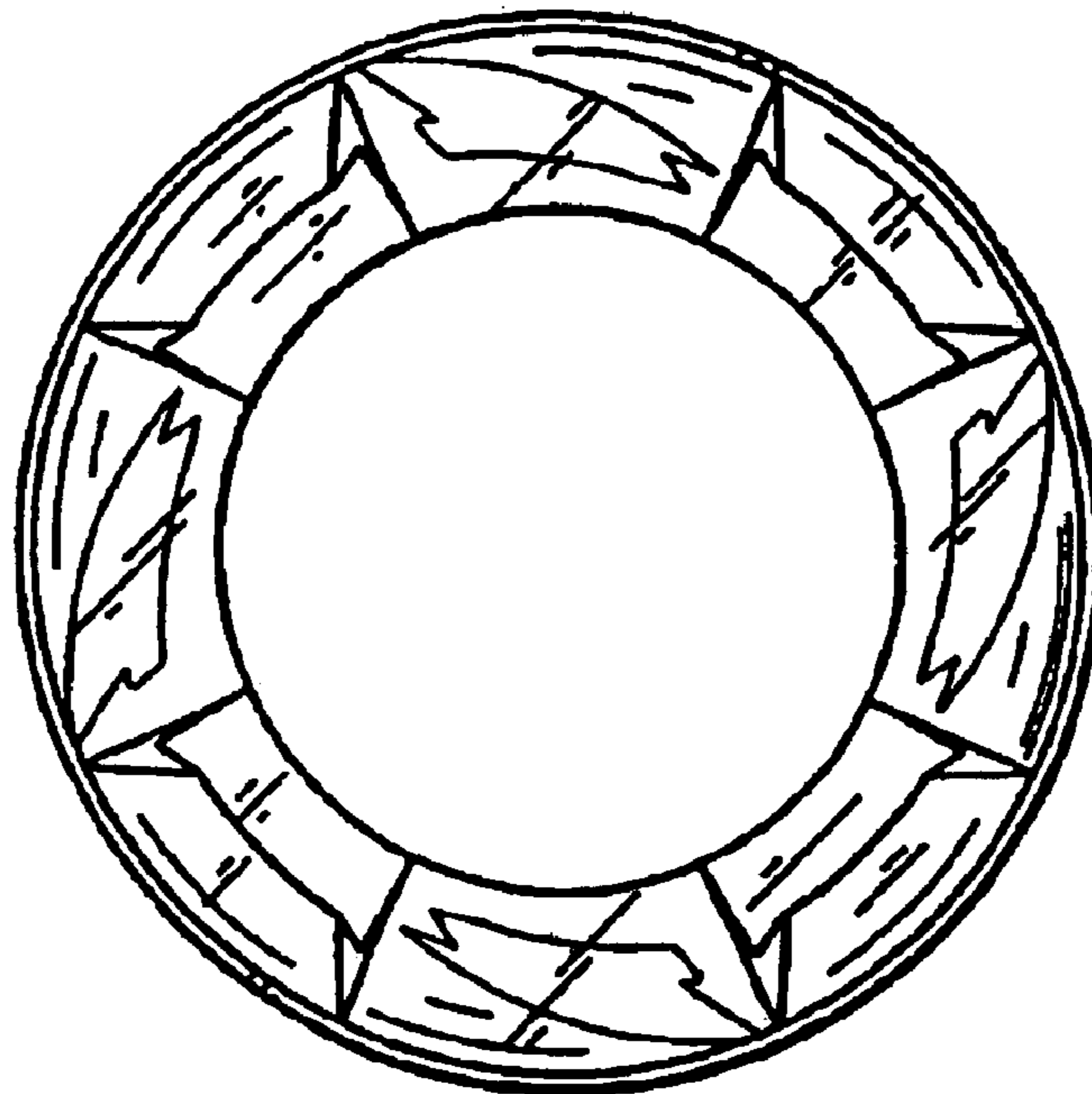

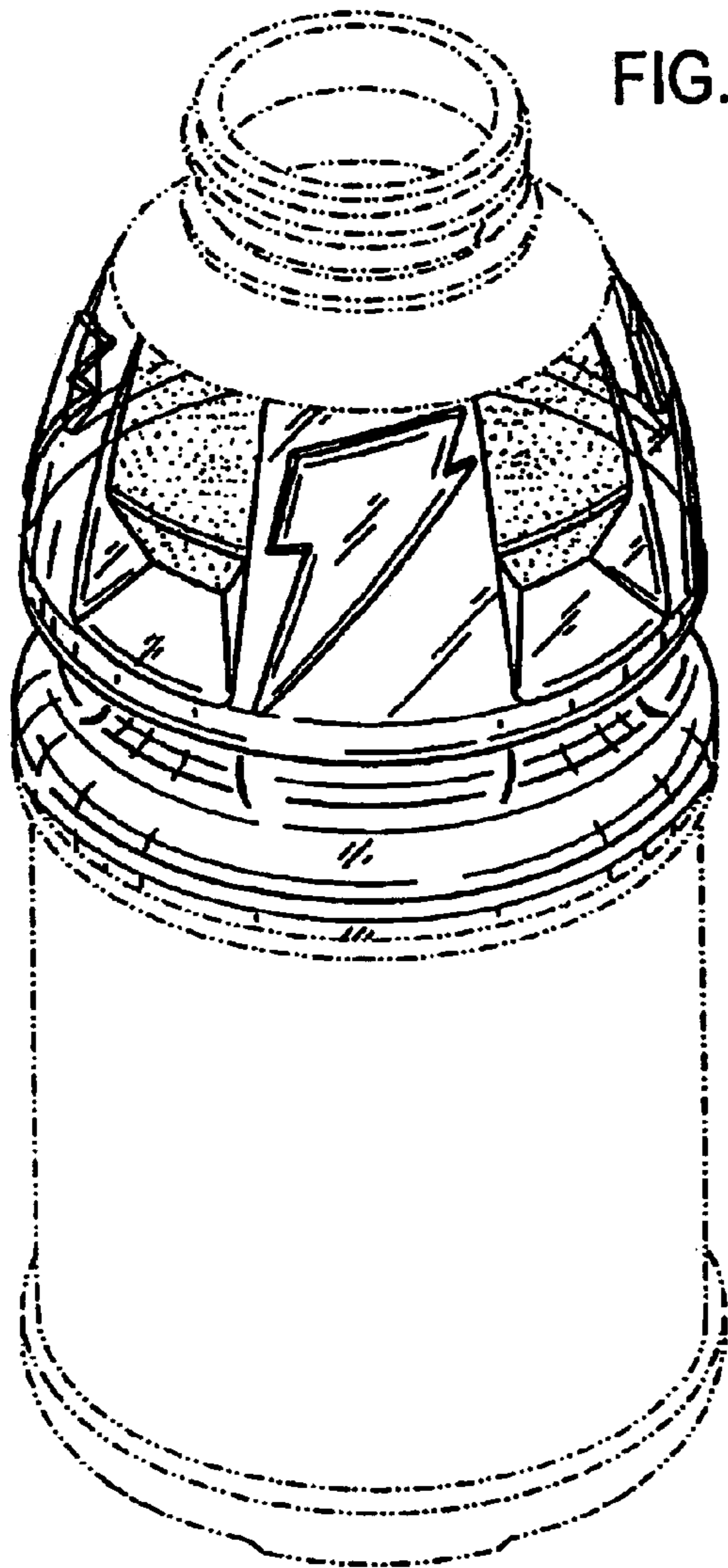

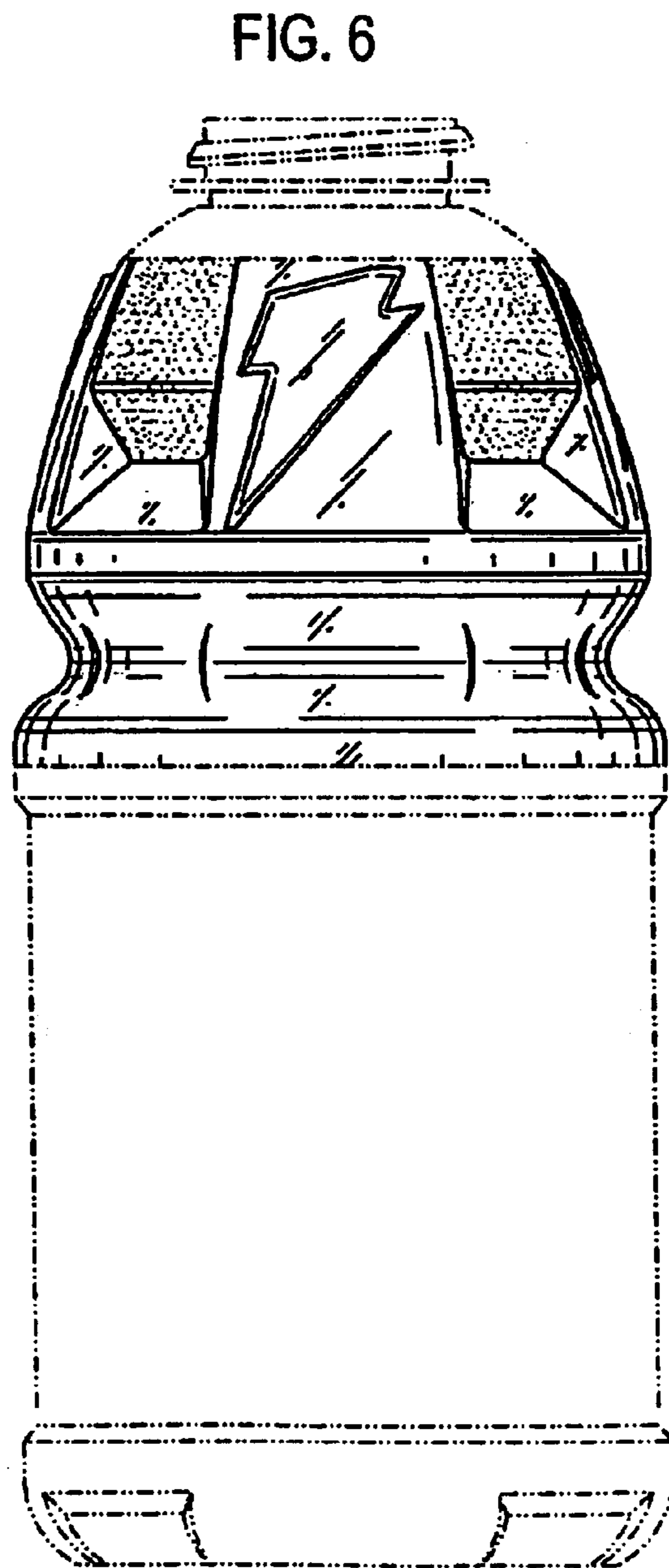

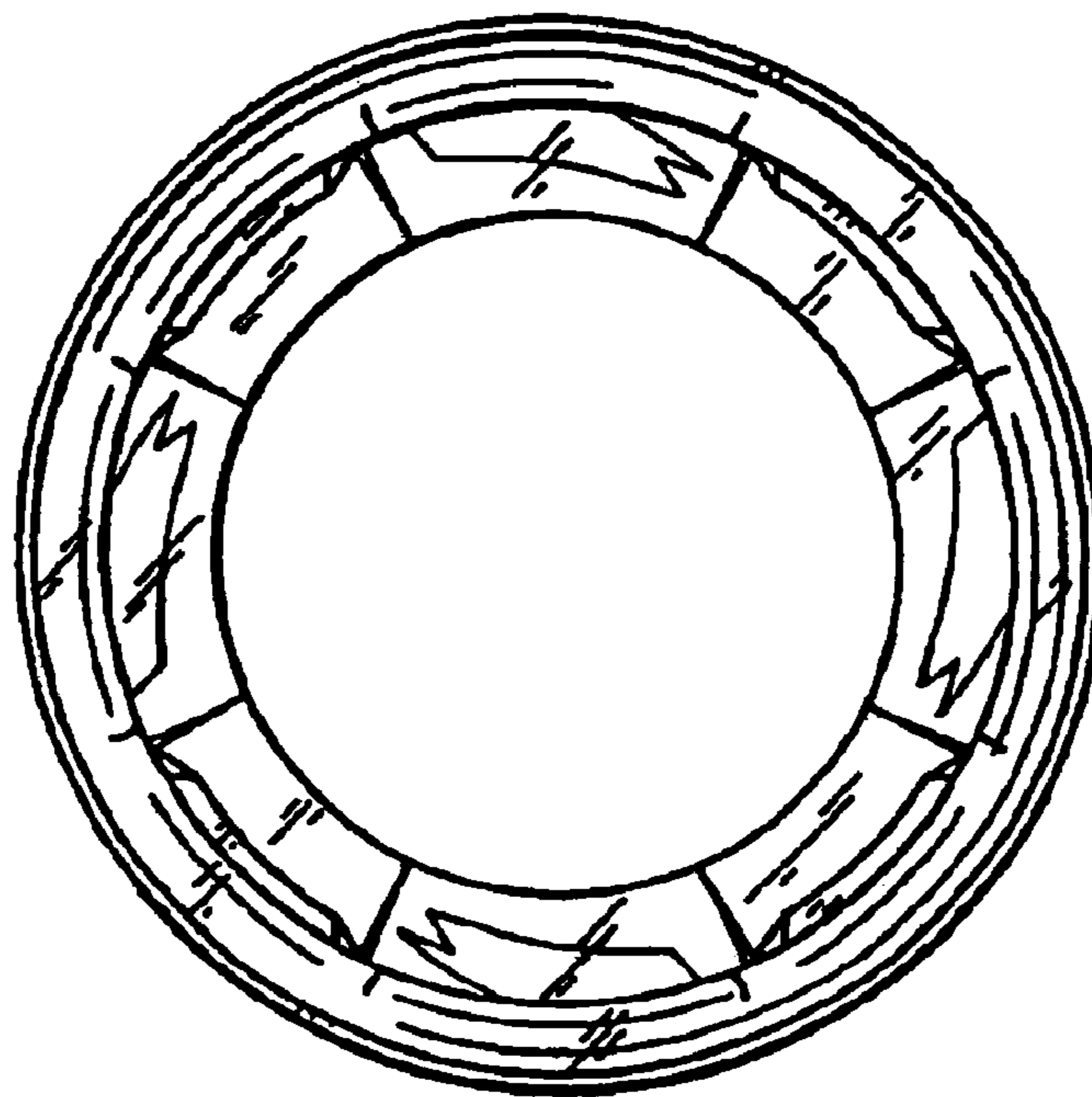
