(57) **CLAIM**

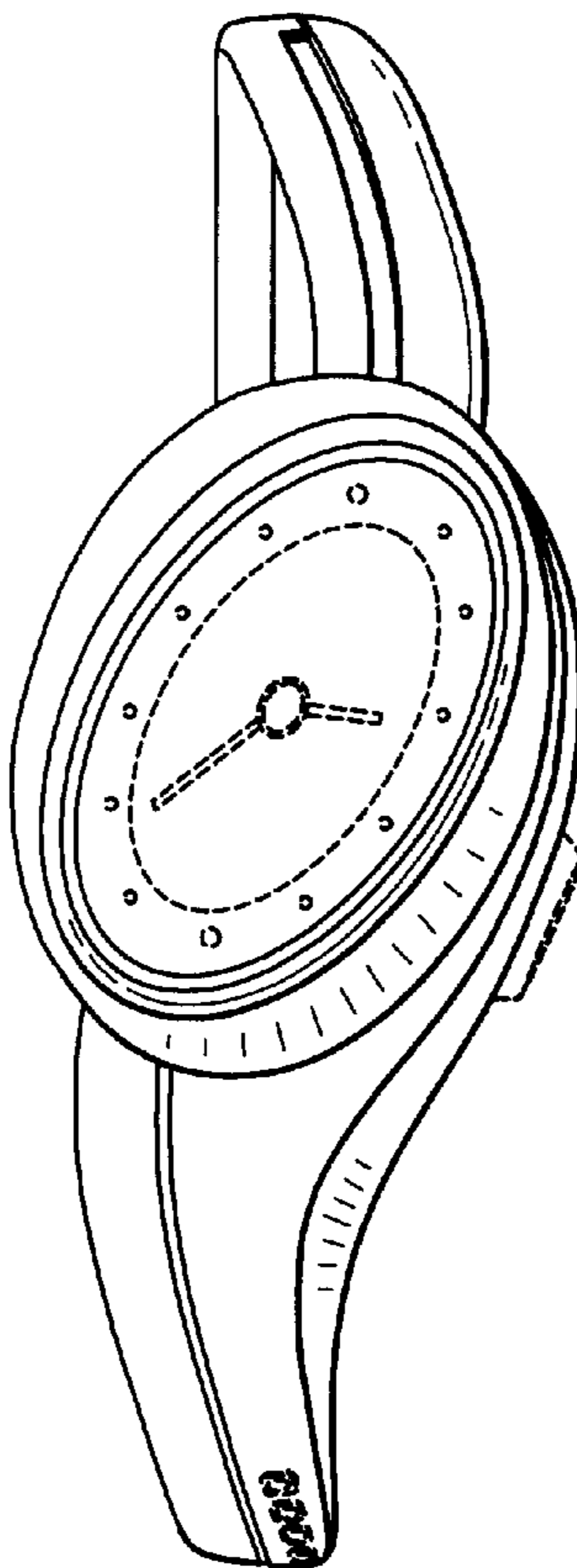
The ornamental design for a wrist watch, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the design of a wrist watch; FIG. 2 is a front view of the design of a wrist watch; FIG. 3 is a back view of the design of a wrist watch; FIG. 4 is a top view of the design of a wrist watch; FIG. 5 is a bottom view of the design of a wrist watch; FIG. 6 is one side view of the design of a wrist watch; and, FIG. 7 is the opposite side view of the design of a wrist watch.

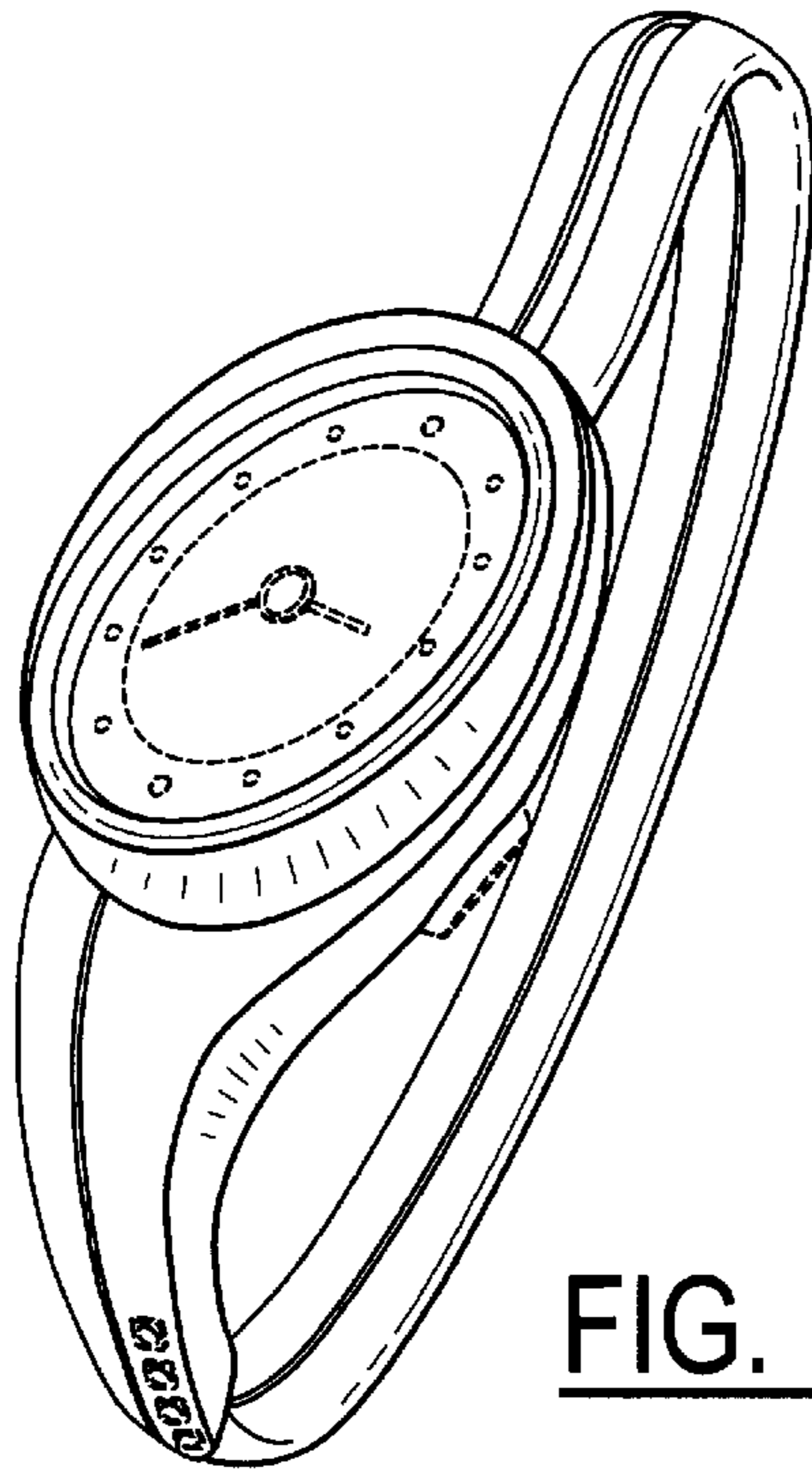

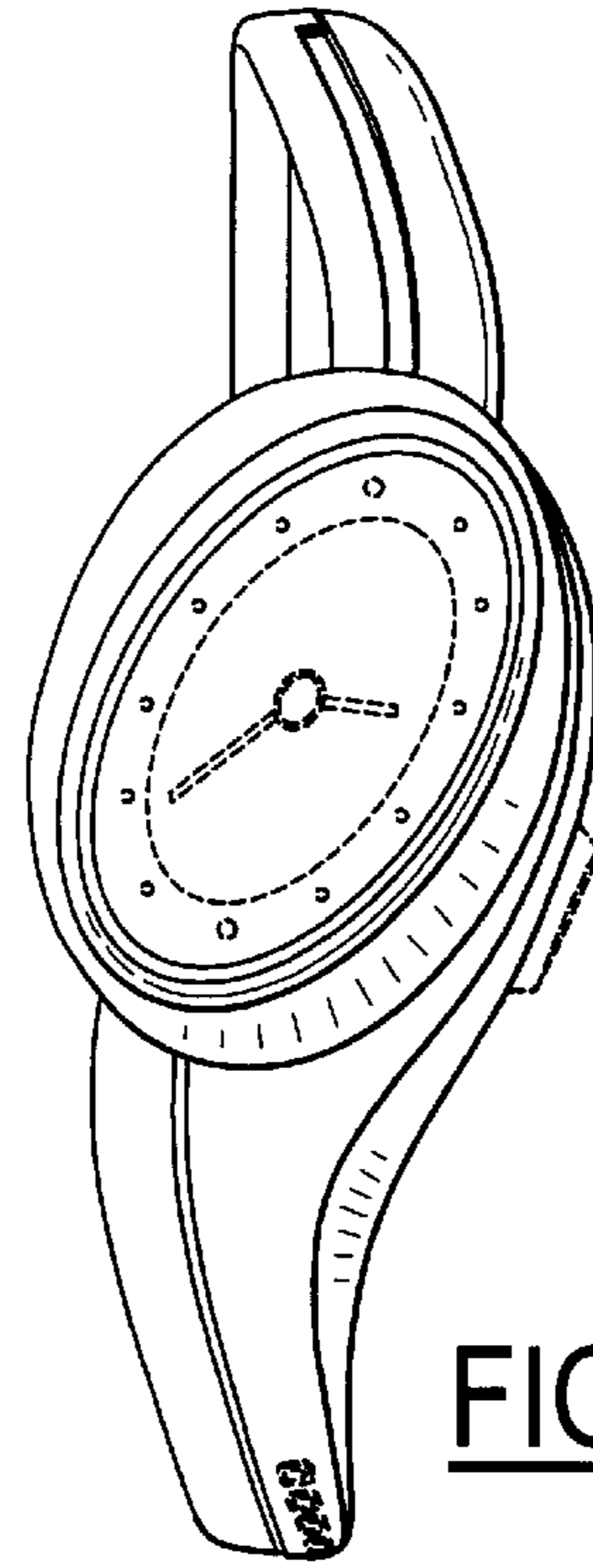

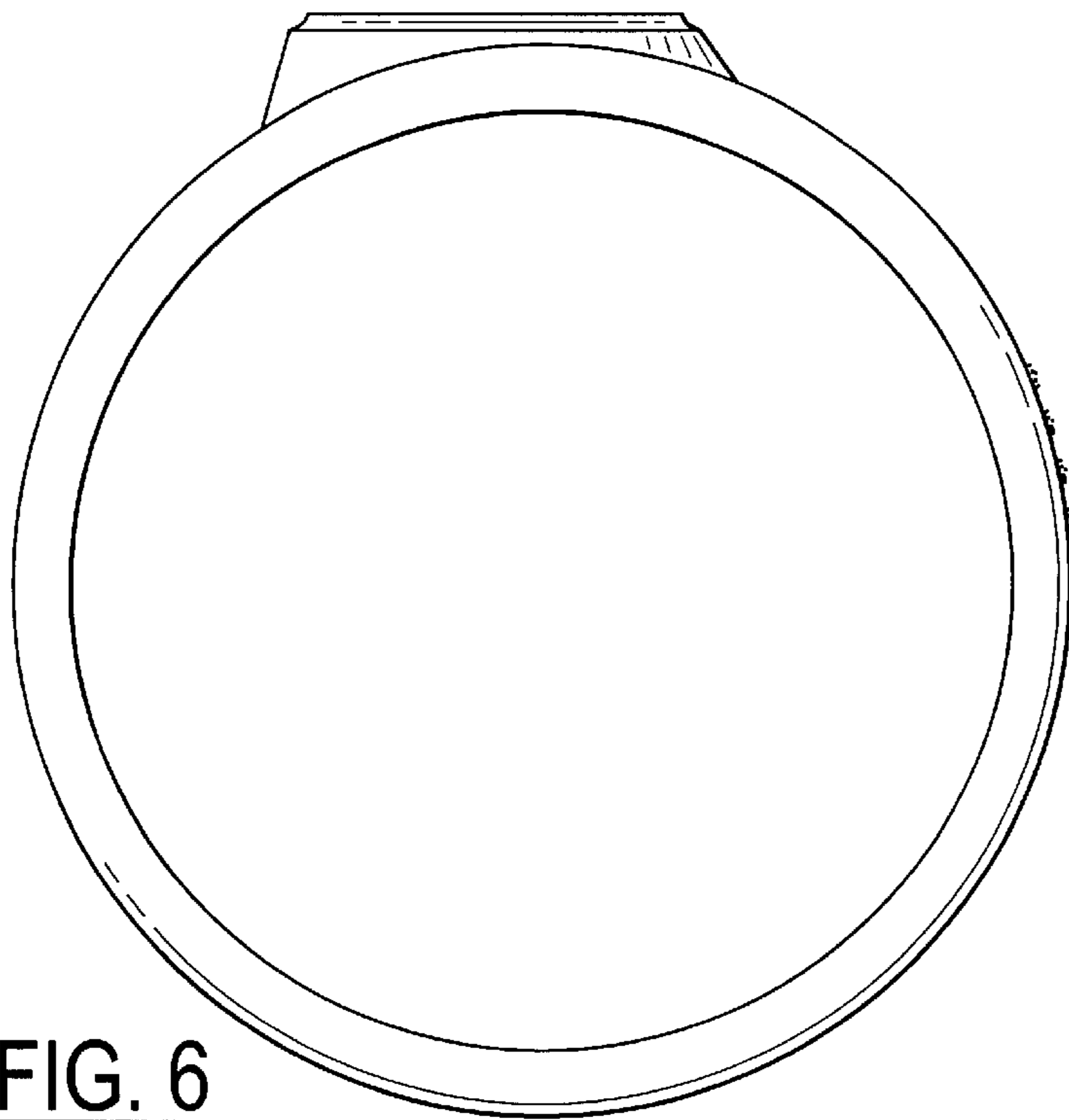

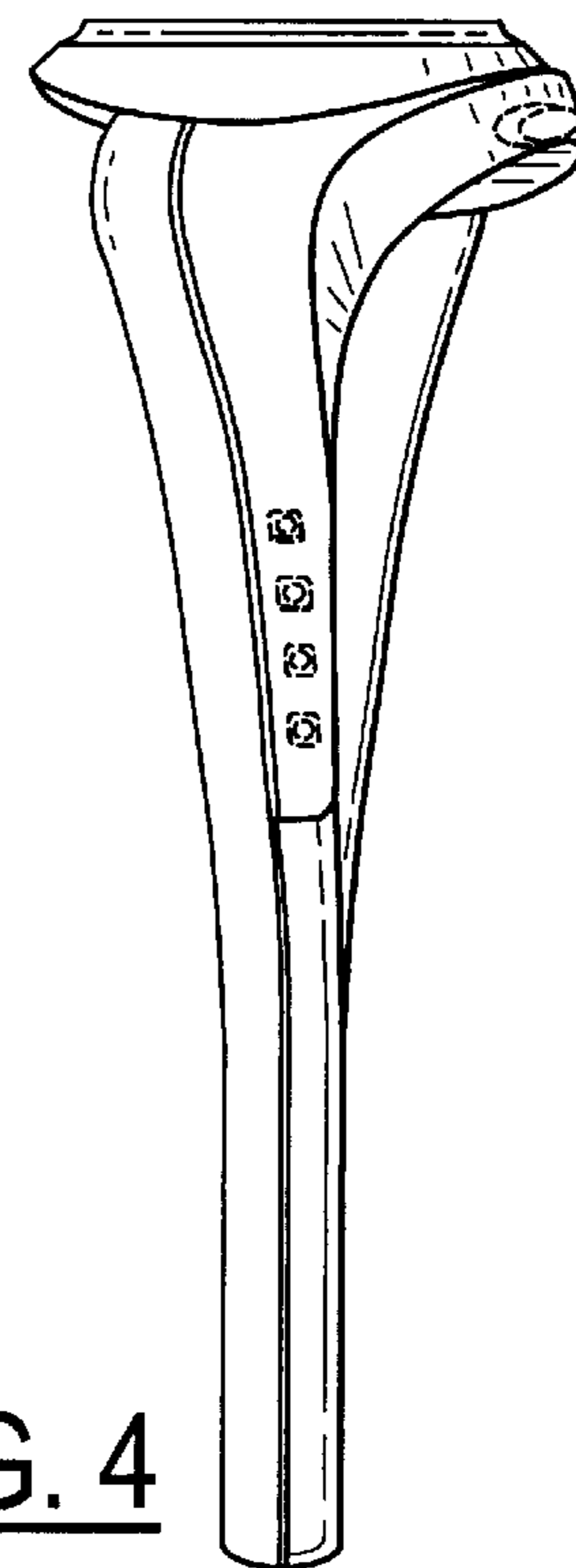

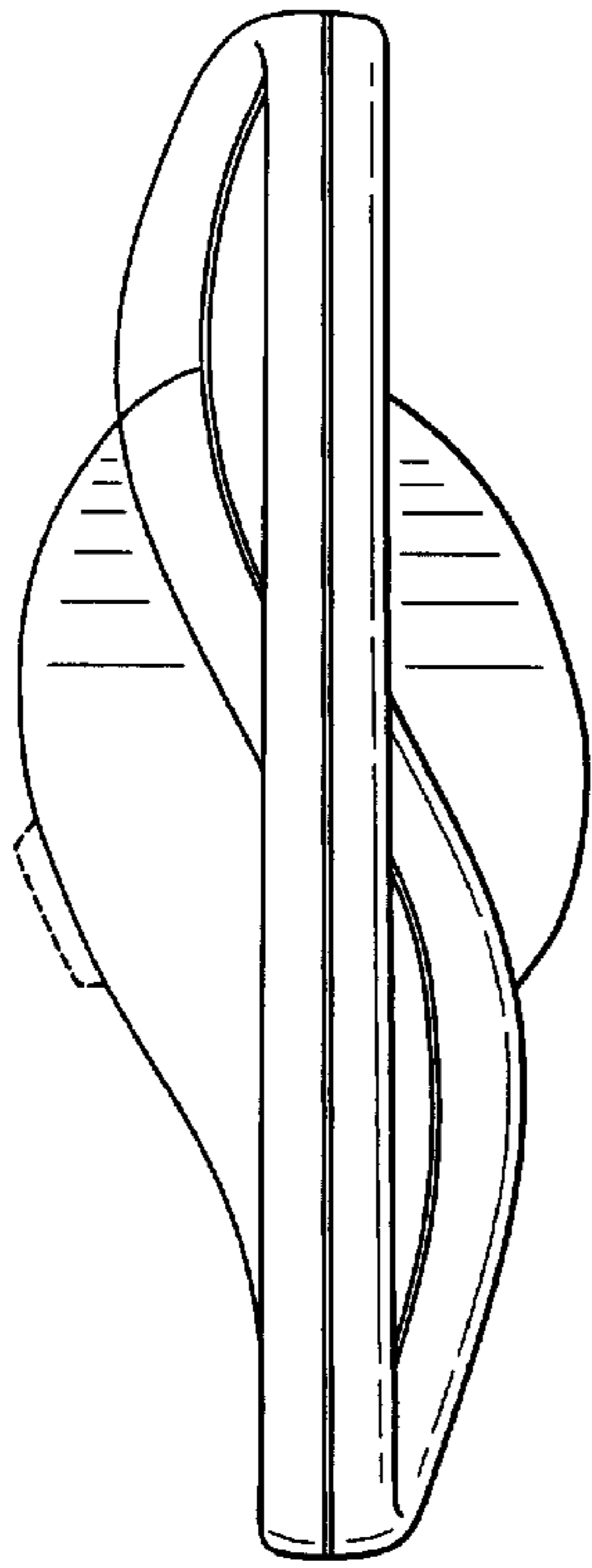

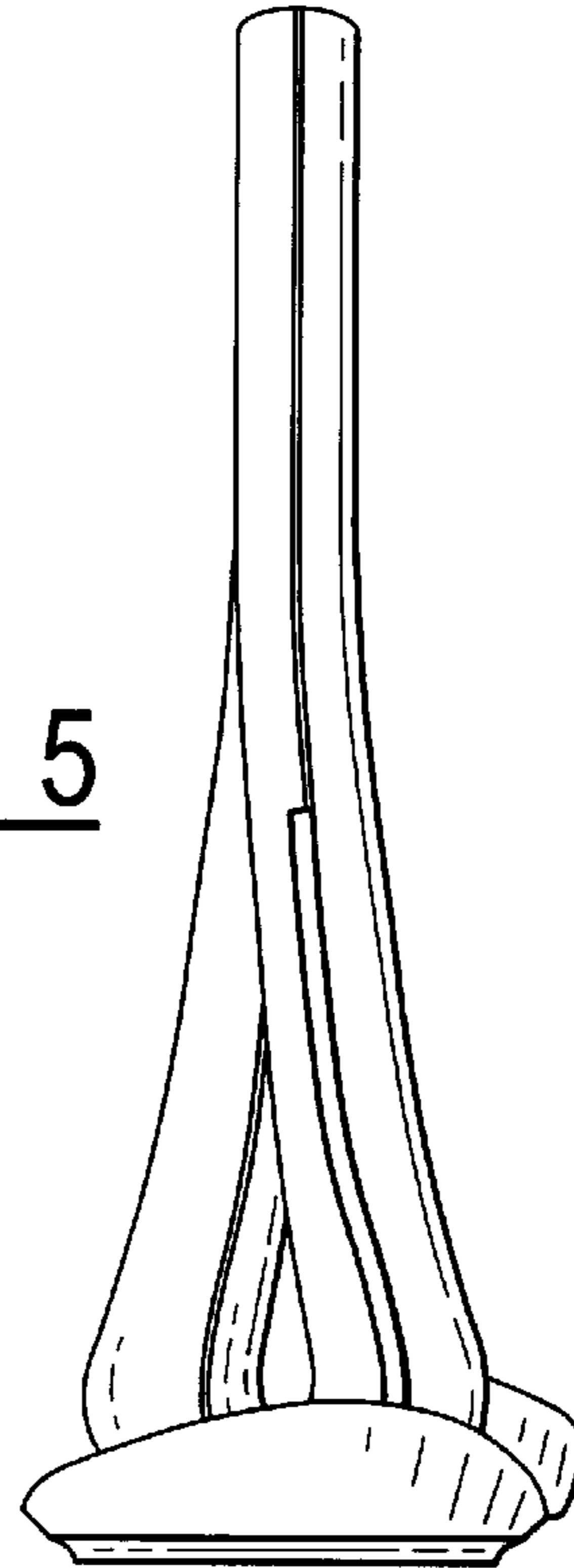

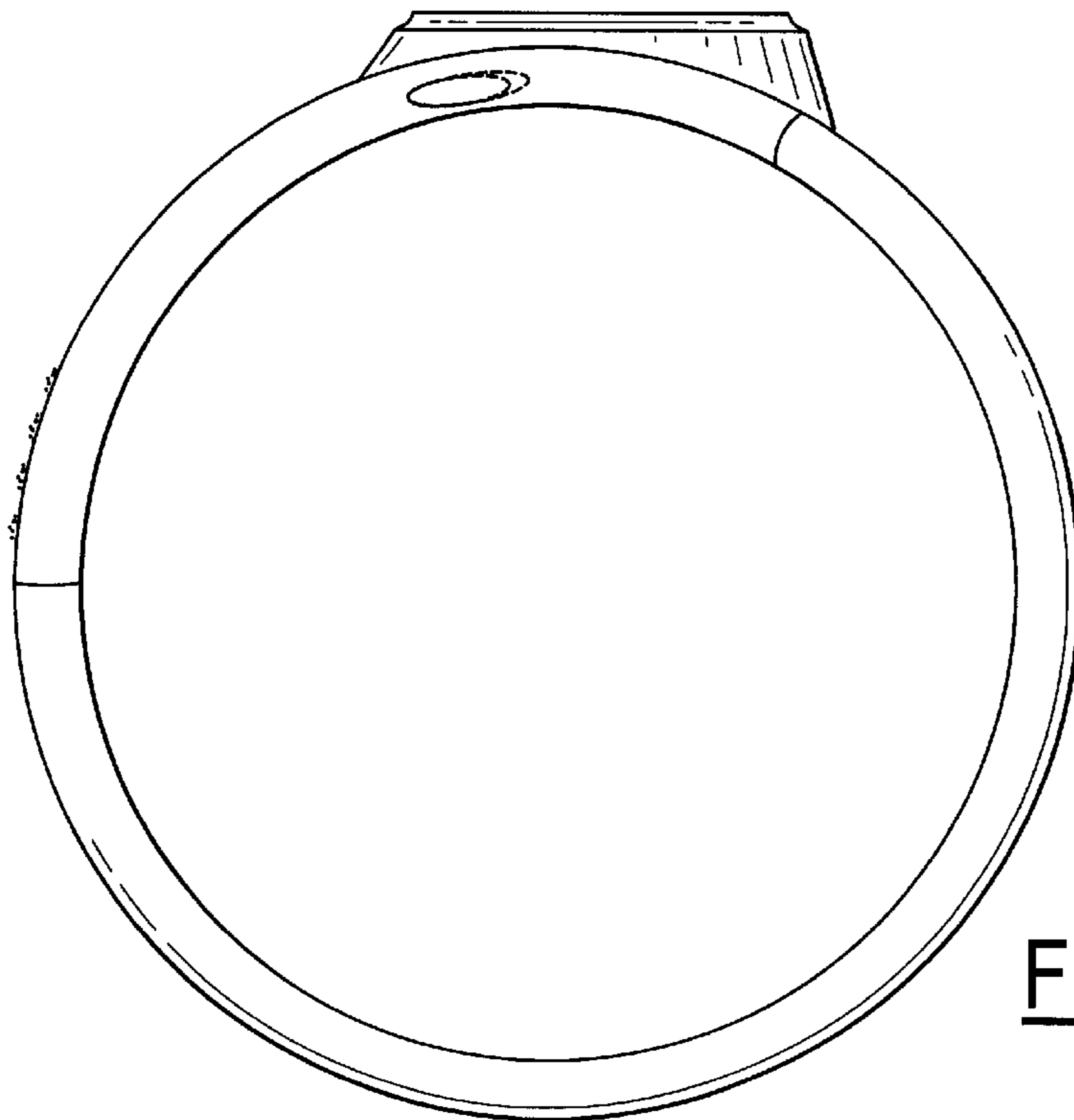
