(57) **CLAIM**

The ornamental design for a lighted pet pendant, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lighted pet pendant having multiple broken line lamp configurations showing my new design;
FIG. 2 is a side view;
FIG. 3 is a top view;
FIG. 4 is a top view showing an alternate broken line configuration from that of FIGS. 1-3; and,
FIG. 5 is a top view showing an alternate broken line configuration from that of FIGS. 1-4.
It being understood that the broken lines are for illustrative purposes only and form no part of the claimed design.

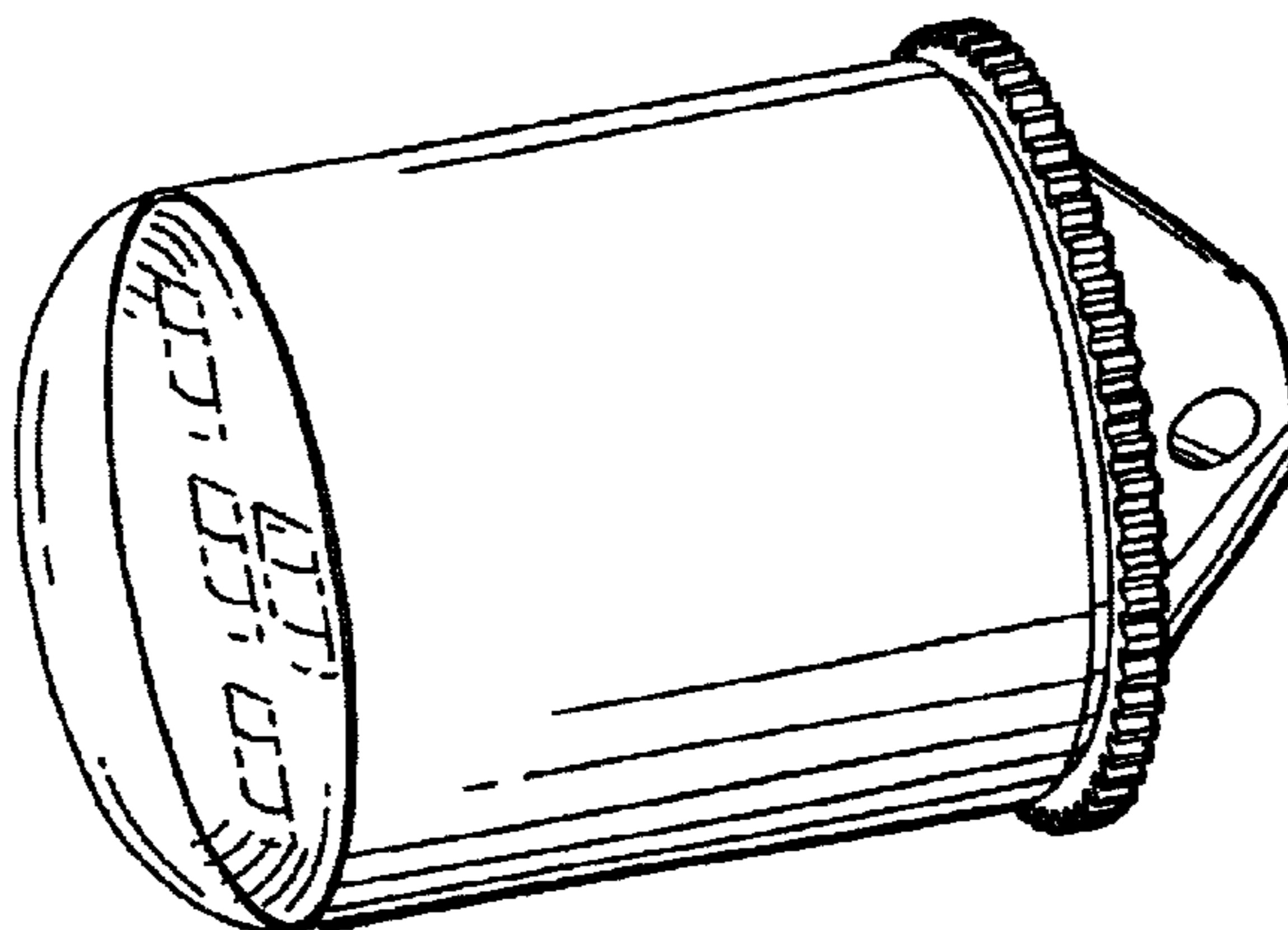

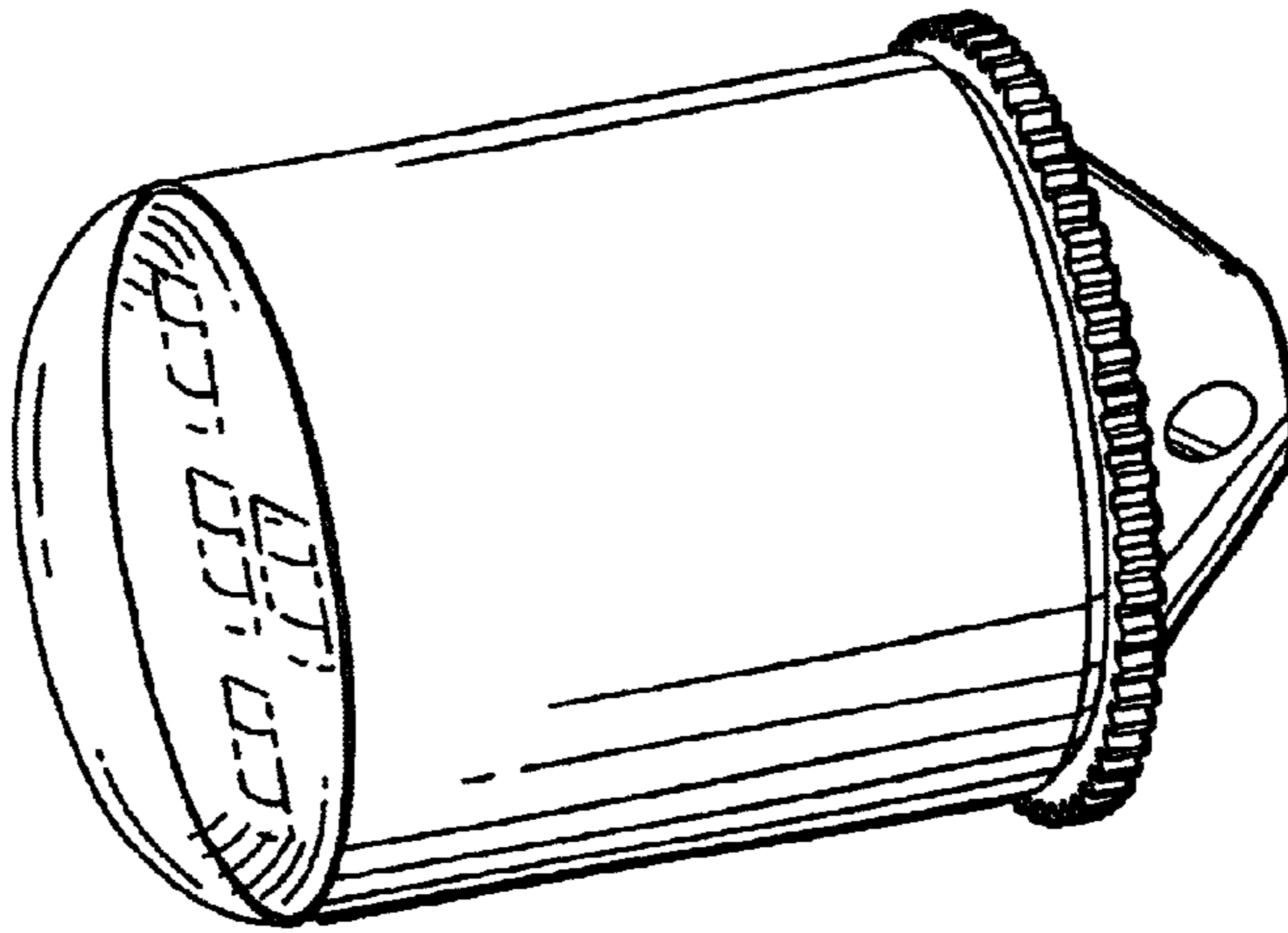

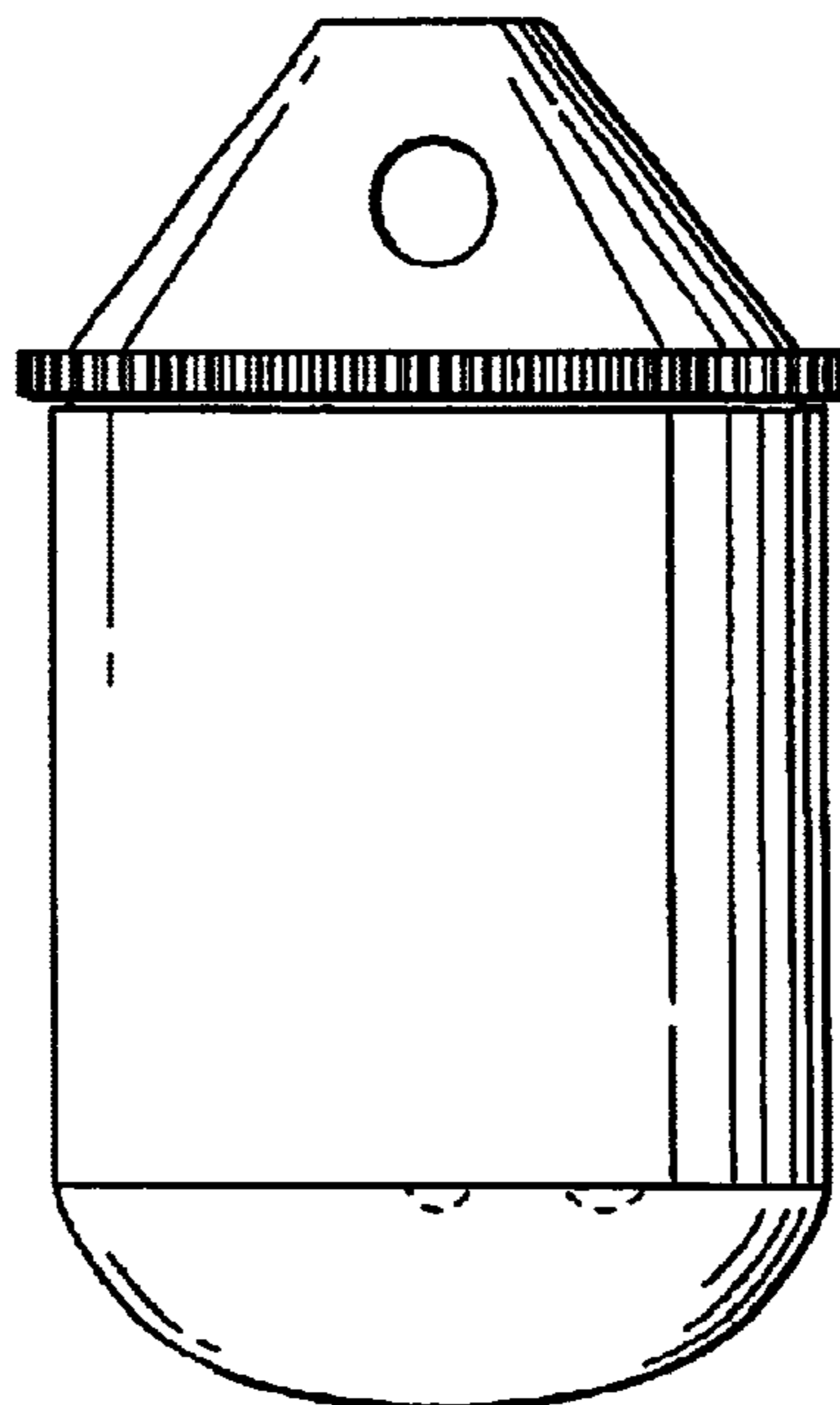

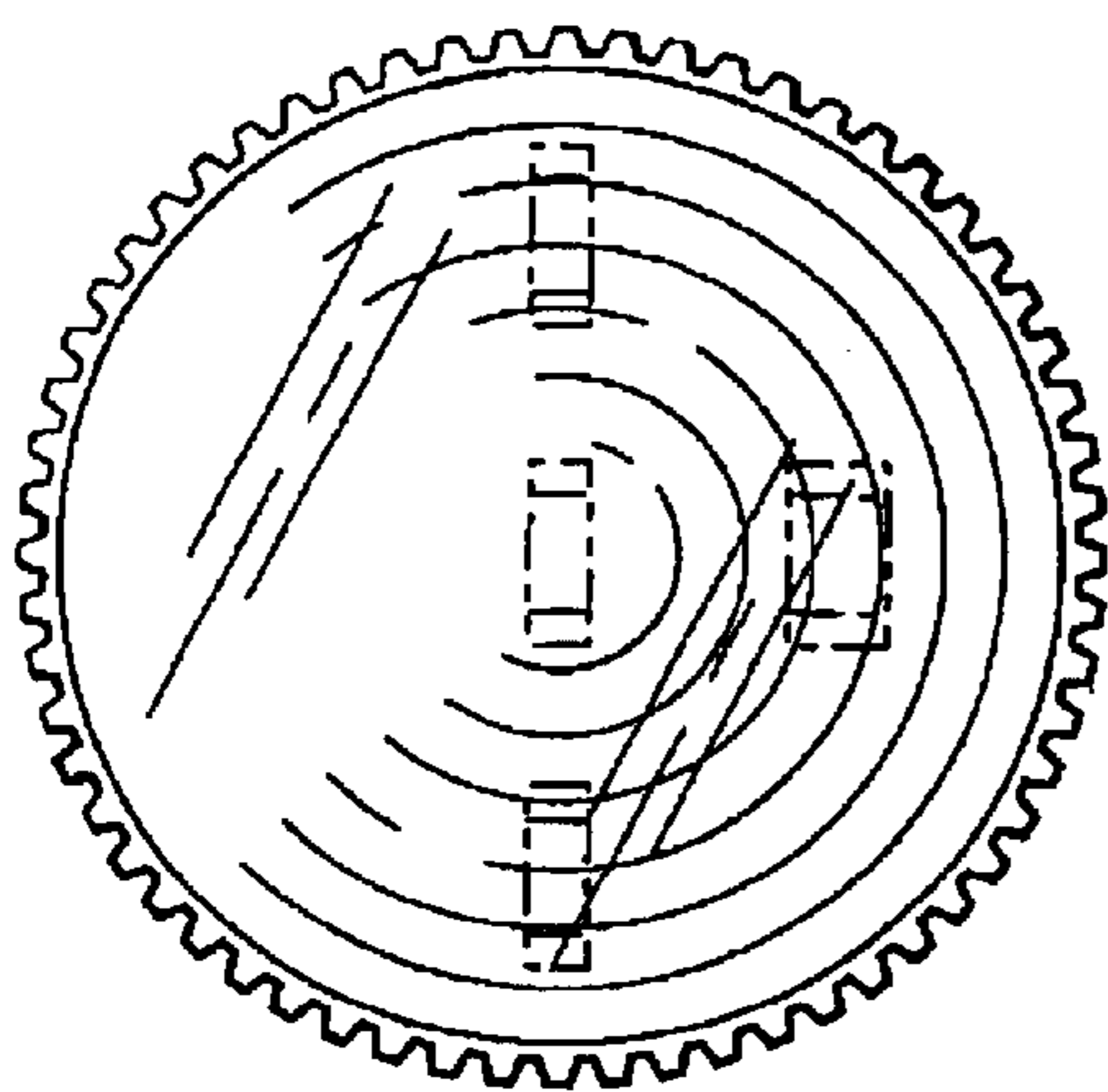

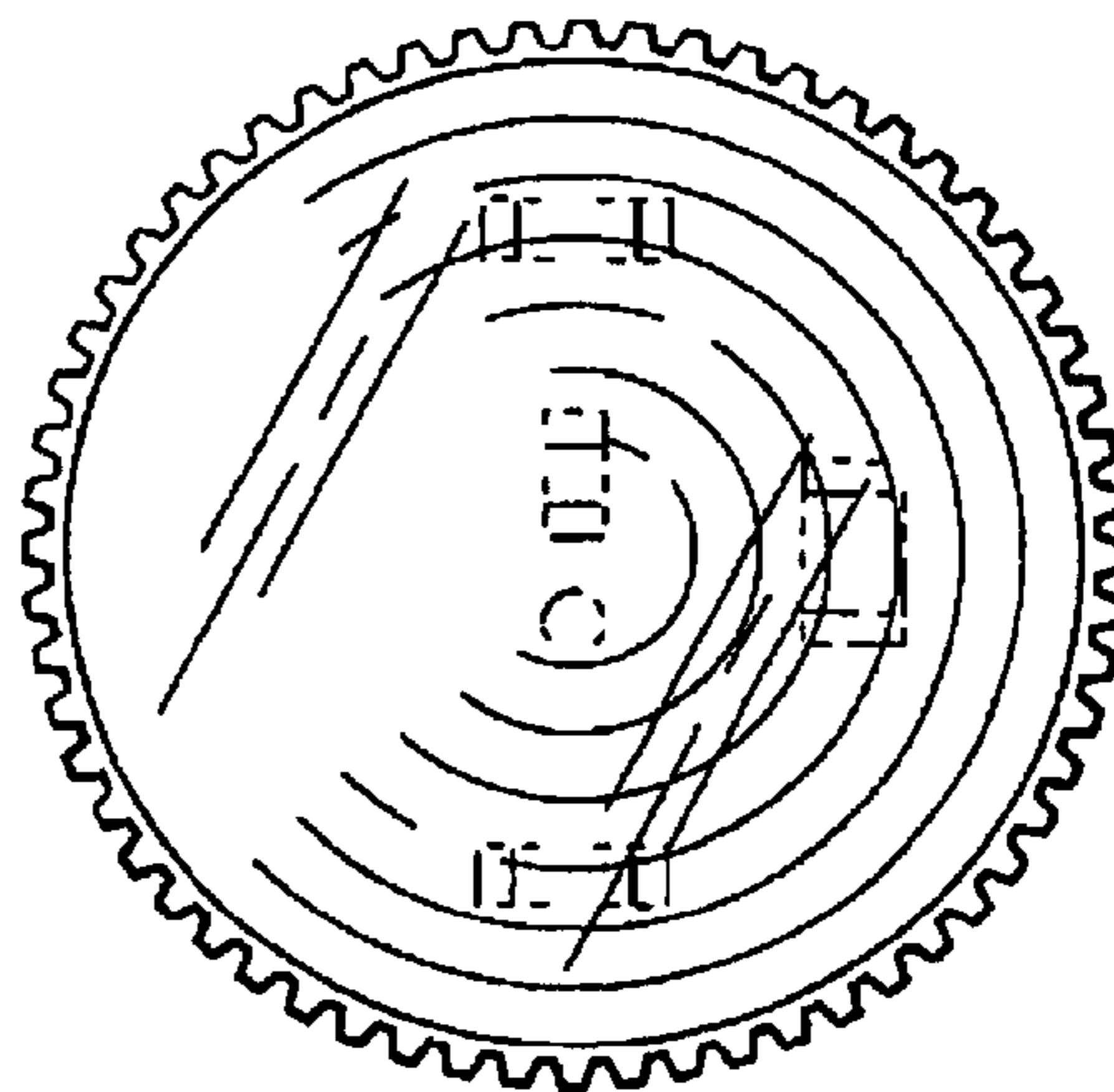
