Broken lines shown in any of the foregoing figures represent only the environment and do not constitute any part of the invention.

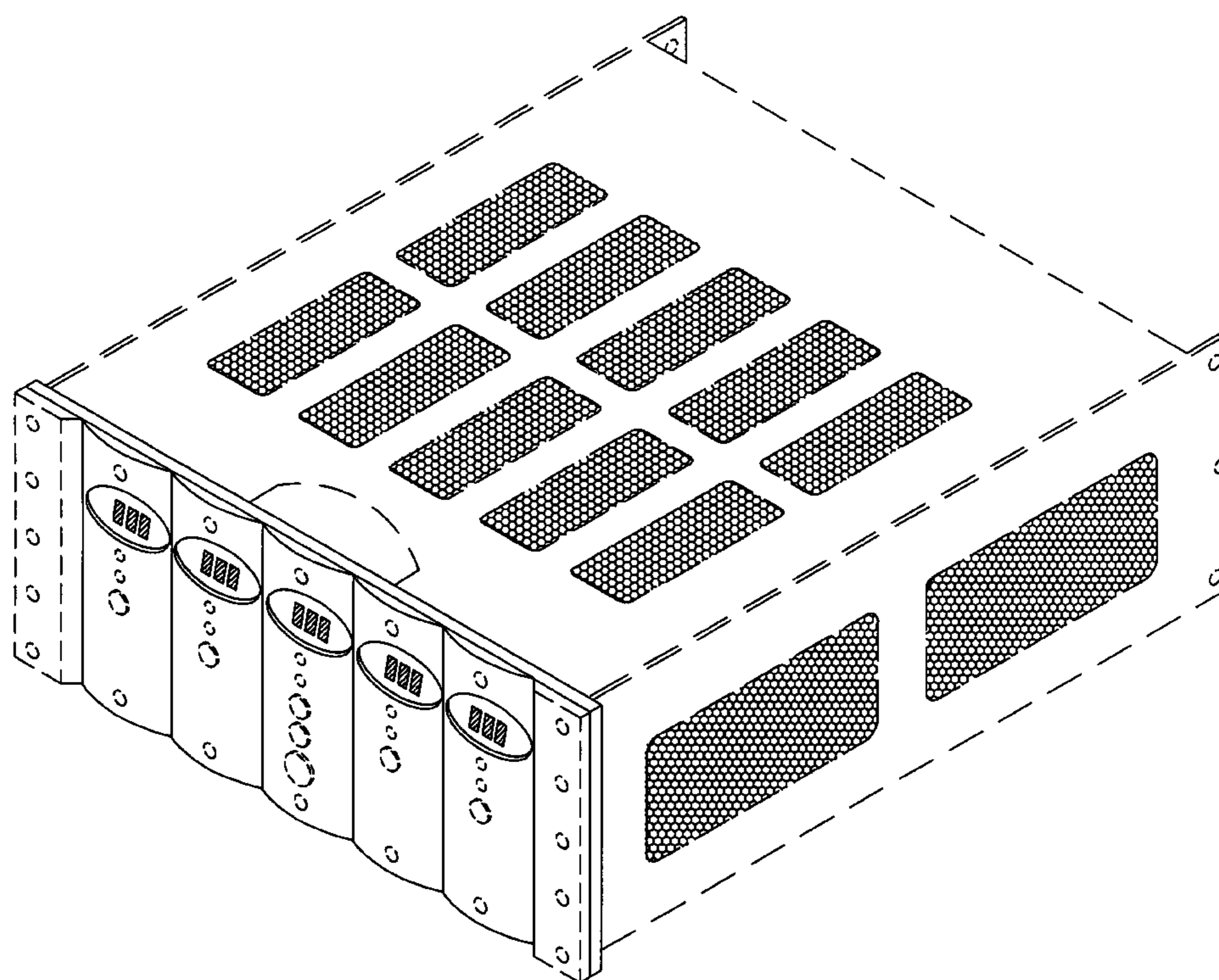

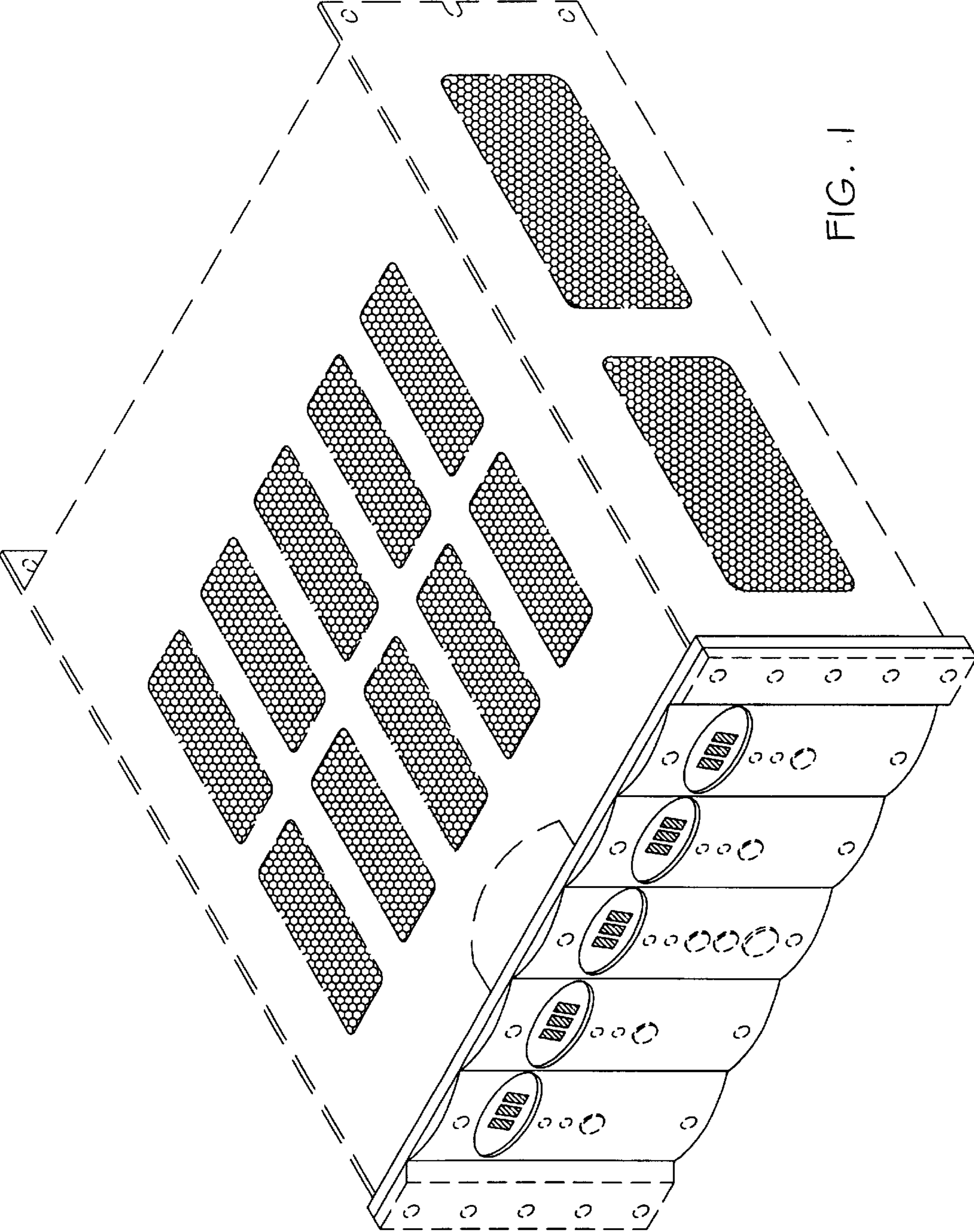

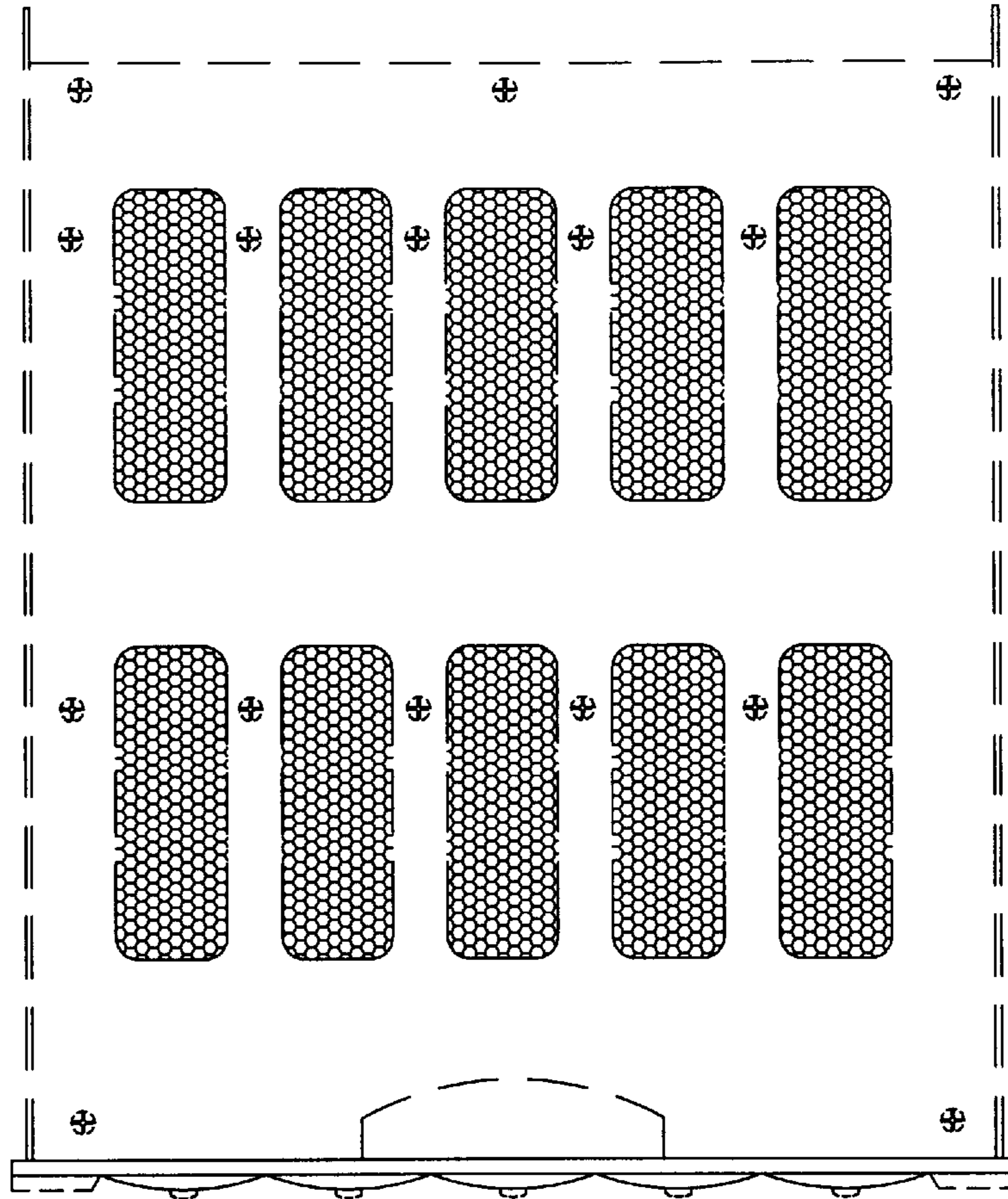

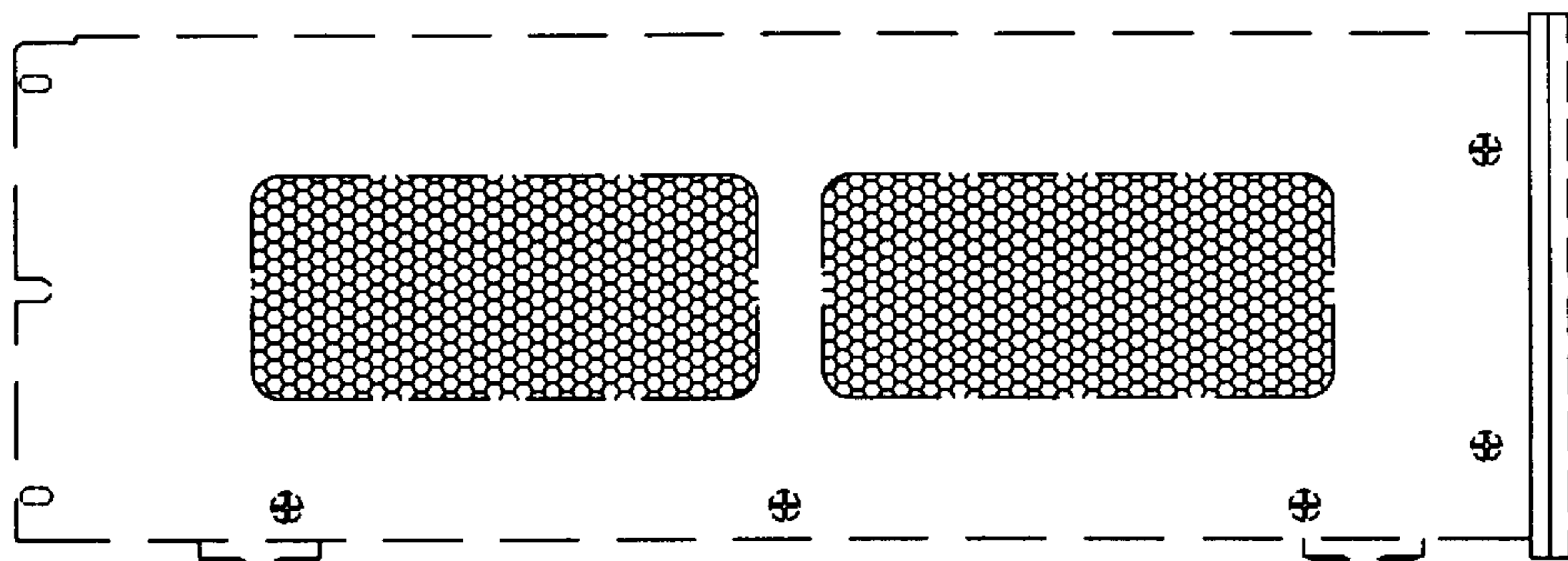

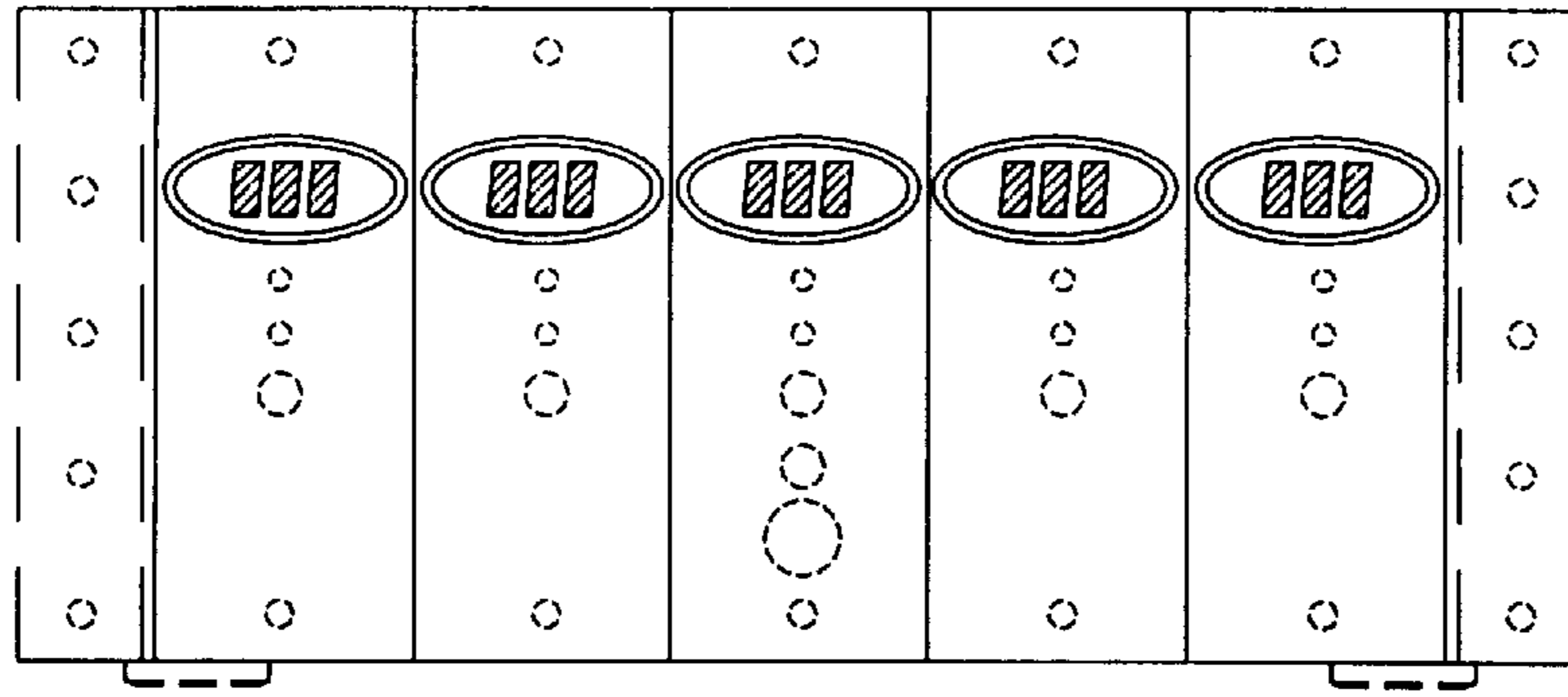

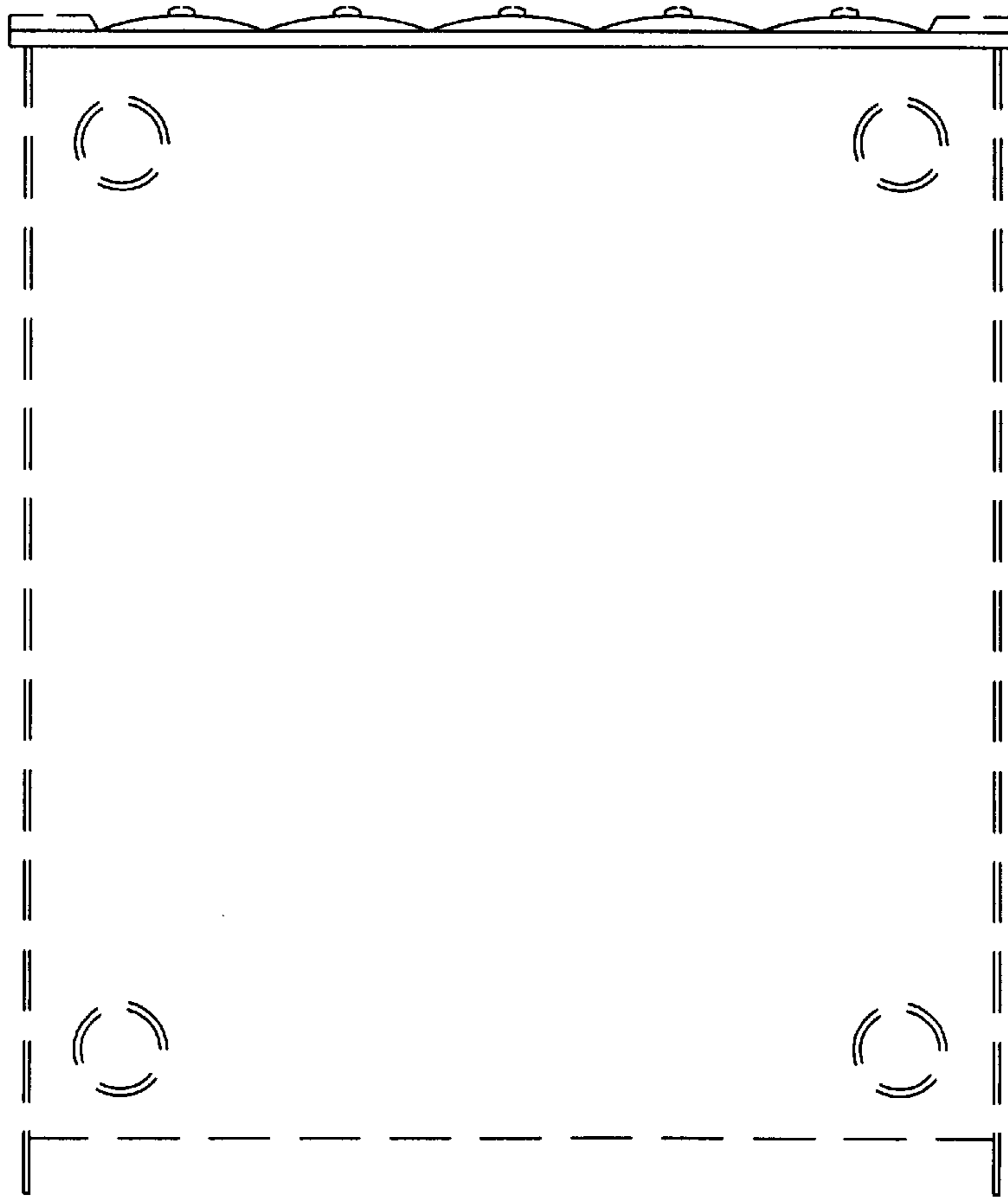

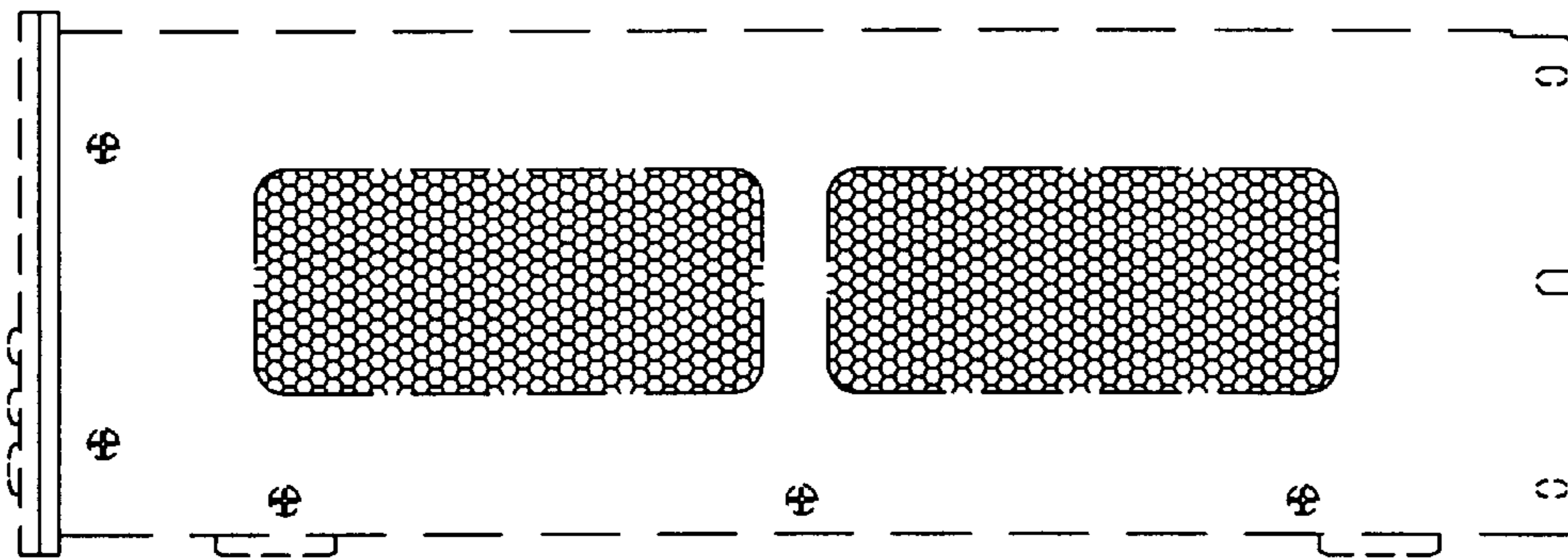

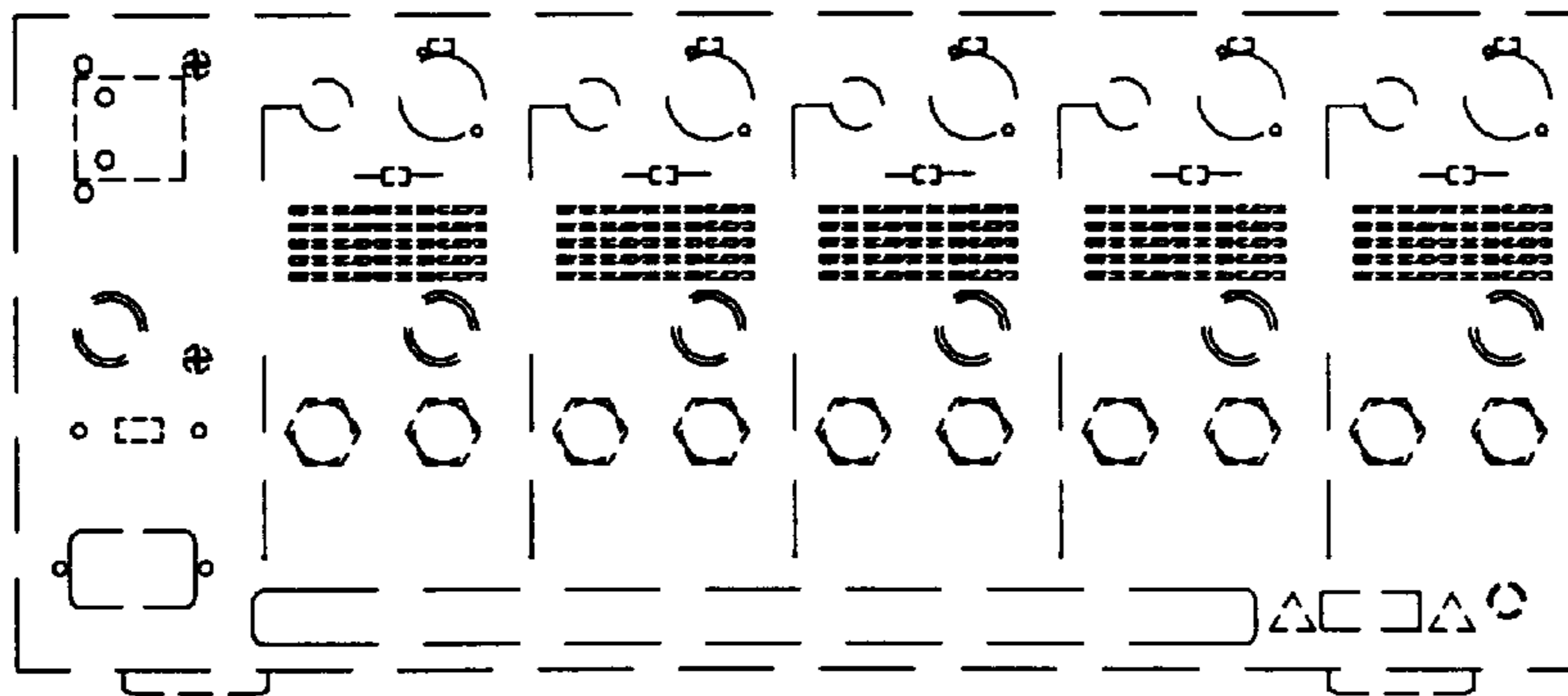
