The ornamental design for a wireless TV transmitter, as shown and described.

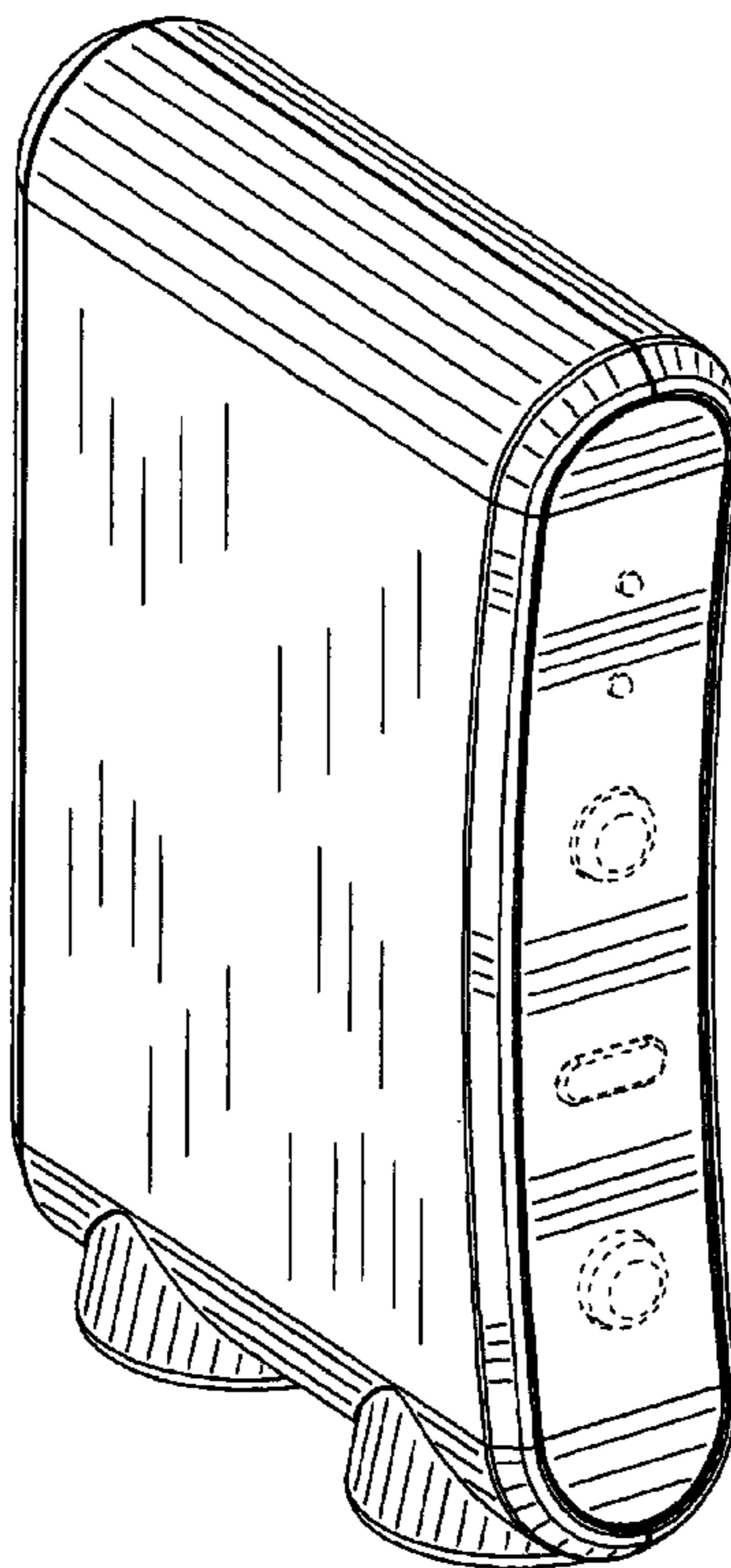
DESCRIPTION

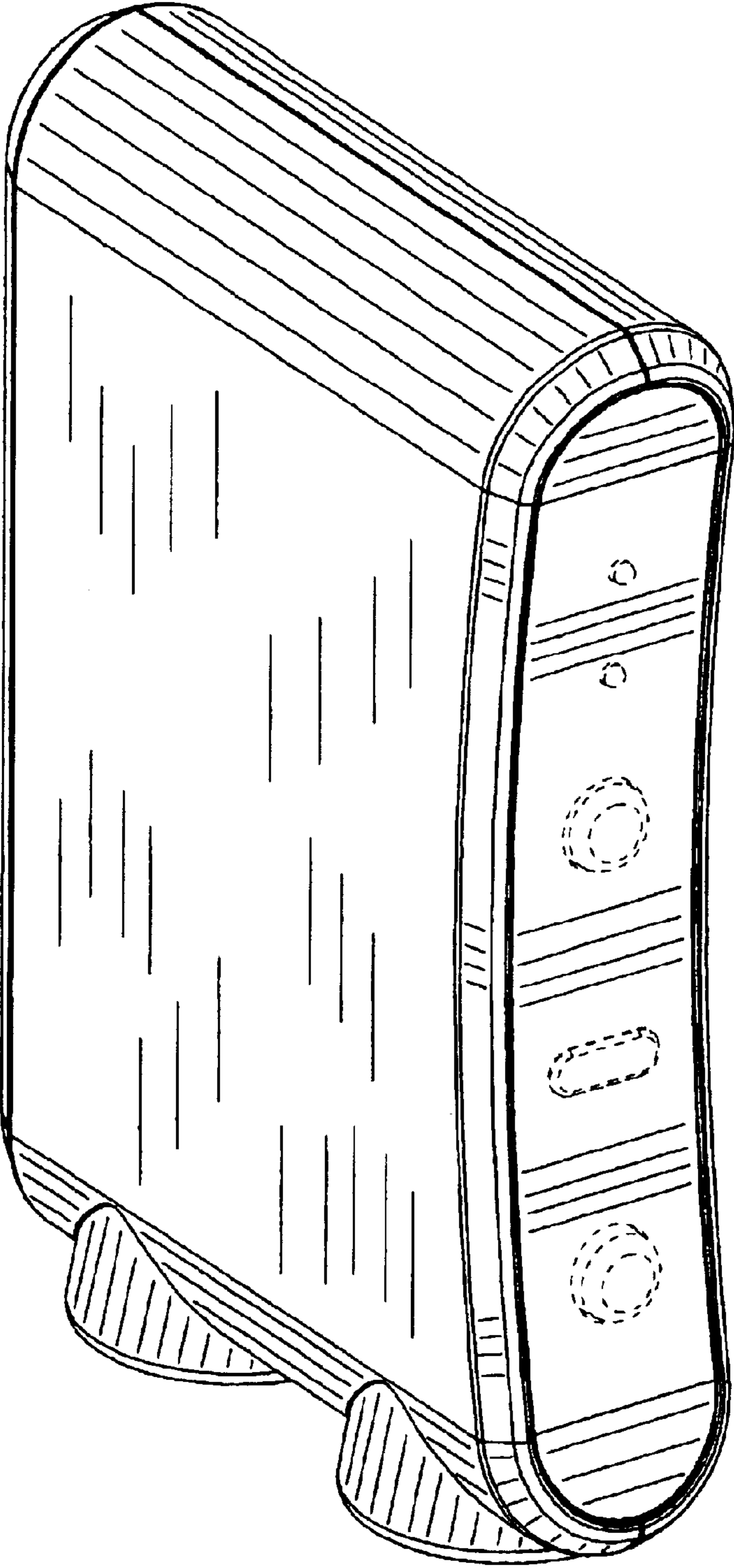

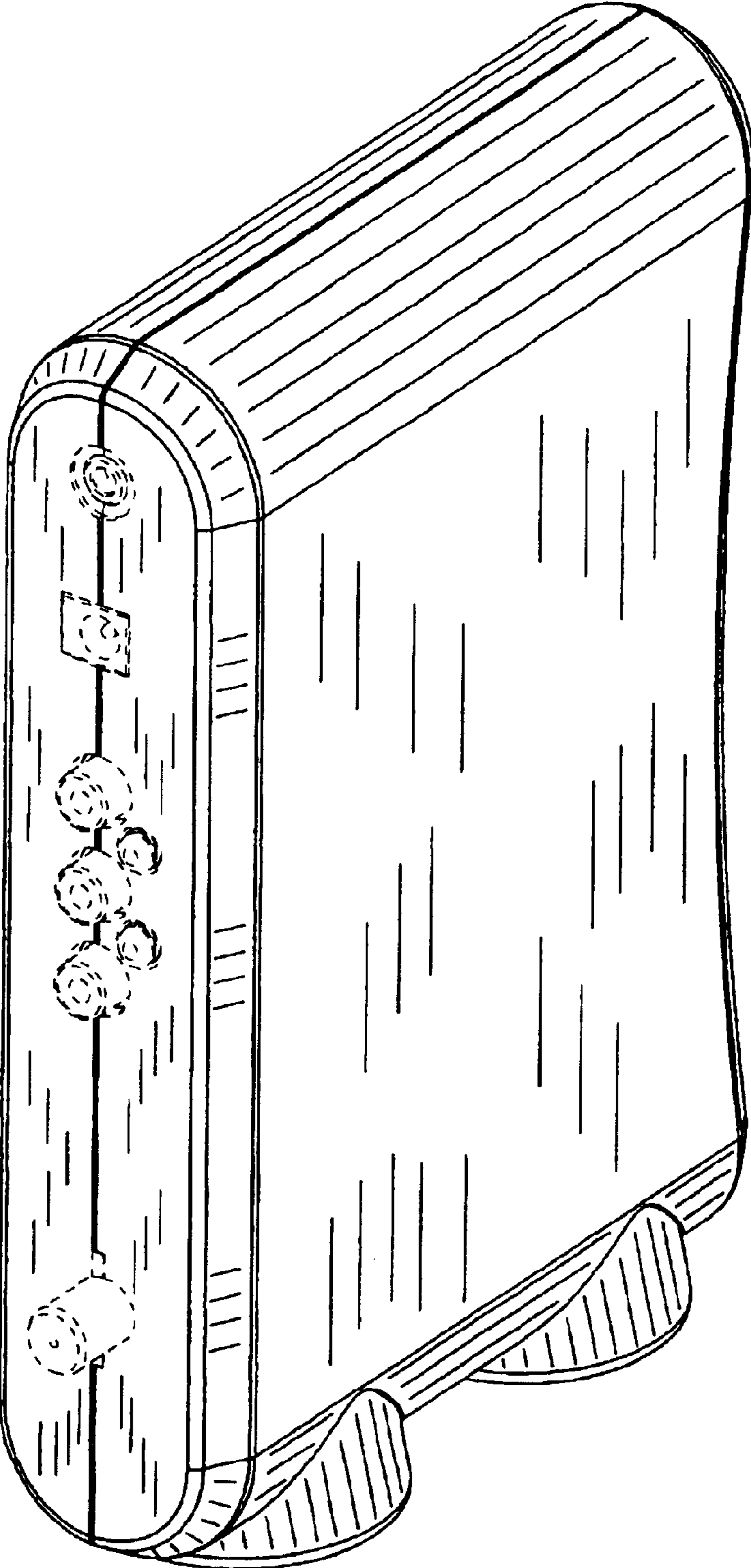

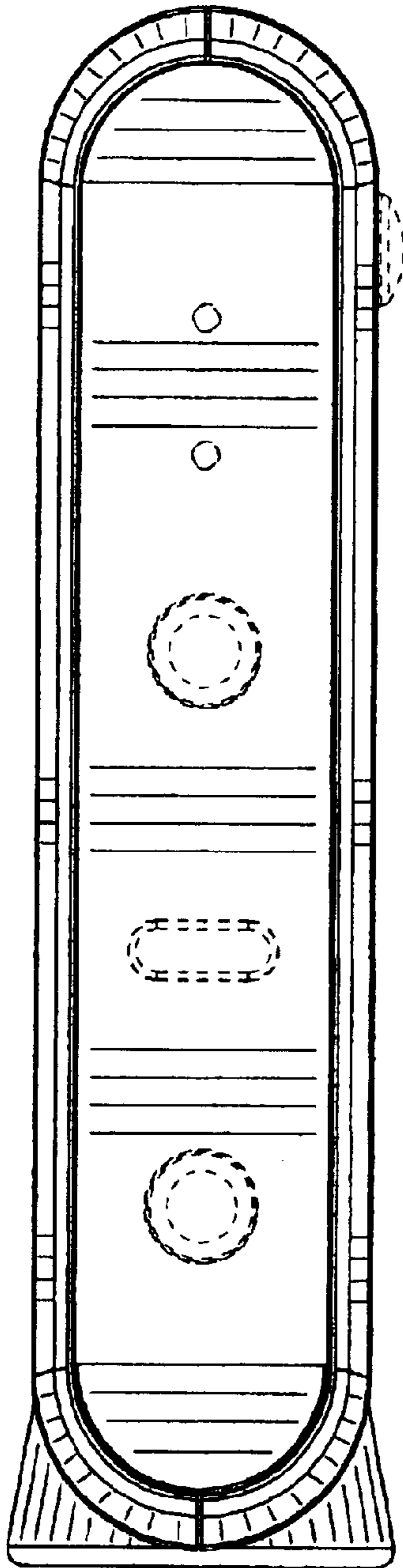

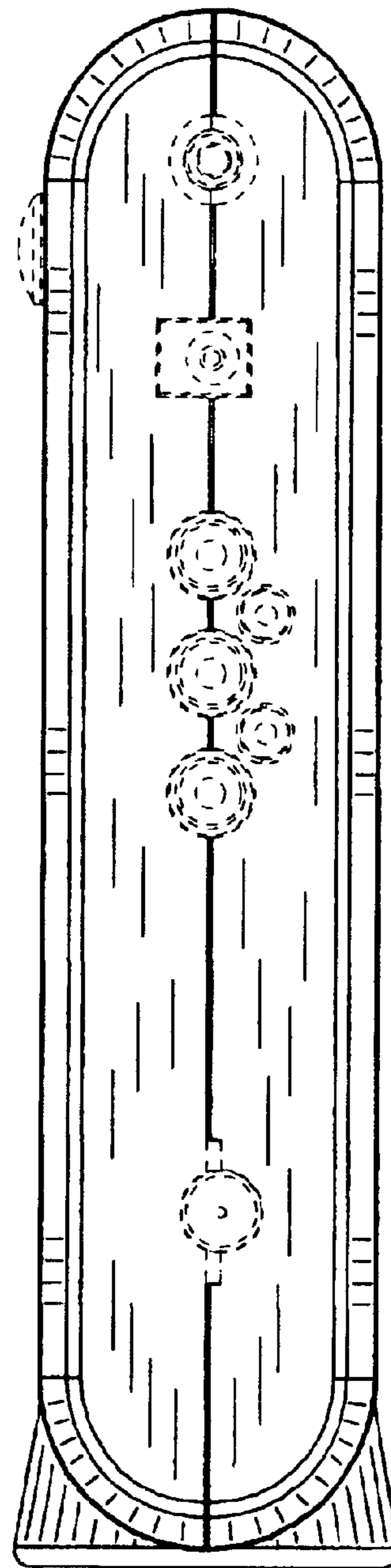

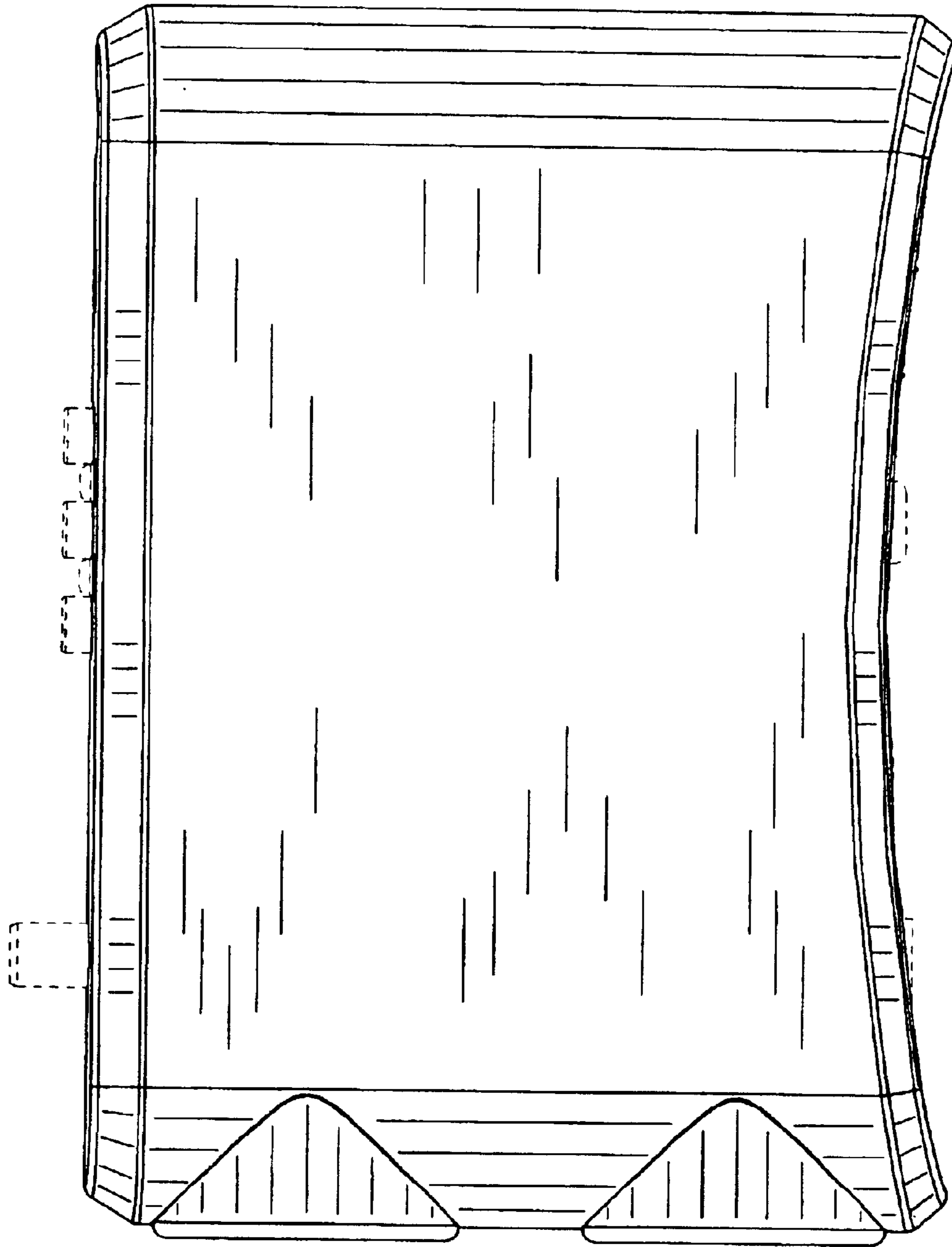

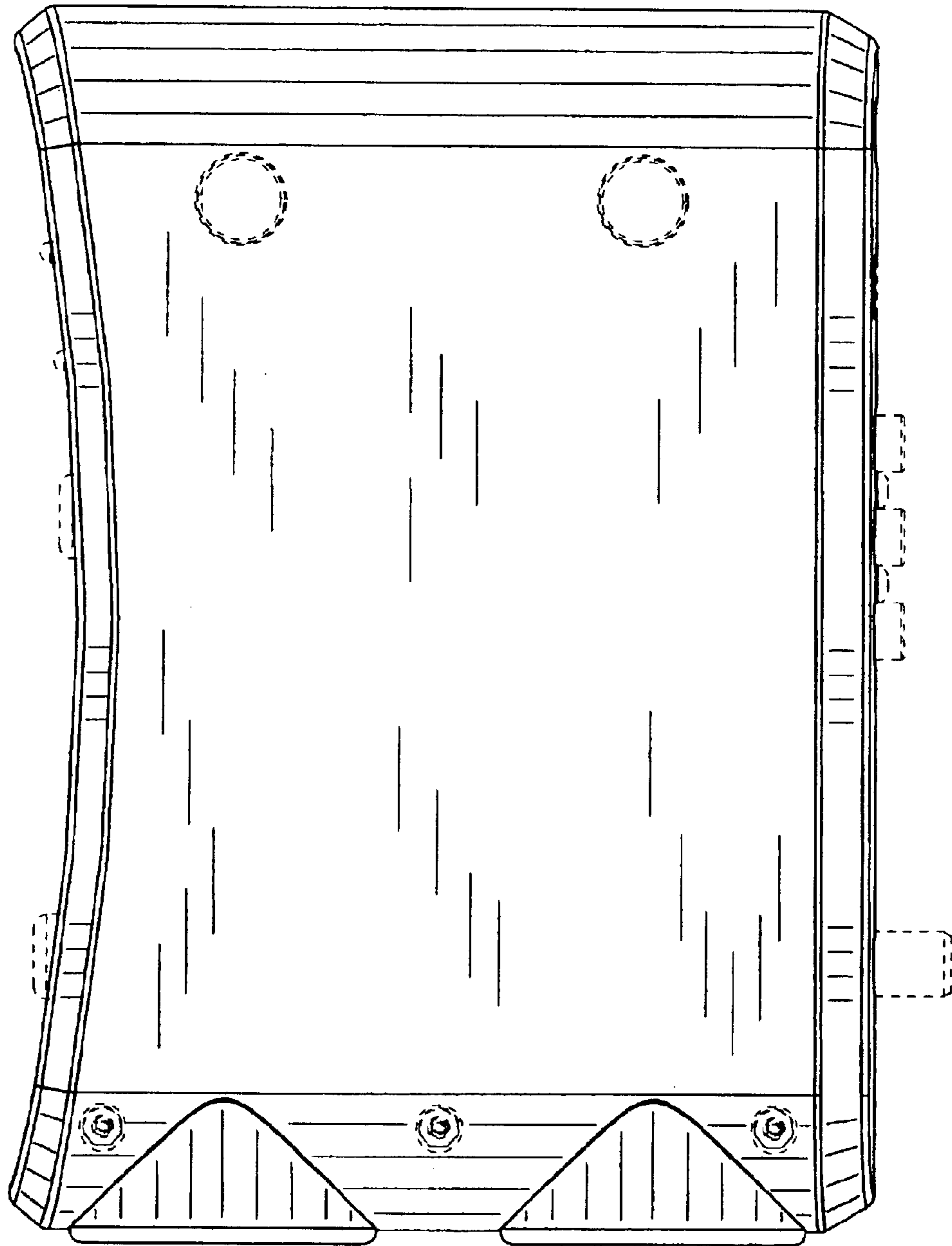

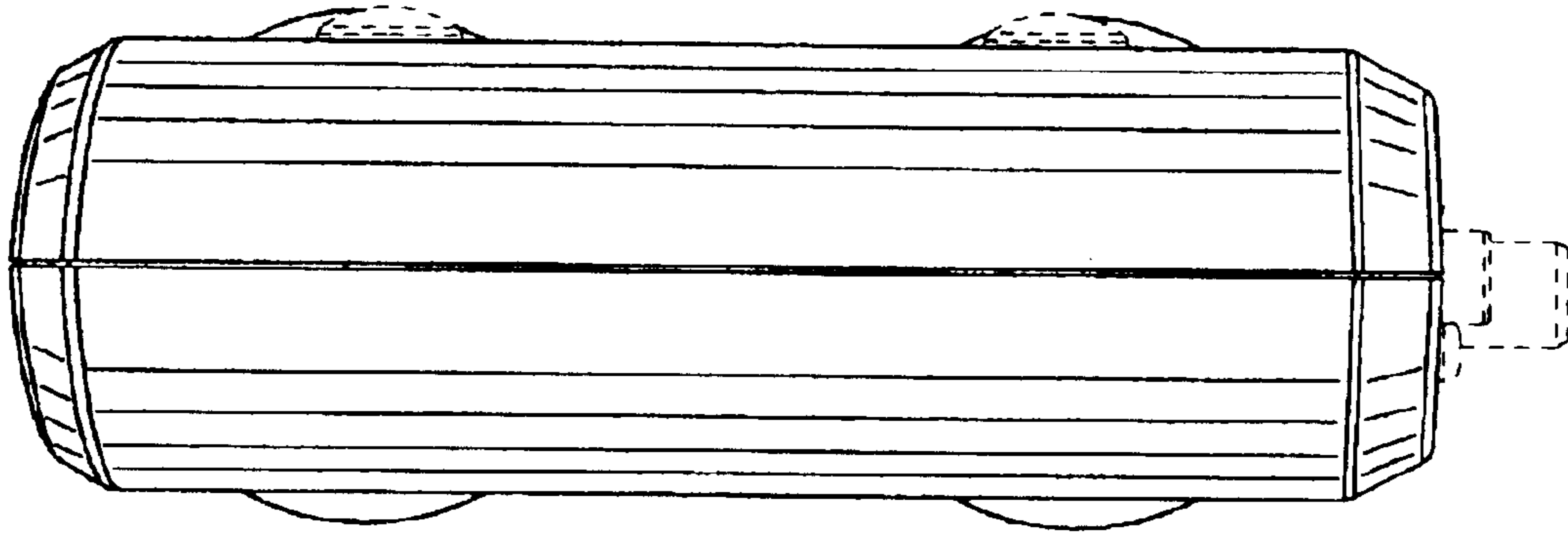

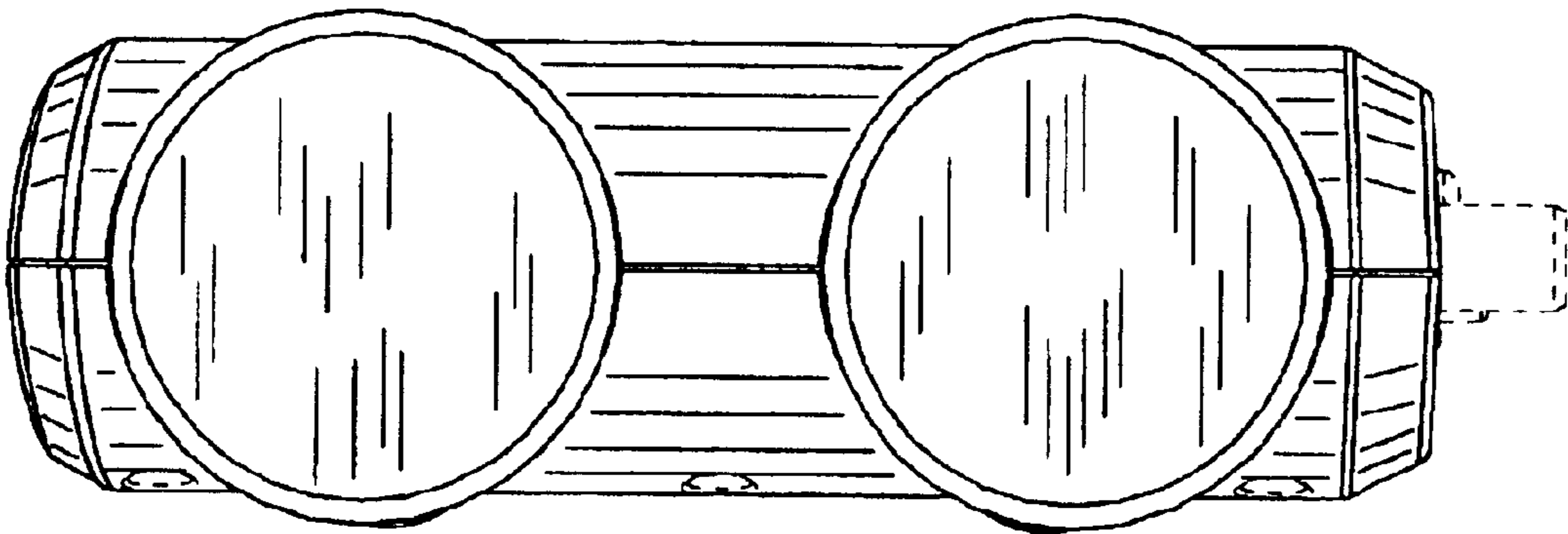
