FIG. 7 is a perspective view of the wireless media player housing.

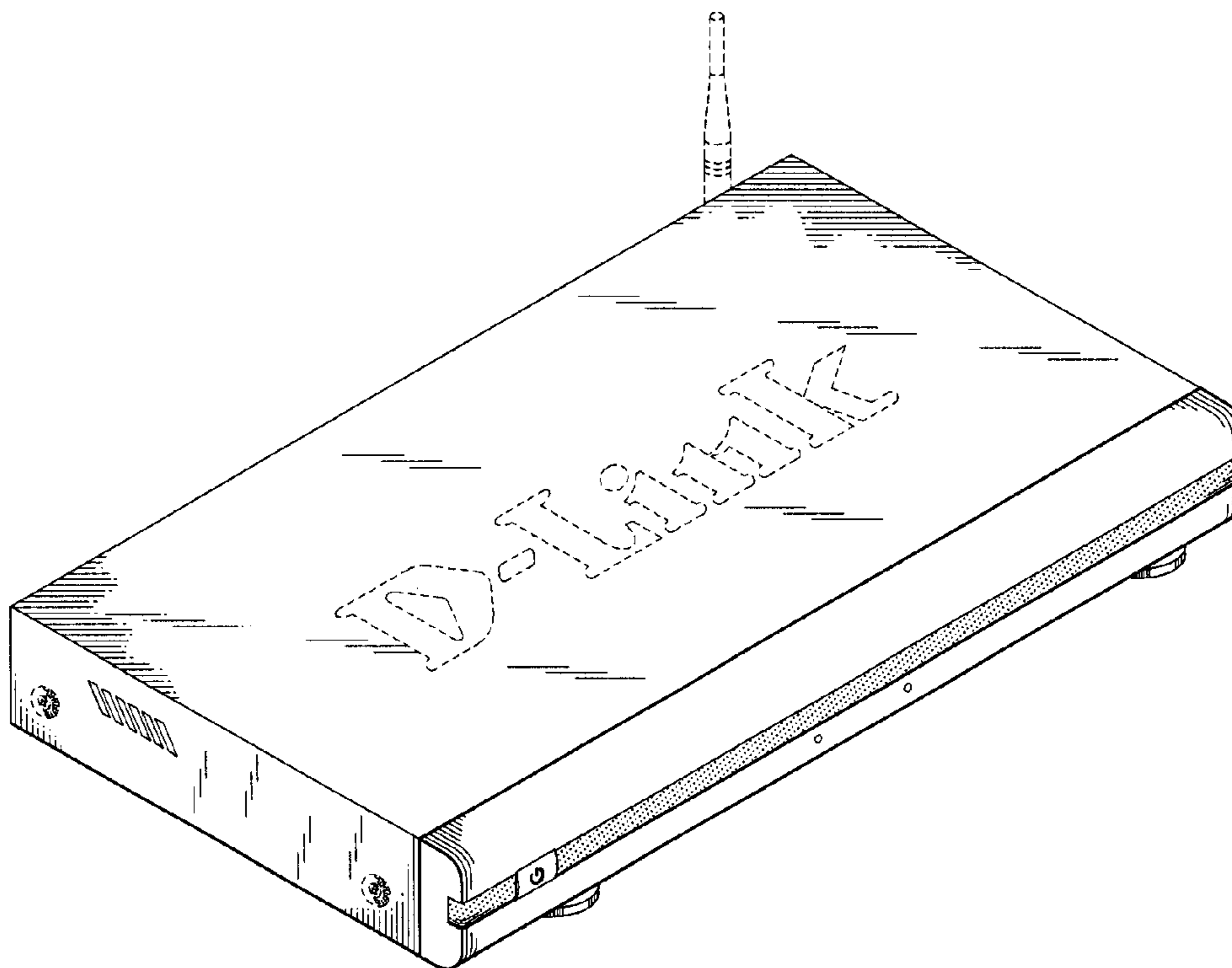

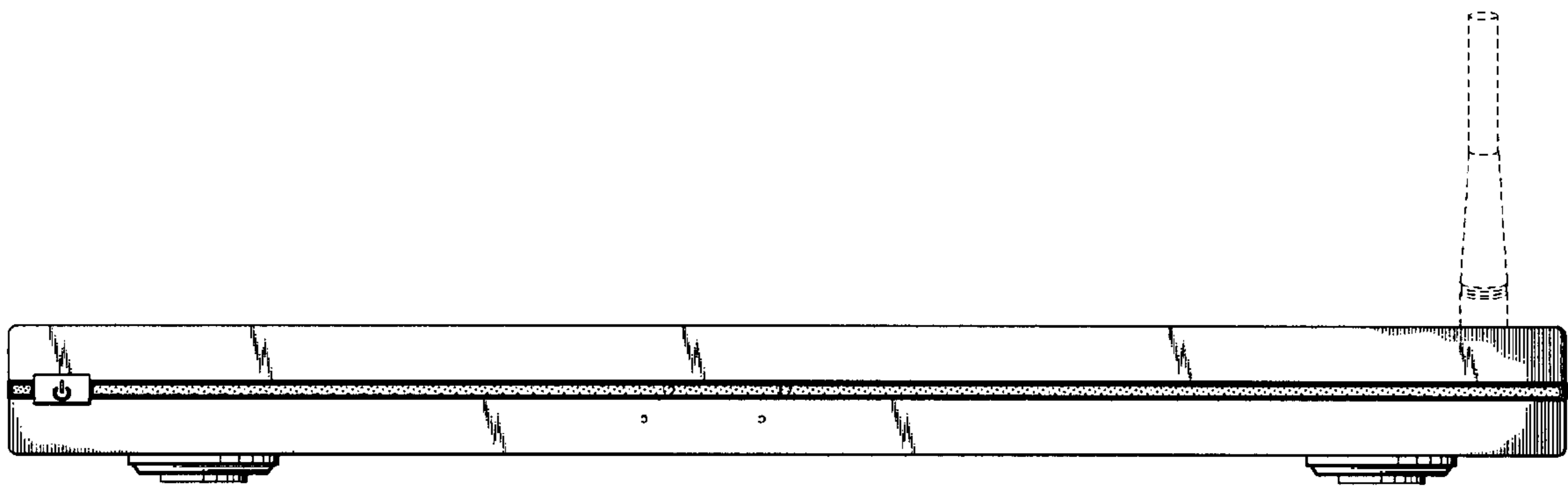

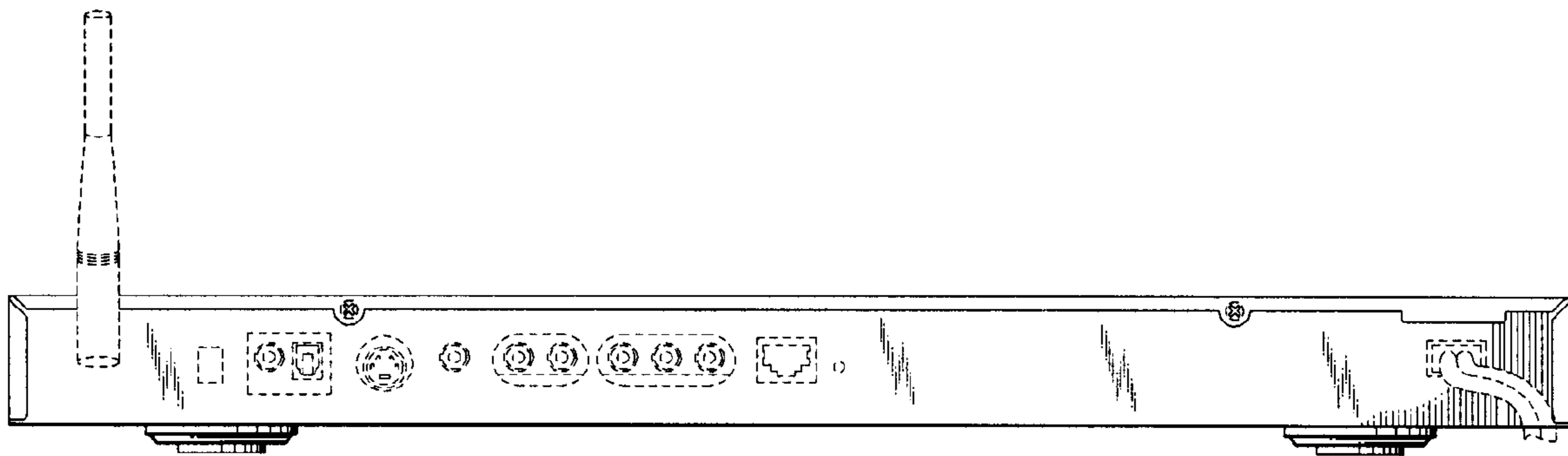

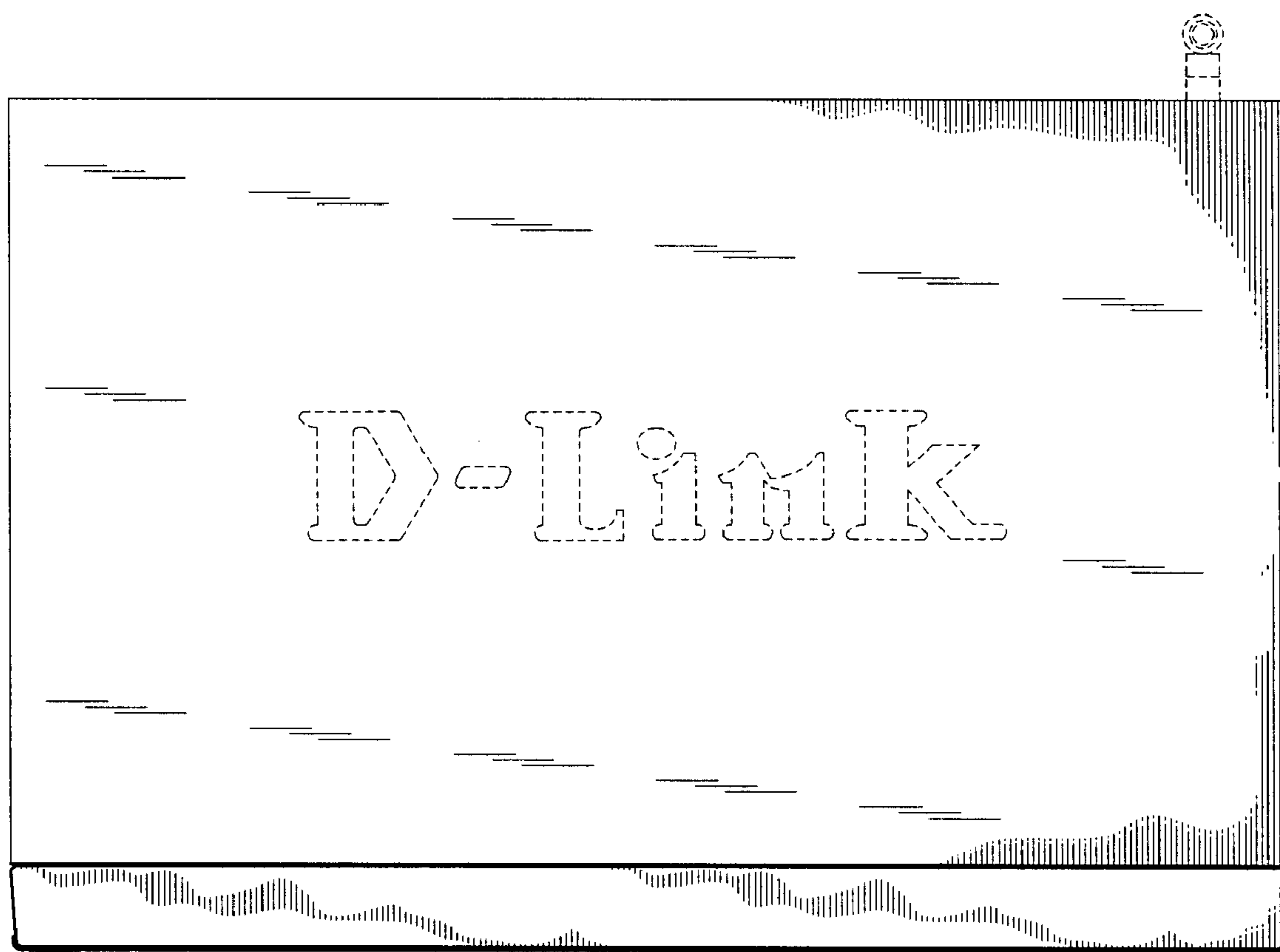

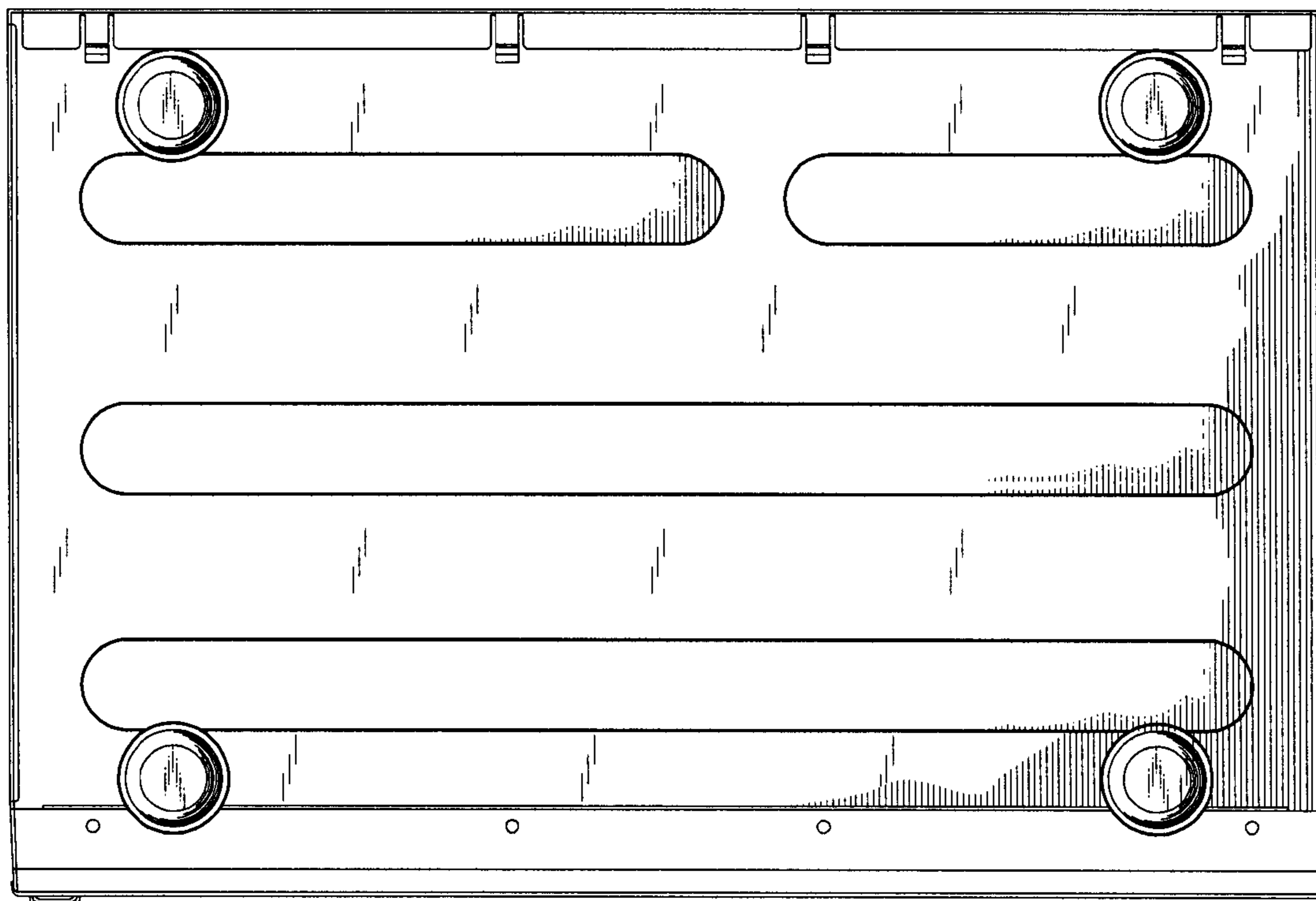

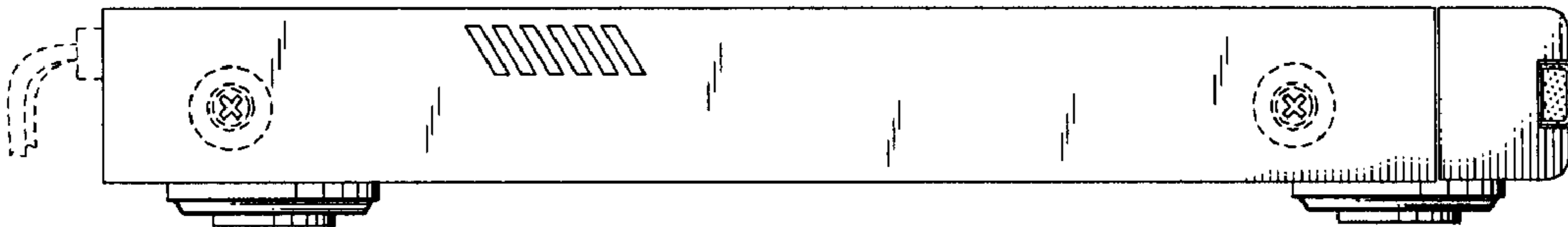

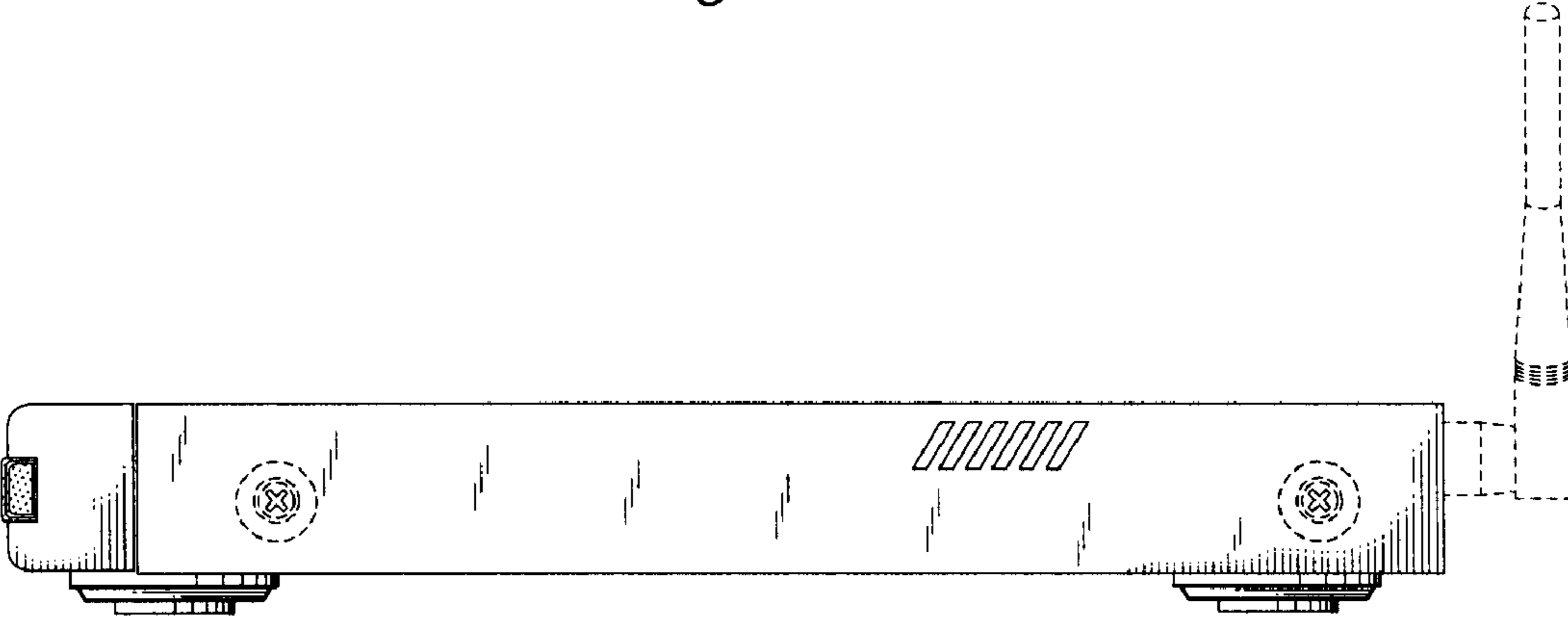

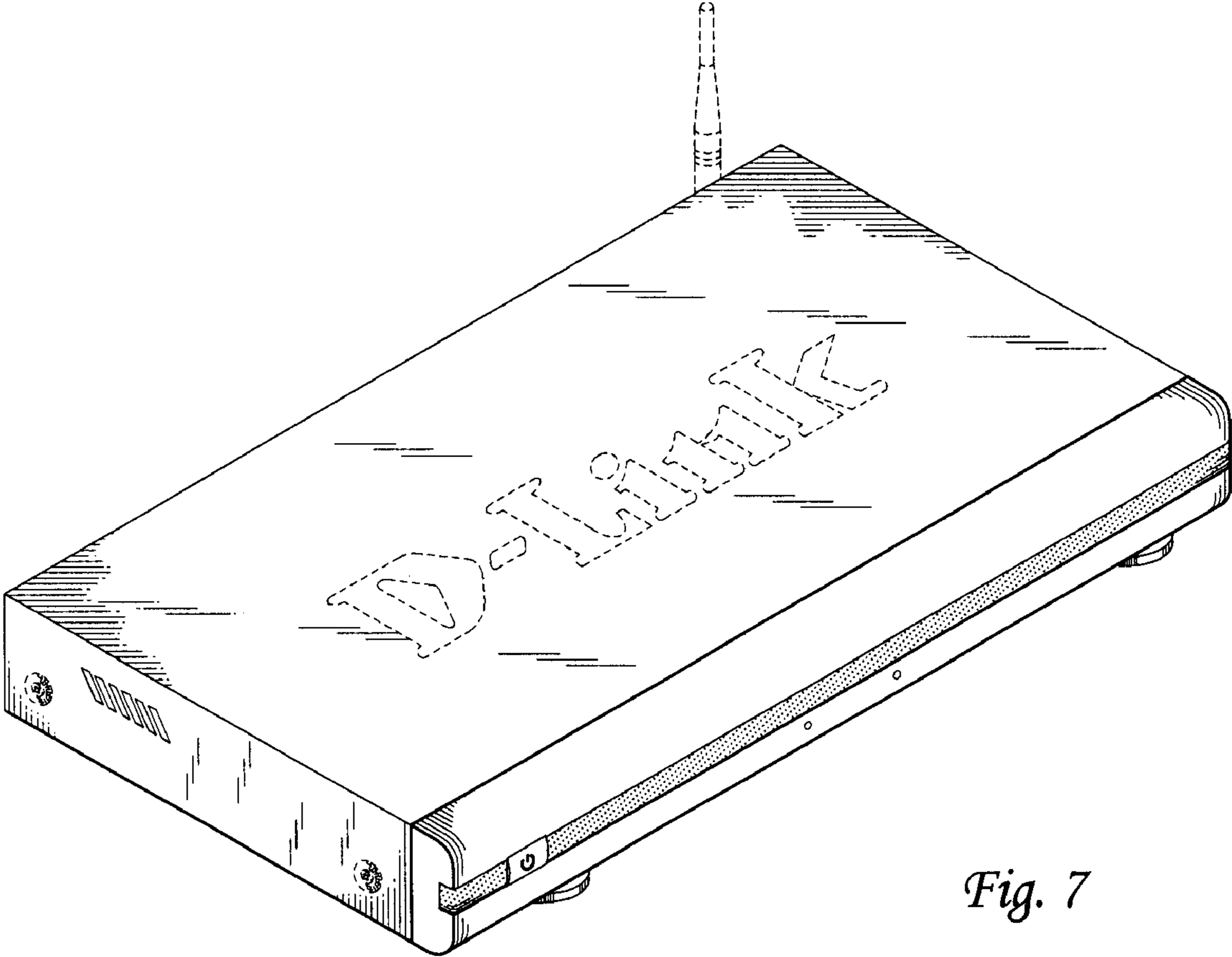
