DESCRIPTION

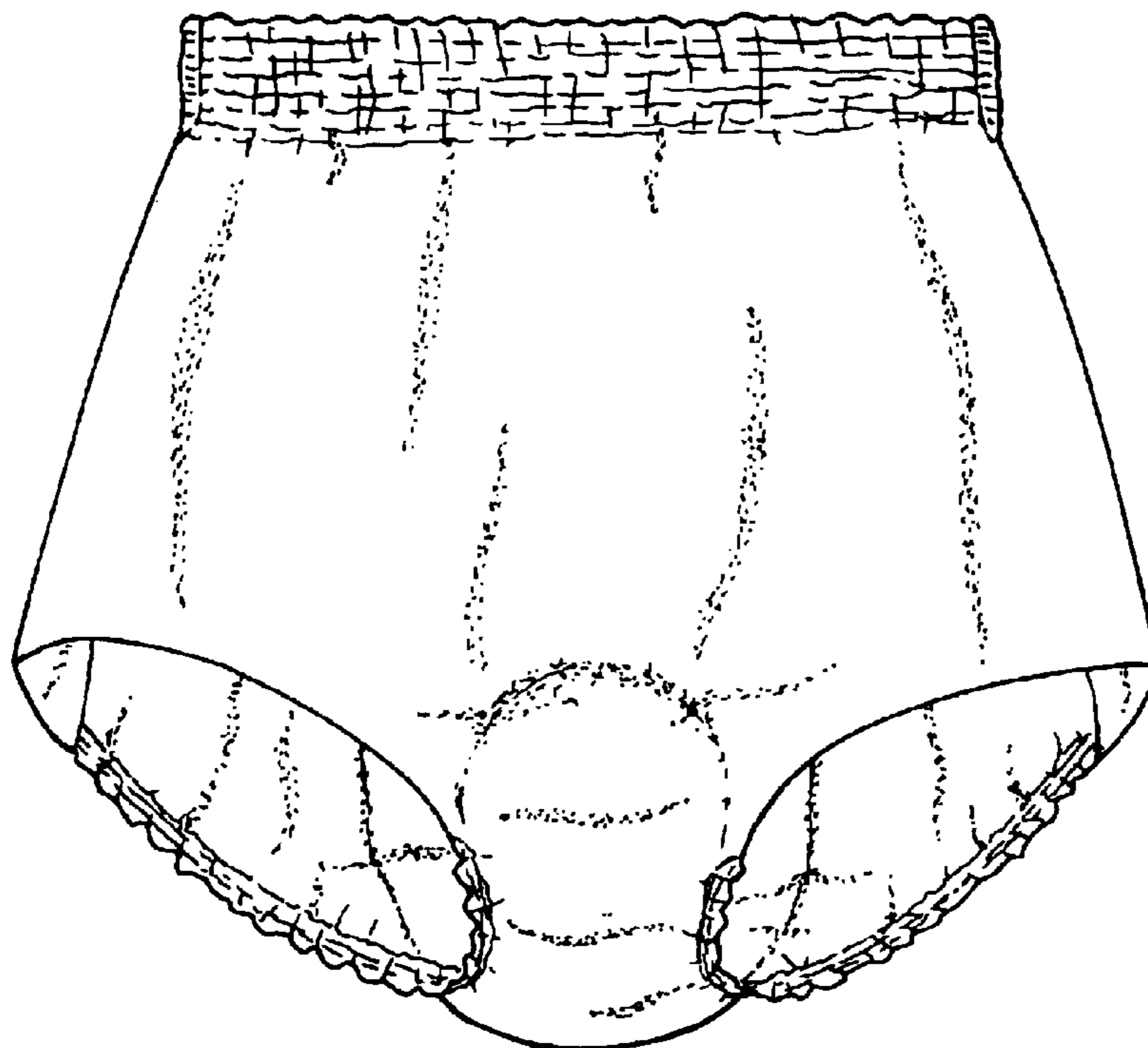
FIG. 1 is a front elevational view of an incontinence pant, according to our new design;

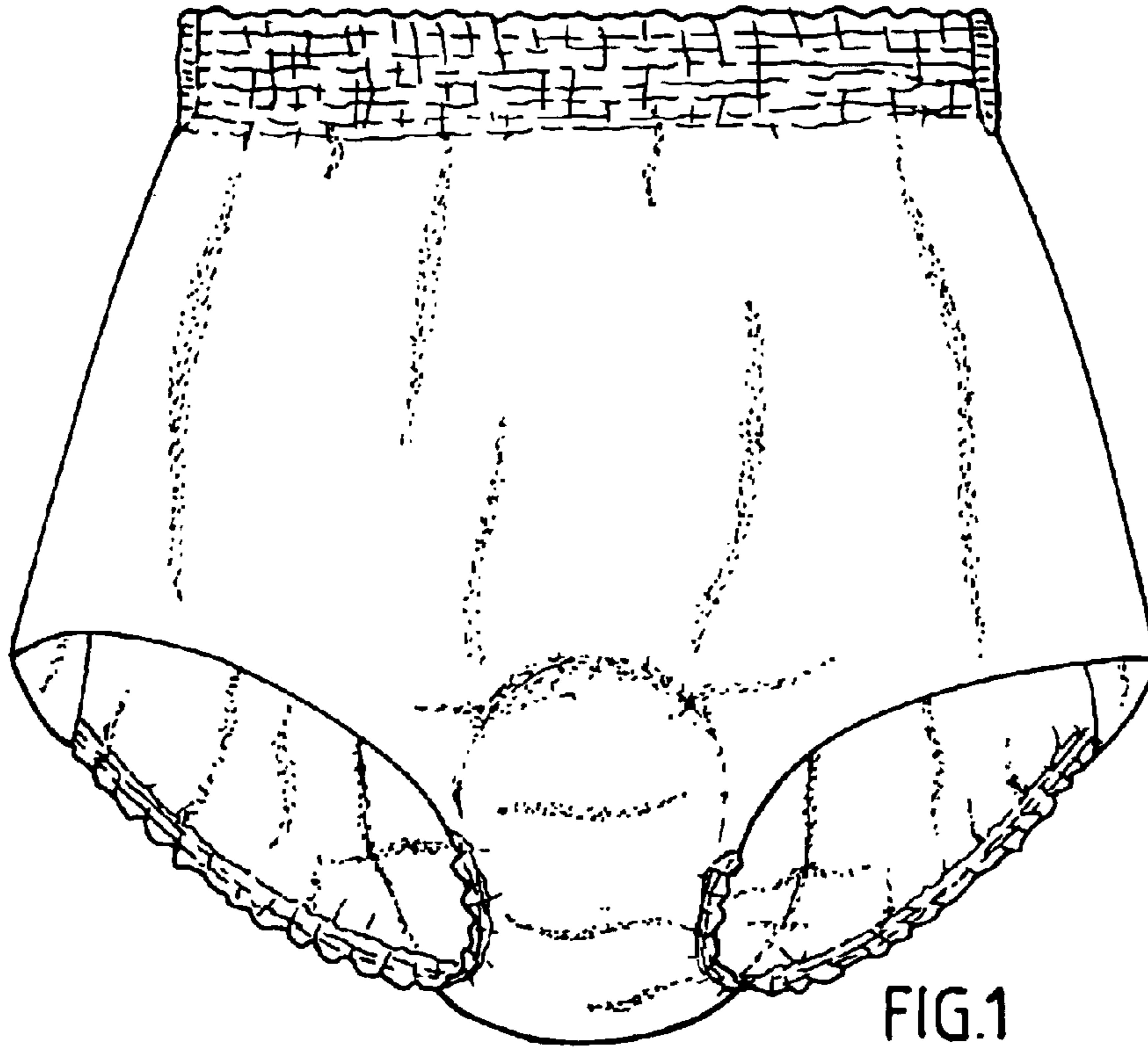

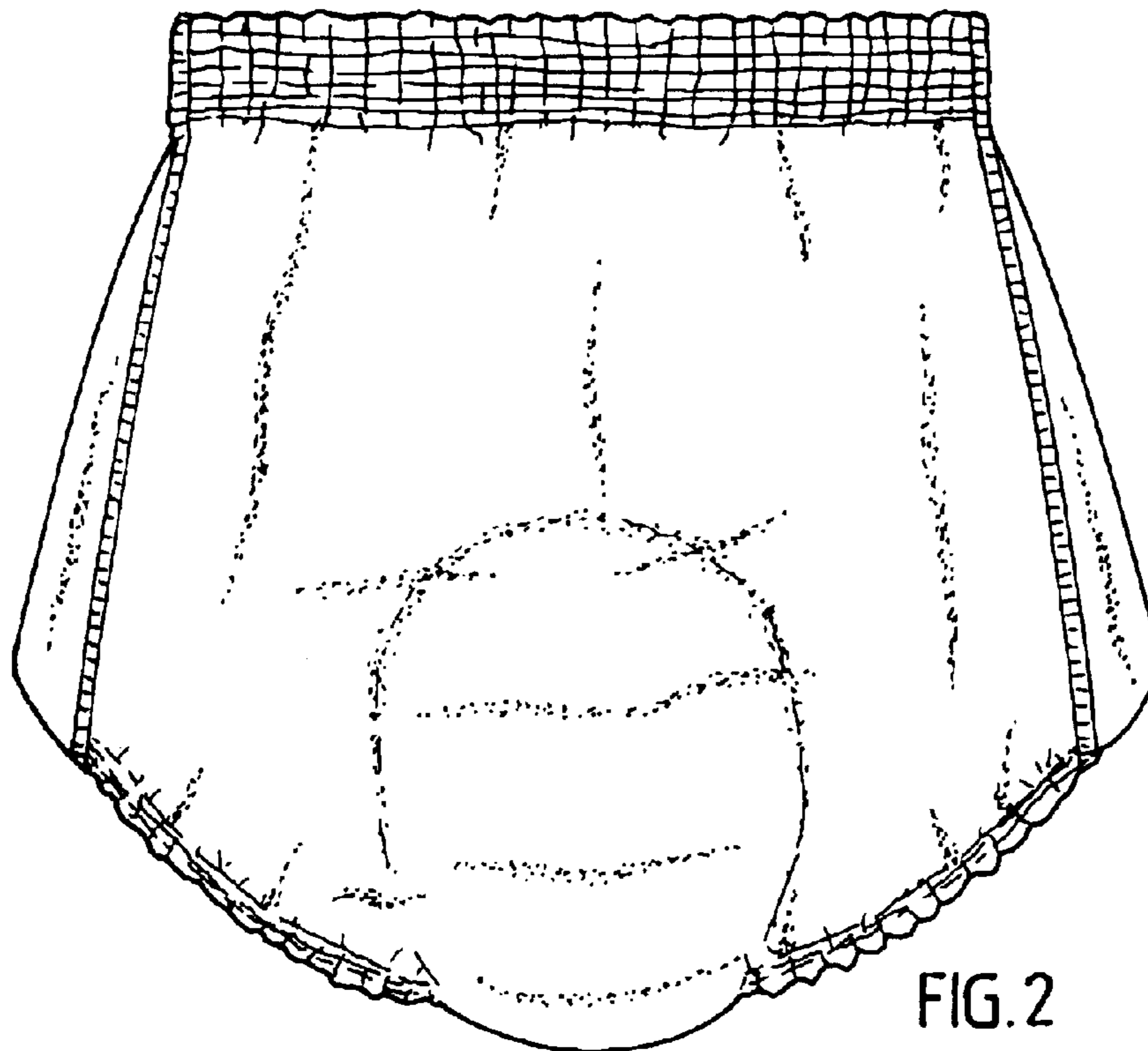

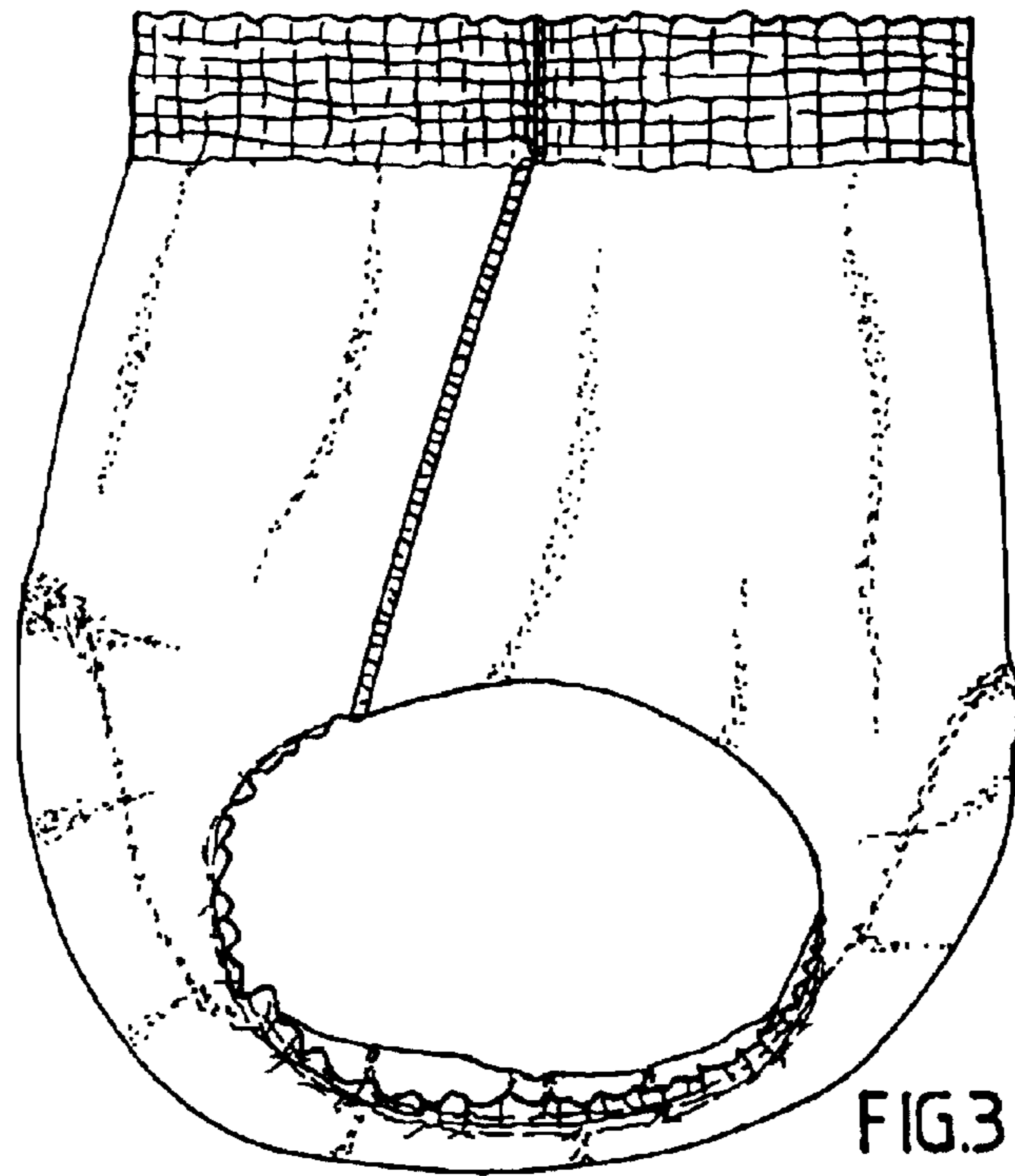

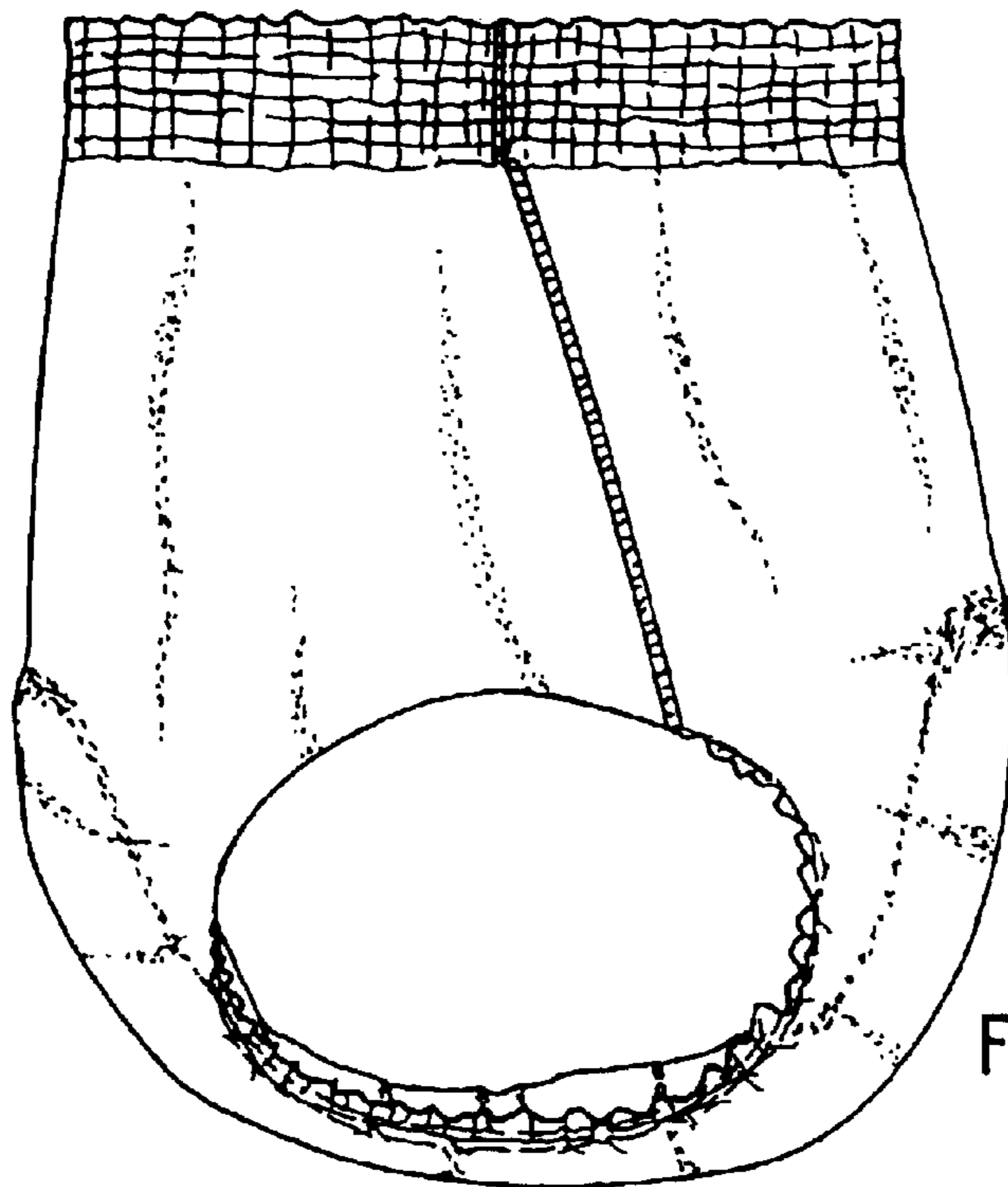
