**DESCRIPTION**

FIG. 1 is a view in side elevation of finger massager illustrating my new design.

FIG. 2 is a view in side elevation thereof in which the device has been rotated 180° along the longitudinal axis of the device from the view in FIG. 1.

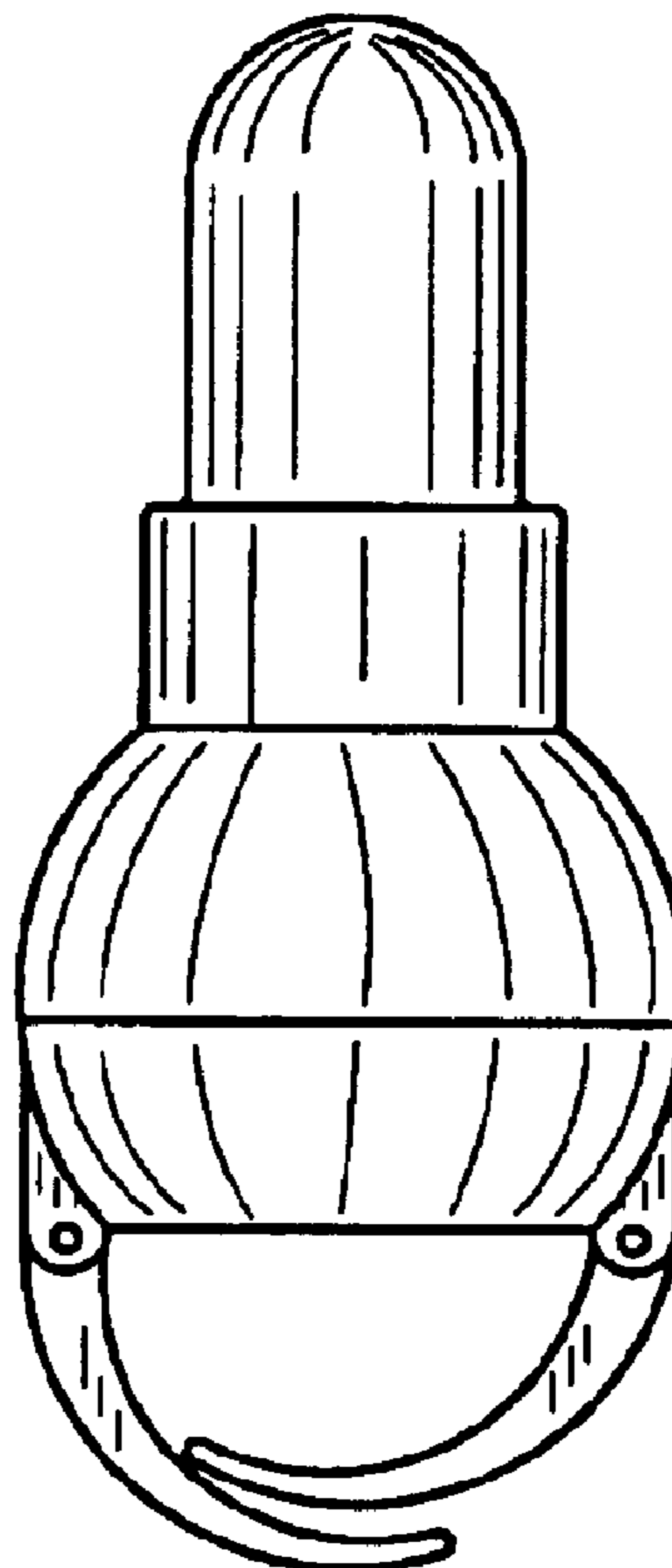
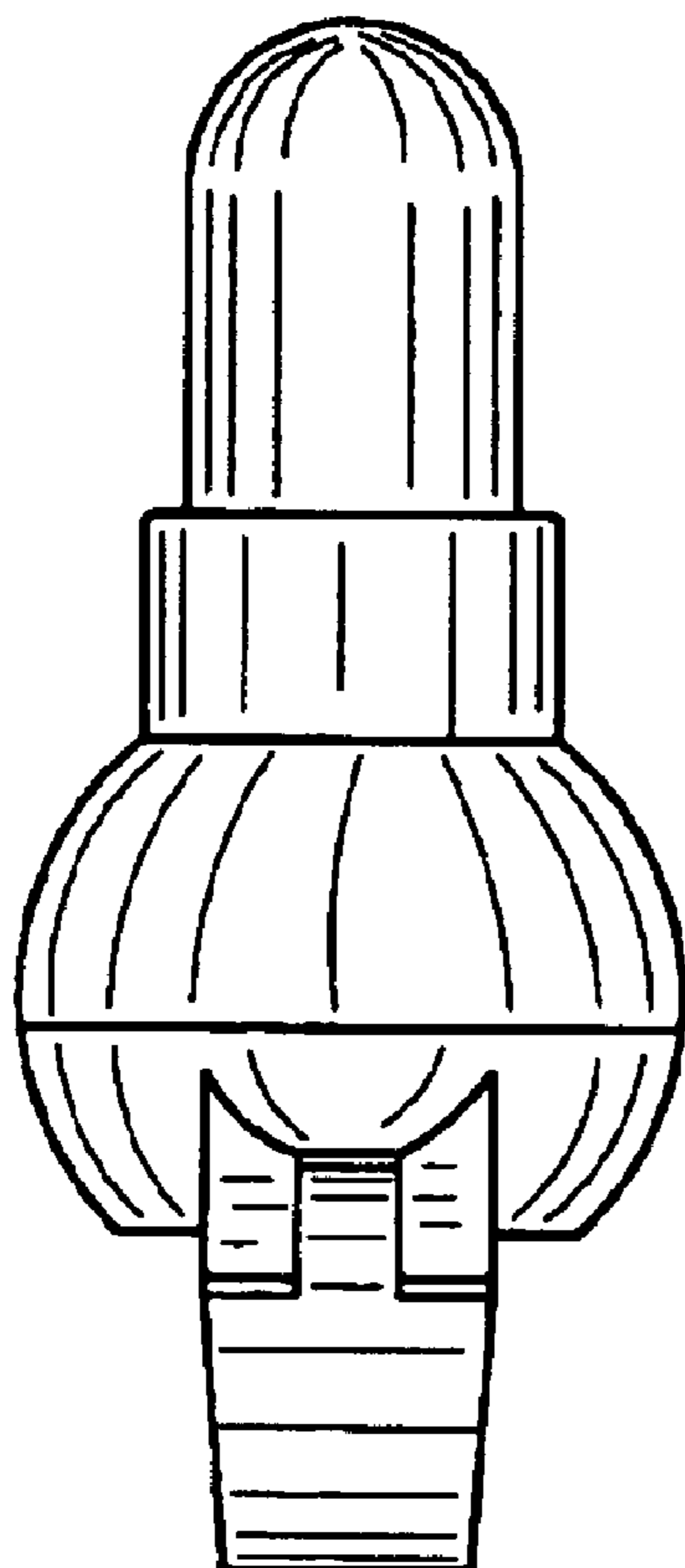
FIG. 3 is a view in side elevation thereof in which the device has been rotated 90° along the longitudinal axis of the device from the view in FIG. 1.

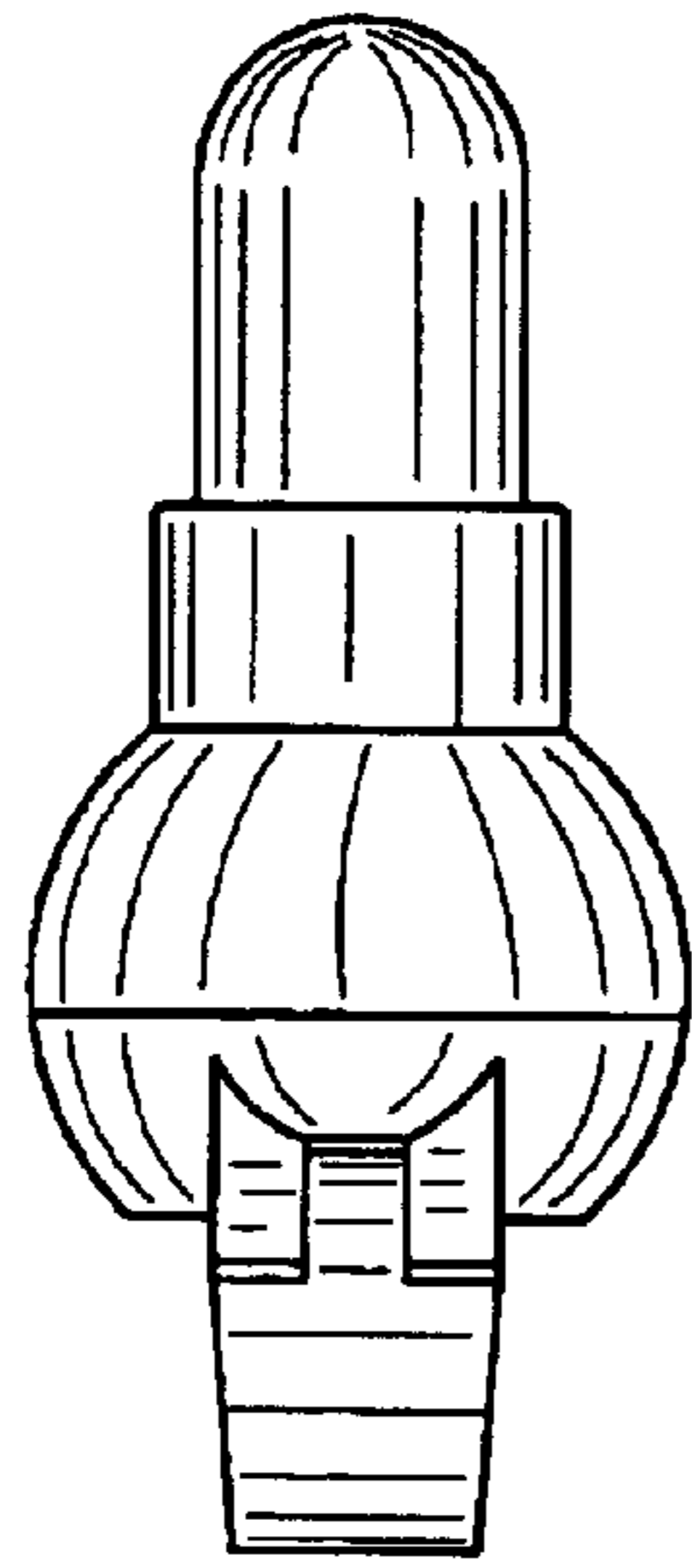

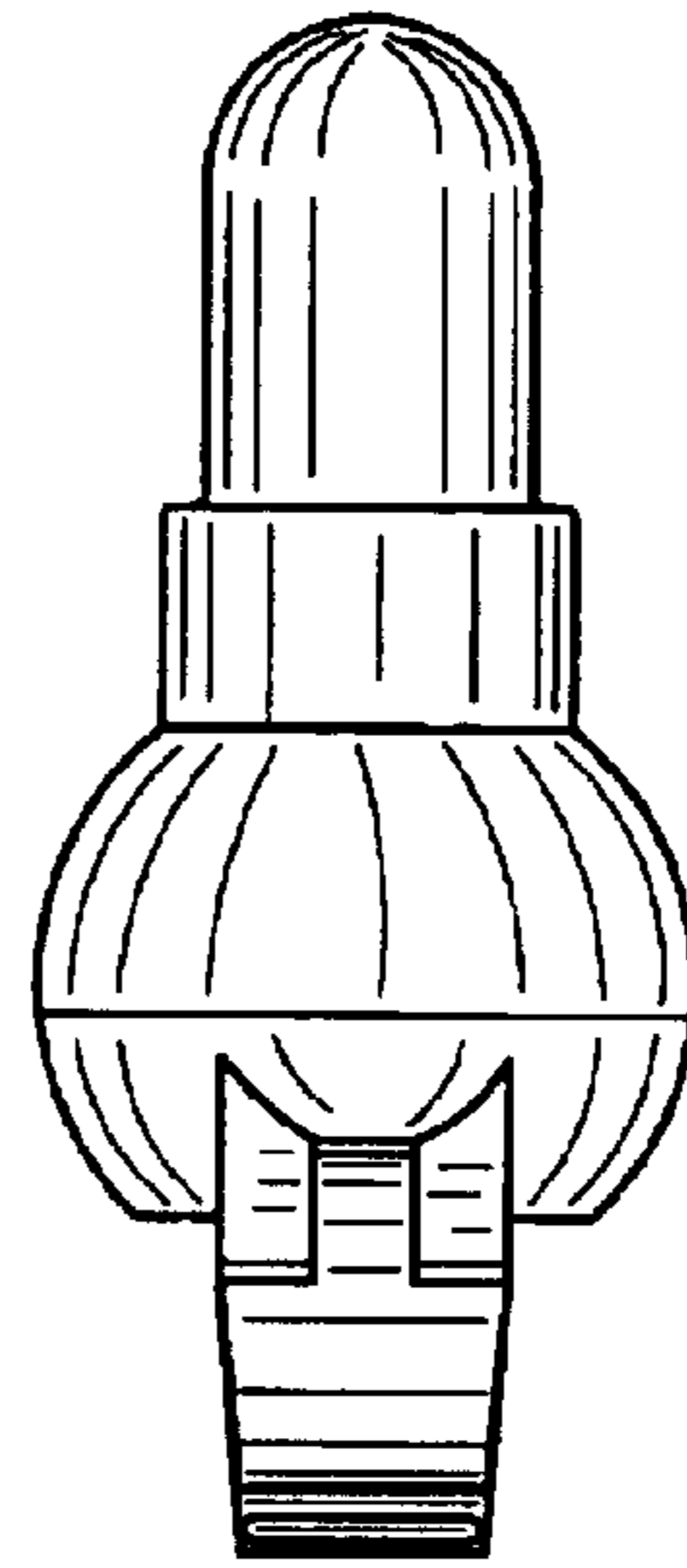

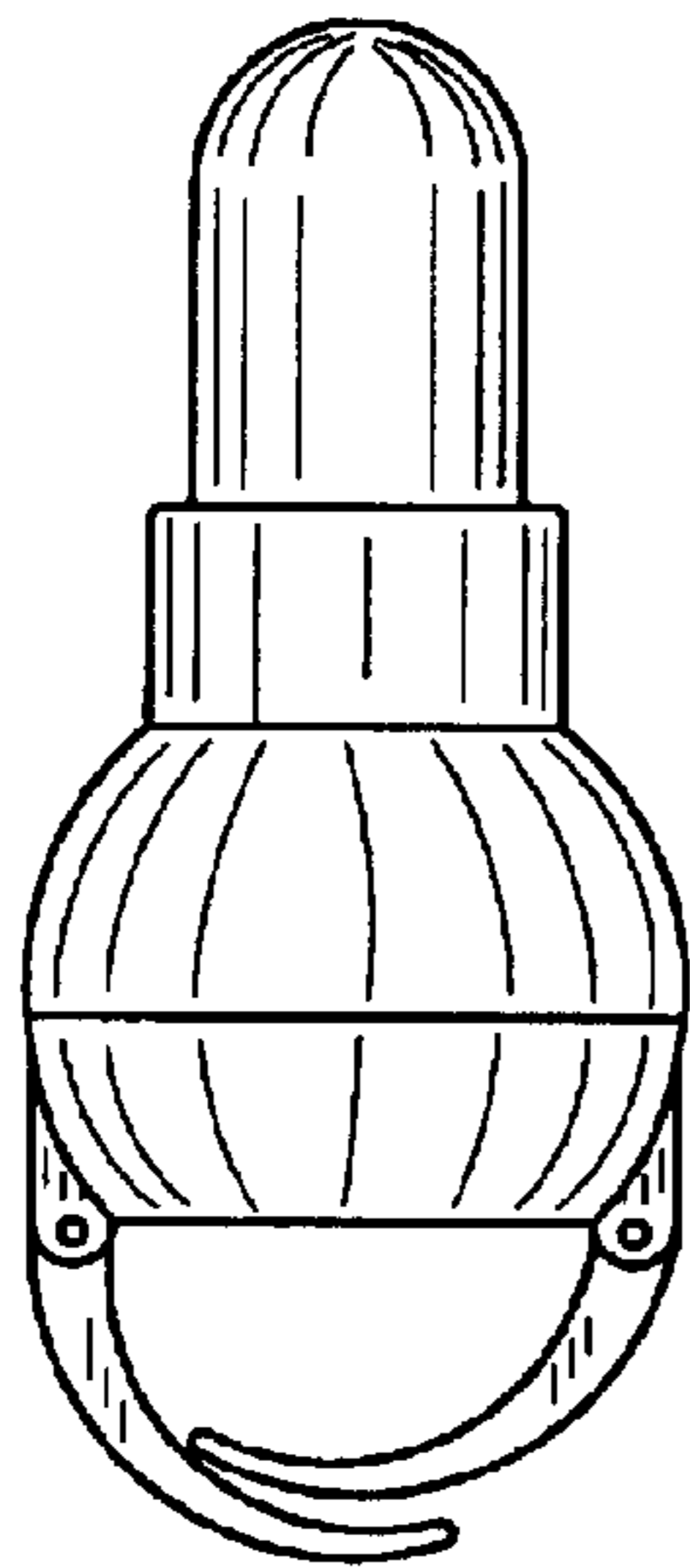

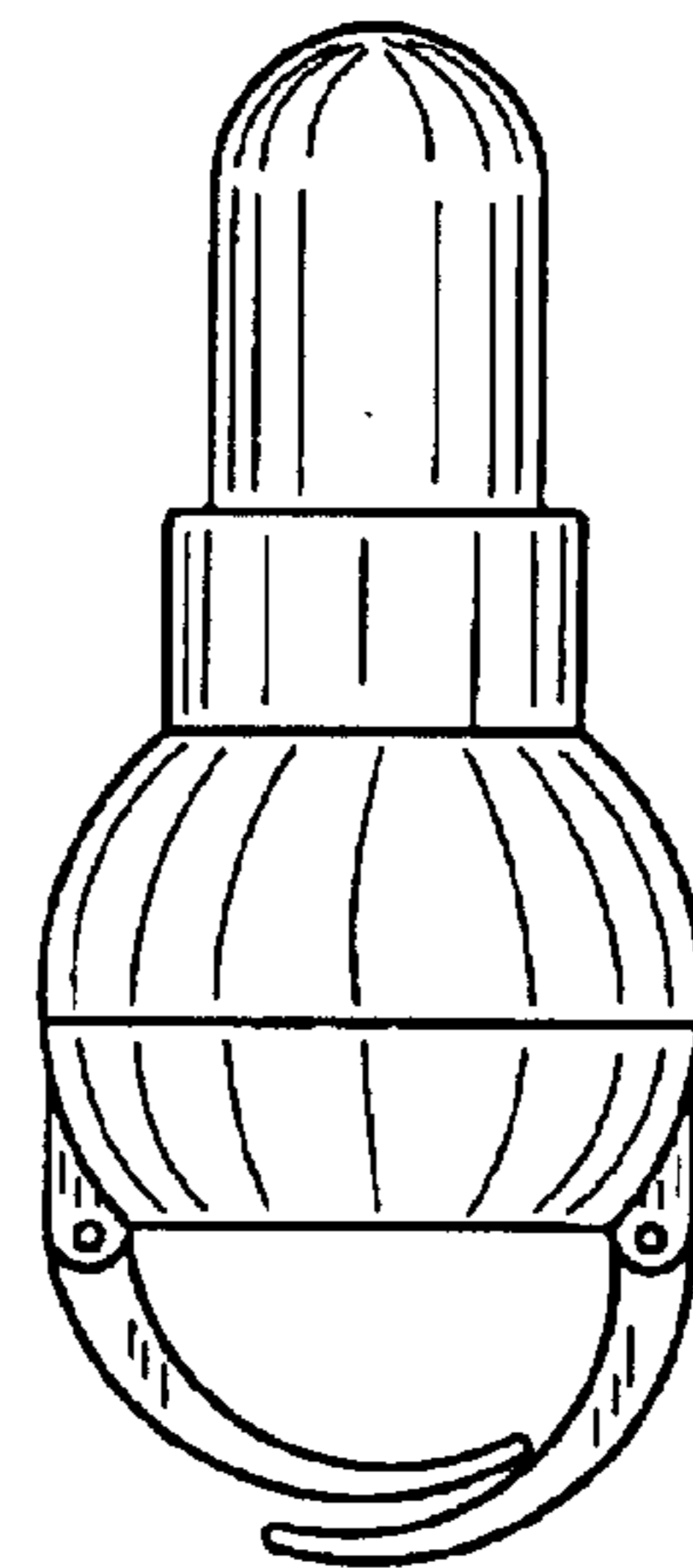

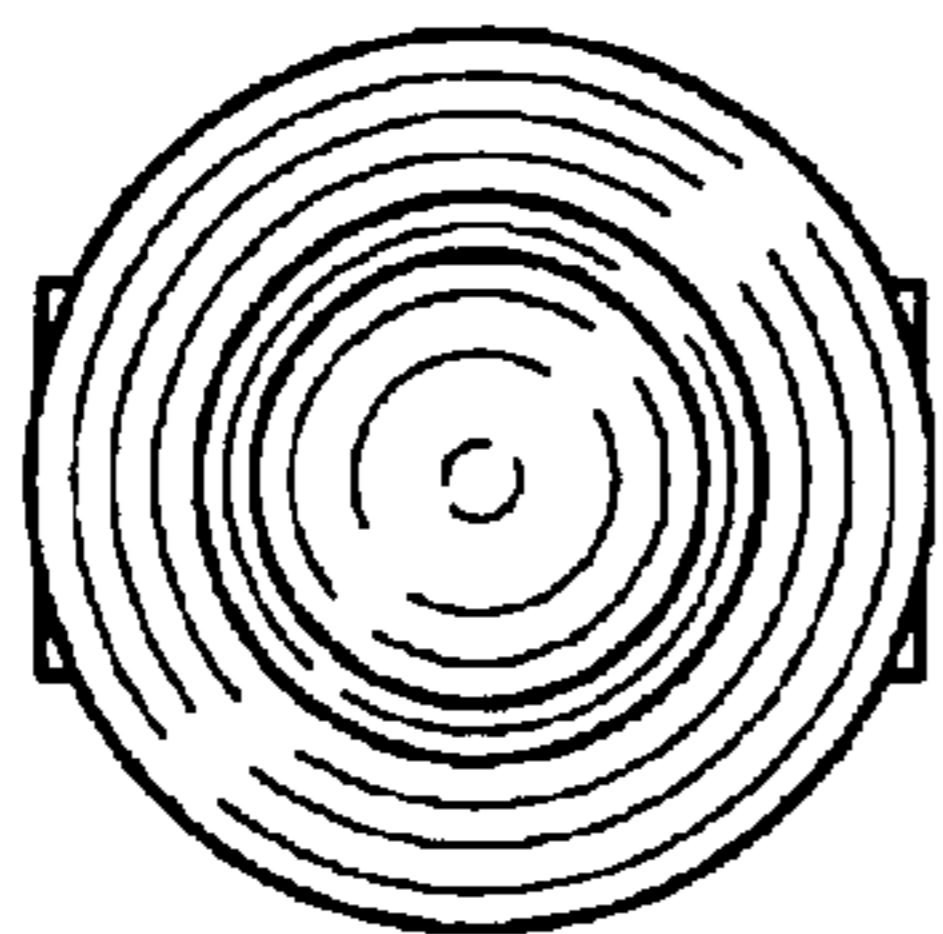

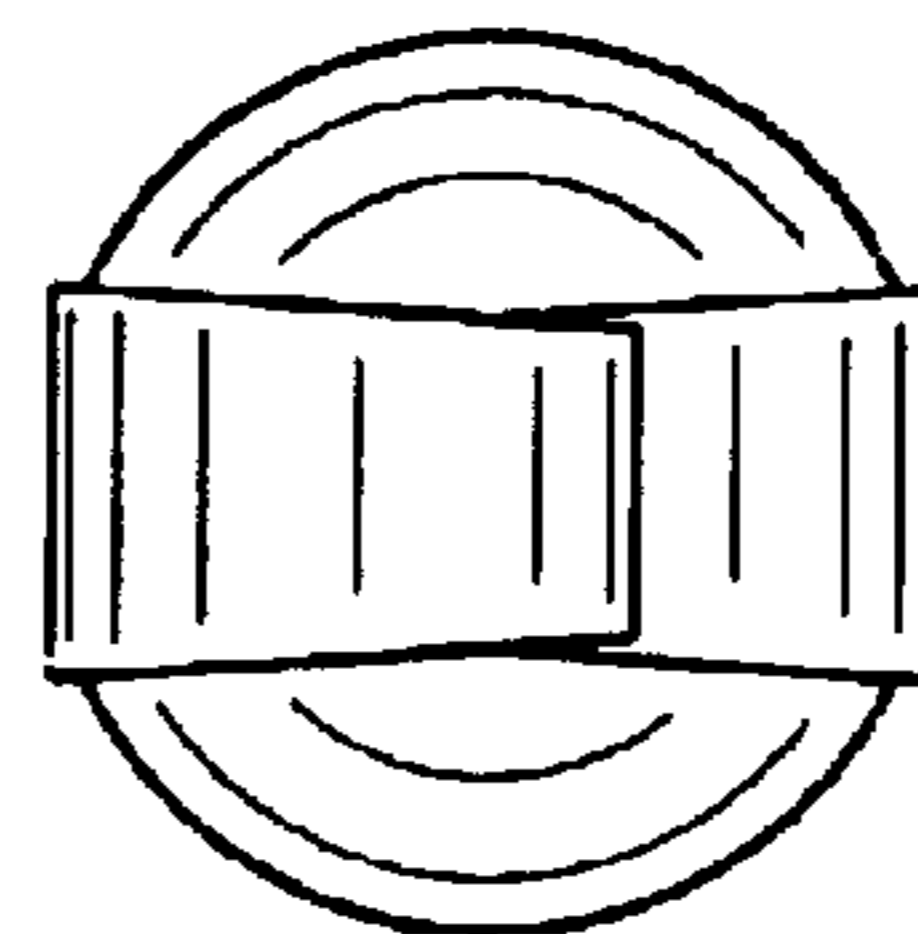
