The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a toothbrush showing our new design;

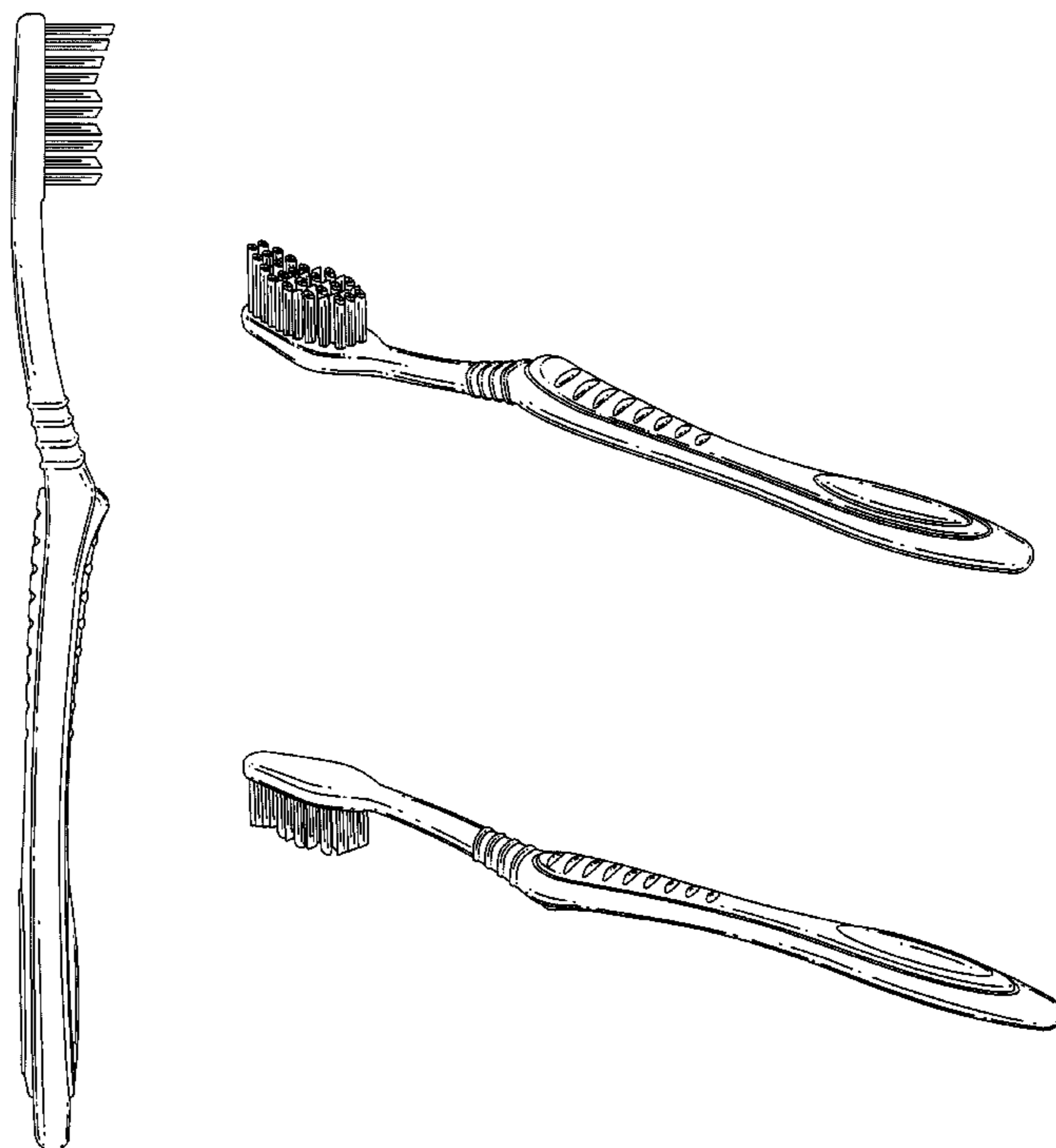

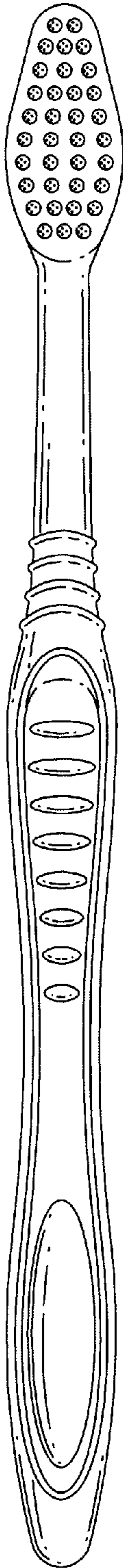

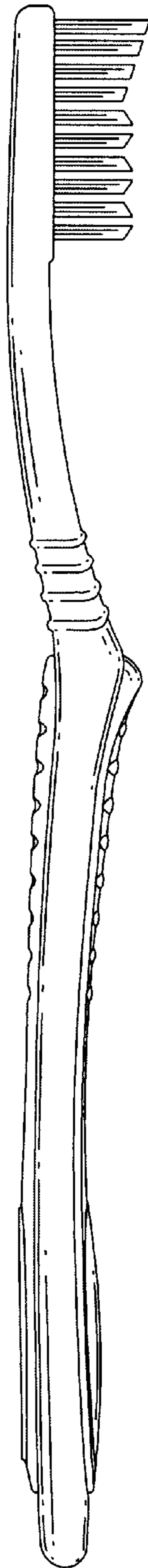
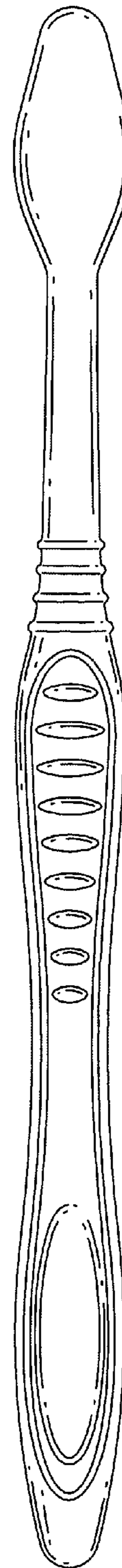
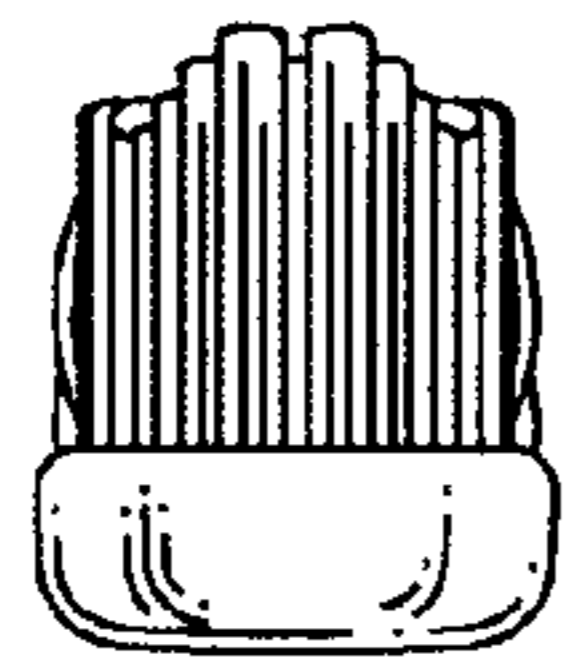


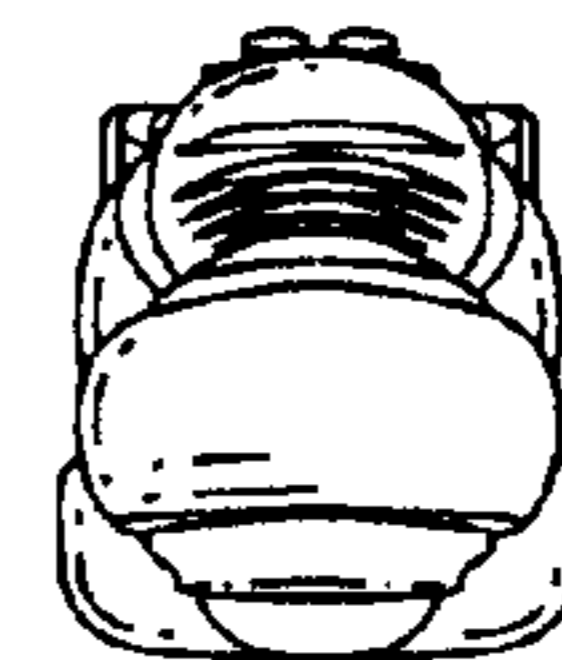

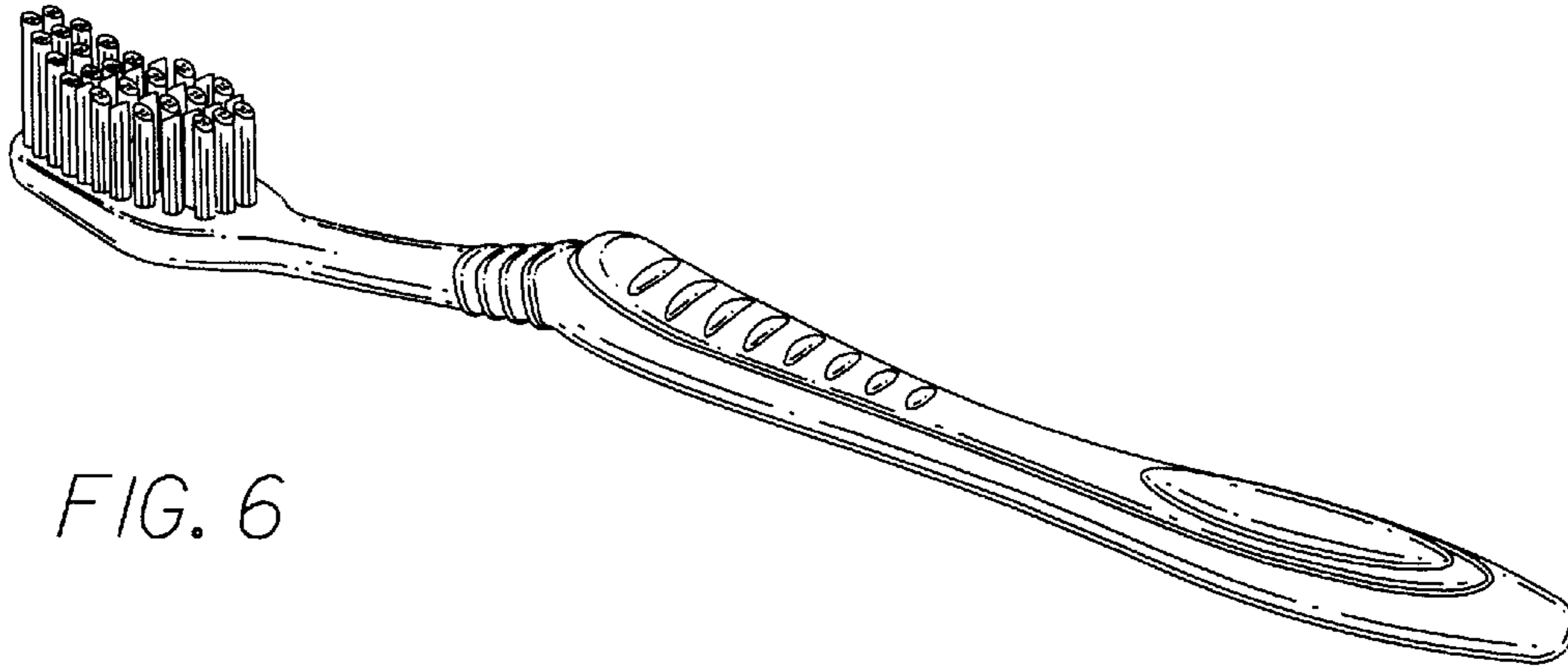

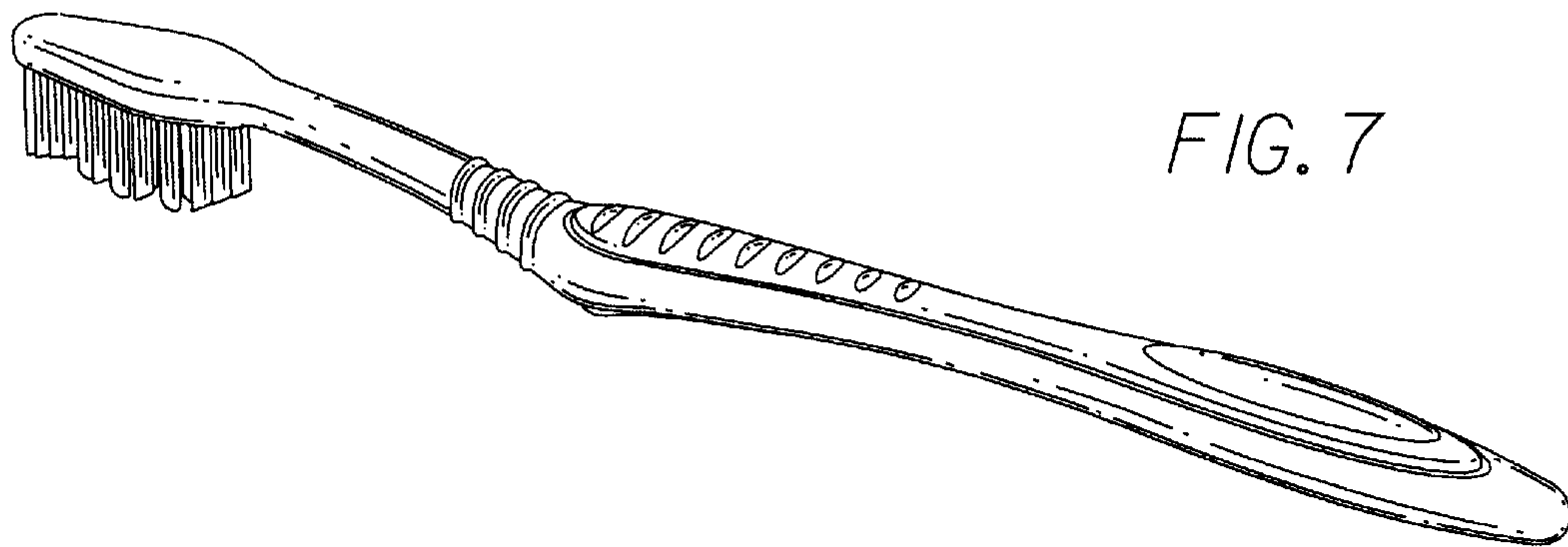

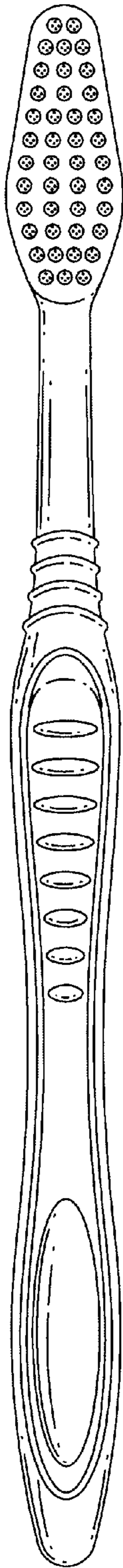

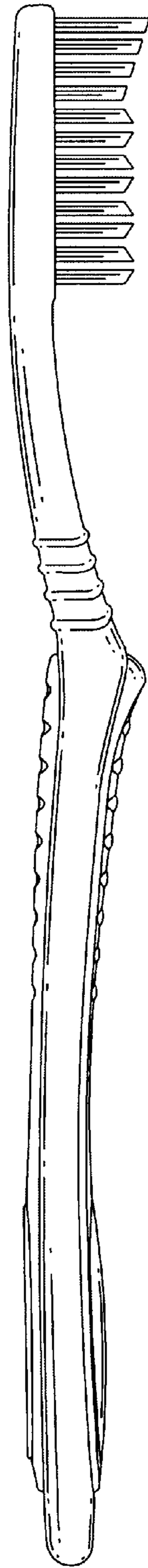
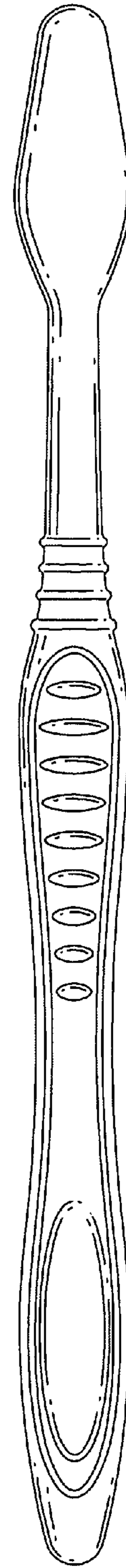
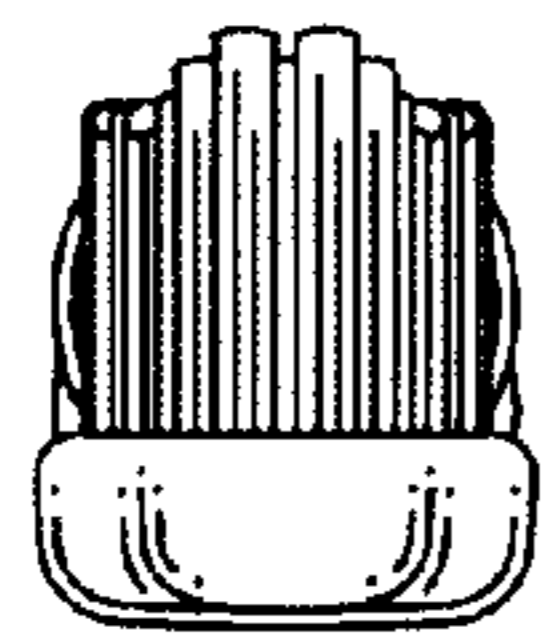


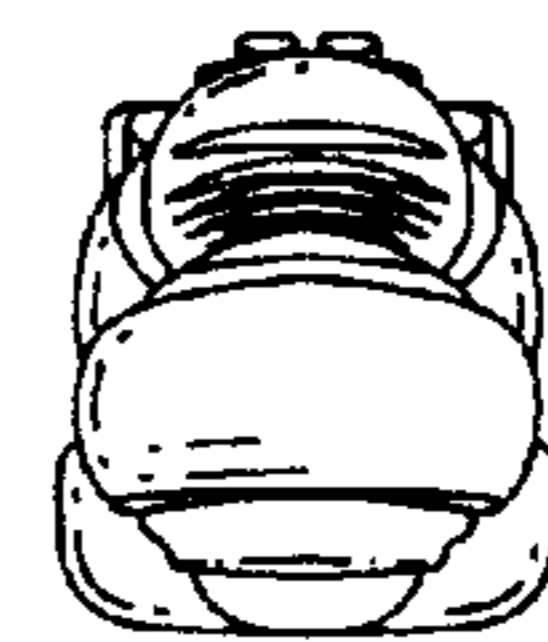

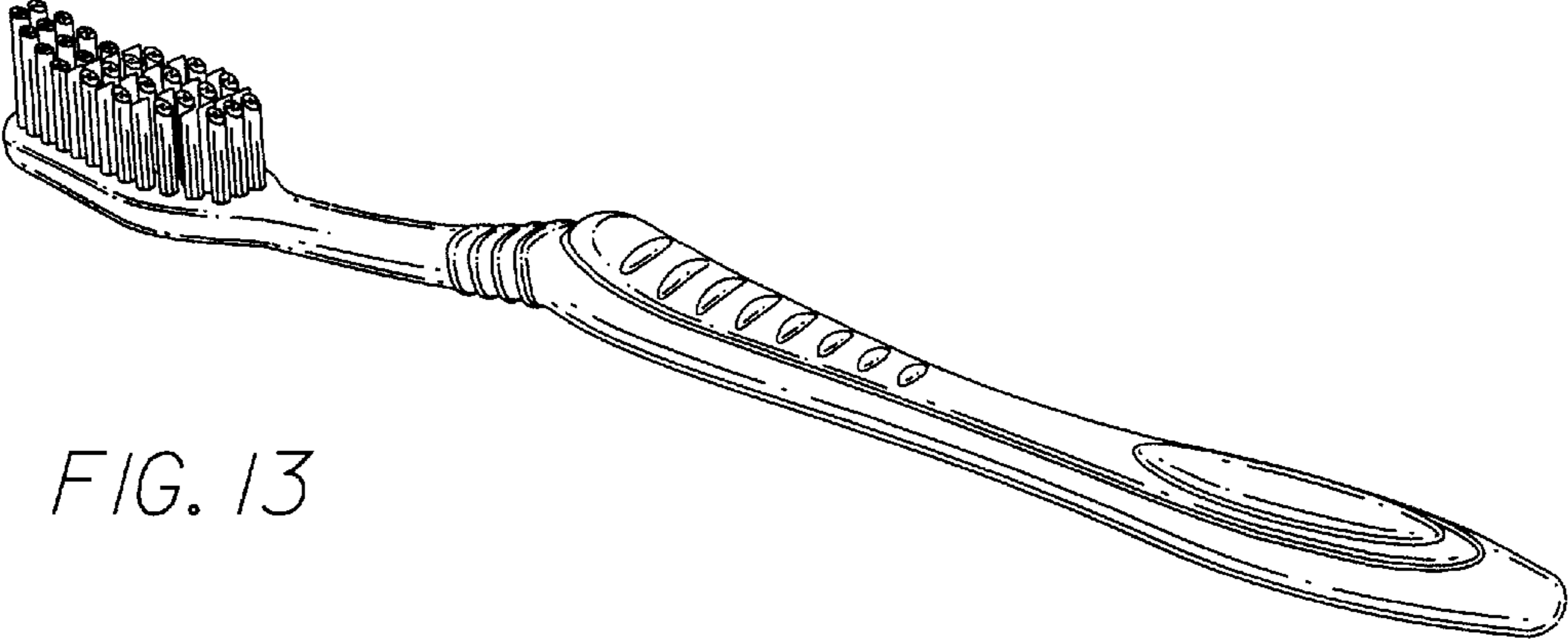

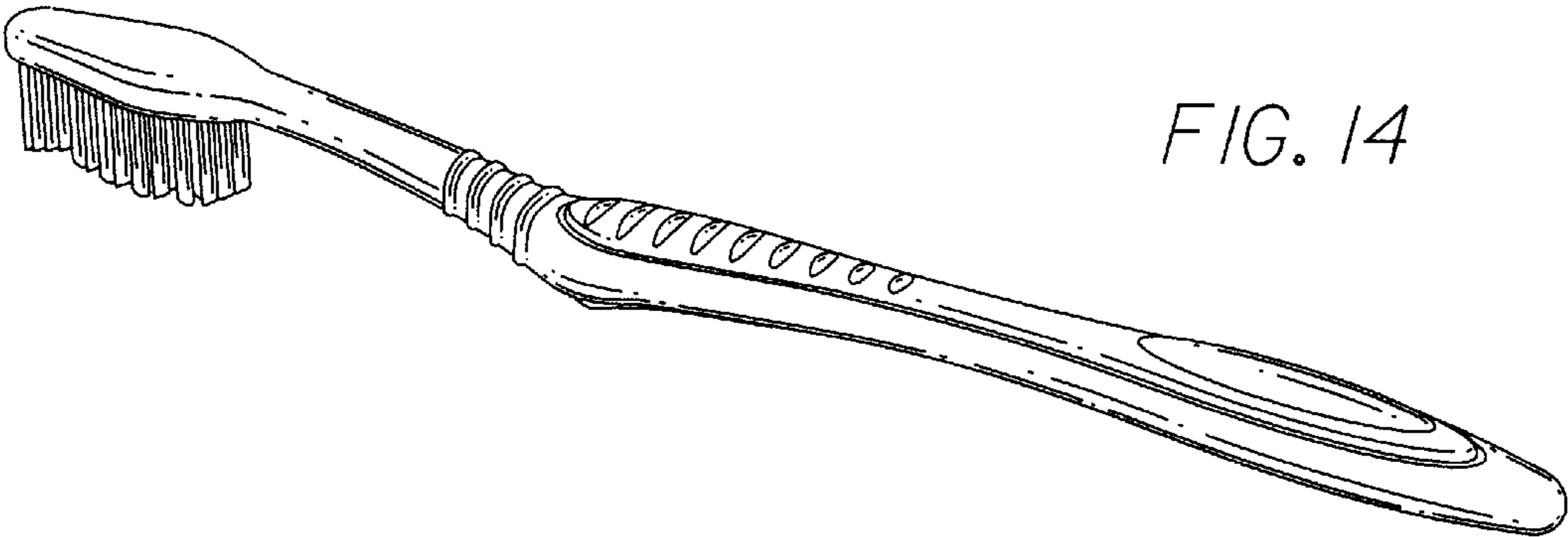
