DESCRIPTION

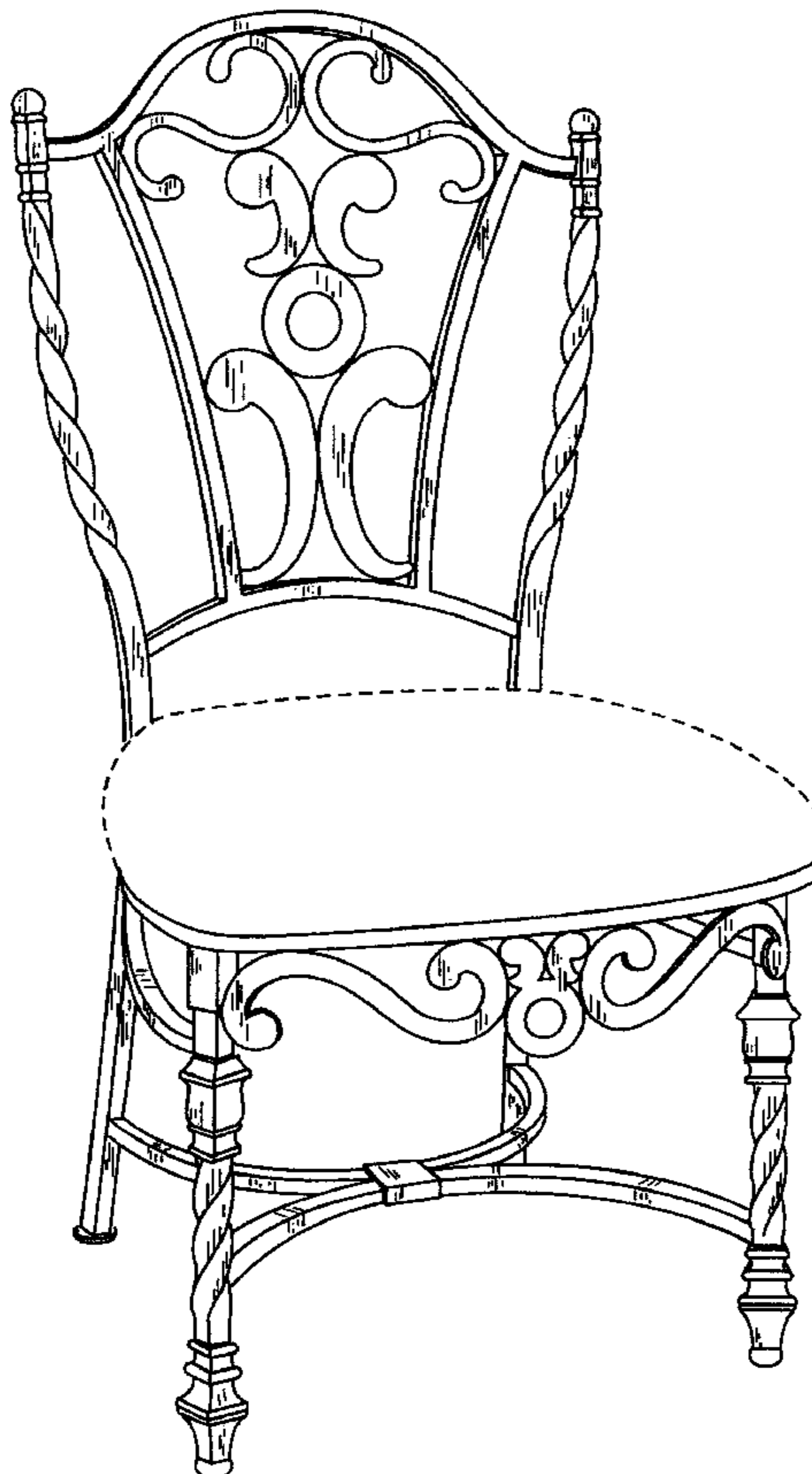
FIG. 1 is a perspective view of a side chair of the invention.

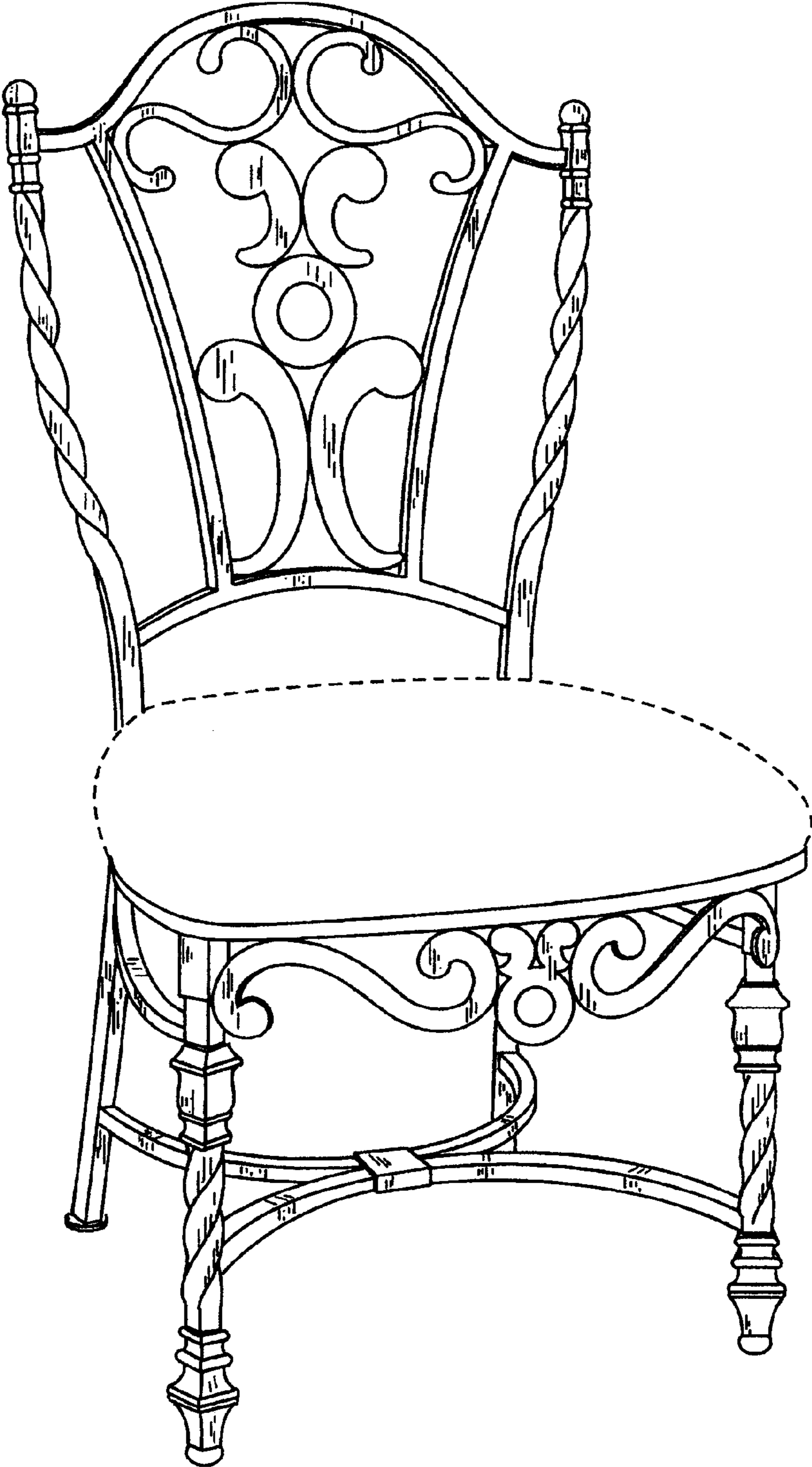

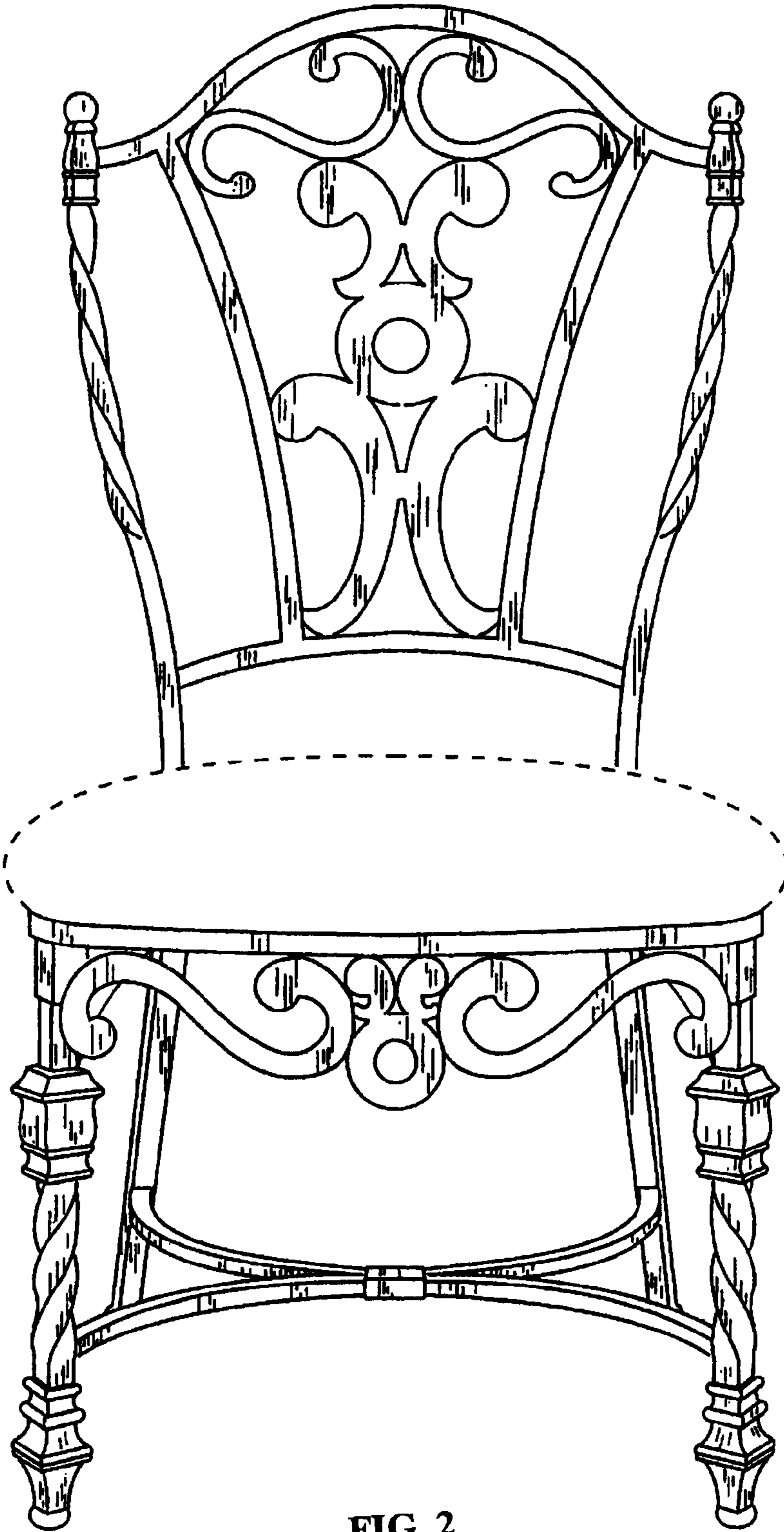

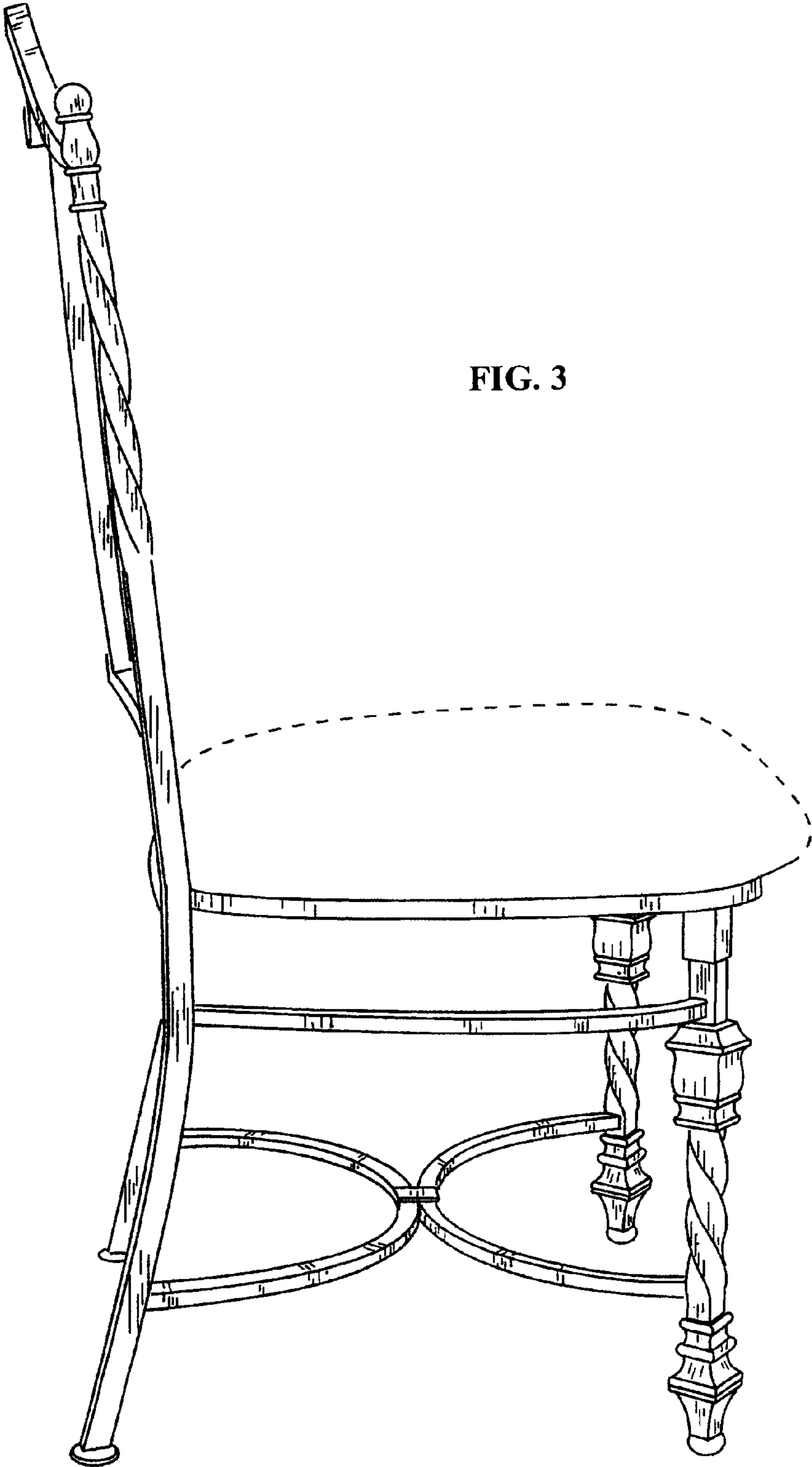
