We claim the ornamental design for a martial arts belt display case, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a display case showing our new design;

FIG. 2 is a front elevation view thereof;

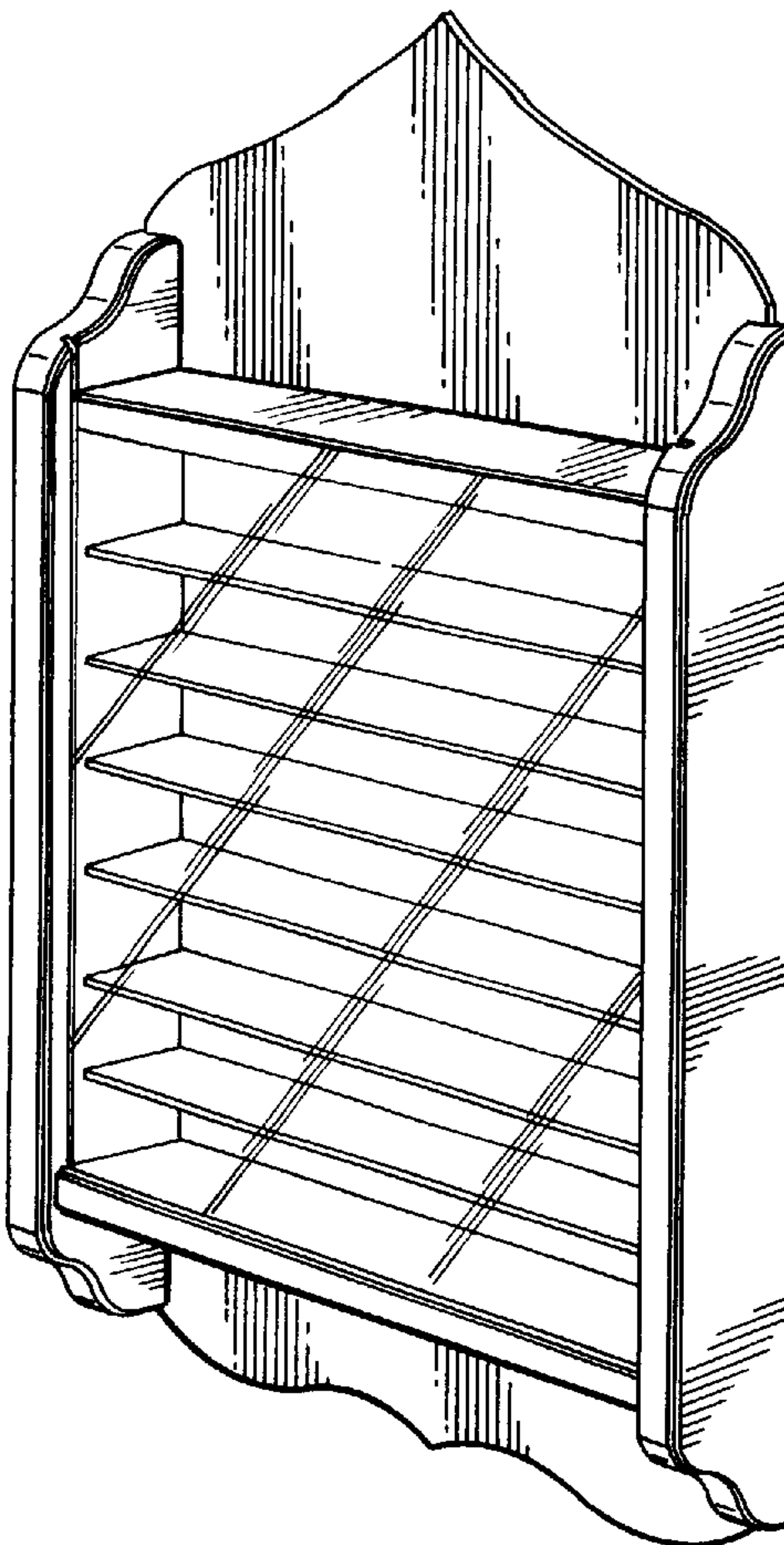
FIG. 3 is a left side elevation view thereof, the right side being a mirror image thereof;

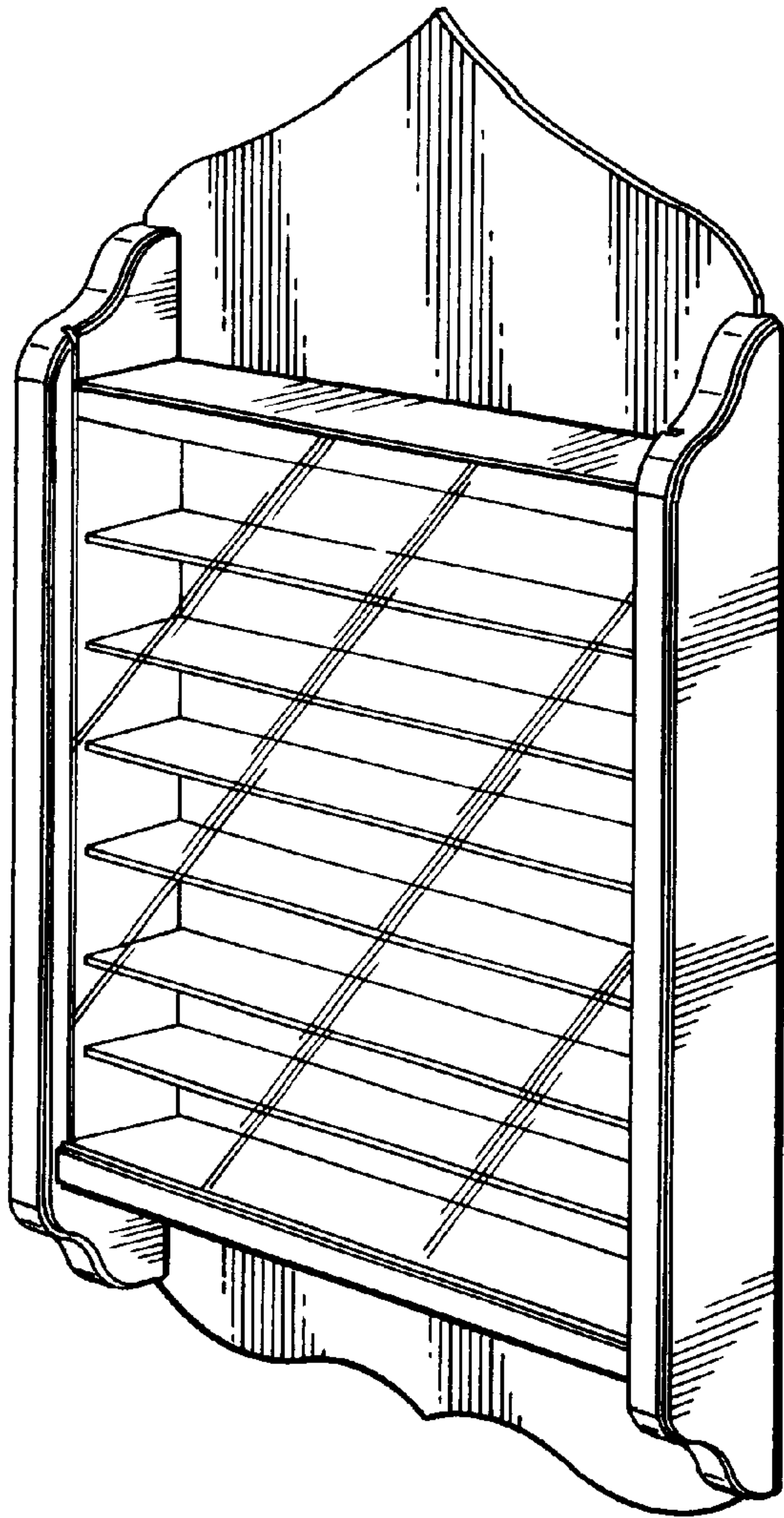

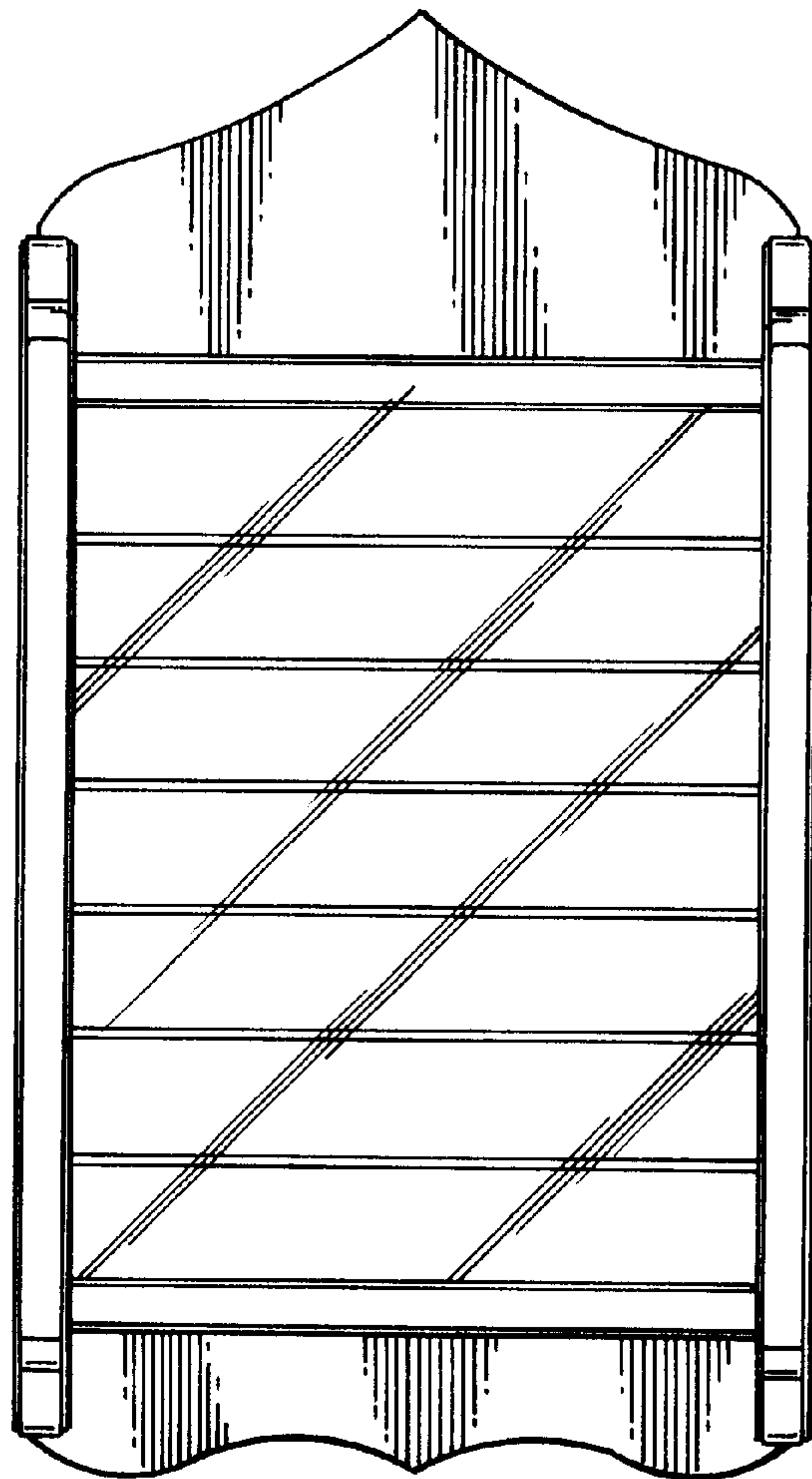

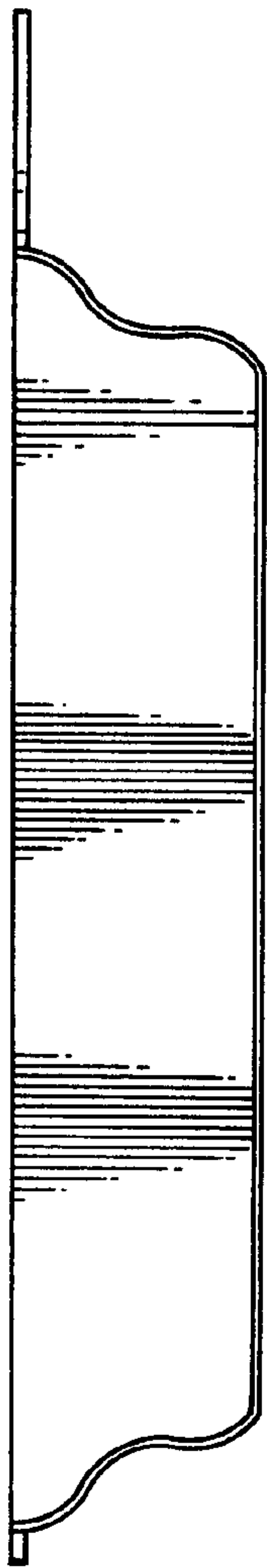

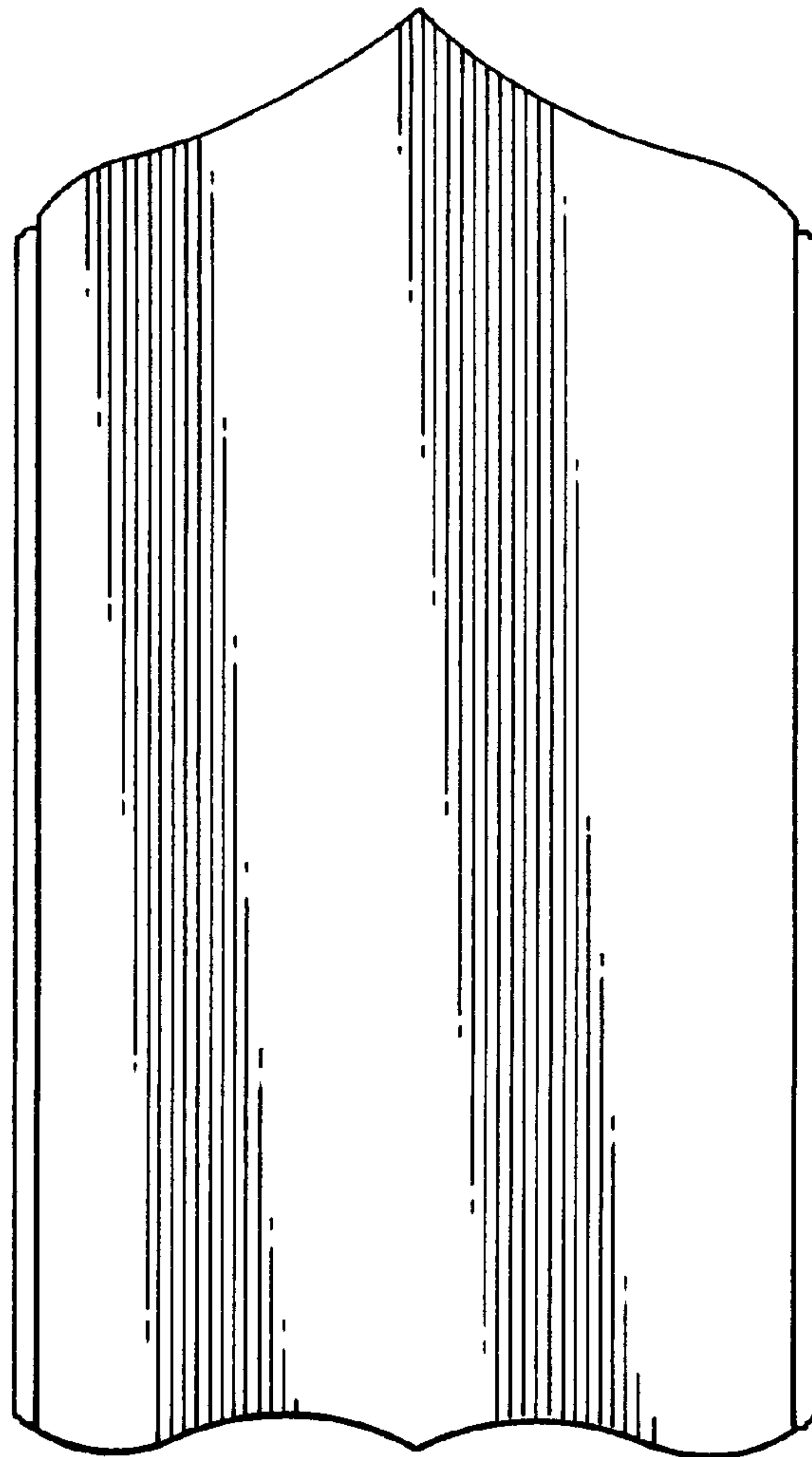

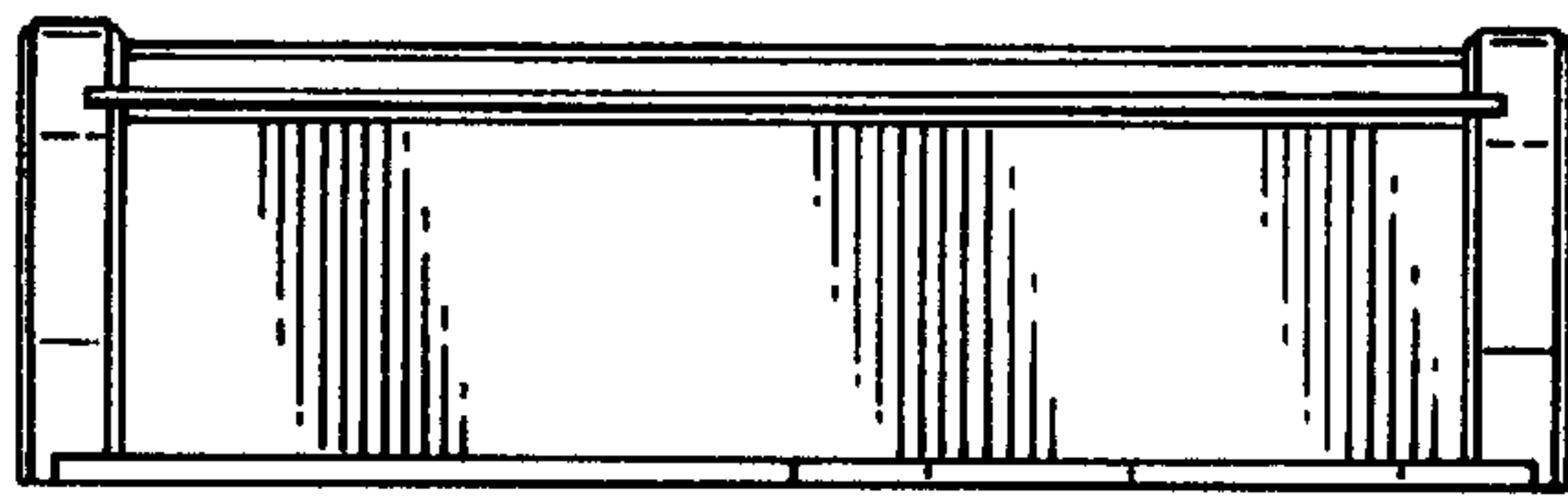
