The ornamental design for a portion of a diskette sleeve, as shown and described.

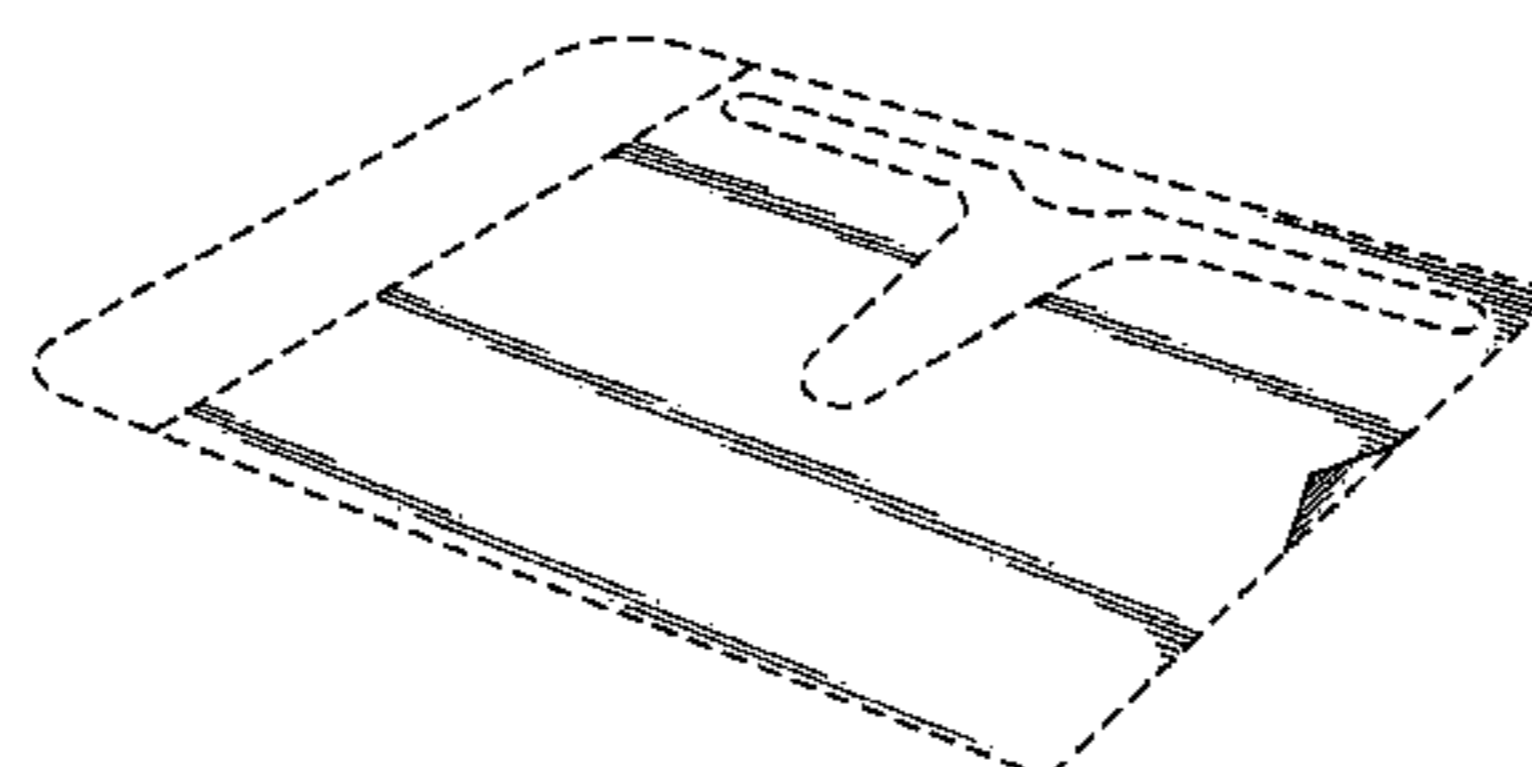
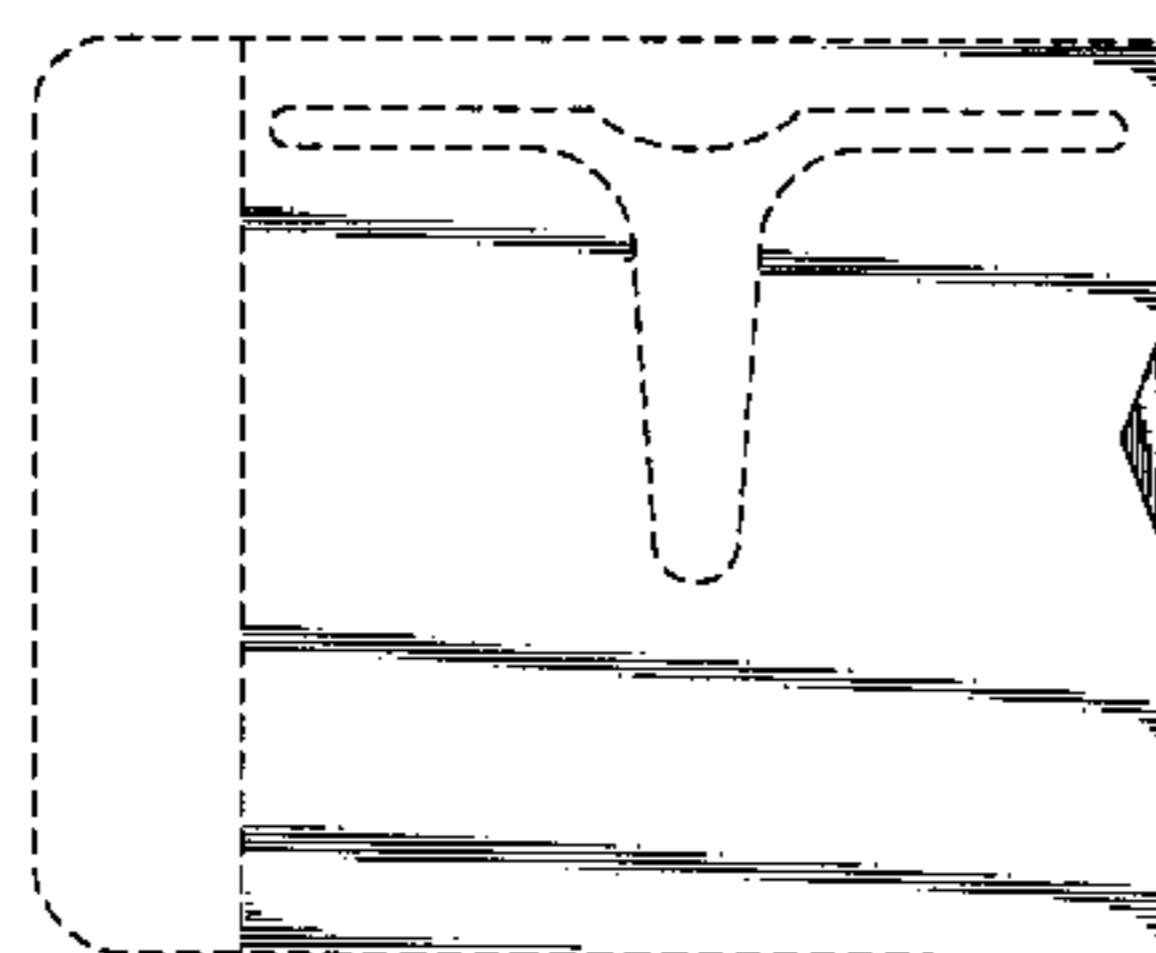
DESCRIPTION
