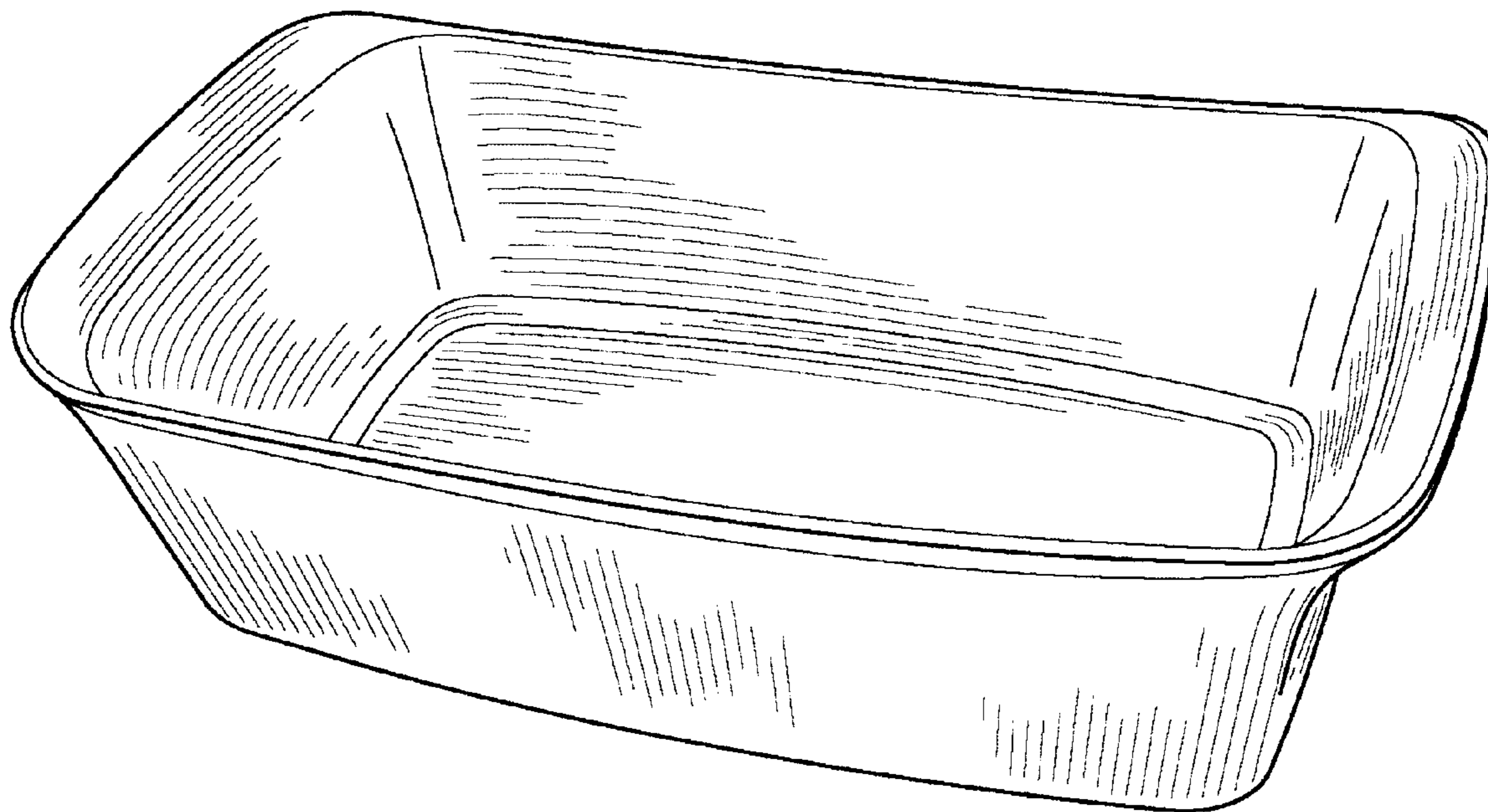
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the dish;
FIG. 2 is a right side elevational view of the dish, the opposite side of which is identical;
FIG. 3 is a front elevational view of the dish, the opposite side of which is identical;
FIG. 4 is a top plan view of the dish; and,
FIG. 5 is a bottom plan view of the dish.

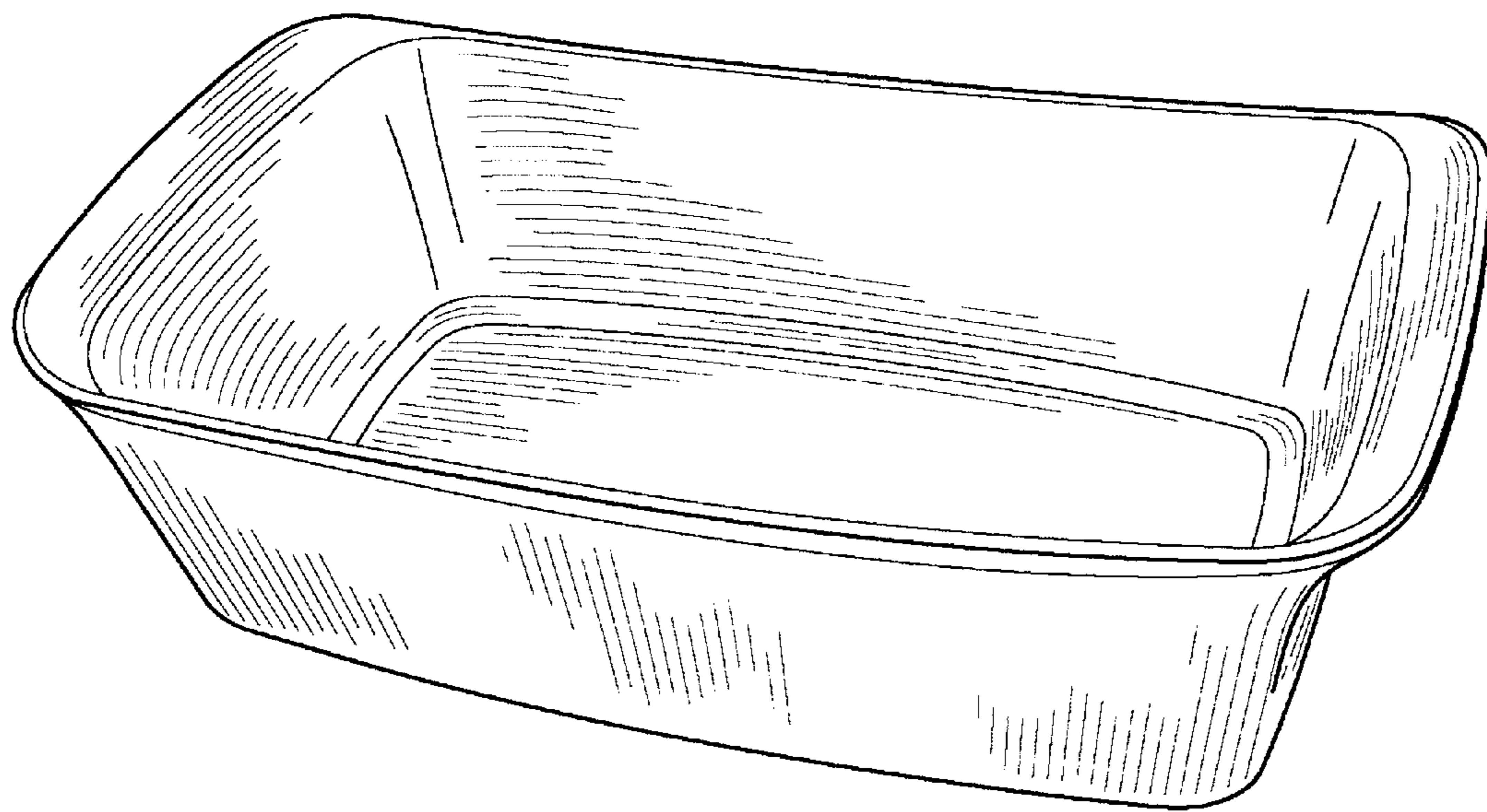

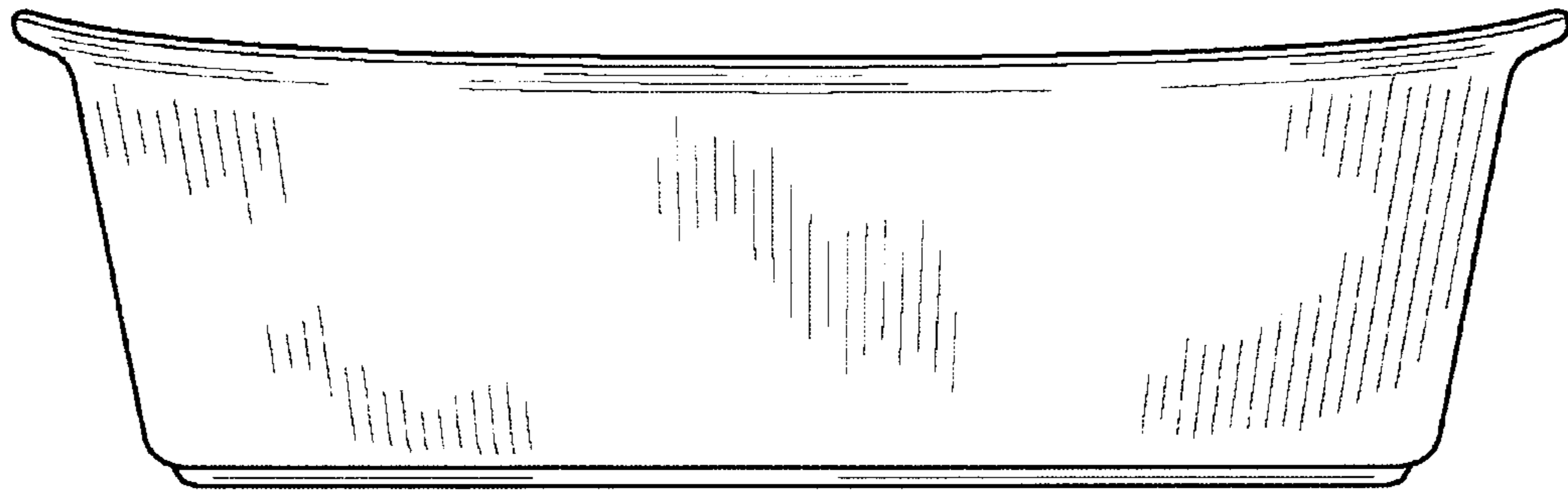

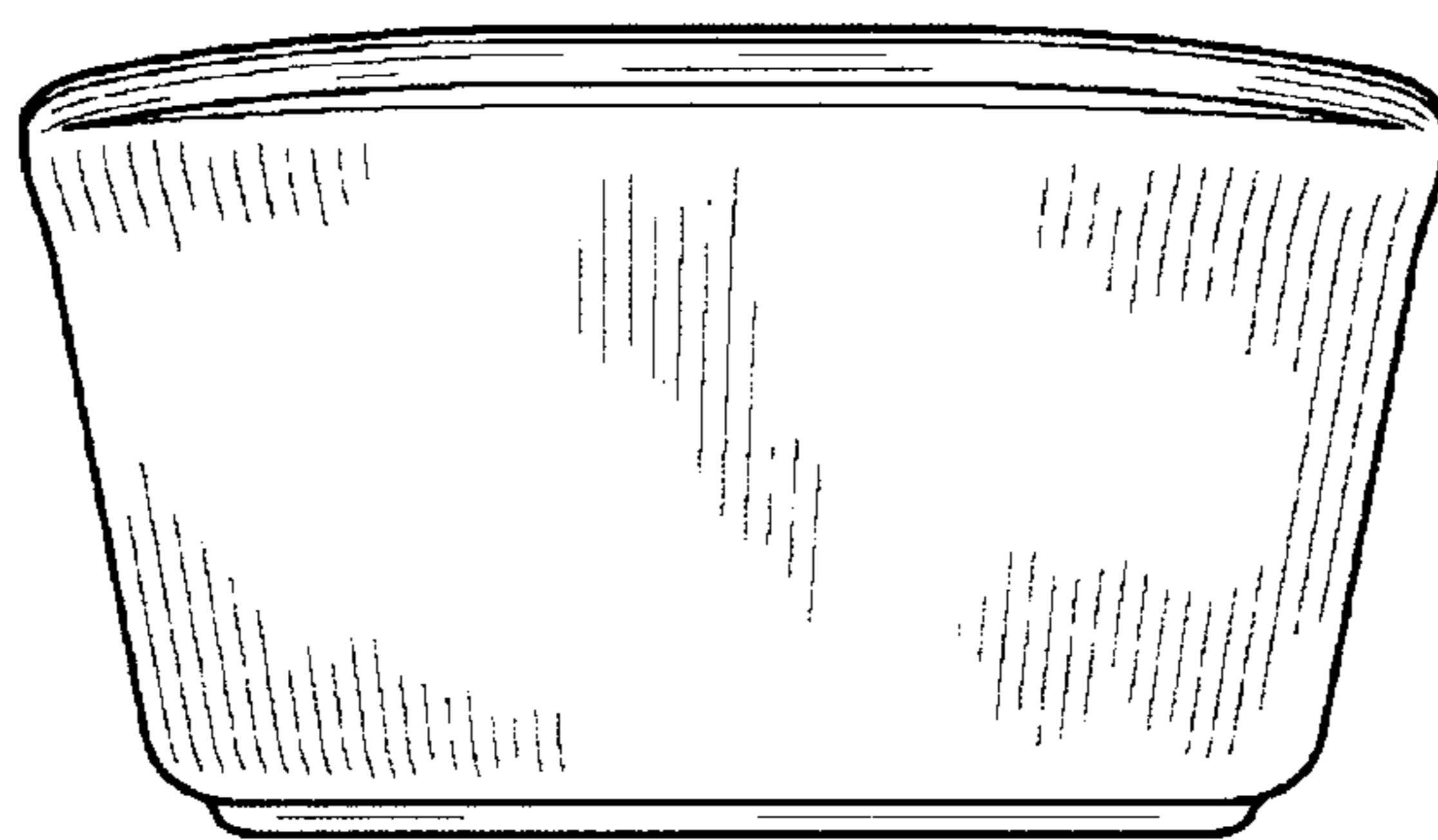

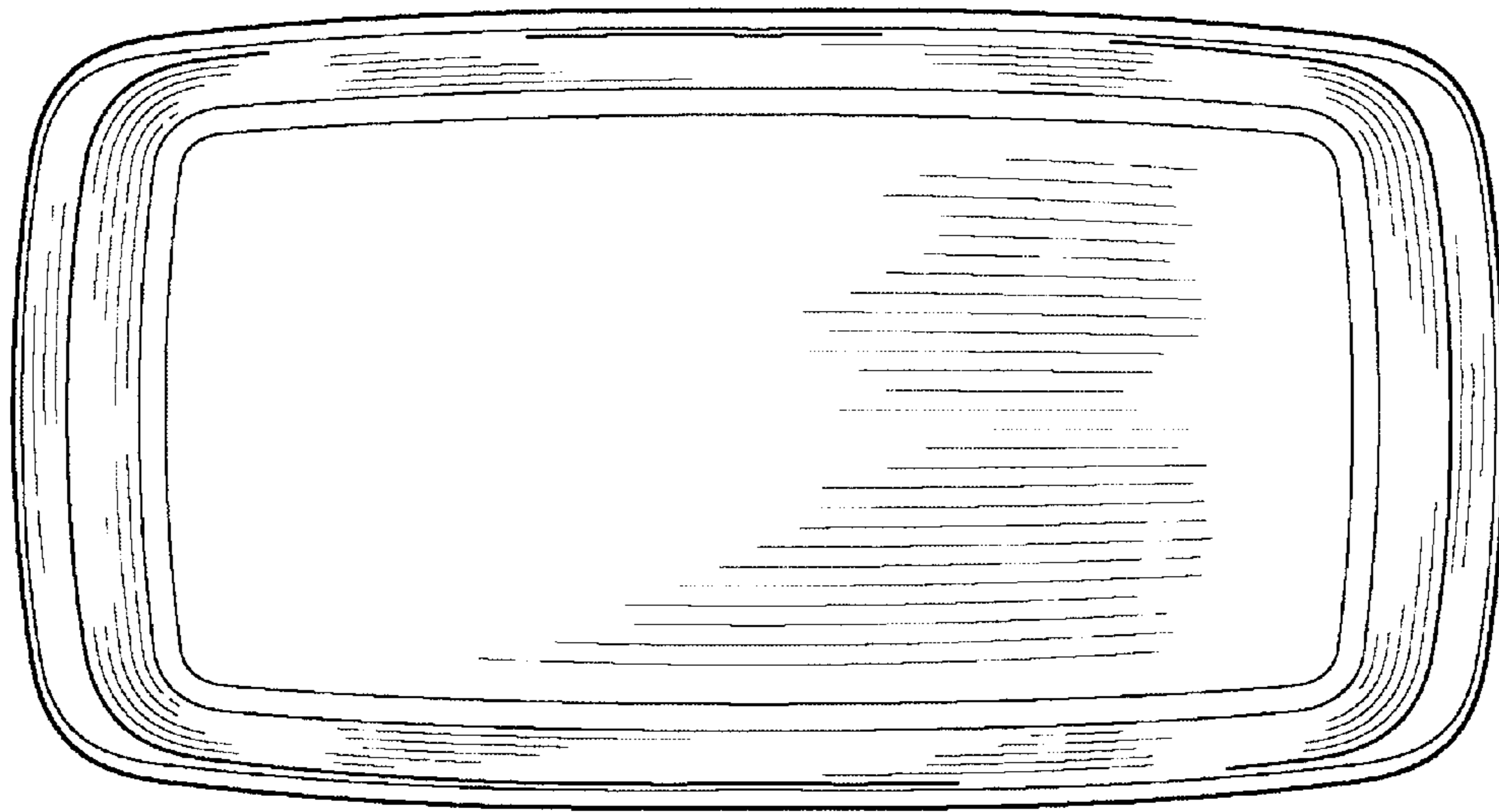

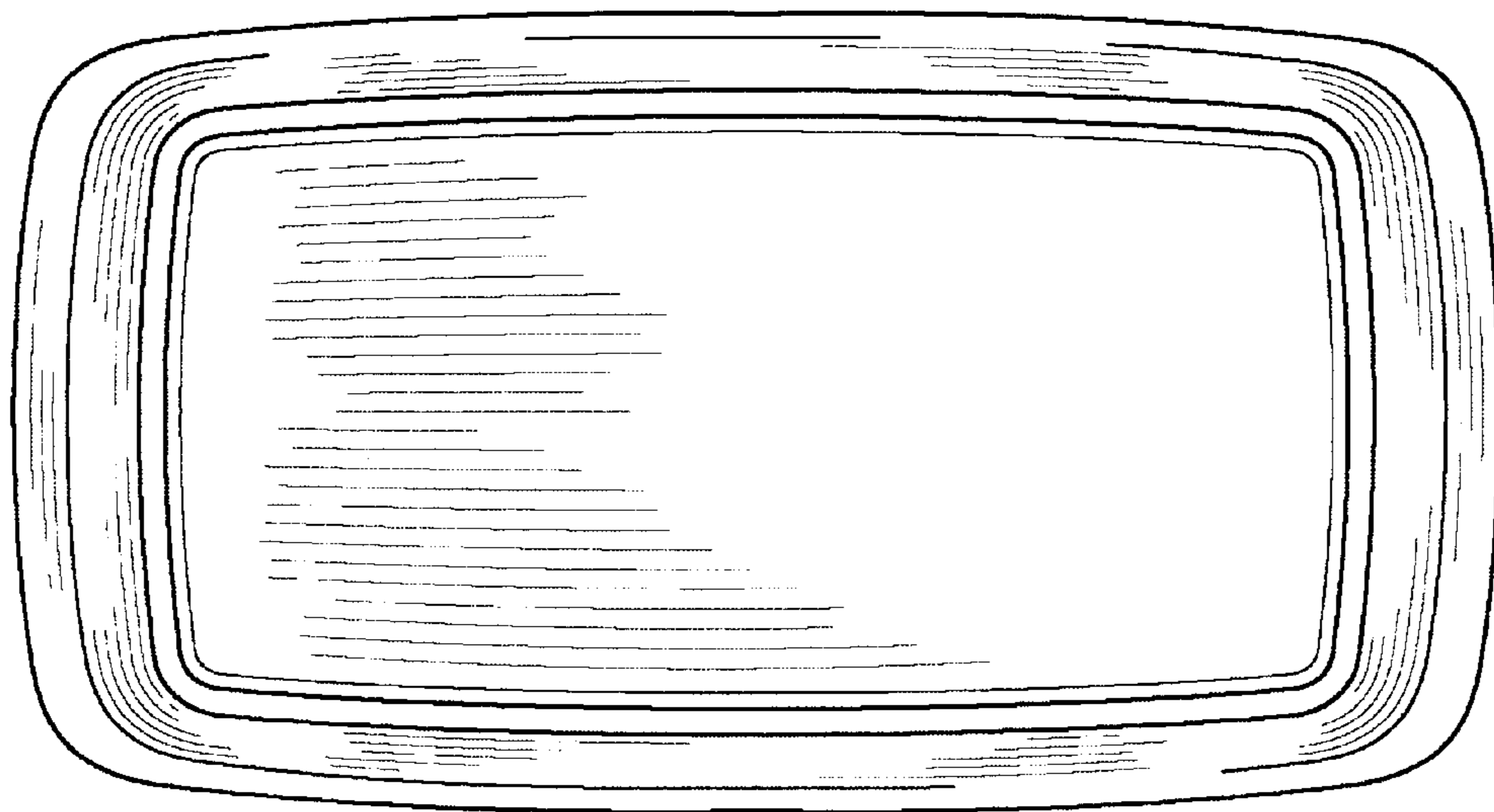
