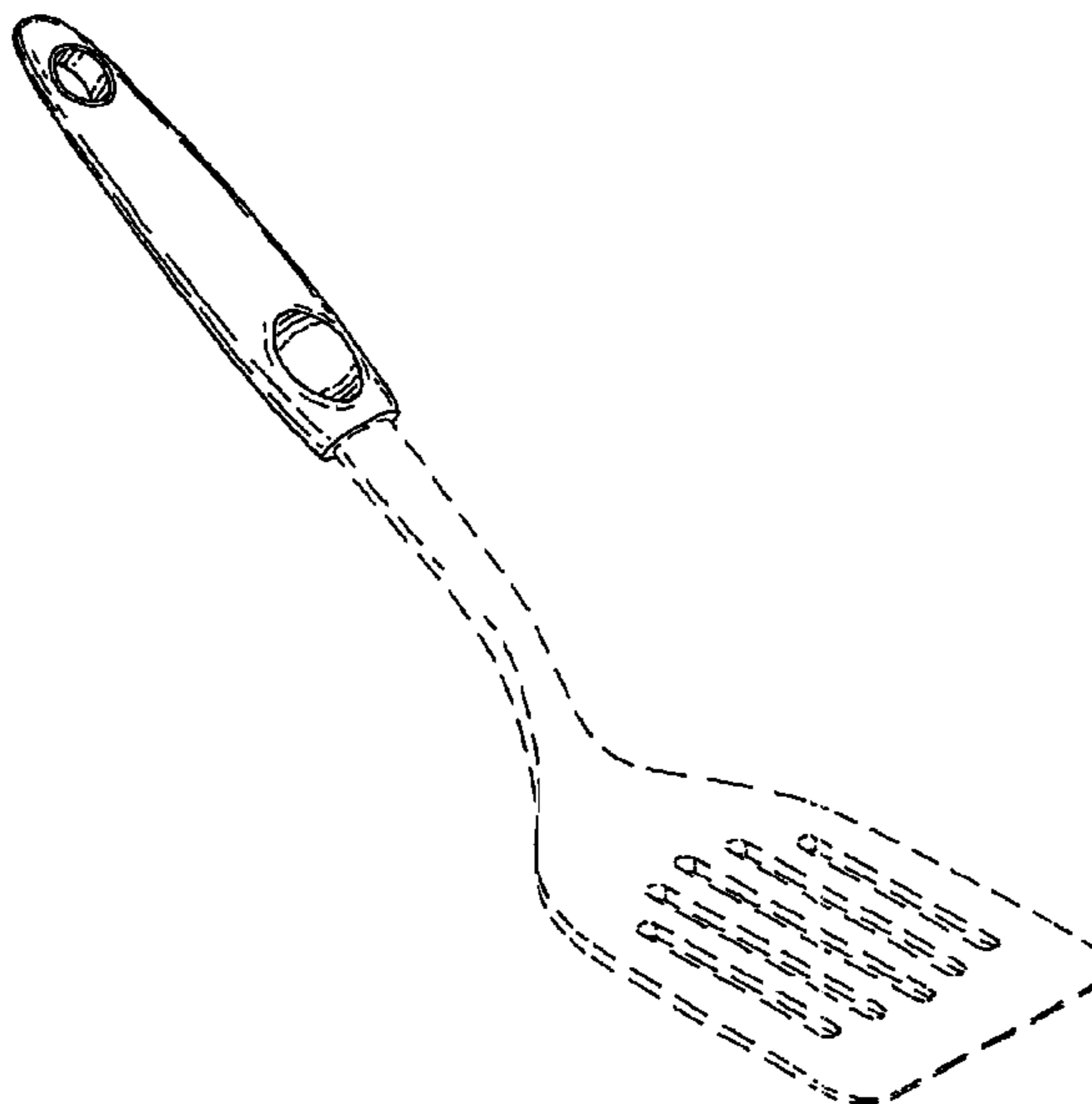

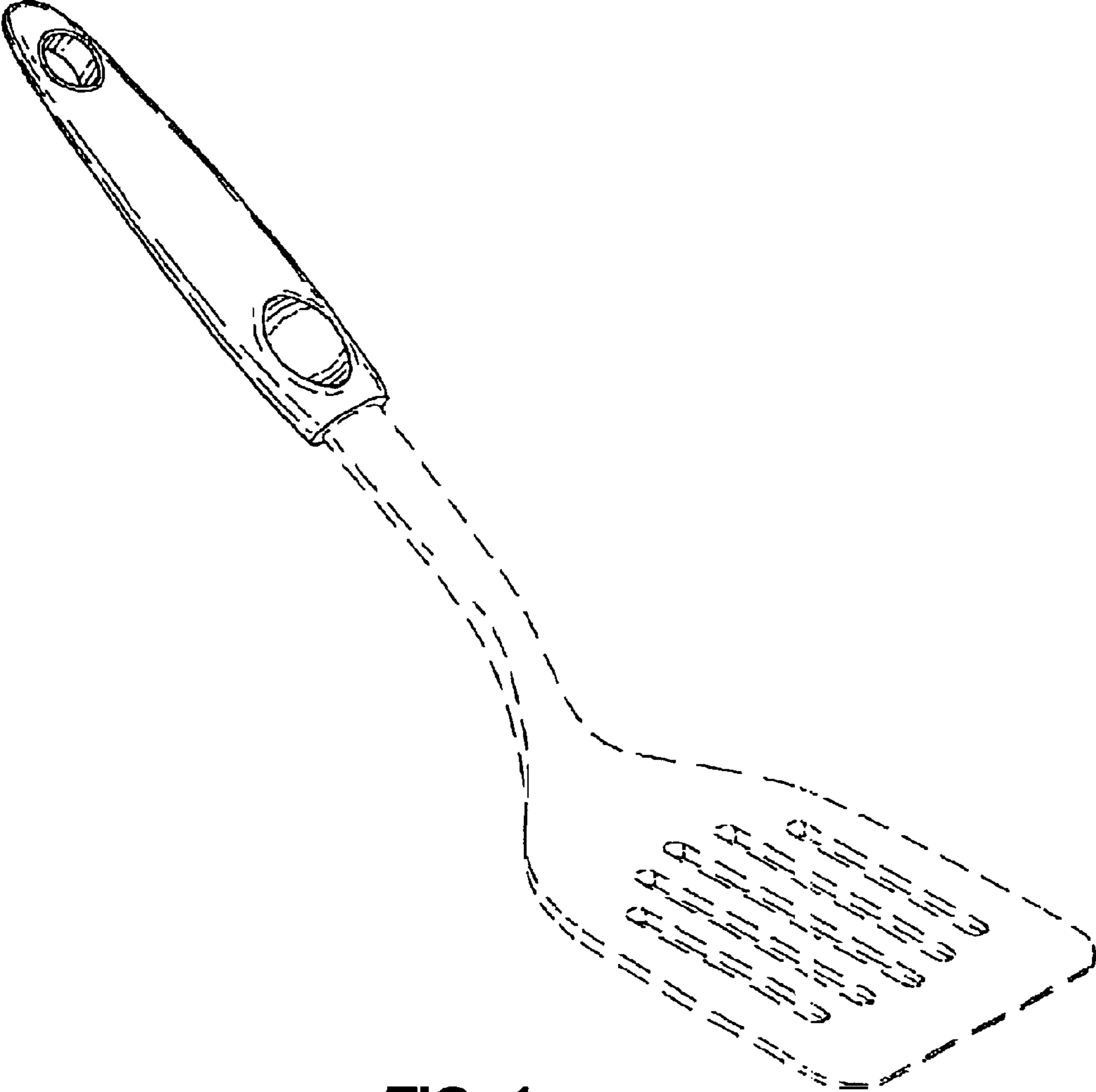
The ornamental design for a utensil handle, as shown and described.

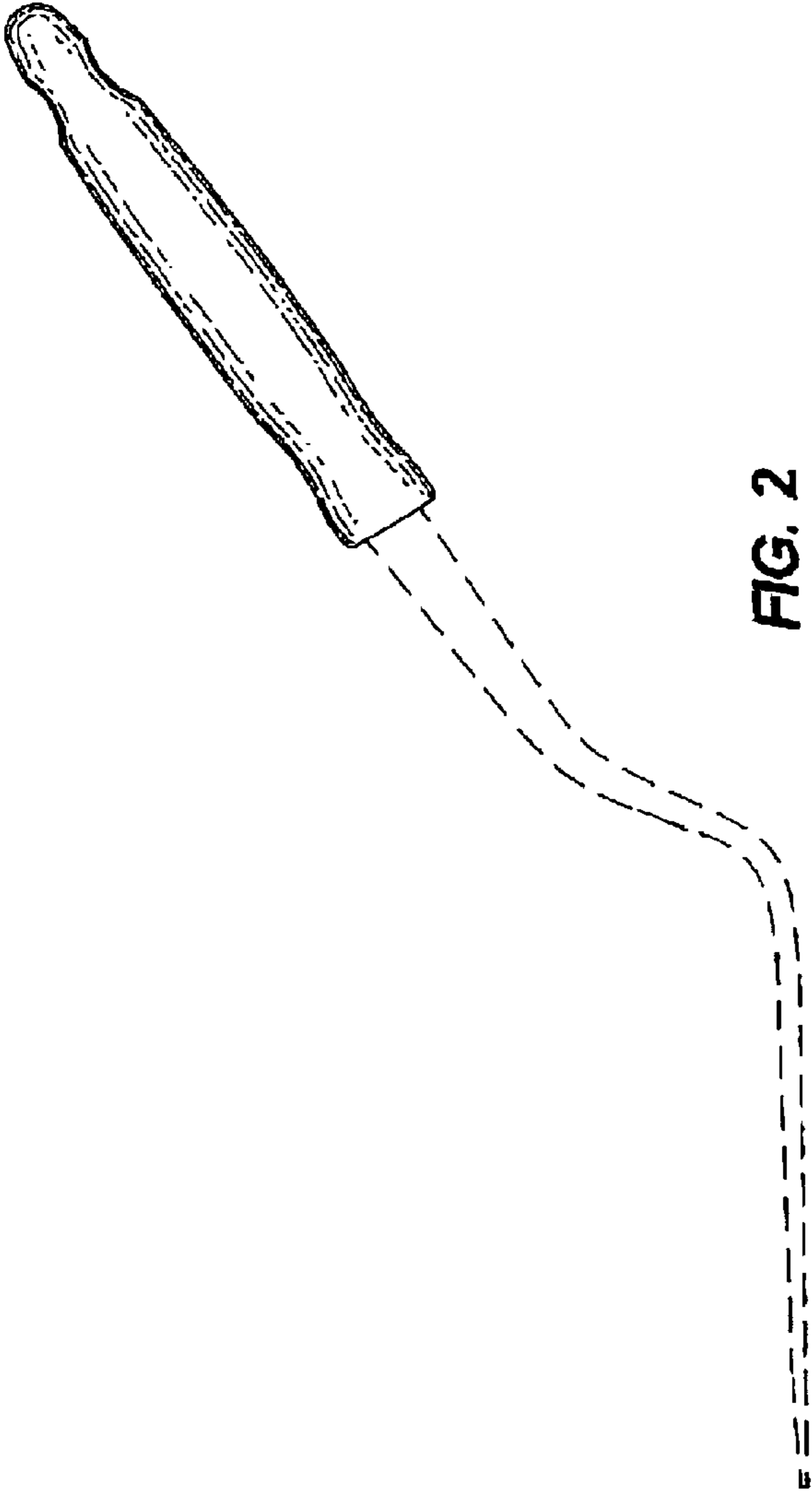

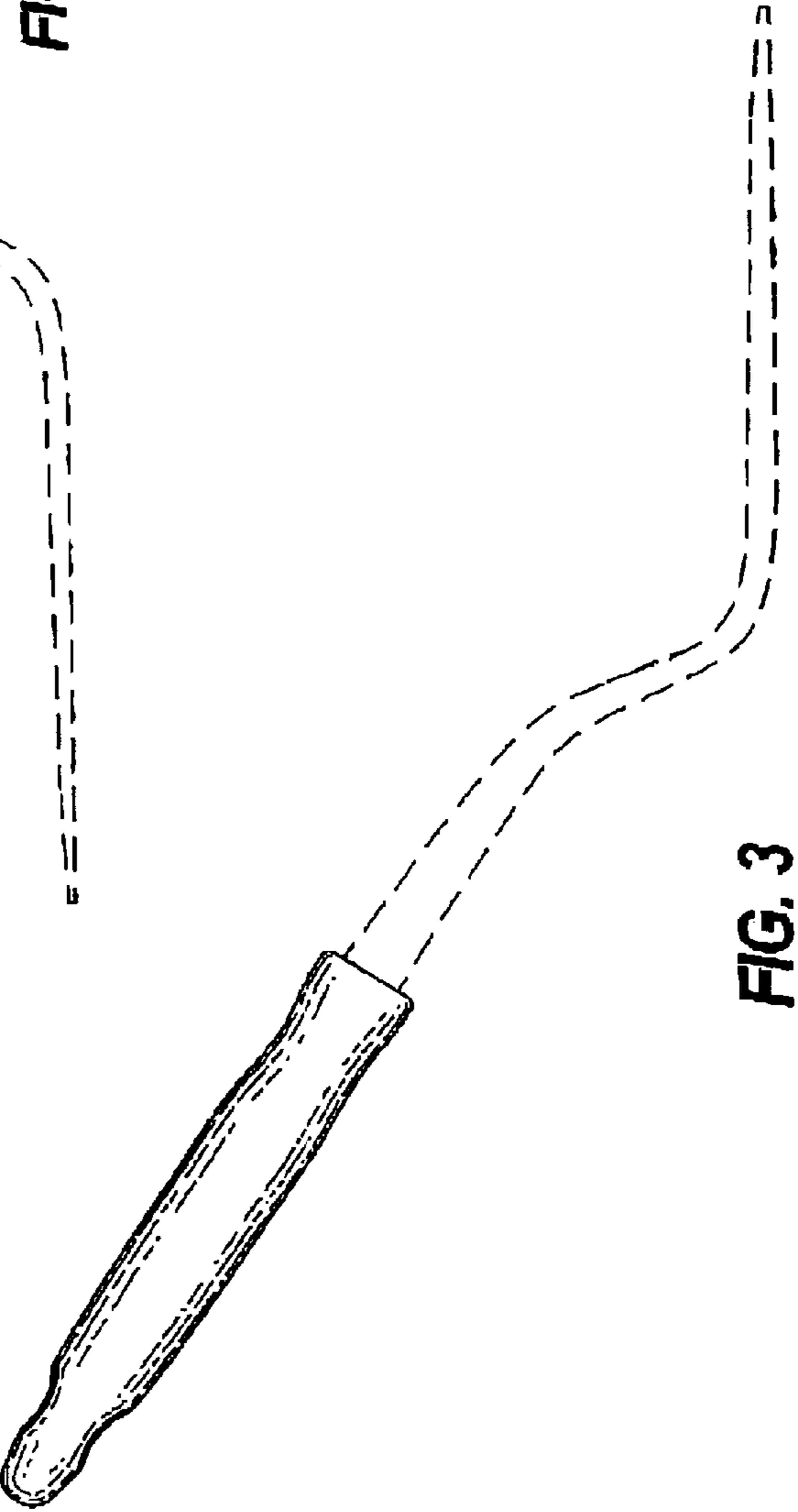
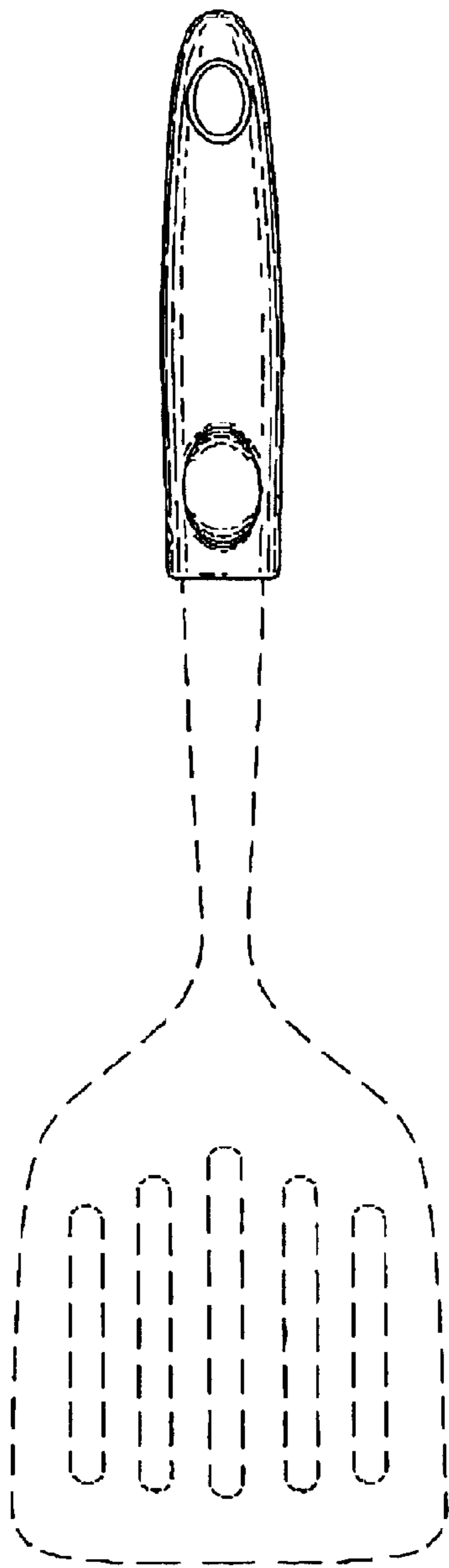
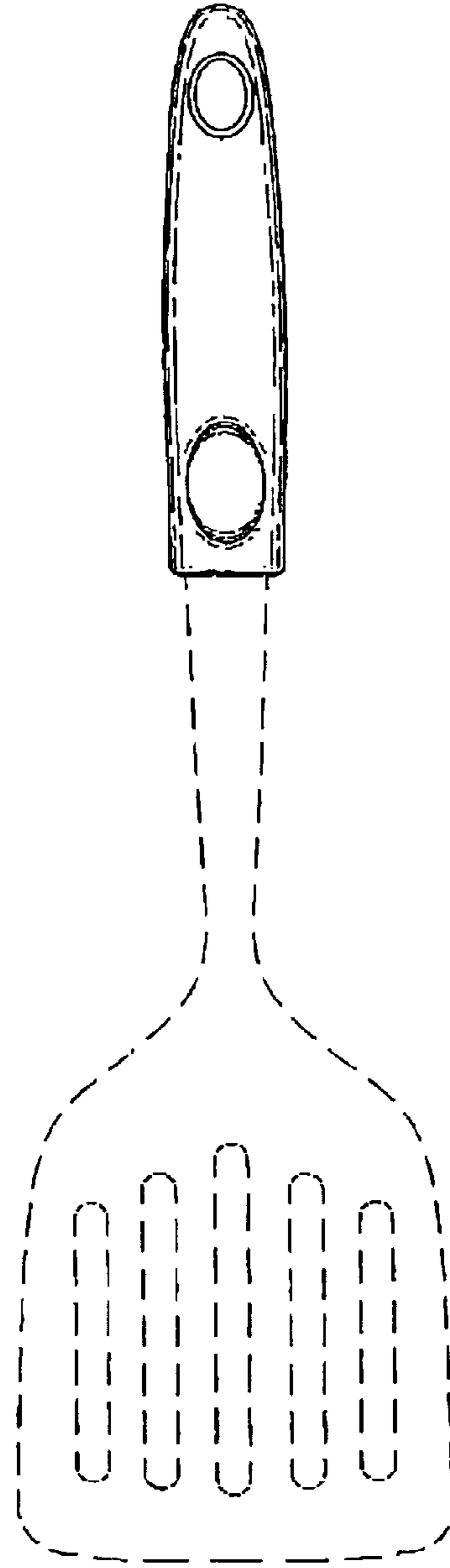
