(57) **CLAIM**

The ornamental design for a “container,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design; FIG. 2 is a front elevational view of the container of FIG. 1; the rear elevational view being a mirror image thereof; FIG. 3 is a right side elevational view of the container of FIG. 1, the left side elevational view being a mirror image thereof;

FIG. 4 is a top plan view of the container of FIG. 1;

FIG. 5 is a bottom plan view of the container of FIG. 1;

FIG. 6 is another perspective view of the container of FIG. 1;

FIG. 7 is a perspective view showing a second embodiment of our new design;

FIG. 8 is a front elevational view of the container of FIG. 7; the rear elevational view being a mirror image thereof;

FIG. 9 is a right side elevational view of the container of FIG. 7, the left side elevational view being a mirror image thereof;

FIG. 10 is a top plan view of the container of FIG. 7;

FIG. 11 is a bottom plan view of the container of FIG. 7; and,

FIG. 12 is another perspective view of the container of FIG. 7.

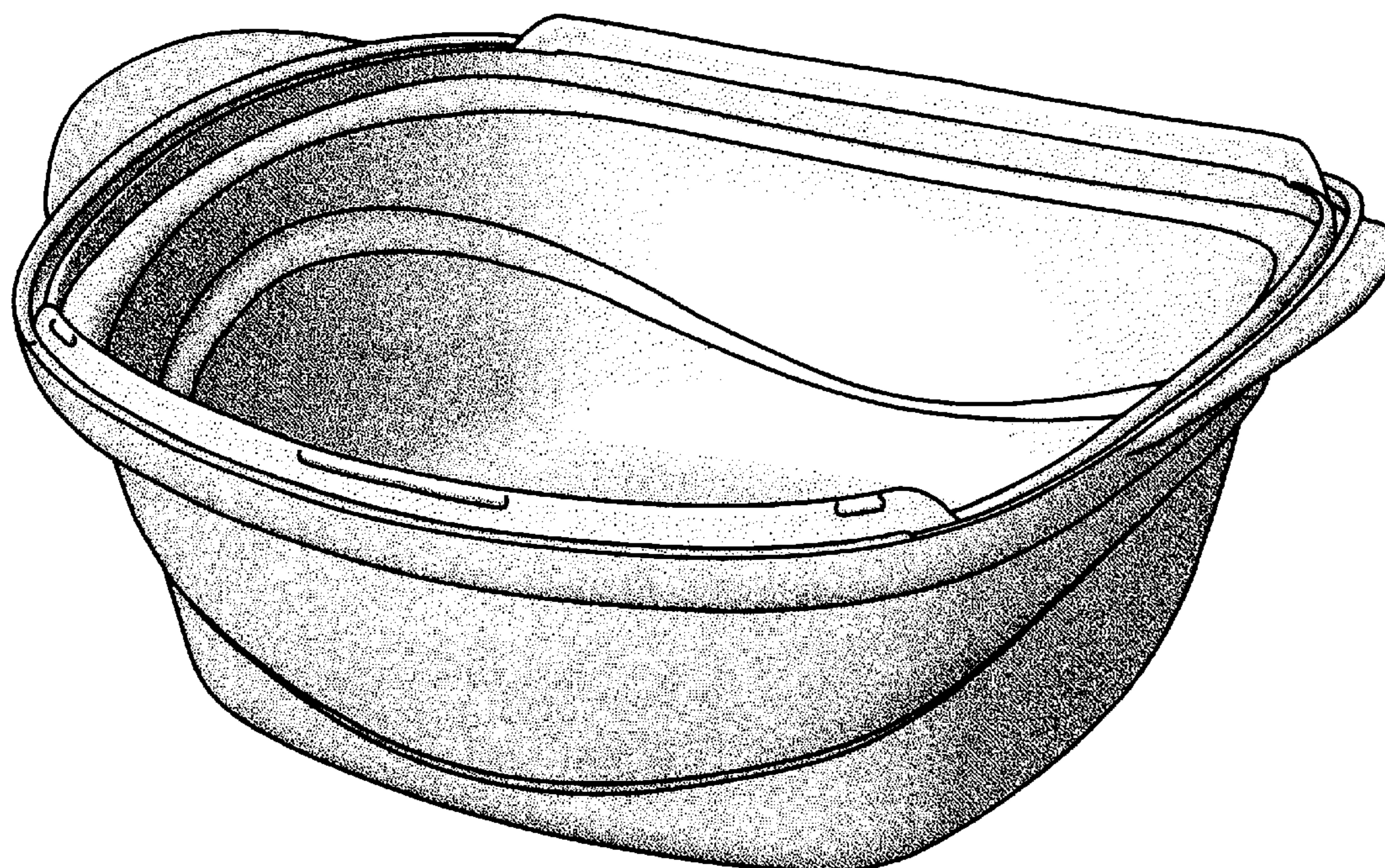

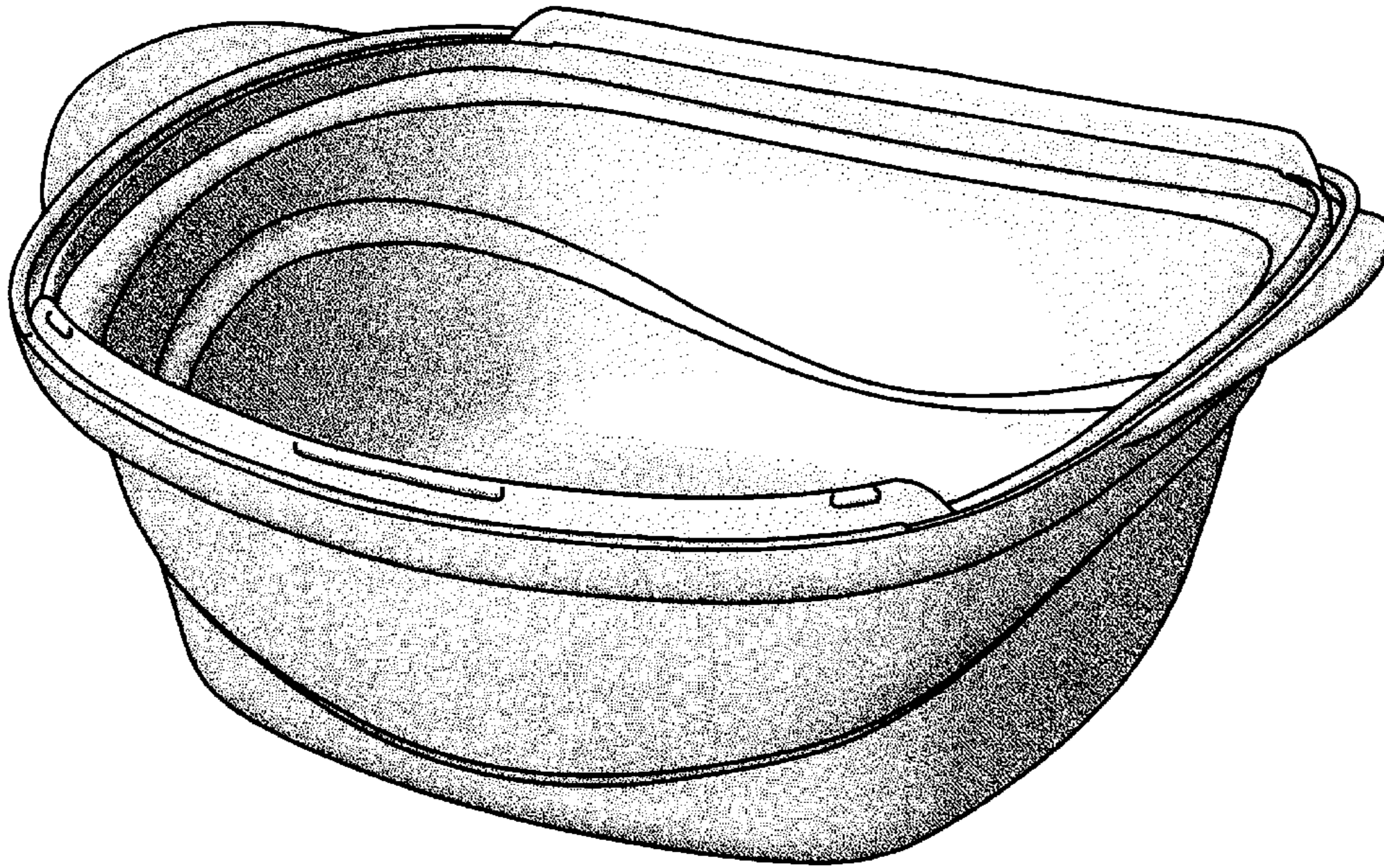

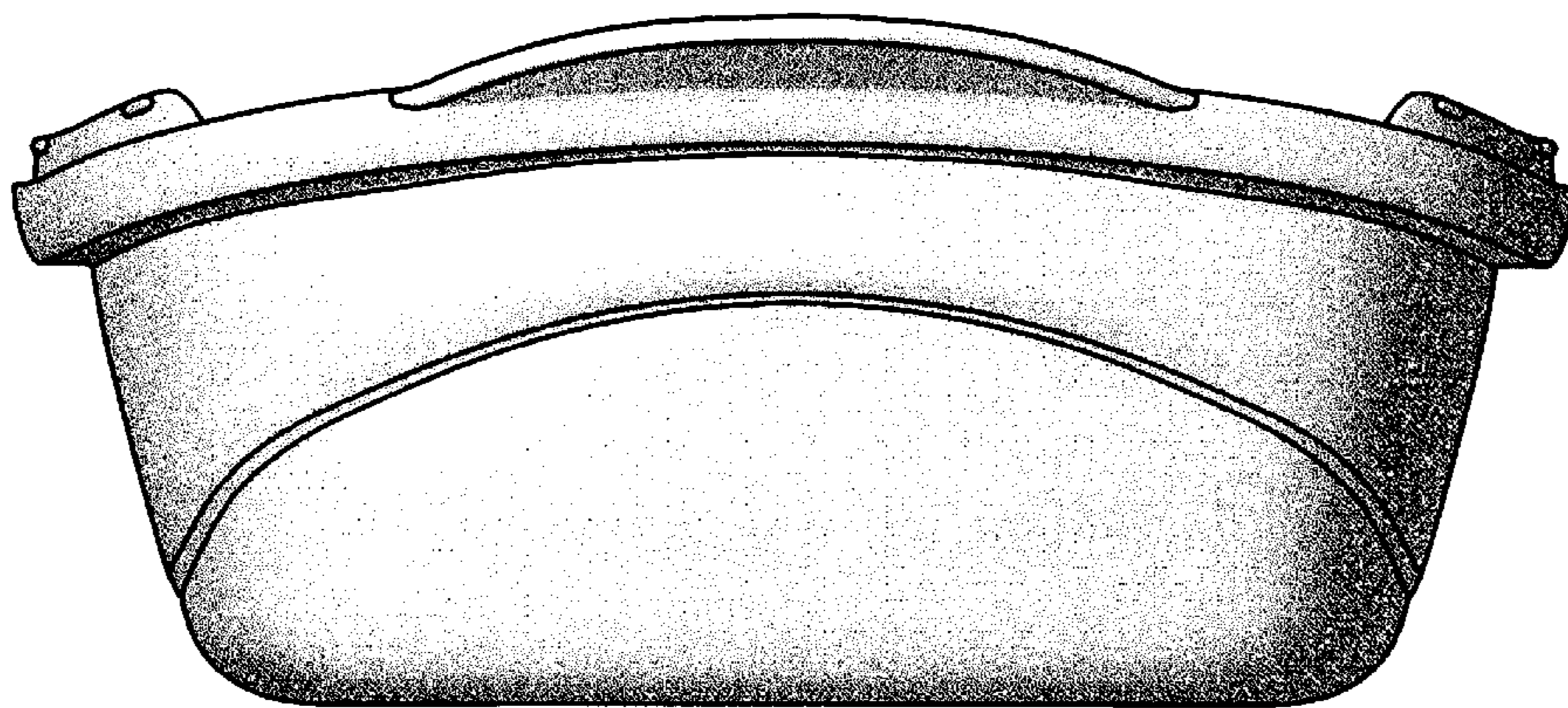

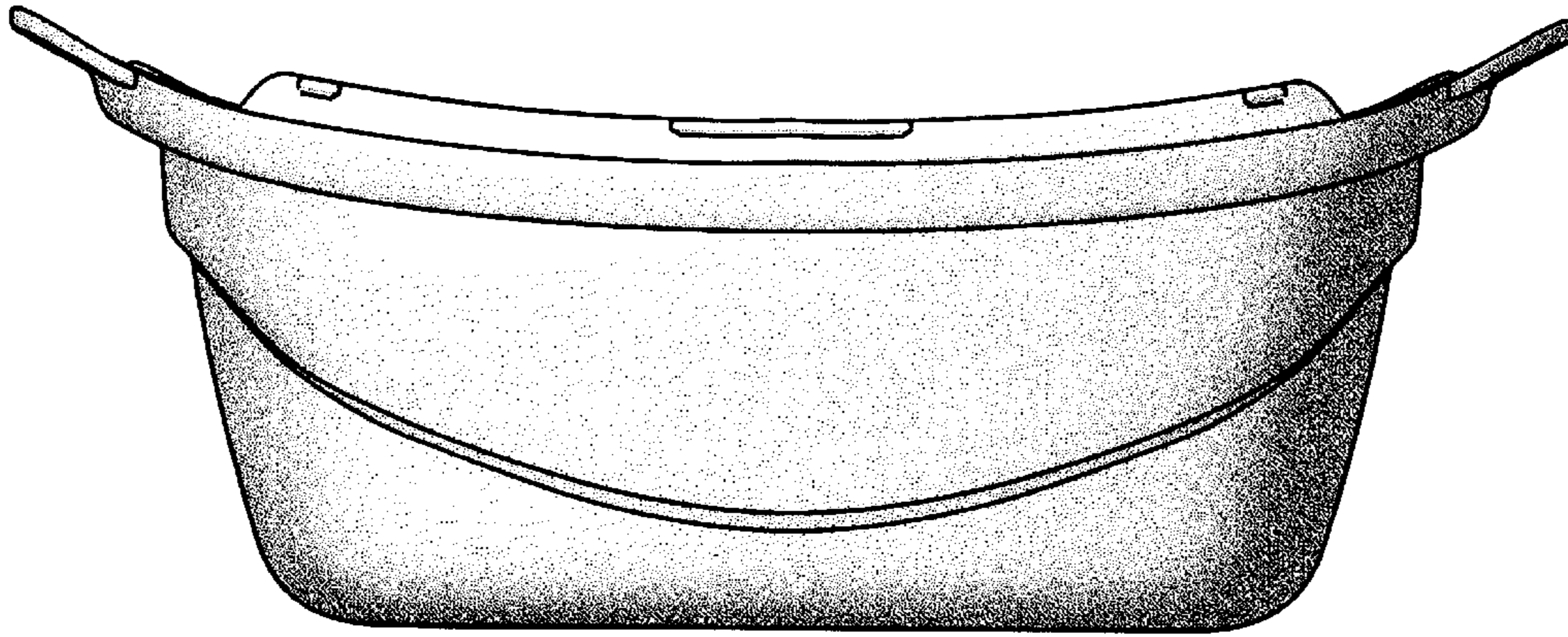

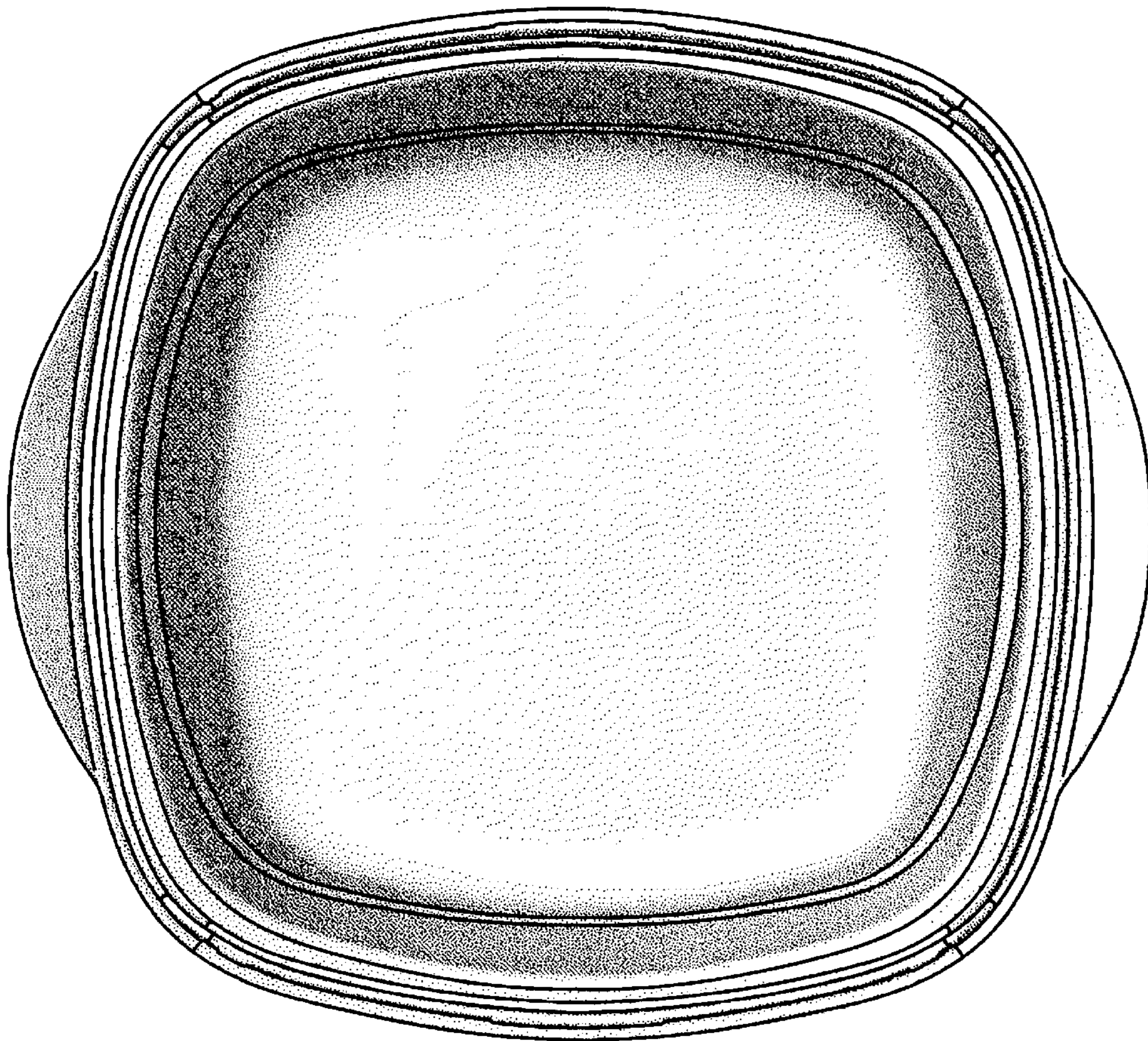

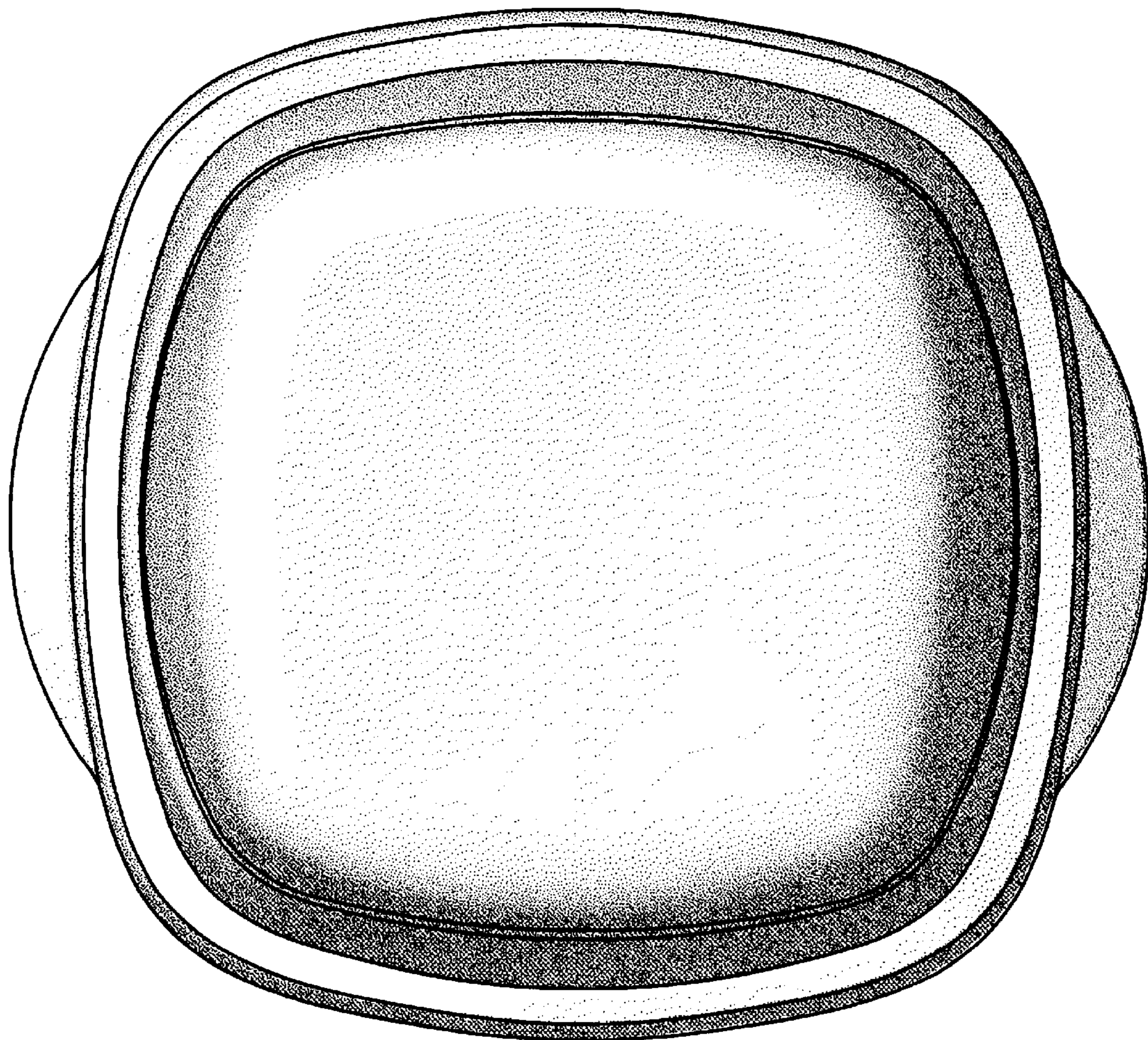

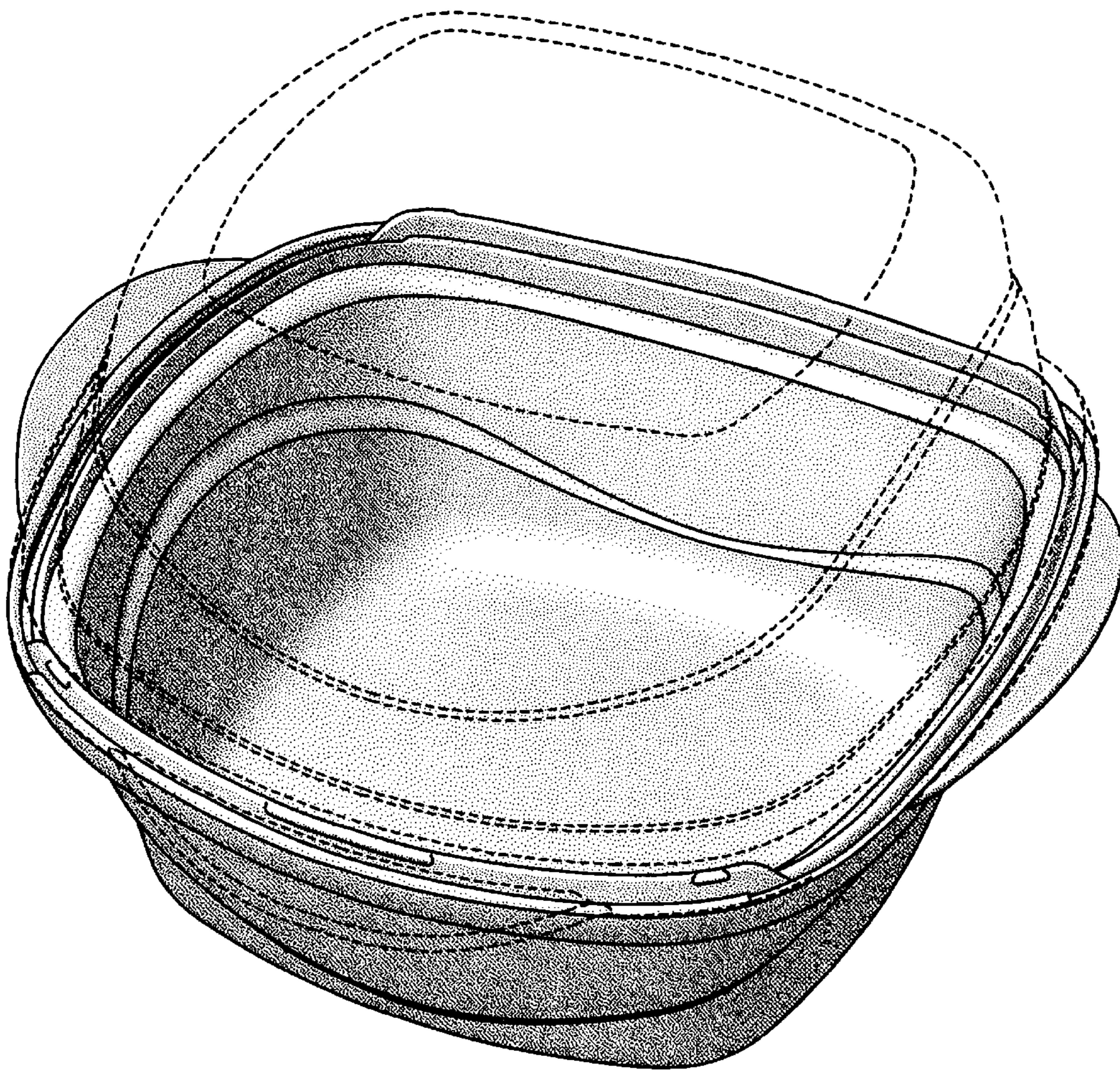

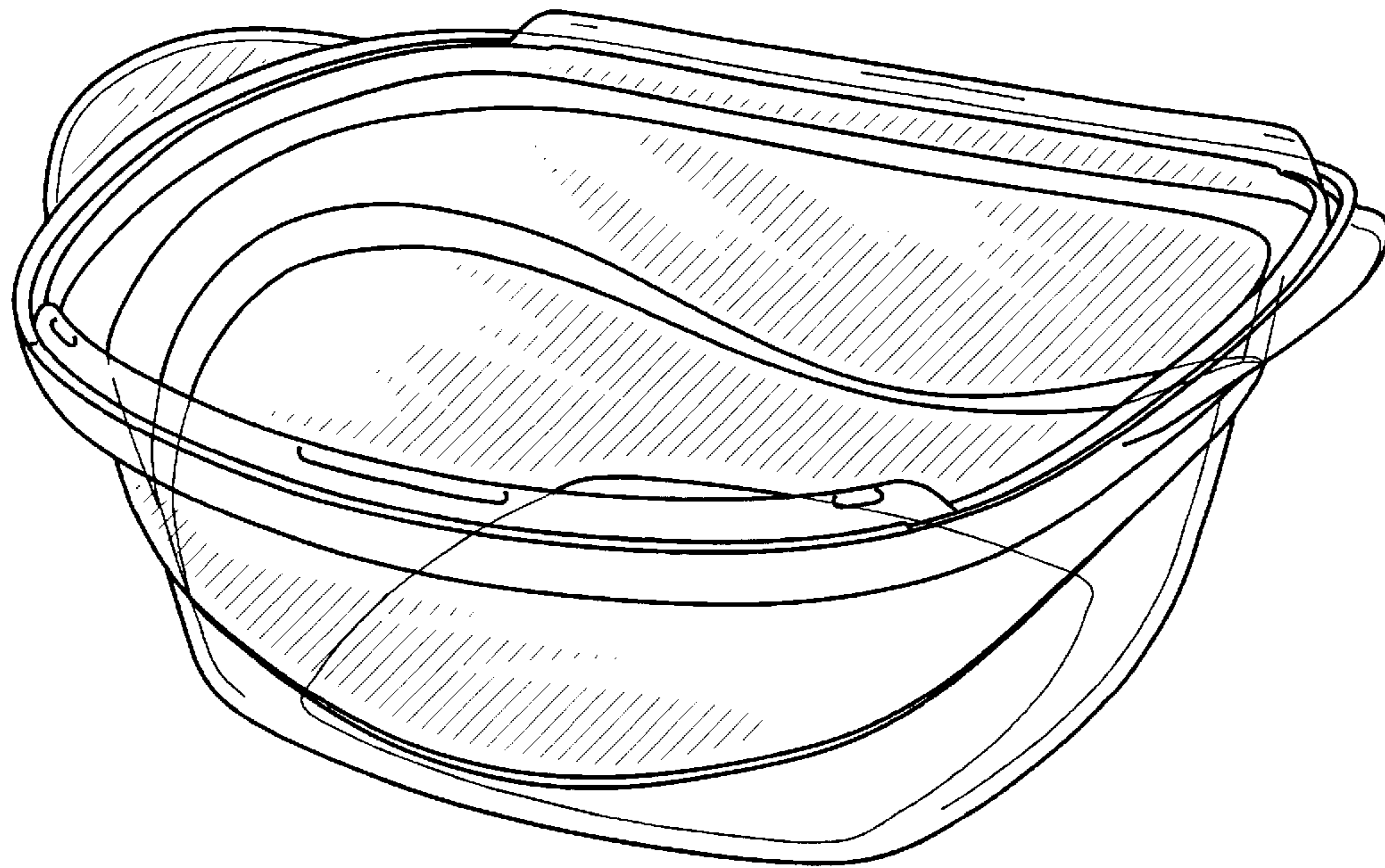

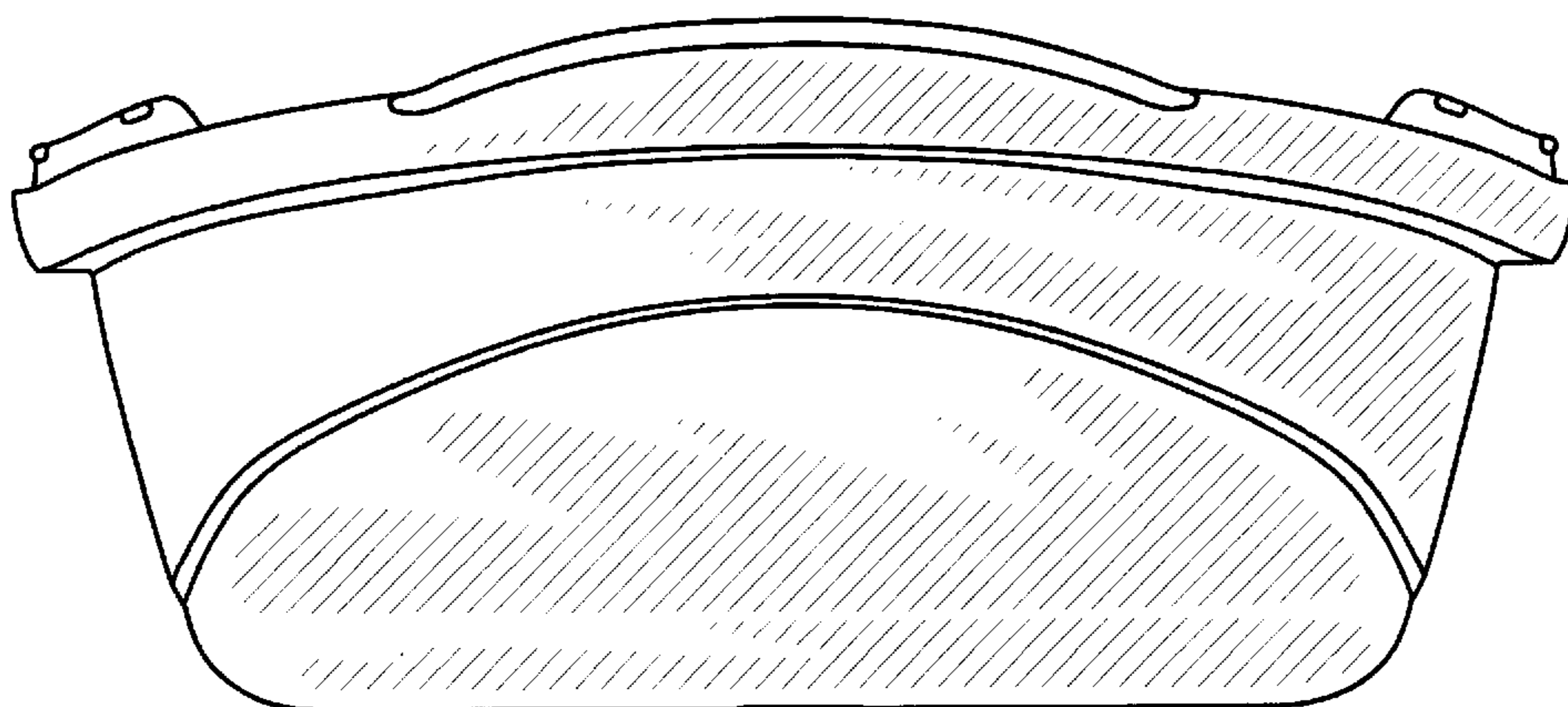

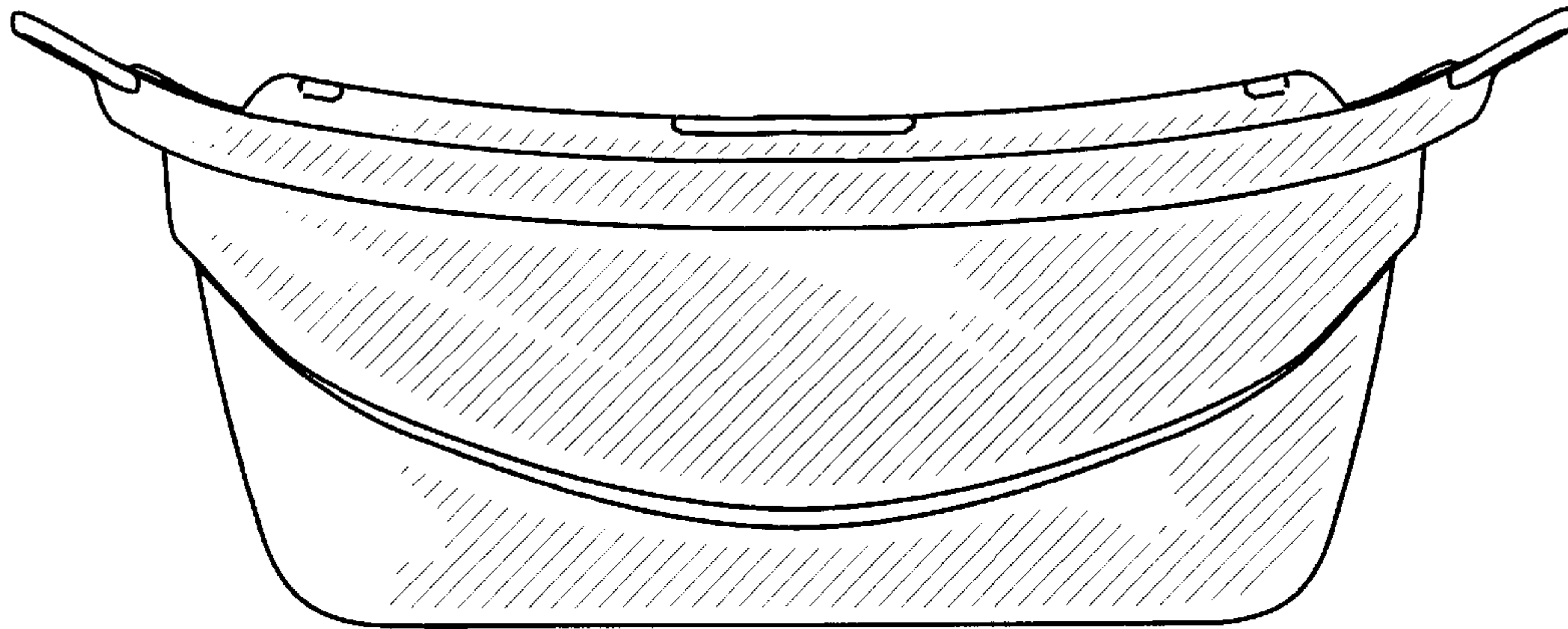

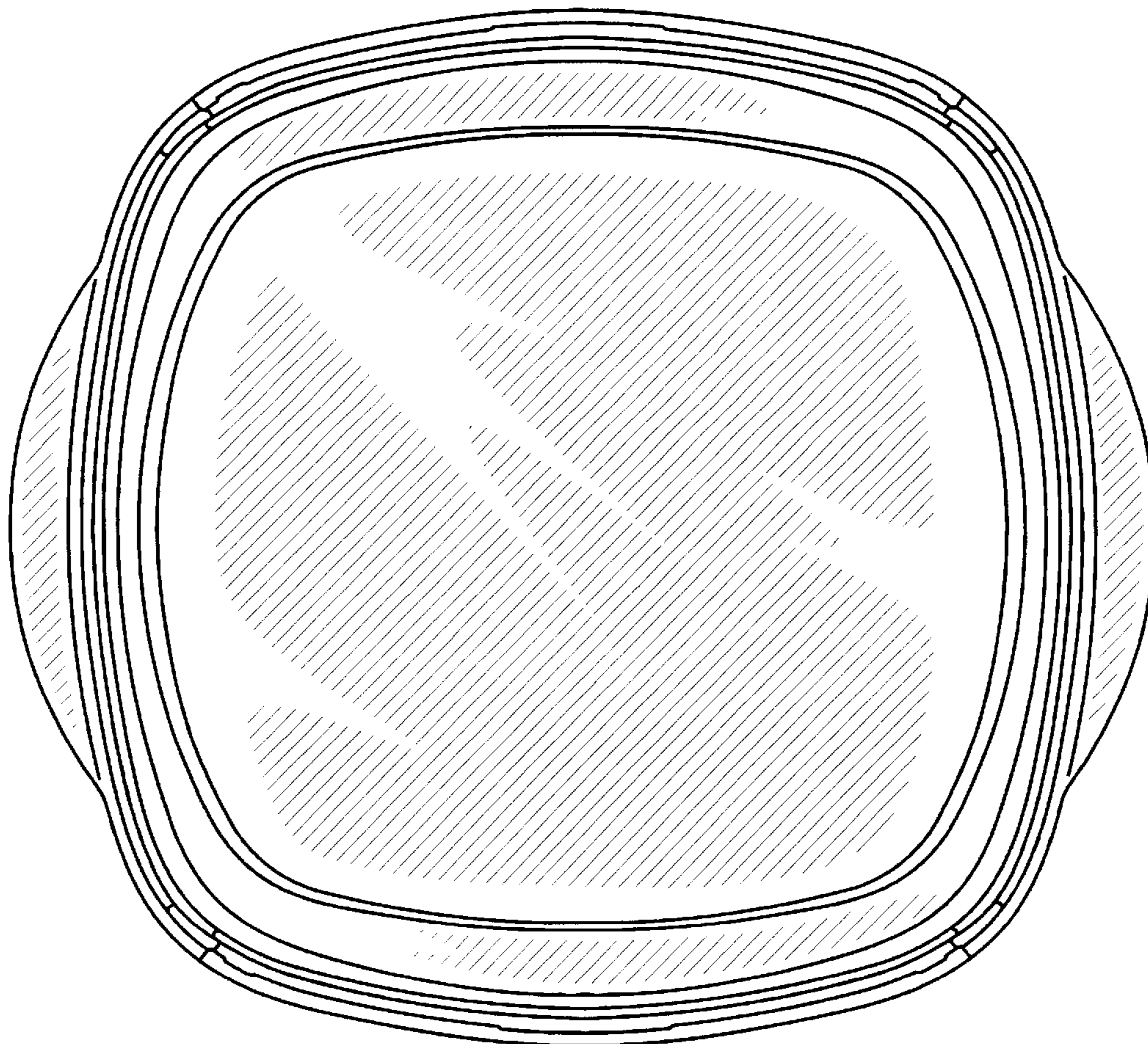

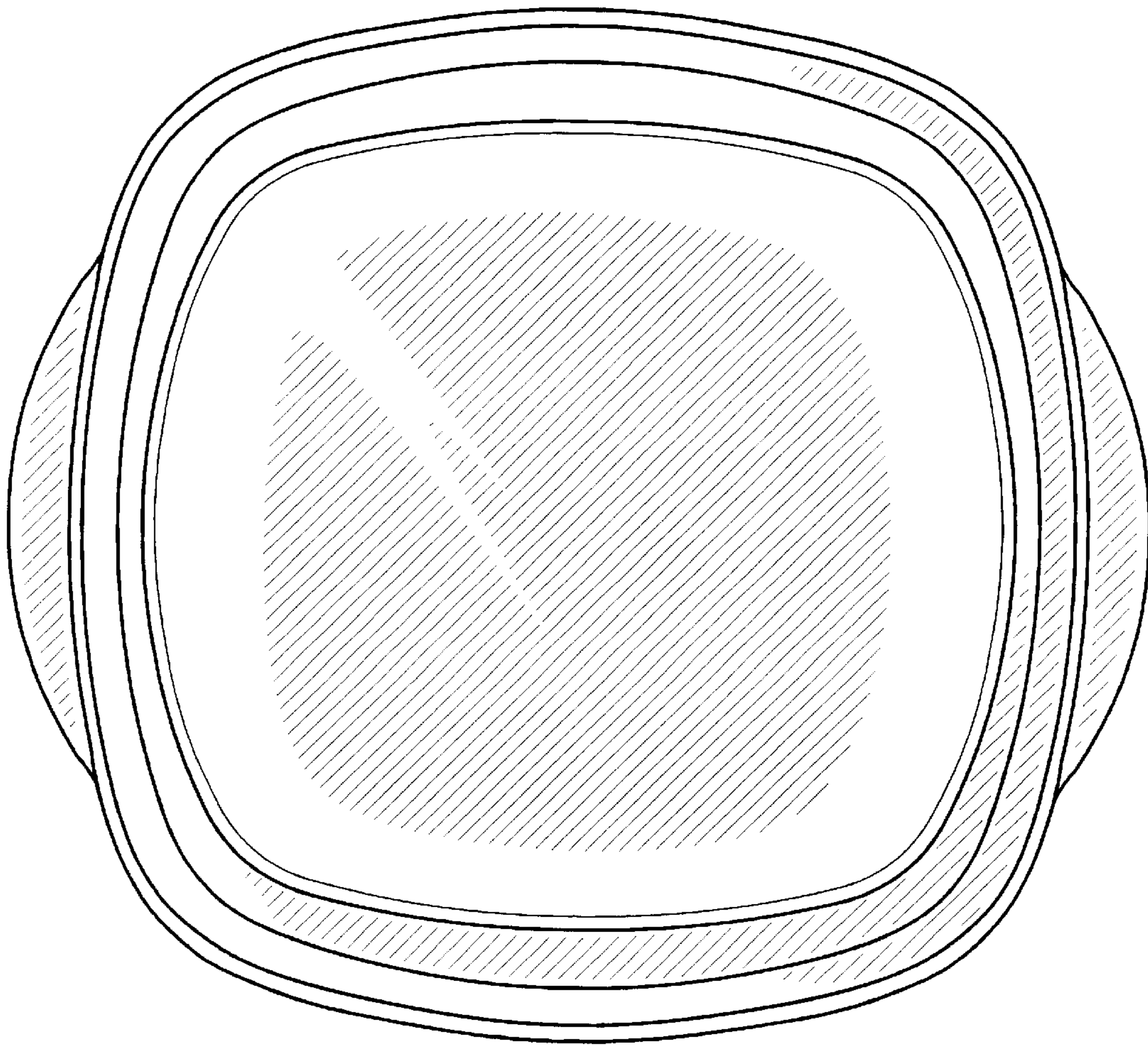
