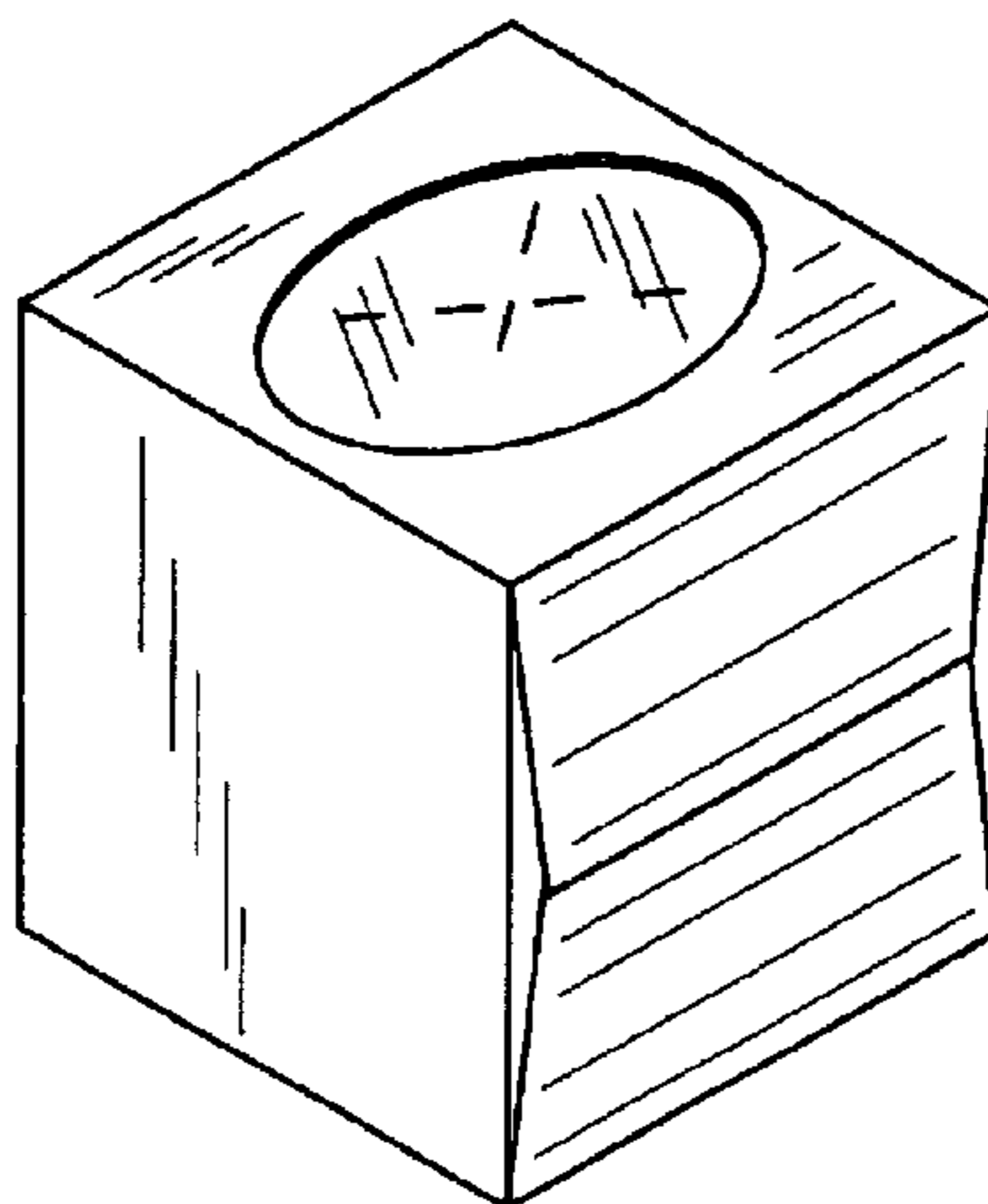
(57) **CLAIM**

I claim, the ornamental design for a tissue box, as shown and described.

DESCRIPTION

FIG. 1 is a view in perspective showing my new design for a tissue box;
FIG. 2 is a left-side view thereof, left being with reference to FIG. 1;
FIG. 3 is a right-side view, opposite to the side shown in FIG. 2;
FIG. 4 is a front-side view thereof;
FIG. 5 is a back-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a view in perspective opposite to the view shown in FIG. 1, showing my new design.

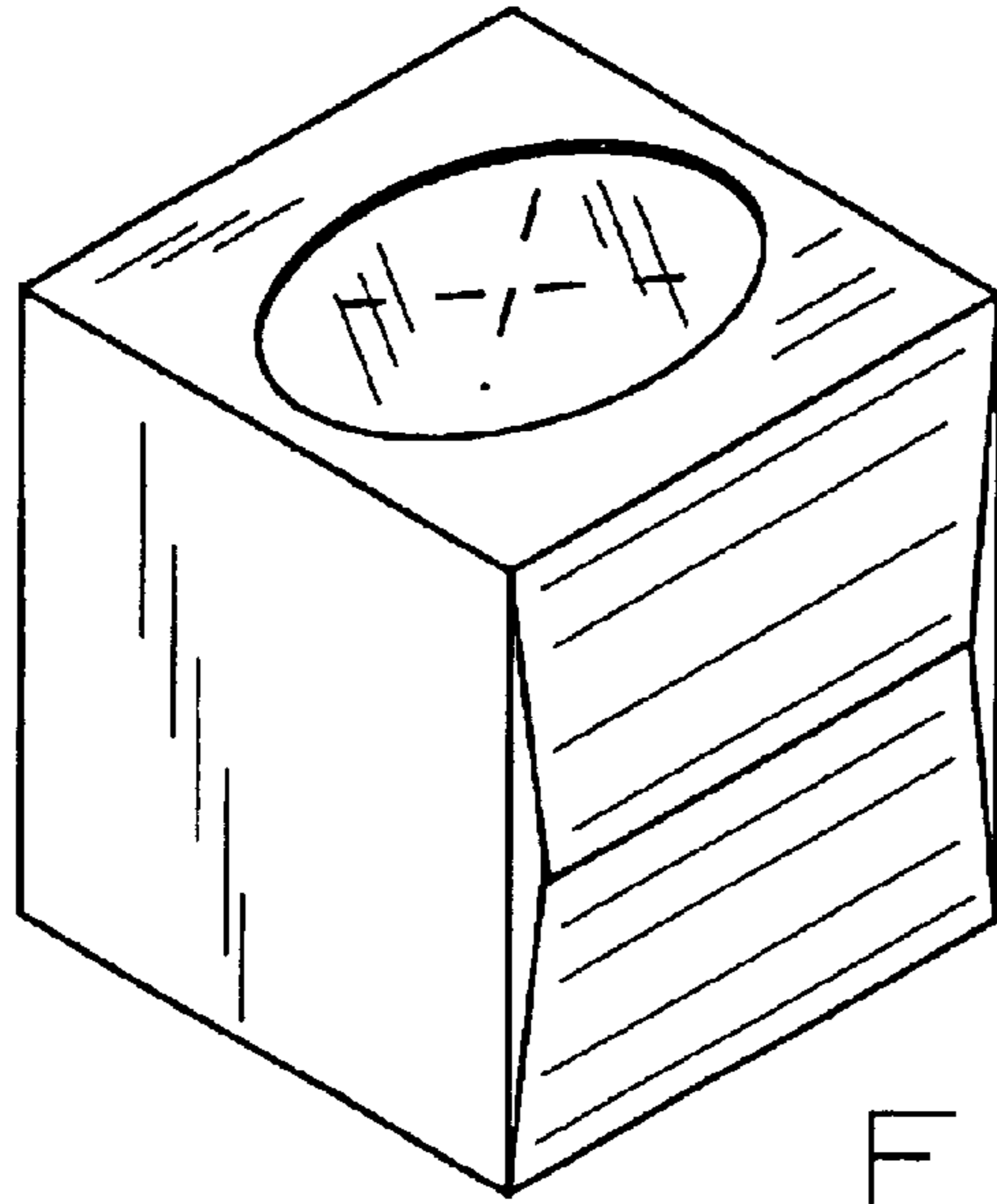

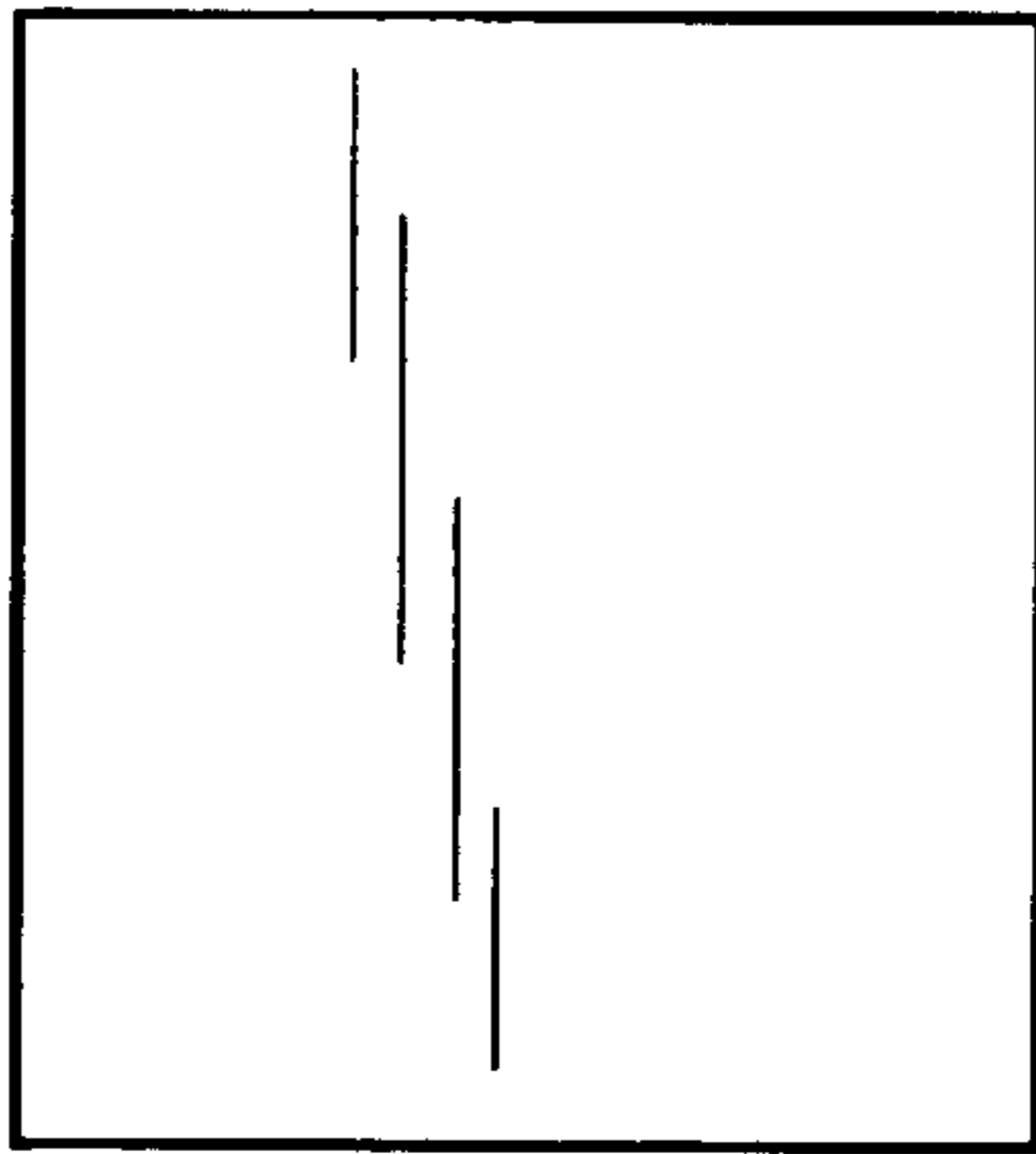

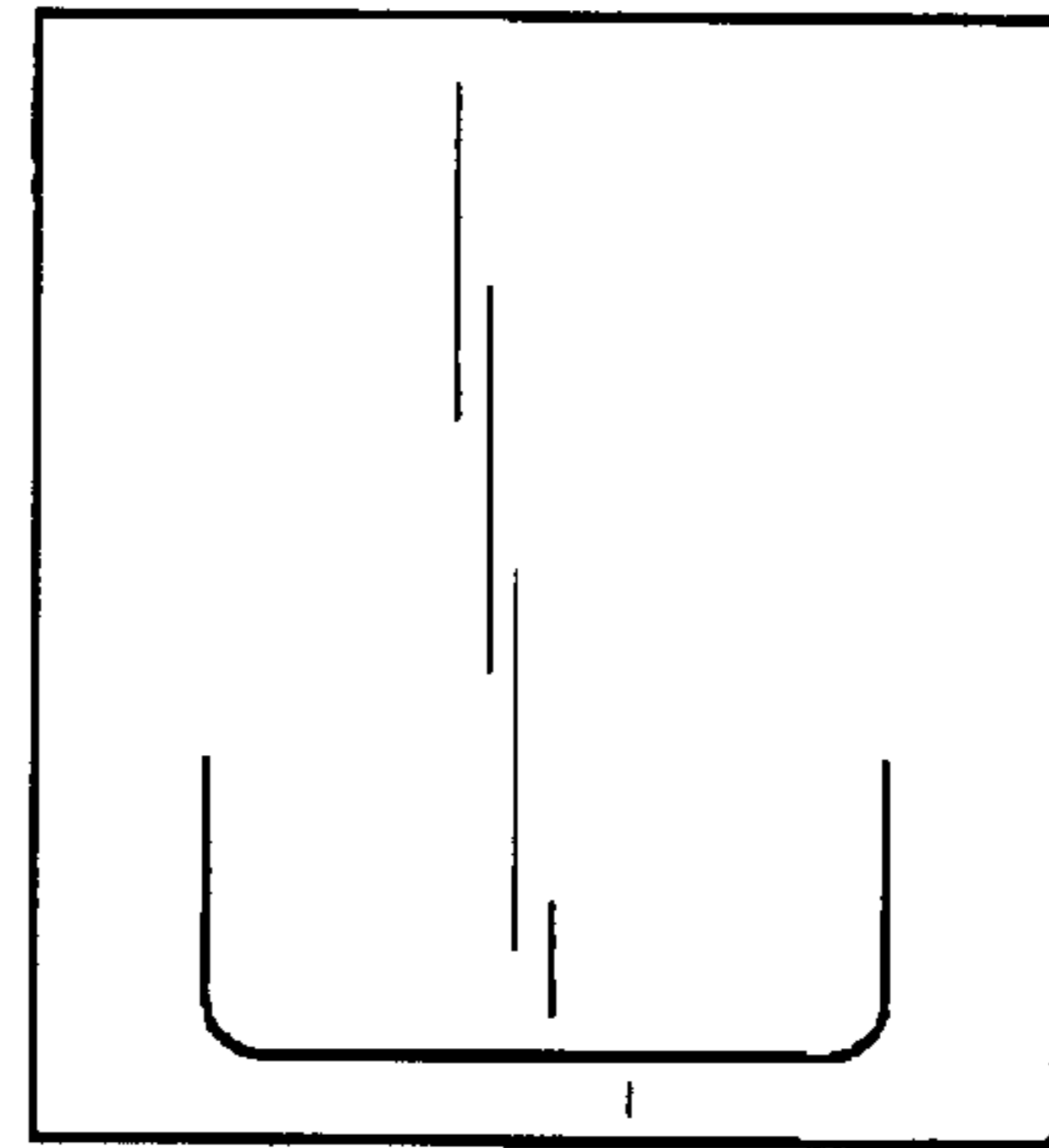

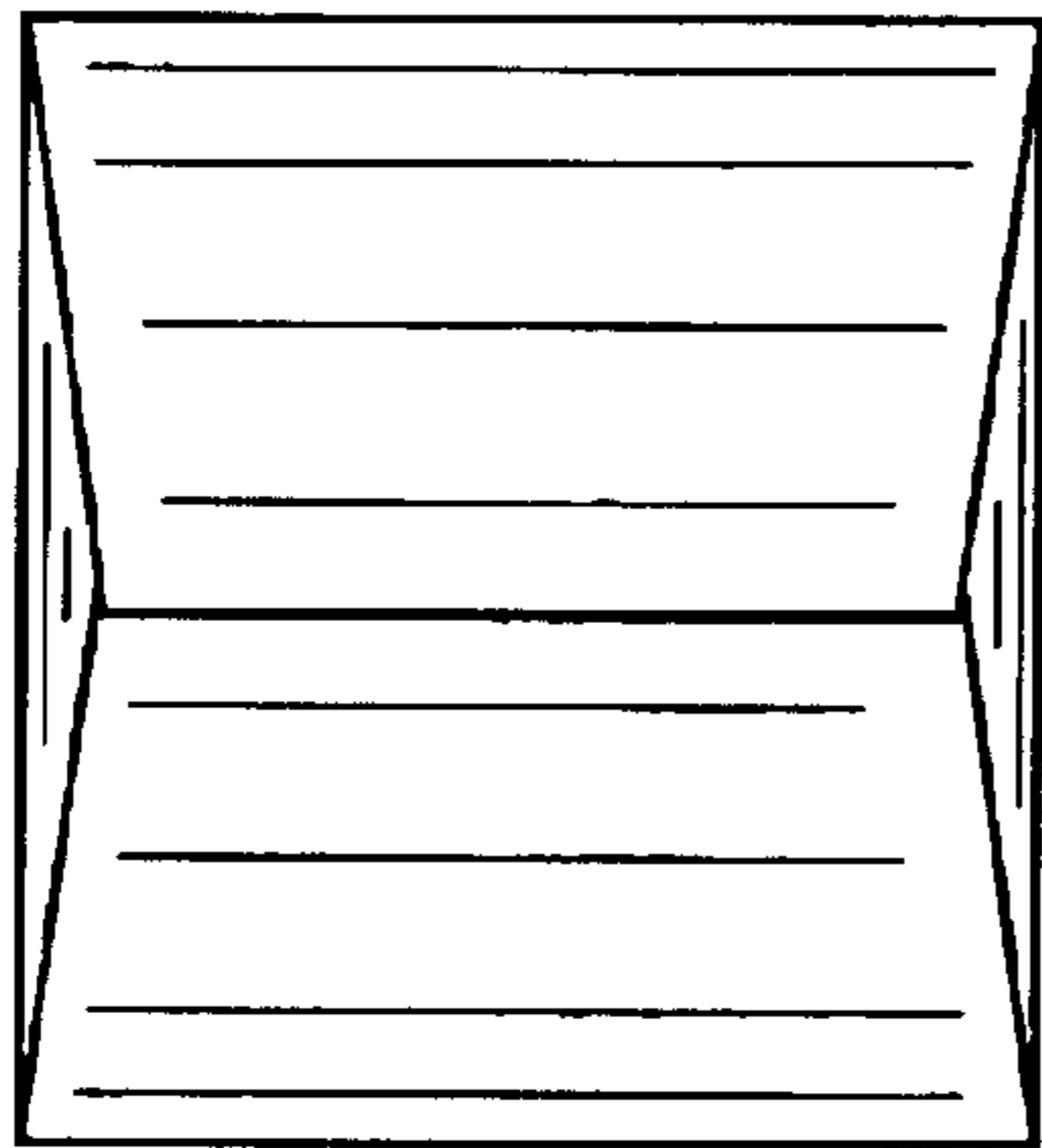

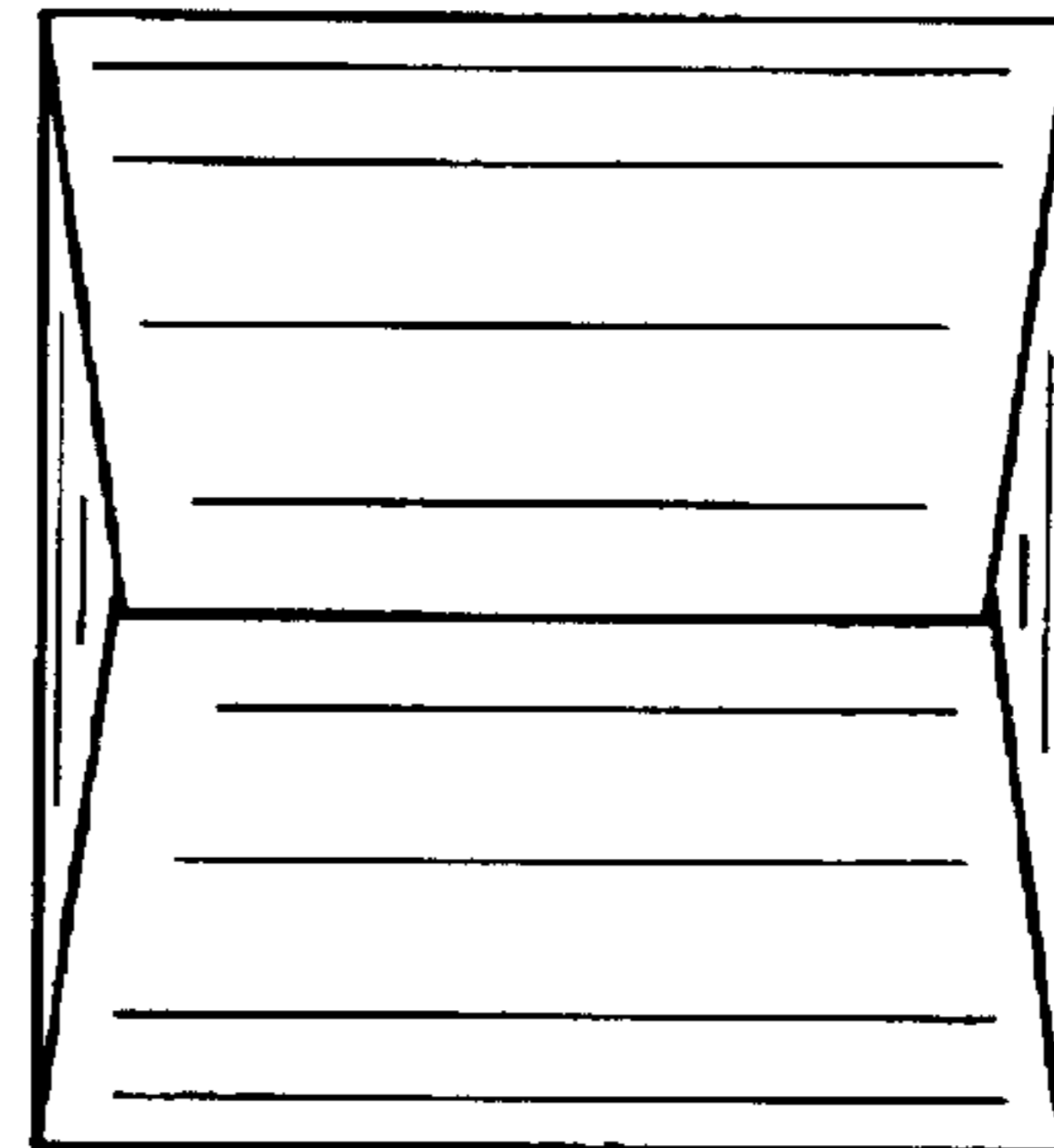

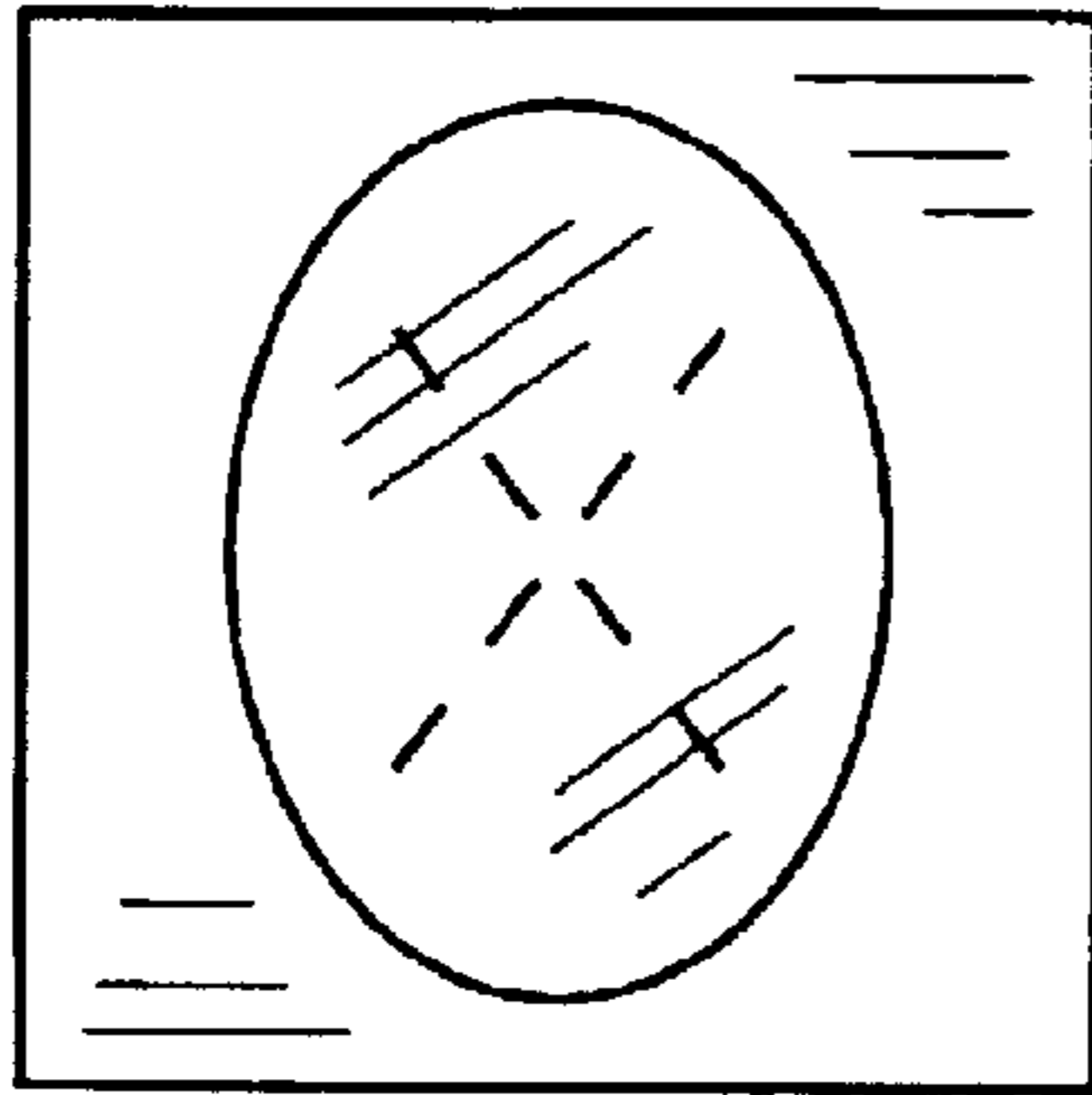

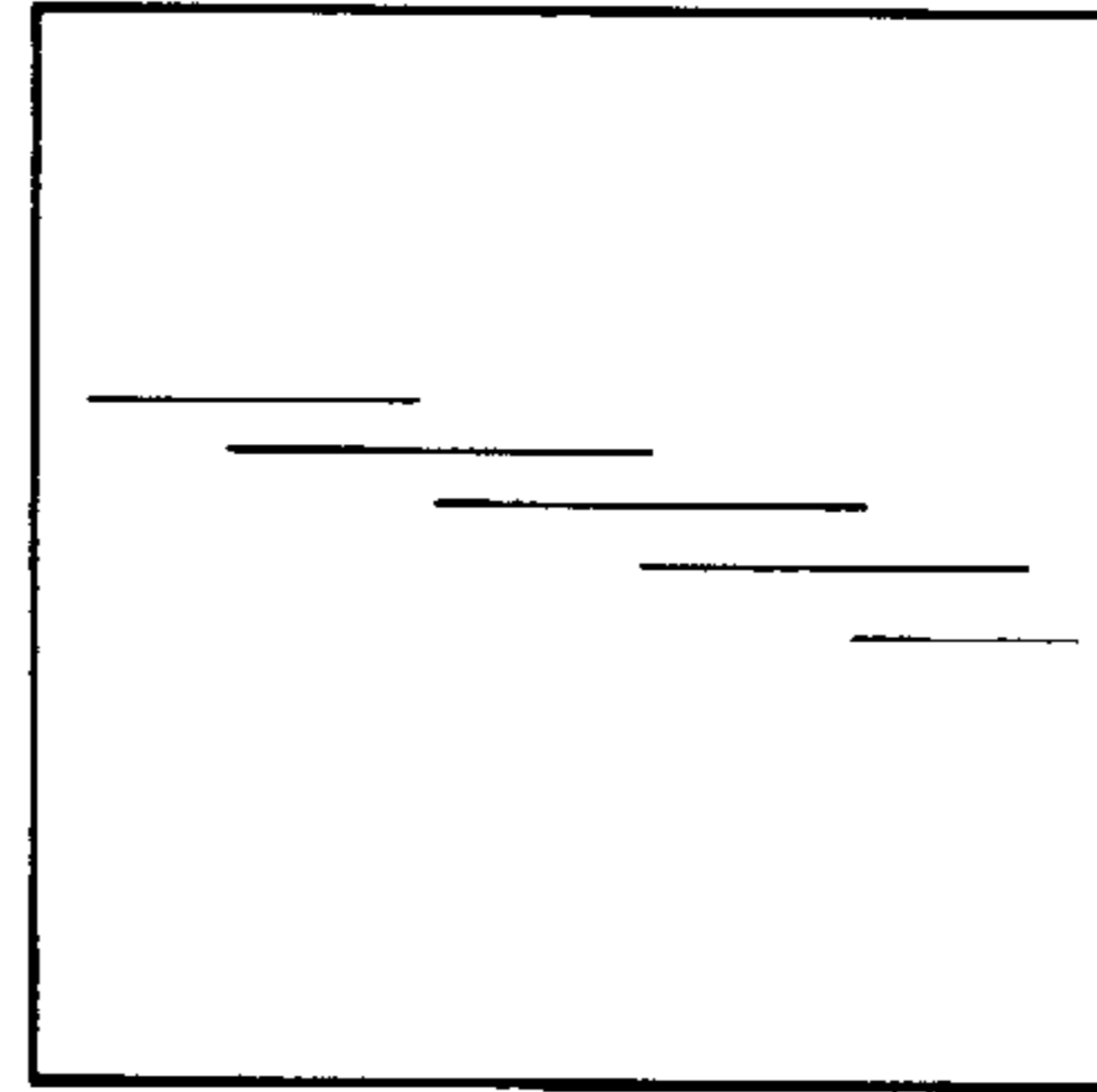

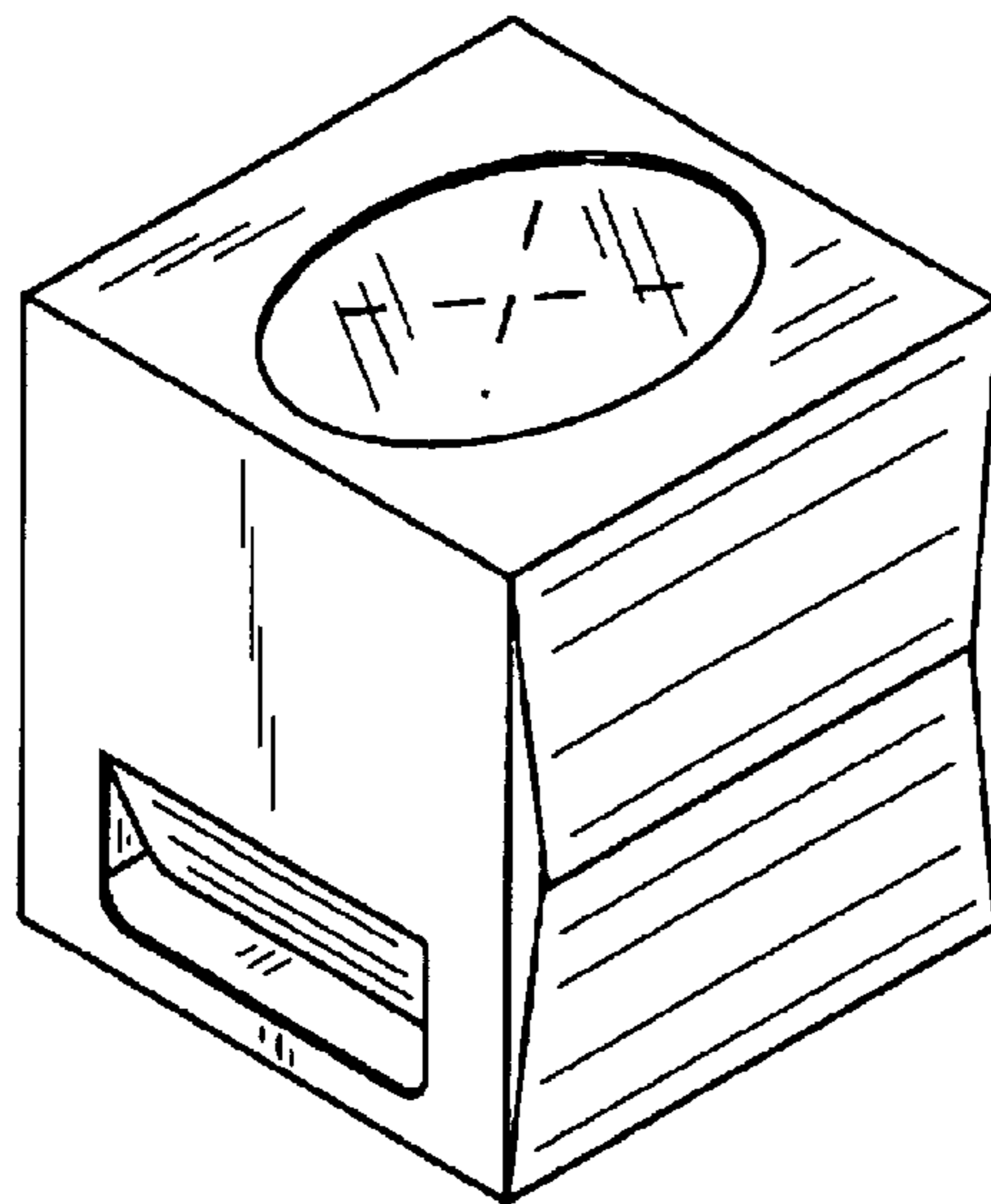
