The ornamental design for a combined diamond engagement and wedding ring set, as shown and described.

DESCRIPTION

FIG. 10 is a front view of FIG. 8;

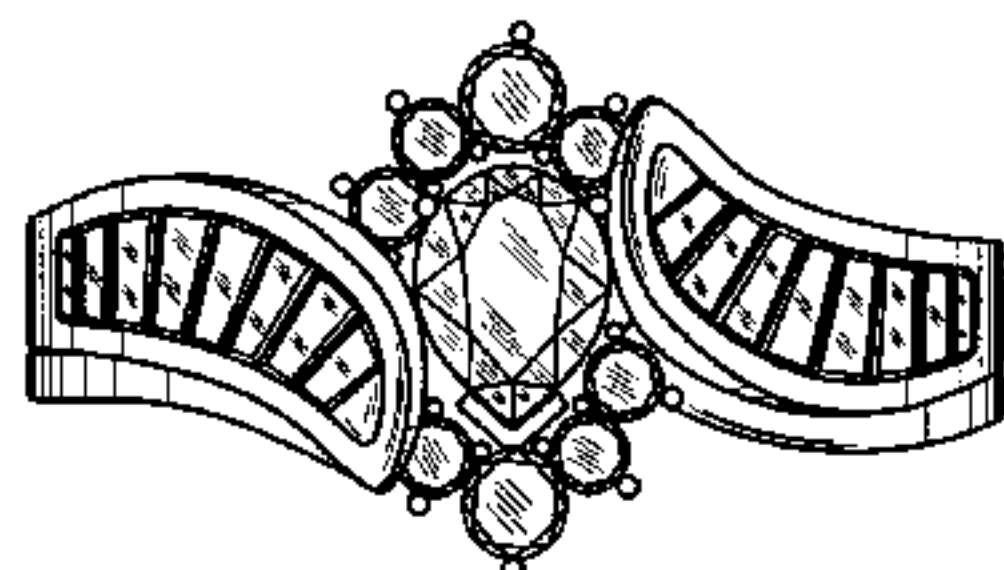
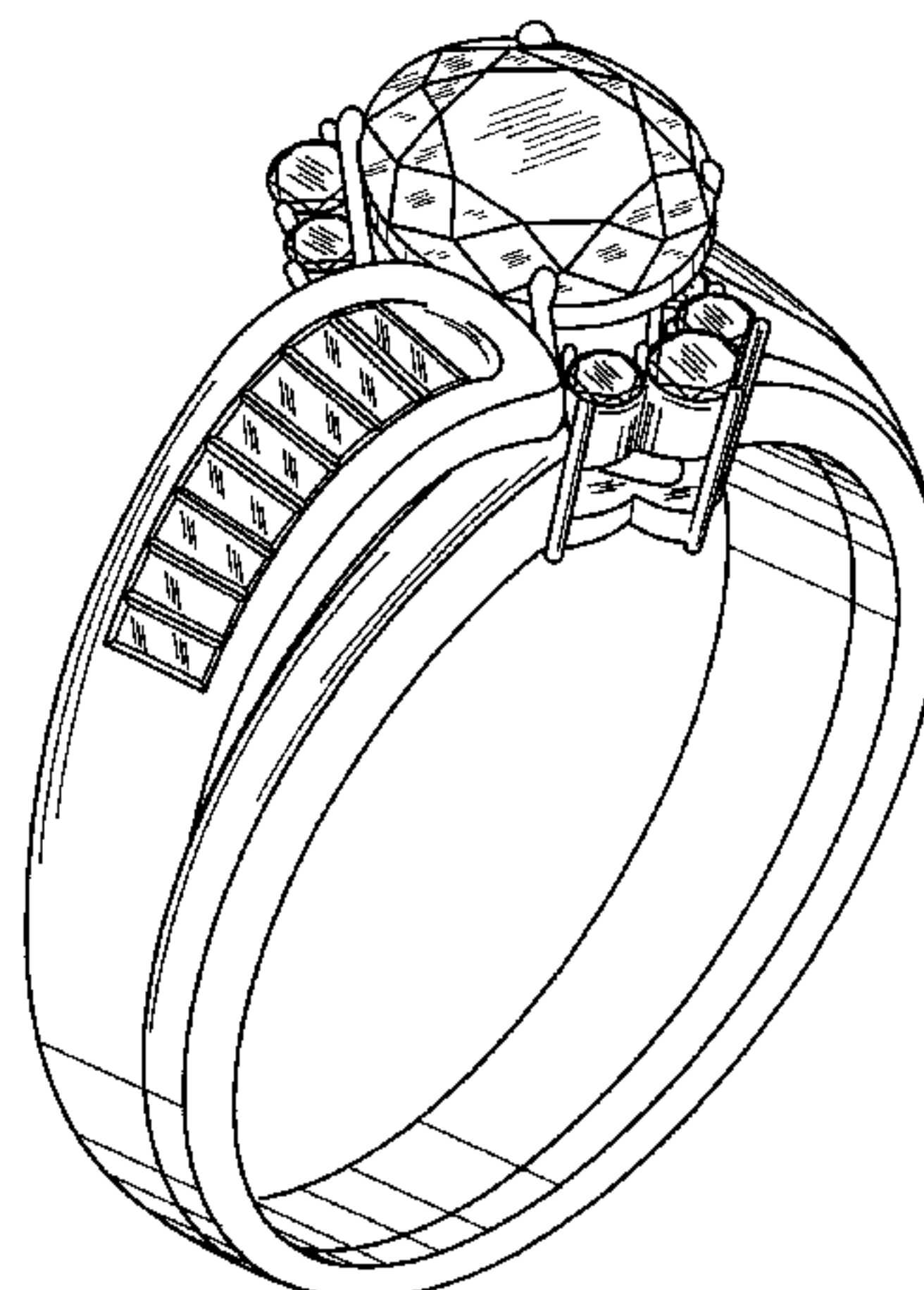
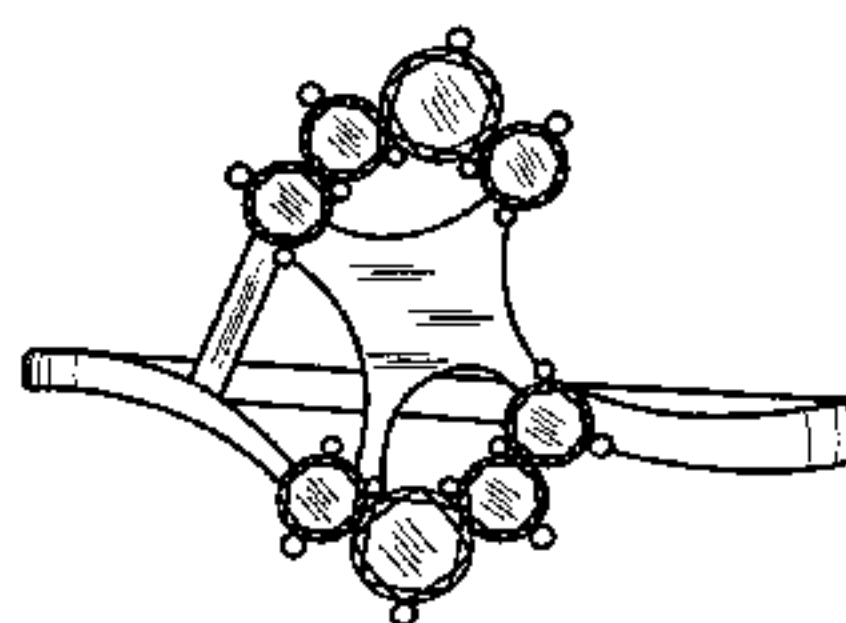
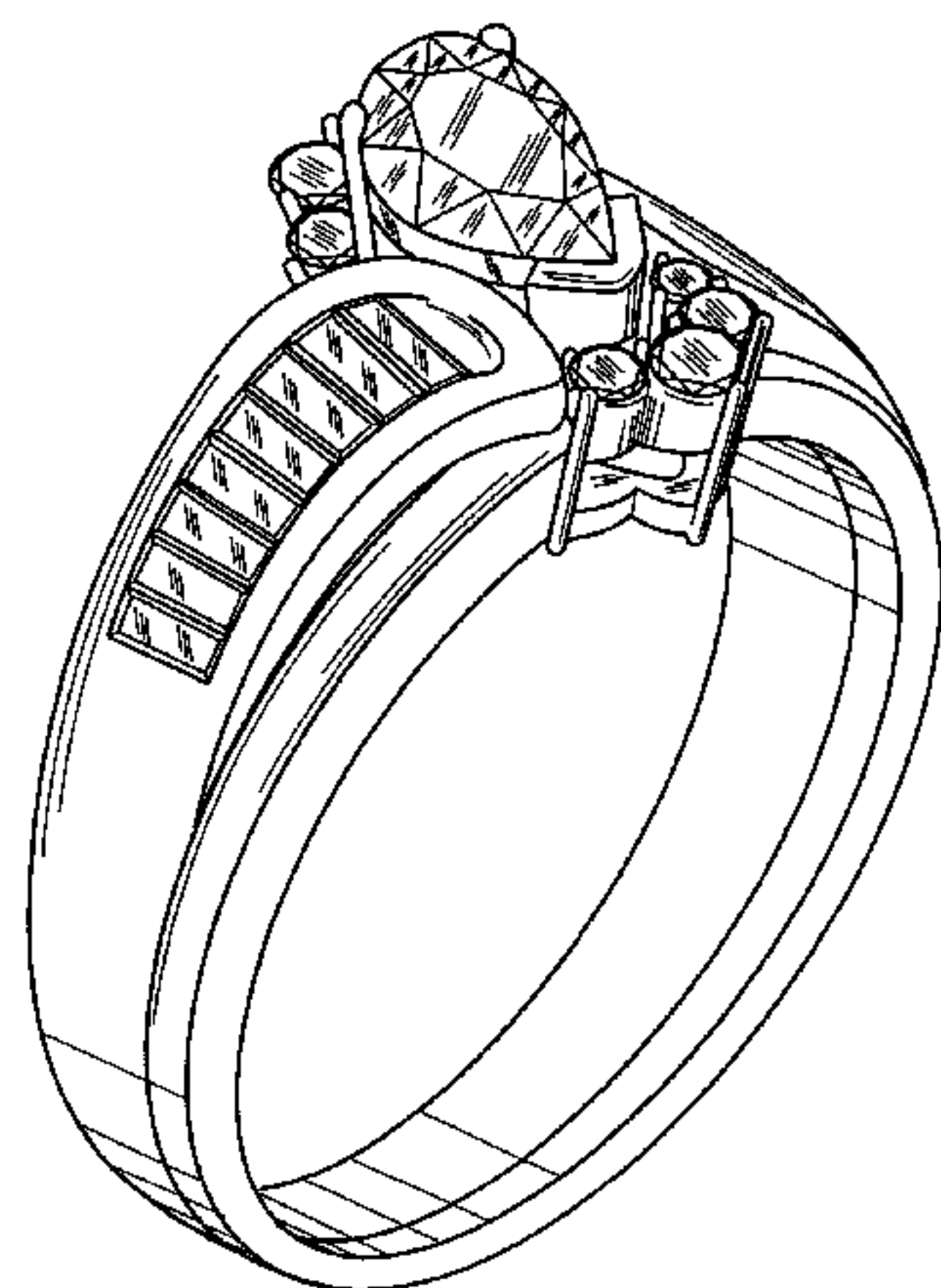
FIG. 11 is a rear view of FIG. 8;

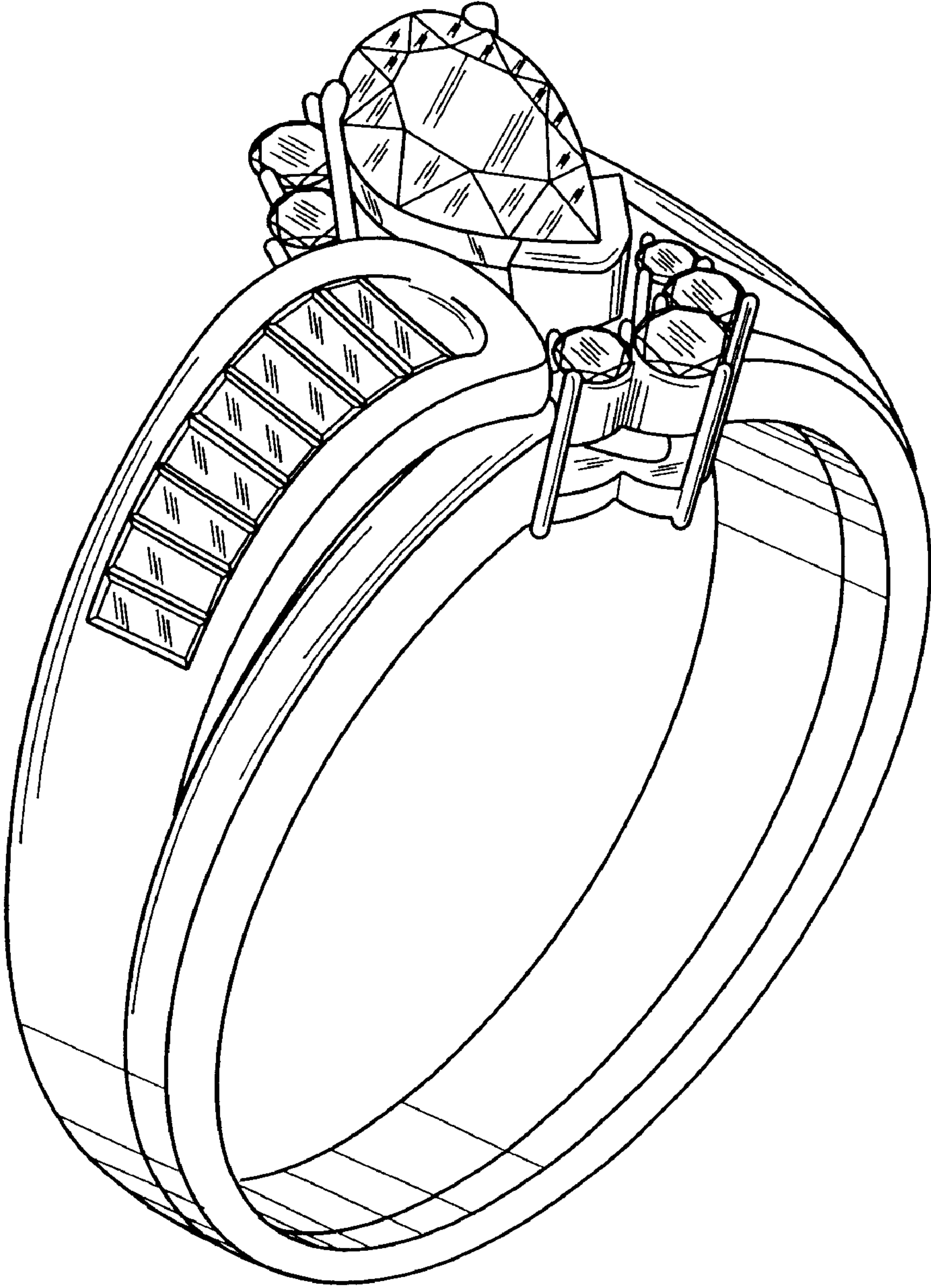

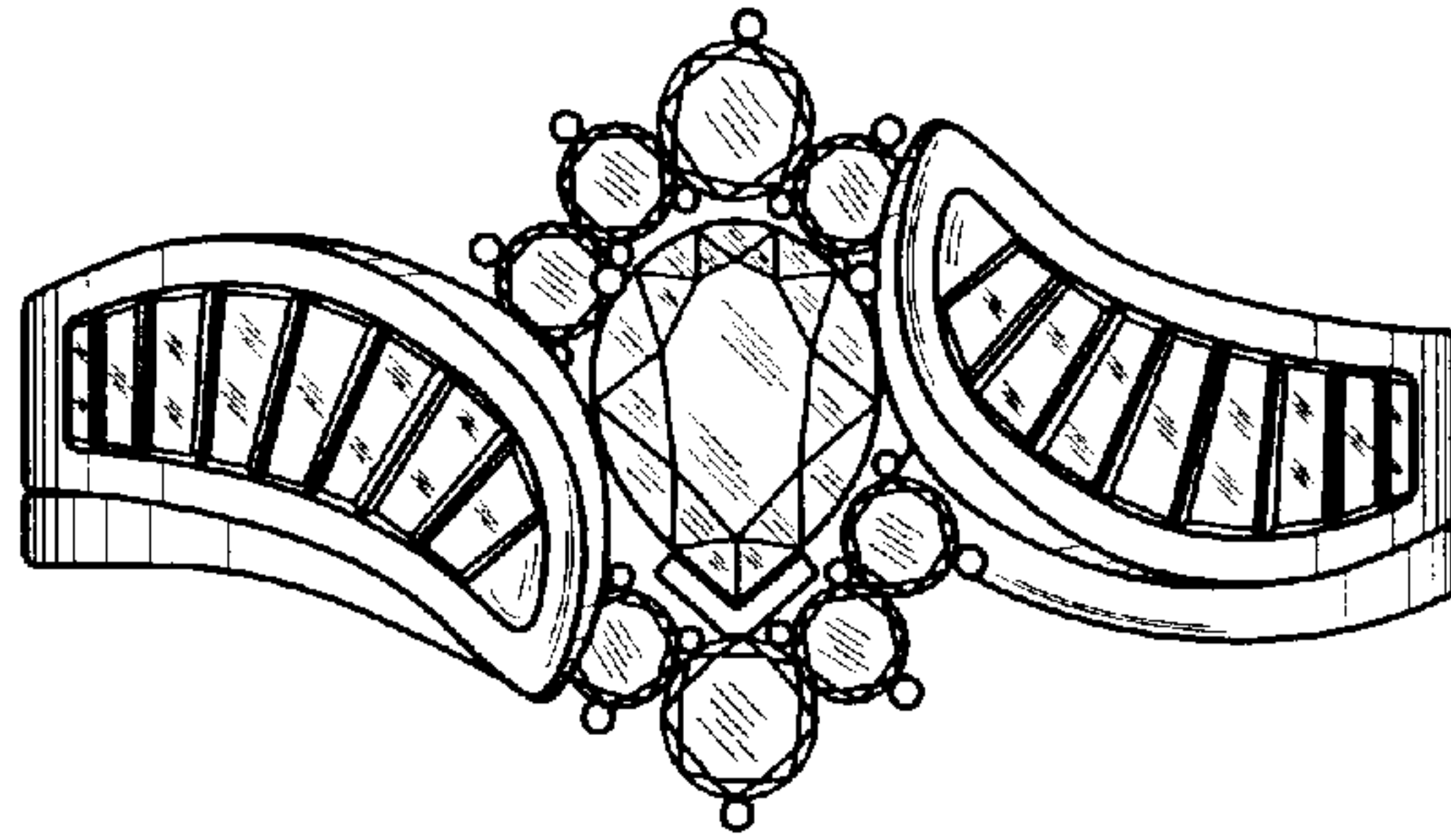

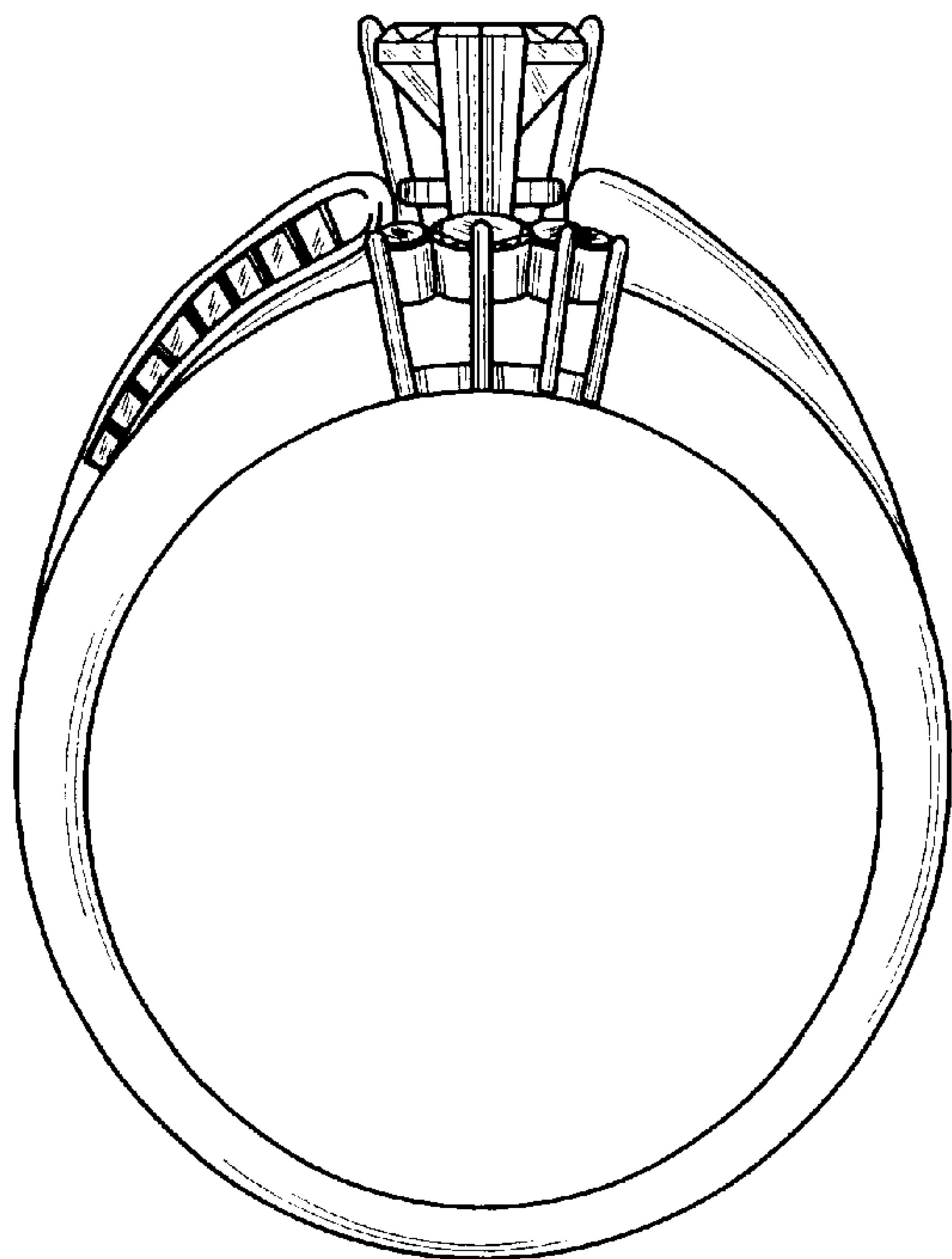

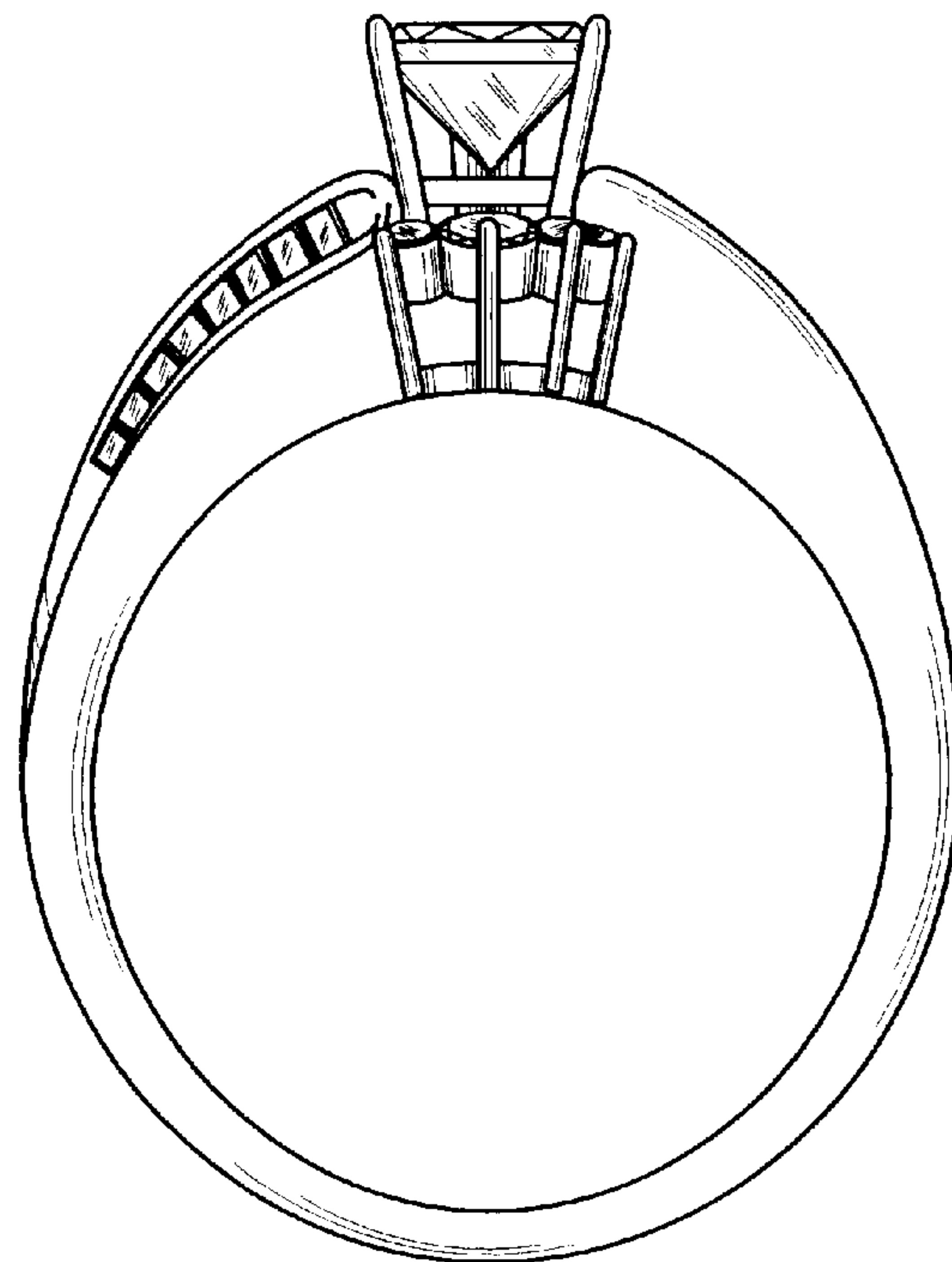

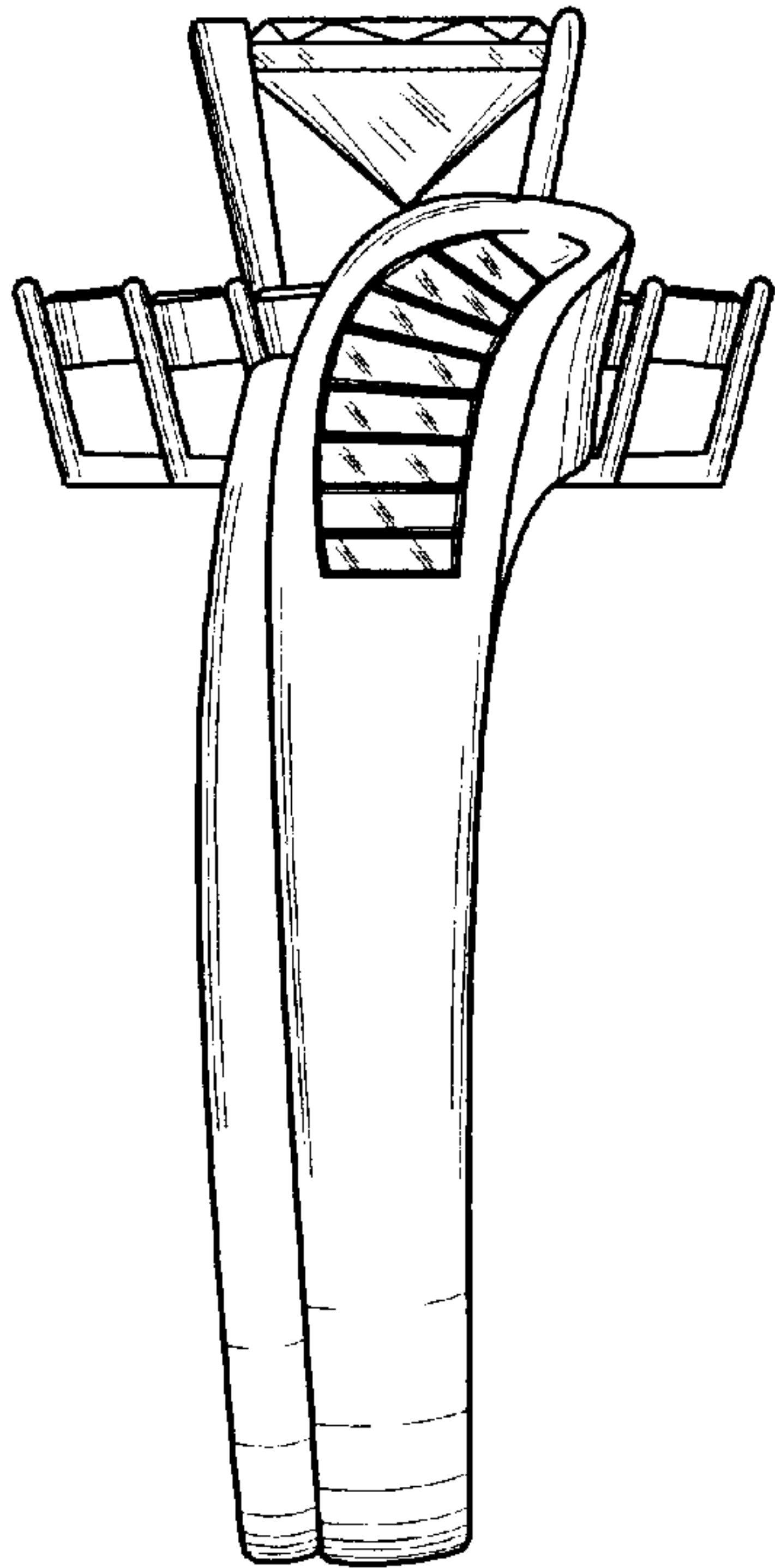

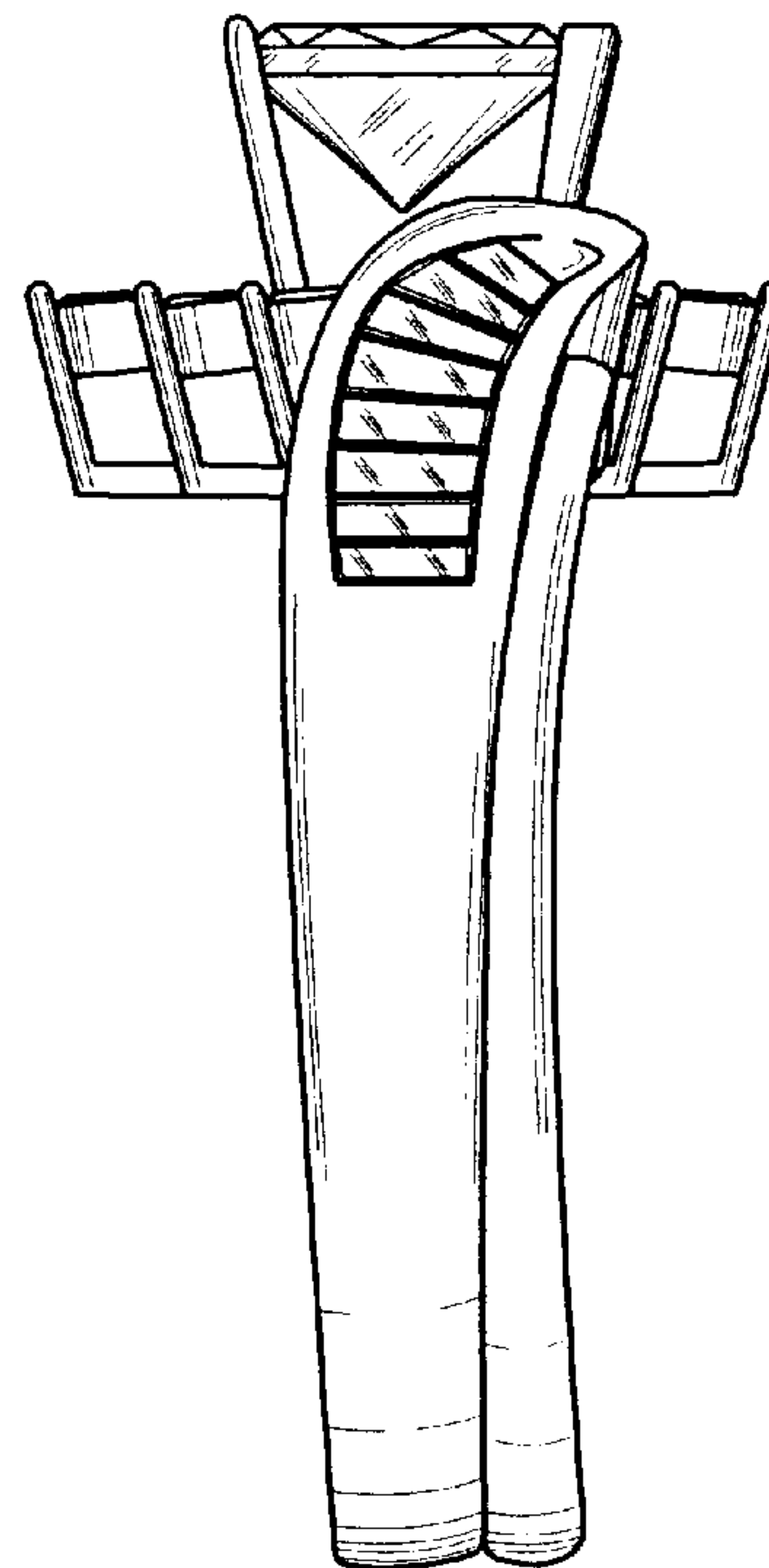

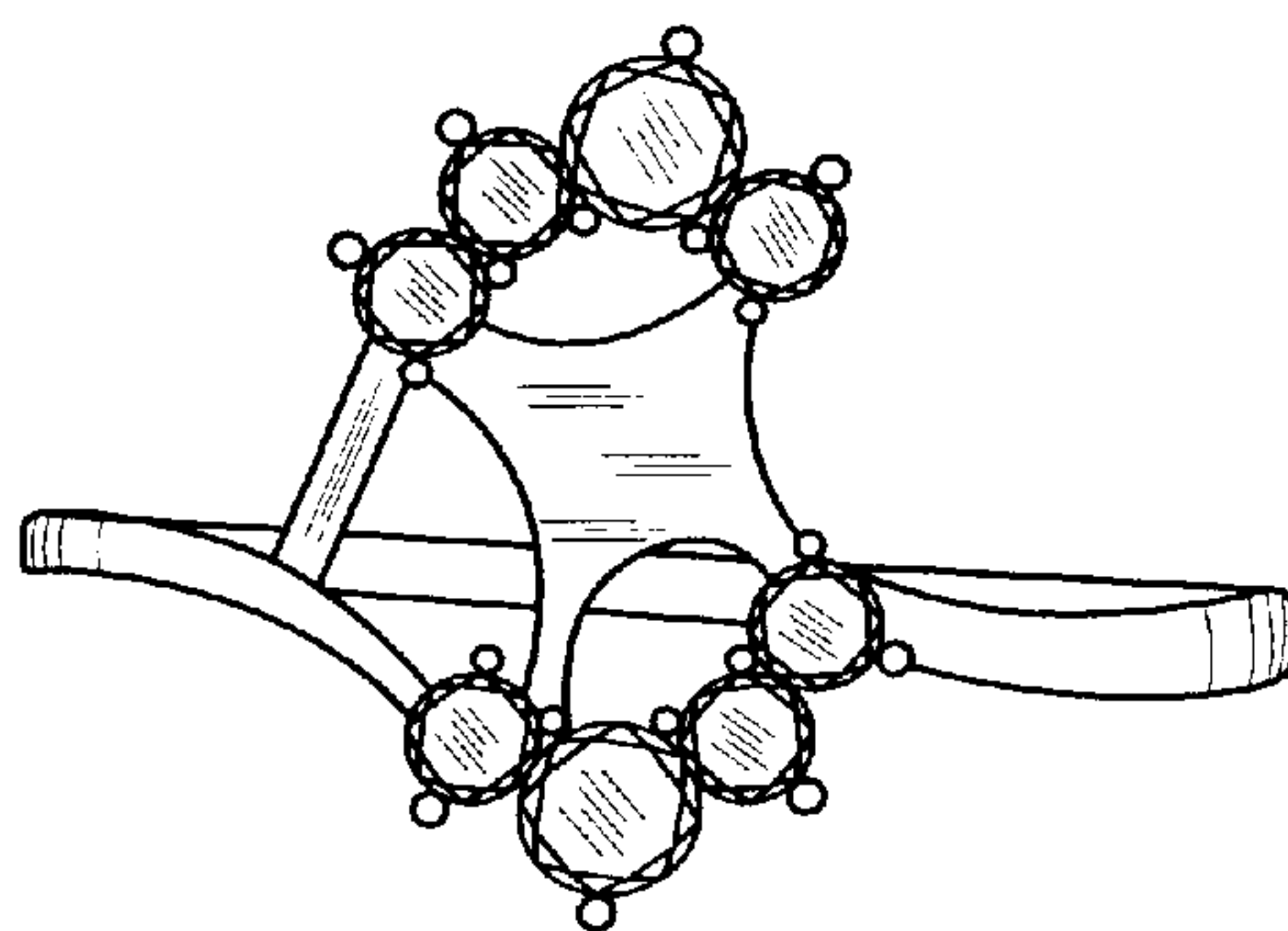

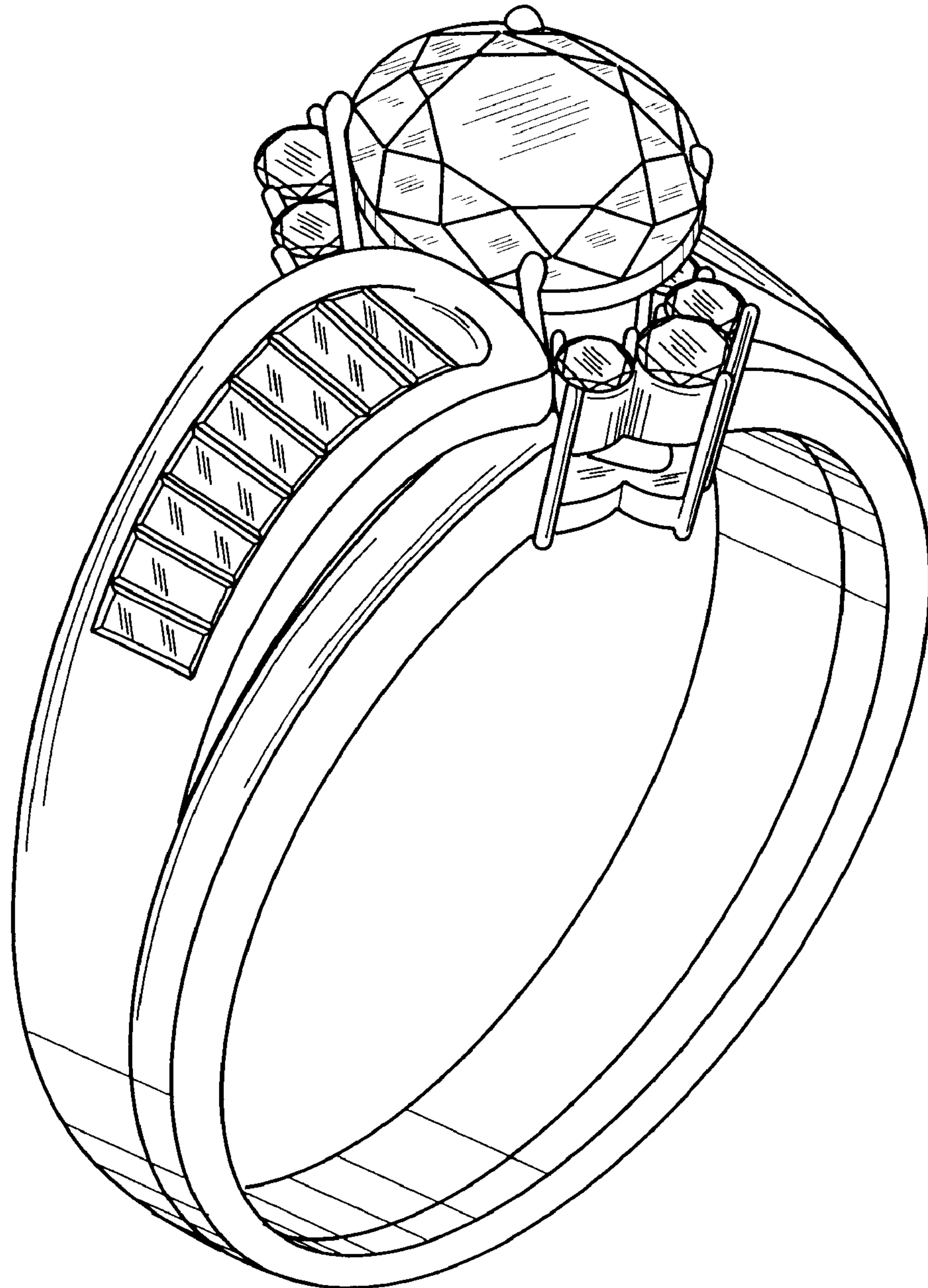

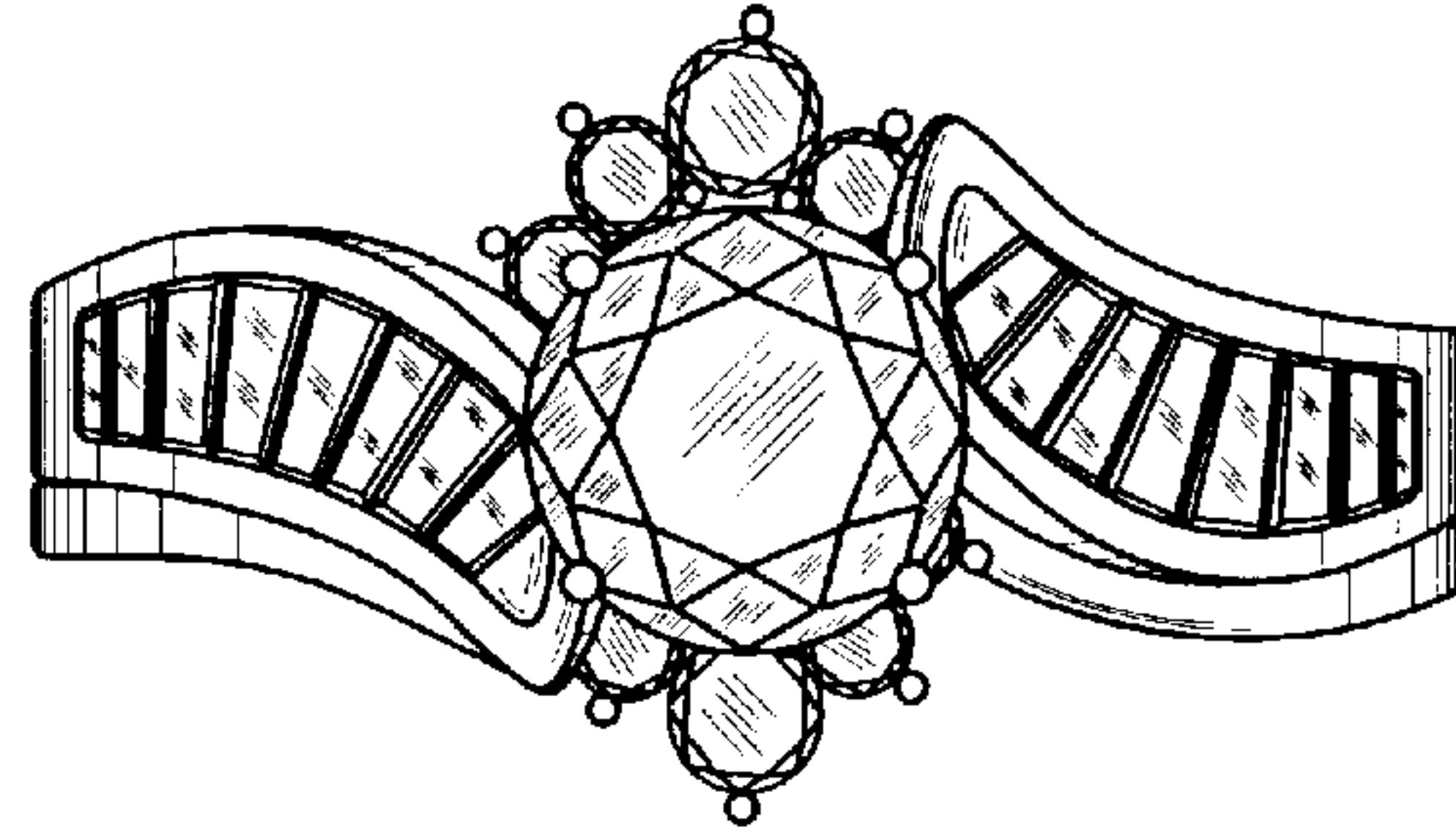

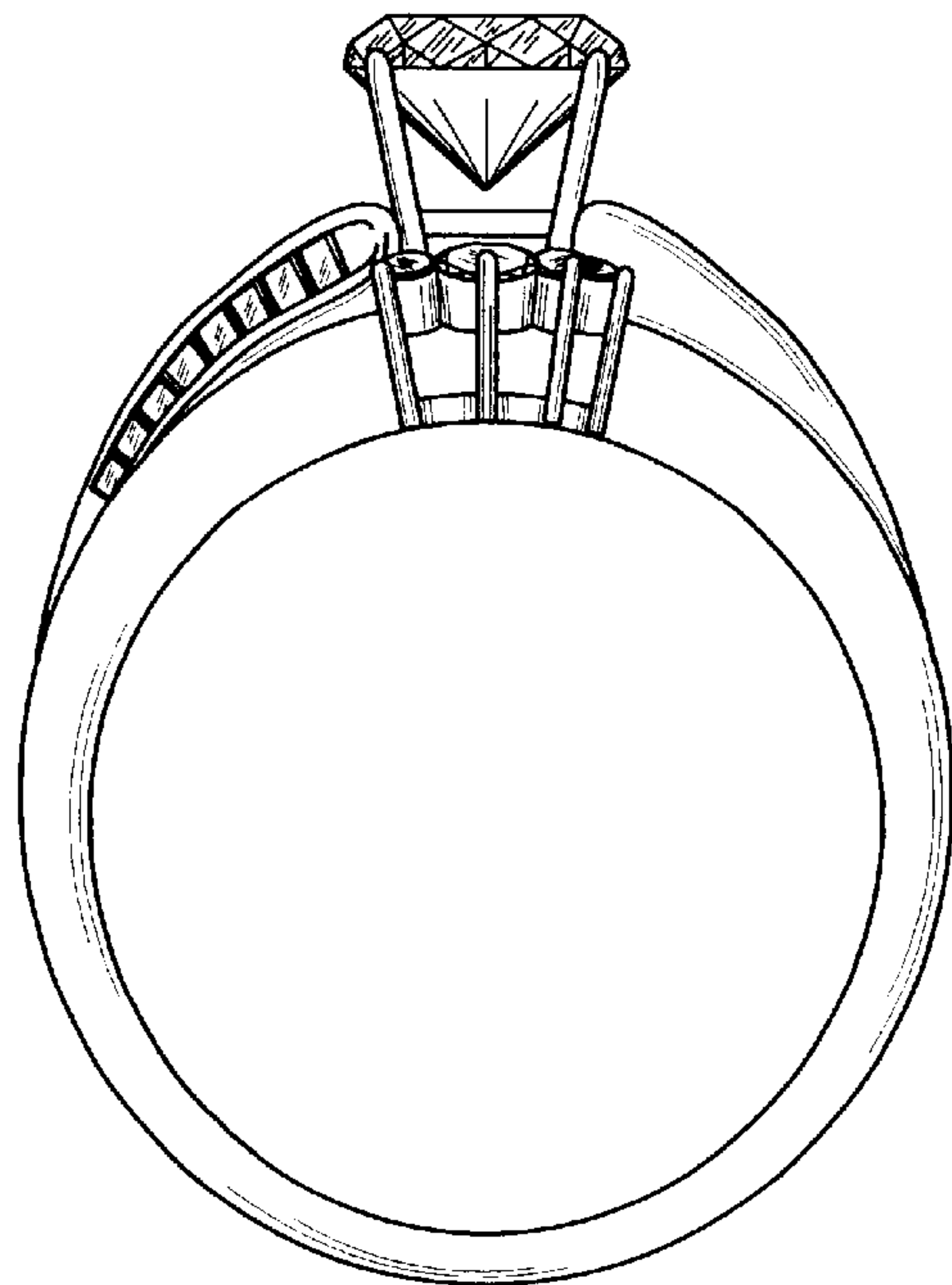

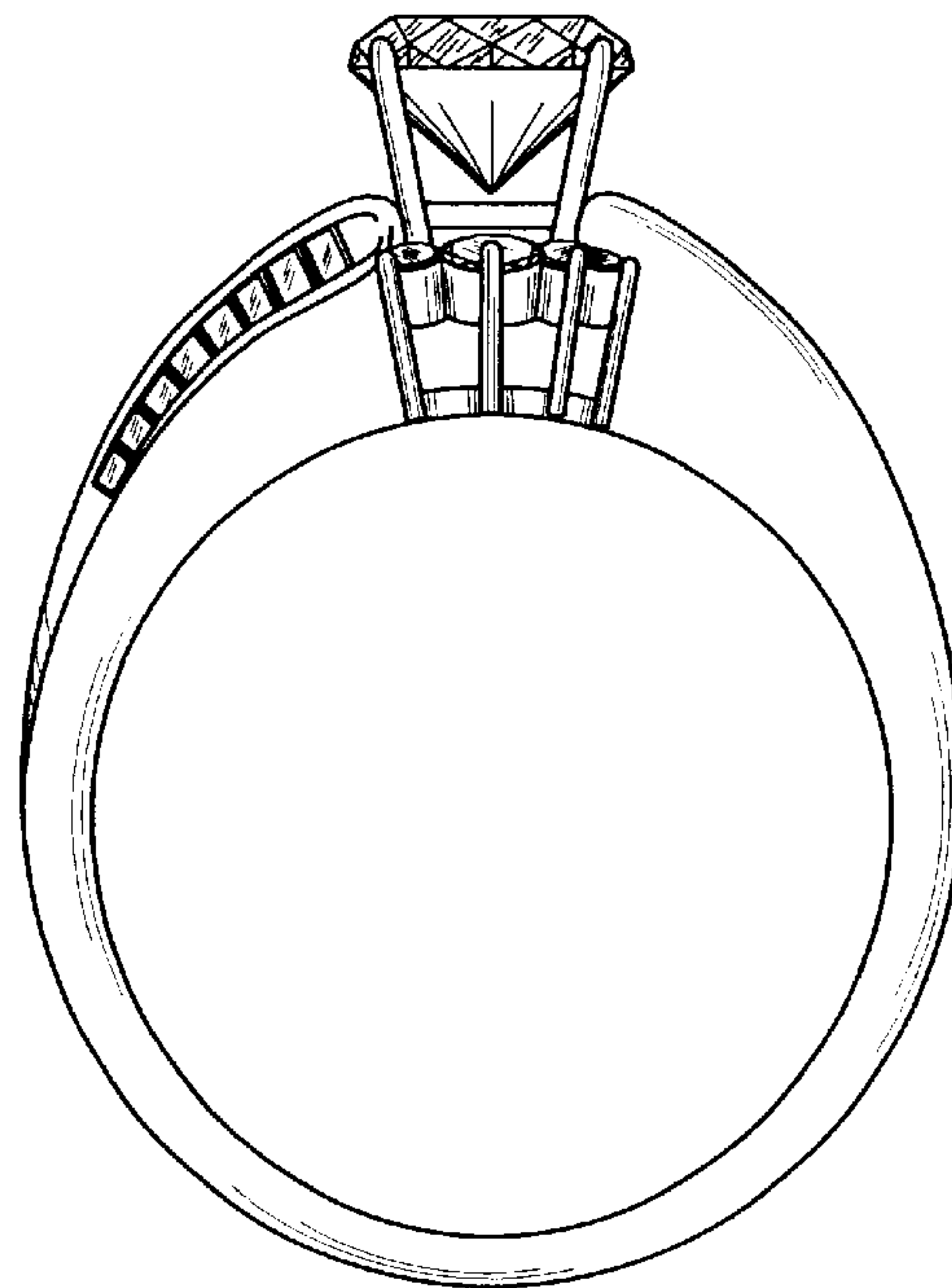

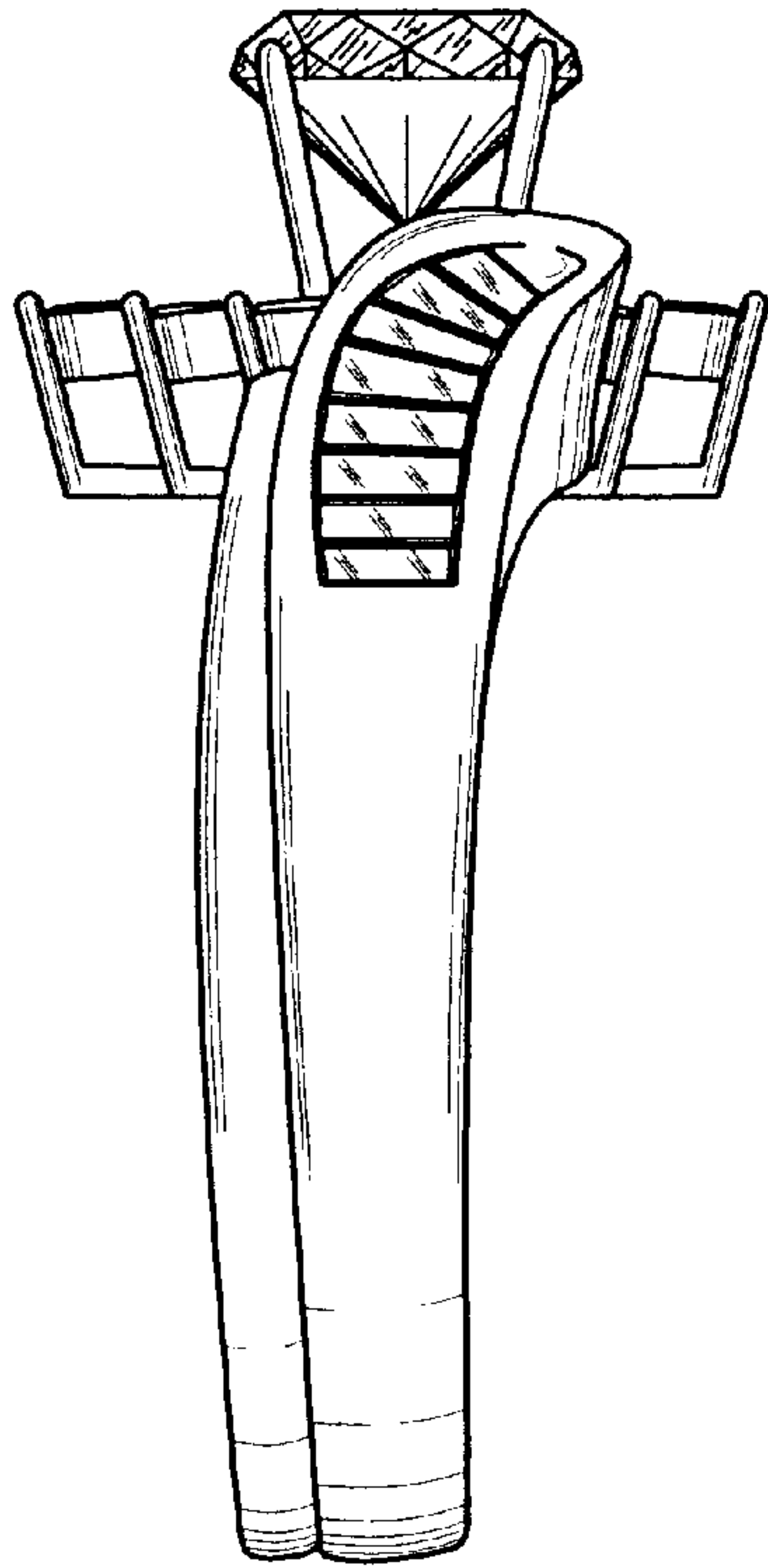

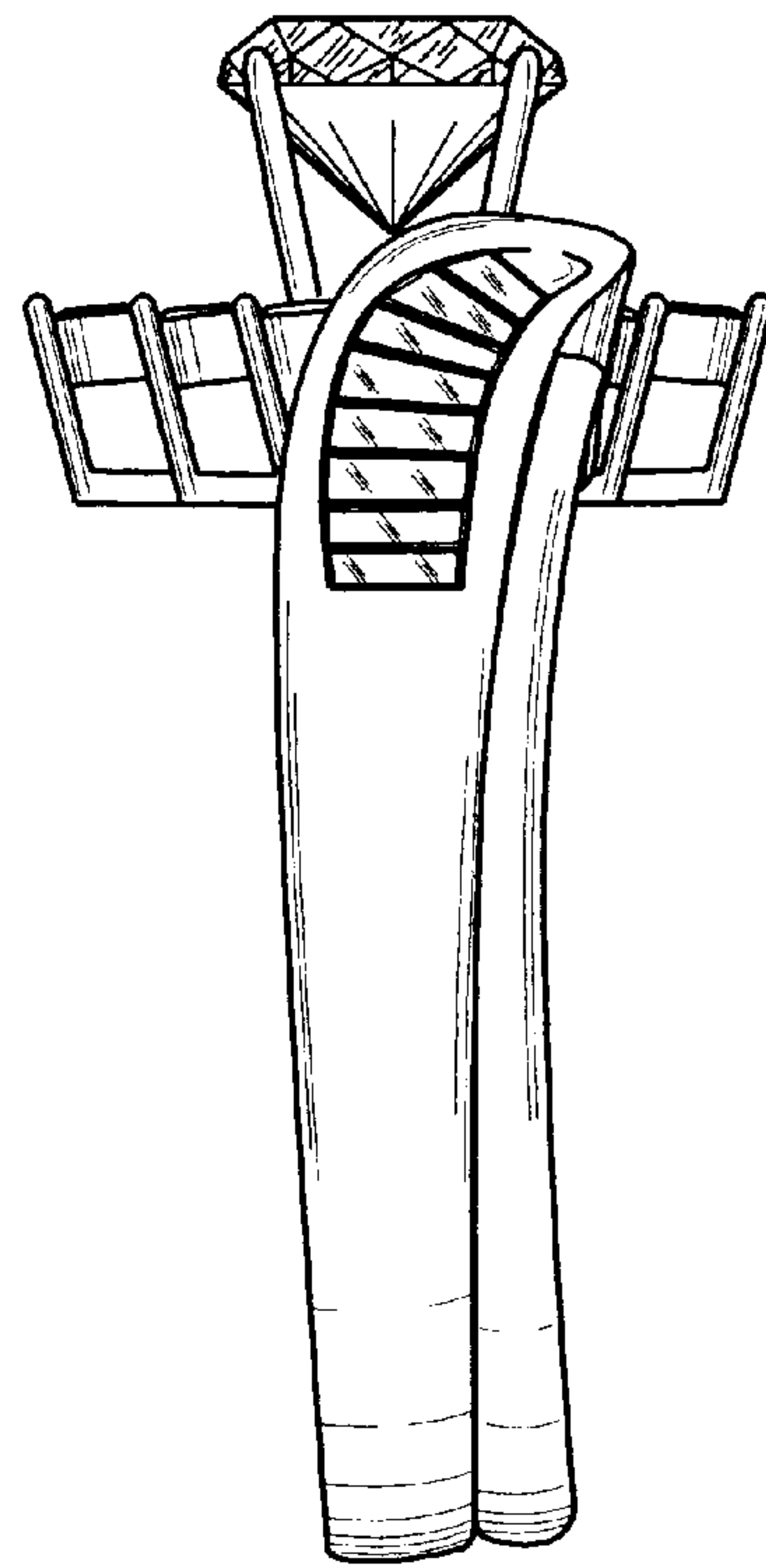

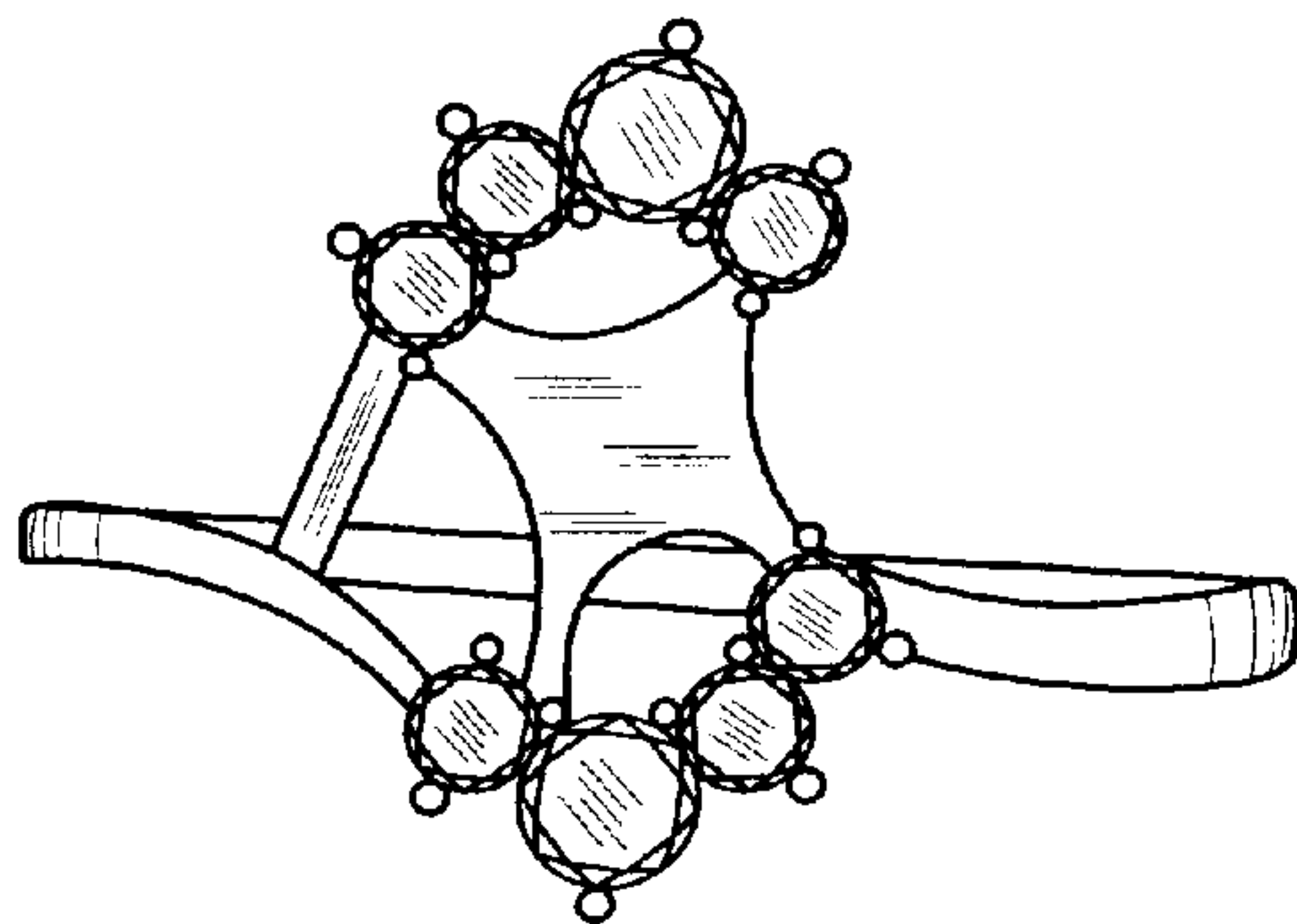
