(57) **CLAIM**

I claim the ornamental design for a skate, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the skate;

FIG. 2 is an opposite side view of the skate;

FIG. 3 is a bottom view of the skate;

FIG. 4 is a front view of the skate; and,

FIG. 5 is a rear view of the skate.

The broken lines immediately adjacent the shaded areas in FIG. 3 represent the bounds of the claim and all other broken lines are for illustrative purposes only. None form a part of the claimed design.

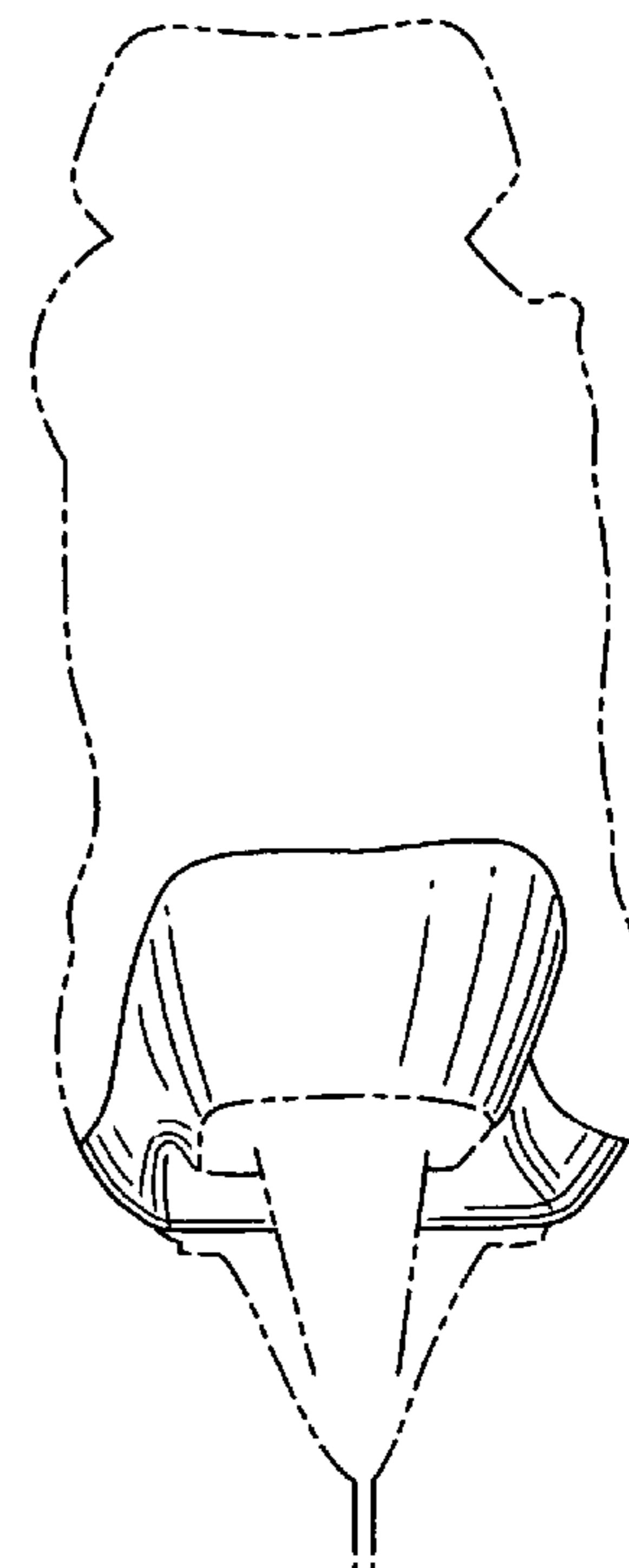
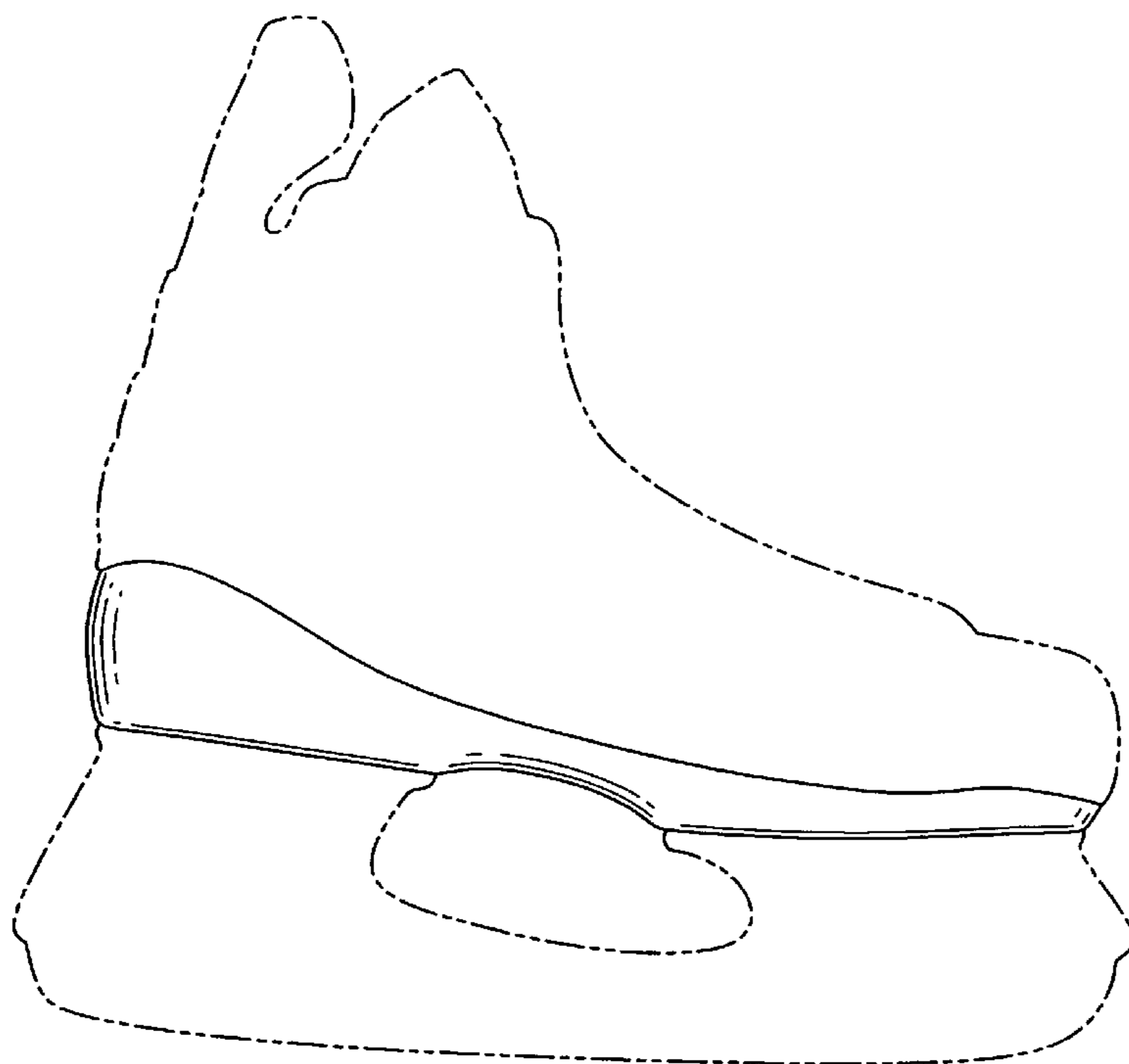

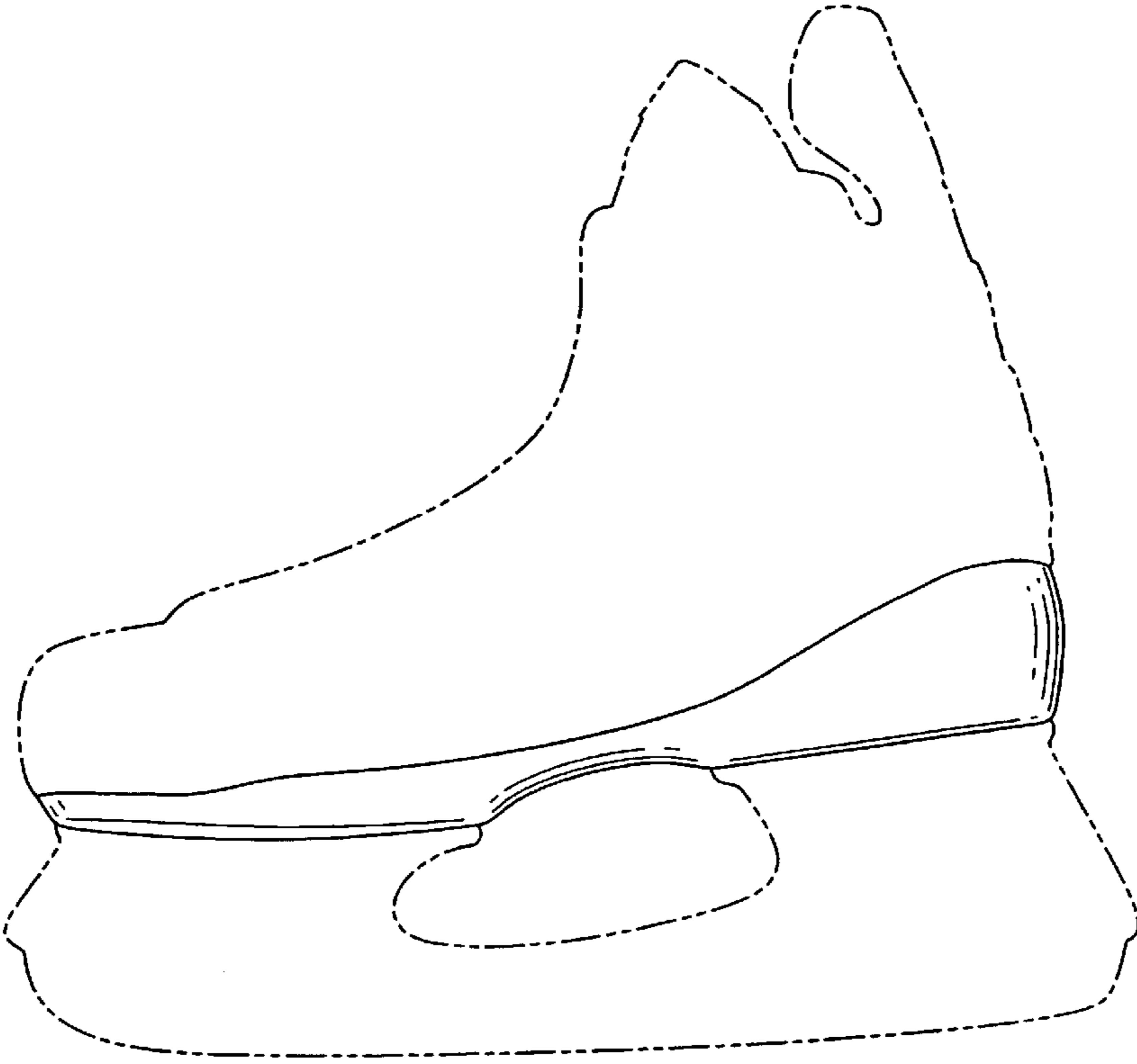

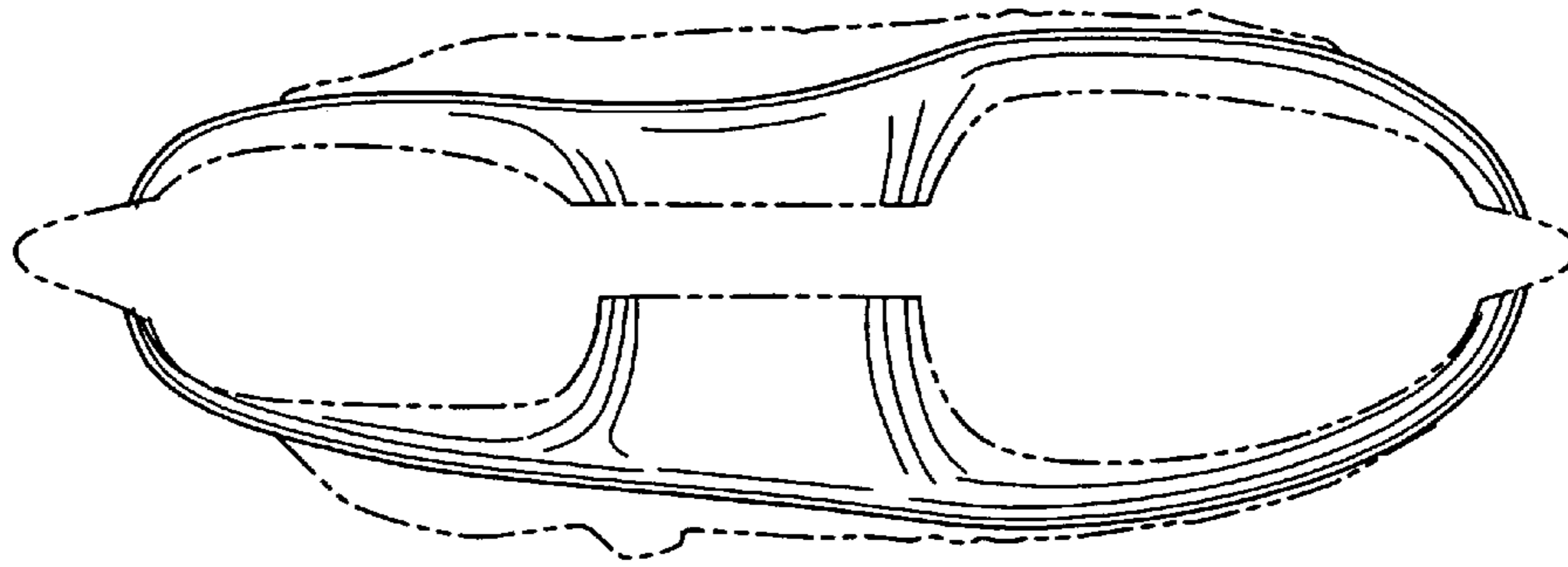

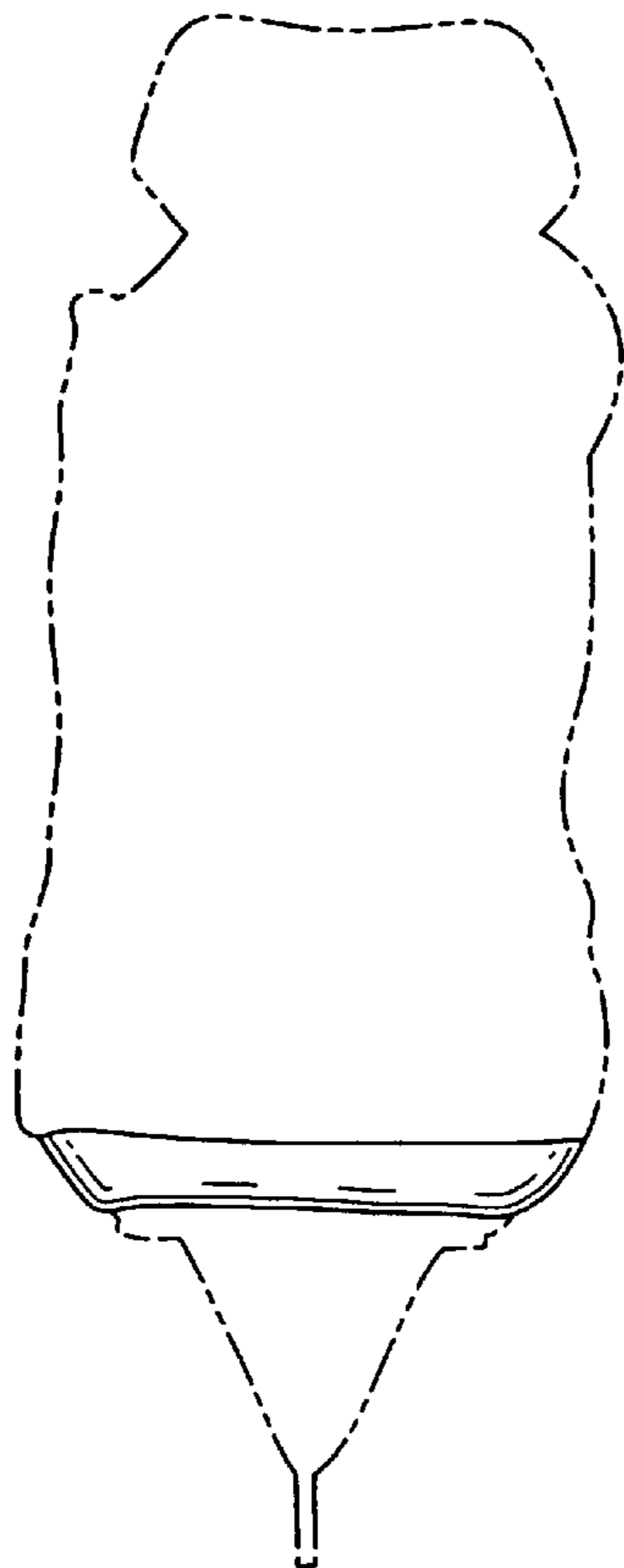

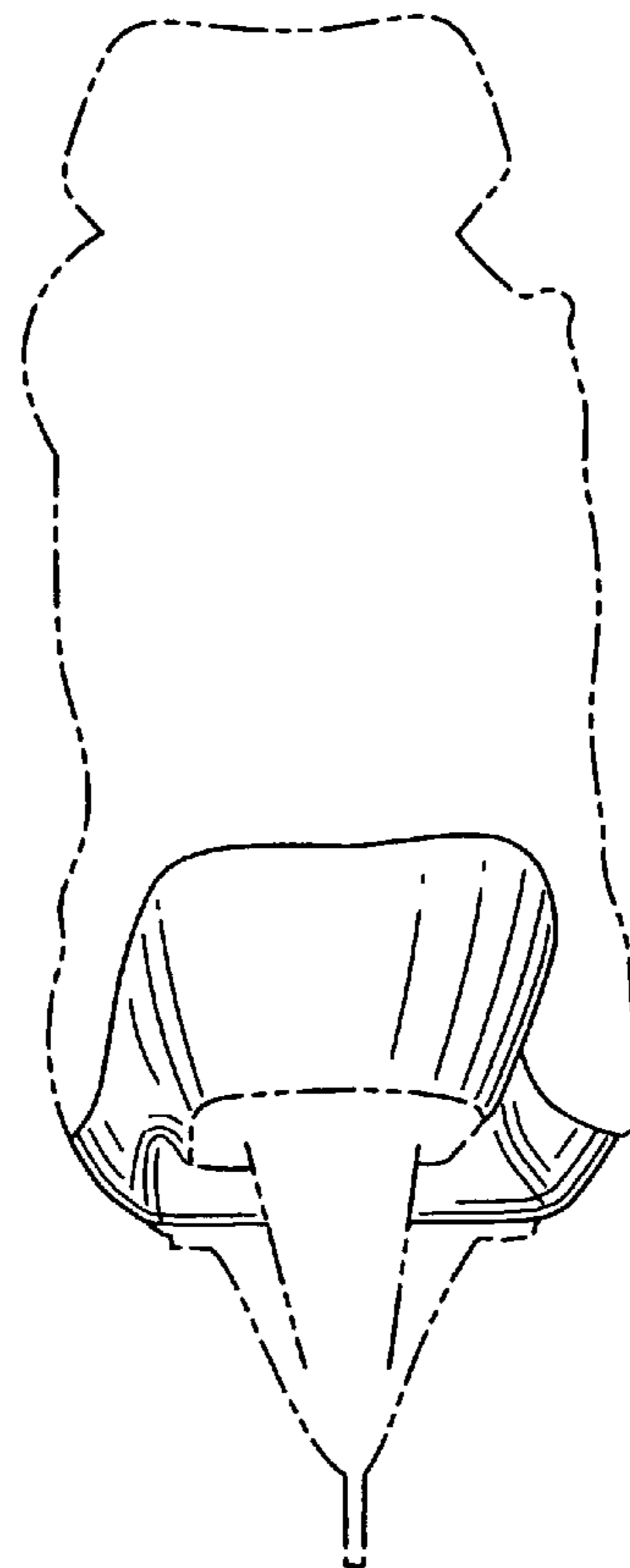
