FIG. 3 shows a top plan view of the present design.

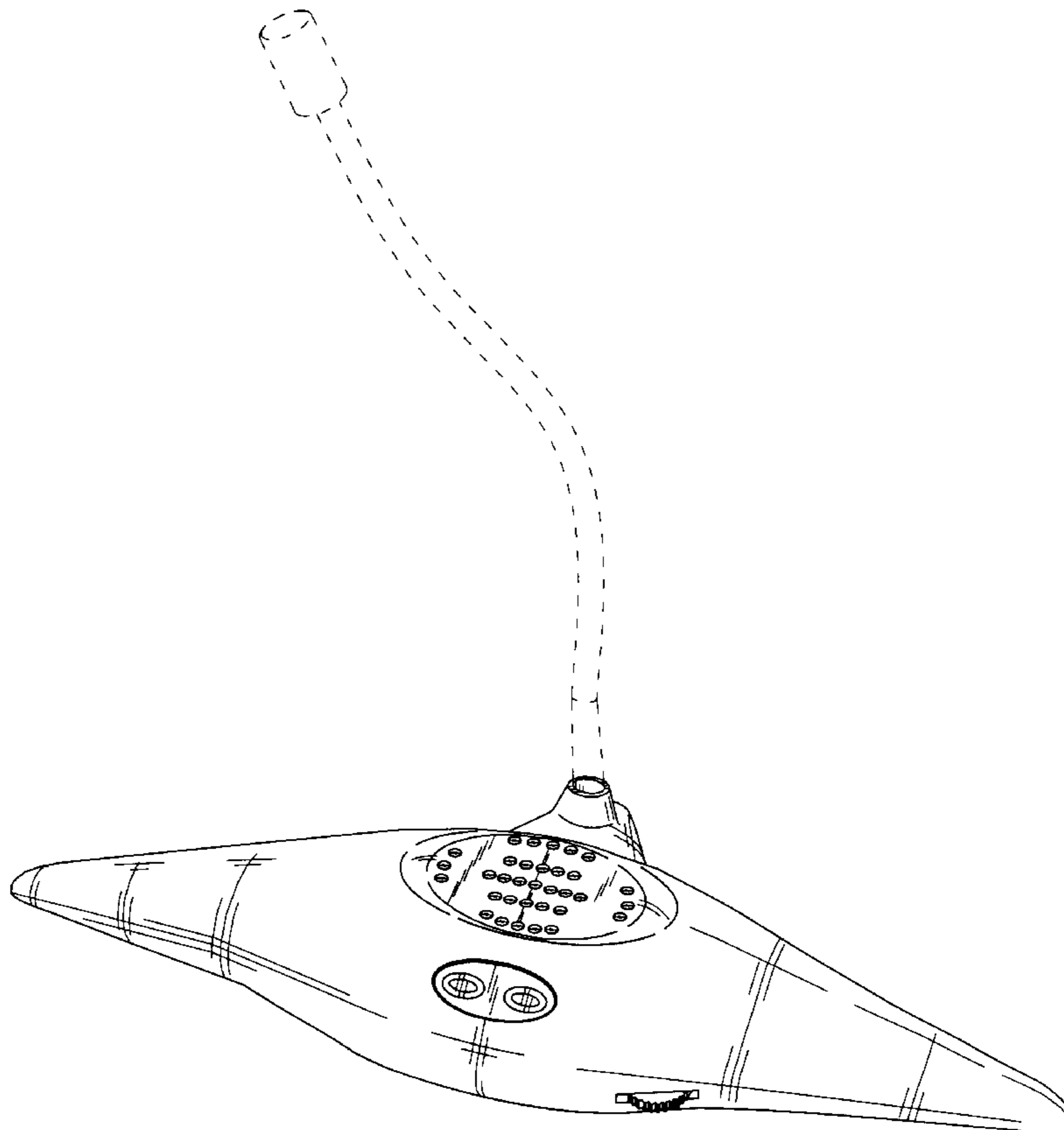
FIG. 4 shows a front elevational view of the present design.

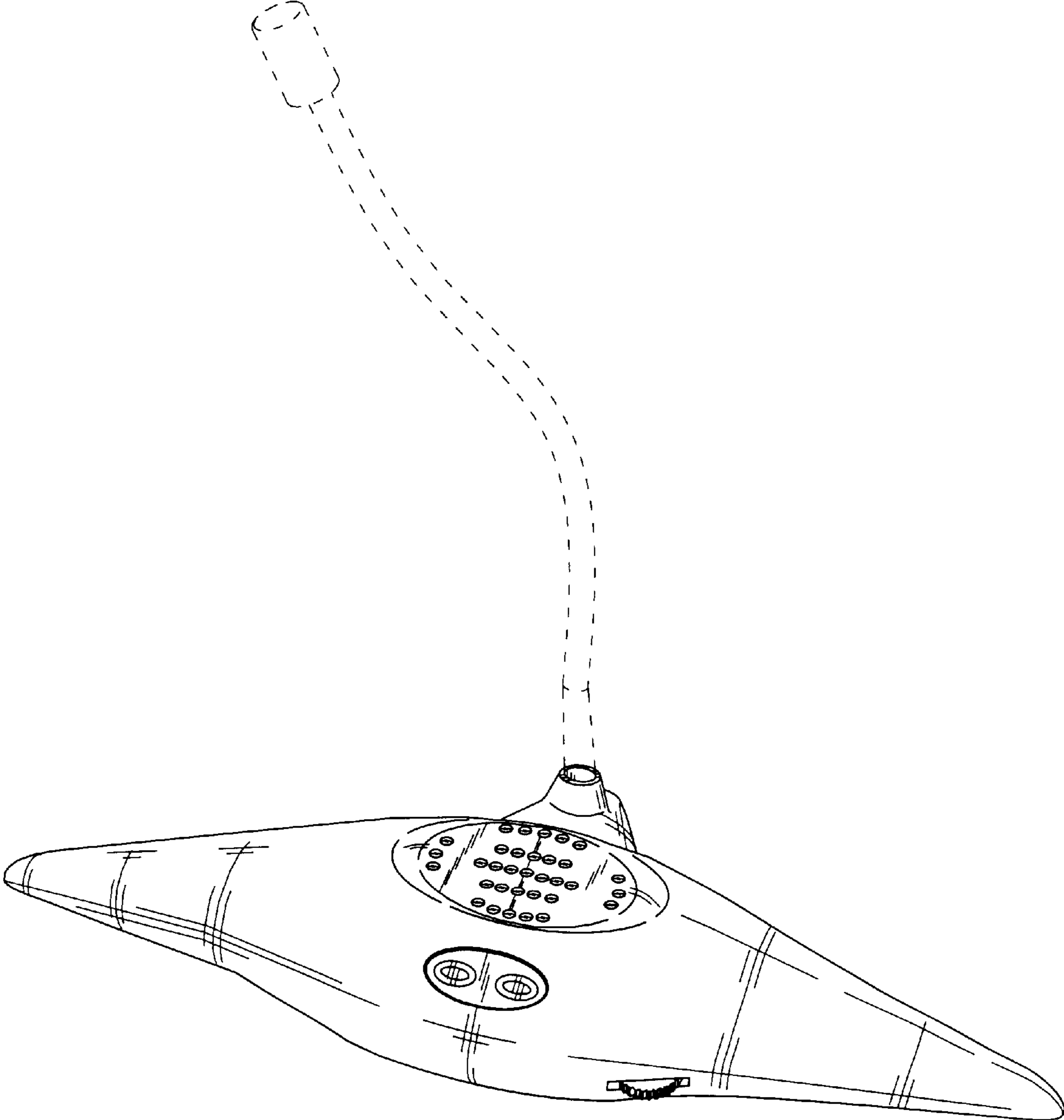

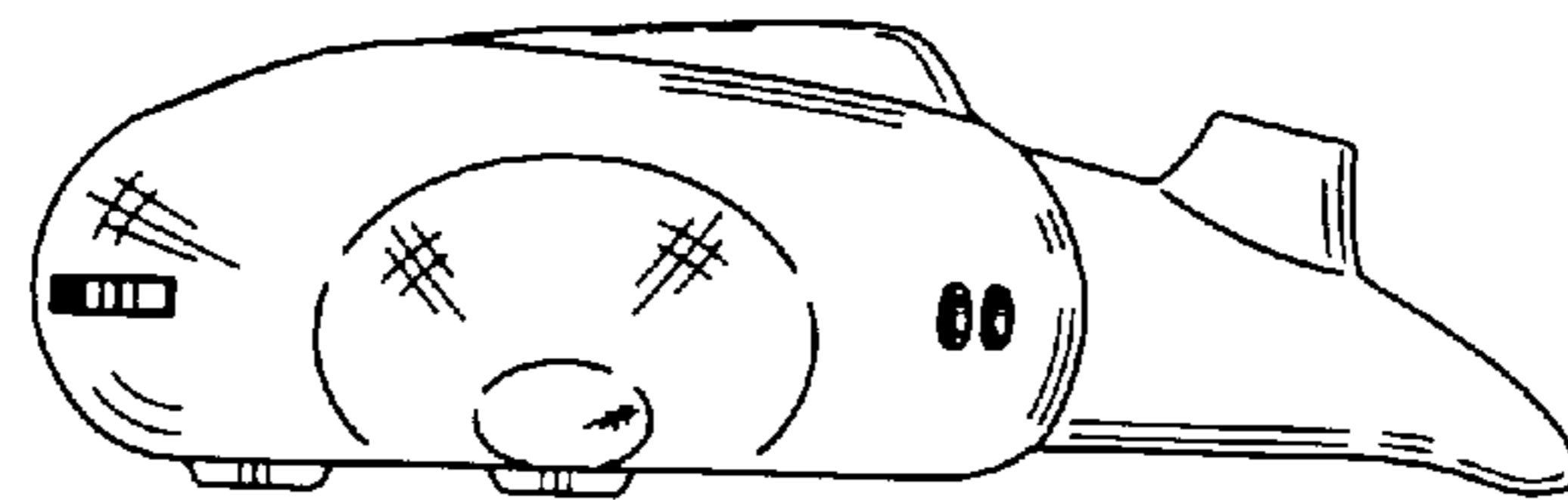

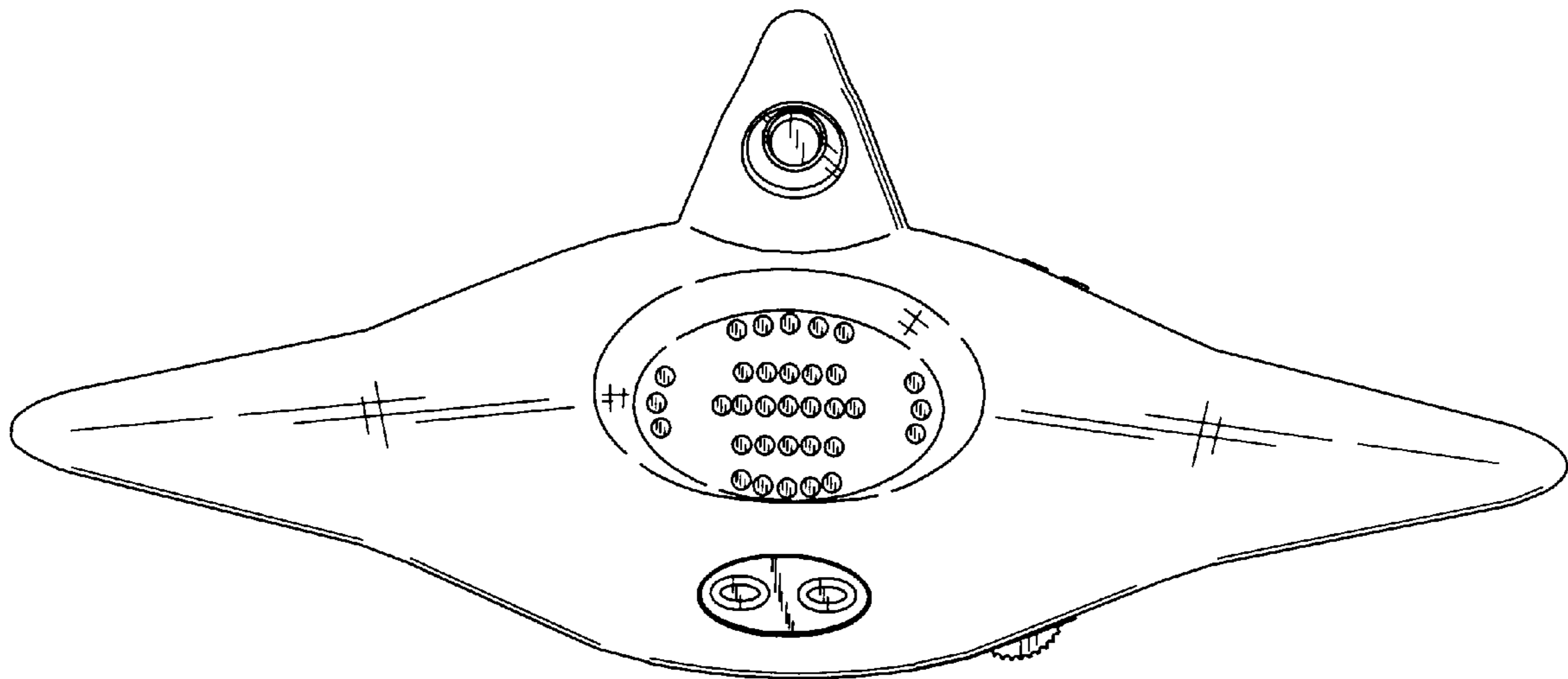

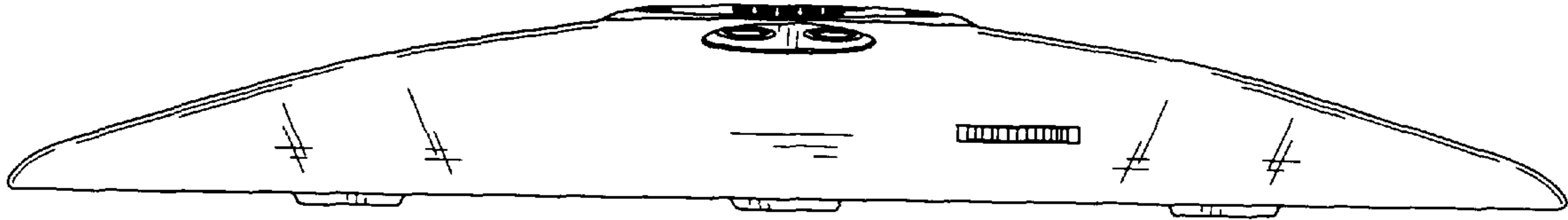

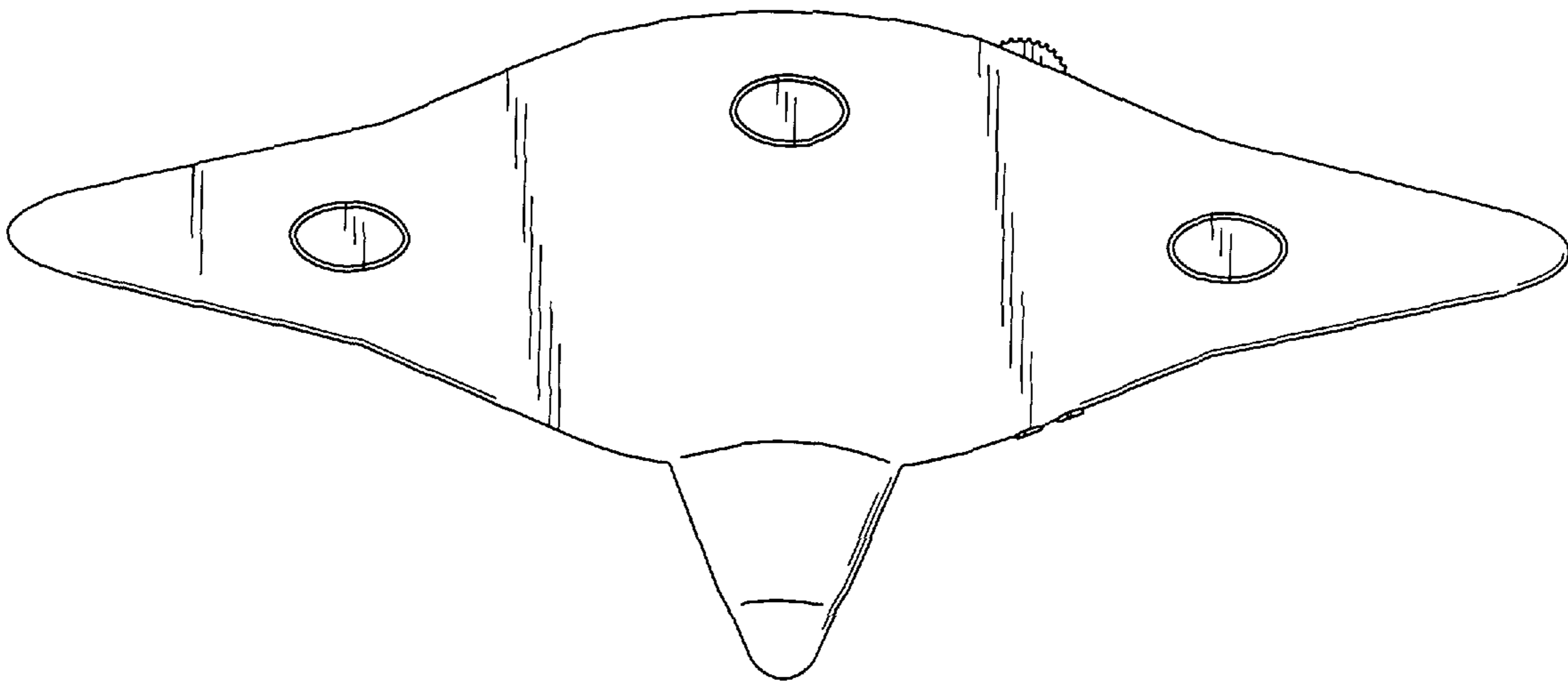

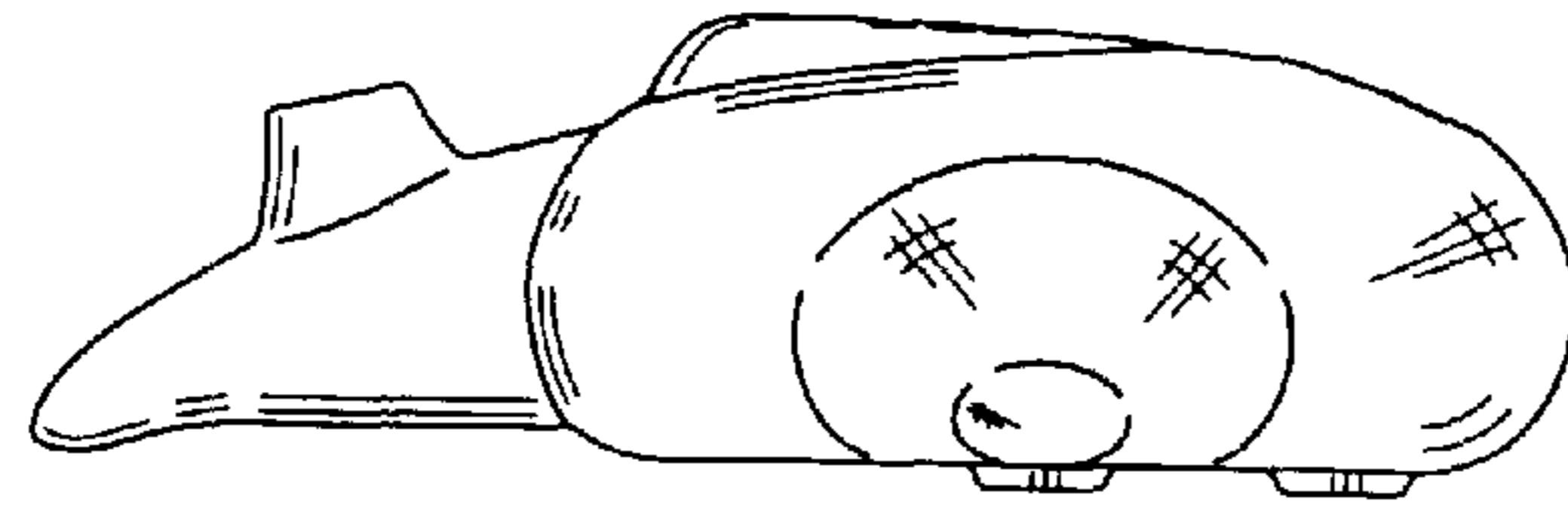

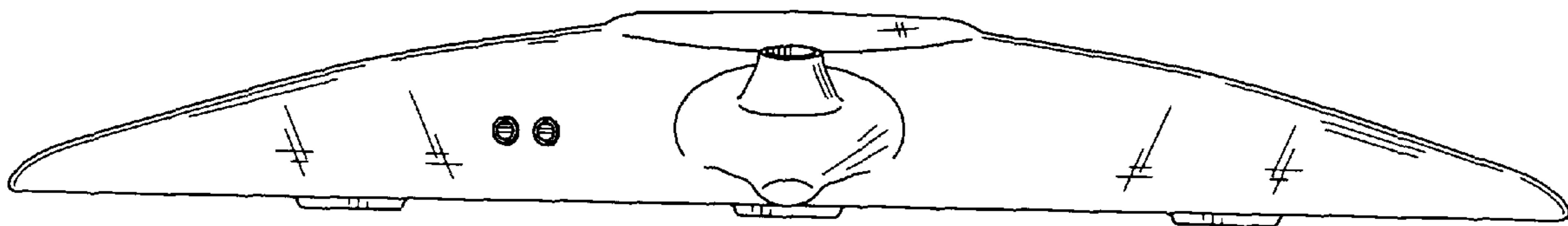
