(57) **CLAIM**

The ornamental design for a baseball bunting target, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a bunting target showing a first  
embodiment of our design with grommets situated in the  
seam;

FIG. 2 is a bottom view of the embodiment shown in FIG.  
1;

FIG. 3 is a front view of the embodiment shown in FIG. 1;

FIG. 4 is a rear view of the embodiment shown in FIG. 1;

FIG. 20 is a front view of the embodiment shown in FIG. 19;

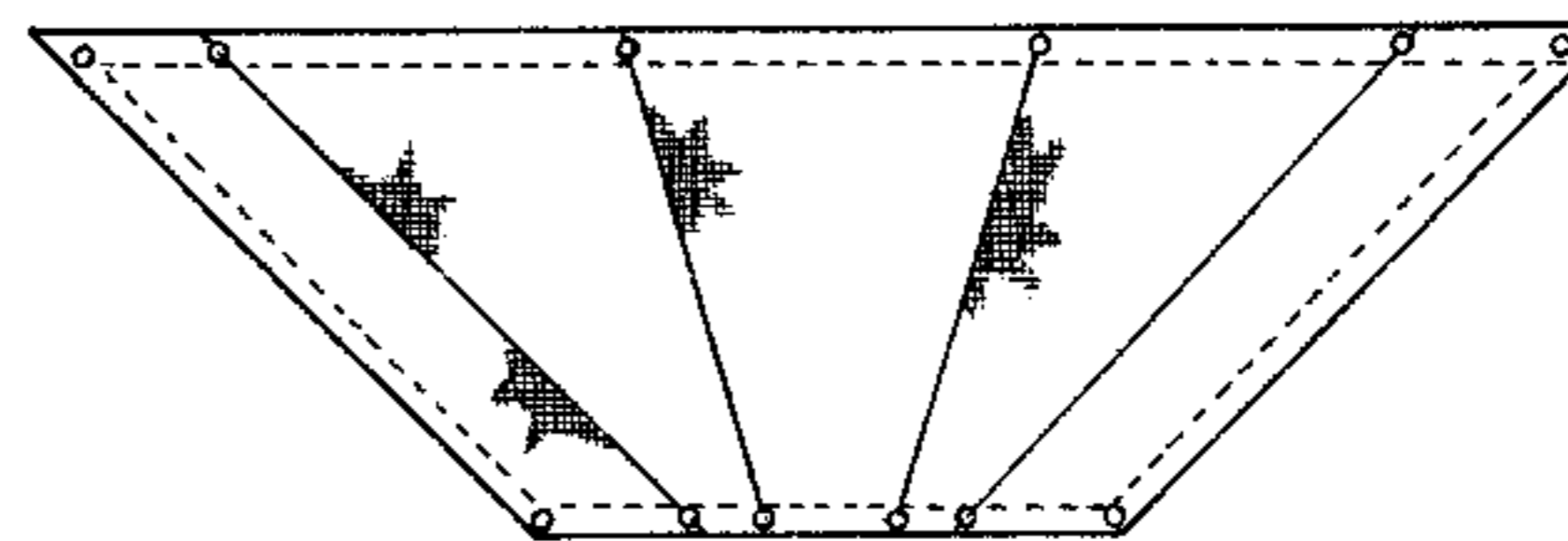
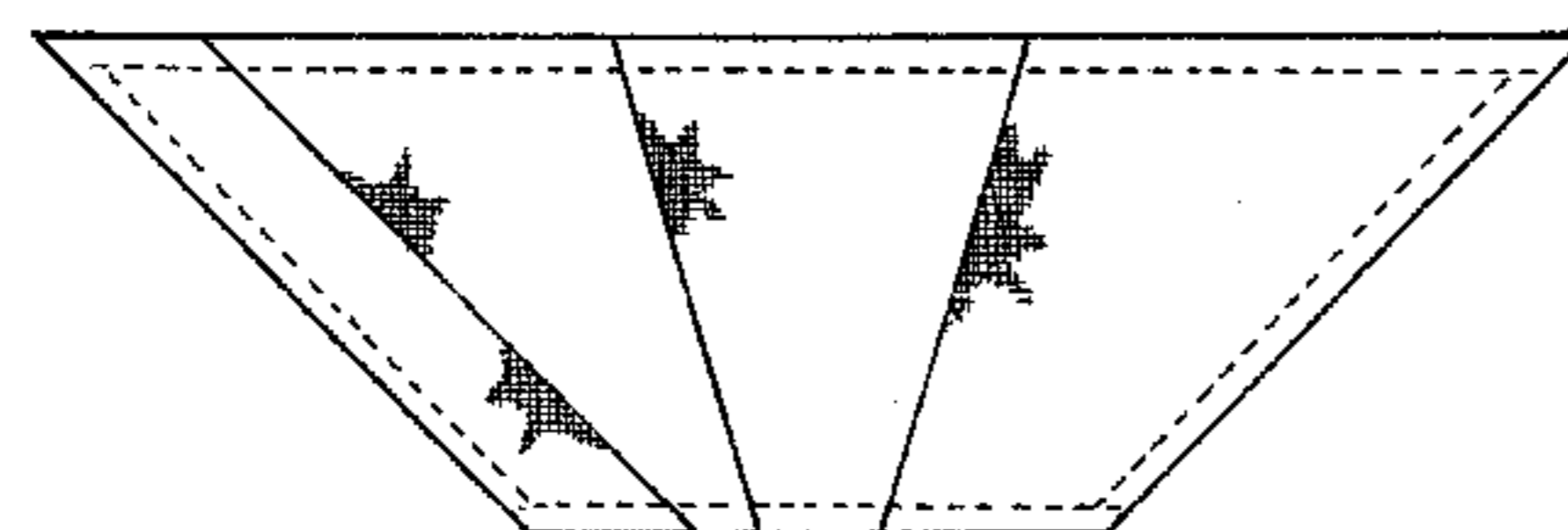
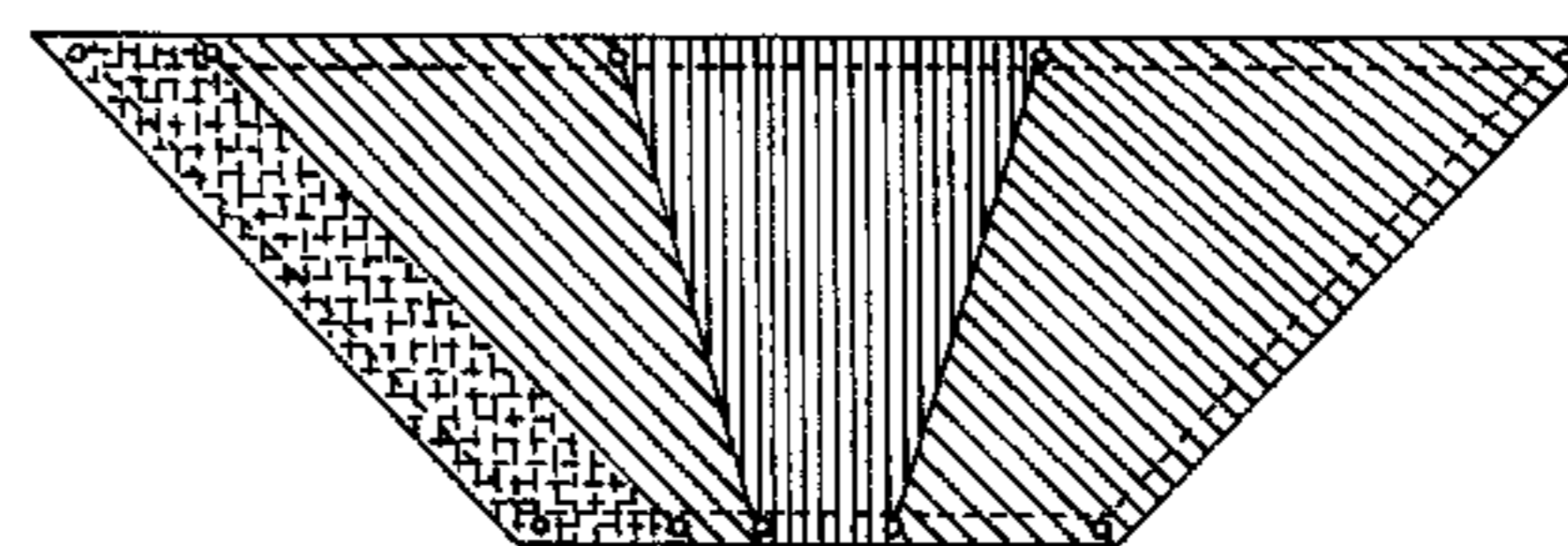
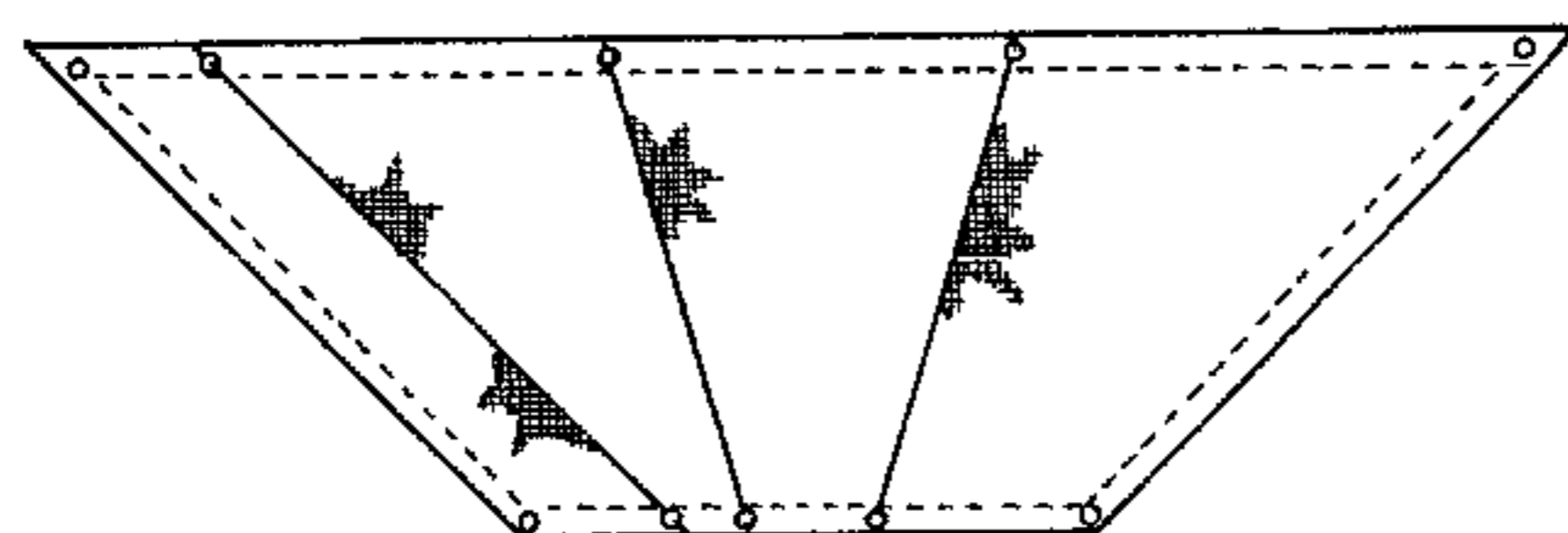
FIG. 21 is a rear view of the embodiment shown in FIG. 19;

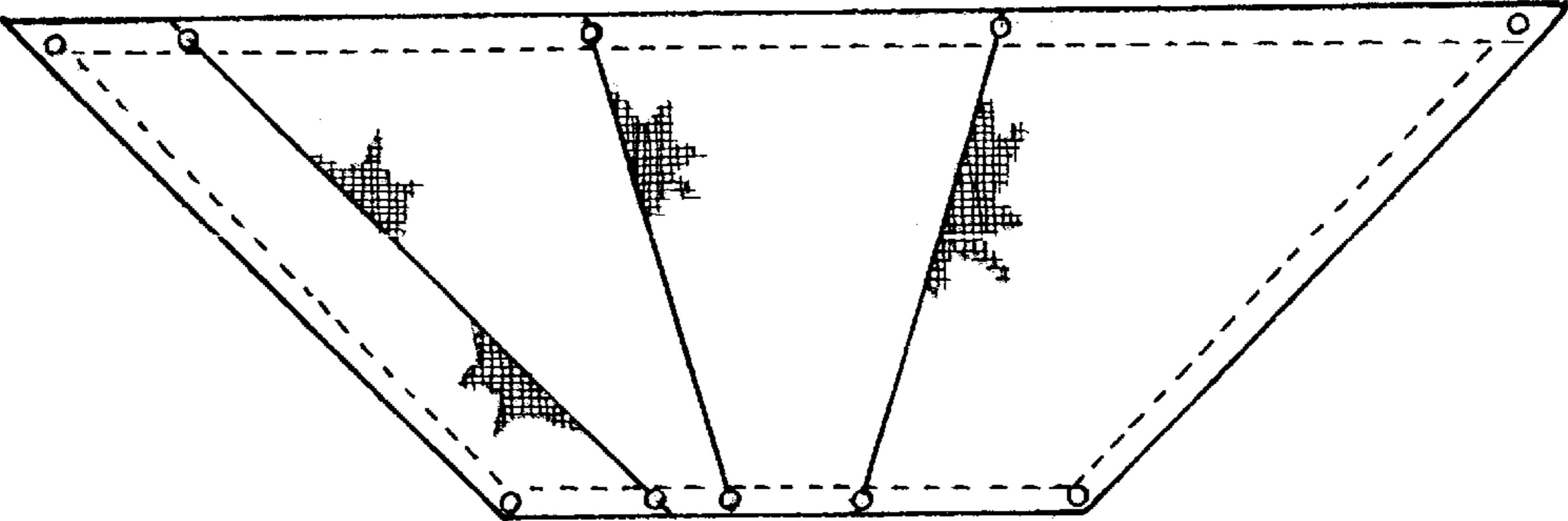

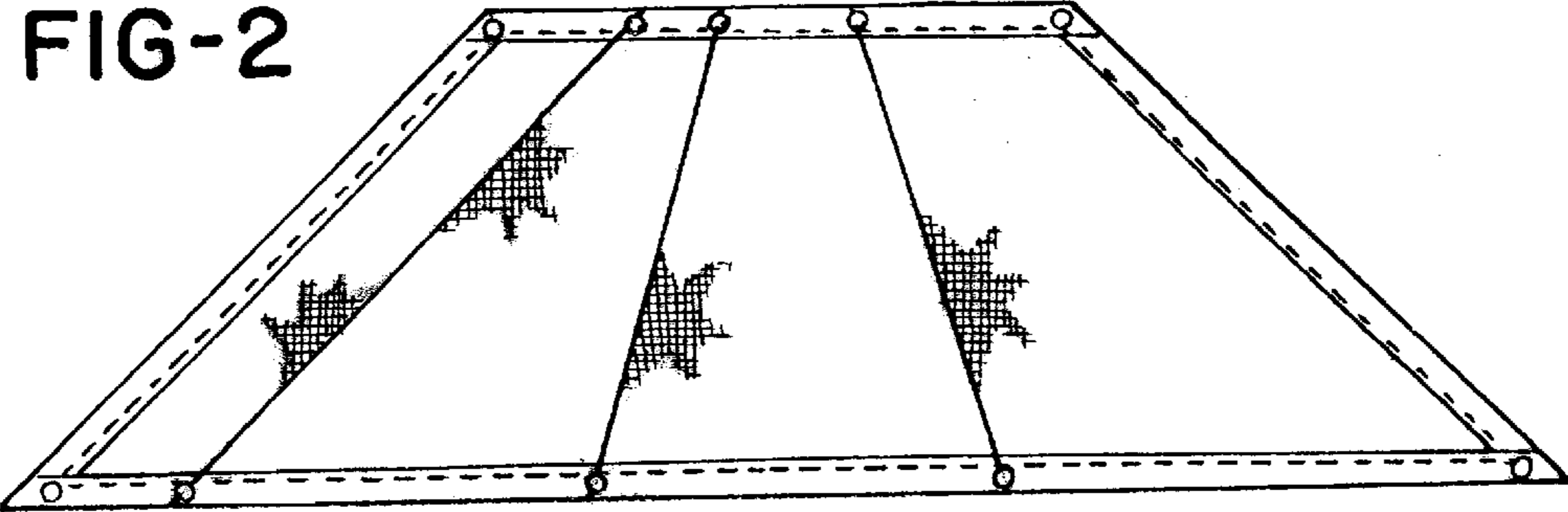

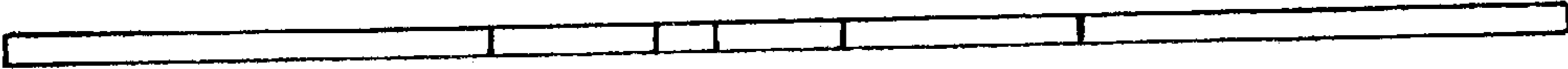

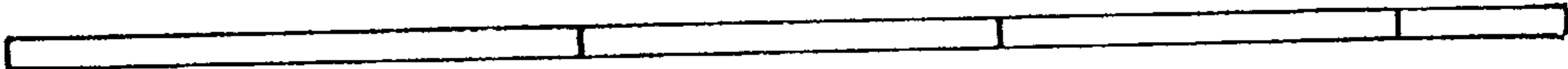

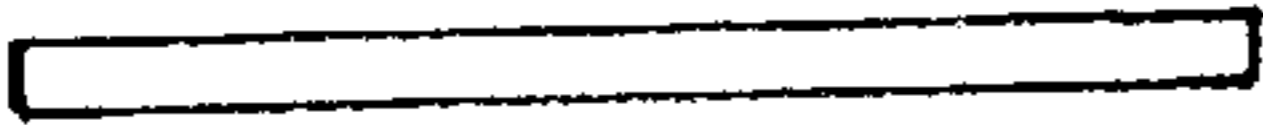

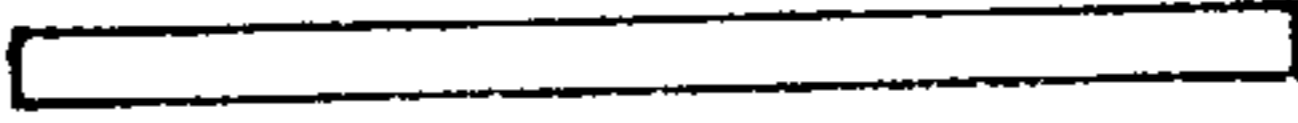

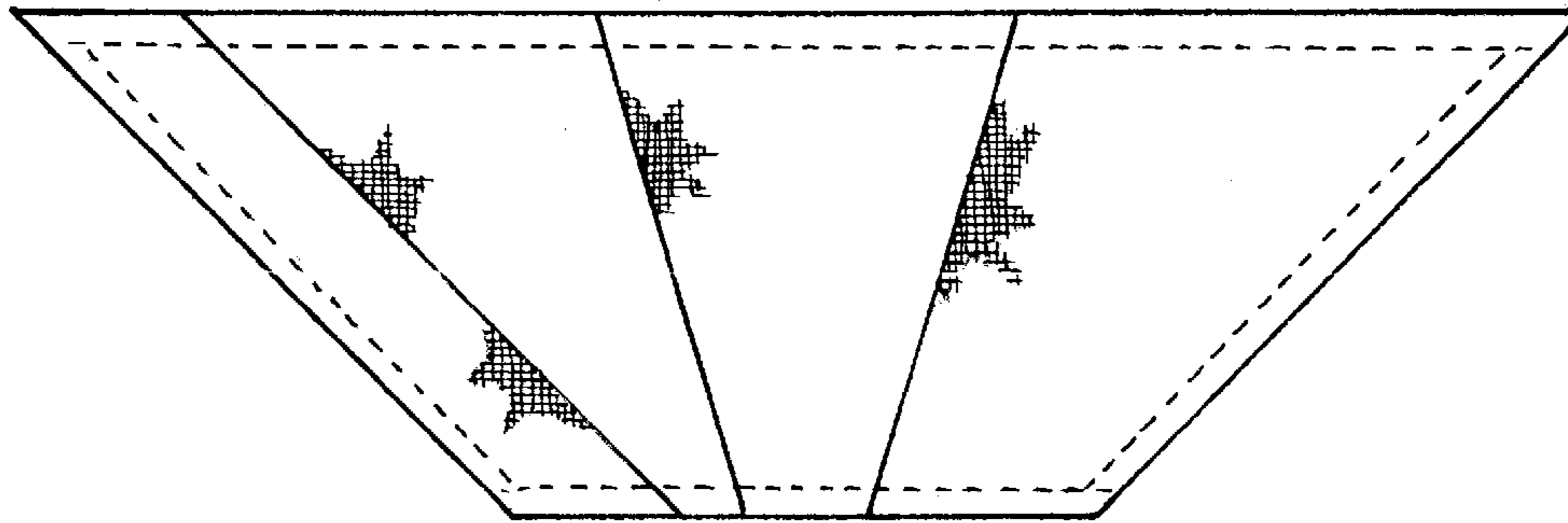

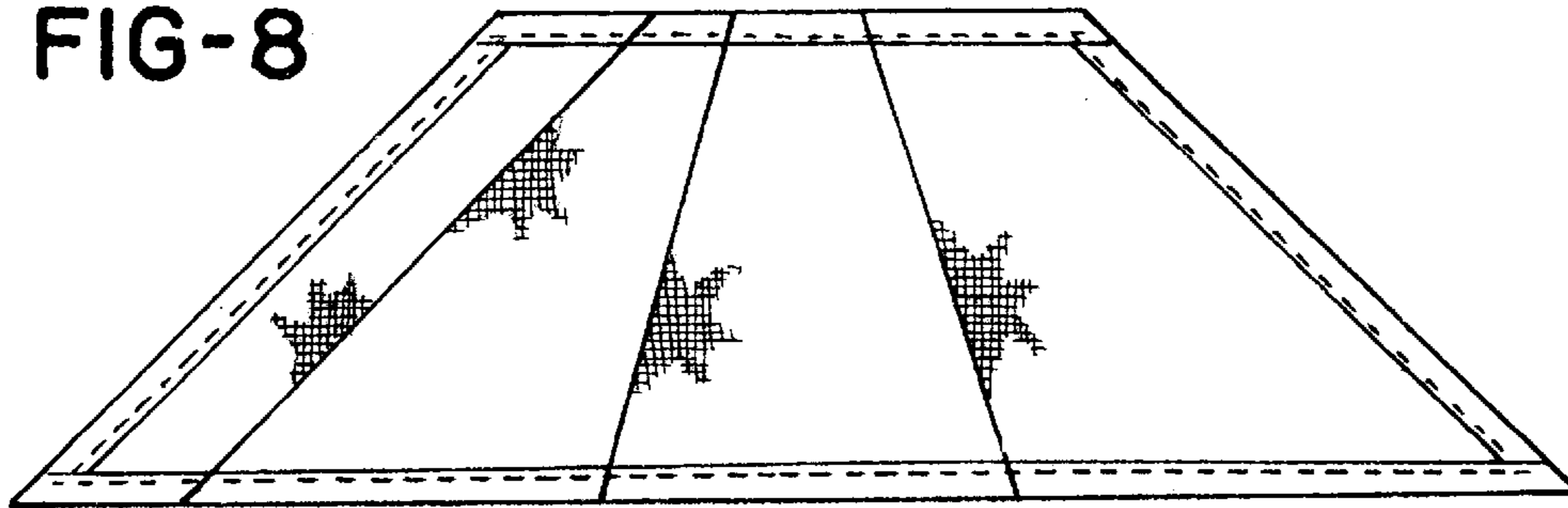

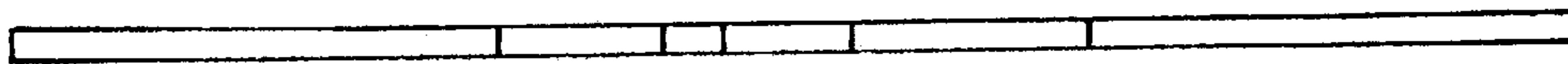

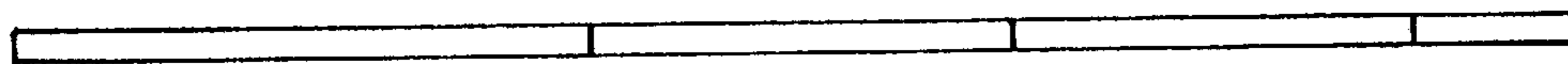

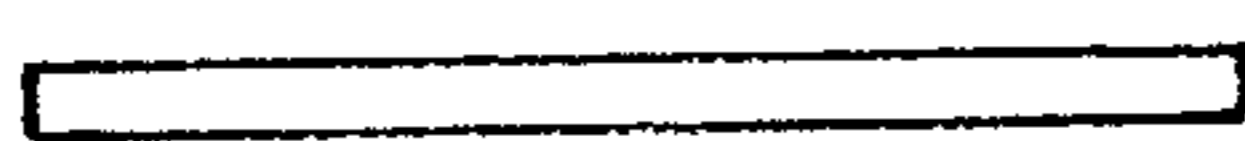

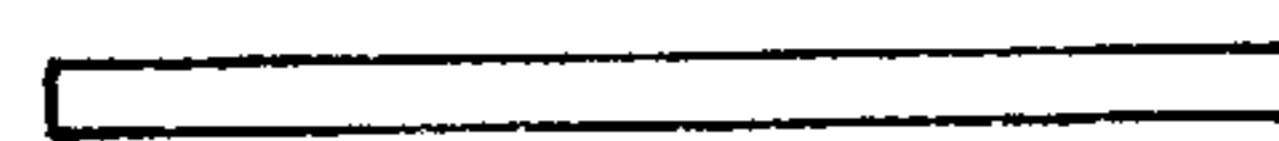

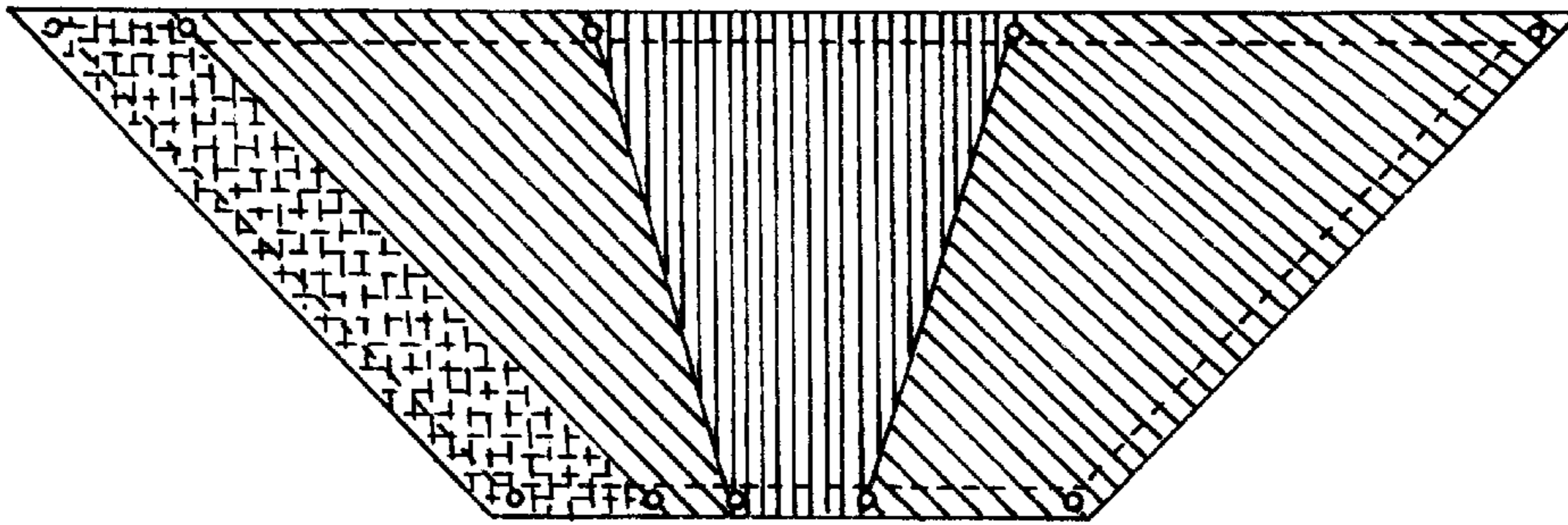

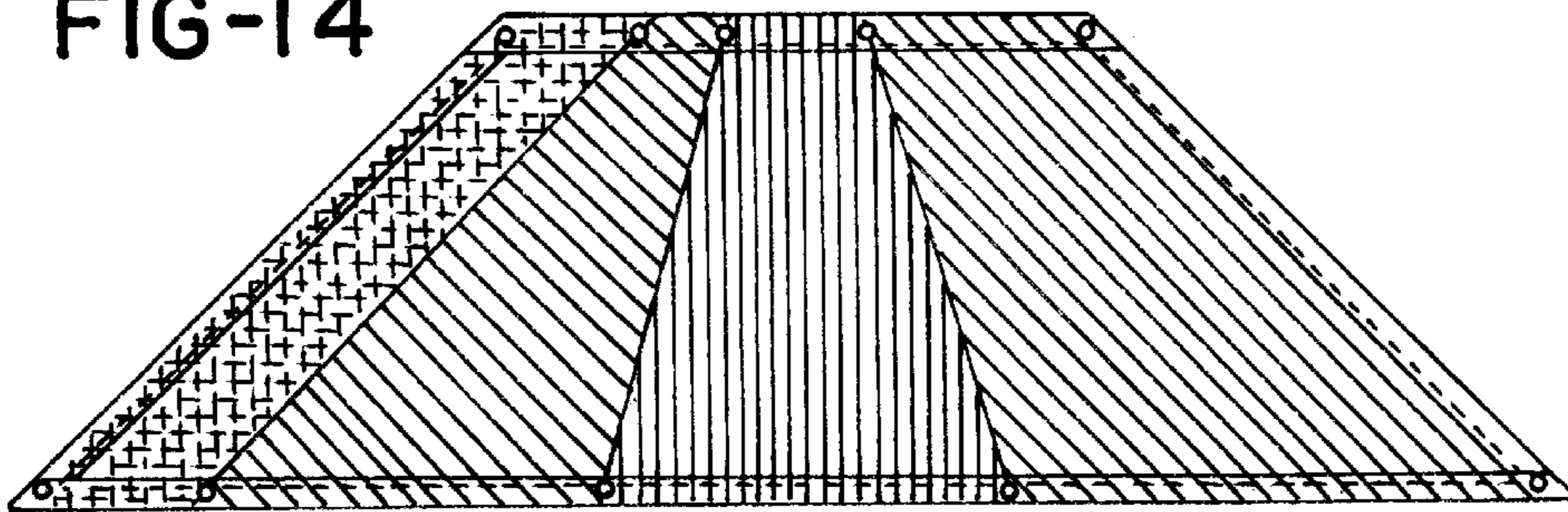

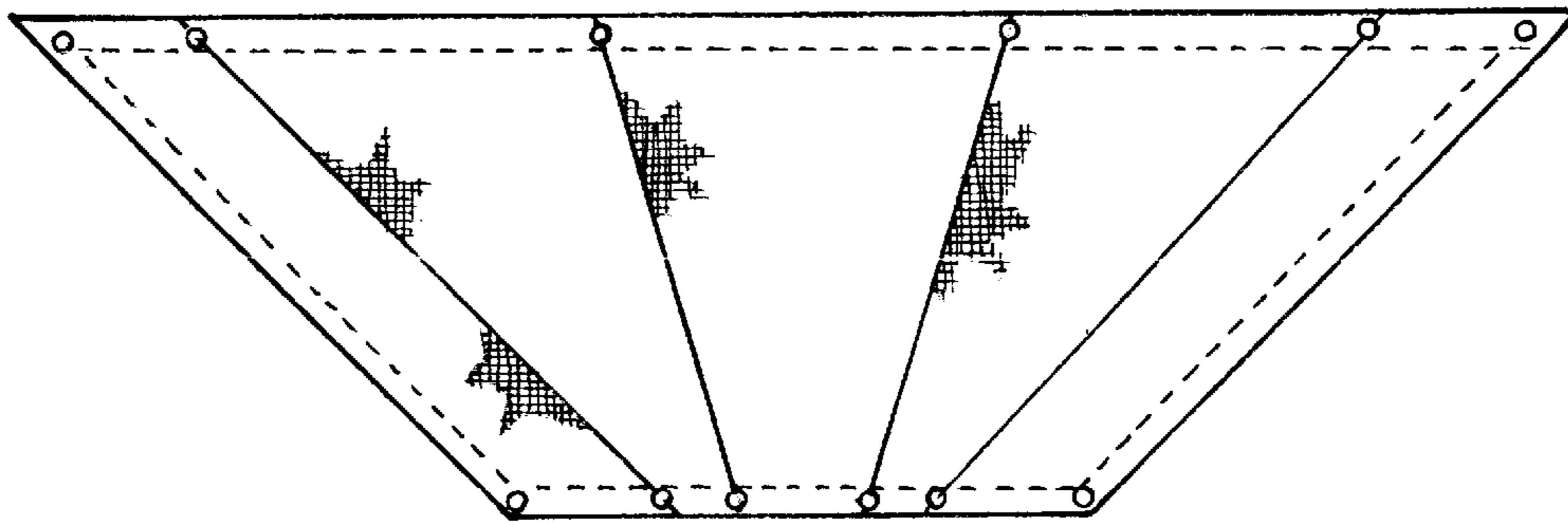

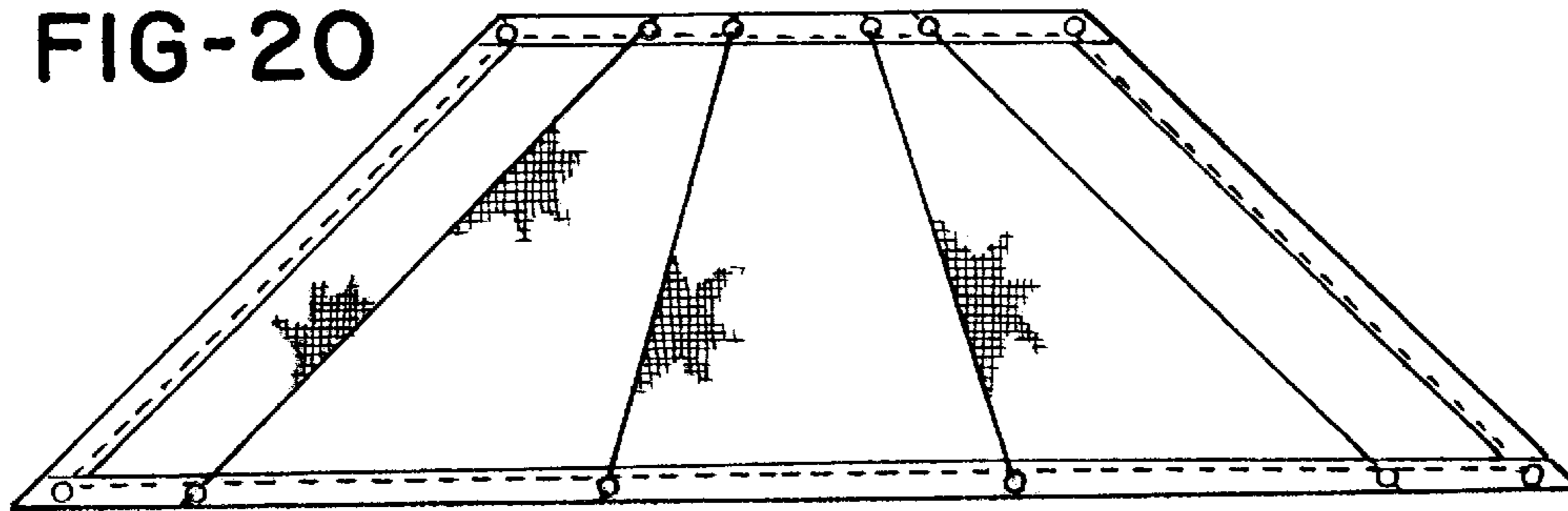

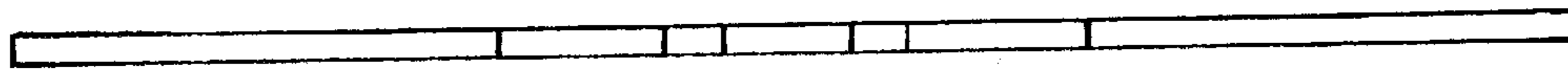

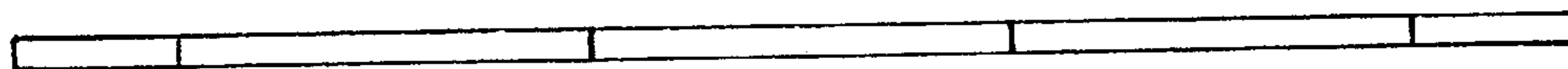

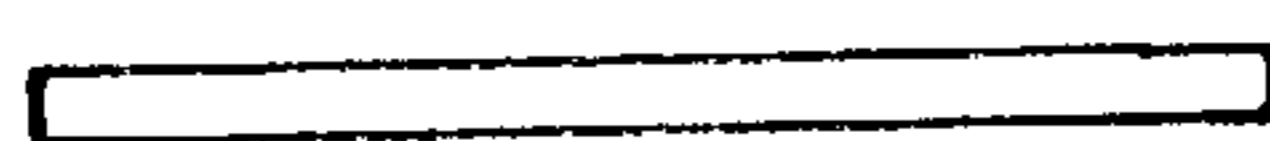
