DESCRIPTION

FIG. 5 is an assembled, rear view of thereof;

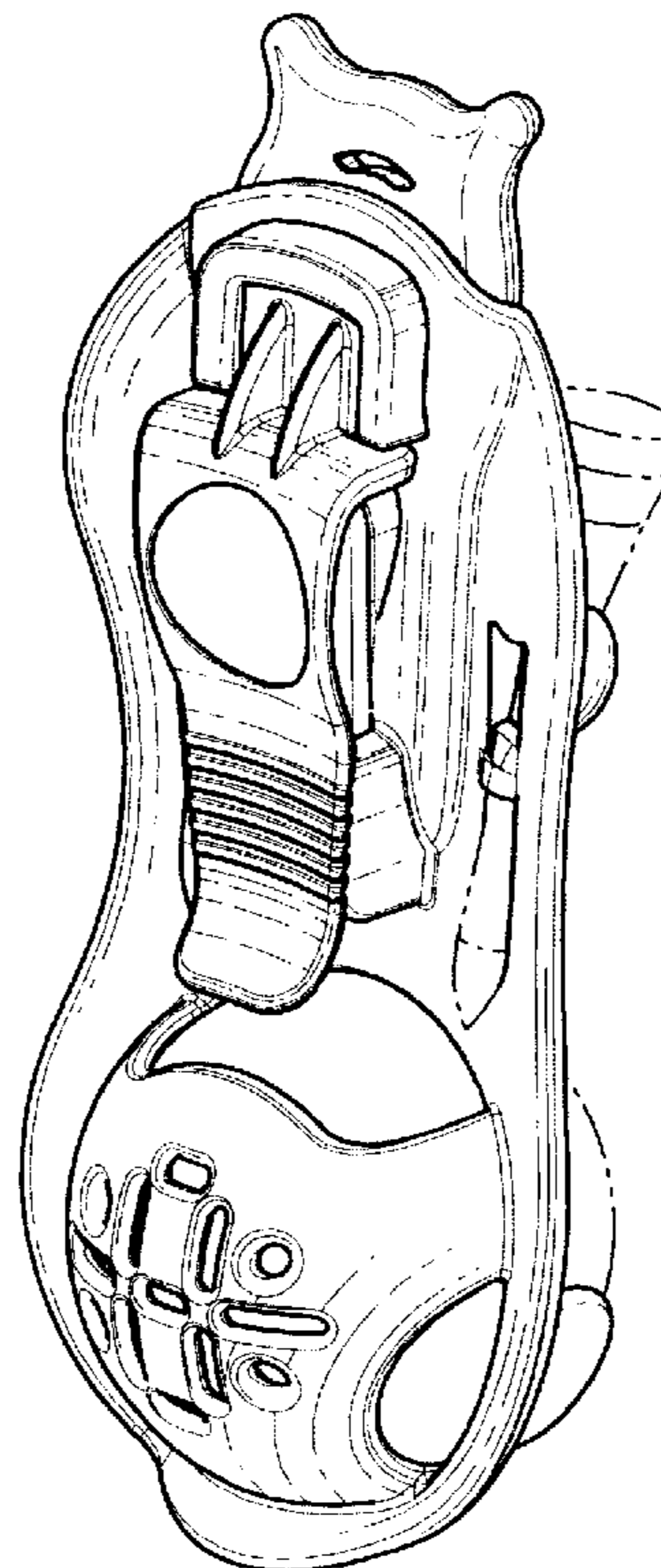
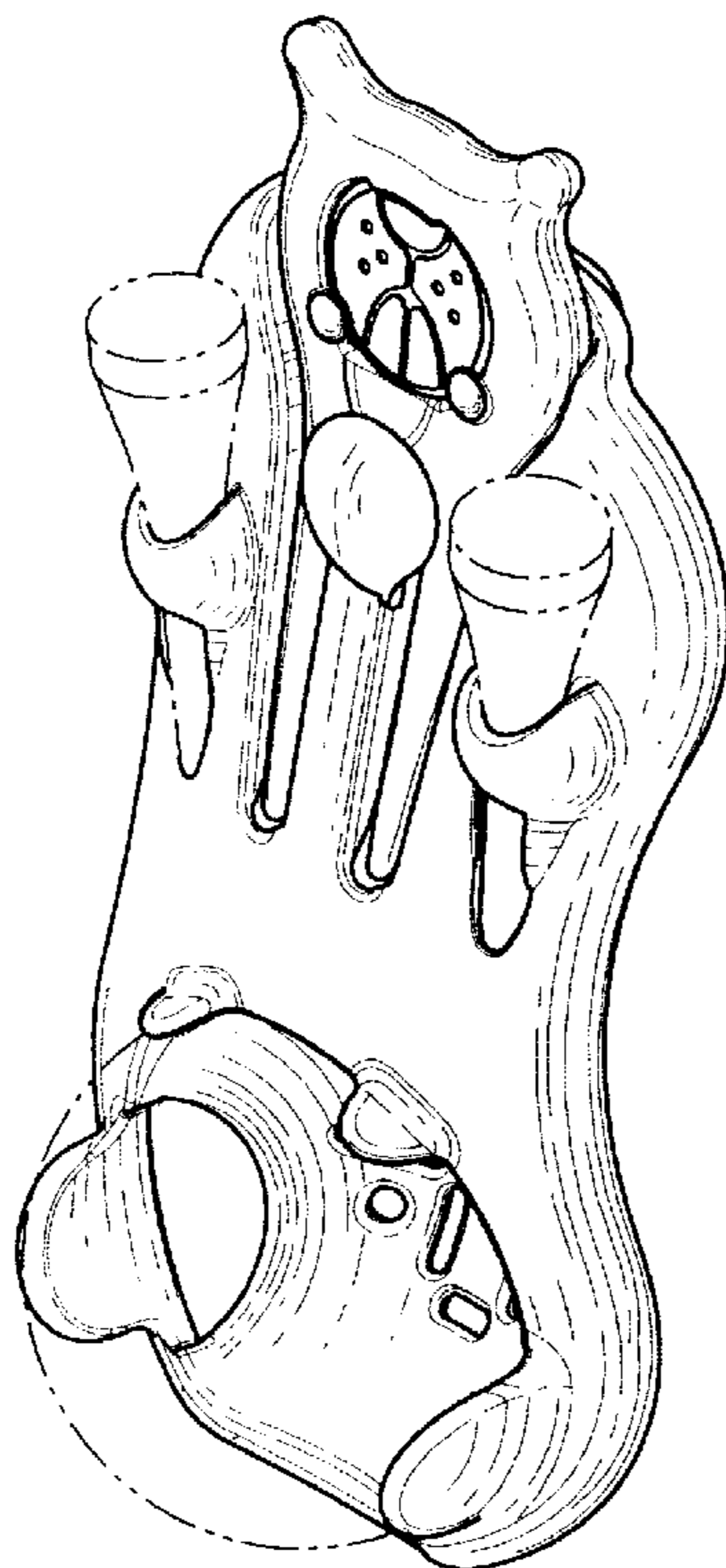
FIG. 6 is an assembled, side view of thereof;

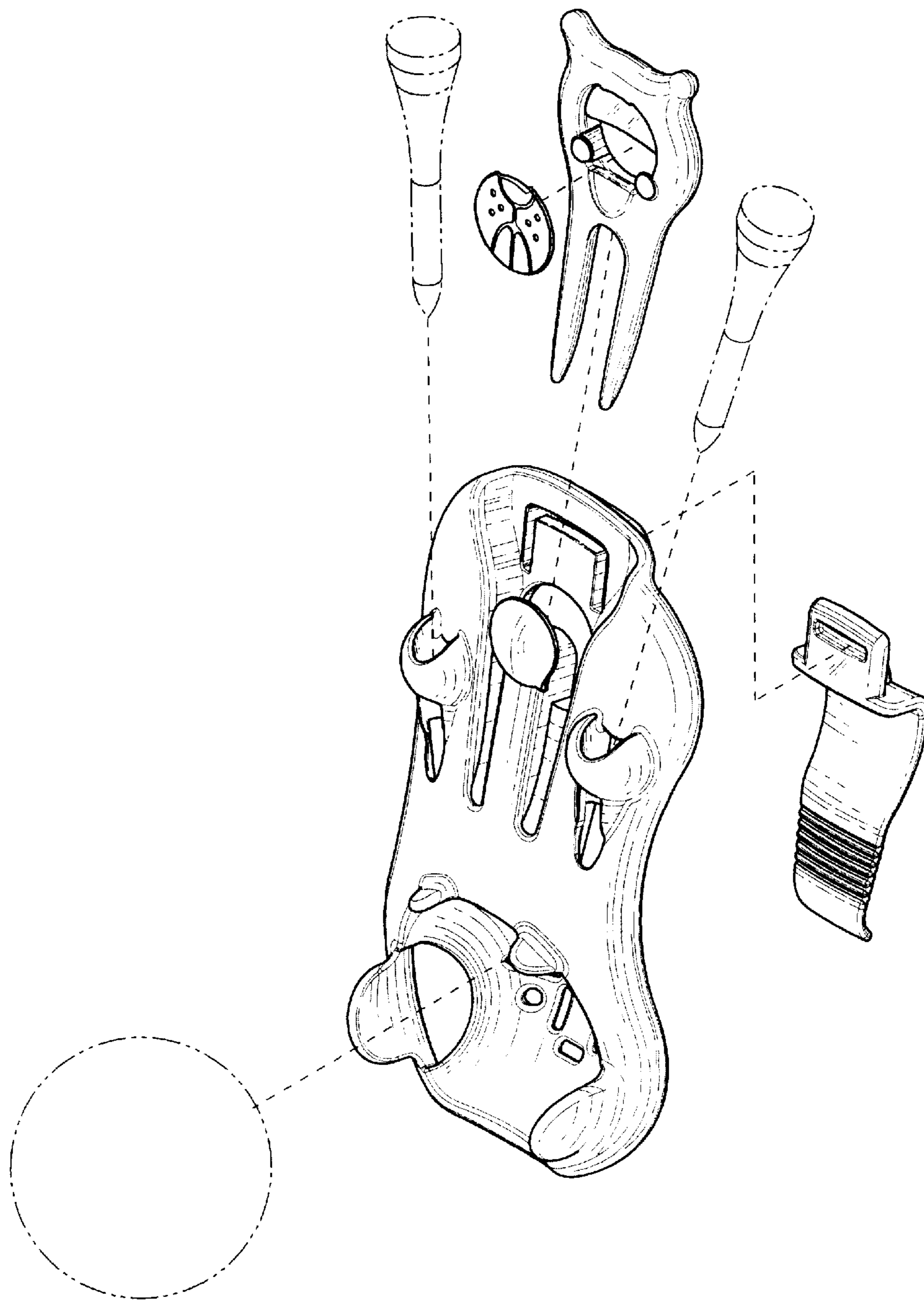

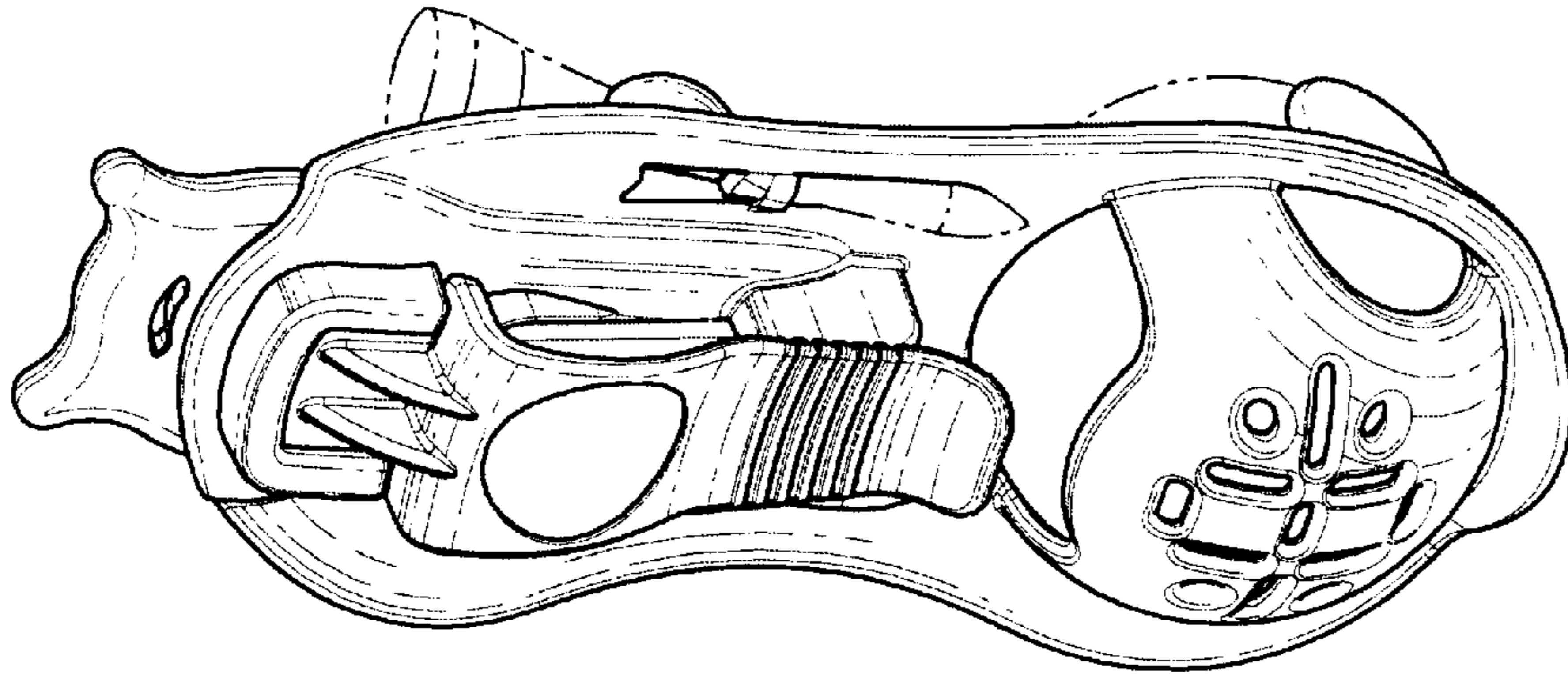

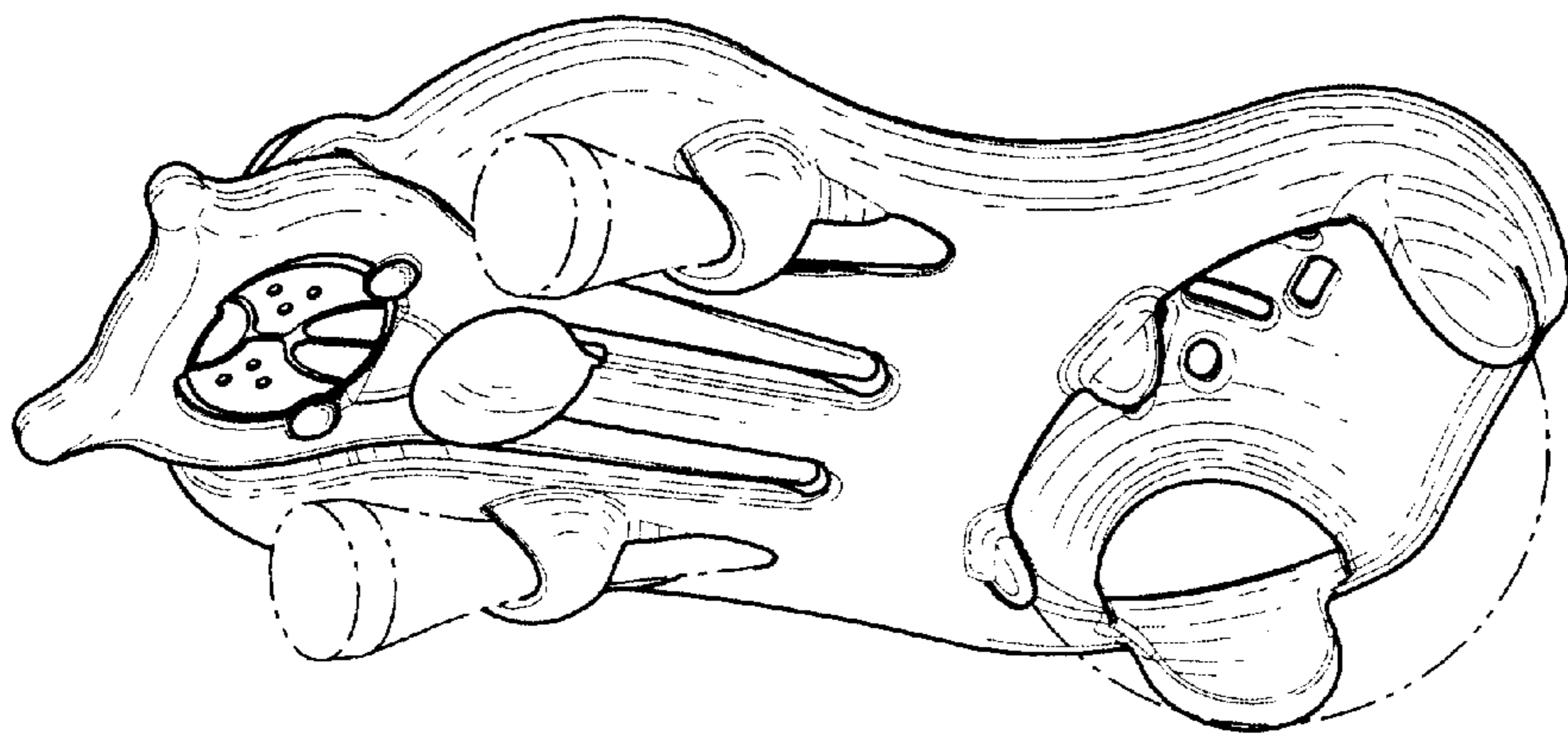

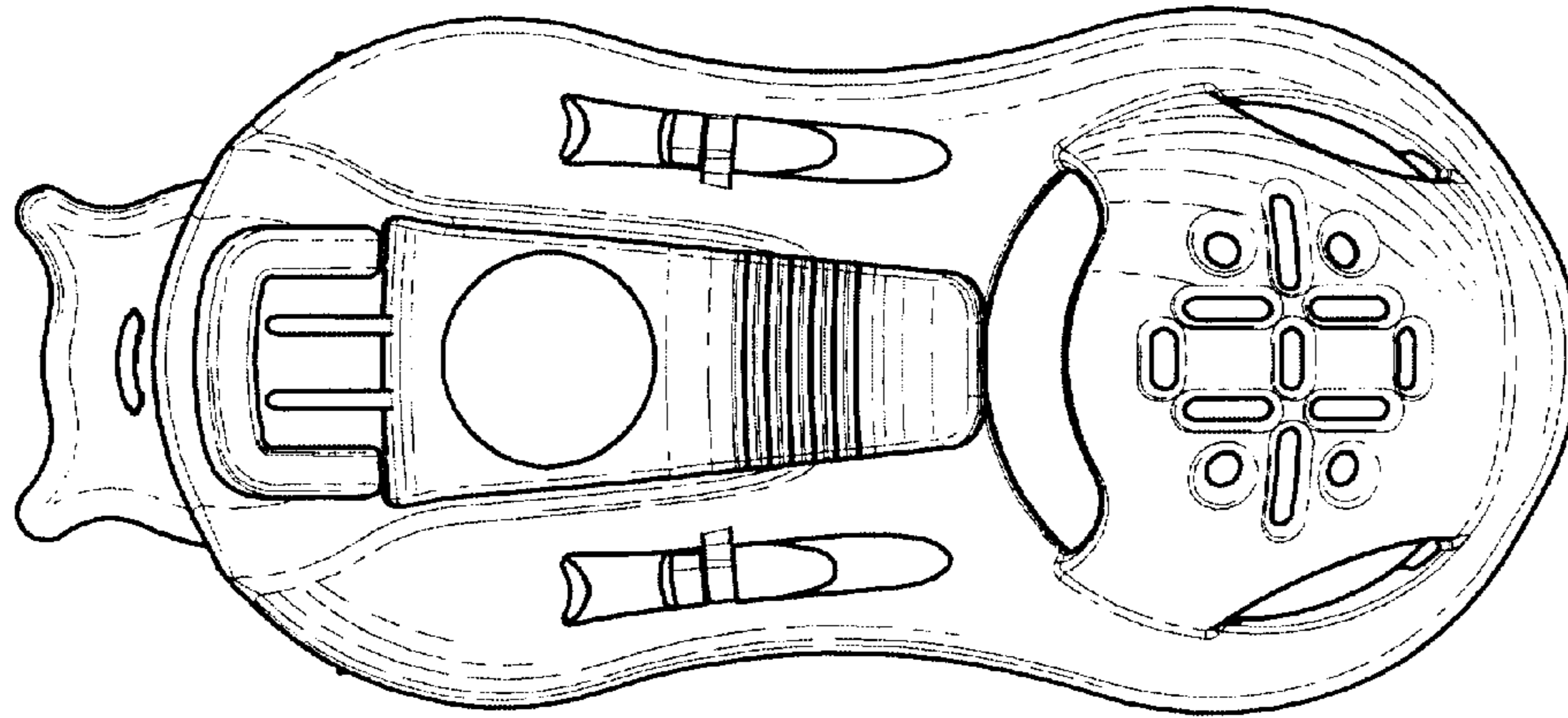

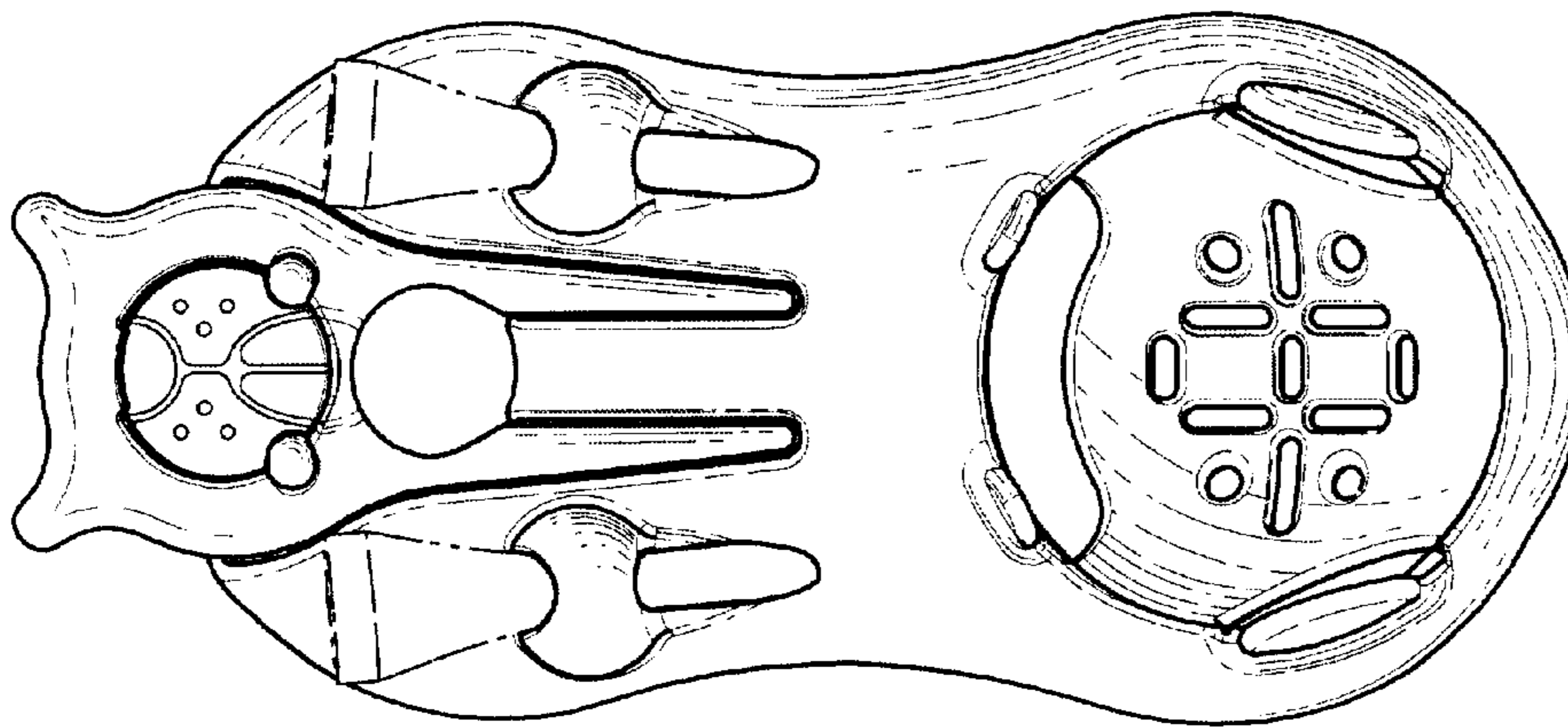

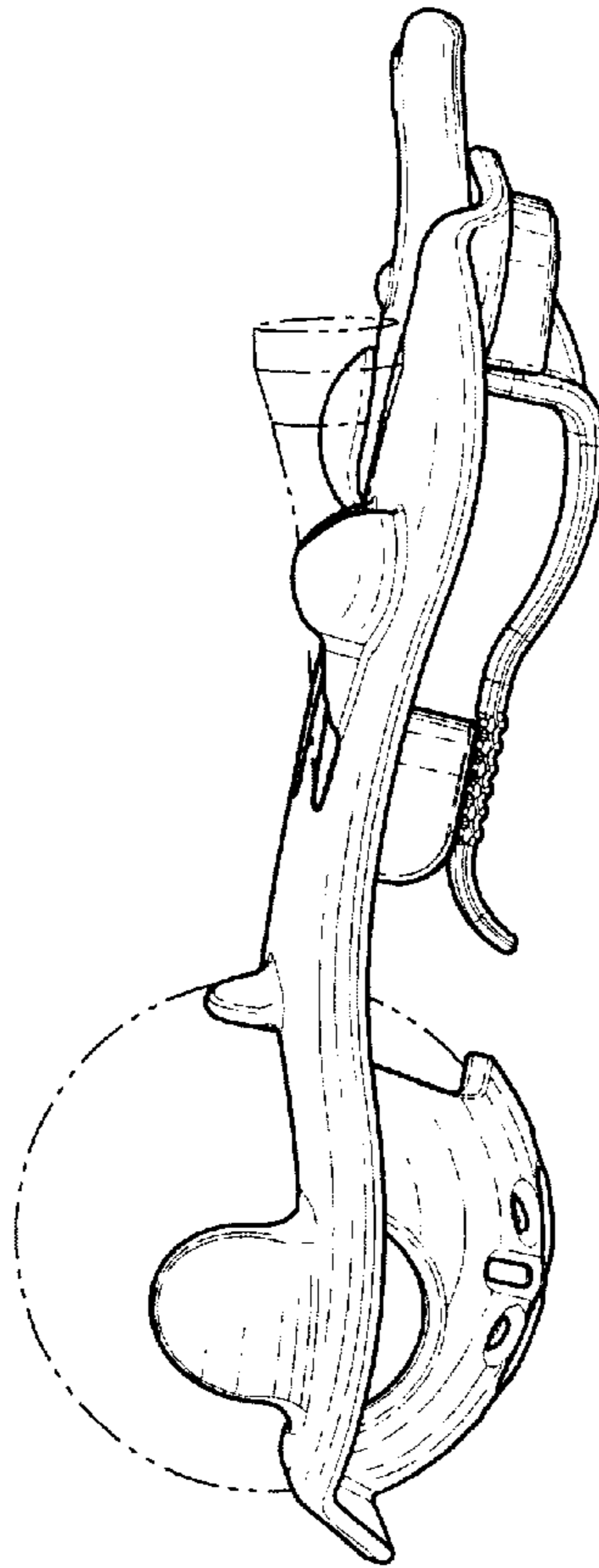

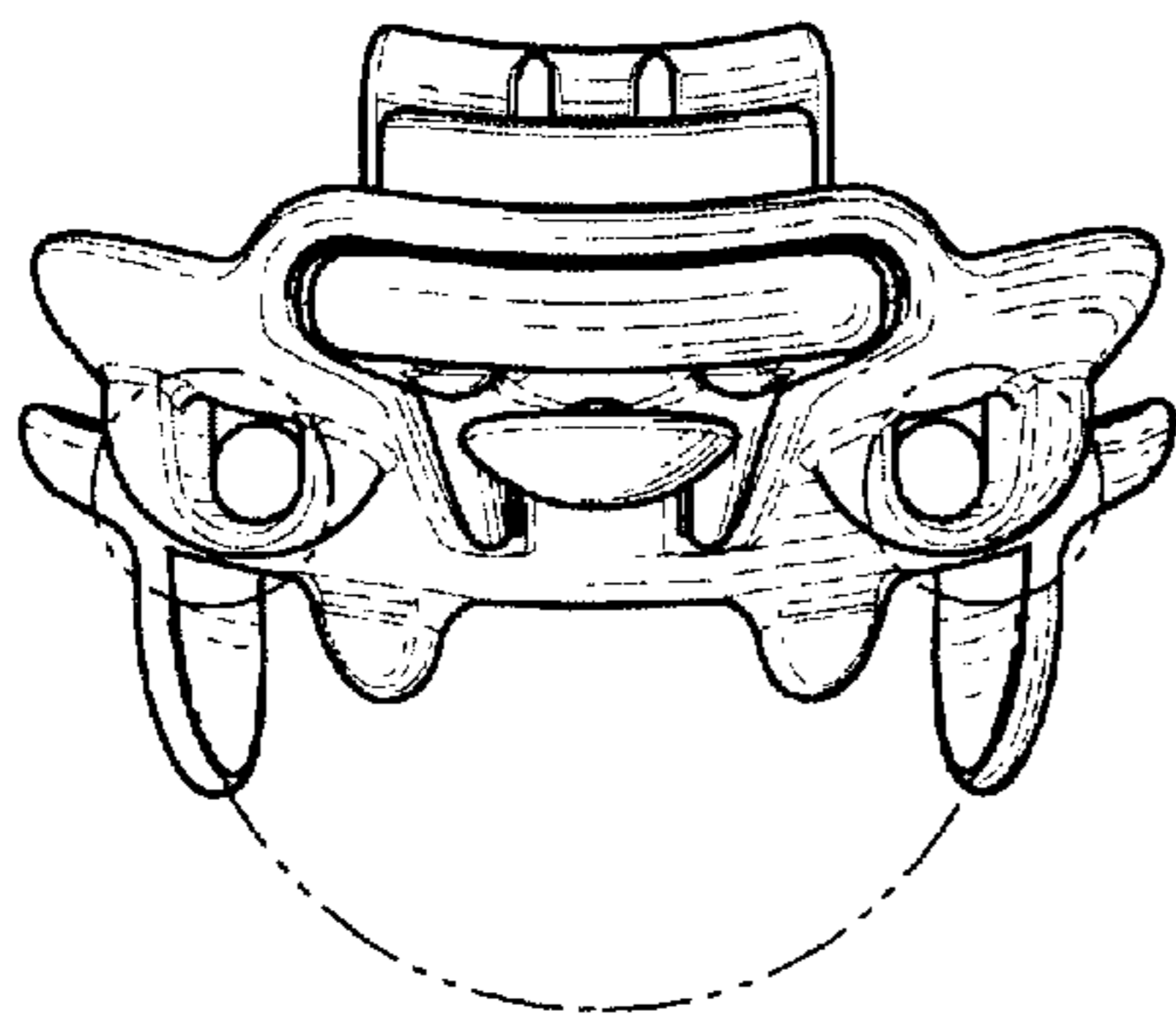

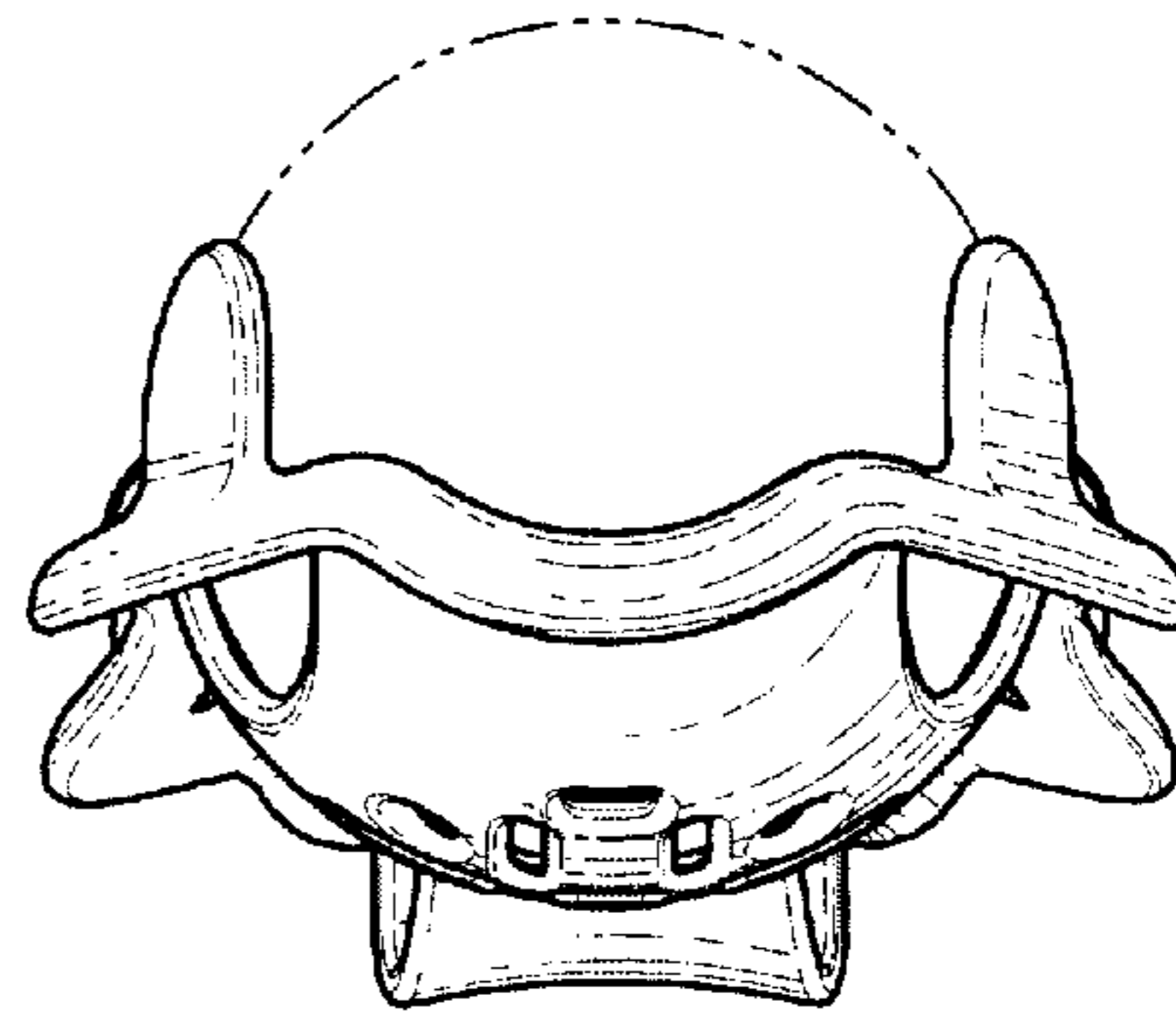
