FIG. 3 is a bottom plan view of the ceiling fan housing in accordance with my design;

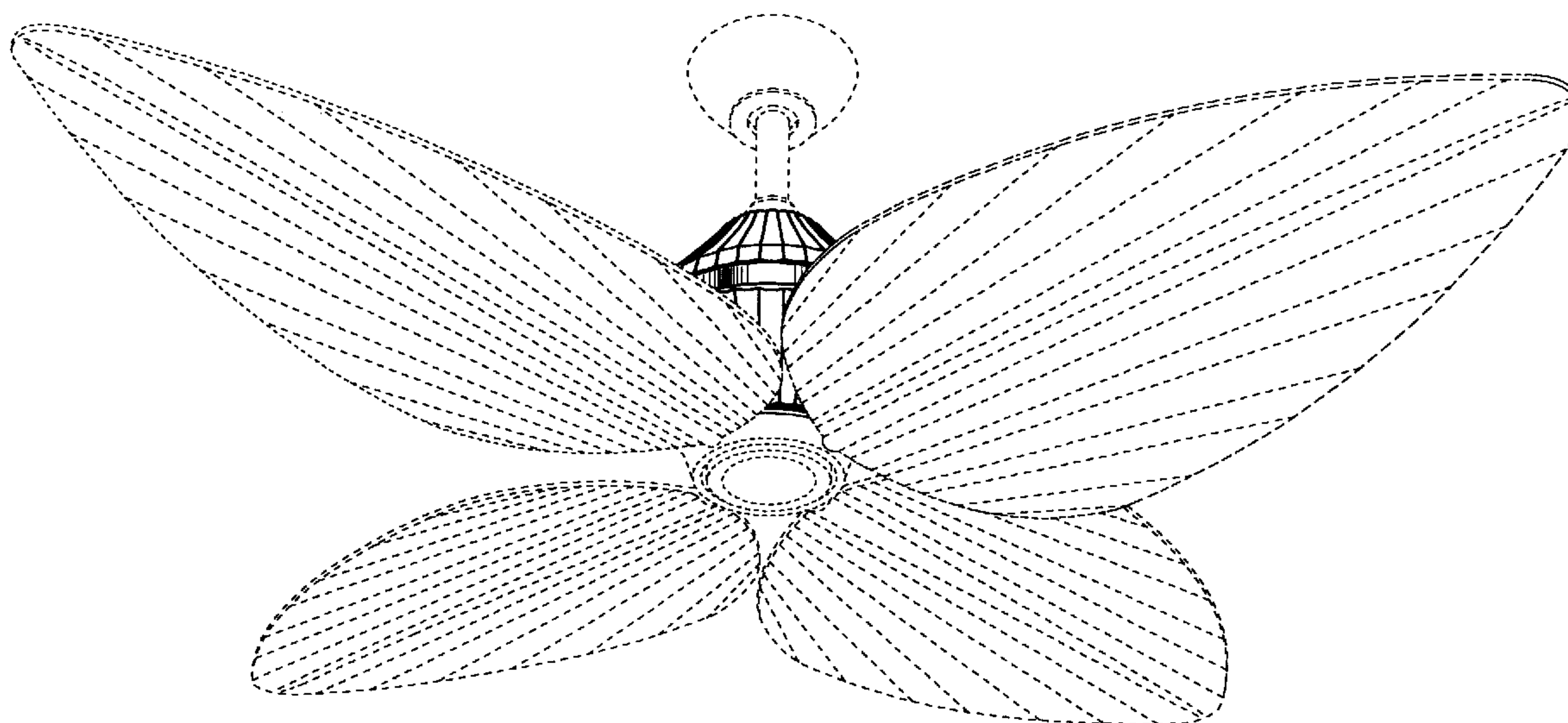
FIG. 4 is a top plan view of the ceiling fan housing in accordance with my design;

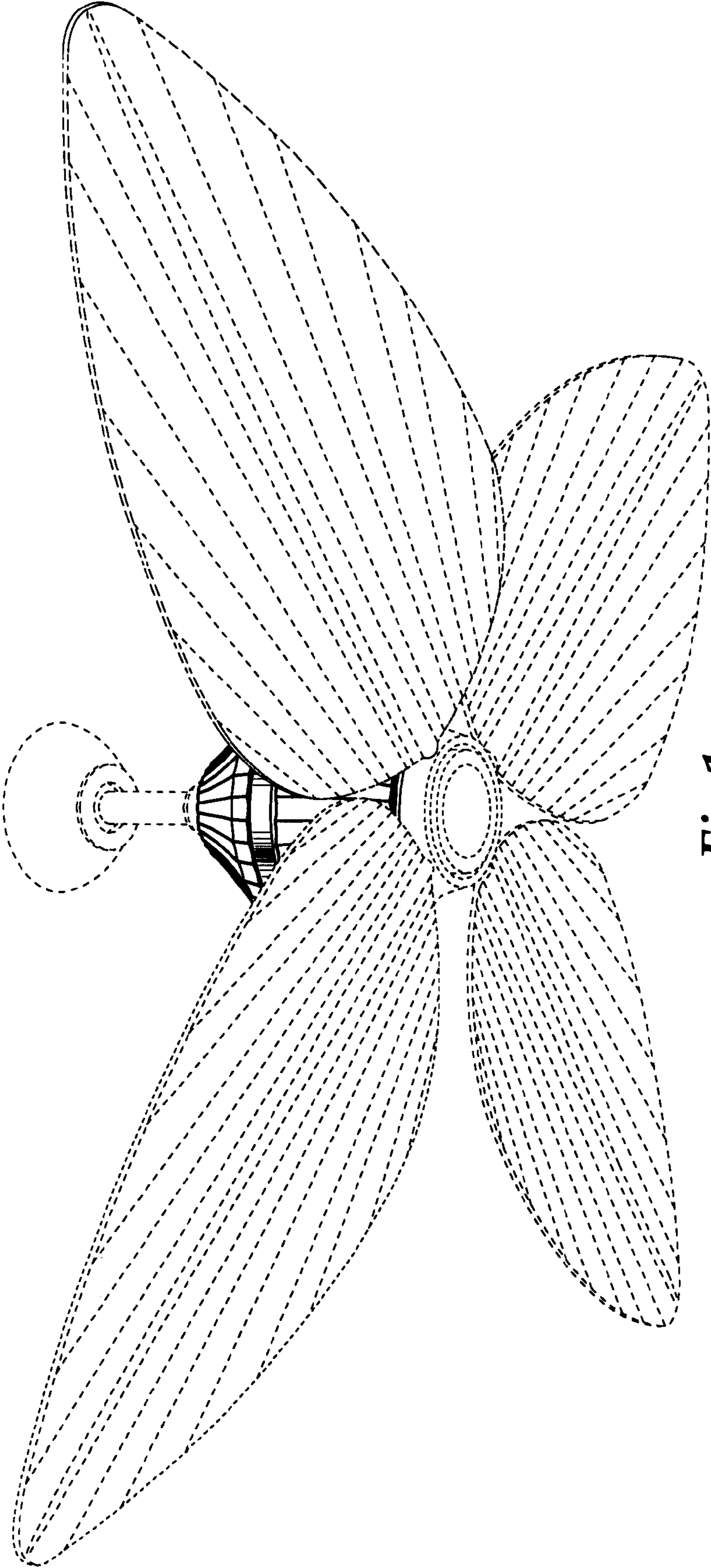
FIG. 5 is a representative side elevation view of the ceiling fan housing in accordance with my design; and,

FIG. 6 is an representative enlarged side elevation view of the ceiling fan housing in accordance with my design.

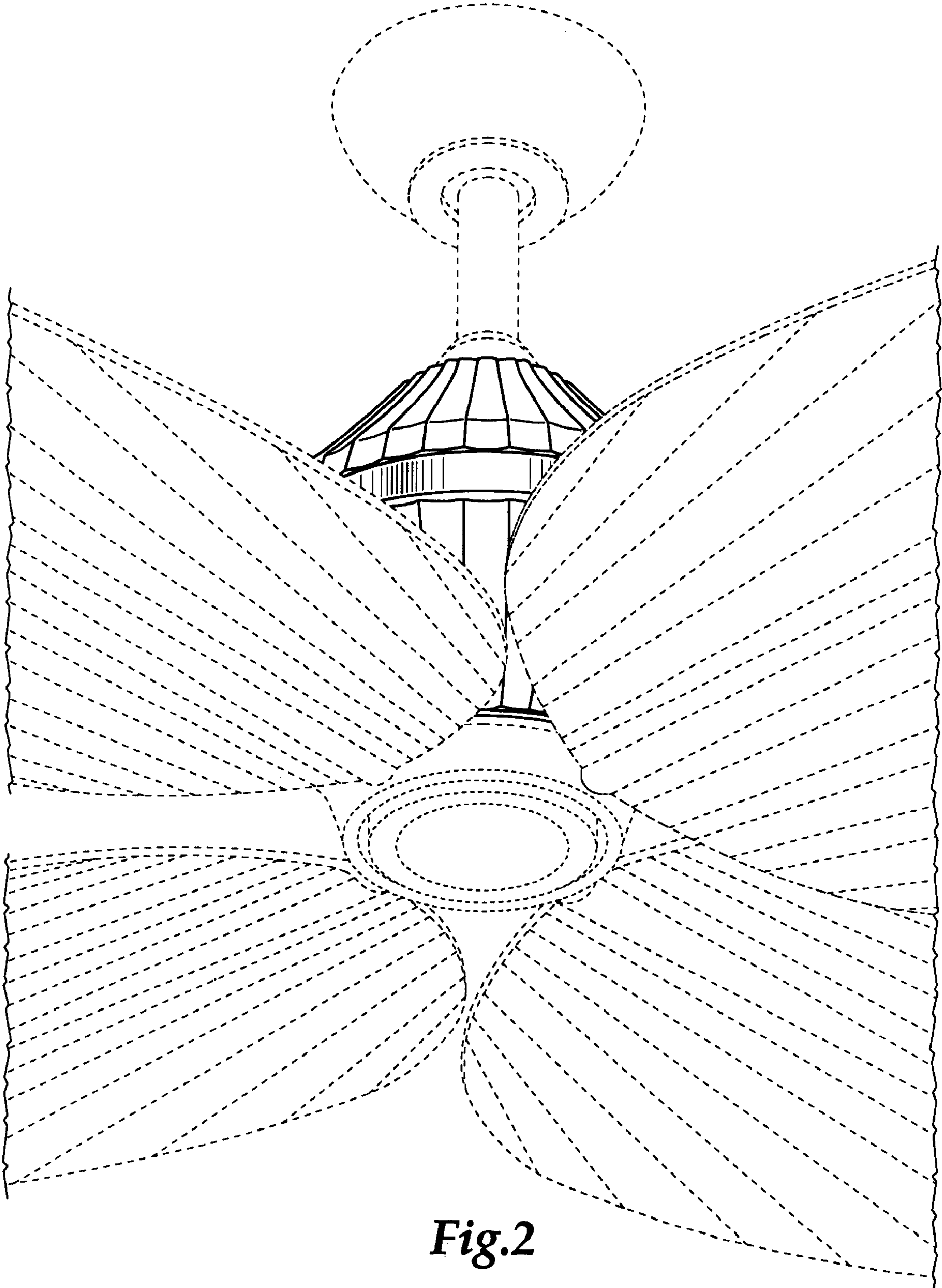
The broken lines showing environmental structure are for illustrative purposes and form no part of the claimed design.

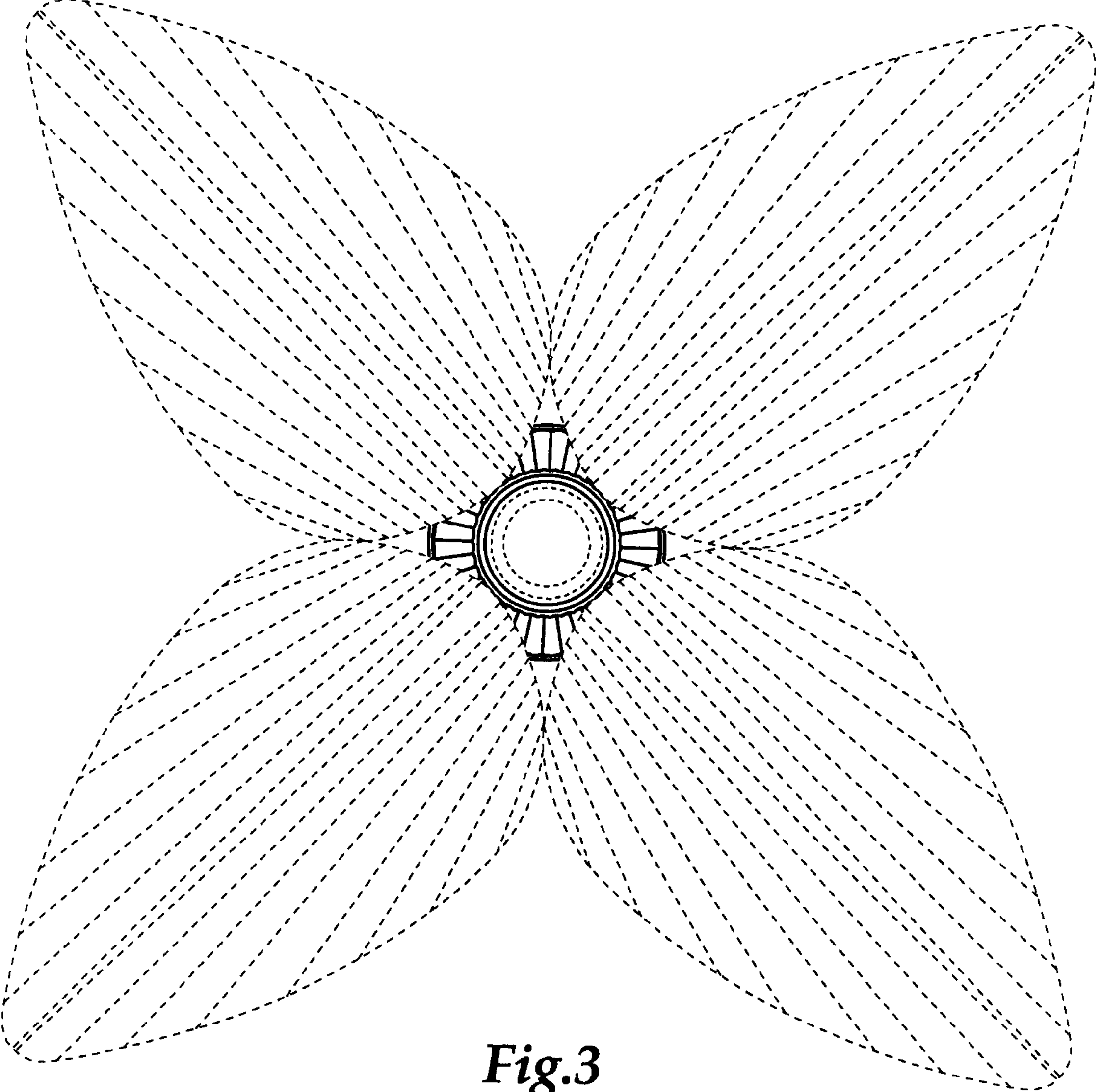

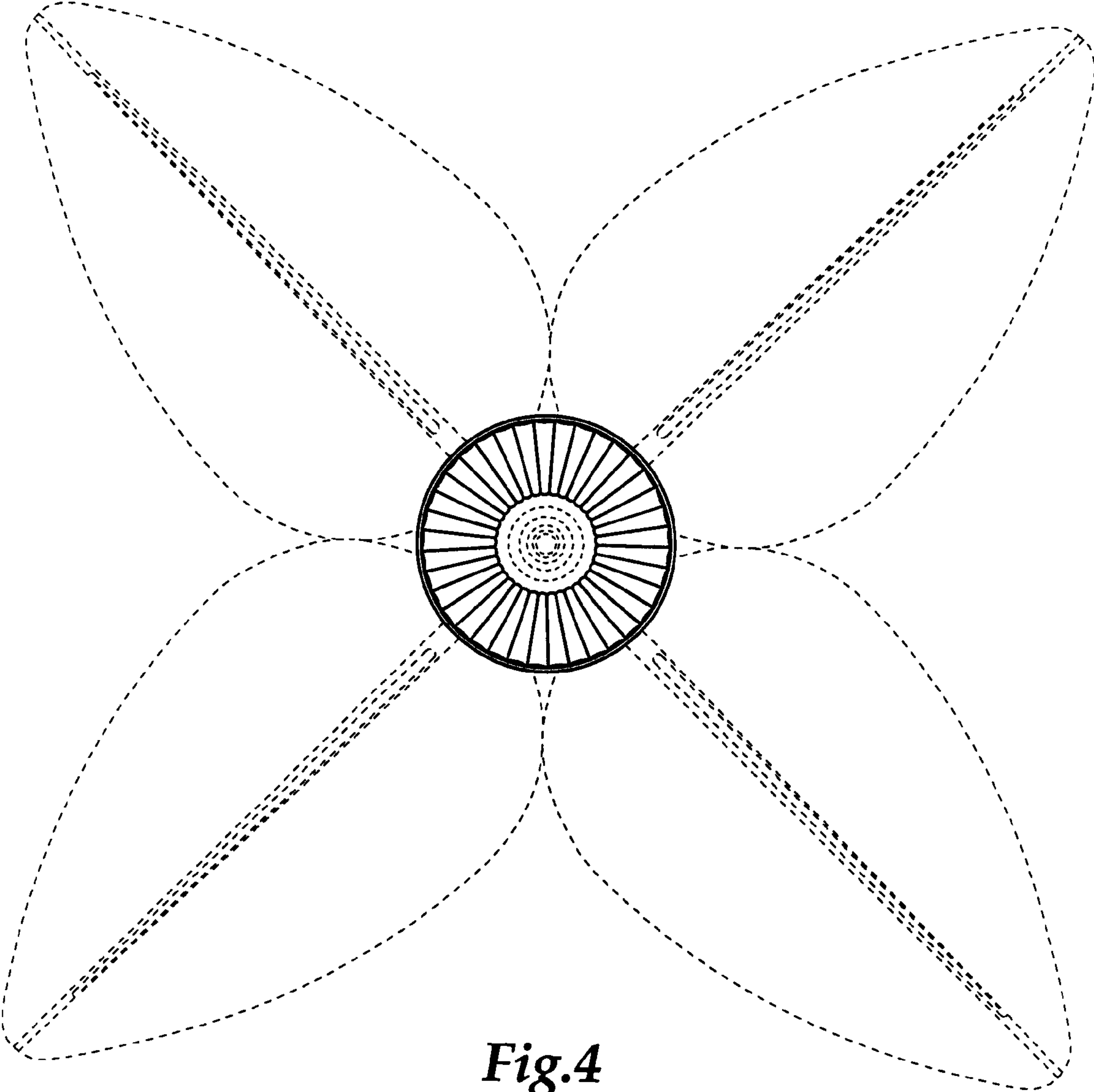

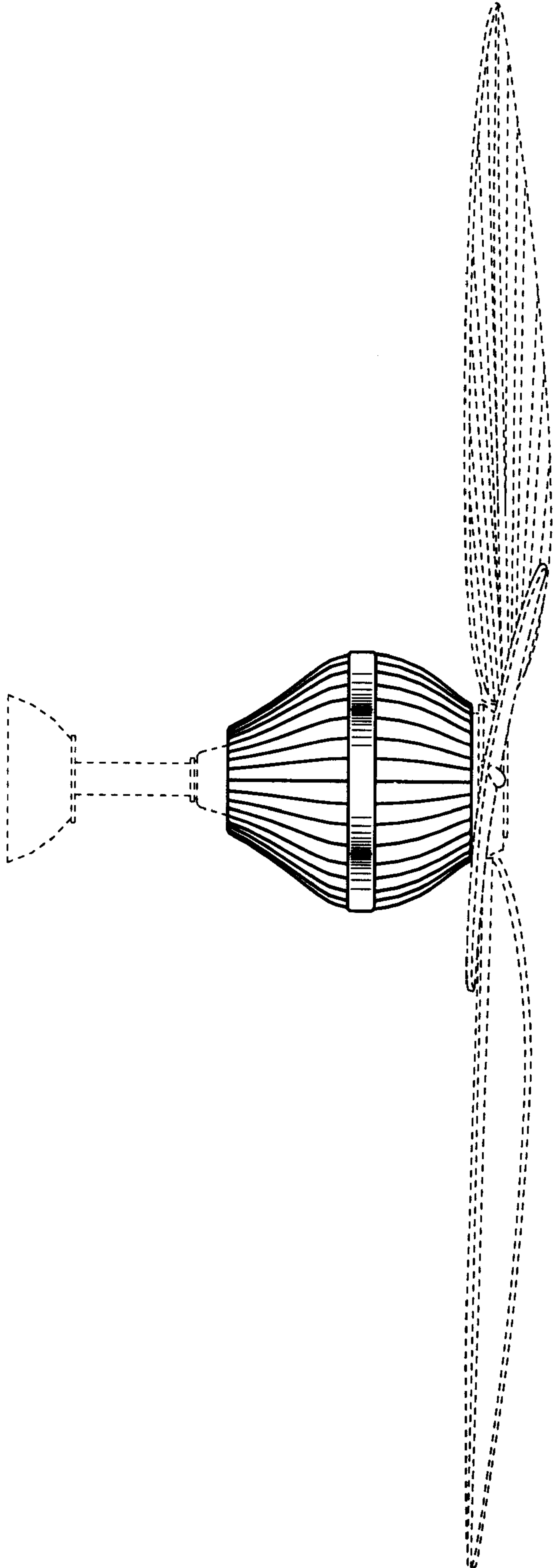
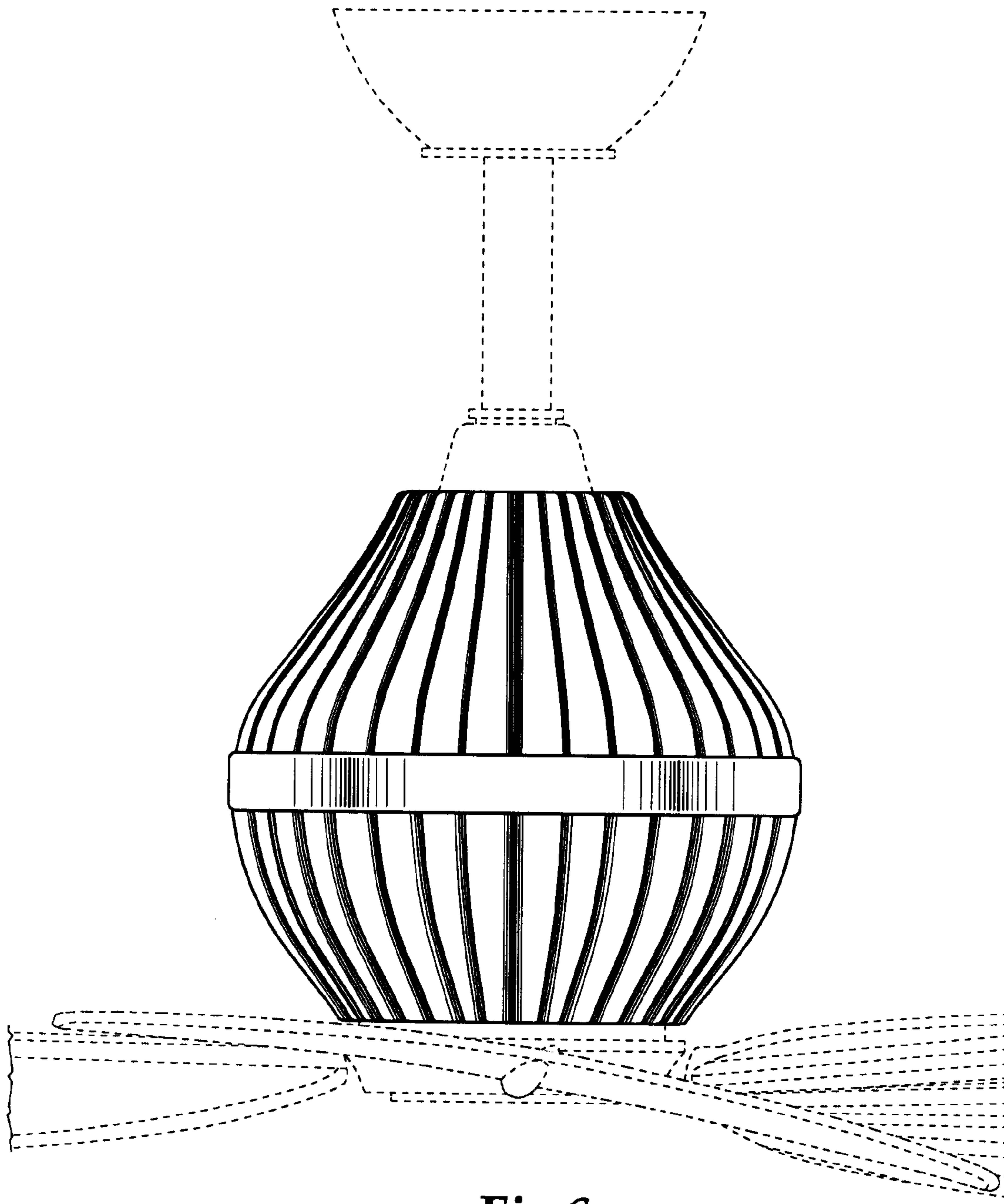
