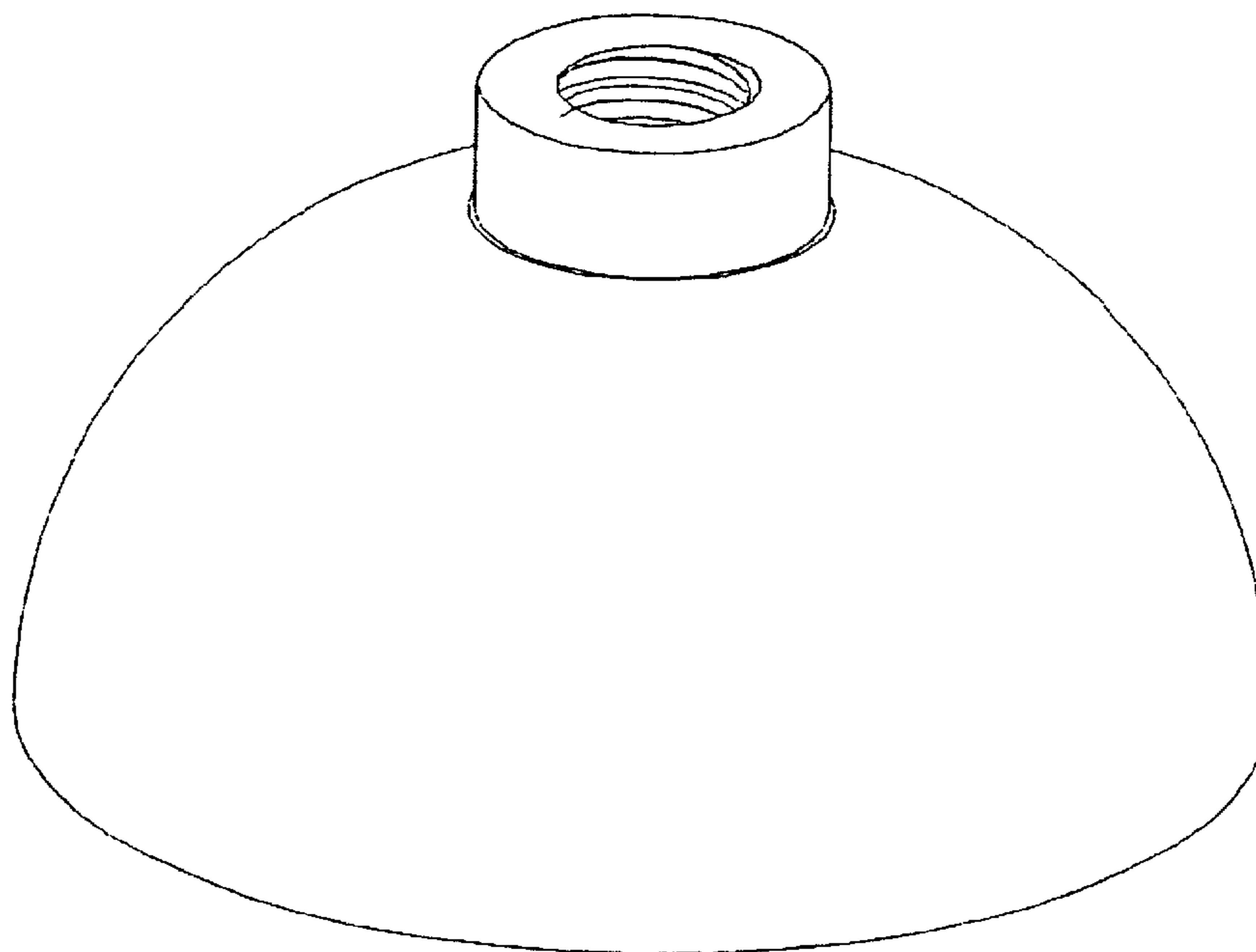
(57) **CLAIM**

The ornamental design for a plunger bell, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a plunger bell of the present invention;
FIG. 2 is a top view of the plunger bell of FIG. 1;
FIG. 3 is a side view of the plunger bell of FIG. 1 with all views being identical through 360° of rotation;
FIG. 4 is a bottom of the plunger bell of FIG. 1; and,
FIG. 5 is a bottom perspective view of the plunger bell of FIG. 1.

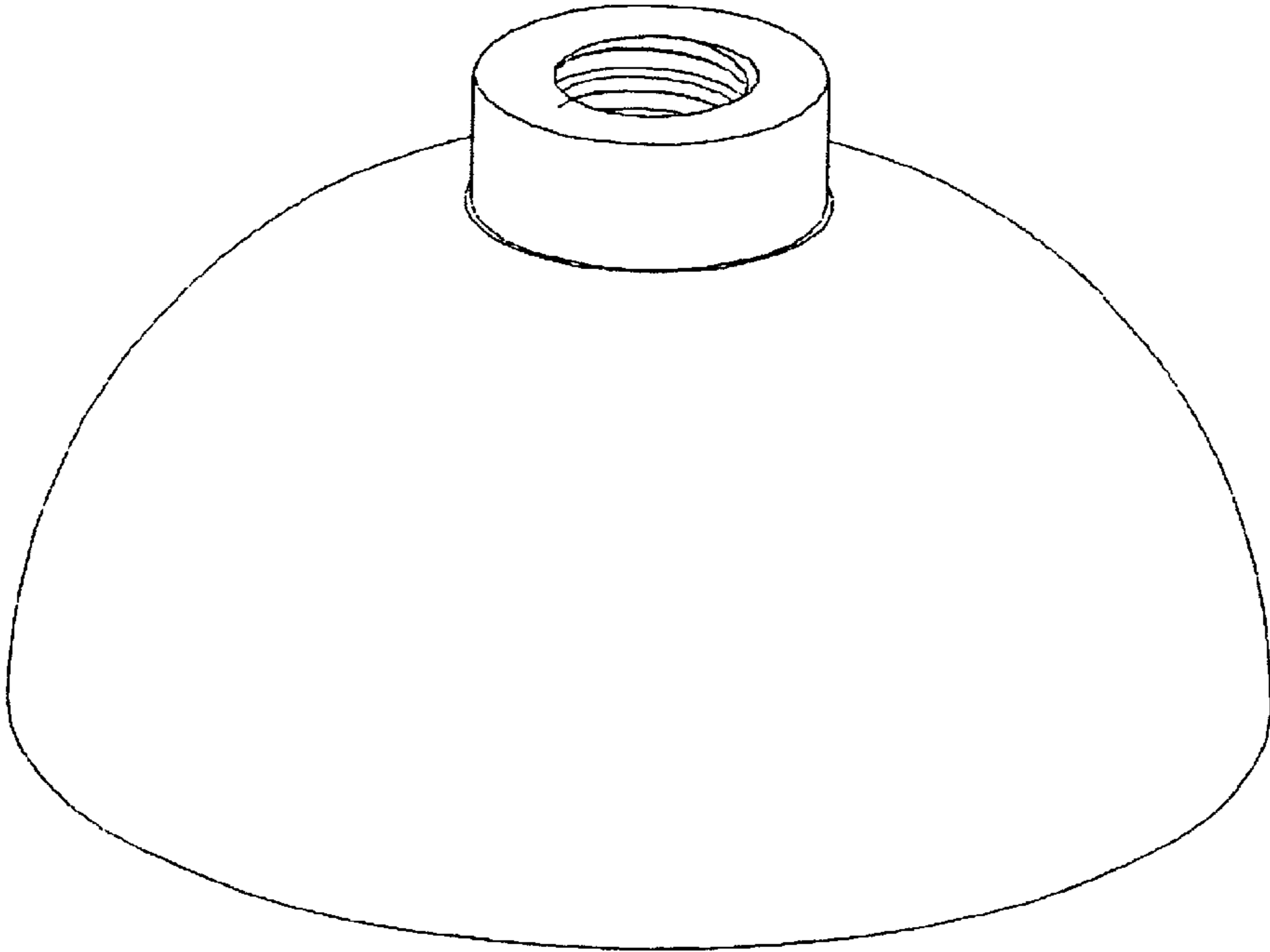

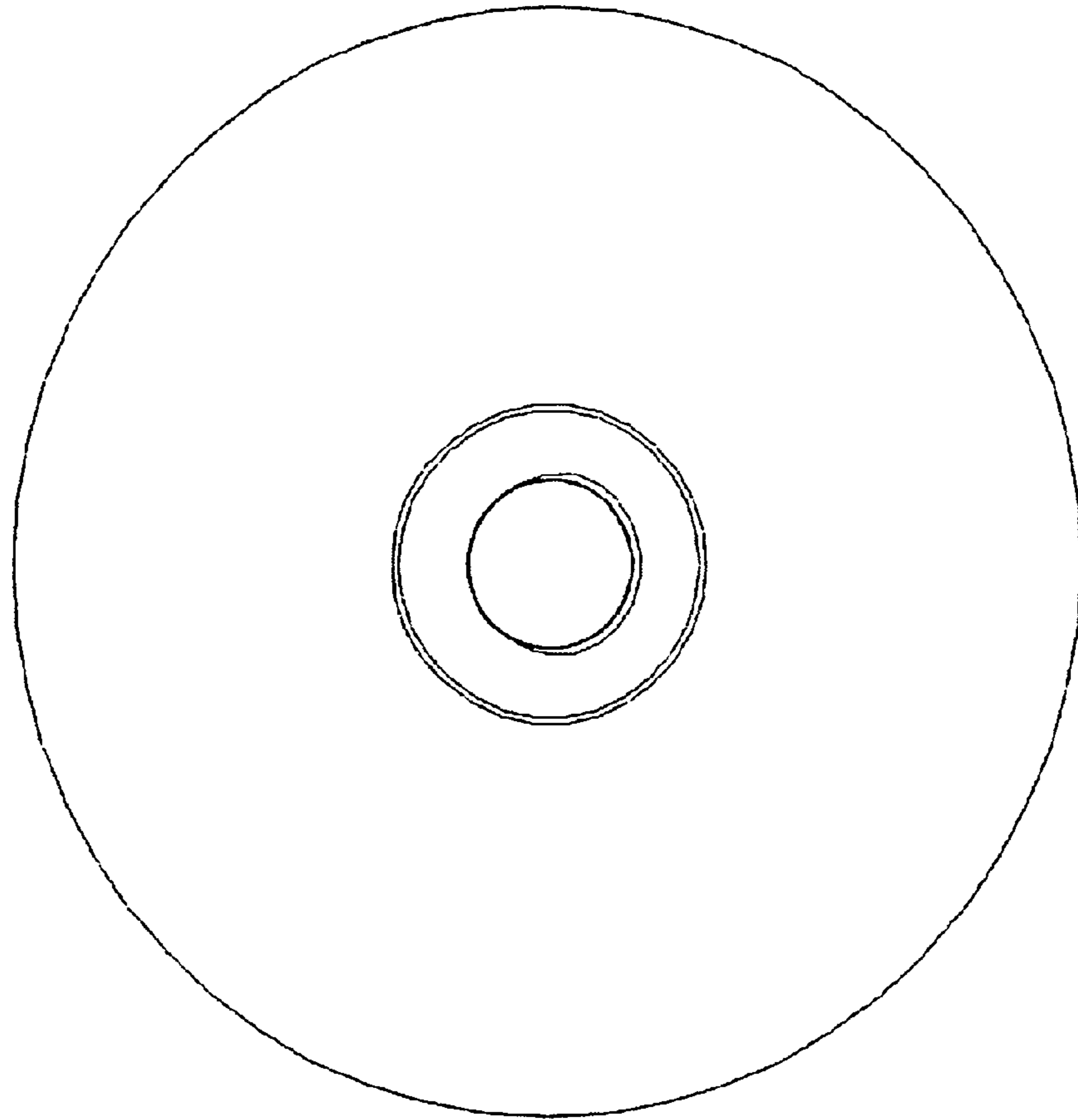

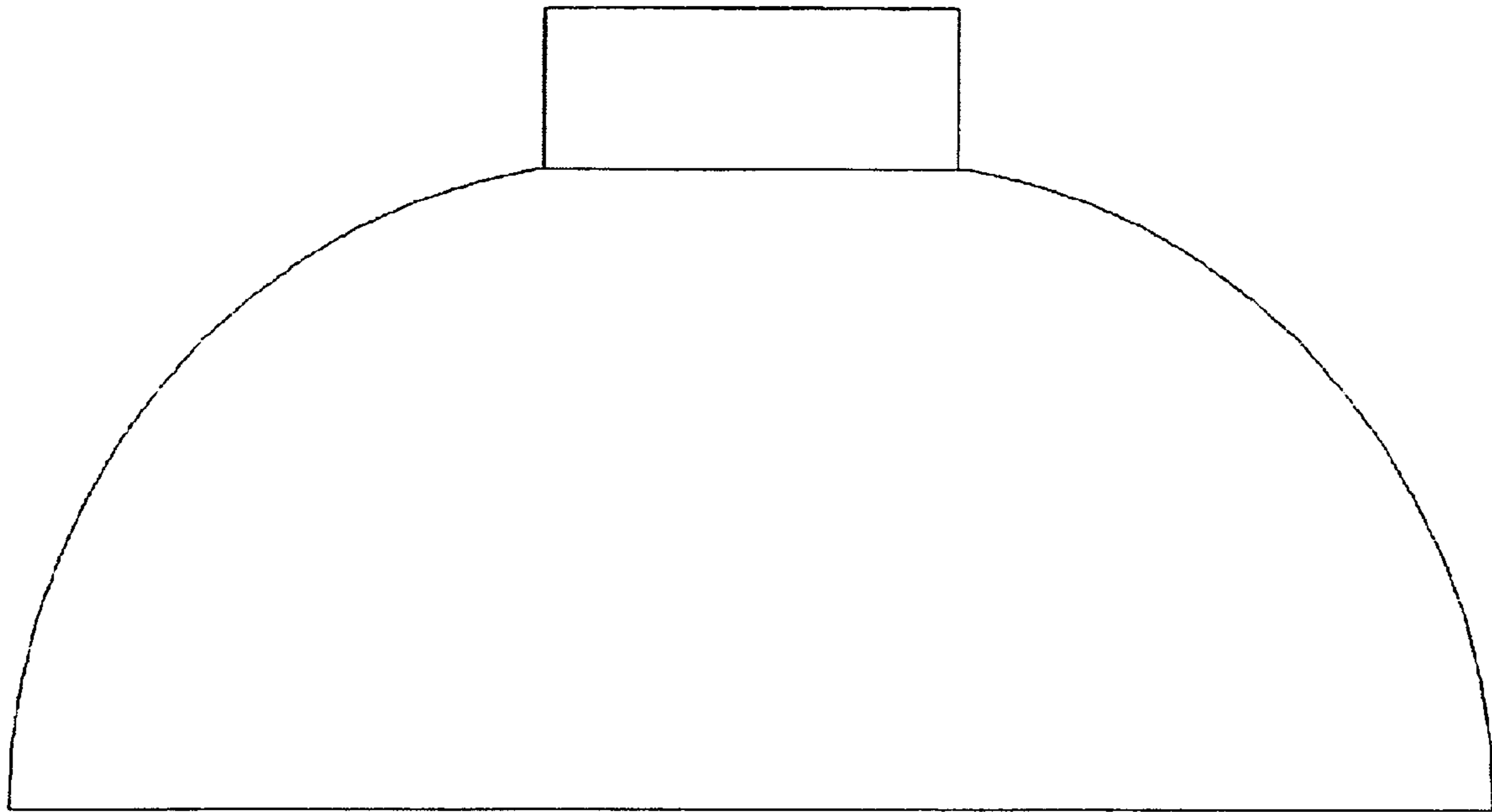

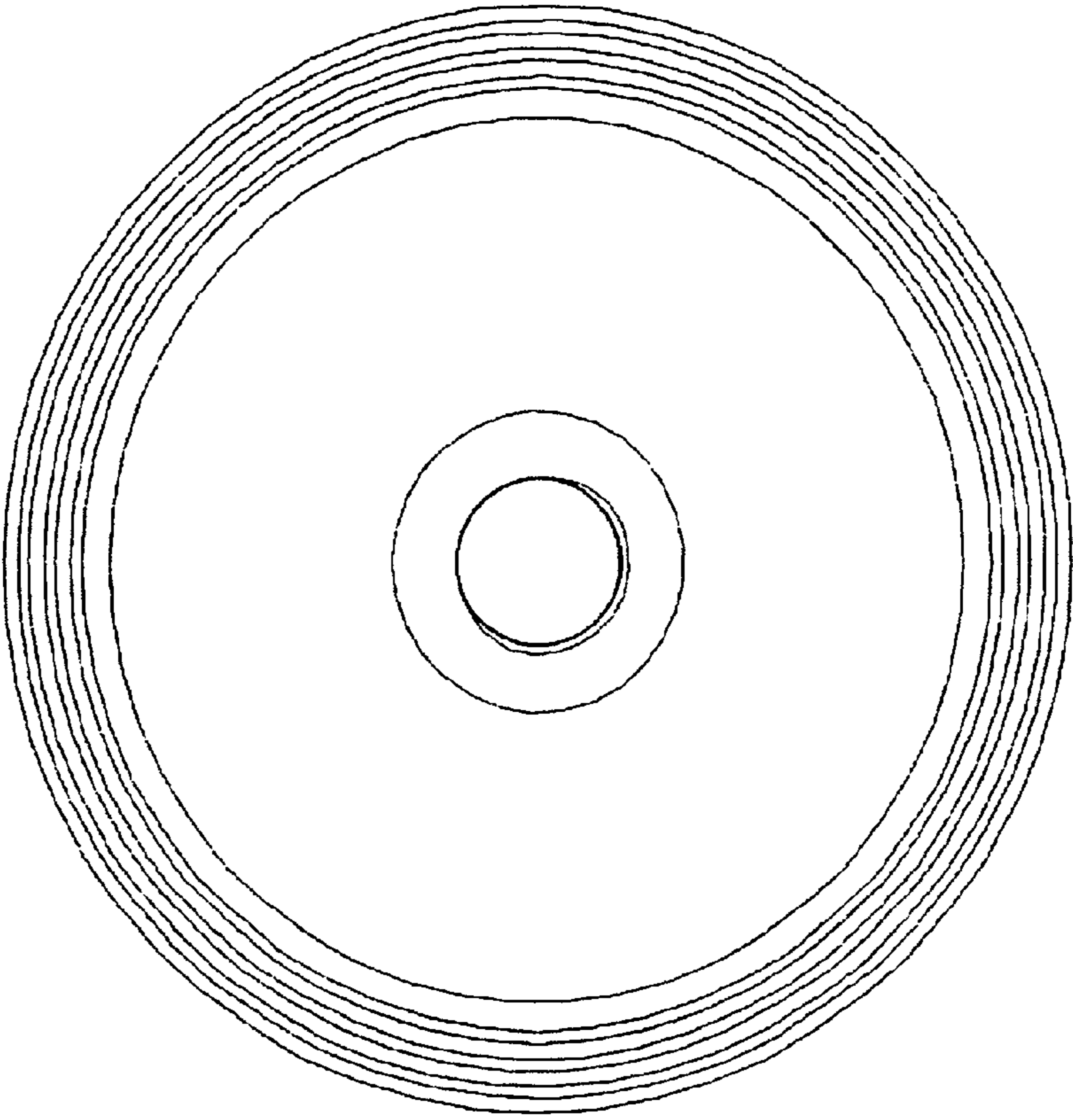

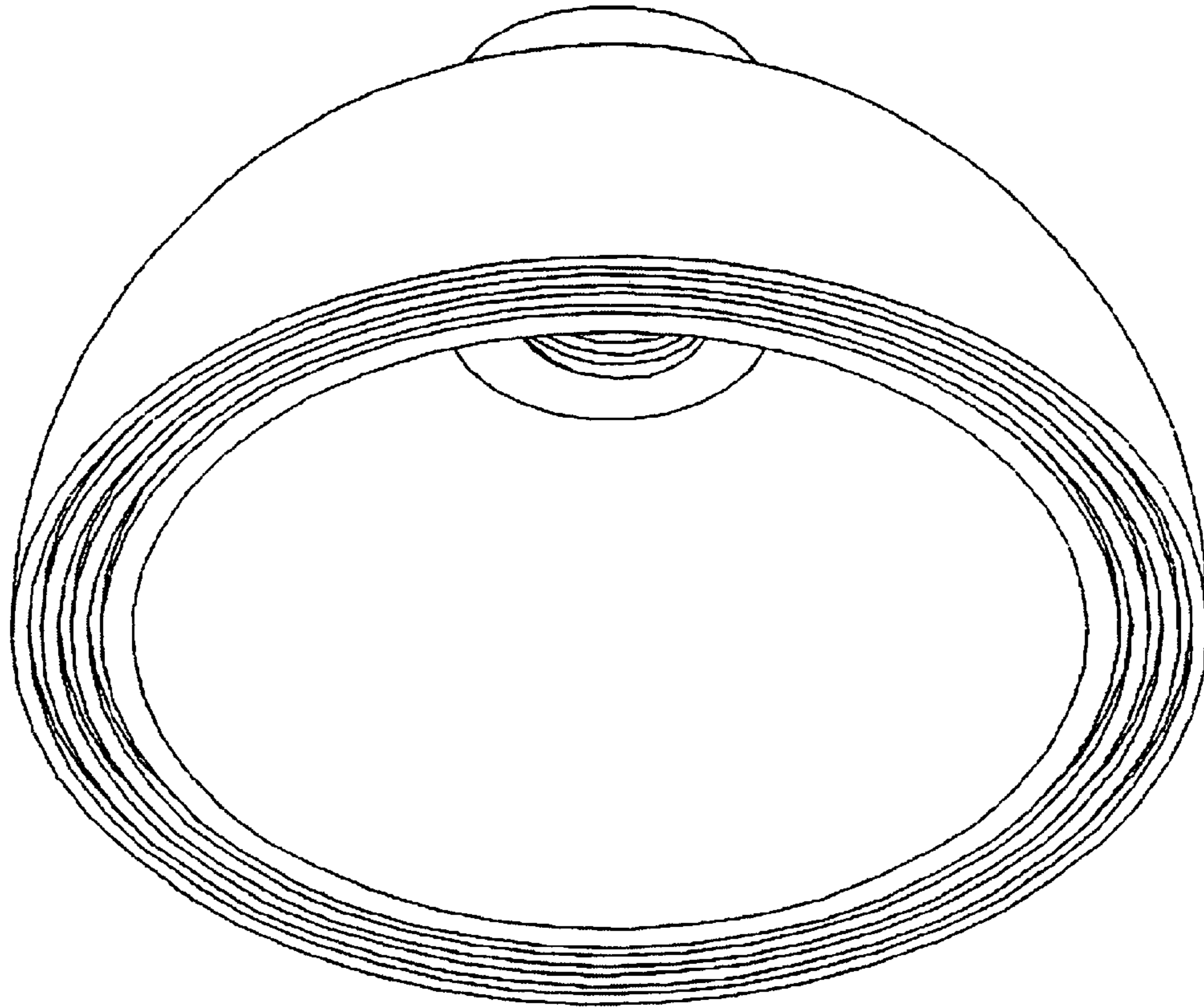
