(57) **CLAIM**

The ornamental design for a cleaning mitt, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view, from the top, front and one side of a cleaning mitt showing my new design; and, FIG. 2 is a bottom plan view thereof.

The view of the back and the other side is the same as the view of the front and the one side.

The stipling in FIGS. 1–2 represents a somewhat rough, terrycloth-like surface.

The mesh in FIGS. 1–2 represents a mesh netting constituting the outer scrubbing surface of the mitt.

The cloth loop indicated in dotted line in FIGS. 1–2 represents only an environment of use and forms no part of the claimed design.

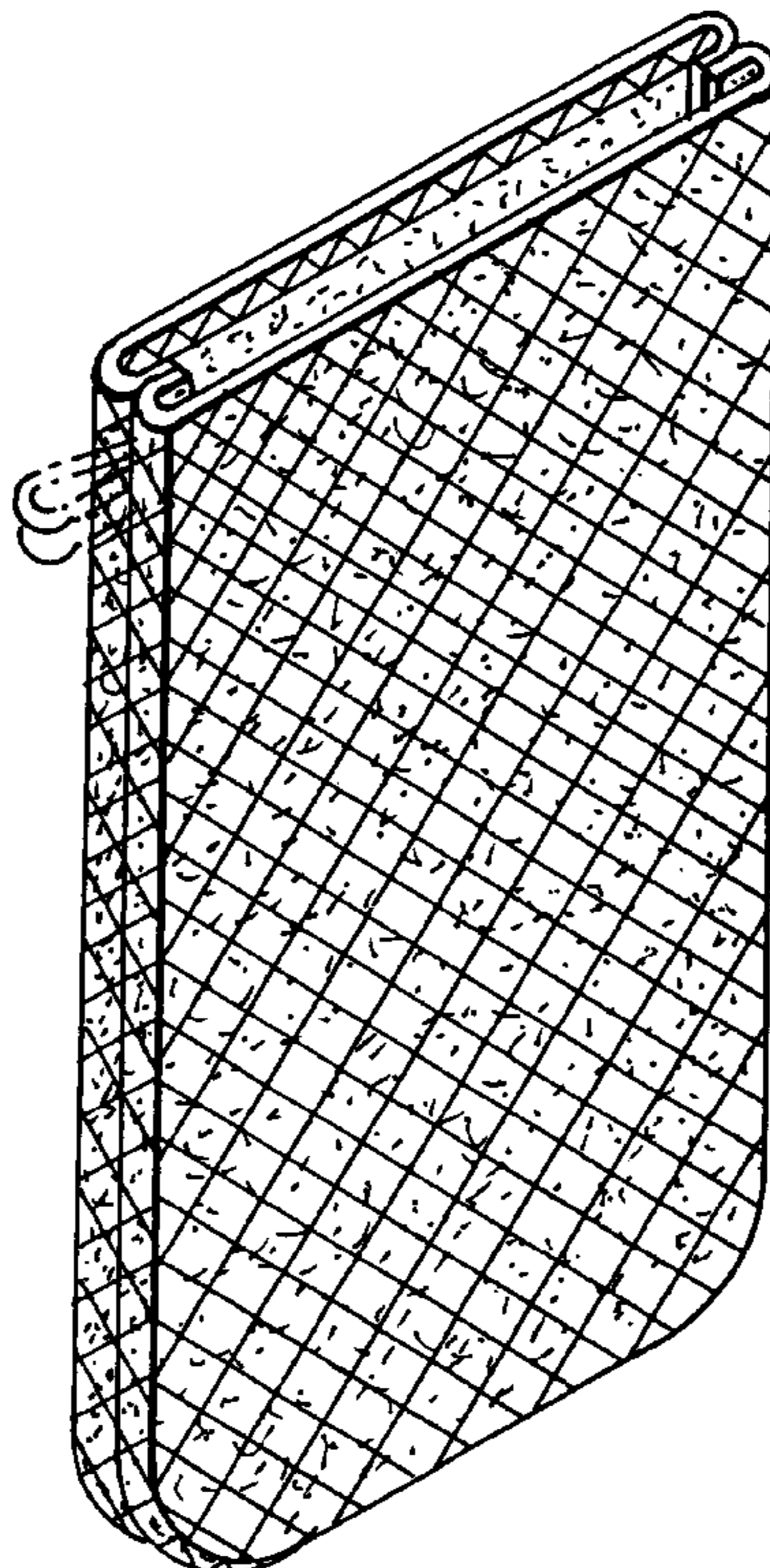

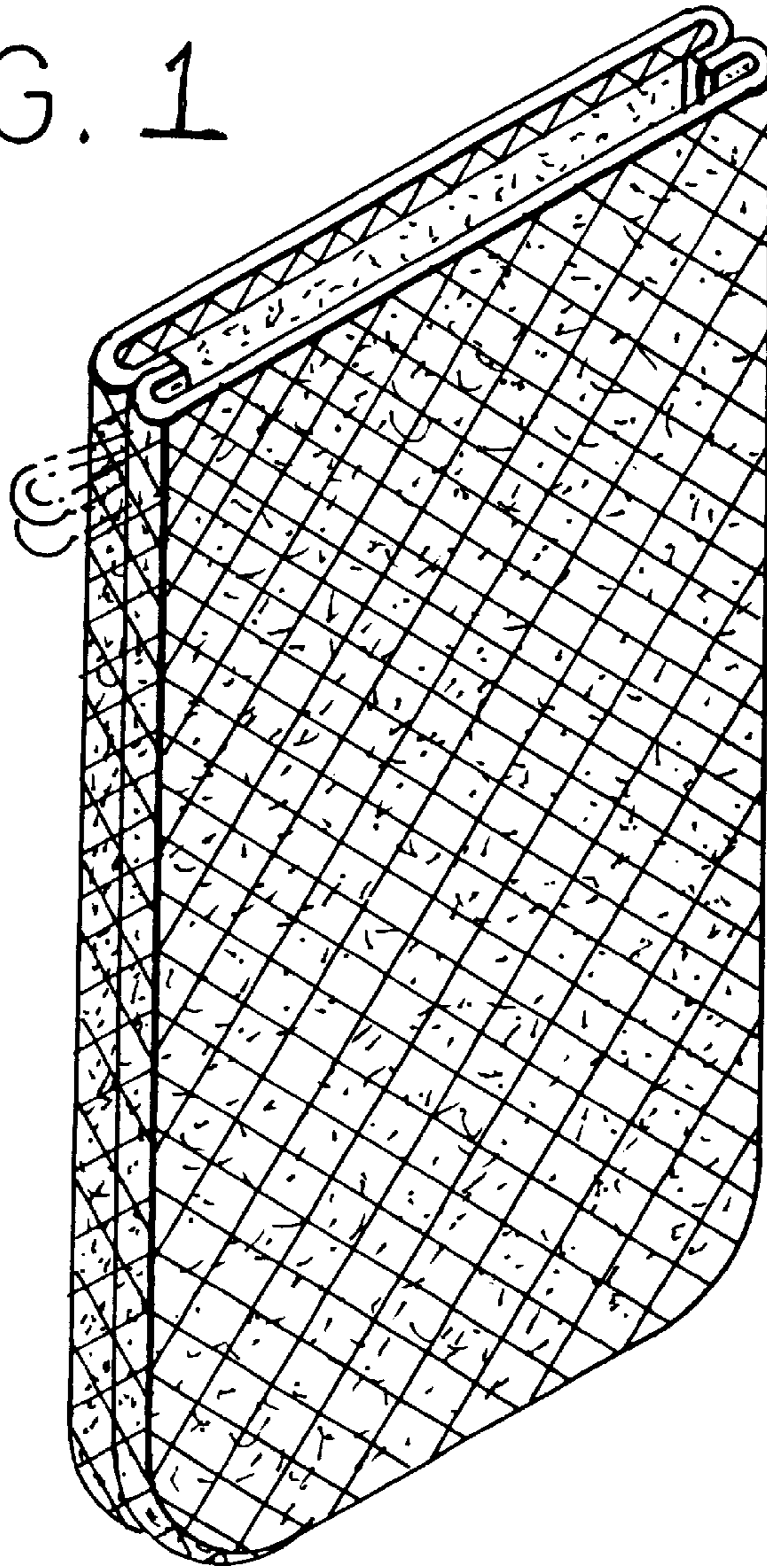
