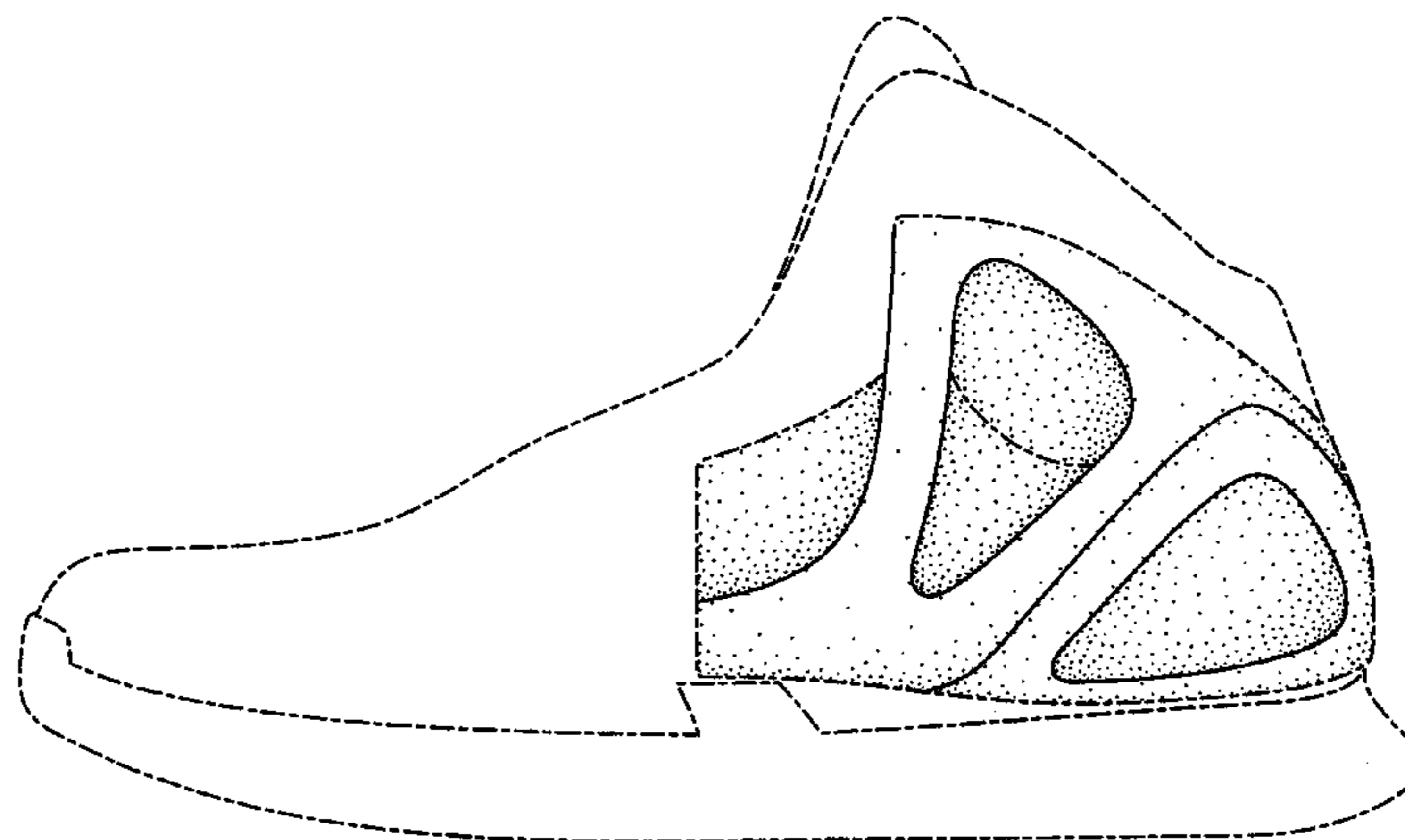
(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design;
 FIG. 2 is a rear perspective view thereof;
 FIG. 3 is a side elevational view thereof; and,
 FIG. 4 is a rear elevational view thereof.
 The broken lines immediately adjacent to the shaded area represent an unclaimed boundary of the design. The broken line showing within the shaded area and the broken line showing of the remainder of the shoe are for illustrative purposes only and form no part of the claimed design.

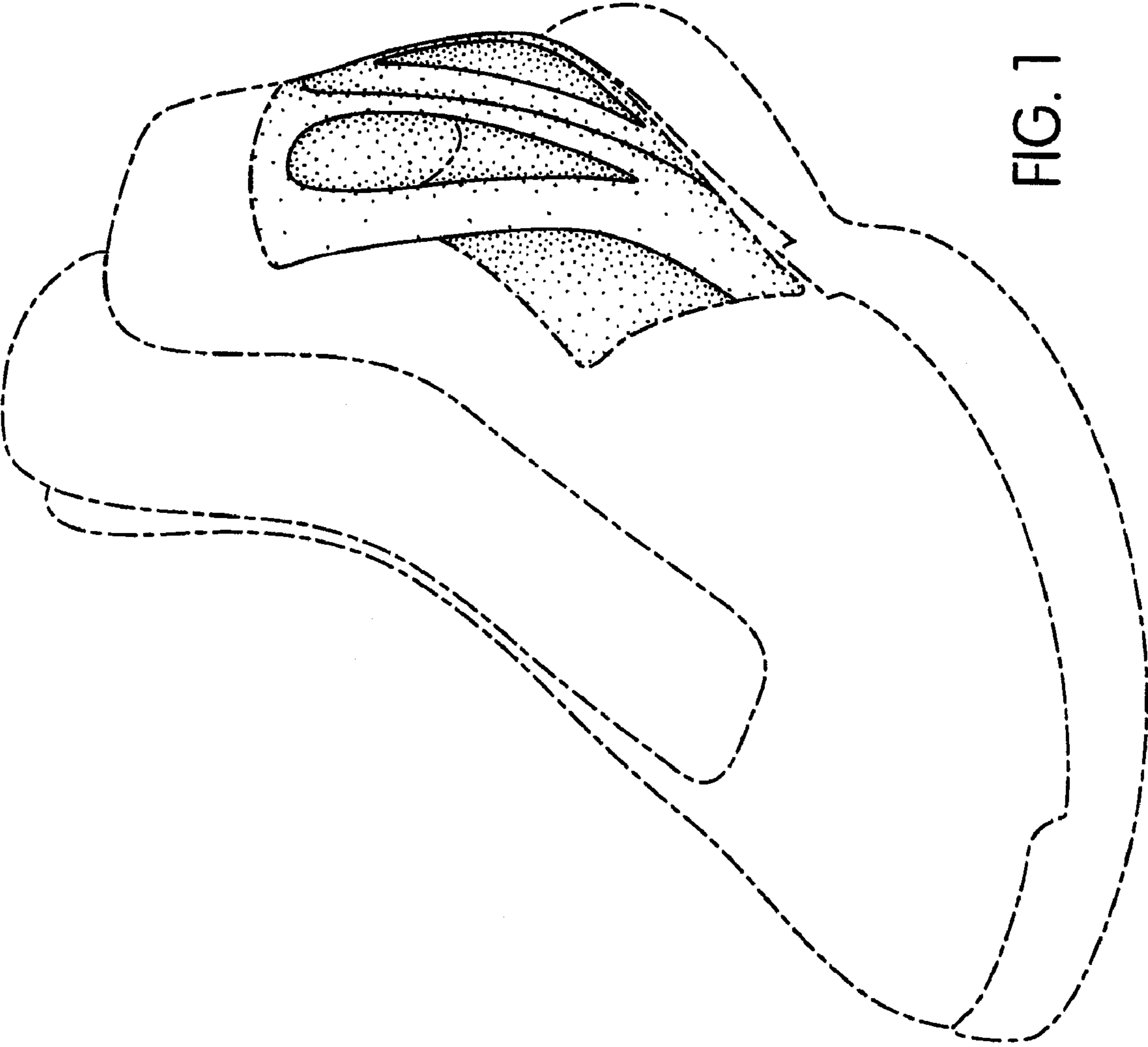

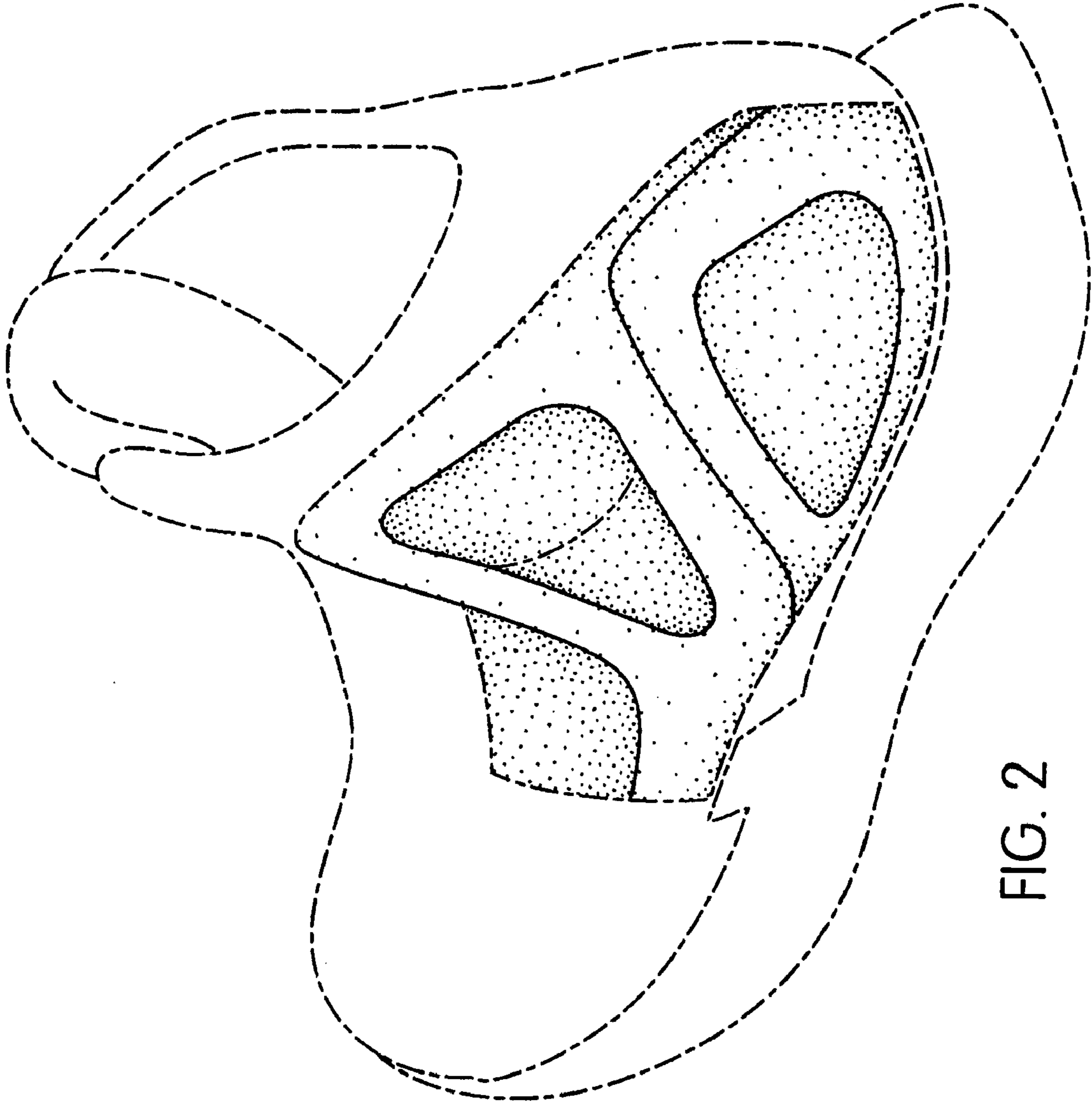

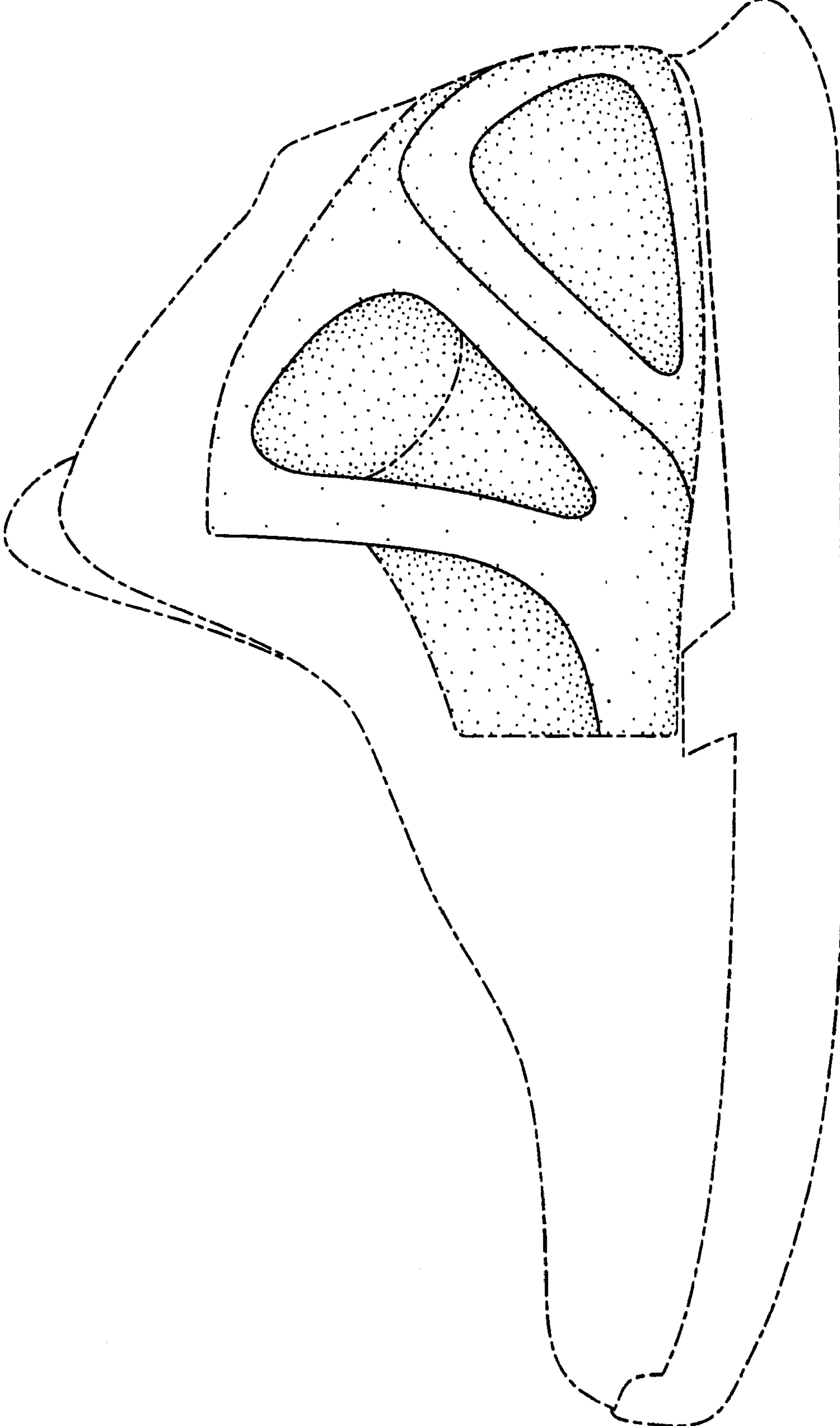

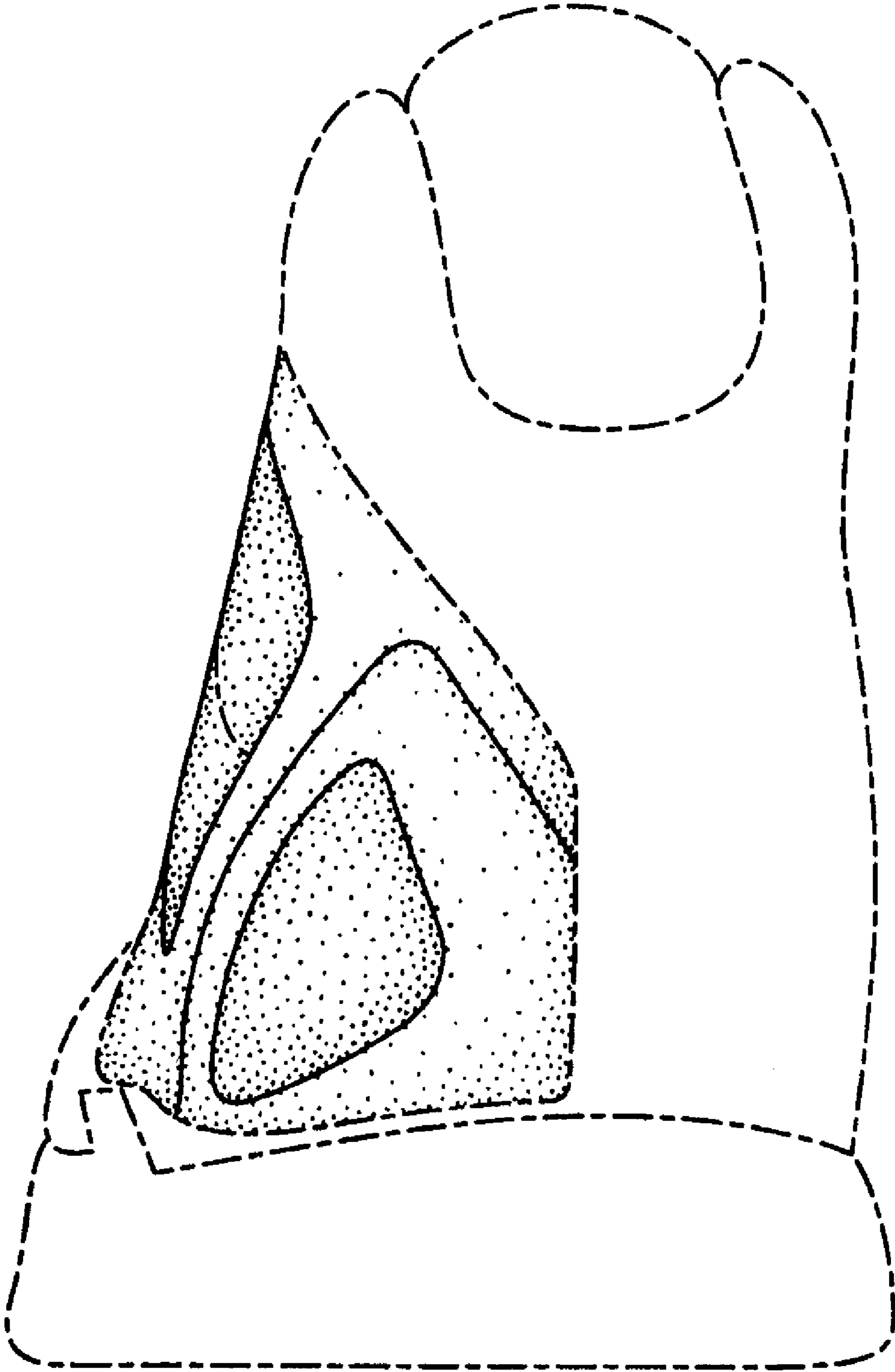
