**DESCRIPTION**

FIG. 10 is a left side elevational view thereof;

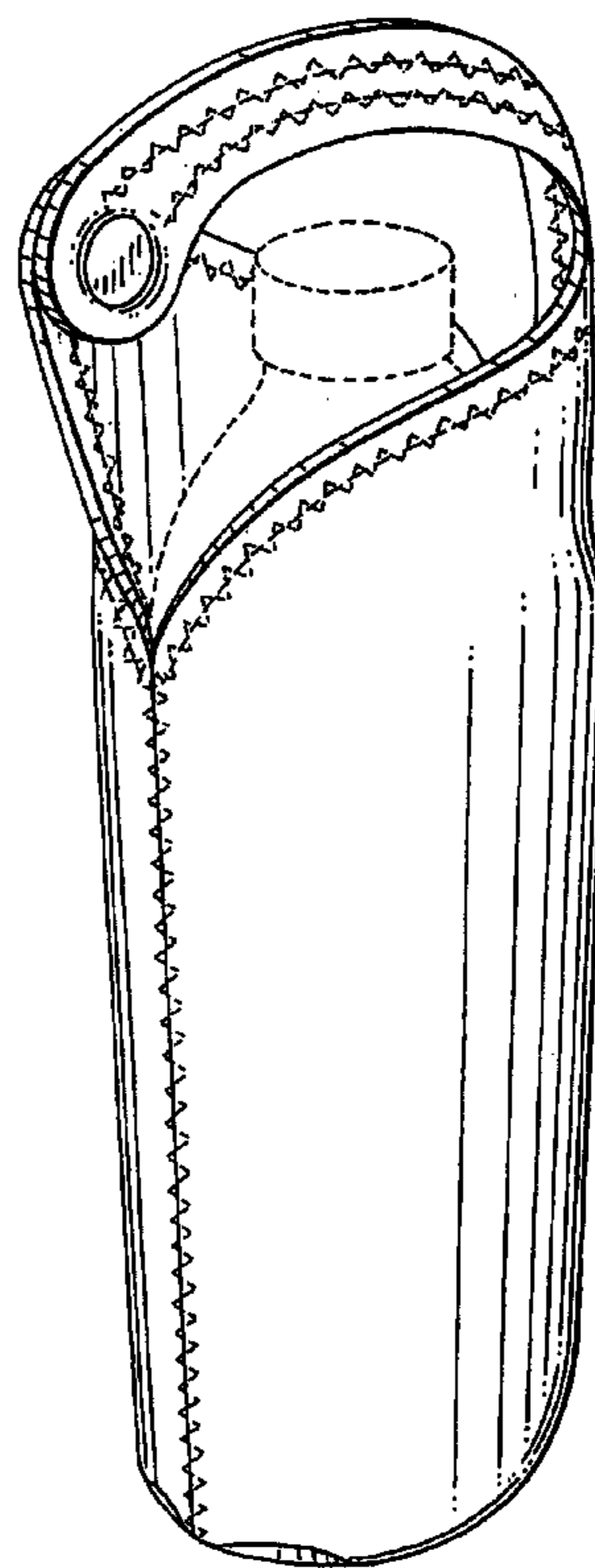
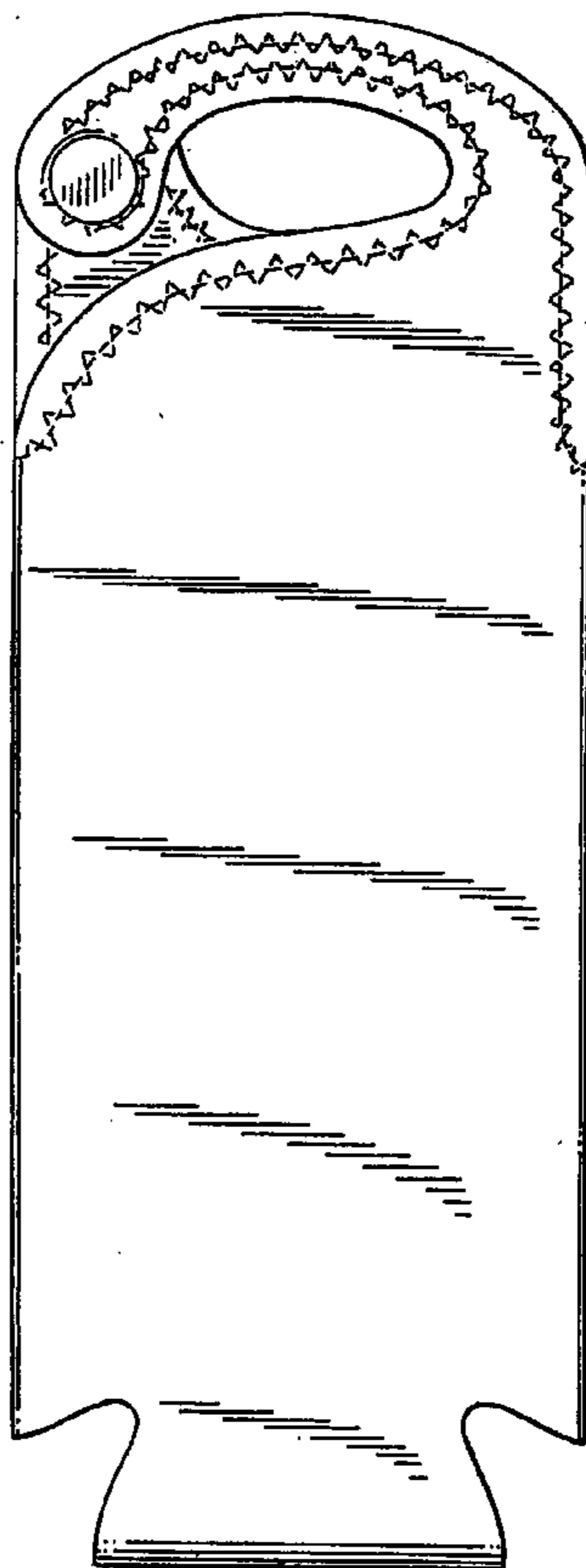
FIG. 11 is a right side elevational view thereof;

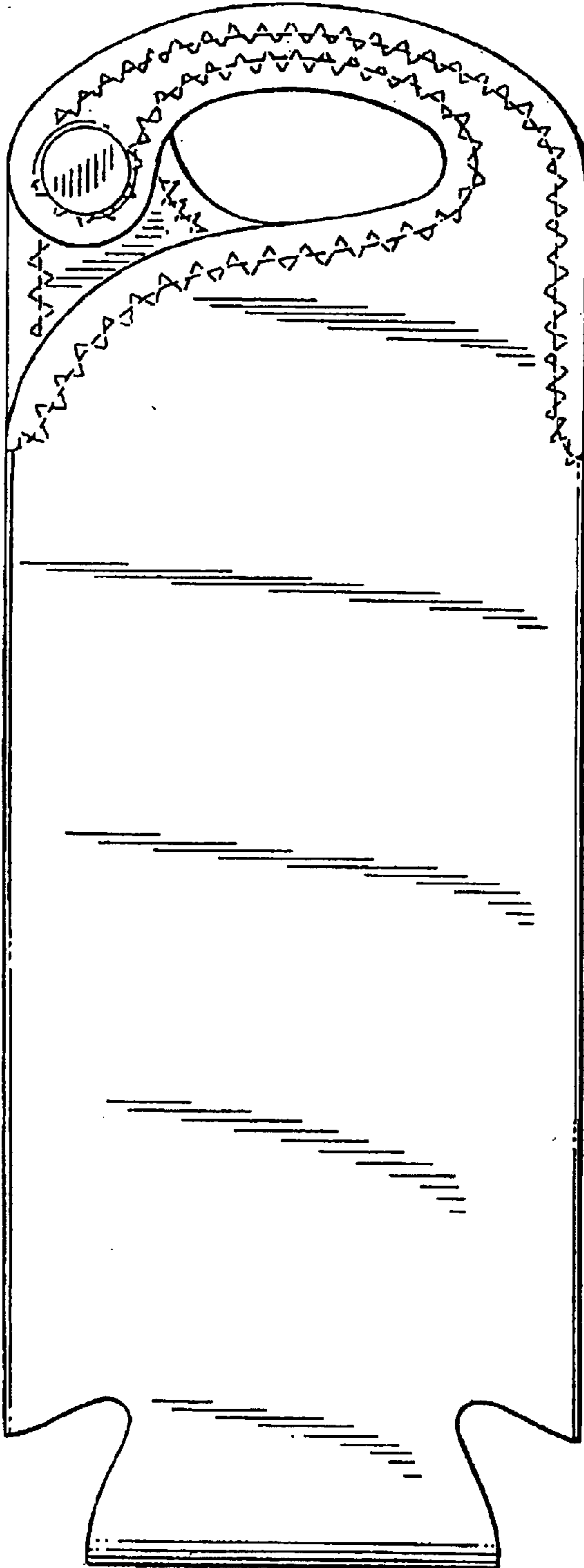

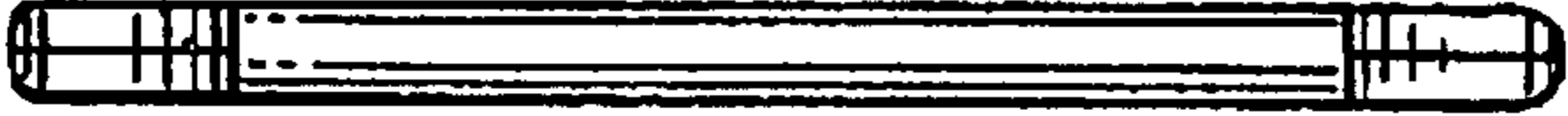

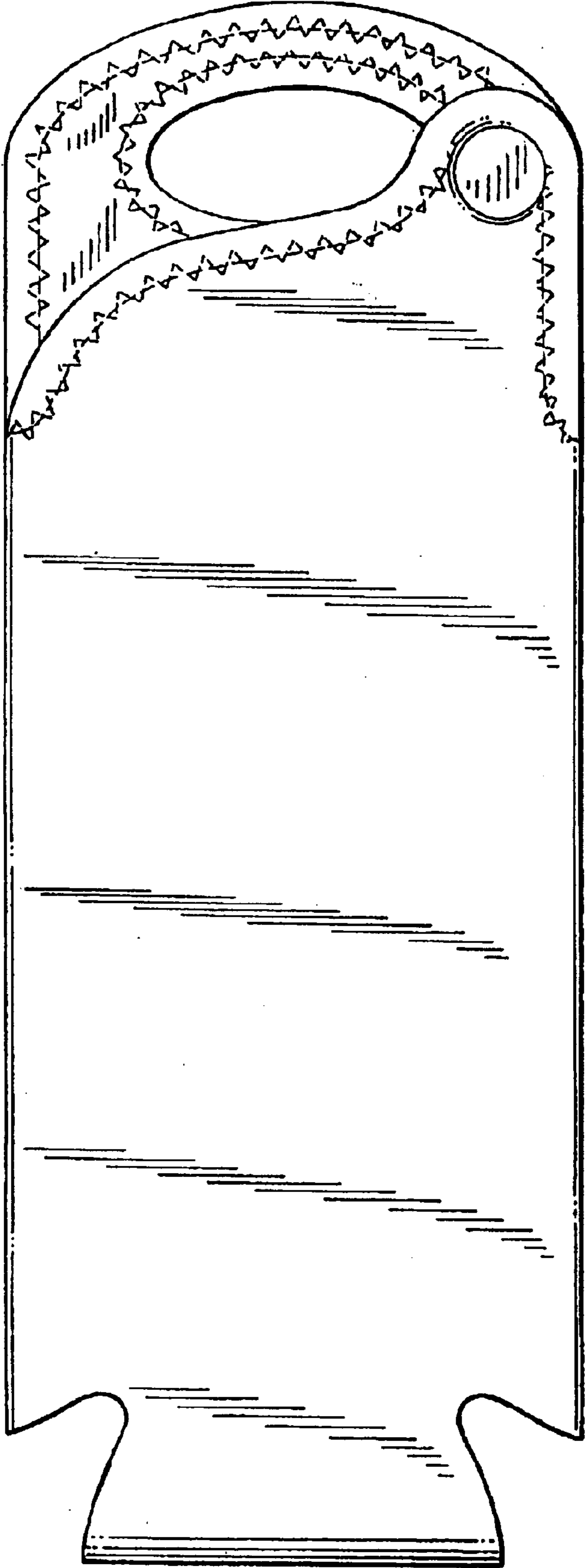

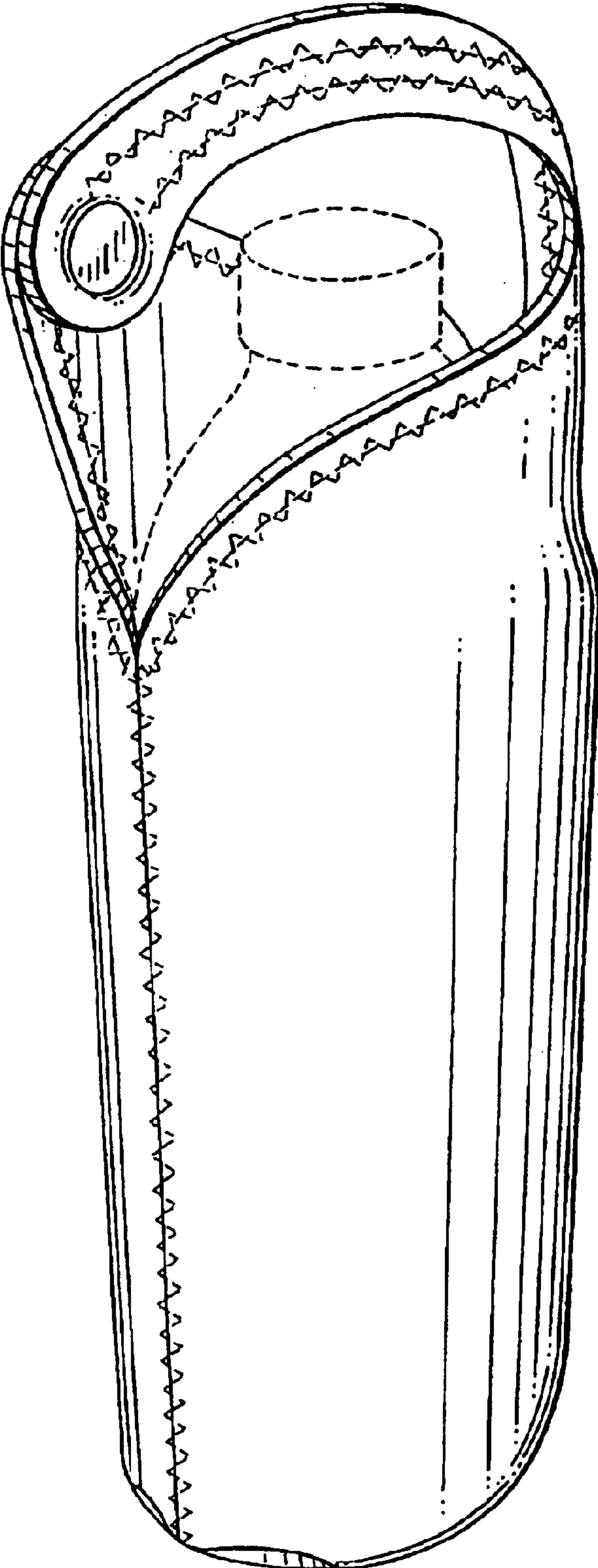

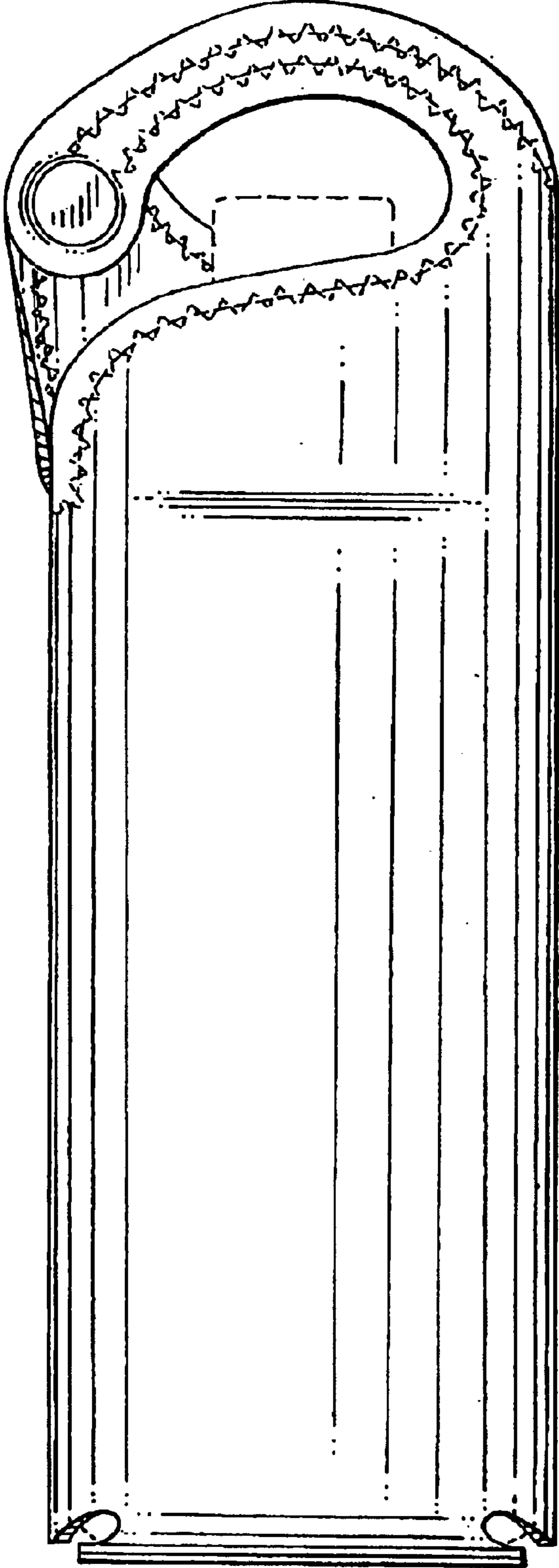

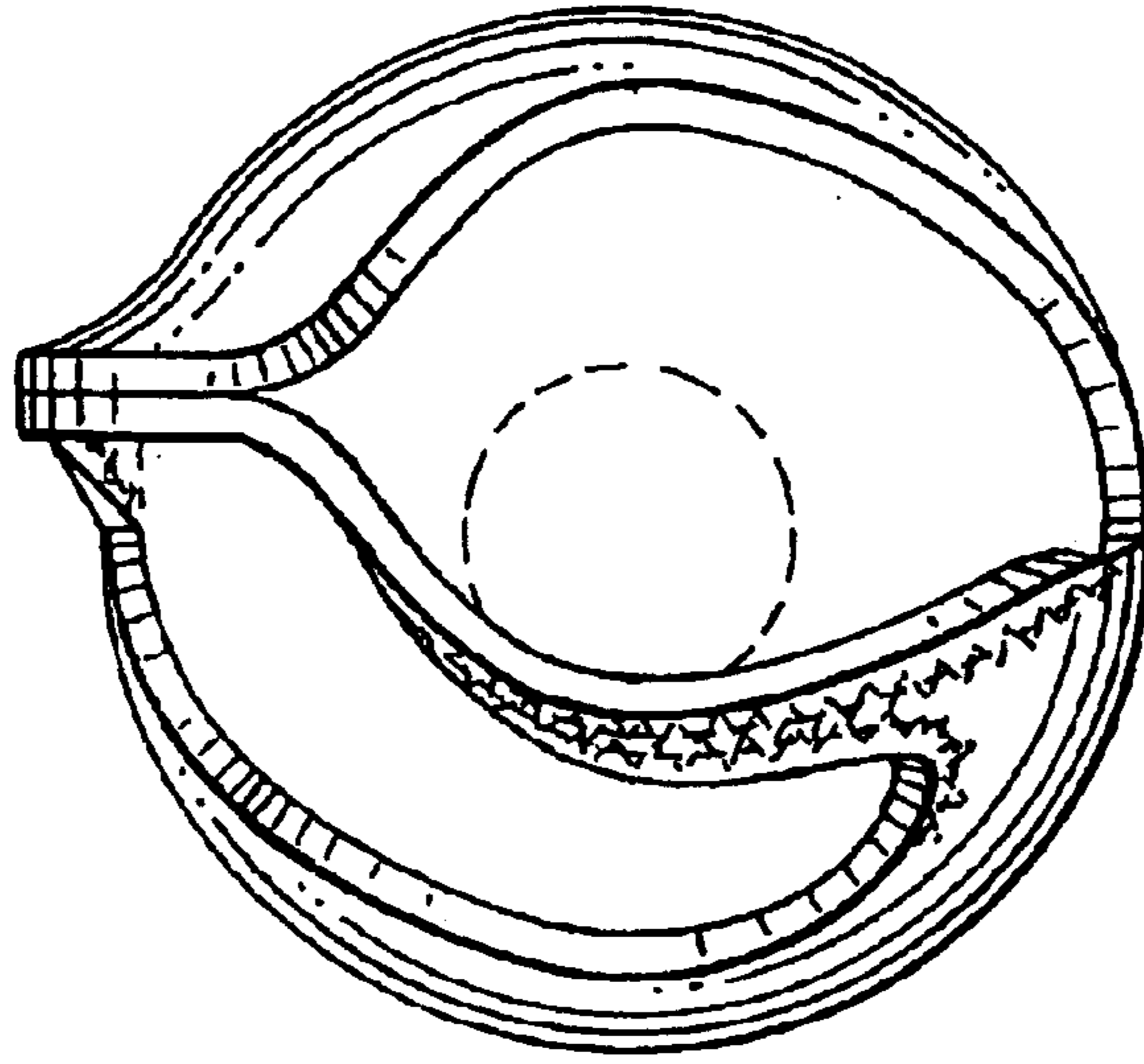

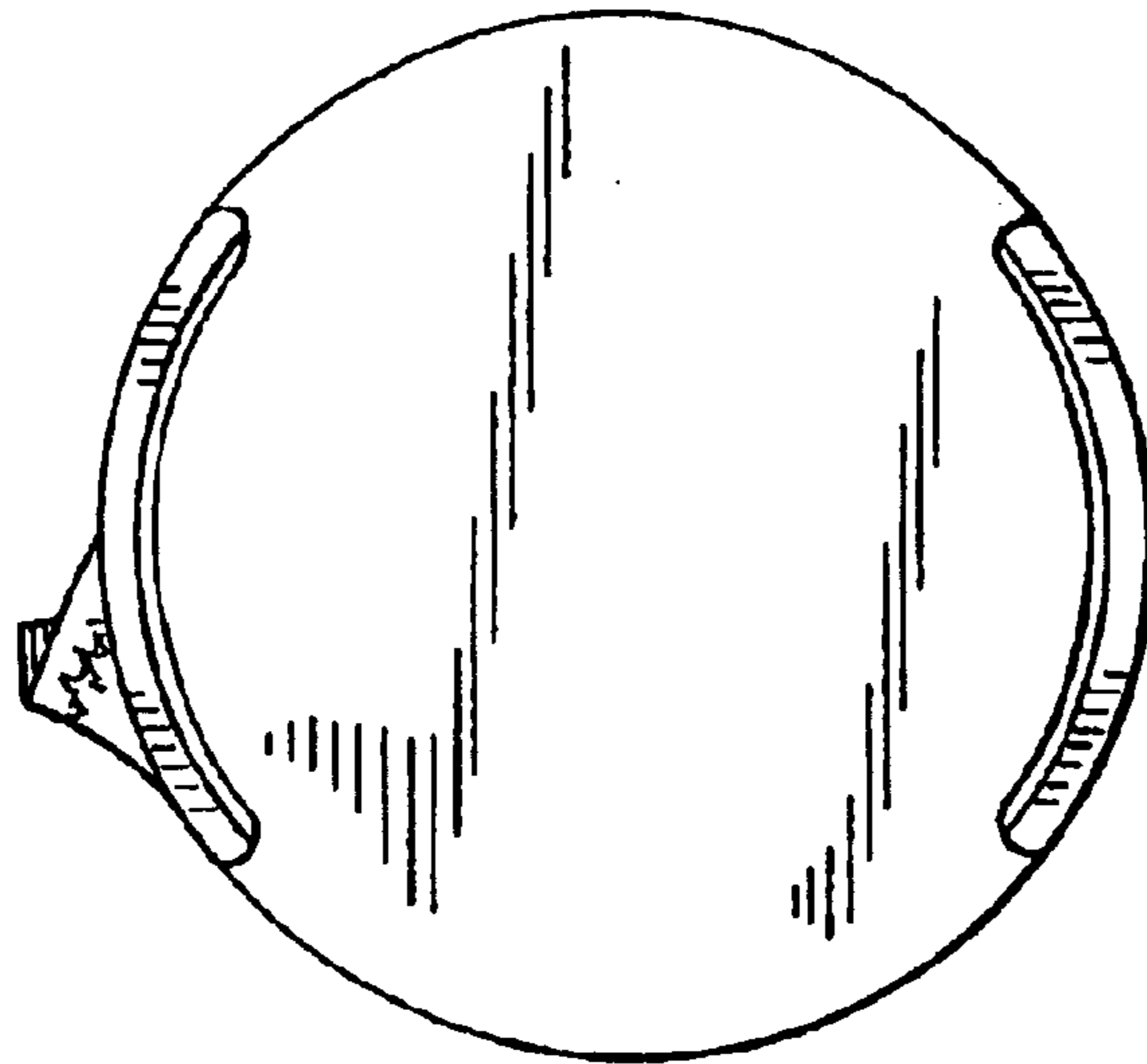

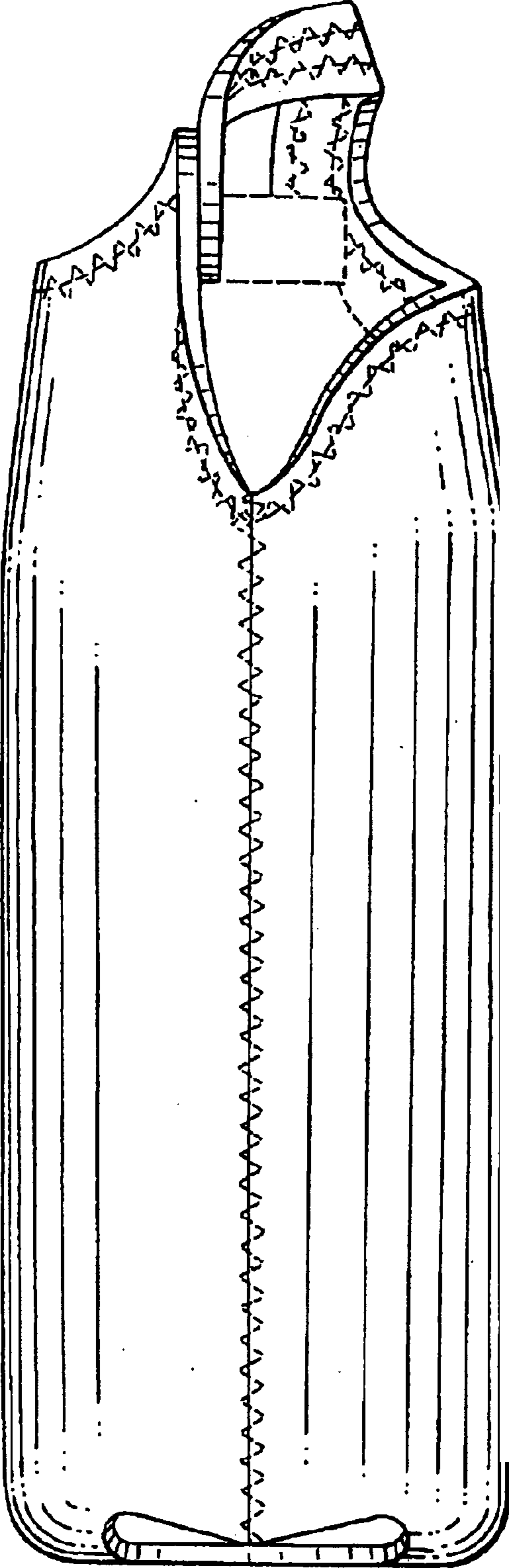

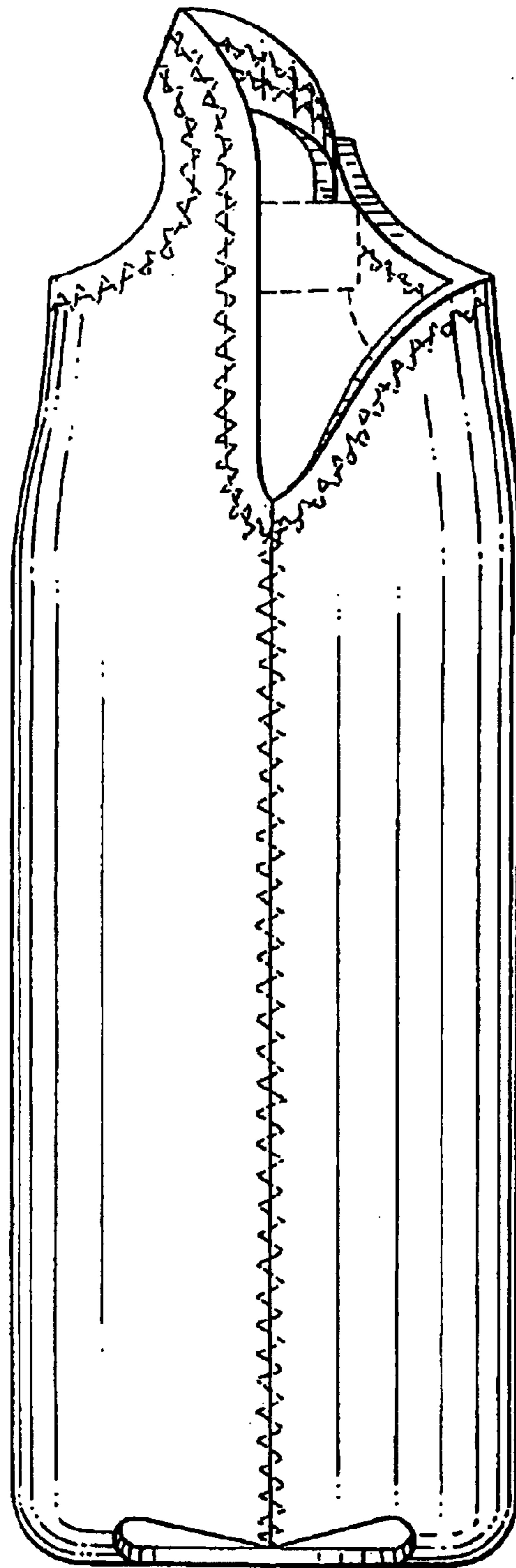

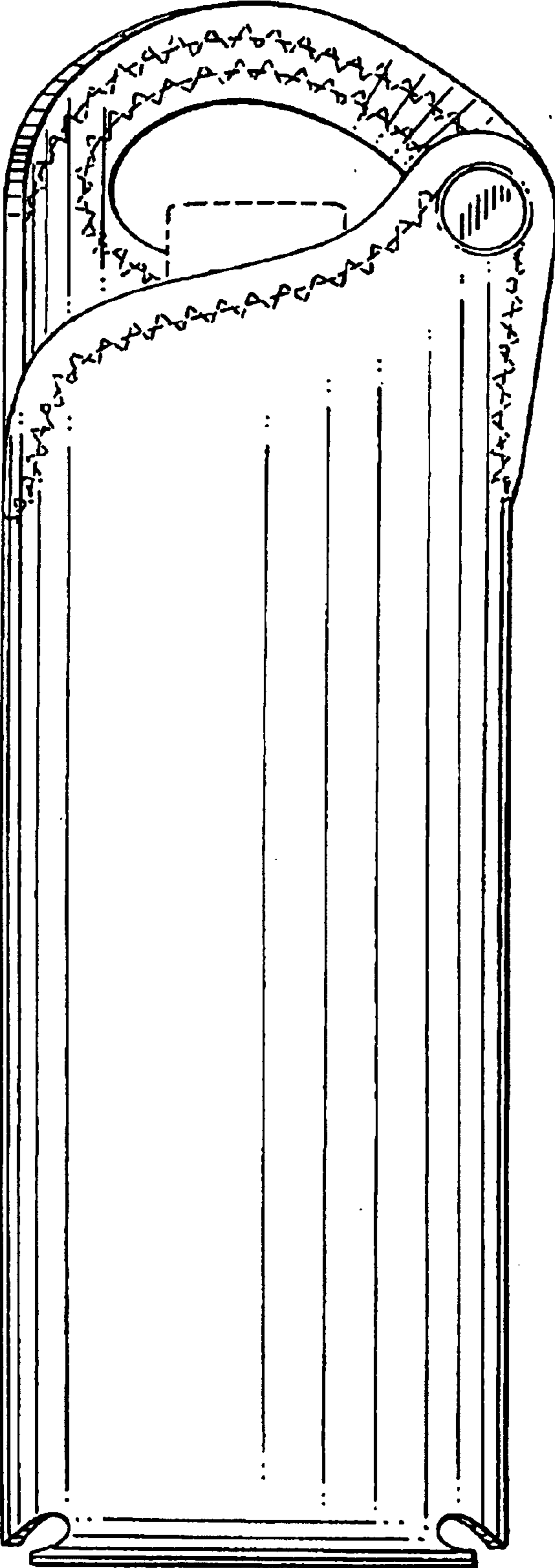
