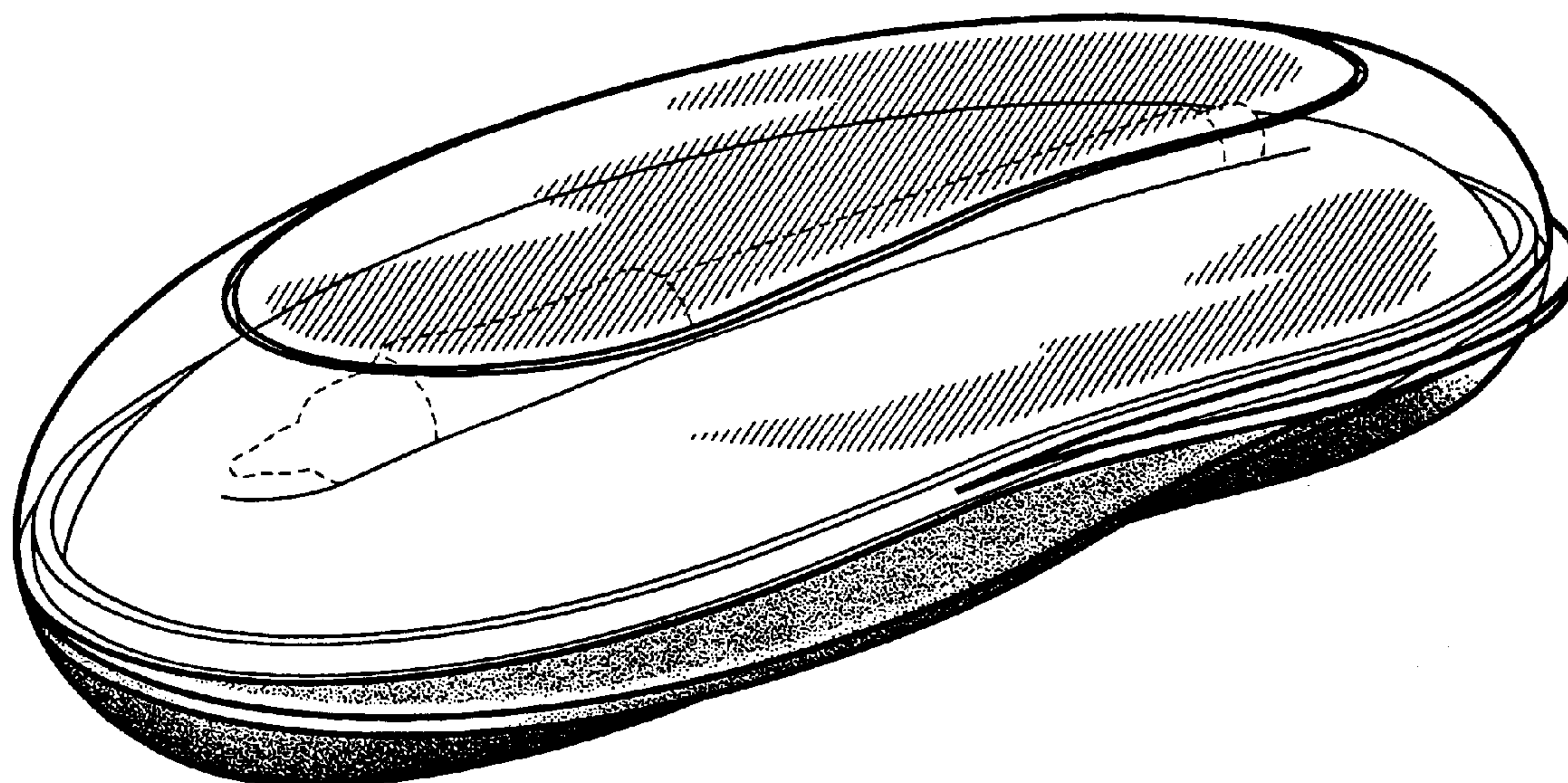
The ornamental design for a “writing instrument container,”

**DESCRIPTION**

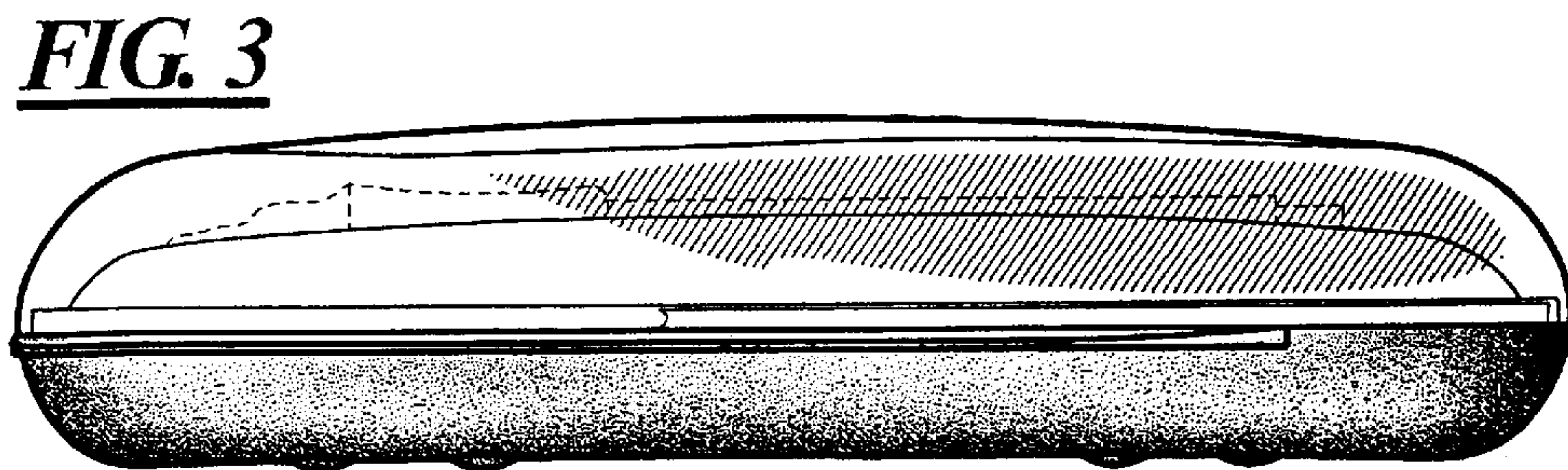
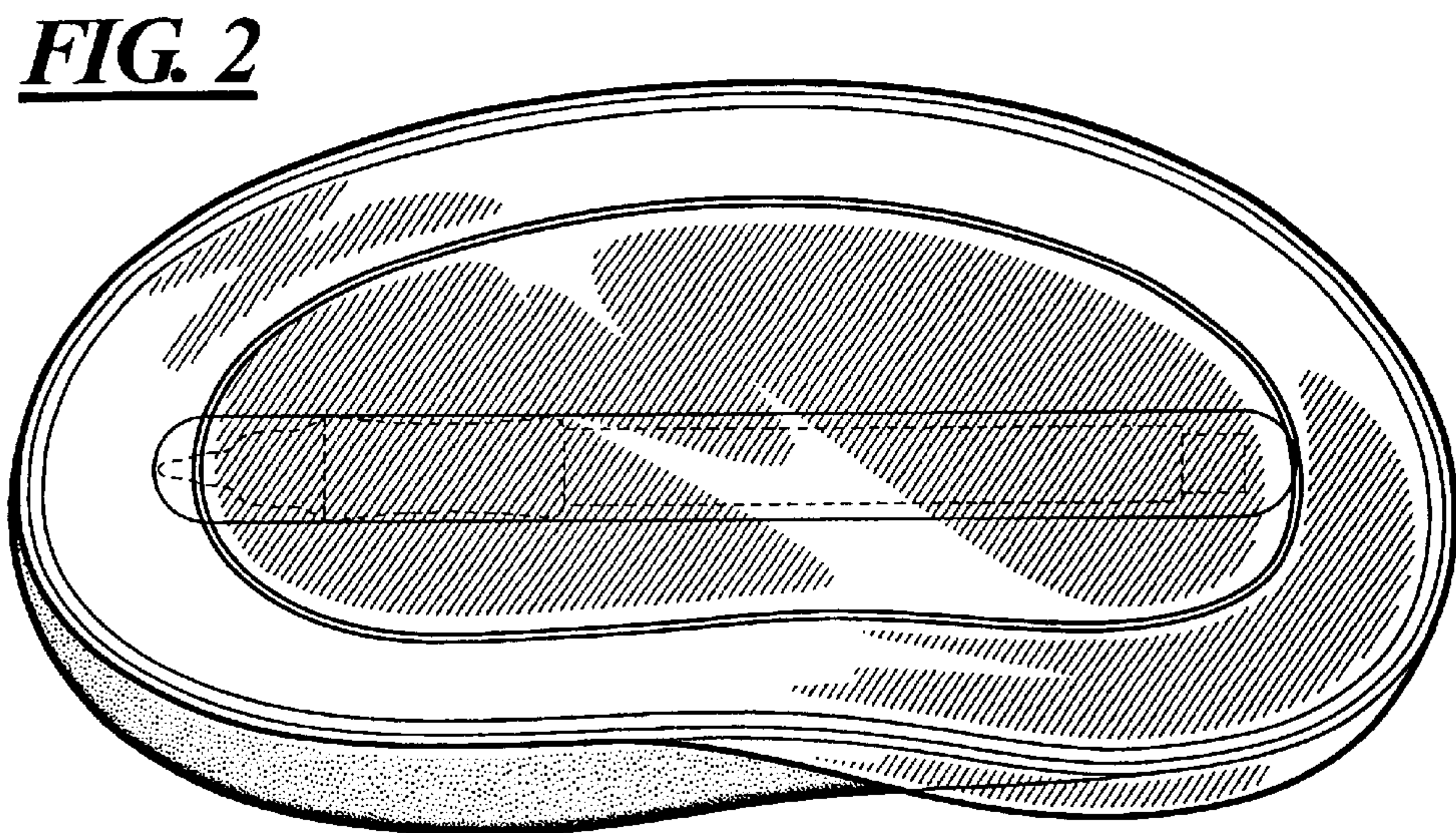
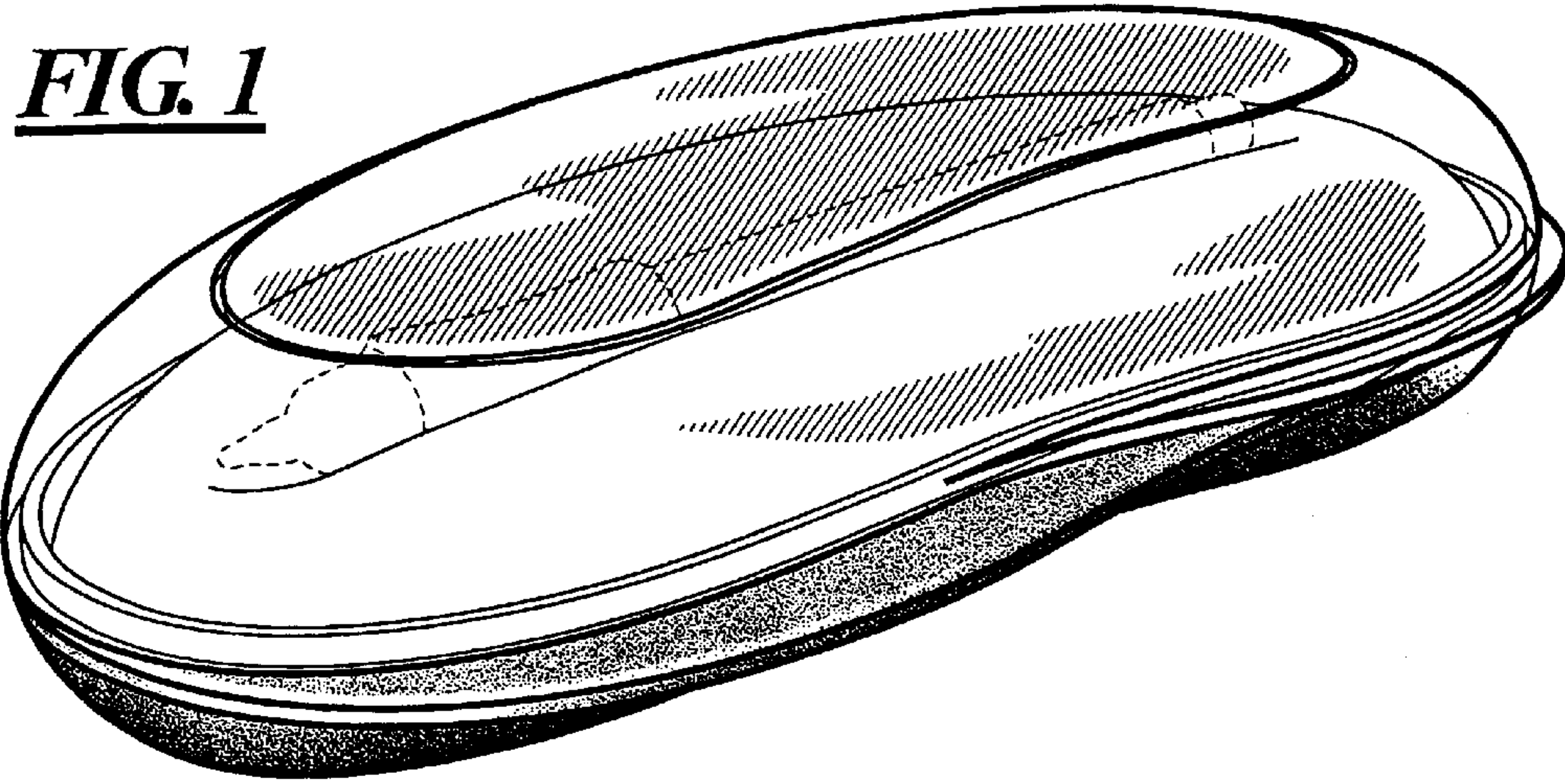
FIG. 1 is a perspective view of a writing instrument con-

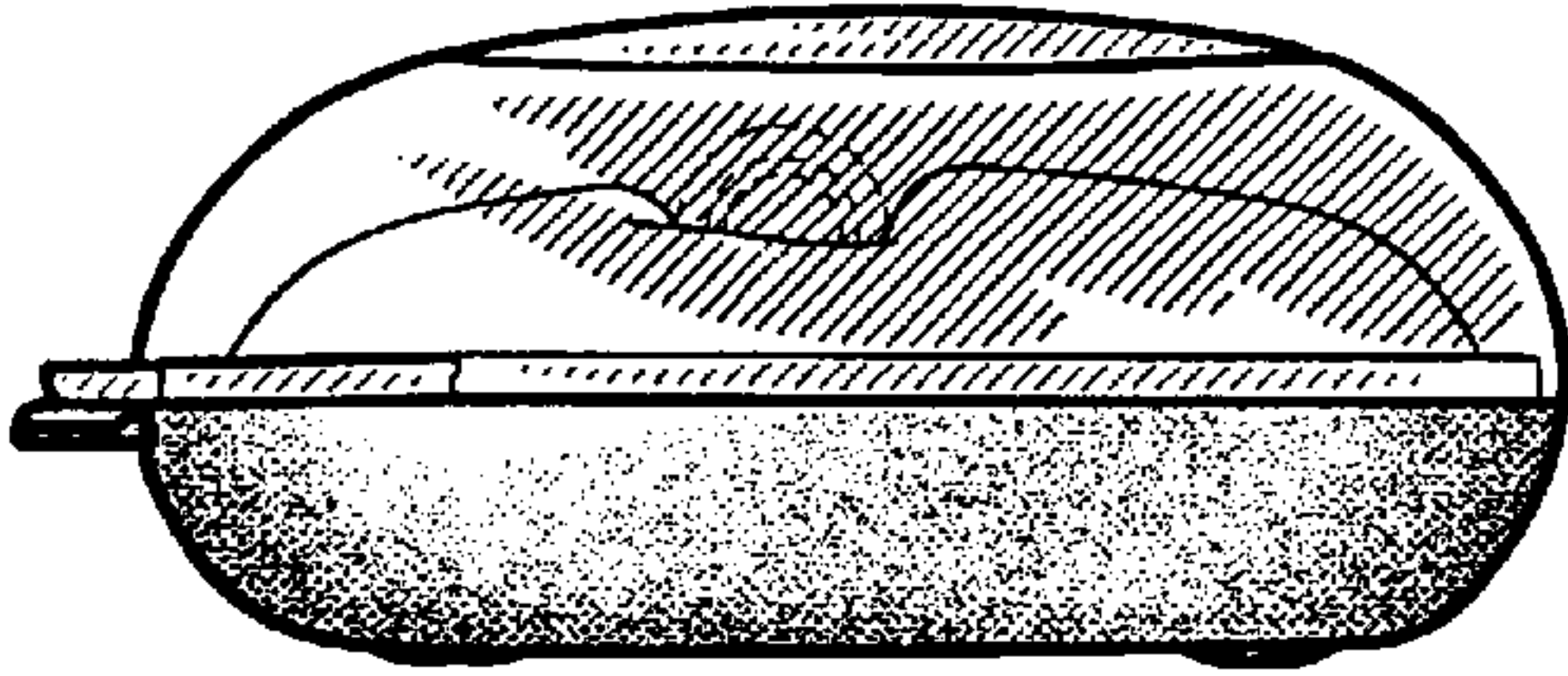




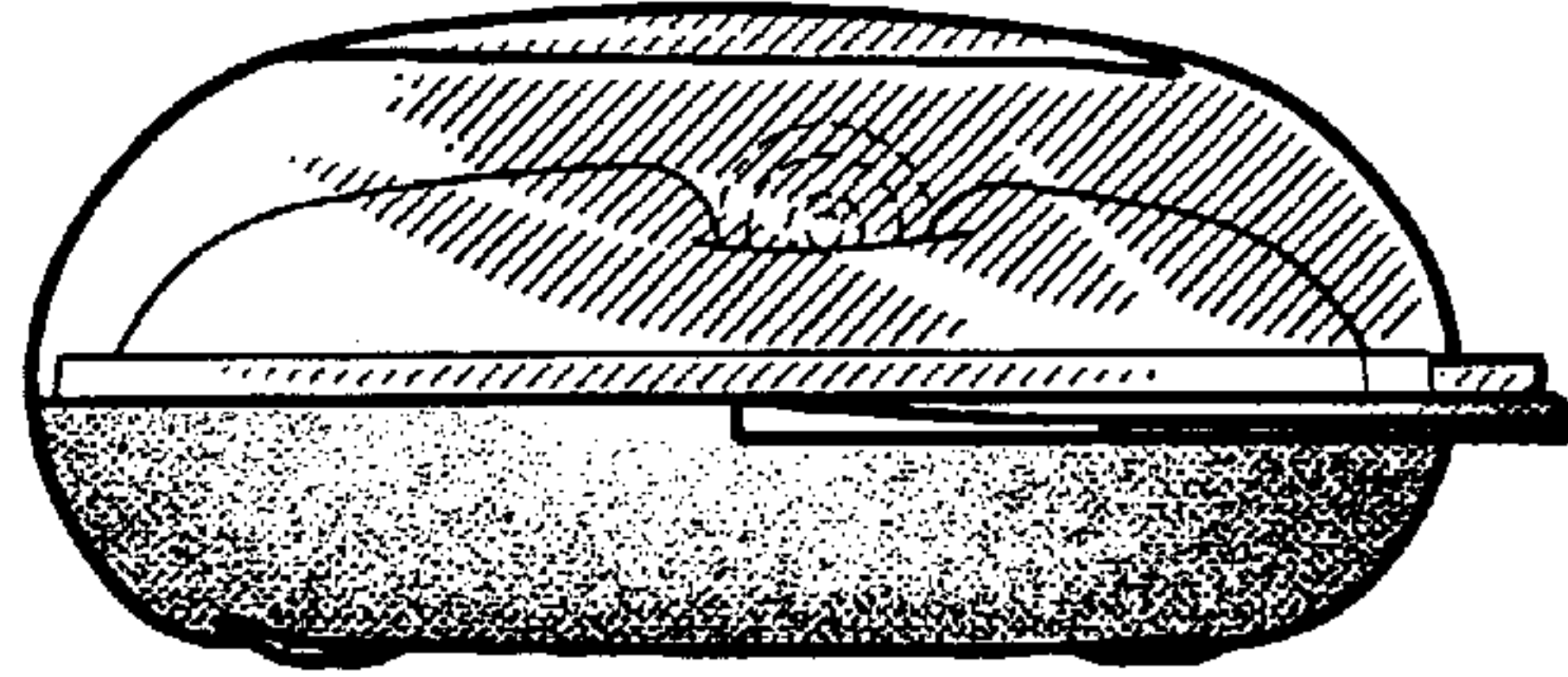




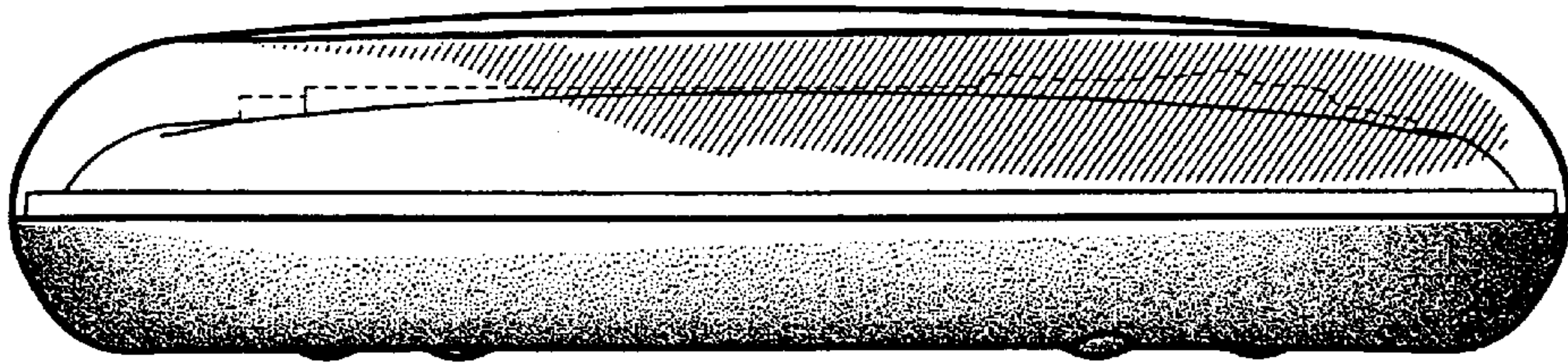
