(57) **CLAIM**

The ornamental design for a combined brush and holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevational view of the brush of the present design;

FIG. 2 is a bottom view of the brush;

FIG. 3 is an exploded bottom-left-rear perspective view of the brush and the holder of the present design;

FIG. 4 is a right side elevational view of the brush;

FIG. 5 is a front elevational view of the brush;

FIG. 6 is an exploded top-right-front perspective view of the brush;

FIG. 7 is a rear elevational view of the brush;

FIG. 8 is a top-right-front perspective view of the brush and the holder; and,

FIG. 9 is a top view of the brush.

The holder is omitted from FIGS. 1, 2, 4-7 and 9 for ease of illustration.

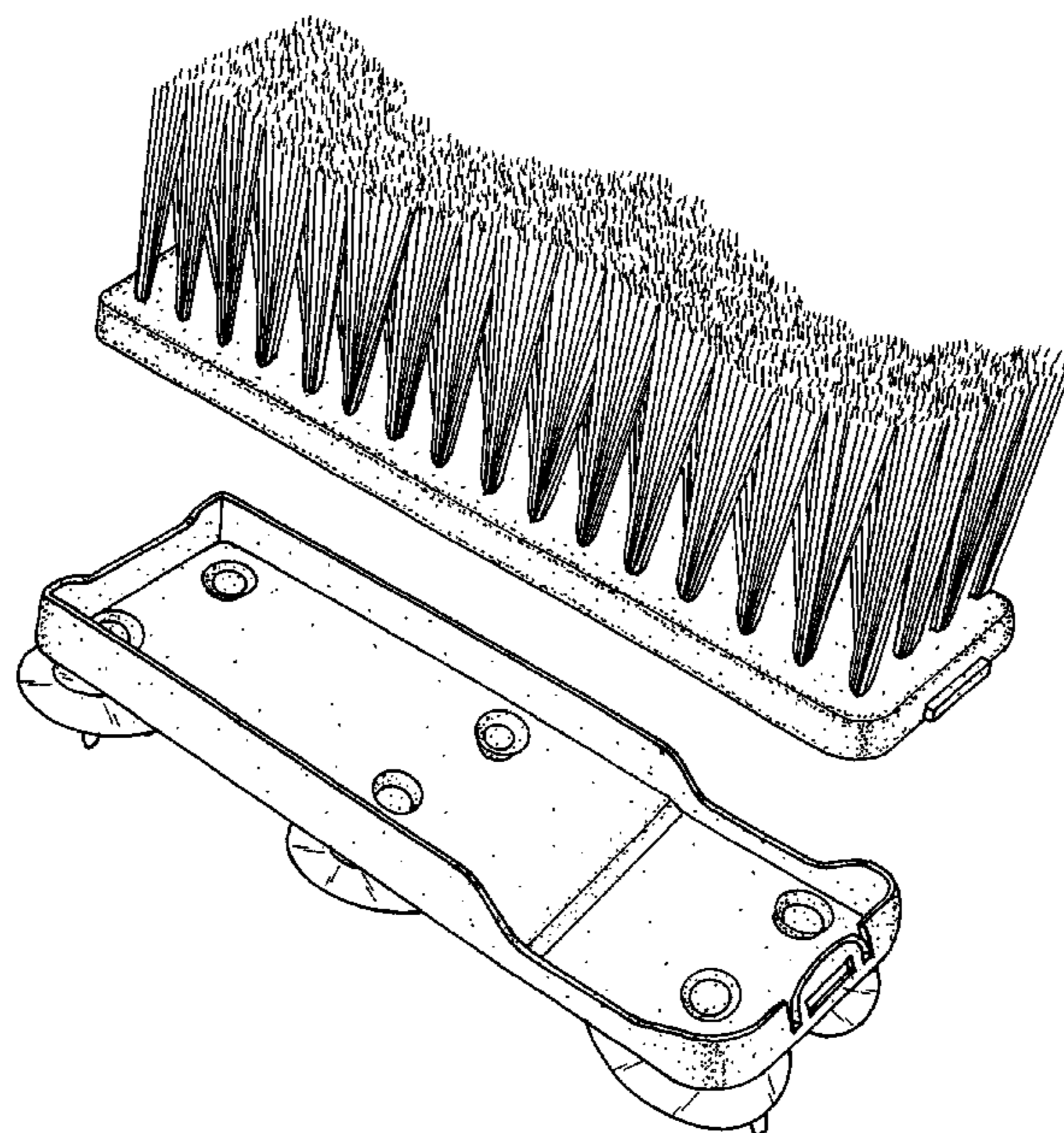

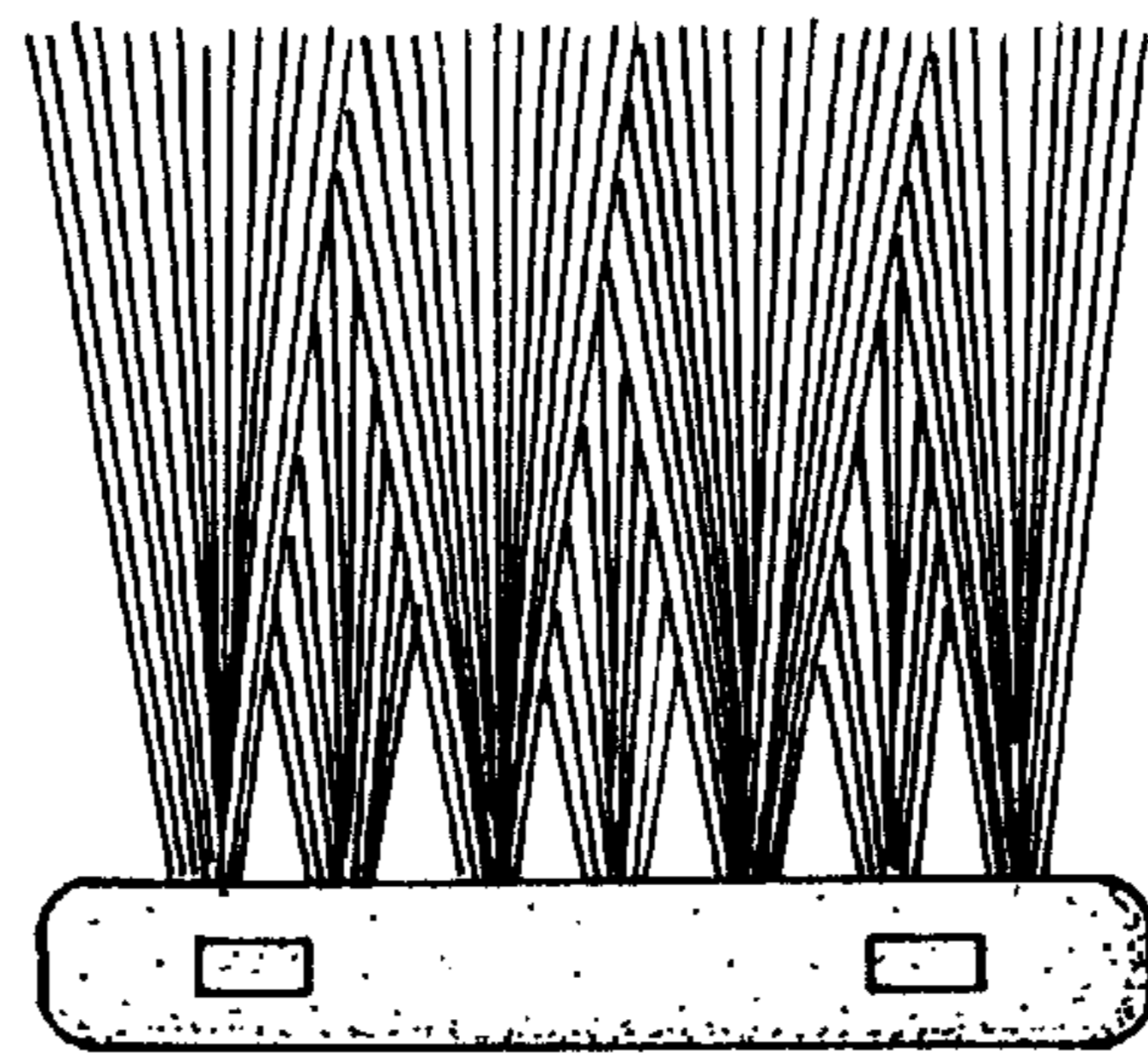

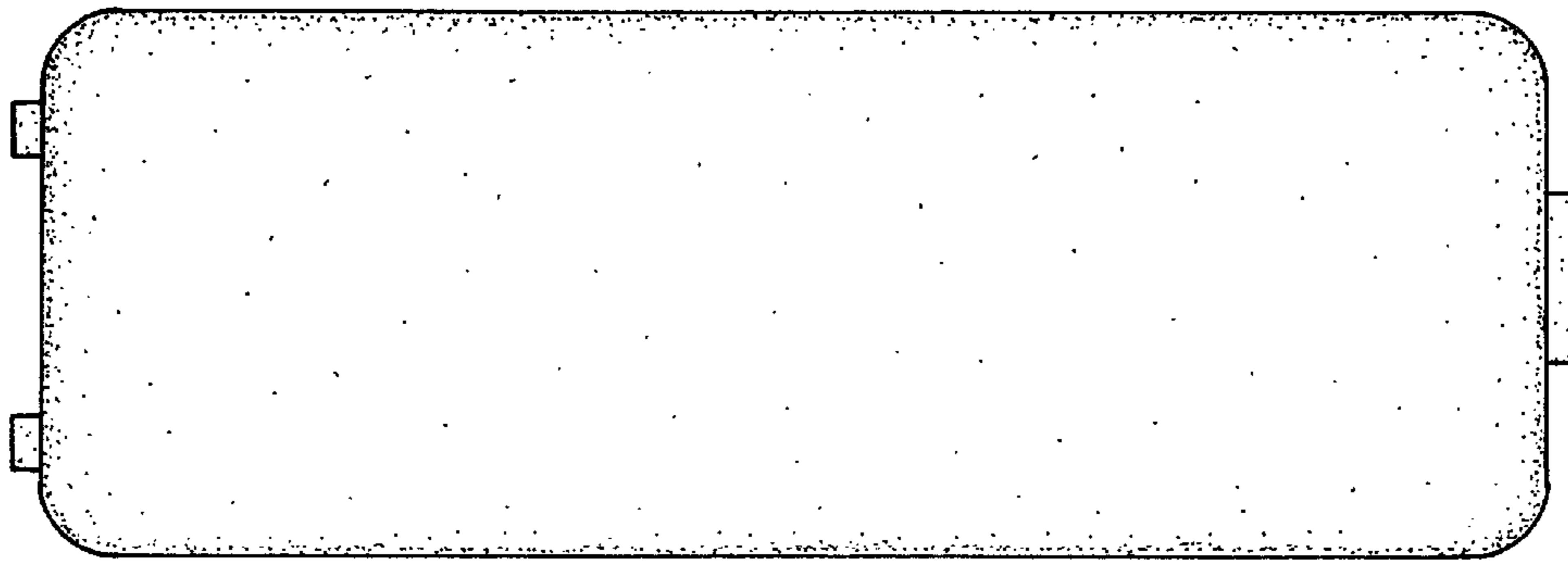

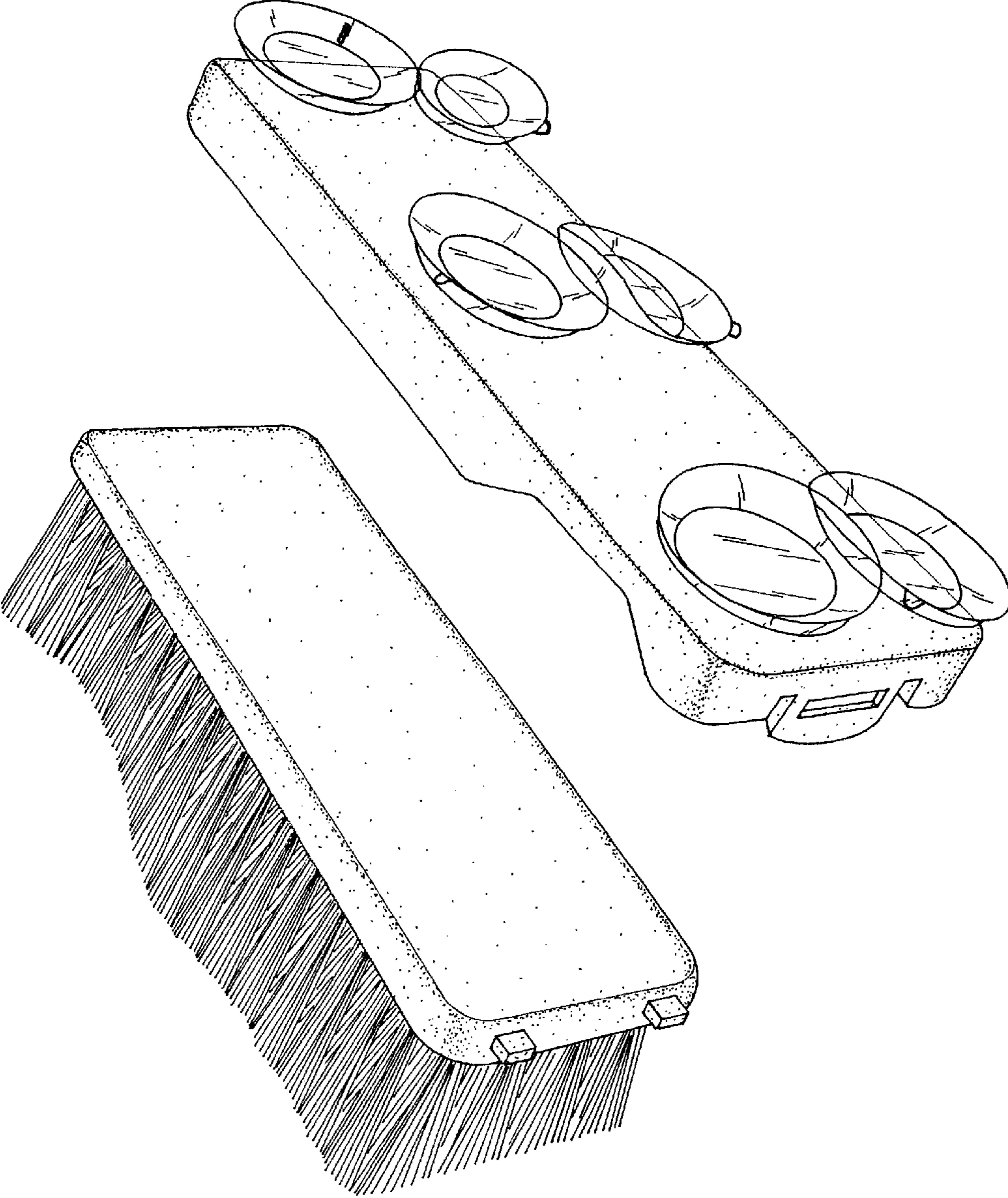

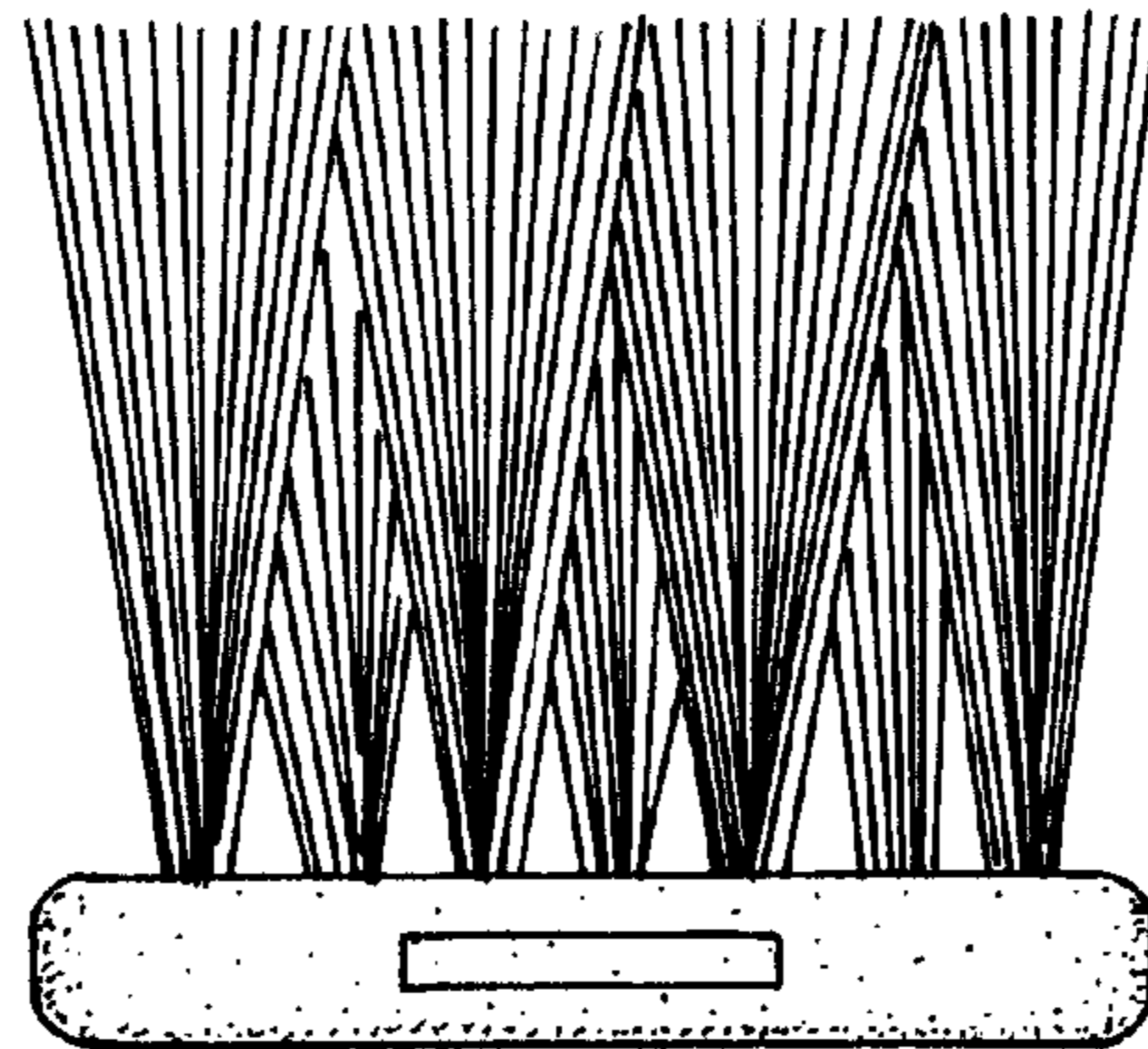

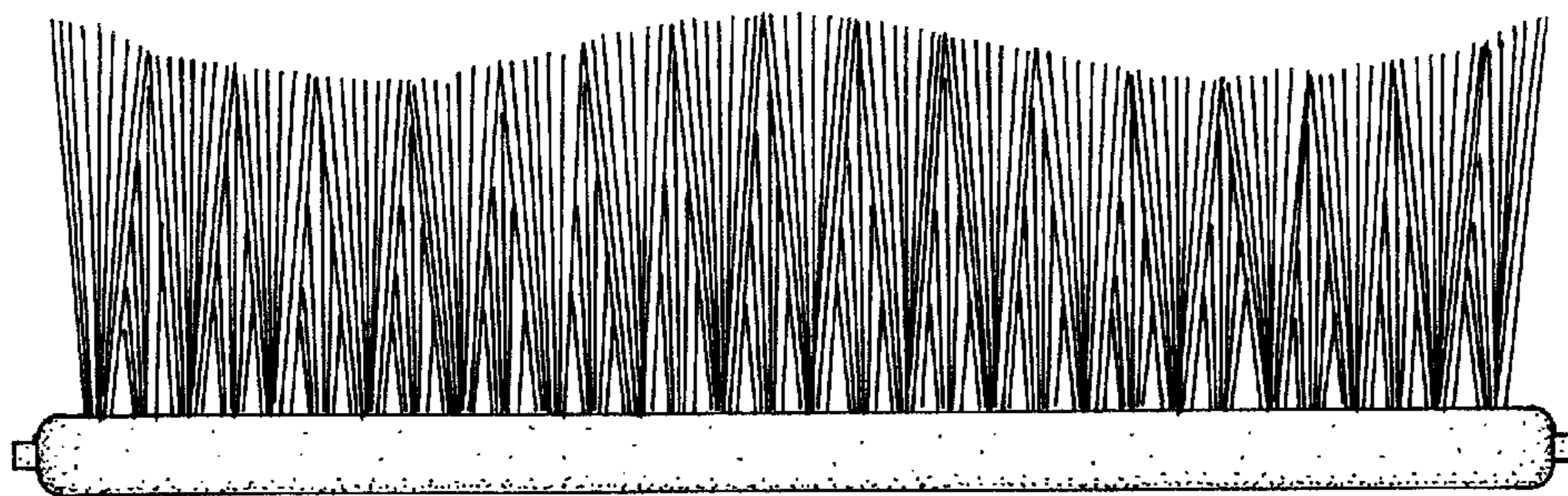

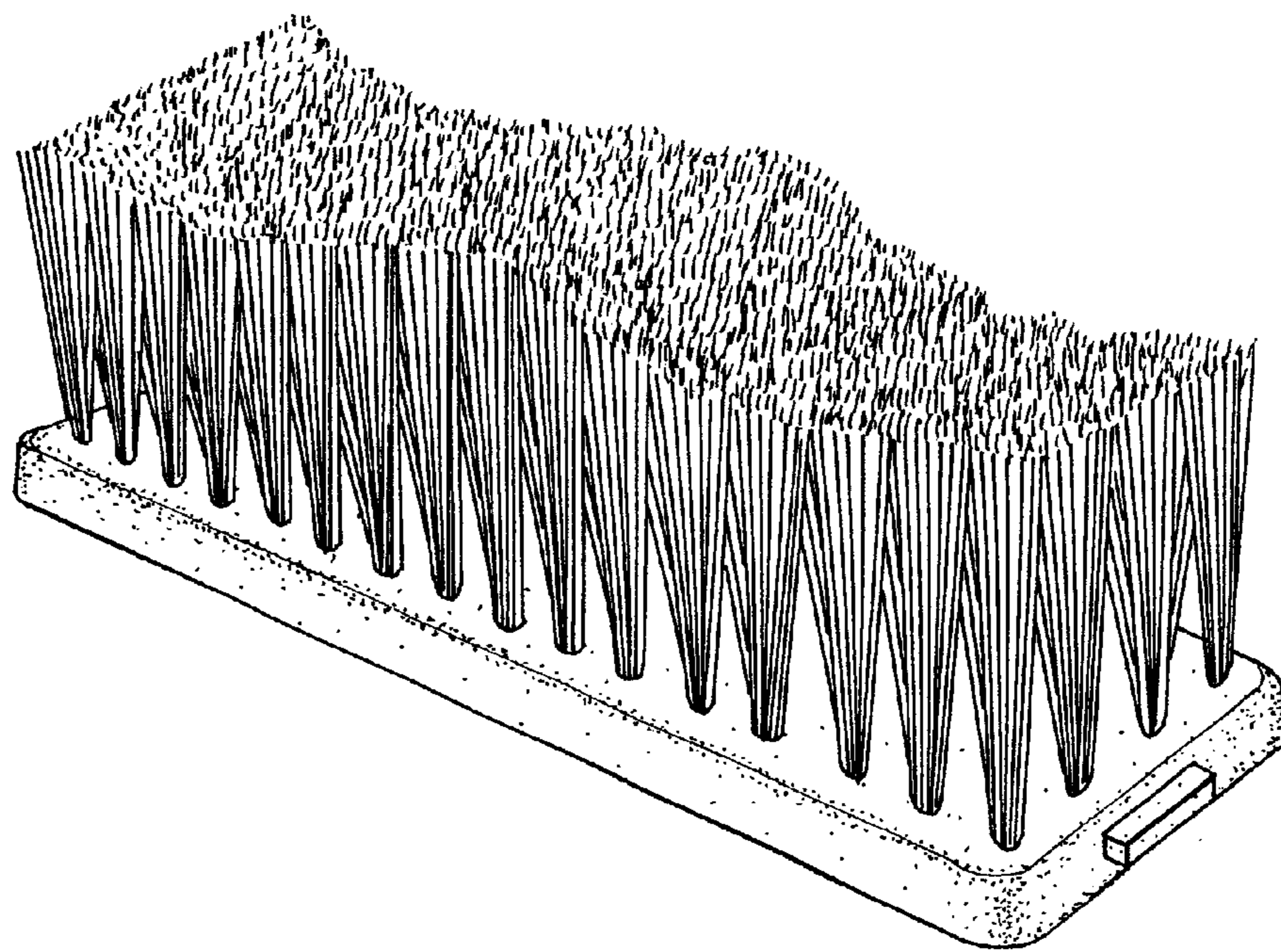

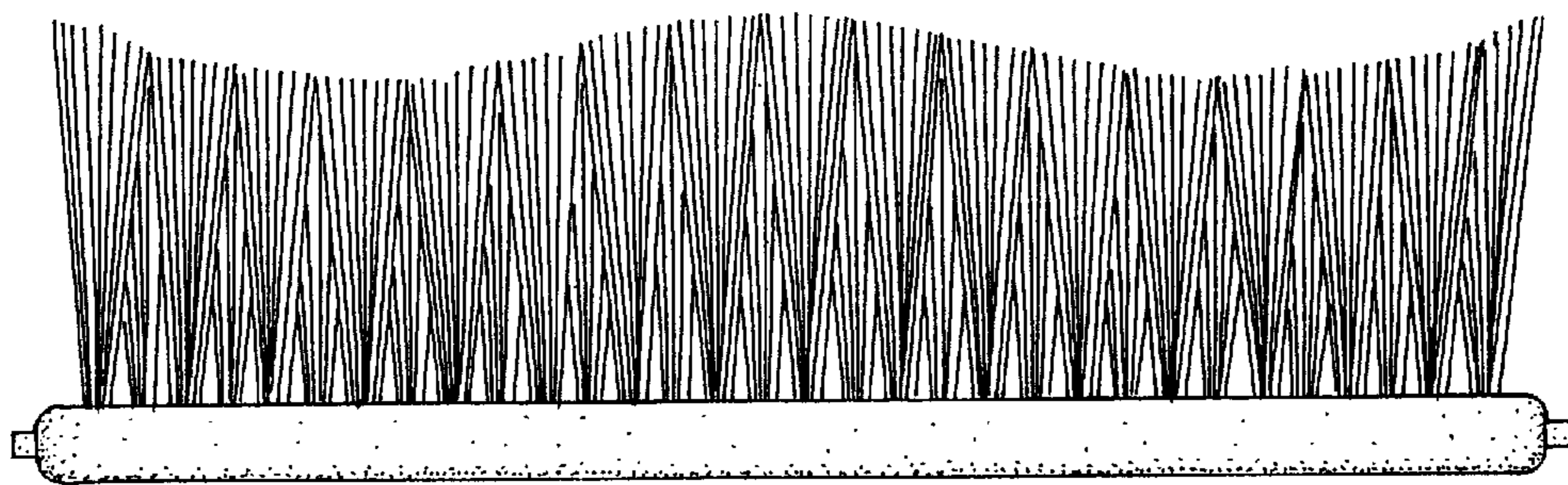

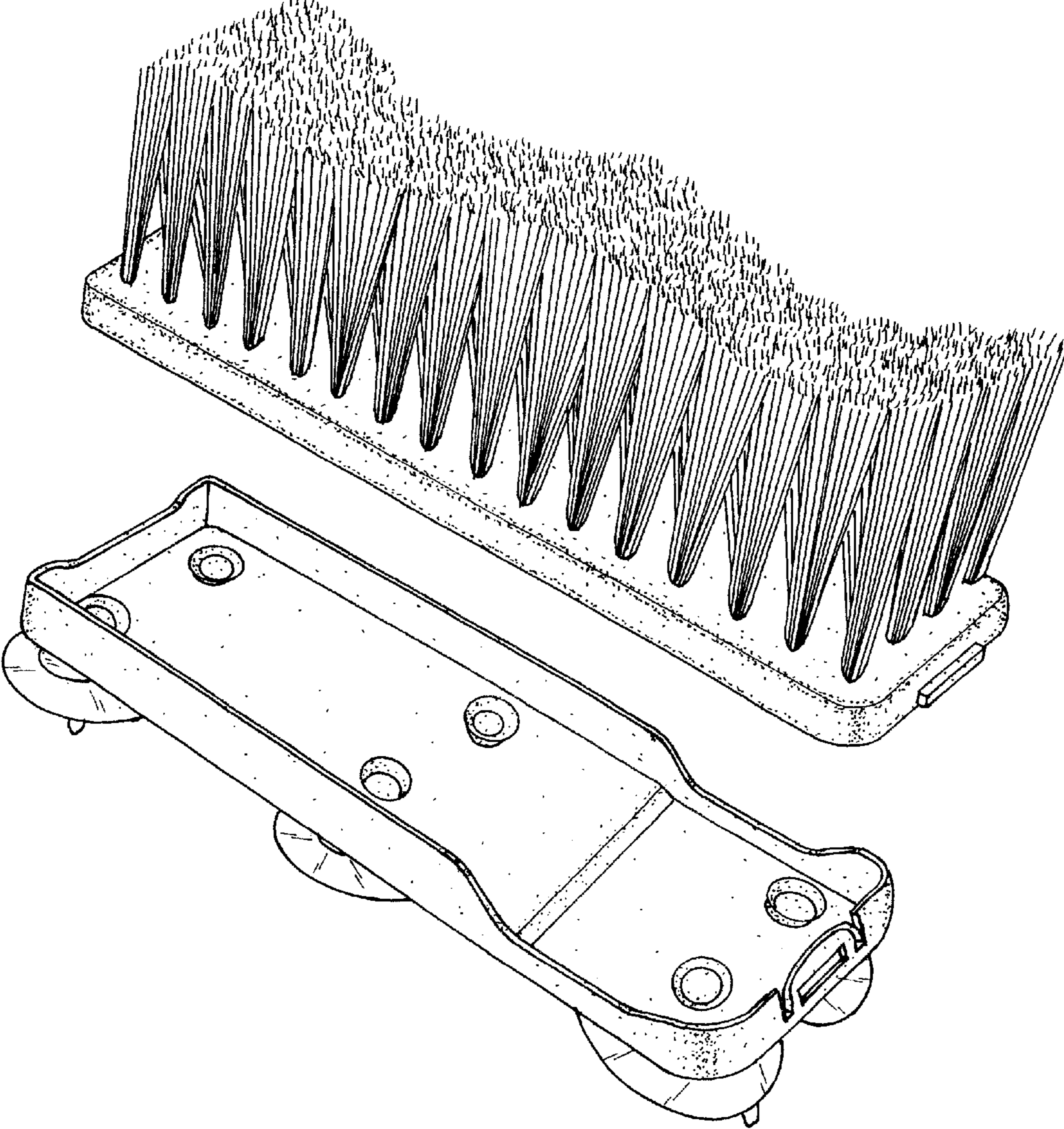

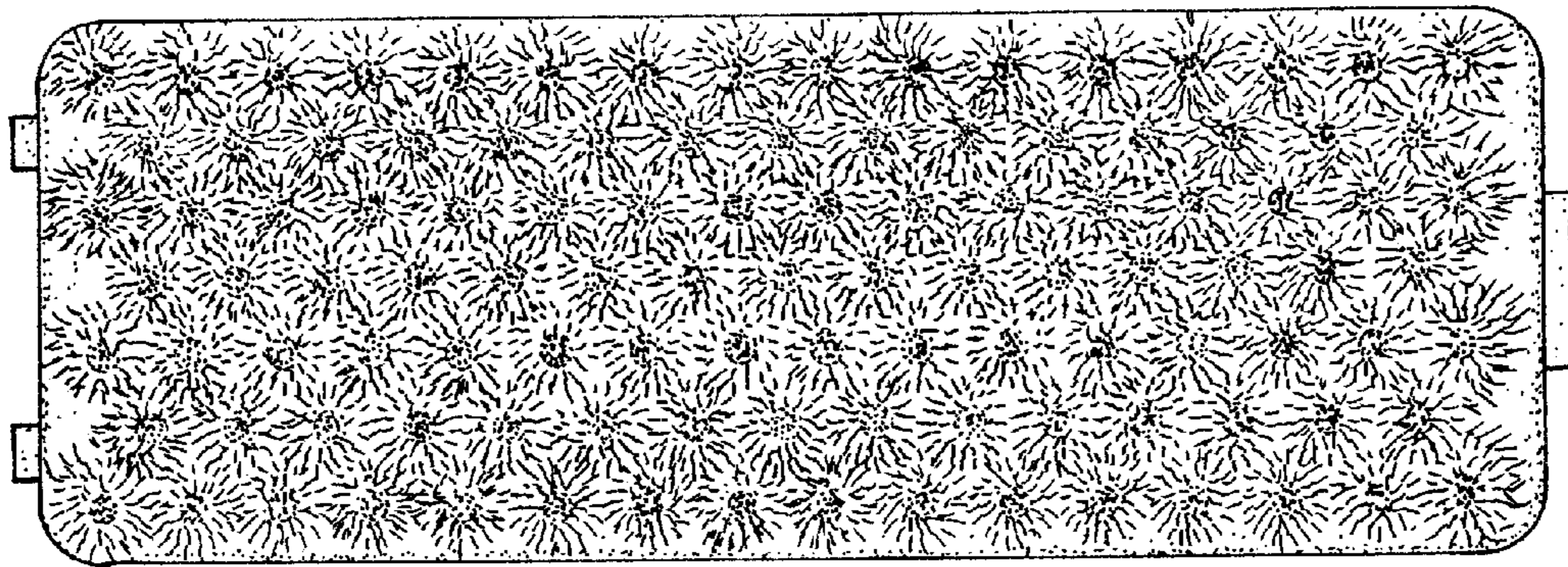
