FIG. 1 is a top plan view of a clothes hanger showing my new design;

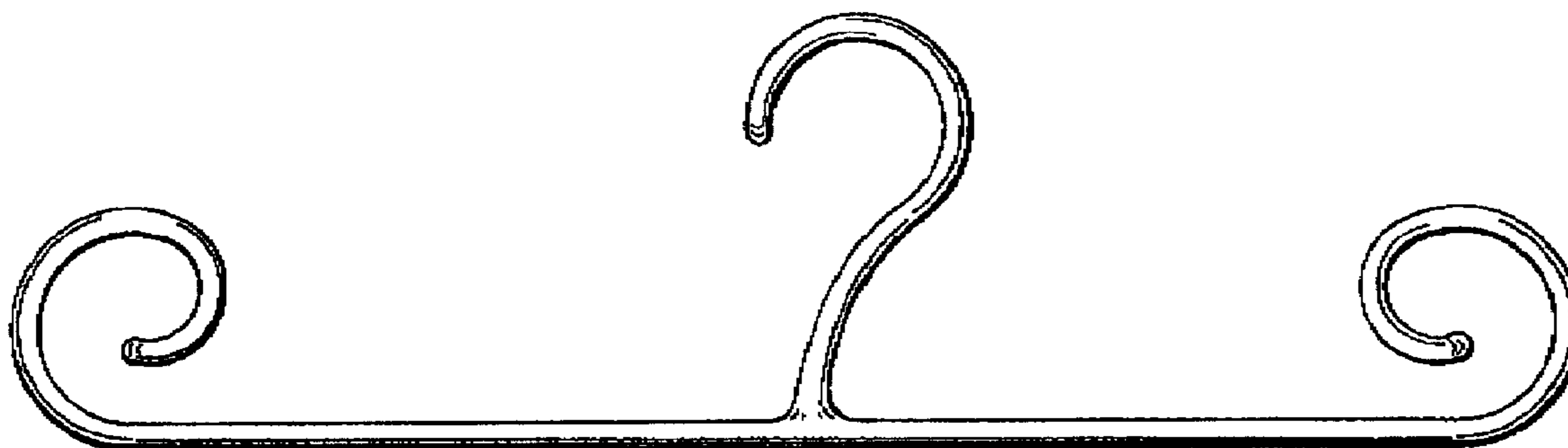
FIG. 2 is a left side elevational view thereof;

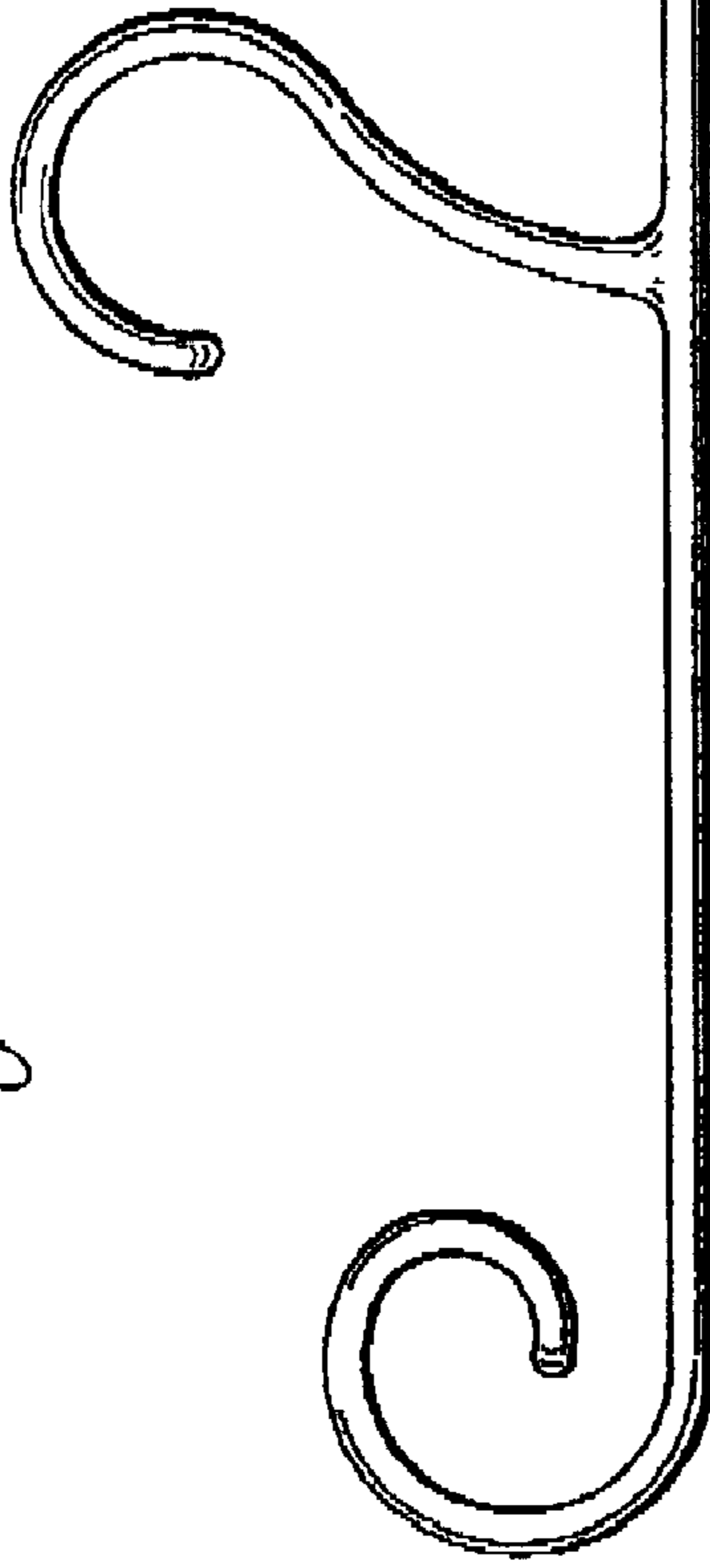
