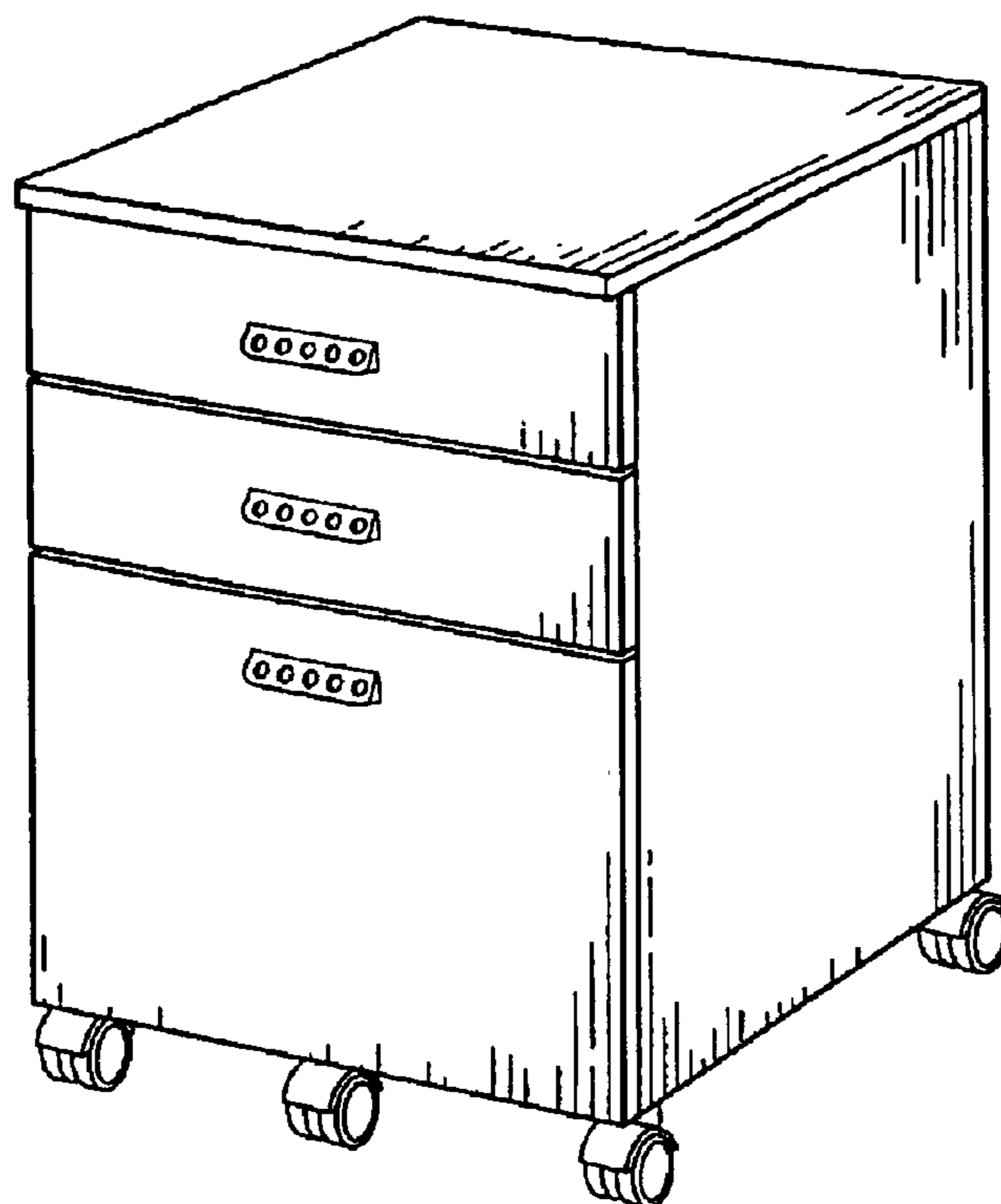
(57) **CLAIM**

I claim the ornamental design for a cabinet having drawers and wheels, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right perspective view of a cabinet having drawers and wheels embodying our new design.  
FIG. 2 is a front elevational view of the cabinet of FIG. 1.  
FIG. 3 is a rear elevational view of the cabinet of FIG. 1.  
FIG. 4 is a left side elevational view of the cabinet of FIG. 1.  
FIG. 5 is a right side elevational view of the cabinet of FIG. 1.  
FIG. 6 is a top plan view of the cabinet of FIG. 1; and,  
FIG. 7 is a bottom plan view of the cabinet of FIG. 1.

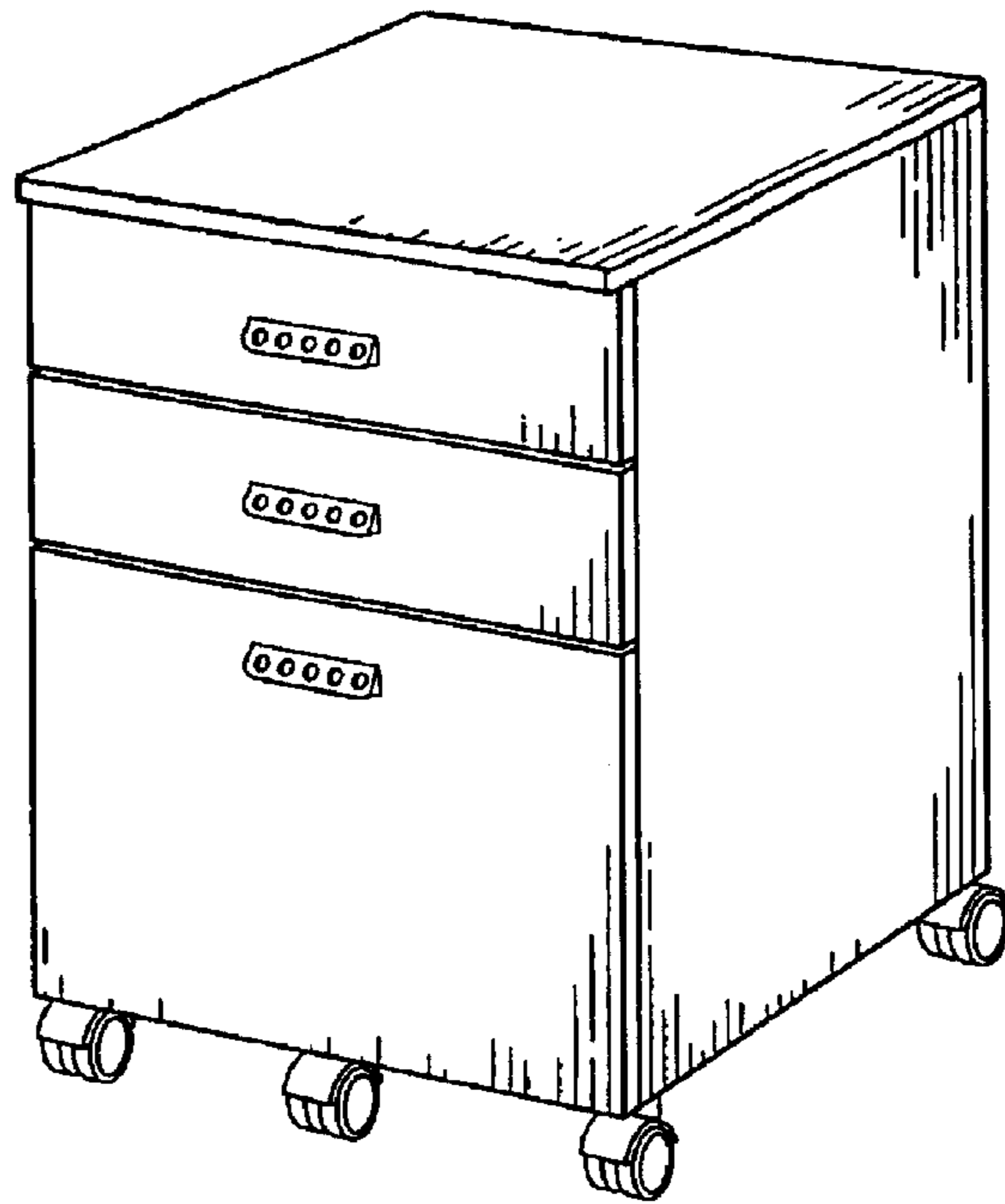

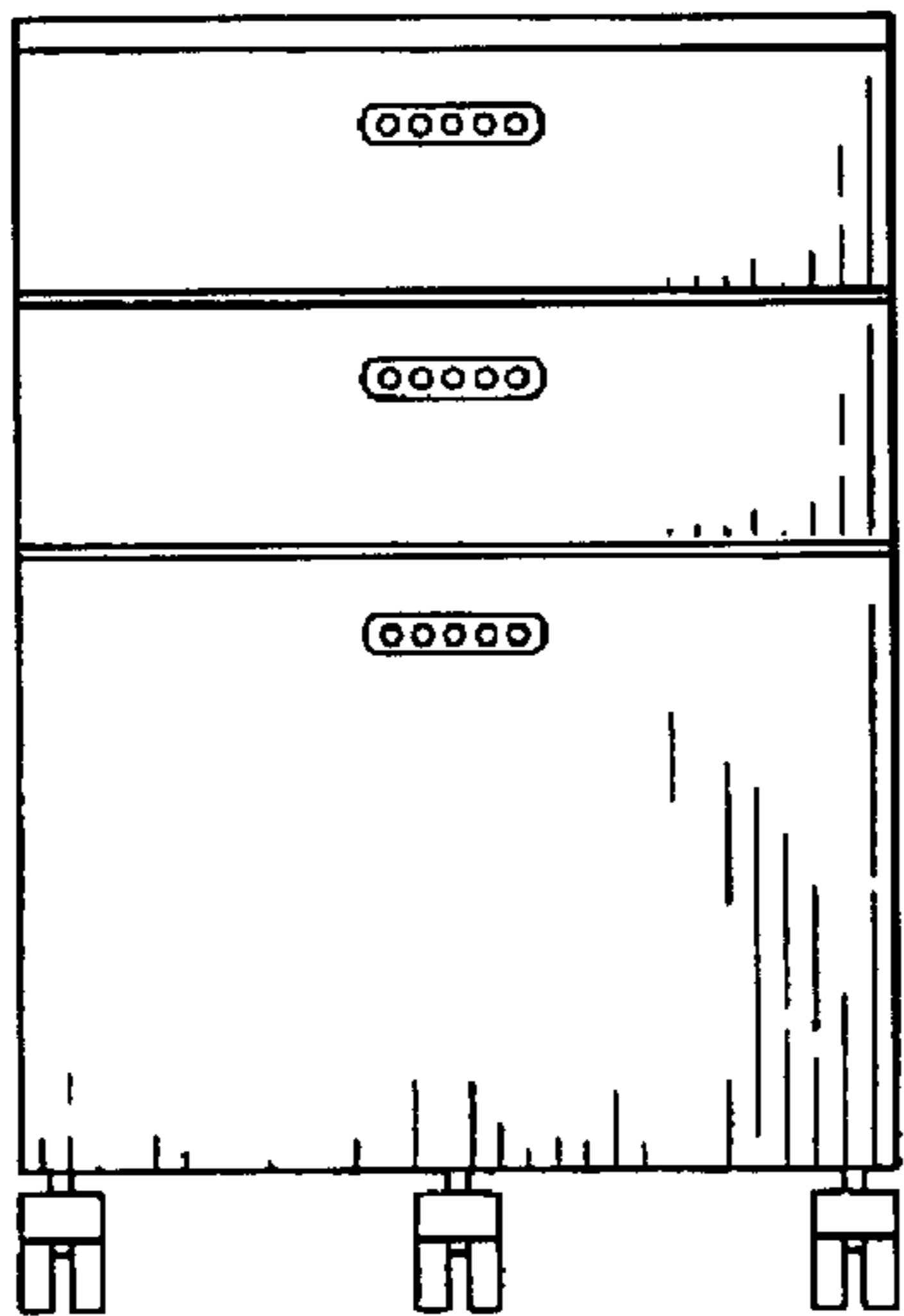

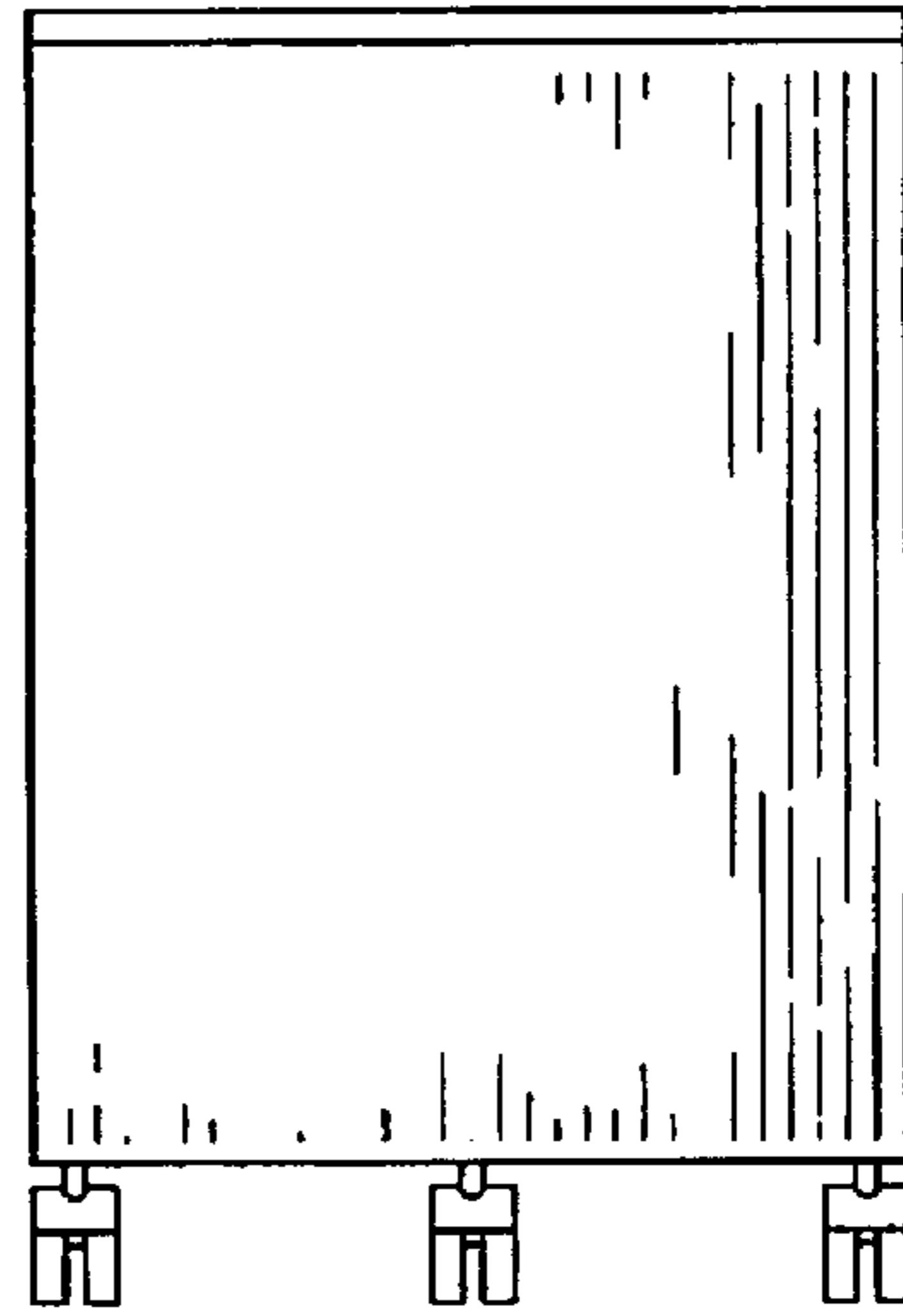
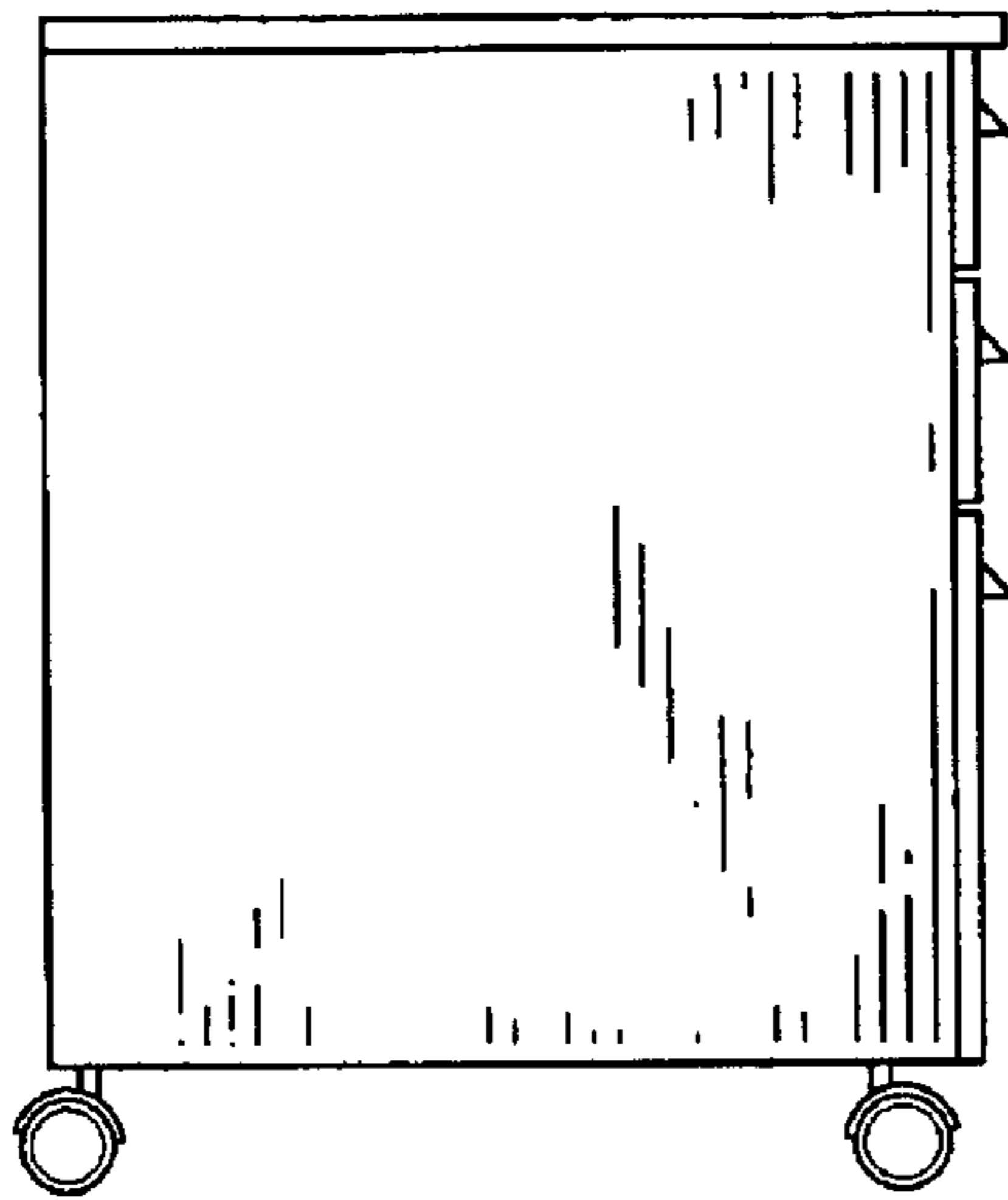
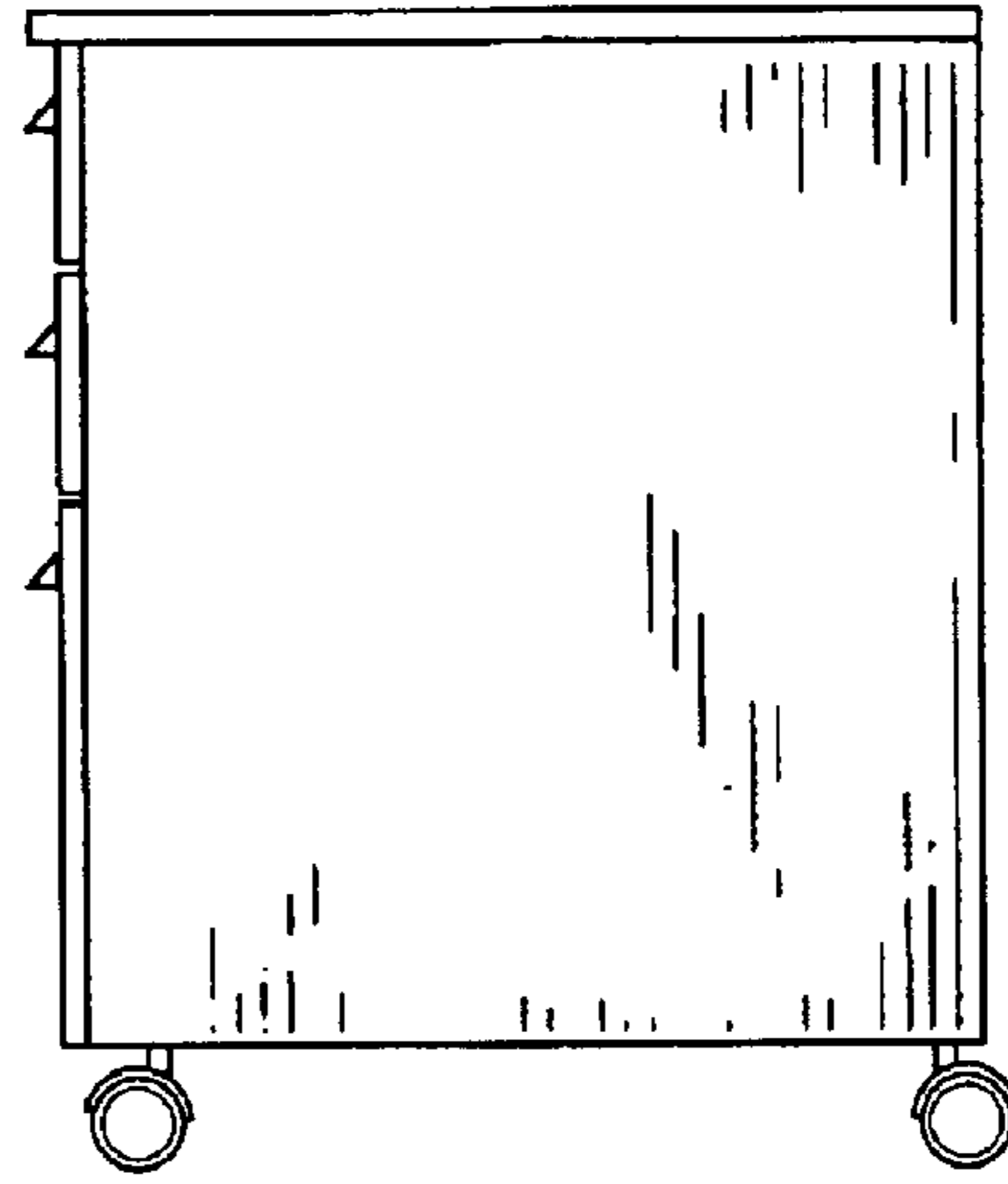


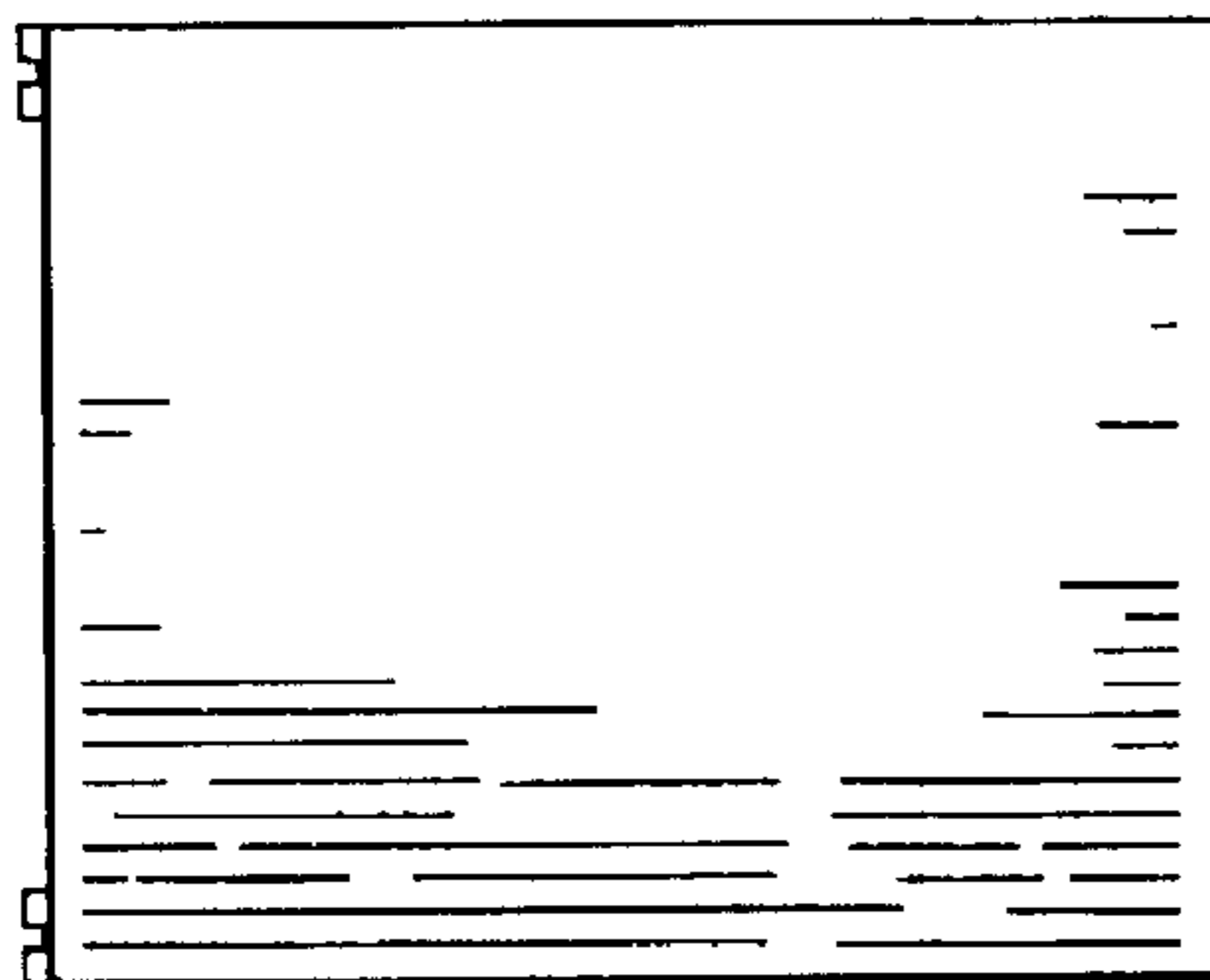

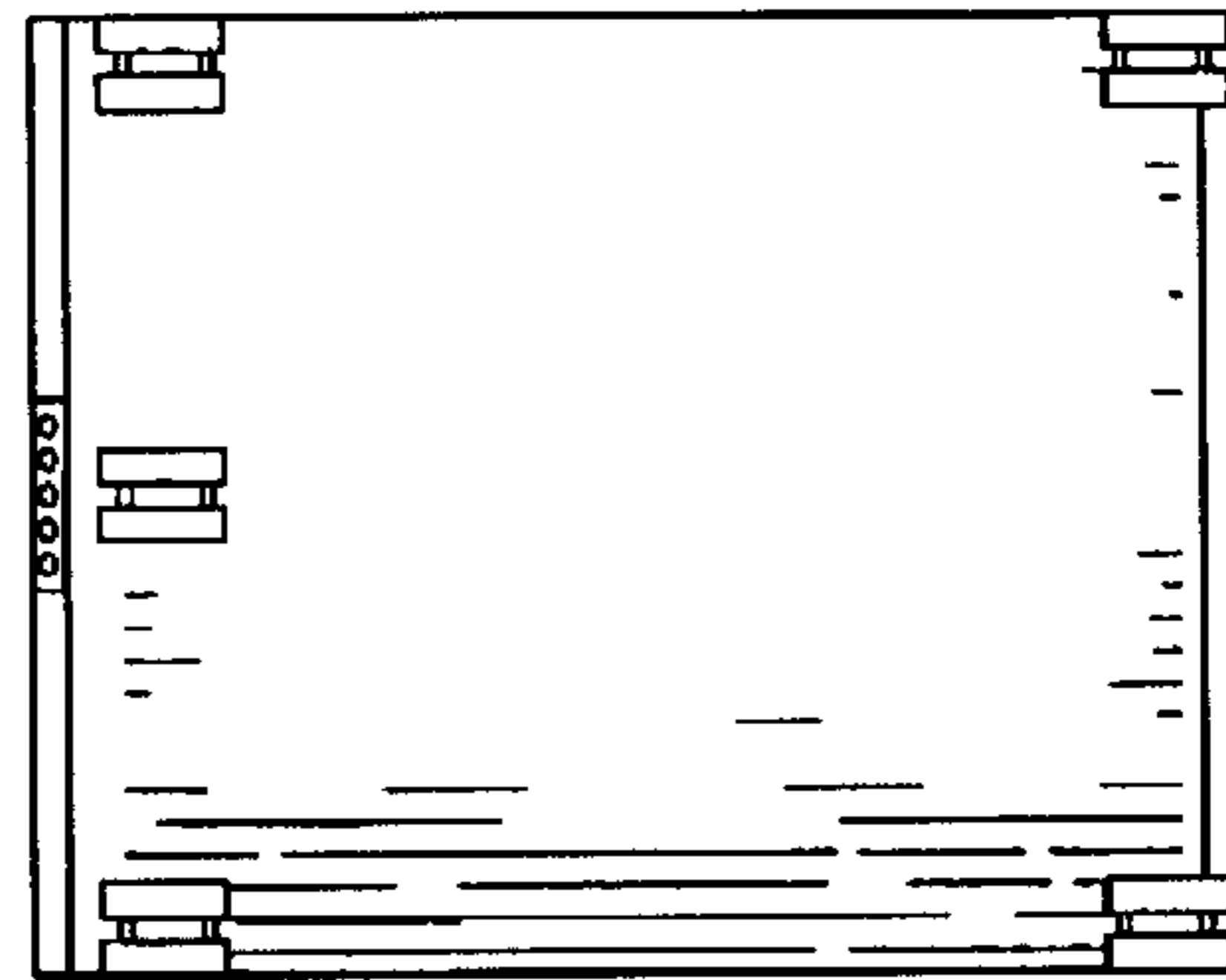
