FIG. 6 is a bottom view of the pearlescent honeycomb blind of FIG. 1.

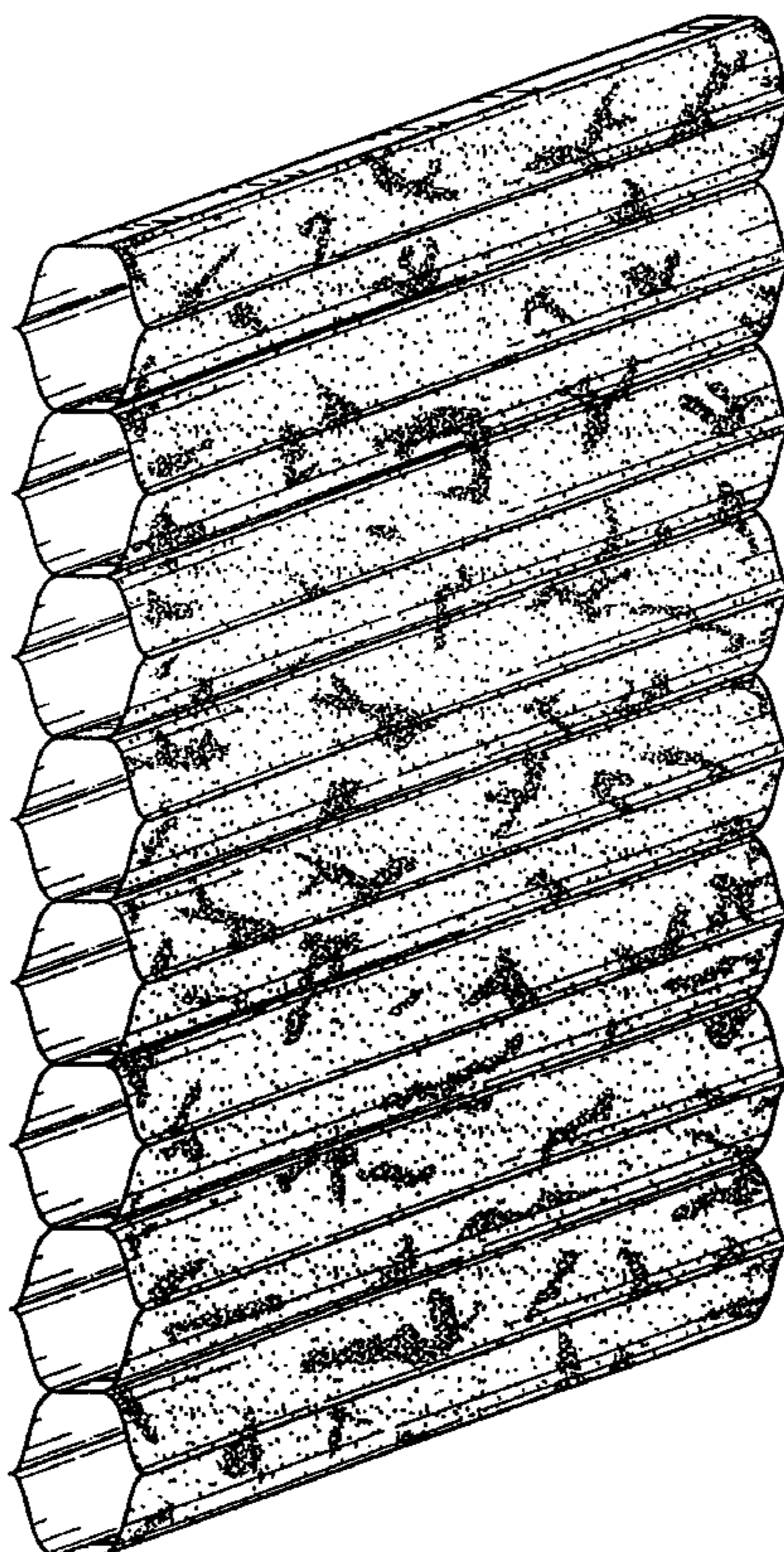

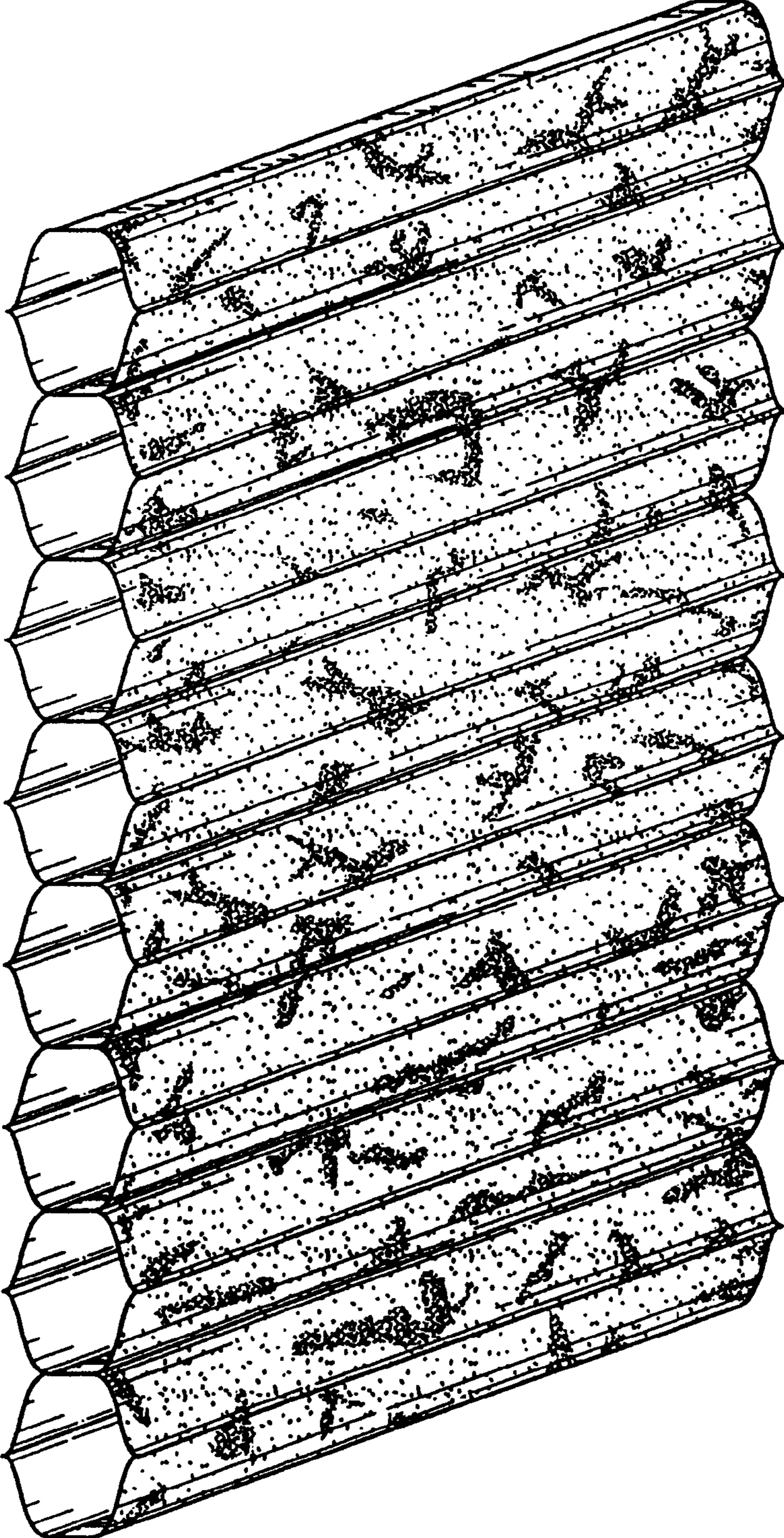

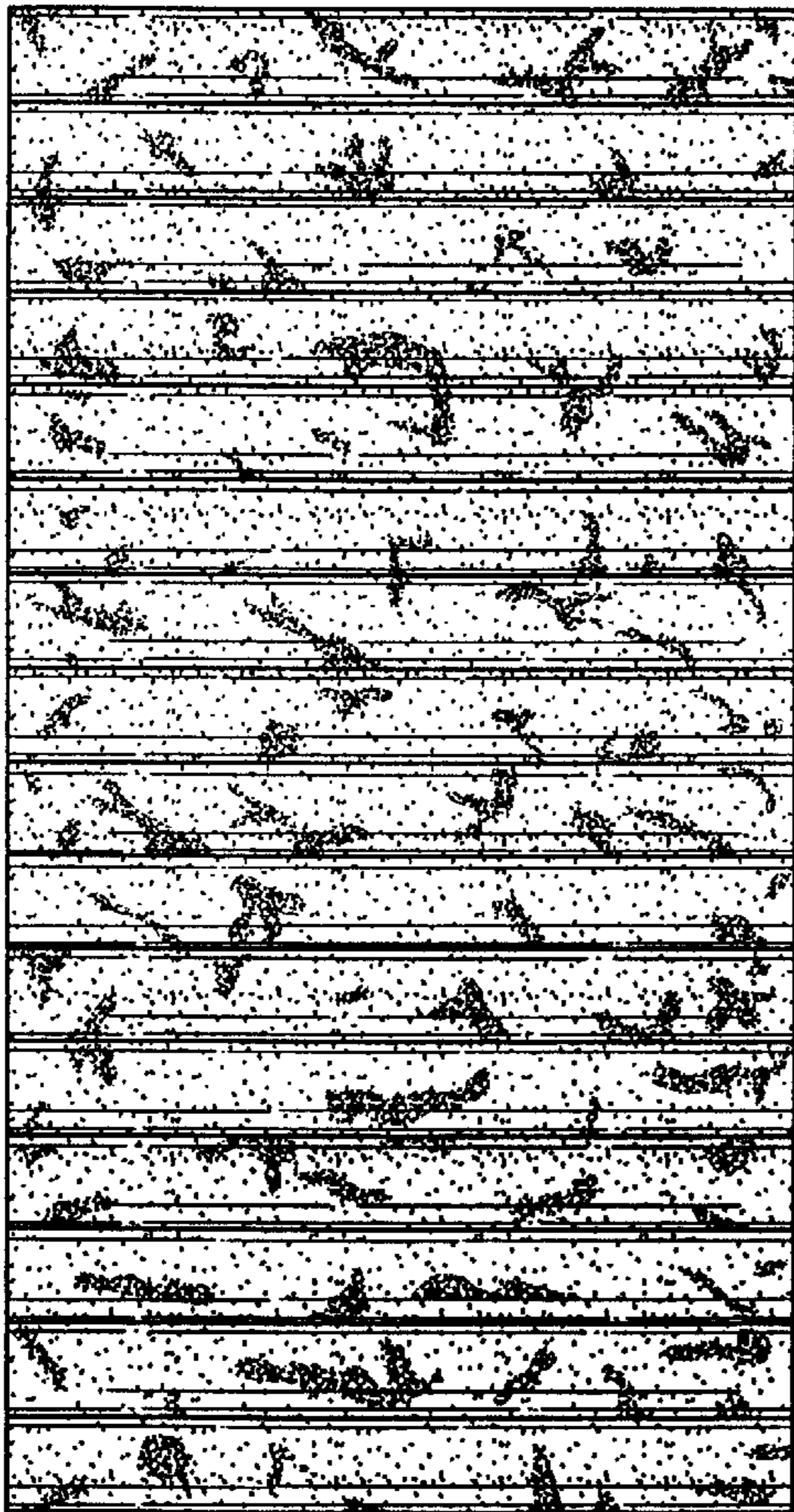

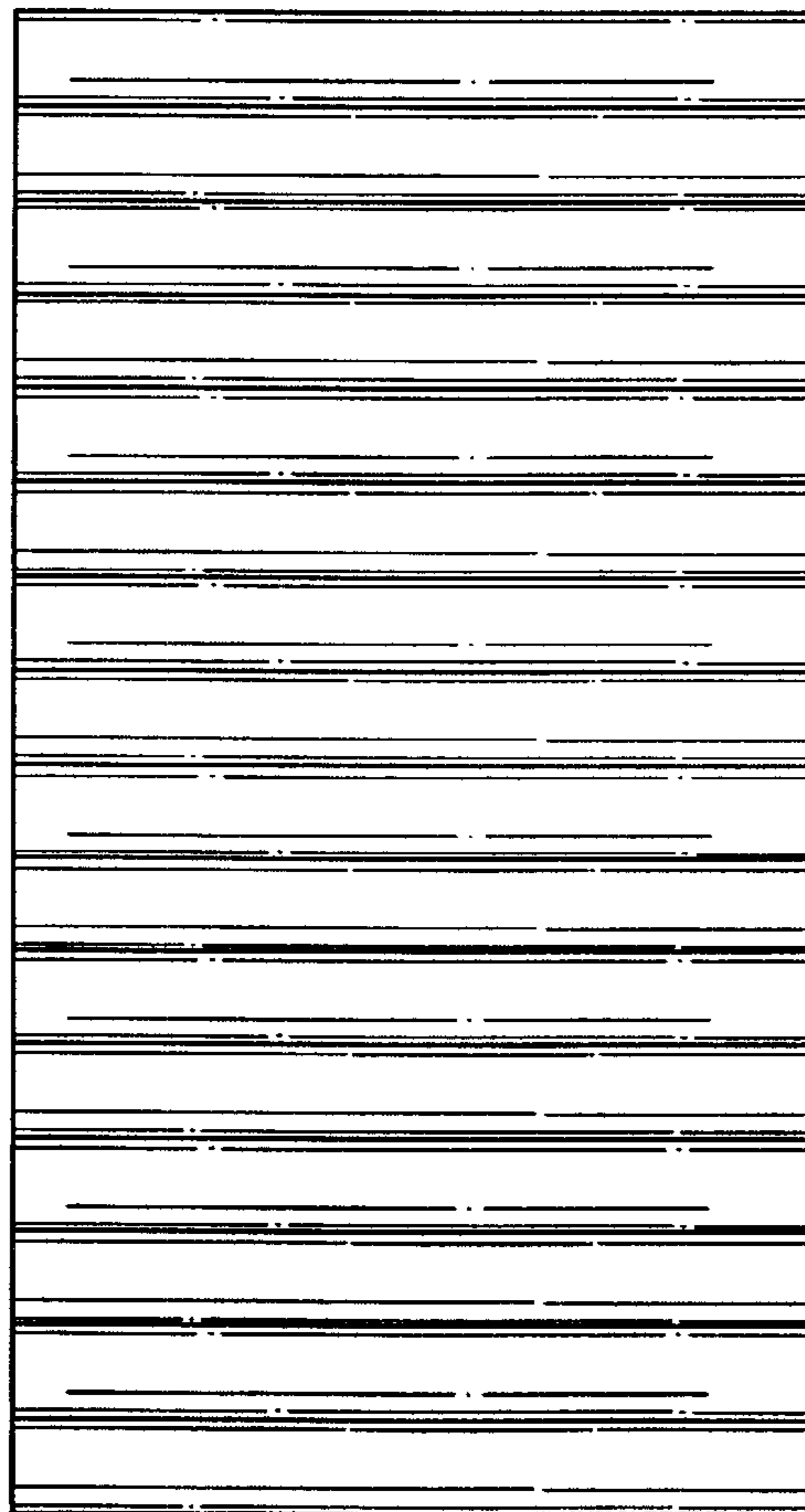

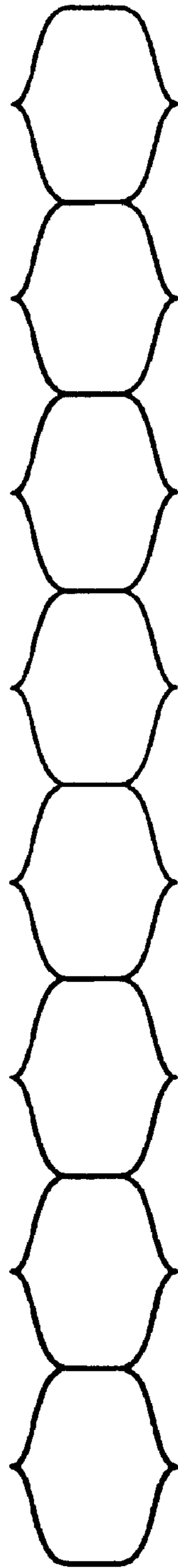

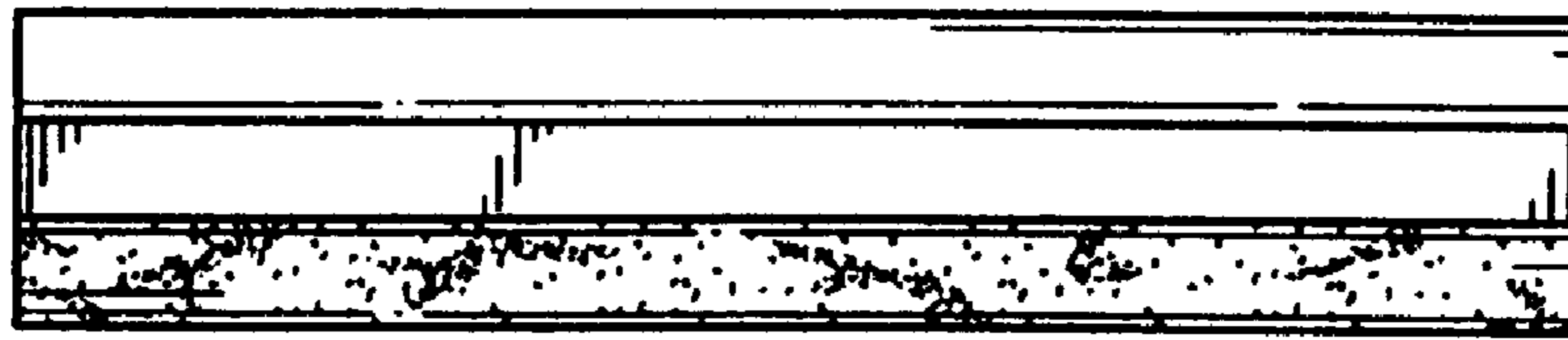

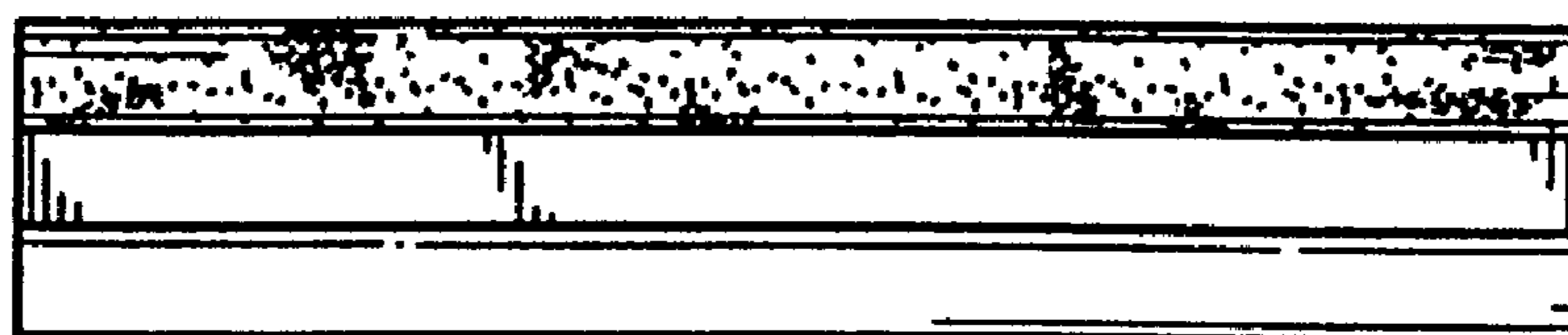
