(57) **CLAIM**

I claim the ornamental design for a drinking vessel with handle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a drinking vessel with handle in accordance with the present invention;  
 FIG. 2 is a right side elevational view thereof;  
 FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image thereof;  
 FIG. 4 is a left side elevational view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a perspective view of a drinking vessel with handle showing a second embodiment of my new design; and,  
 FIG. 8 is a top plan view thereof, all other sides of the second embodiment not shown are the same as that of the first embodiment.

The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

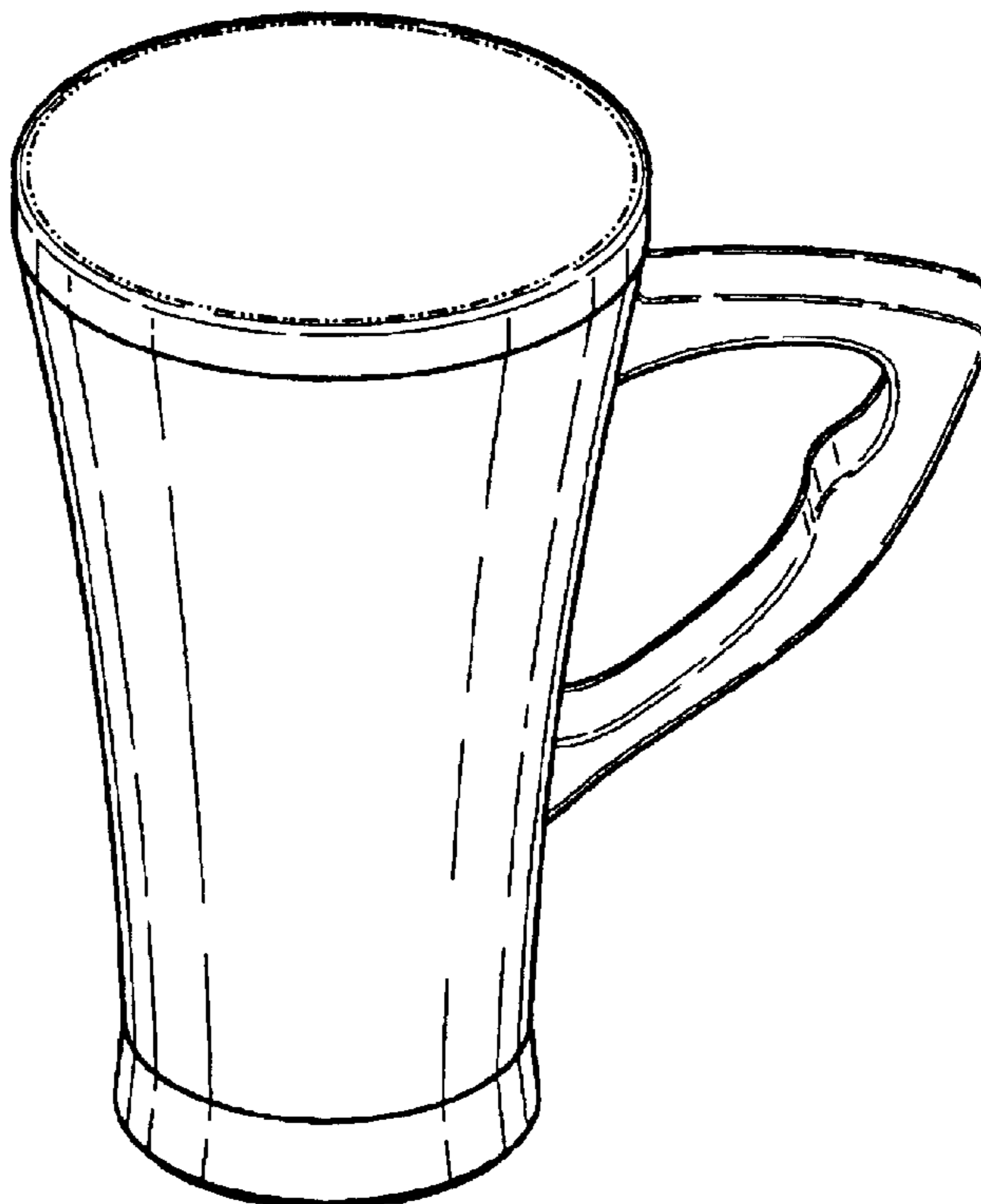

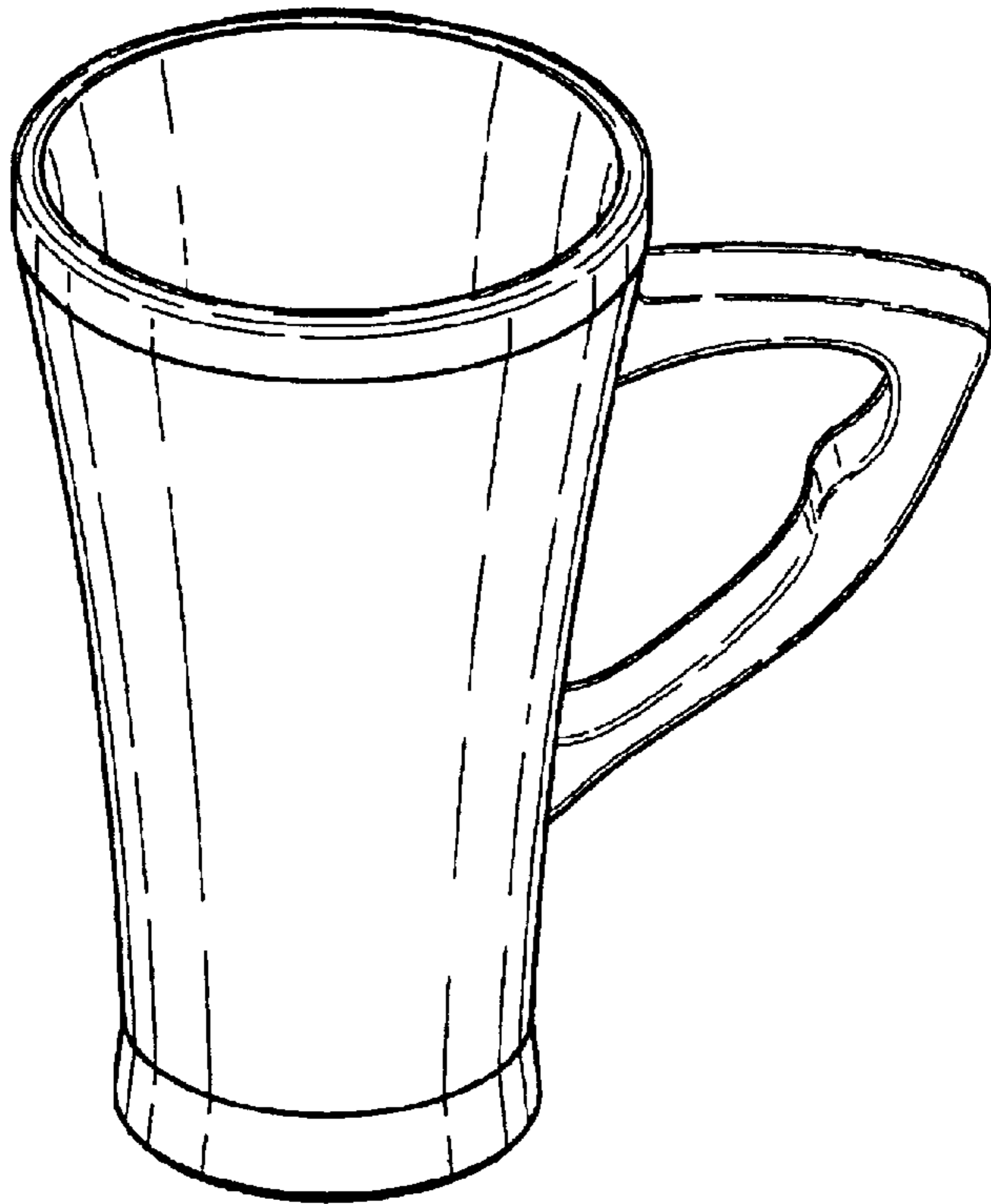

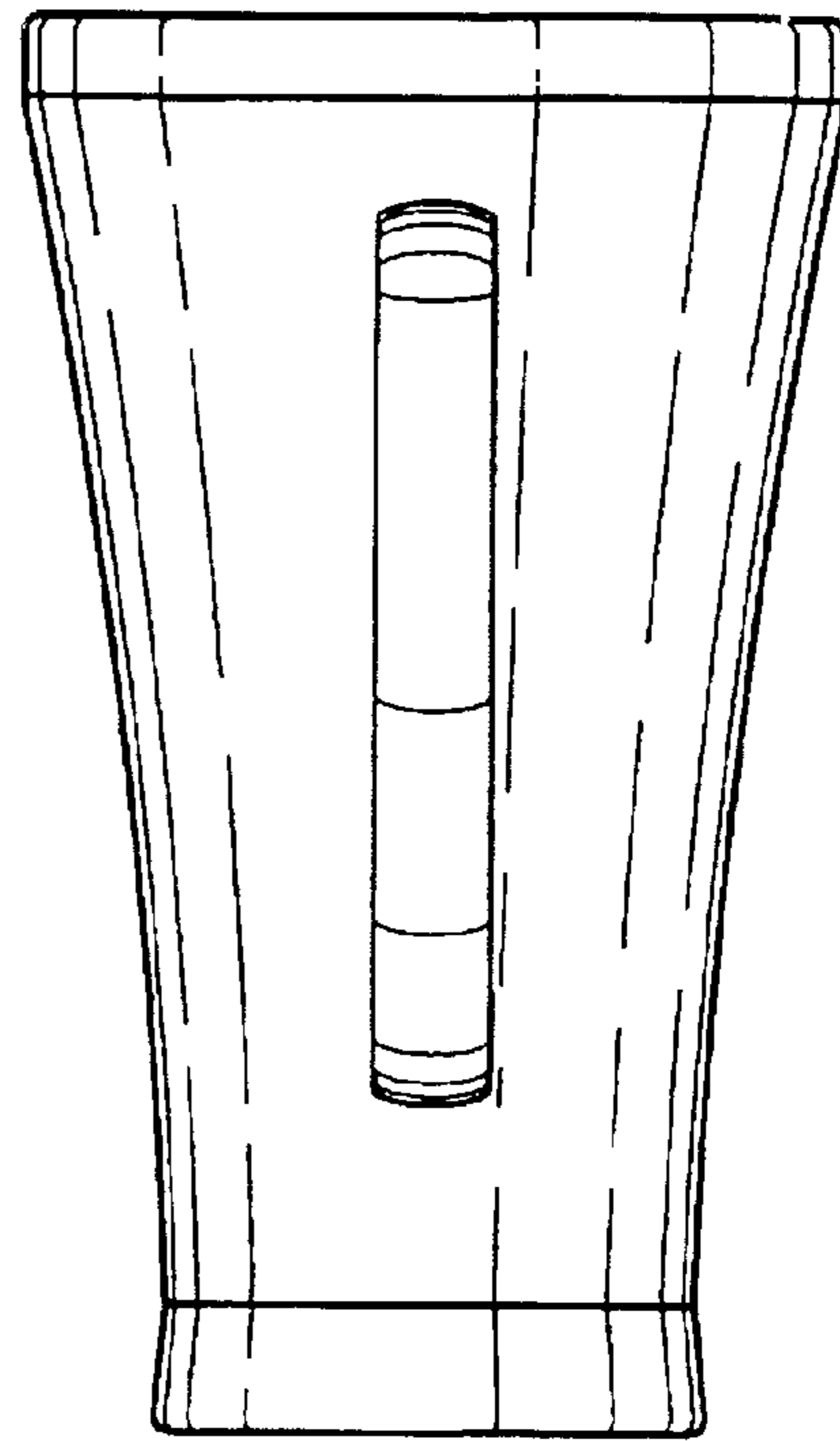

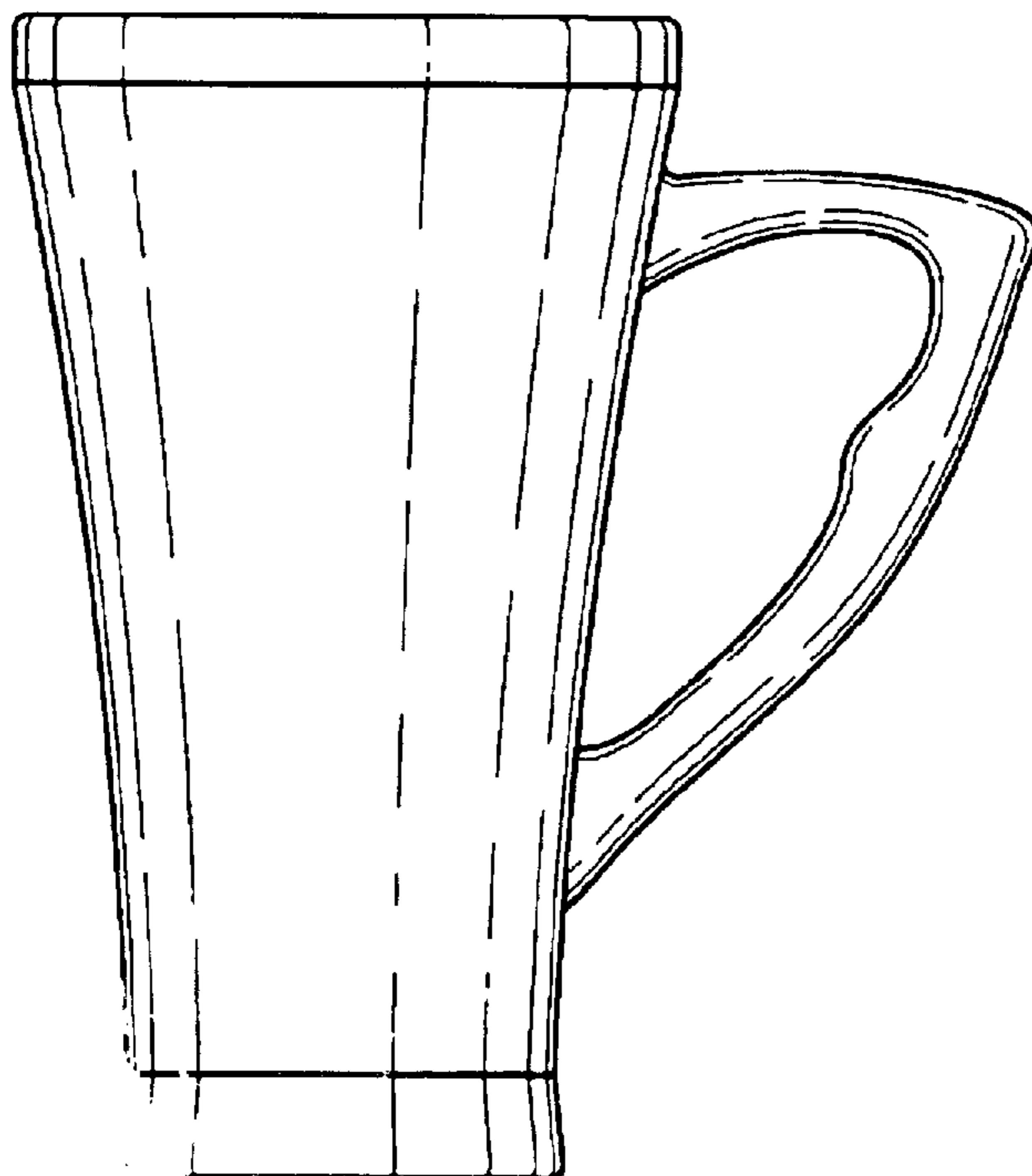

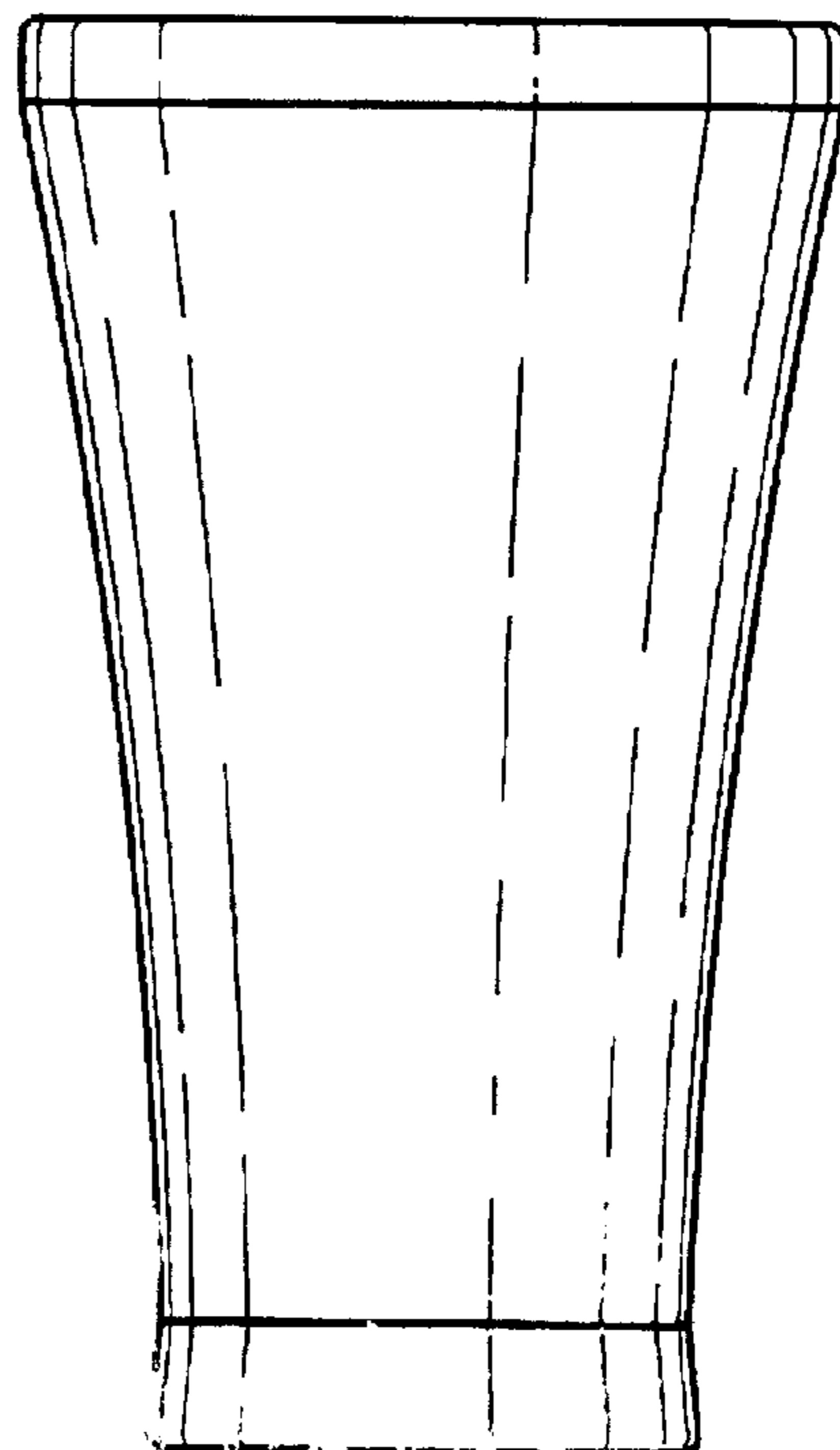

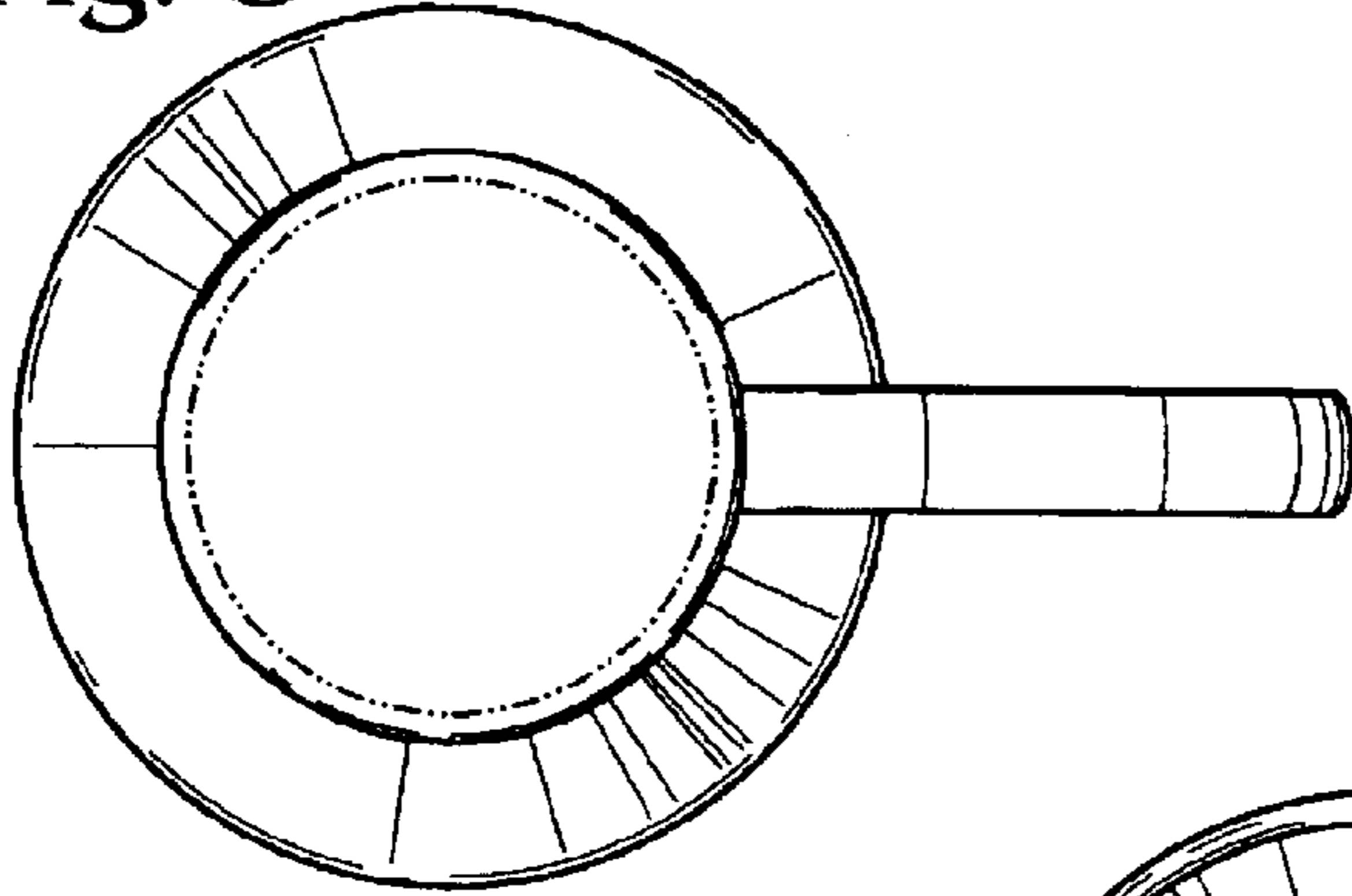

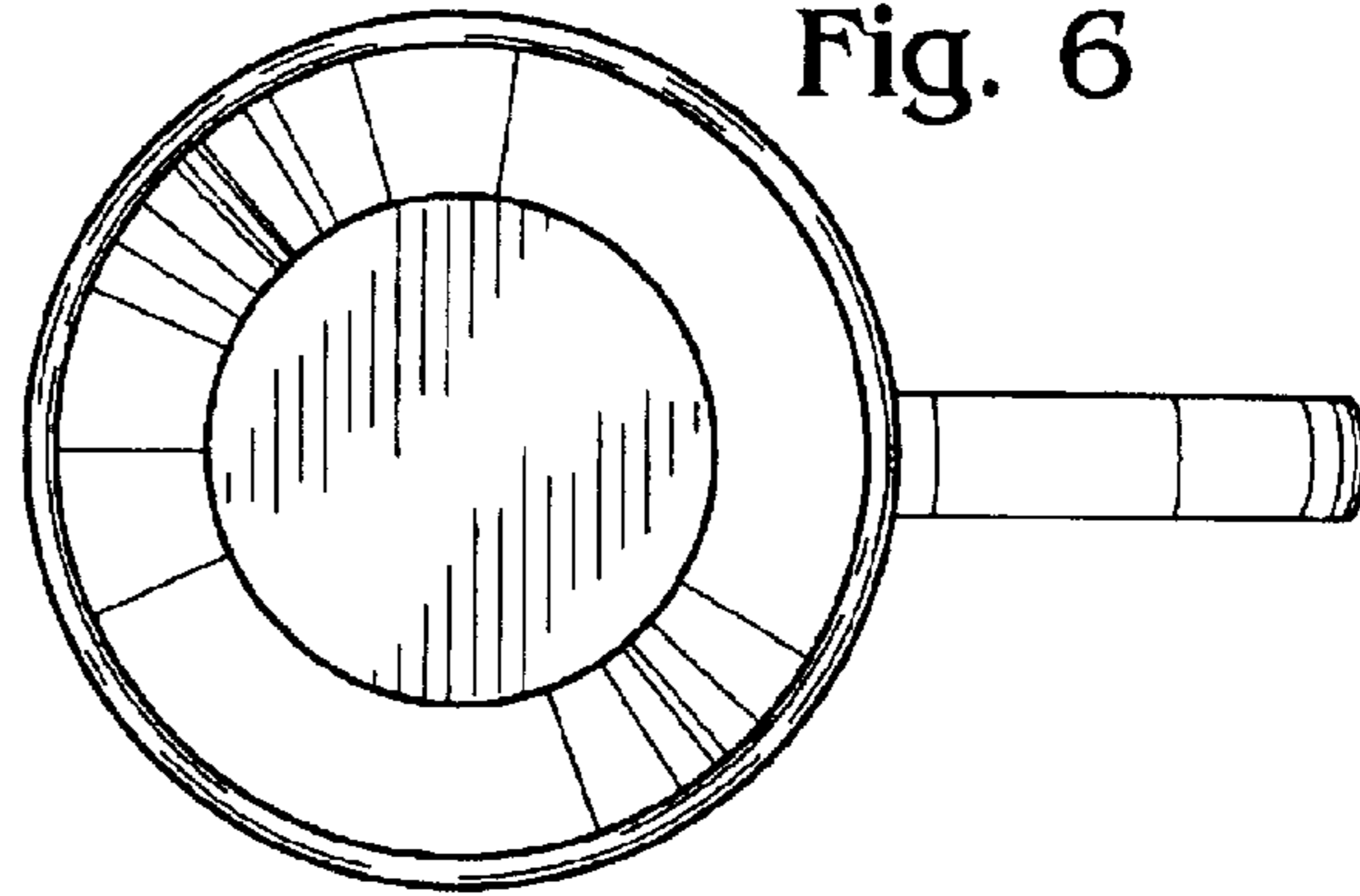

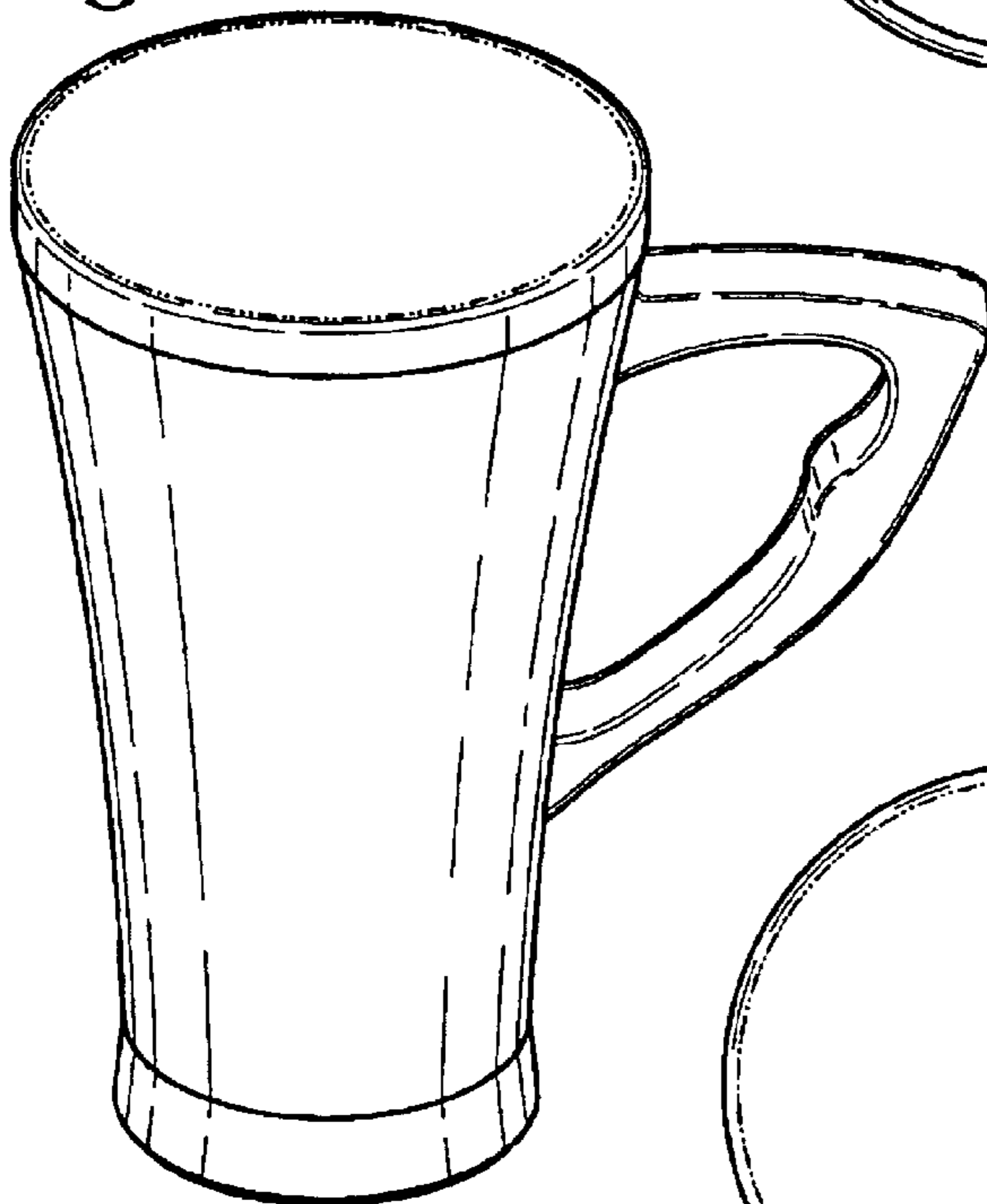
