DESCRIPTION

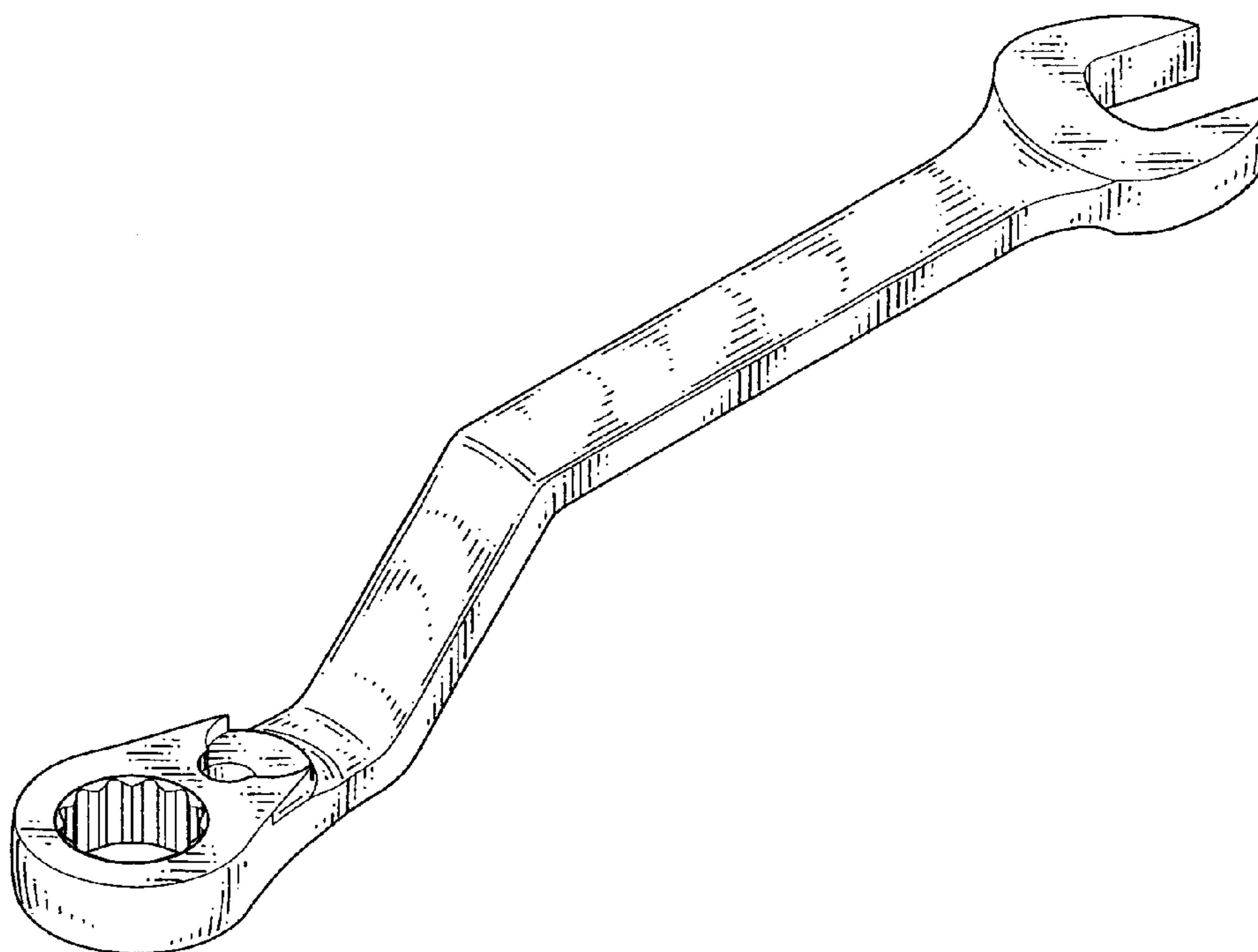
FIG. 1 is a perspective view of a ratchet wrench showing my new design;

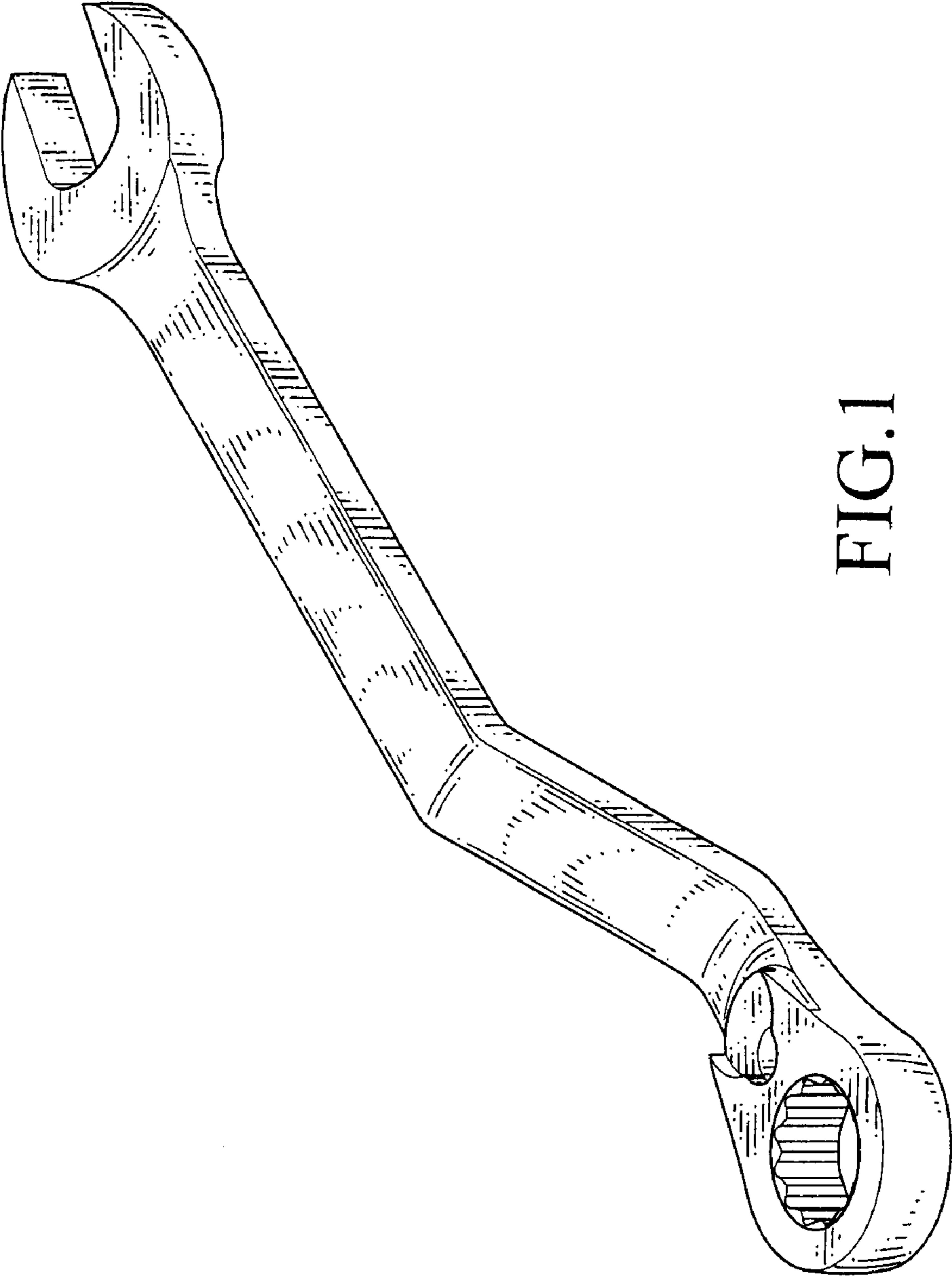

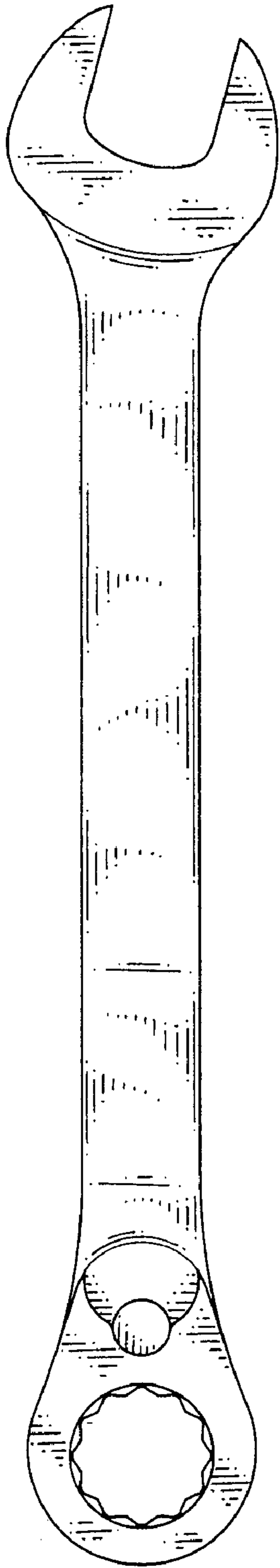

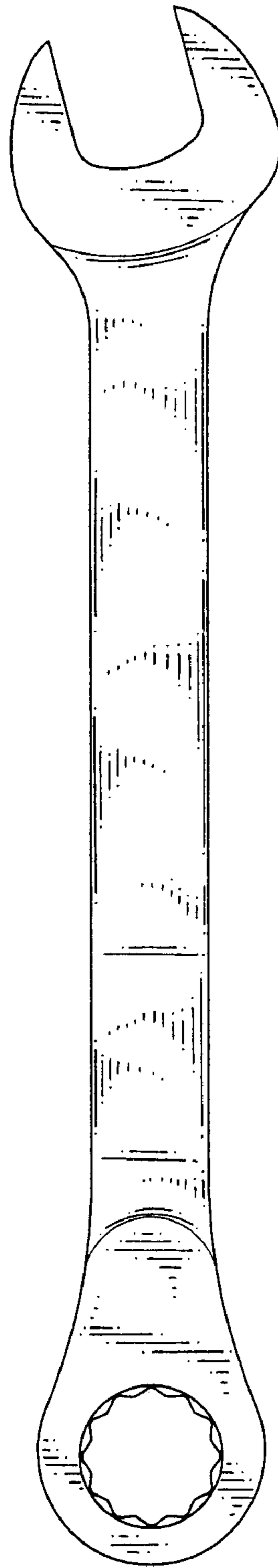
