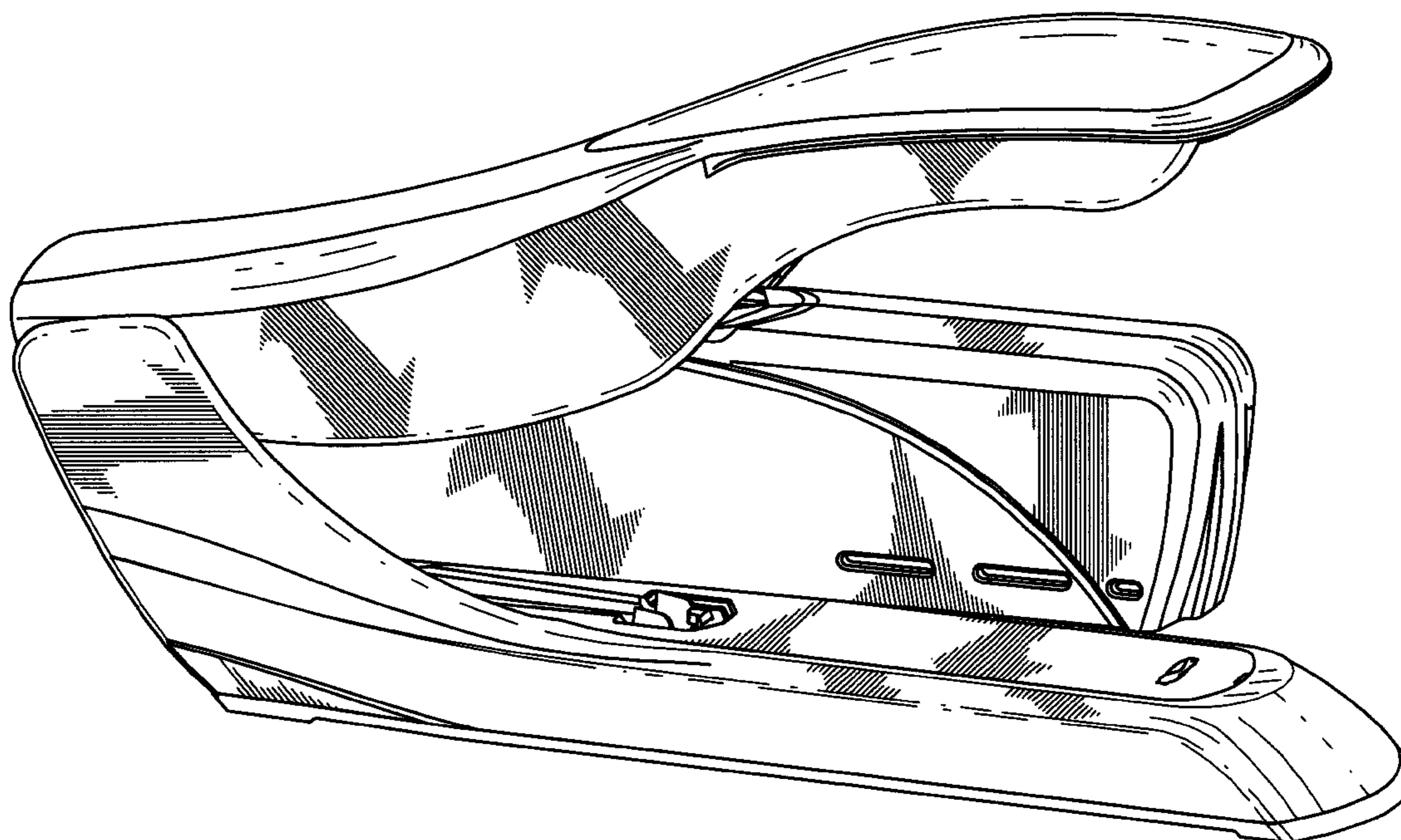
FIG. 3 is a right side elevational view showing our new design;

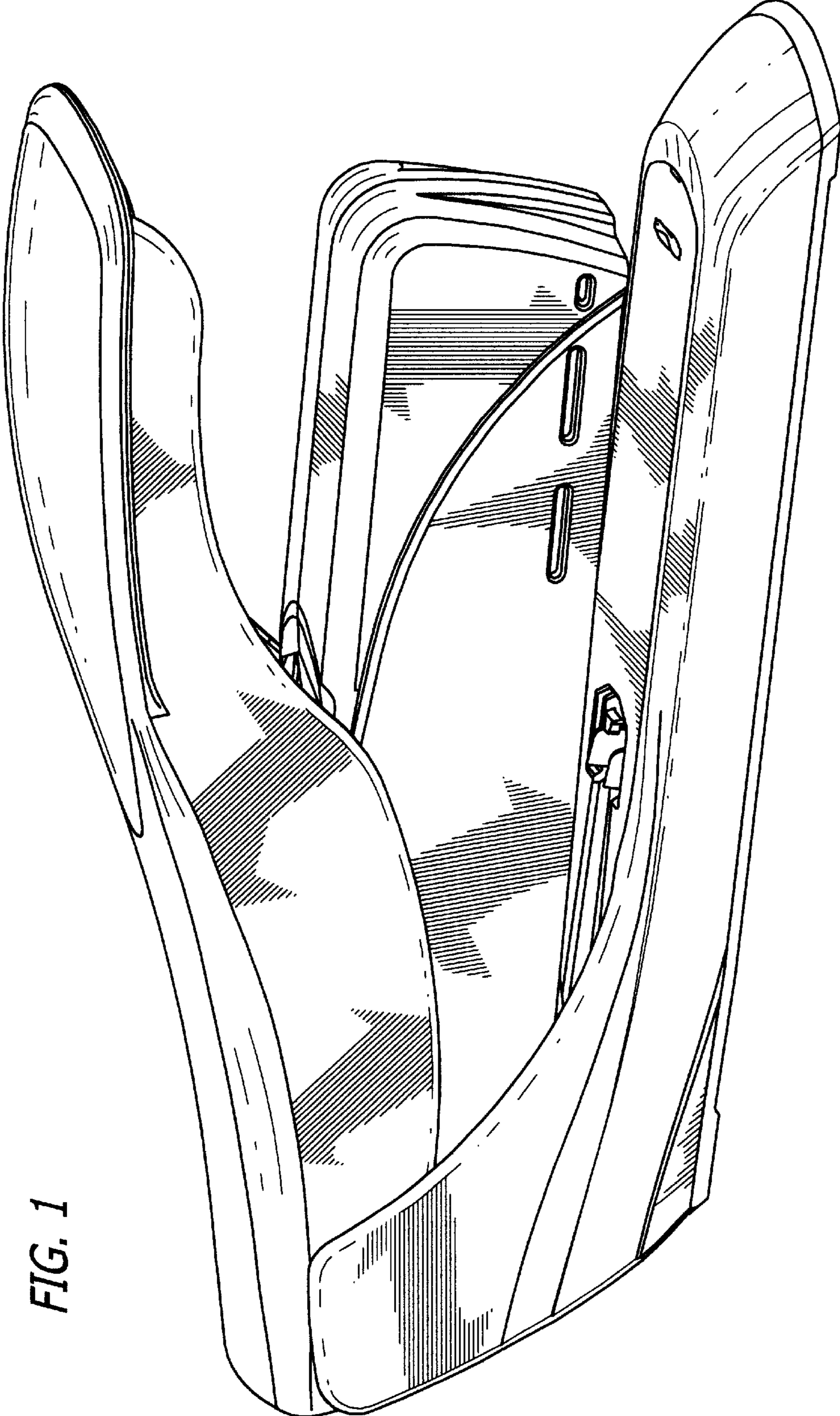

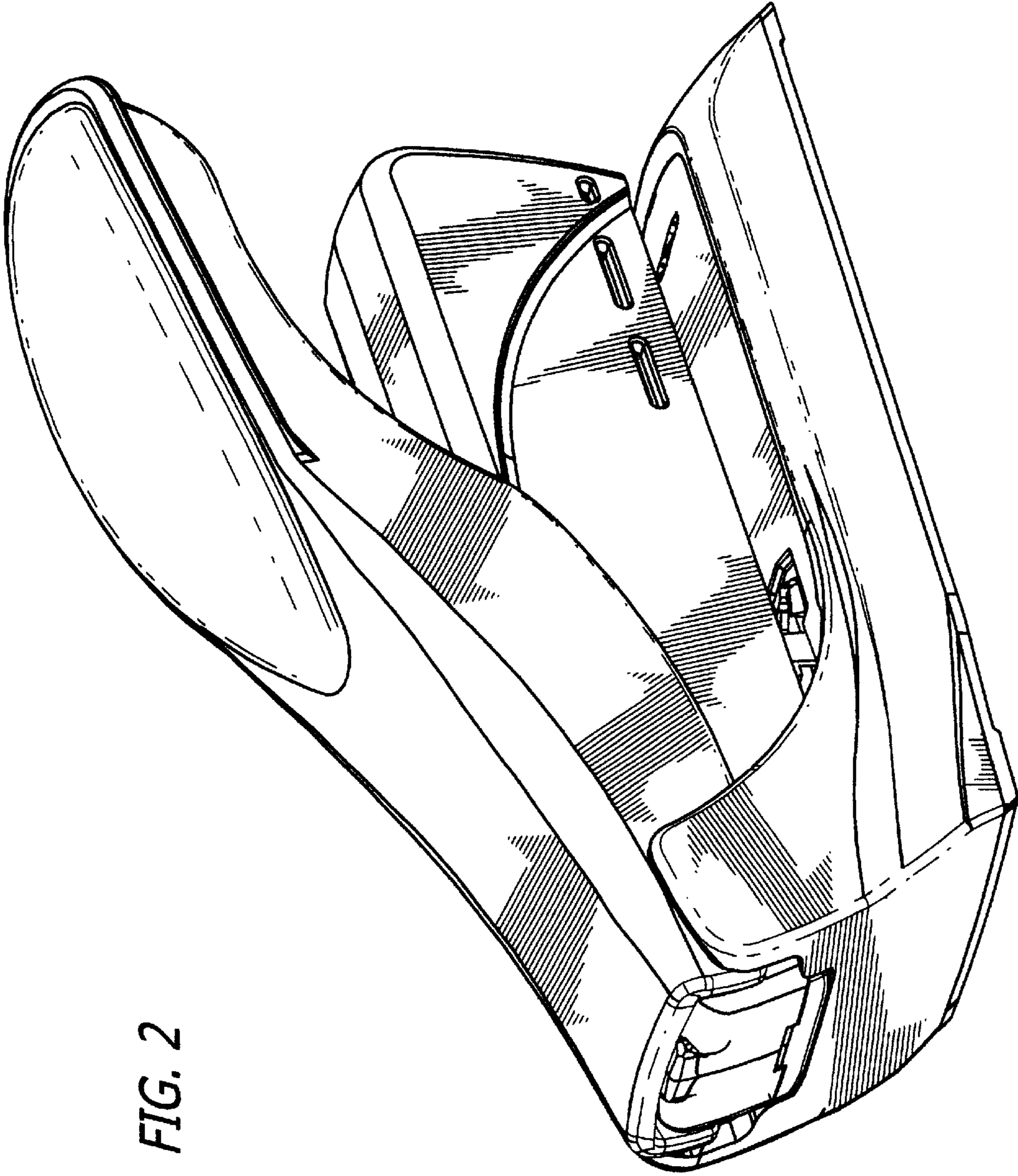

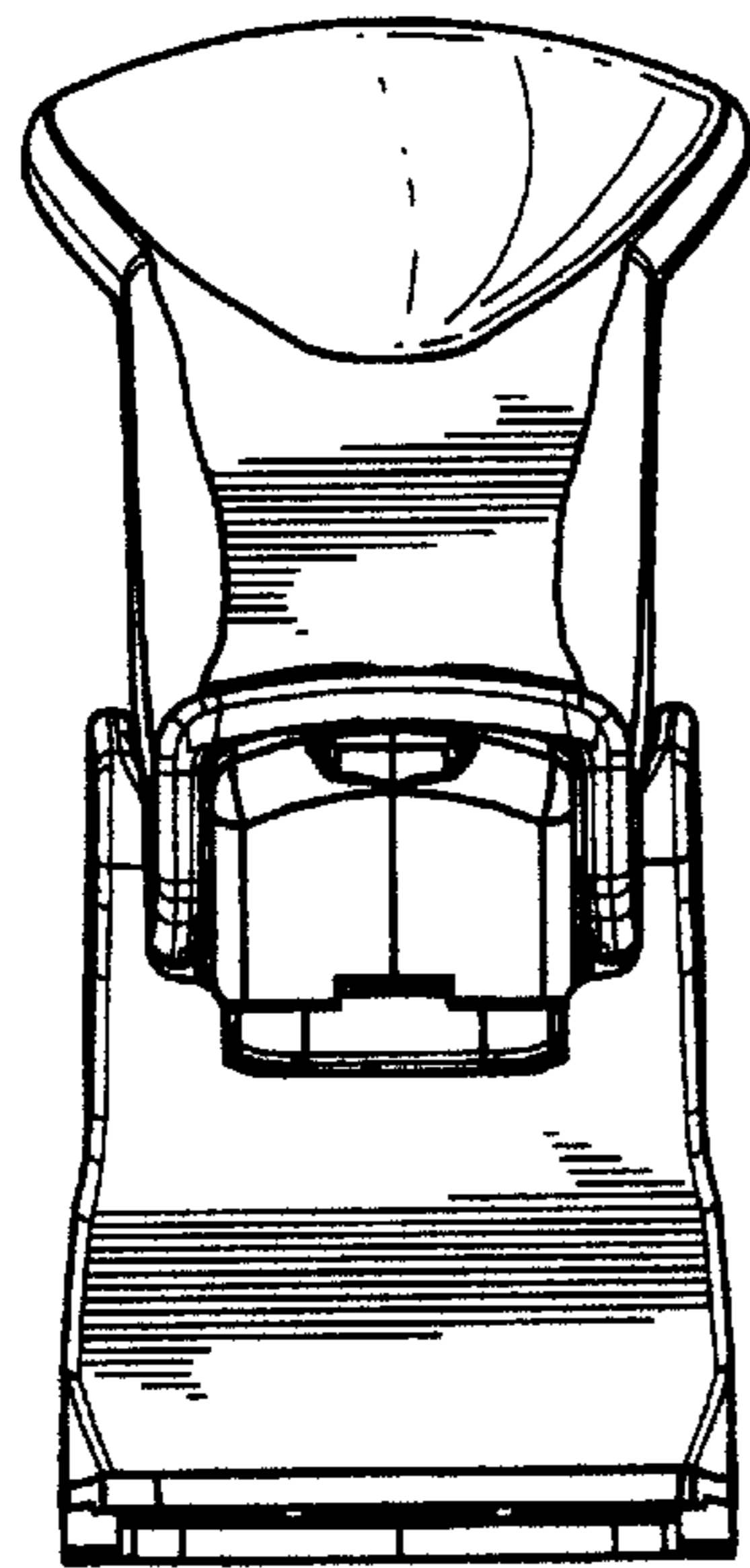
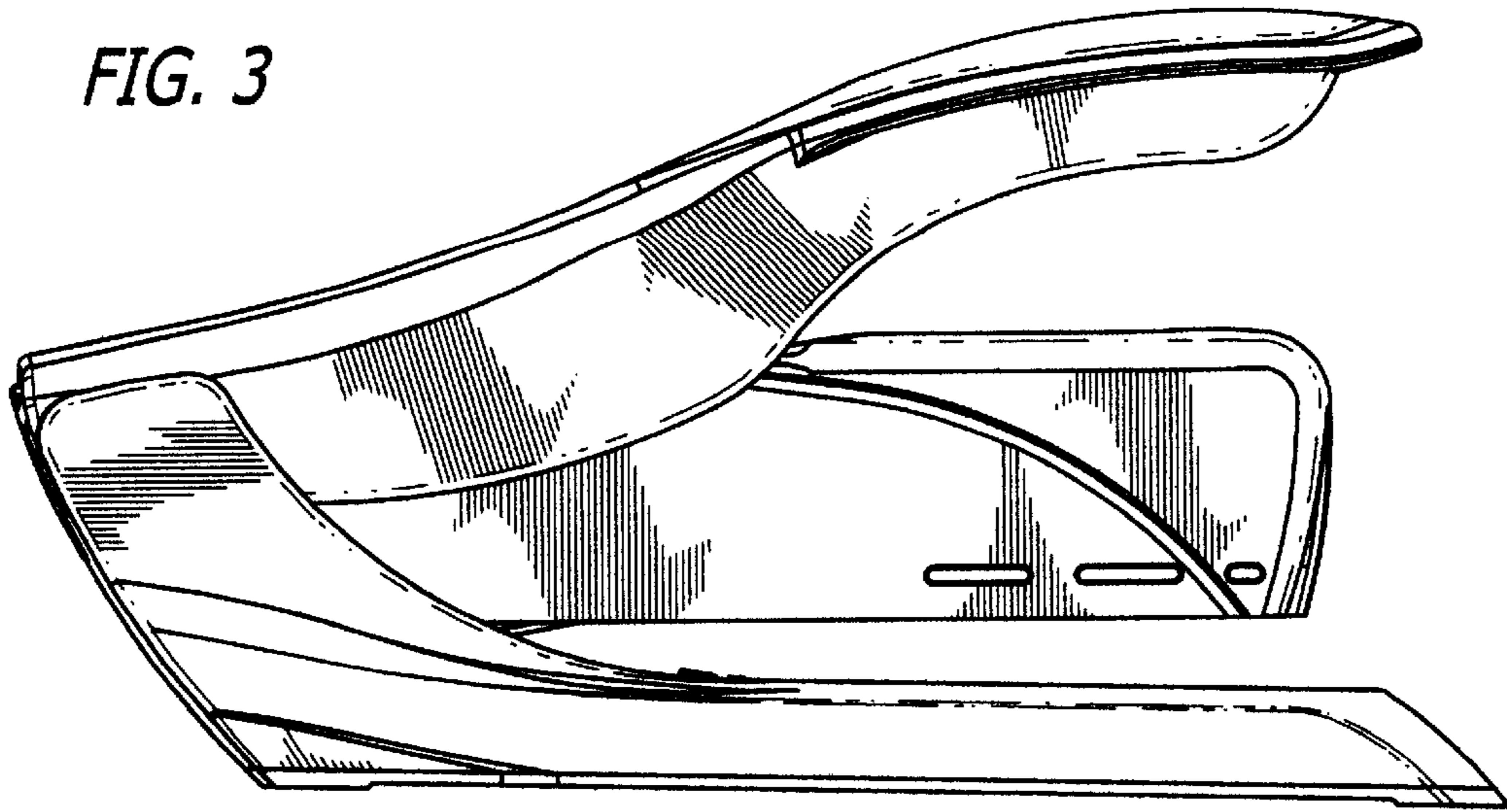

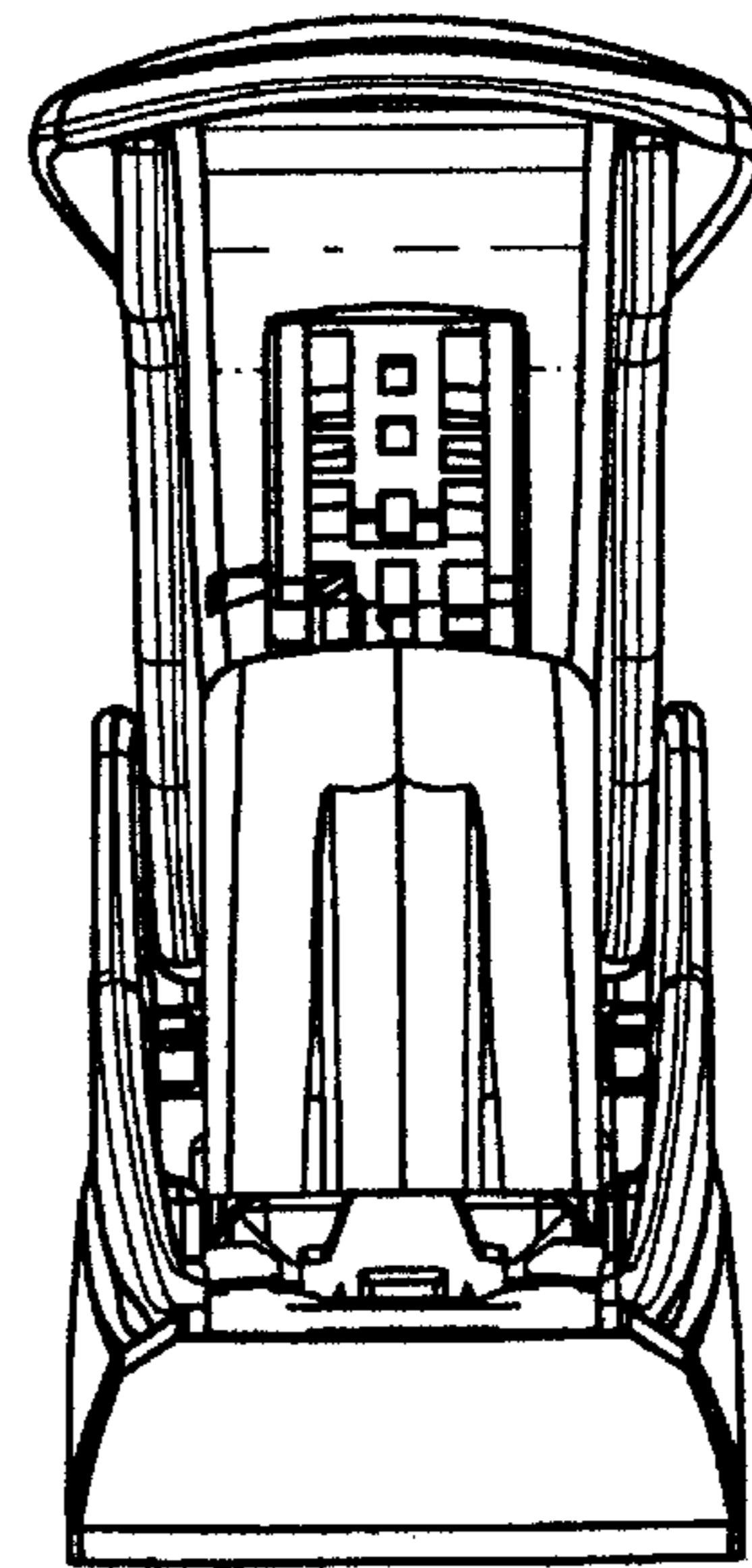

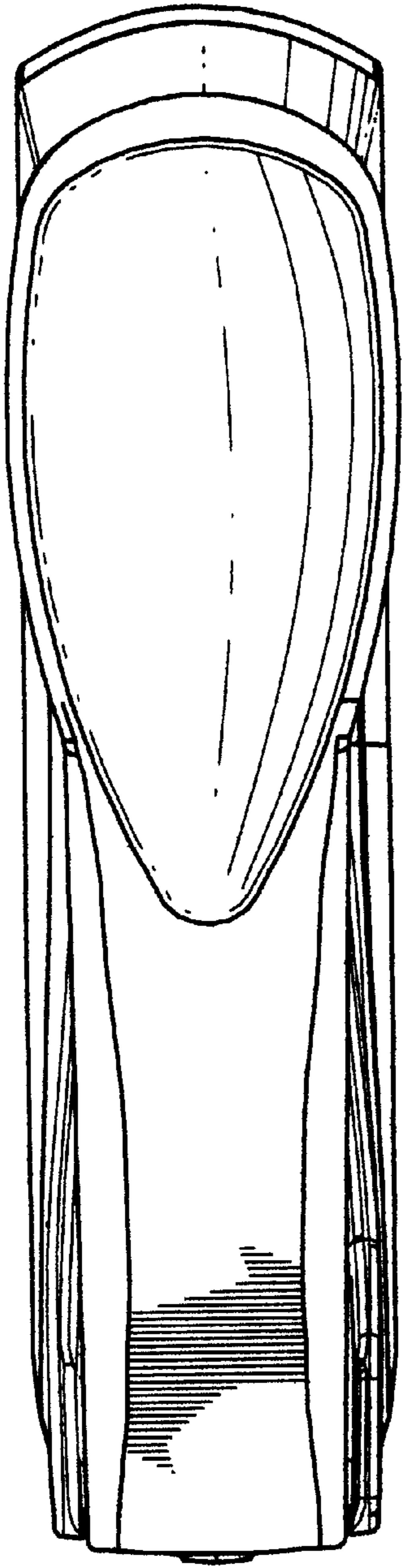

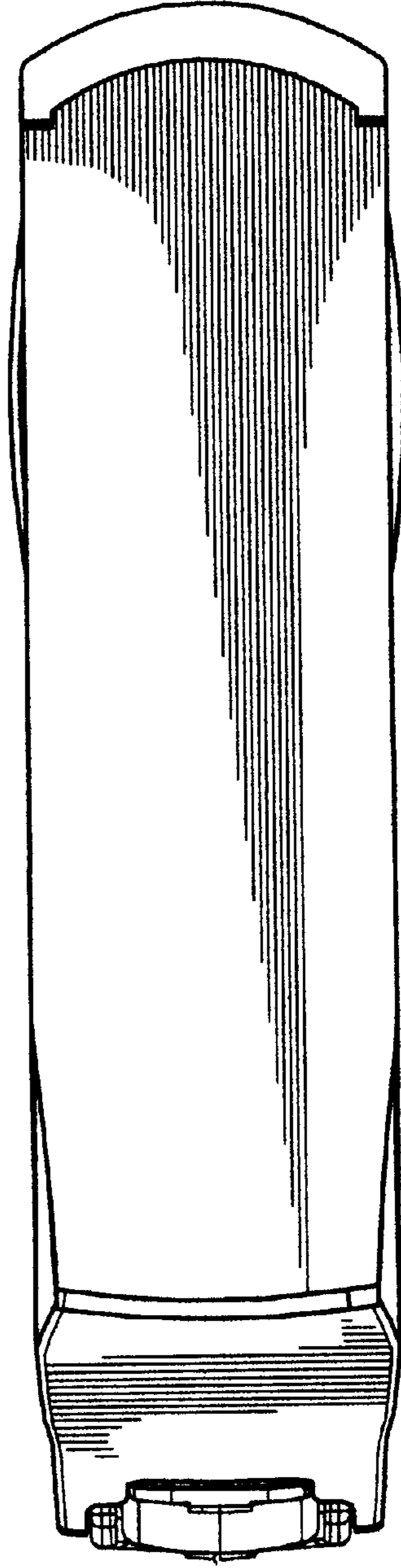
