DESCRIPTION

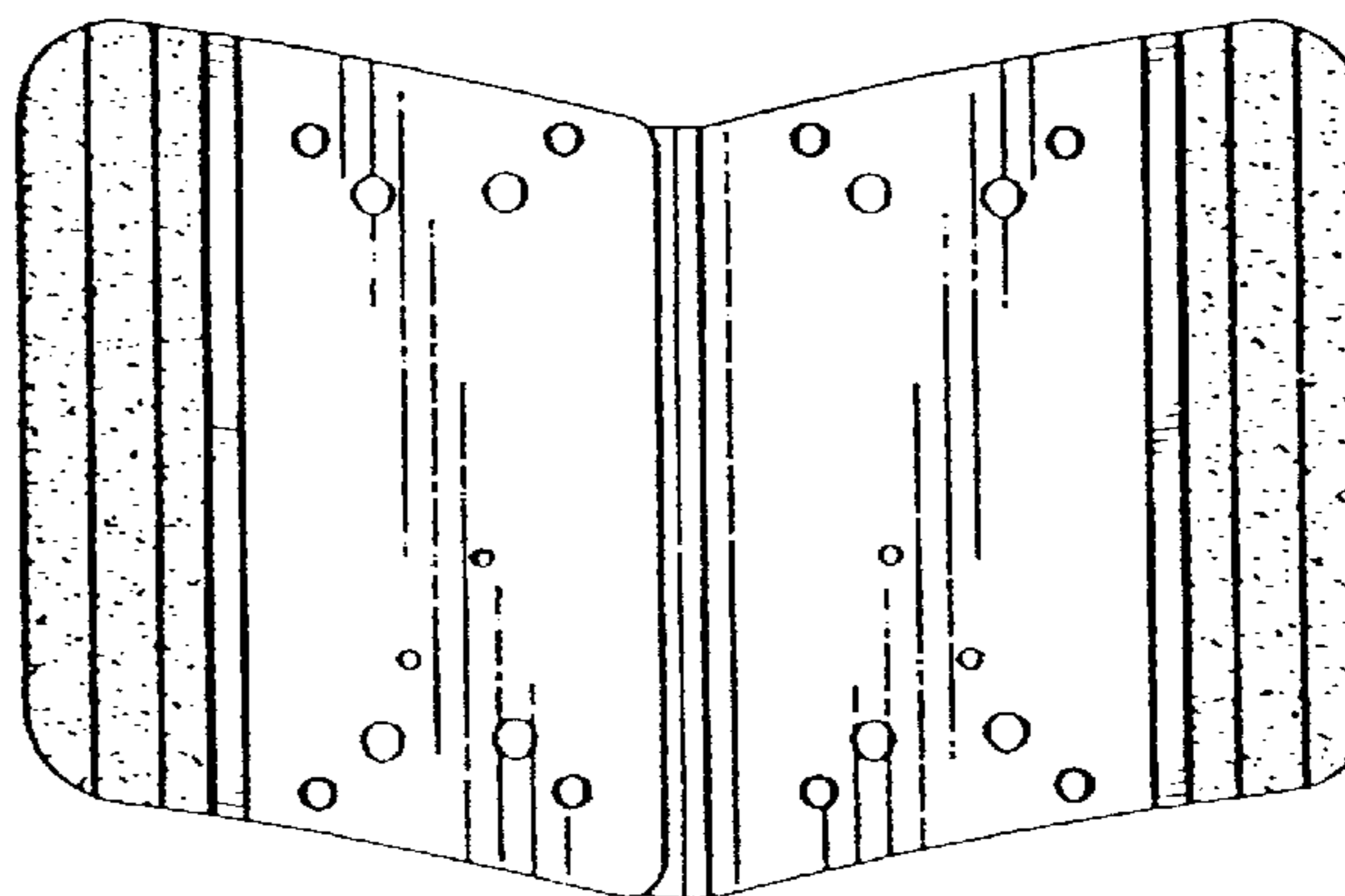
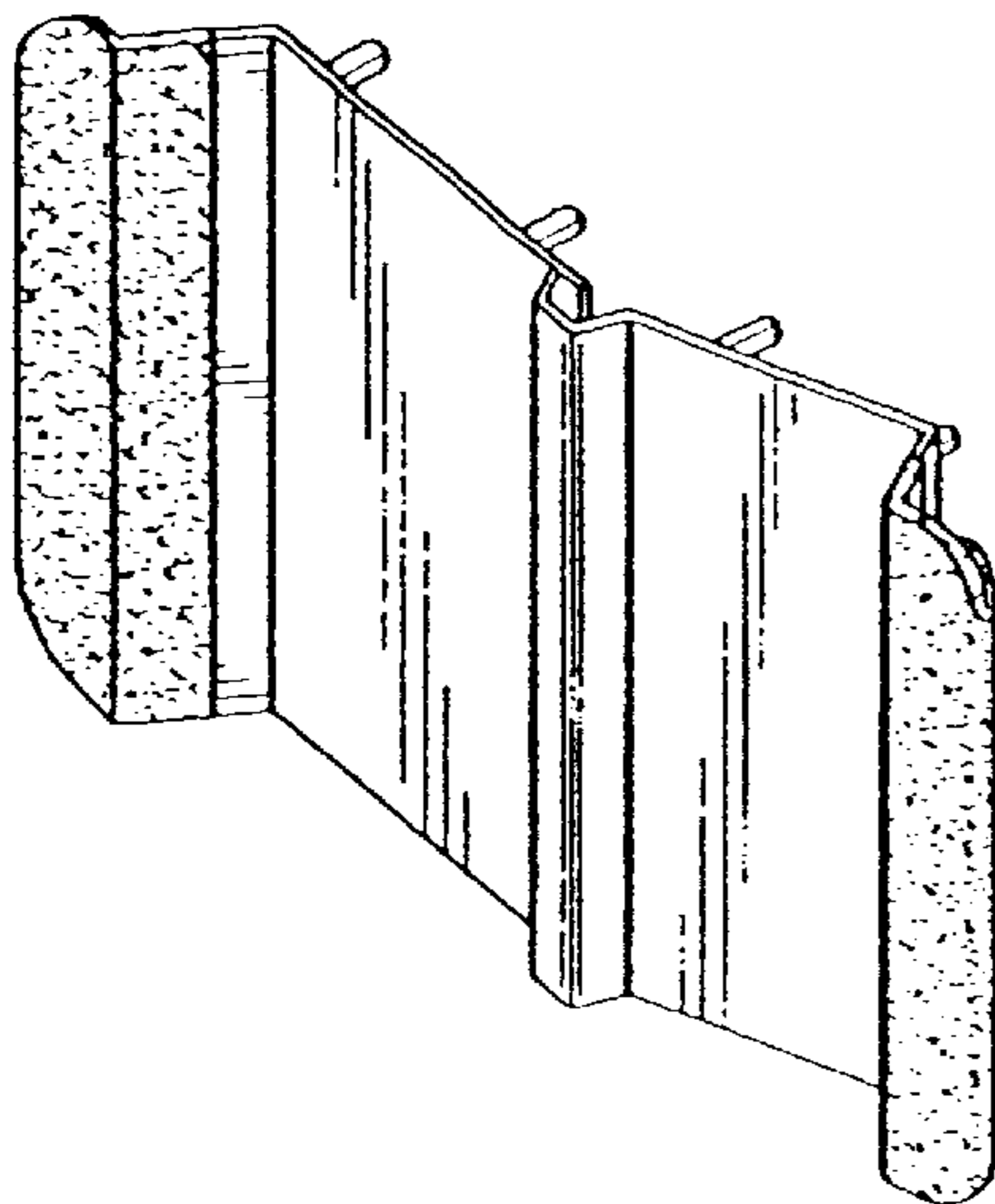

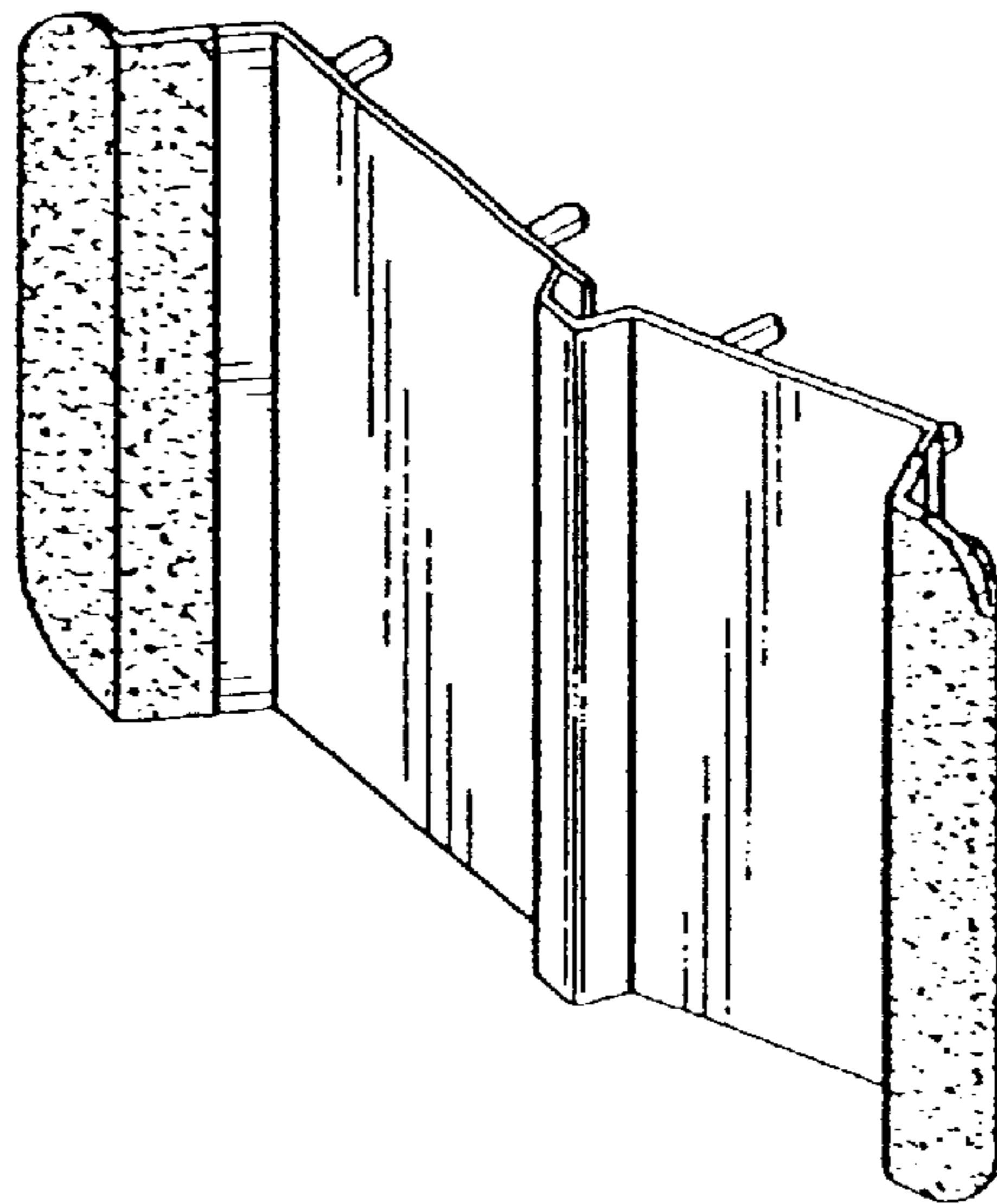

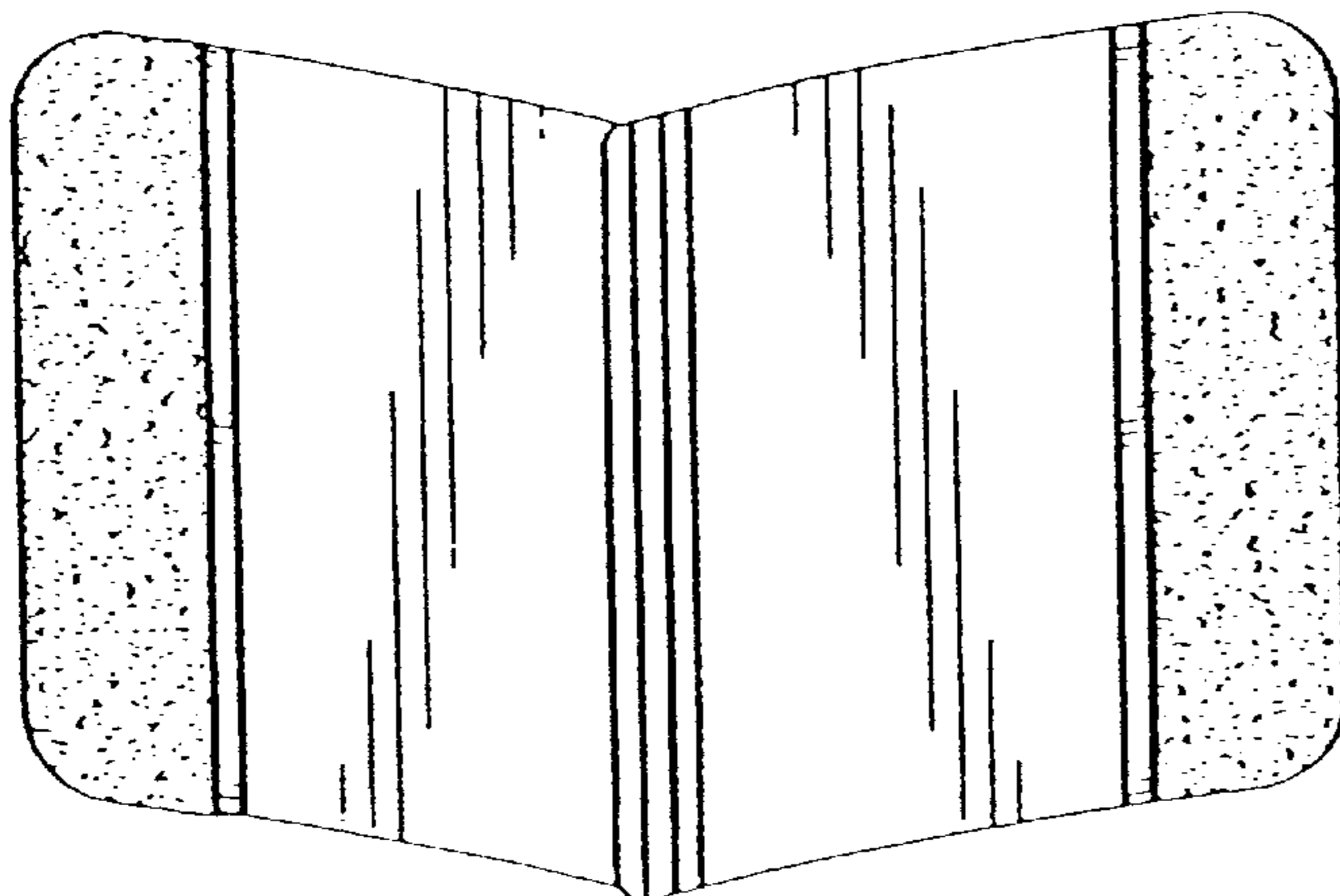

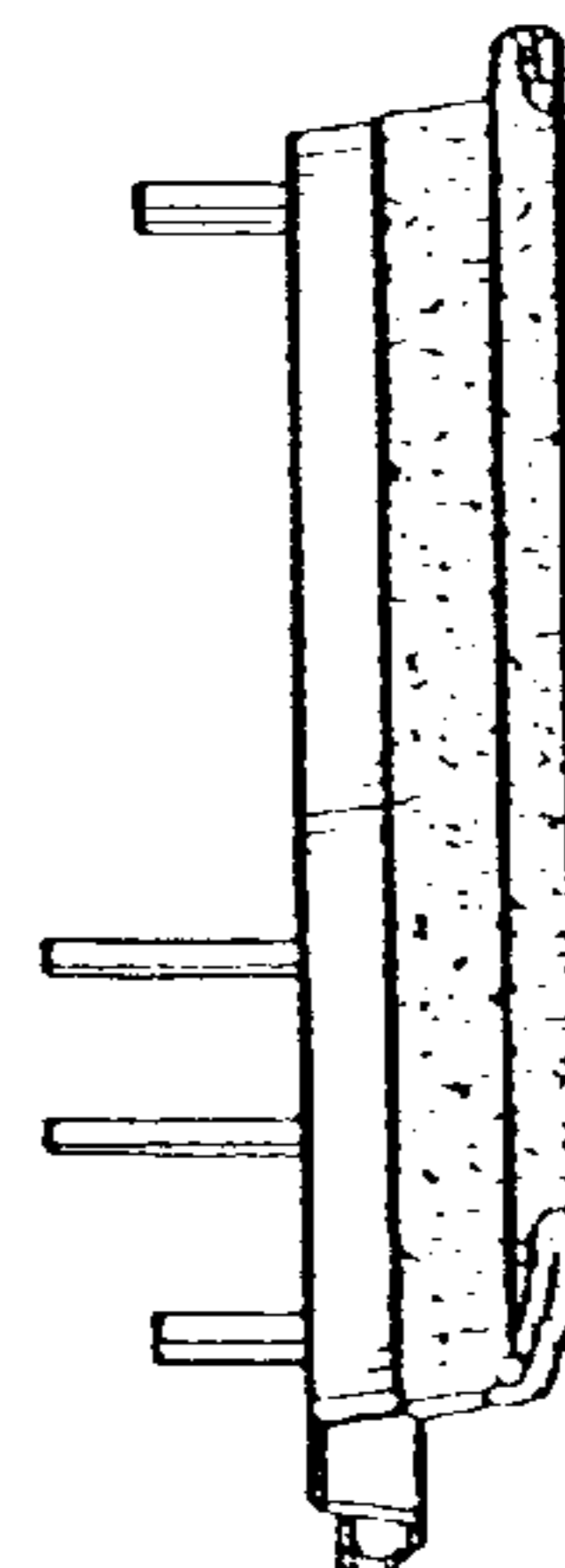

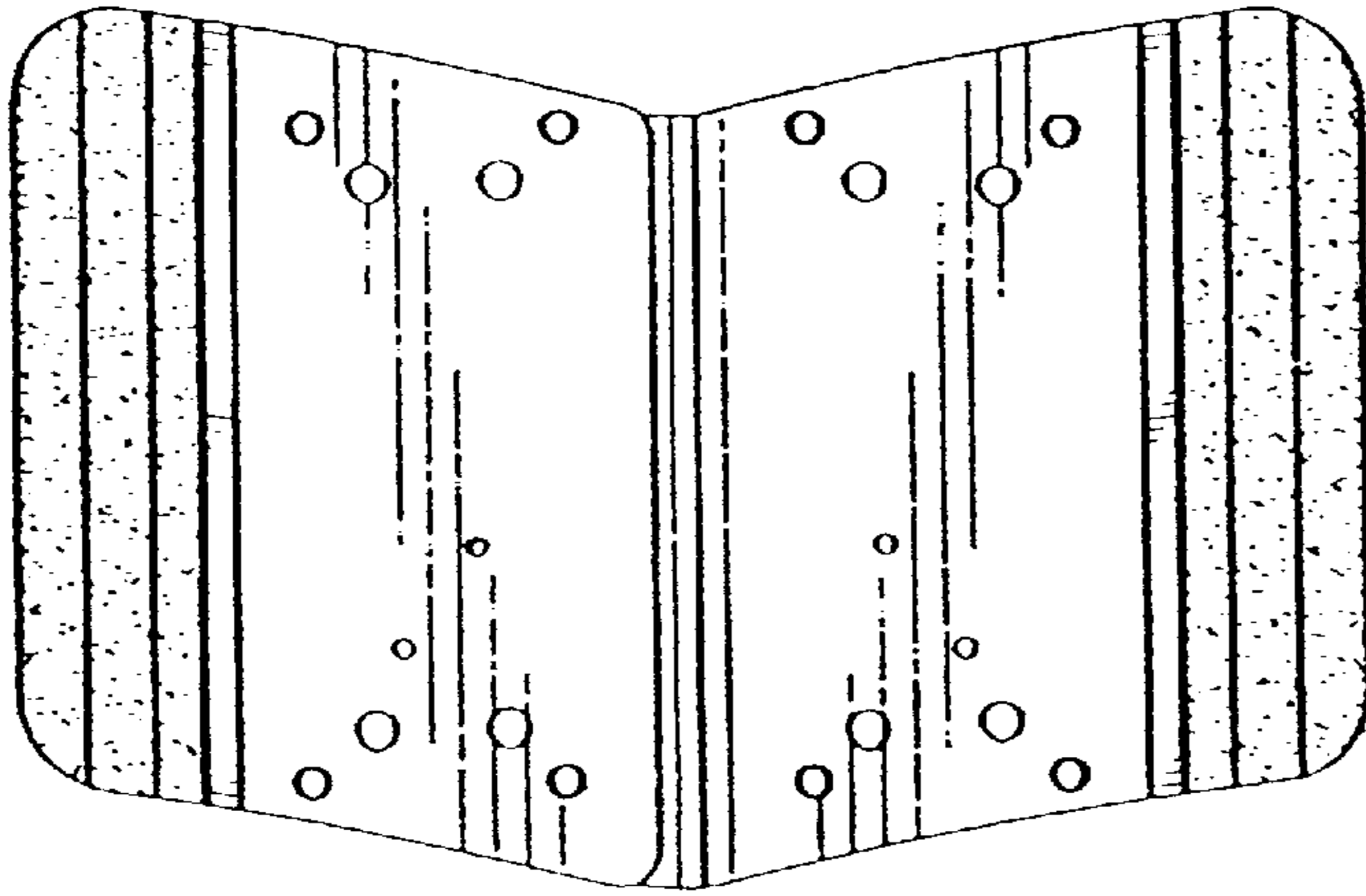

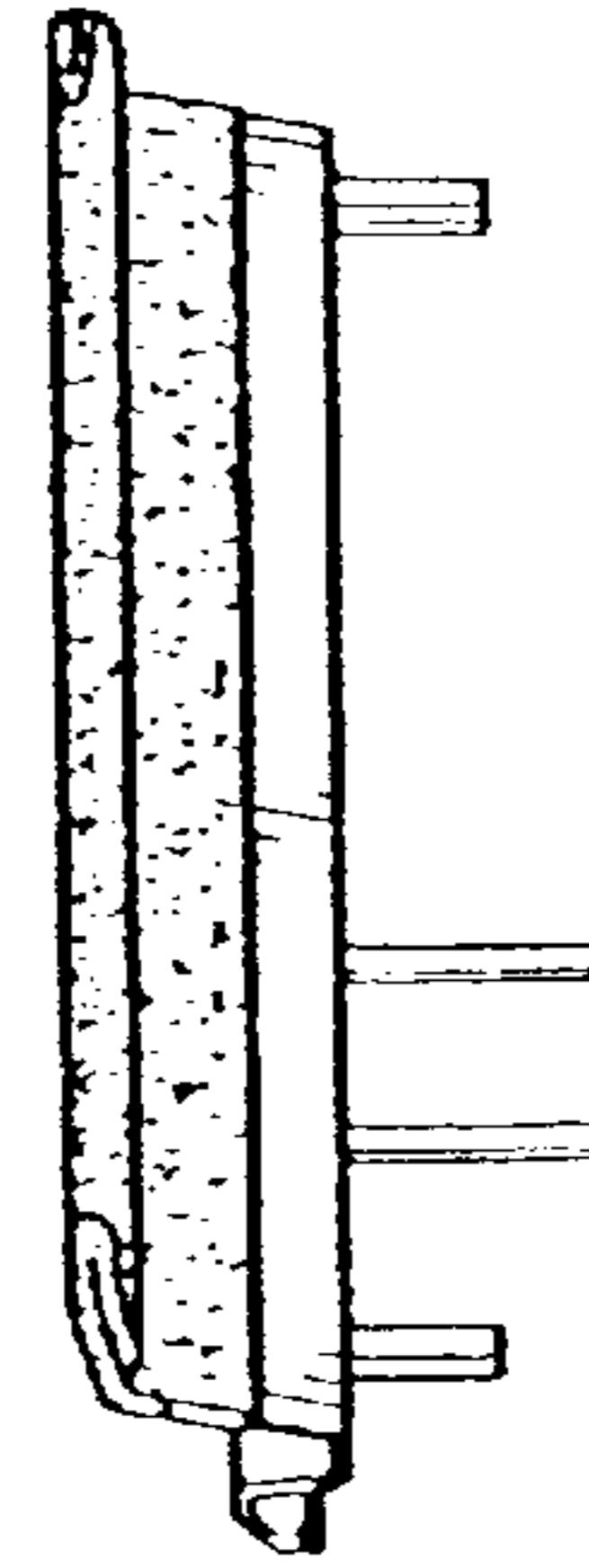

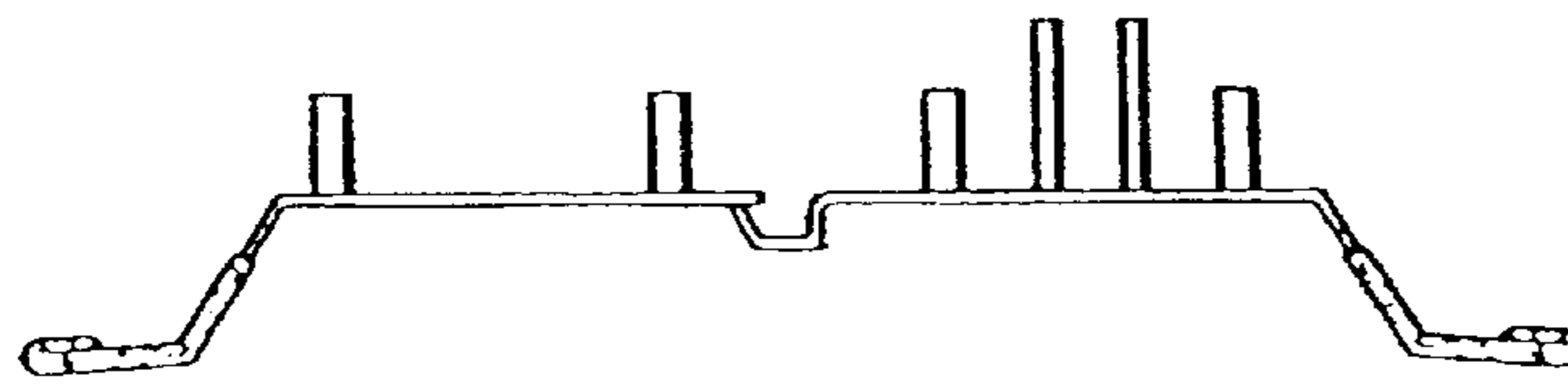

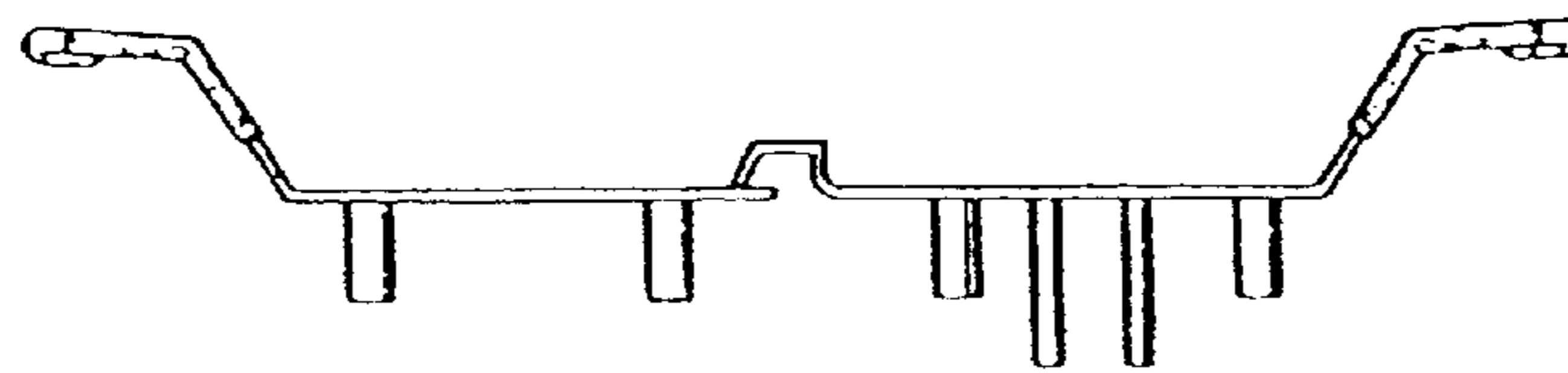

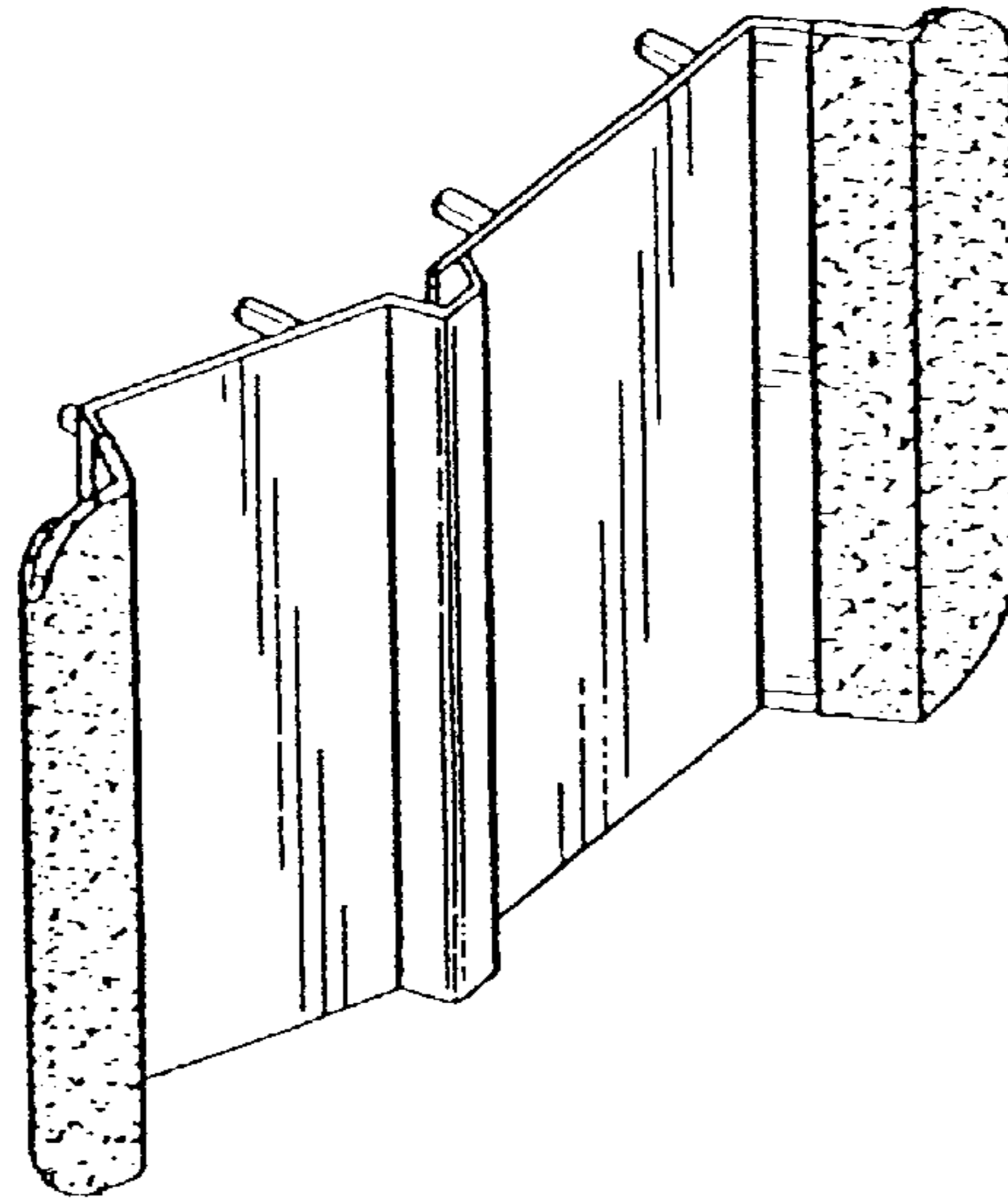

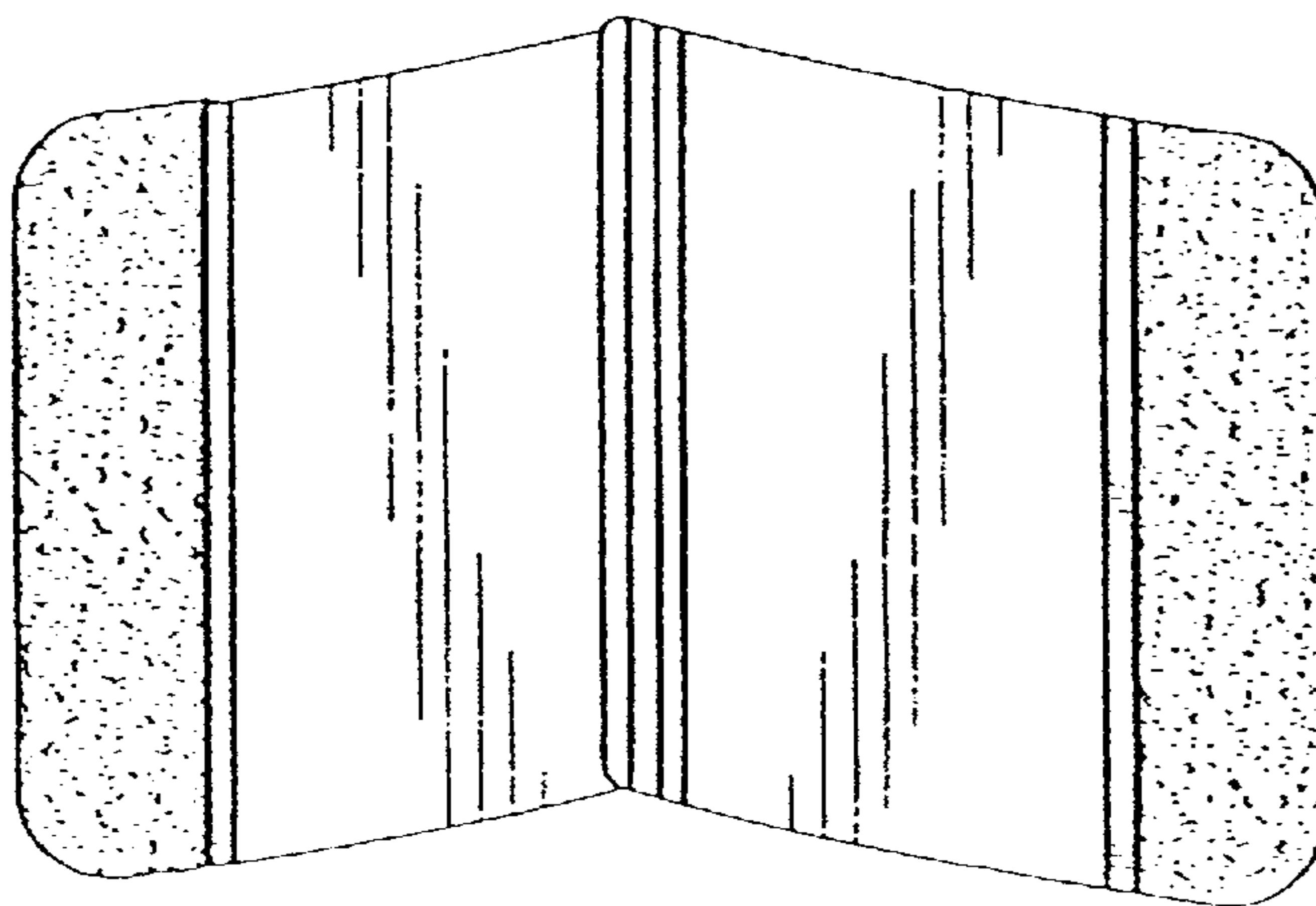

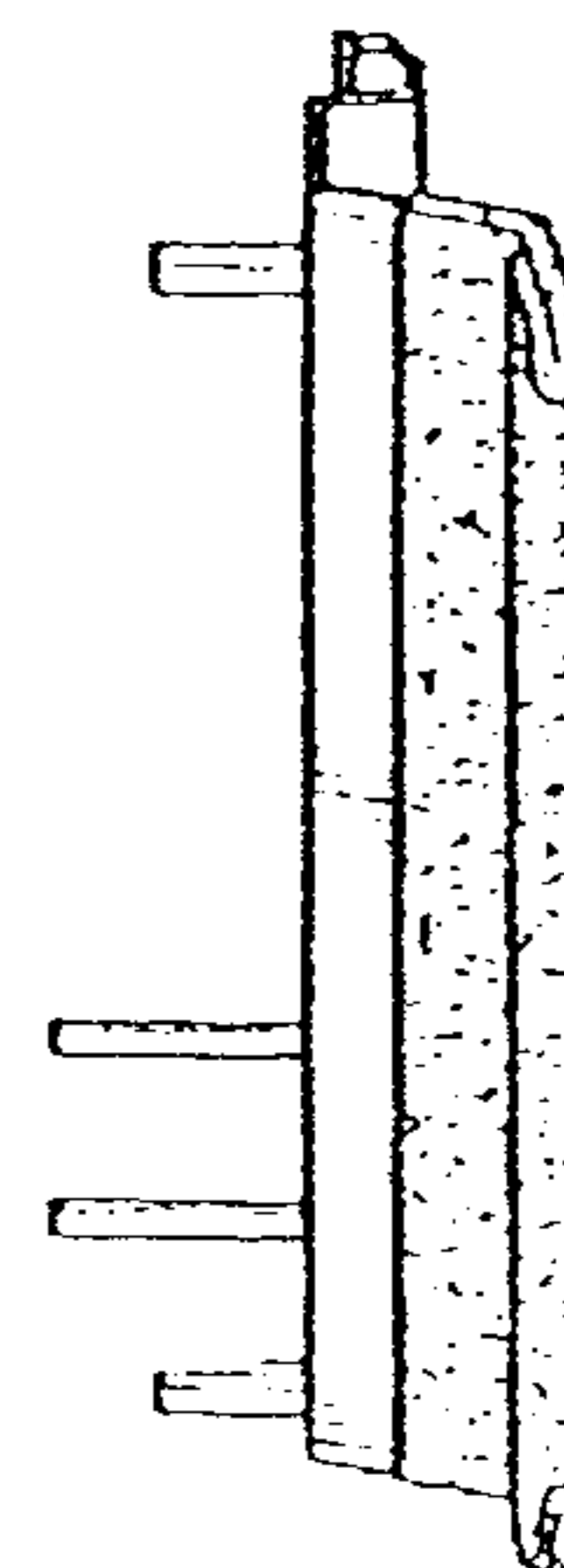

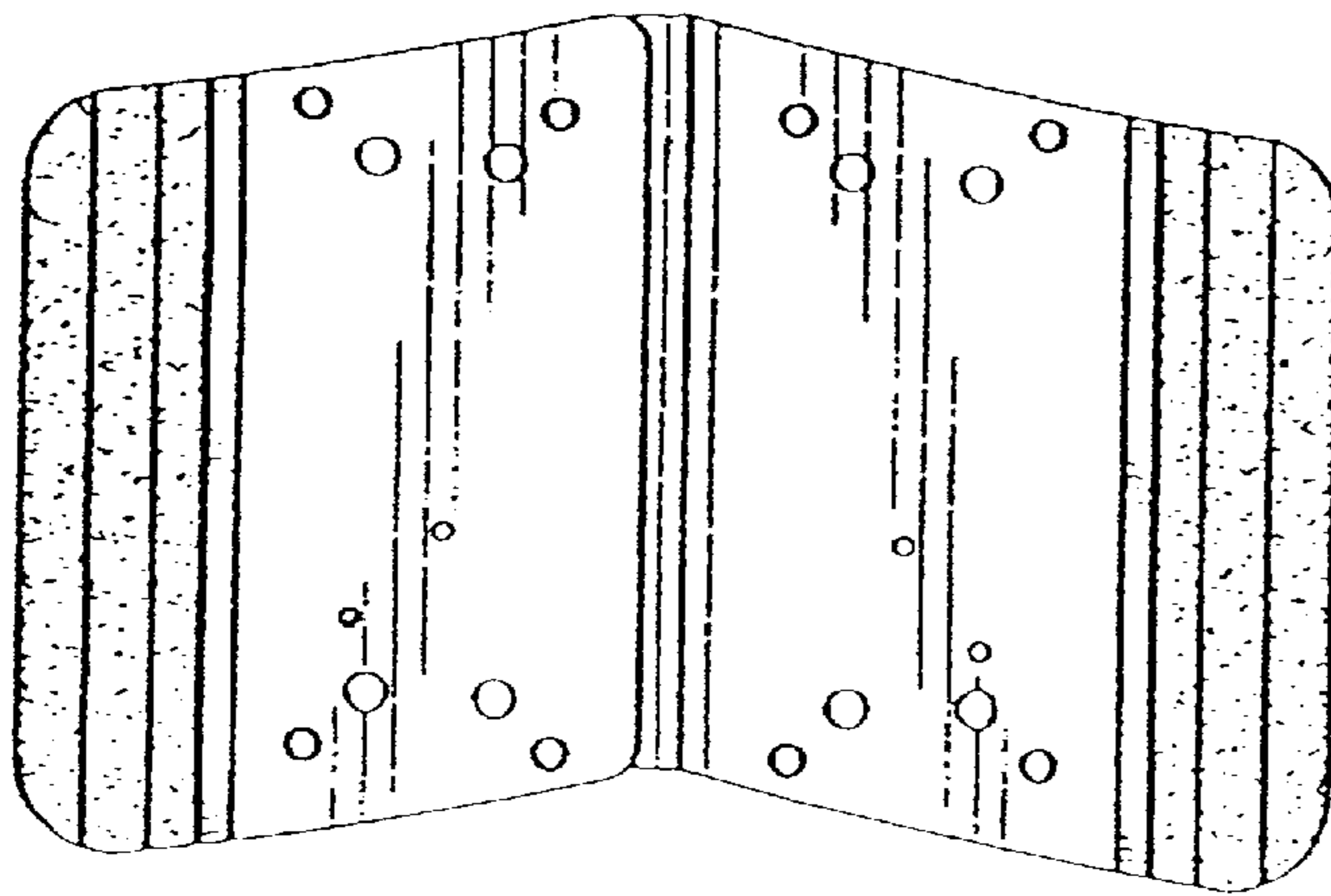

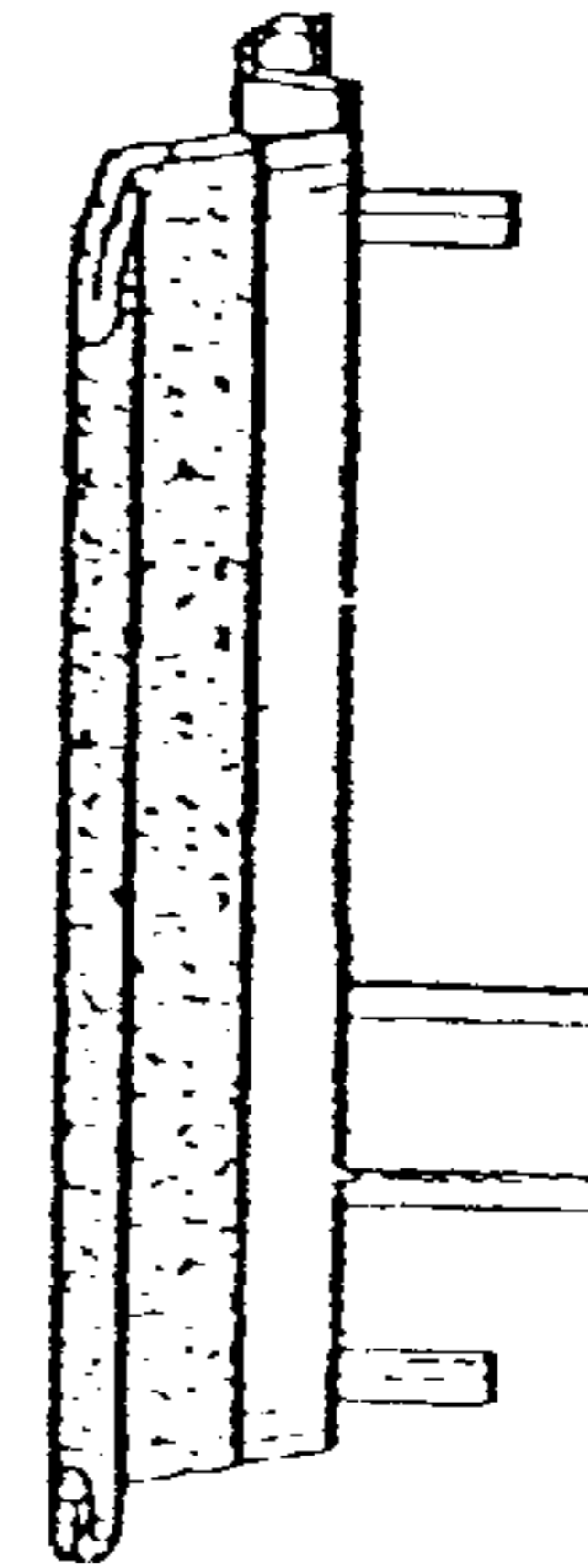

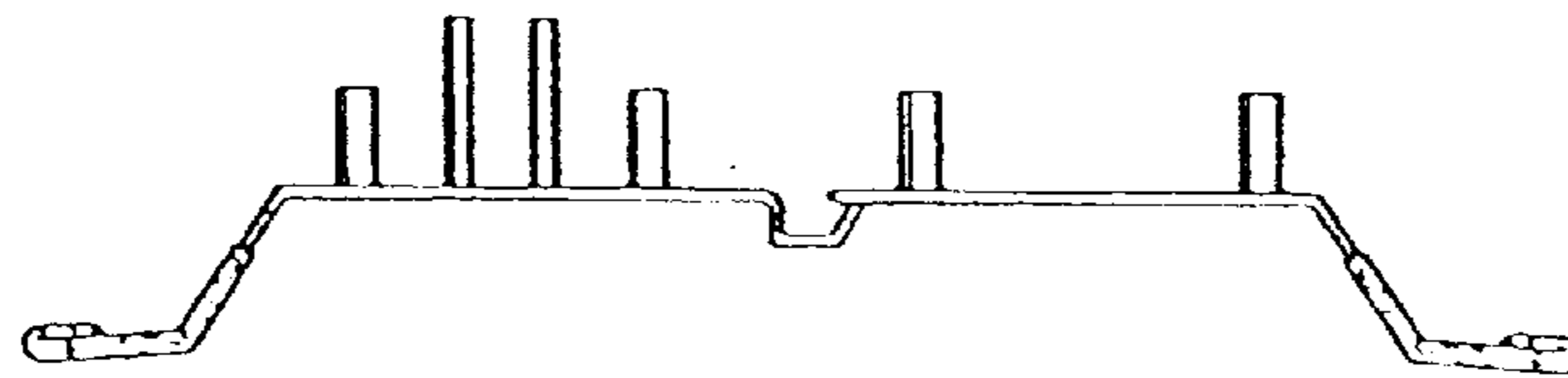
