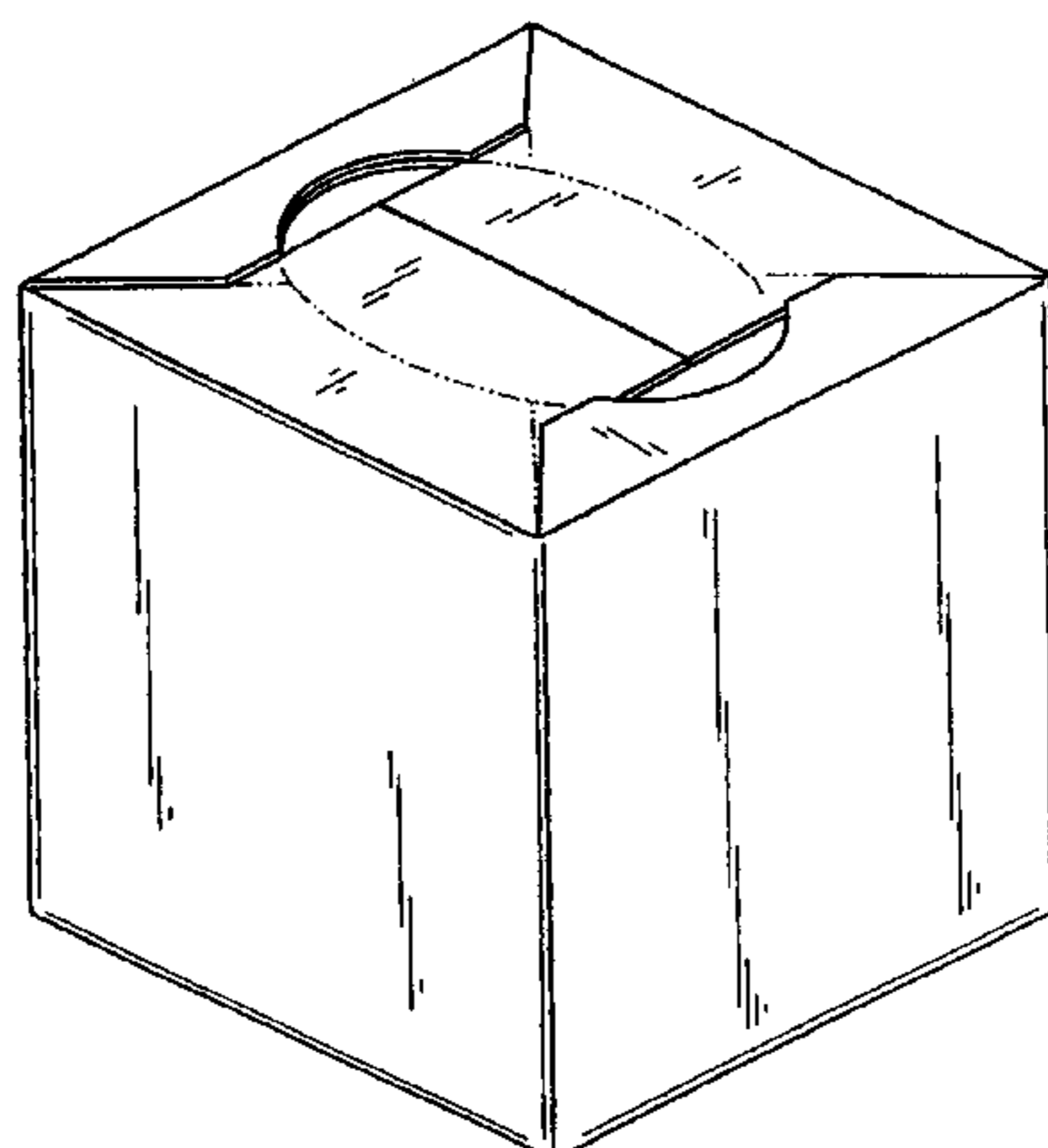
(57) **CLAIM**

The ornamental design for a facial tissue box, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a facial tissue box blank showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a perspective view of a facial tissue box formed by folding the facial tissue box blank of FIG. 1;  
FIG. 8 is a top plan view thereof;  
FIG. 9 is a left side view thereof, with the right side view being identical;  
FIG. 10 is a front view thereof; and,  
FIG. 11 is a bottom view thereof.

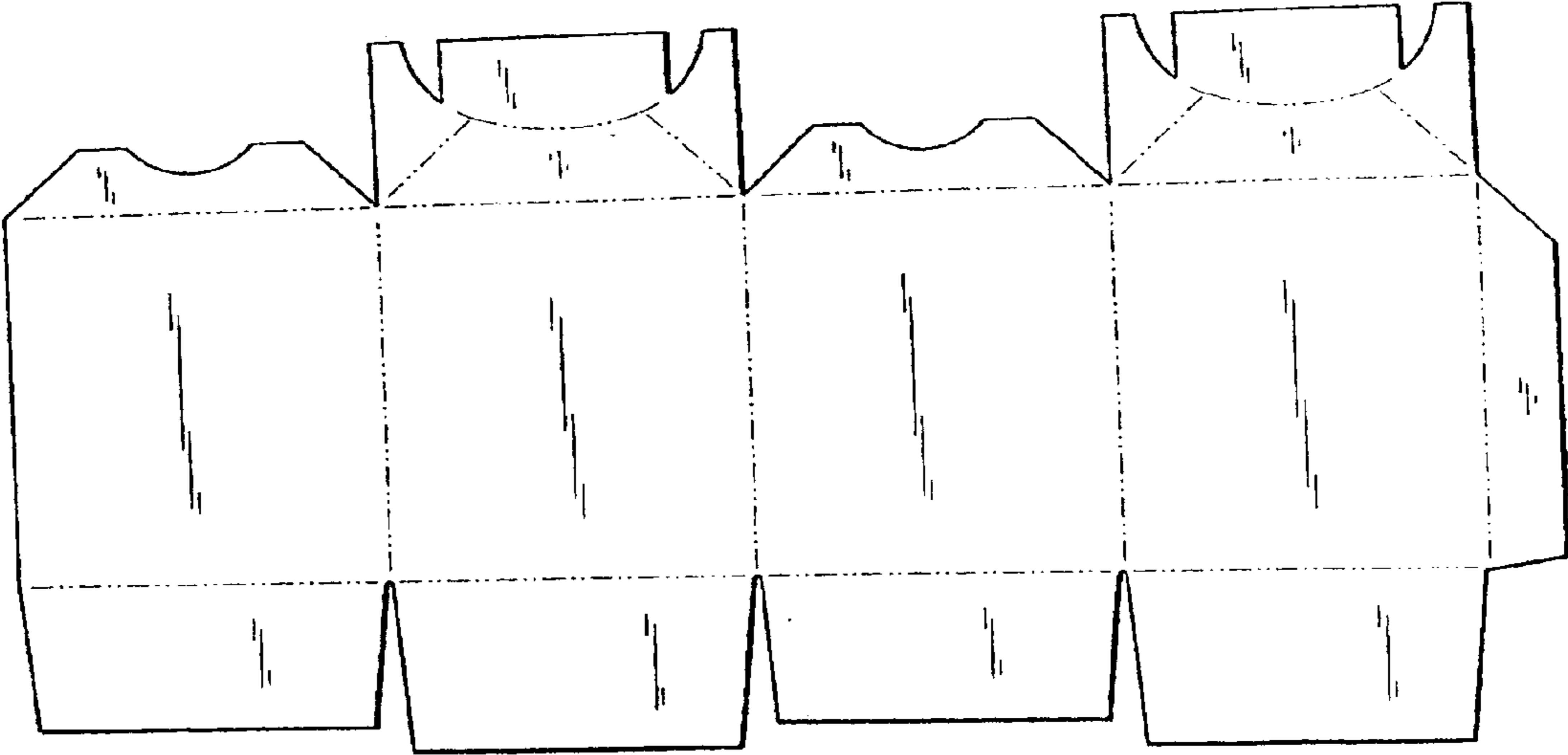
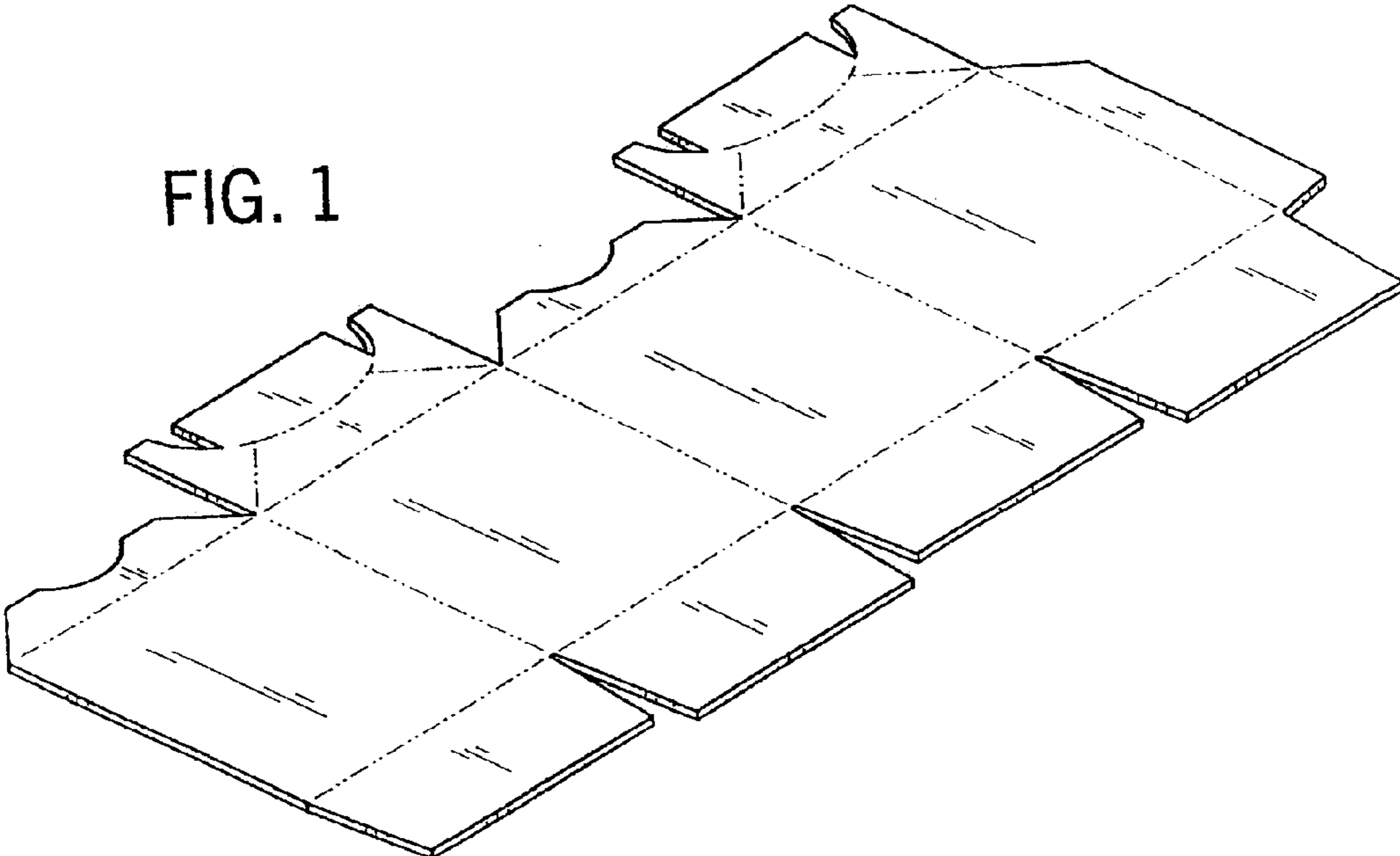

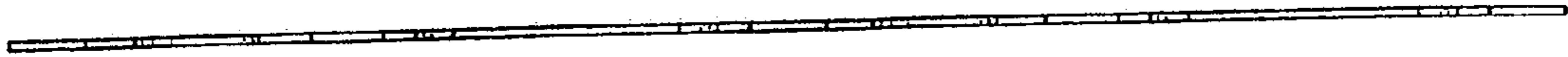

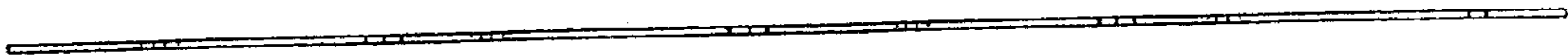

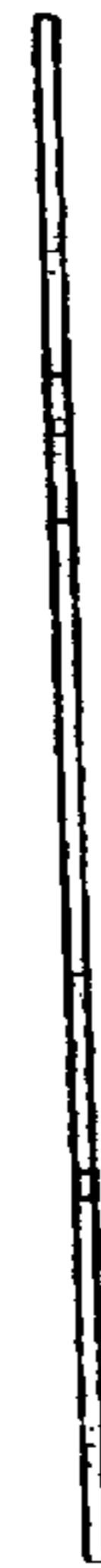

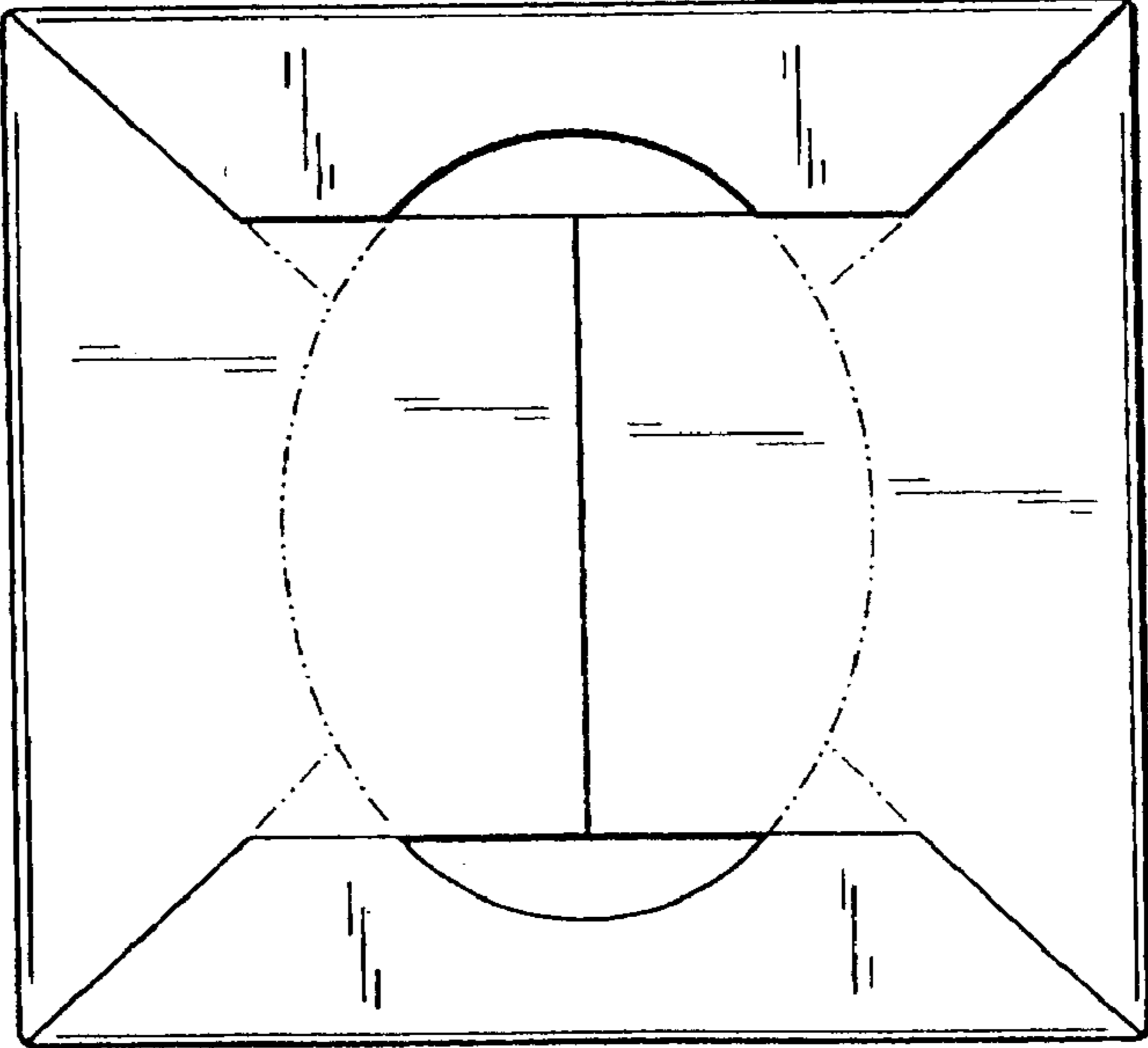
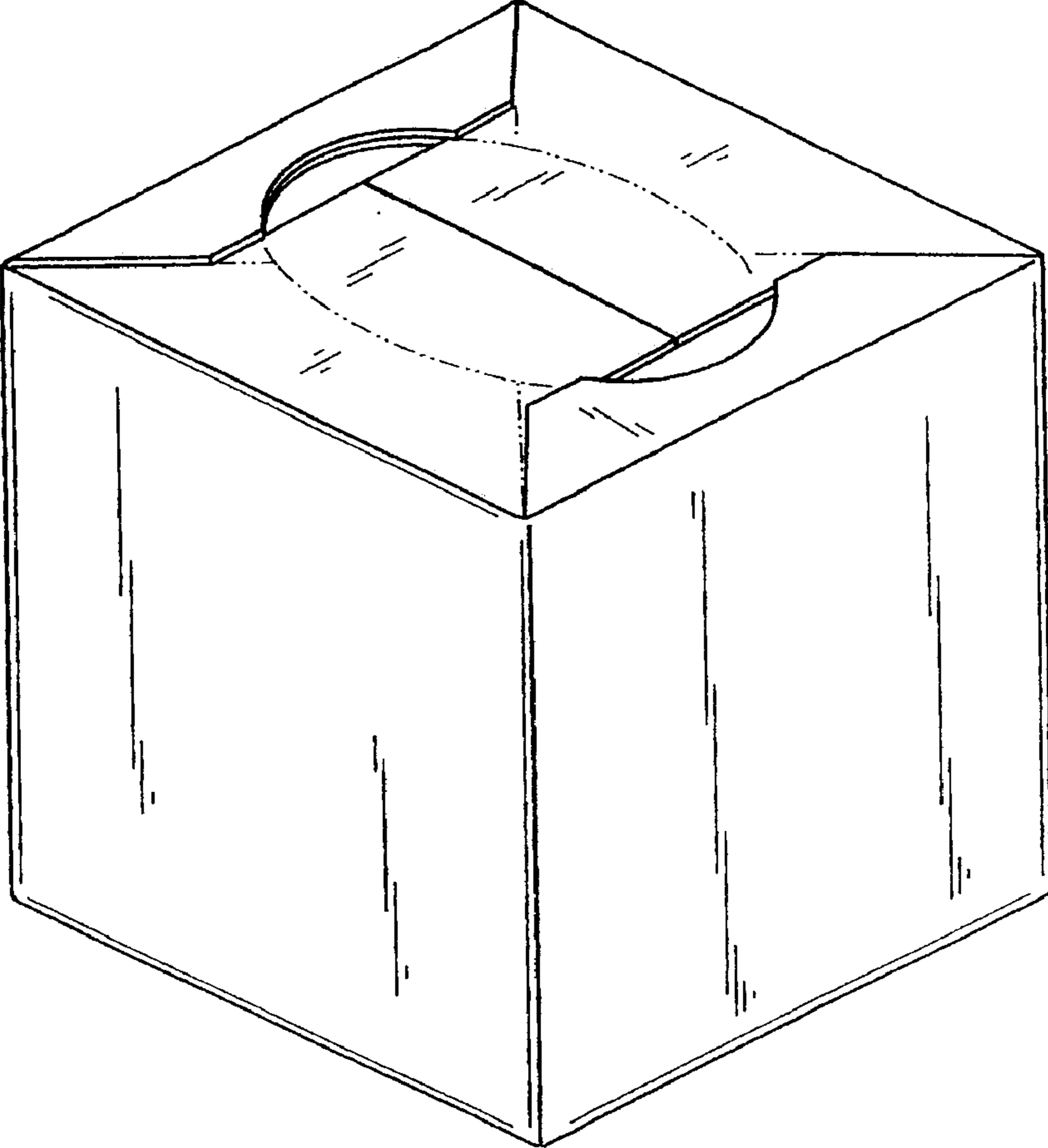

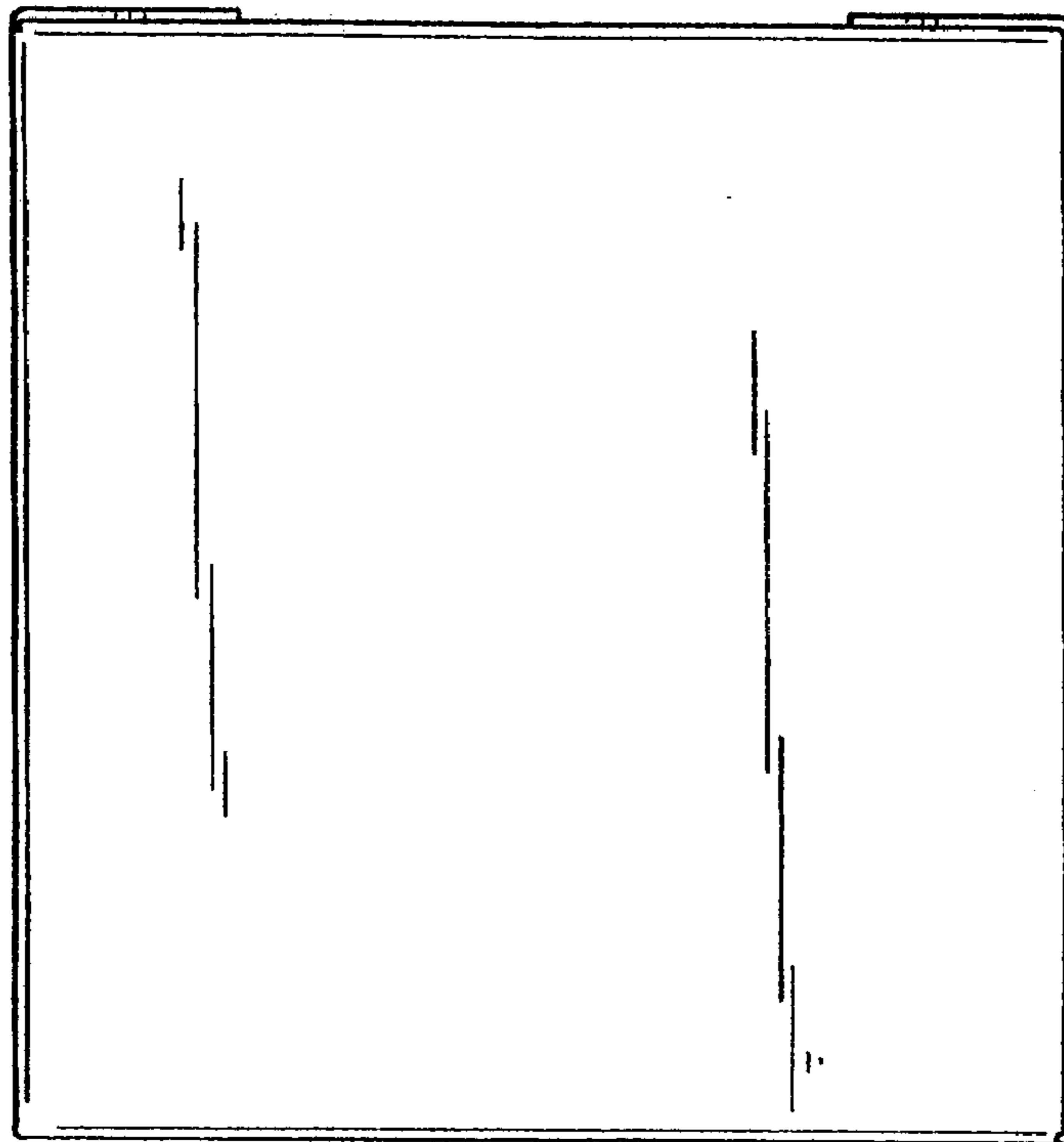

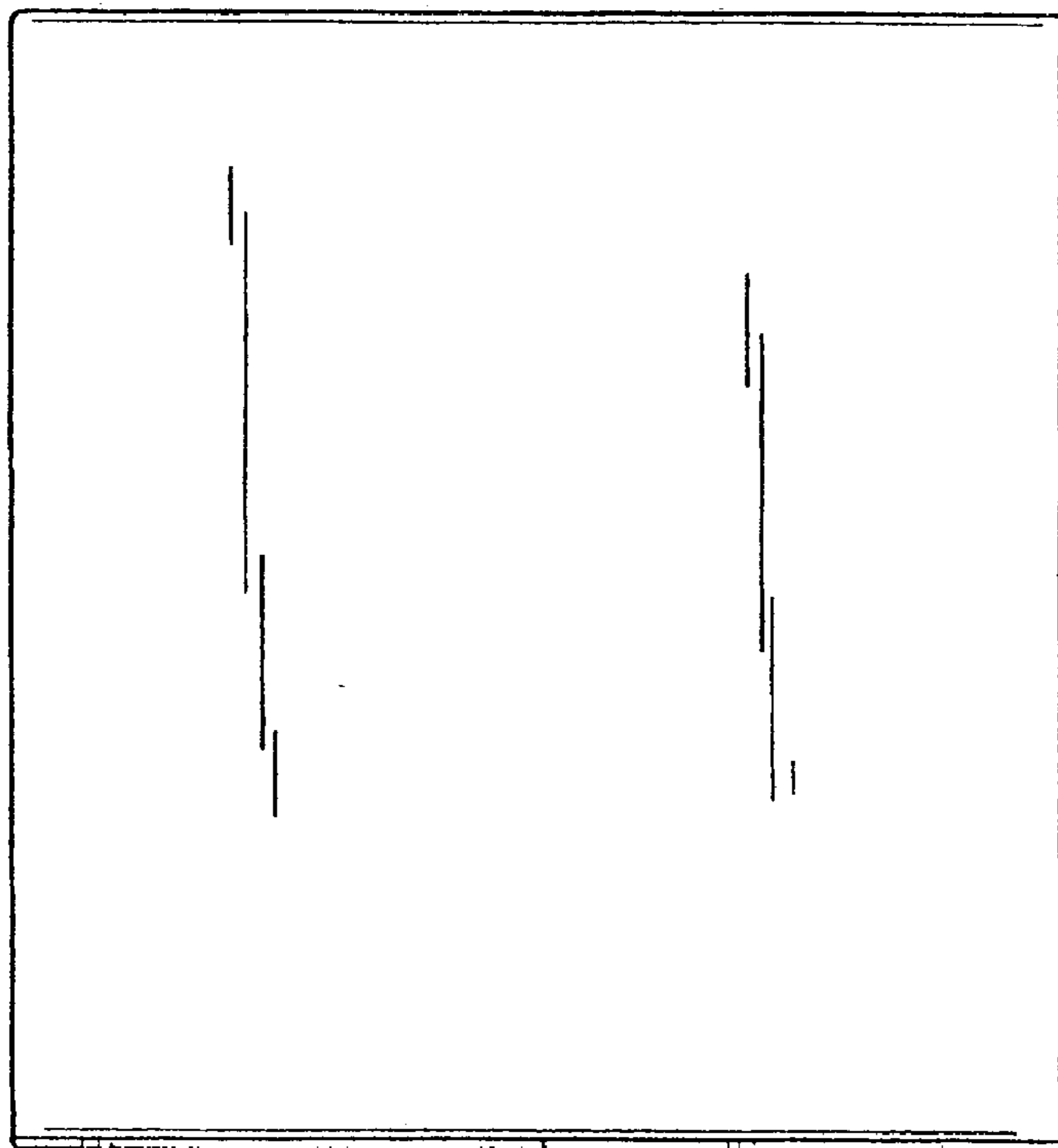

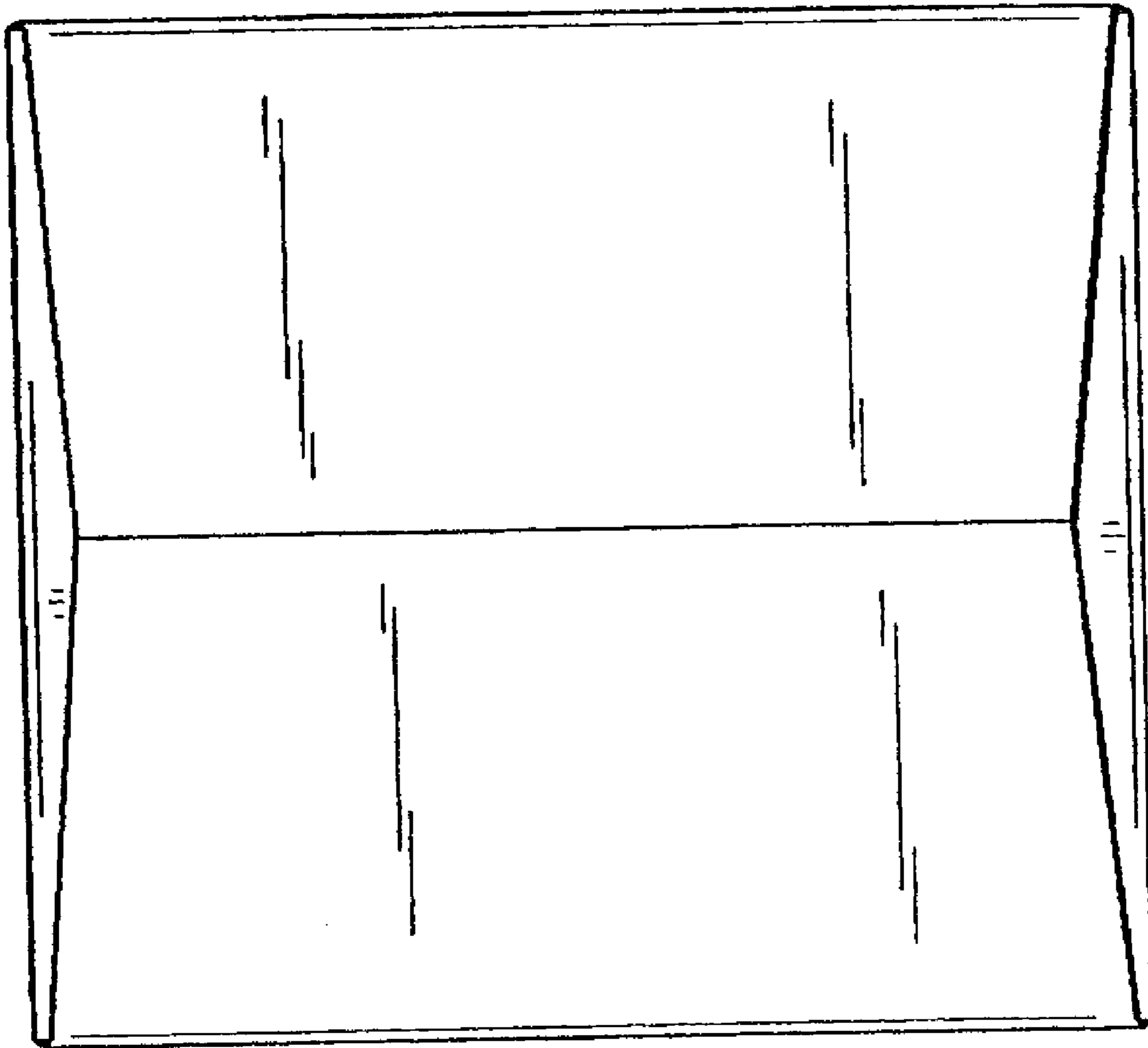
