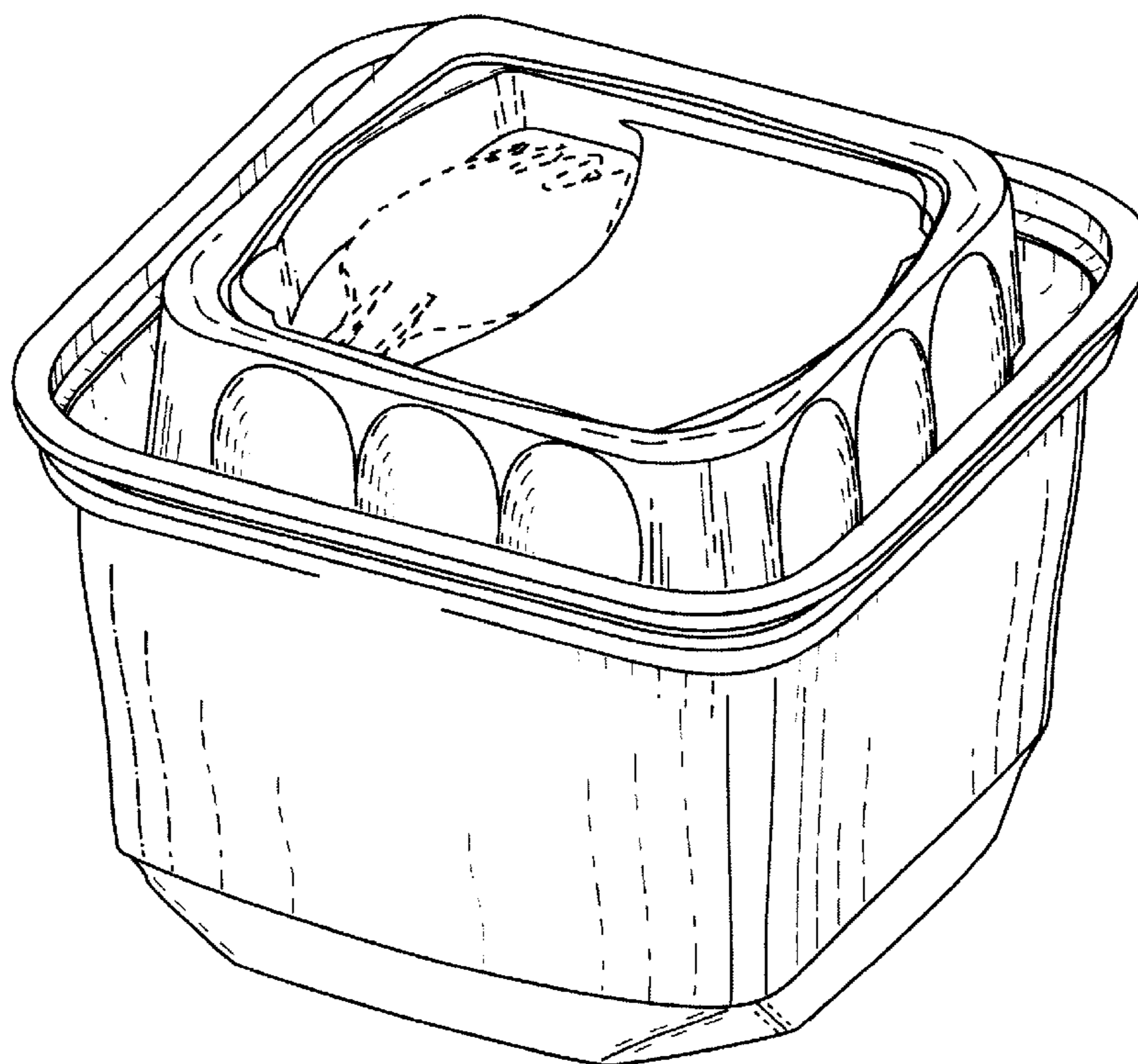
(57) **CLAIM**

The ornamental design for a container and lid with recess, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the container and lid with recess;  
 FIG. 2 is a top view of the container and lid with recess;  
 FIG. 3 is a side view of the container and lid with recess;  
 and,  
 FIG. 4 is a bottom view of the container and lid with recess.

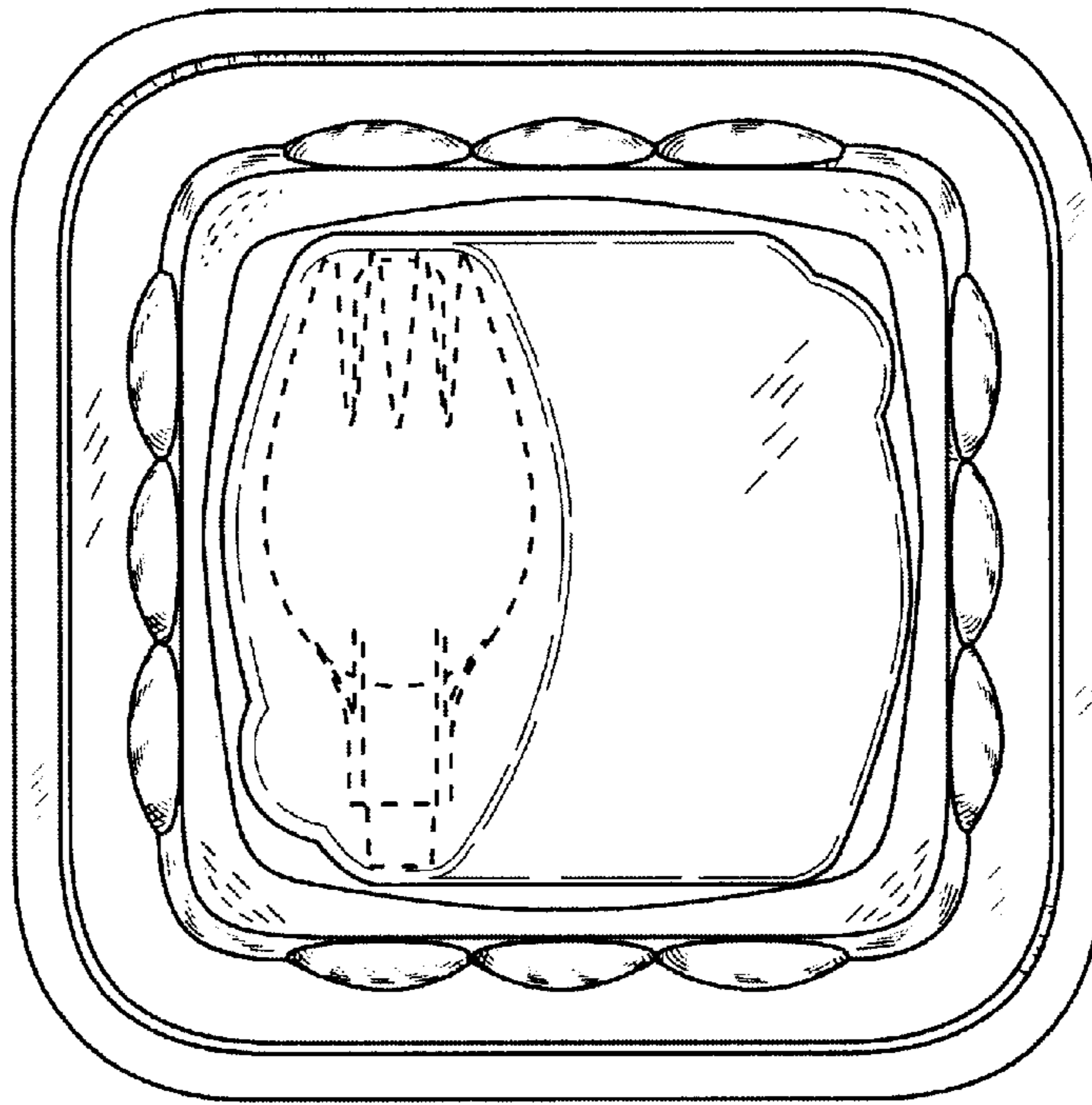

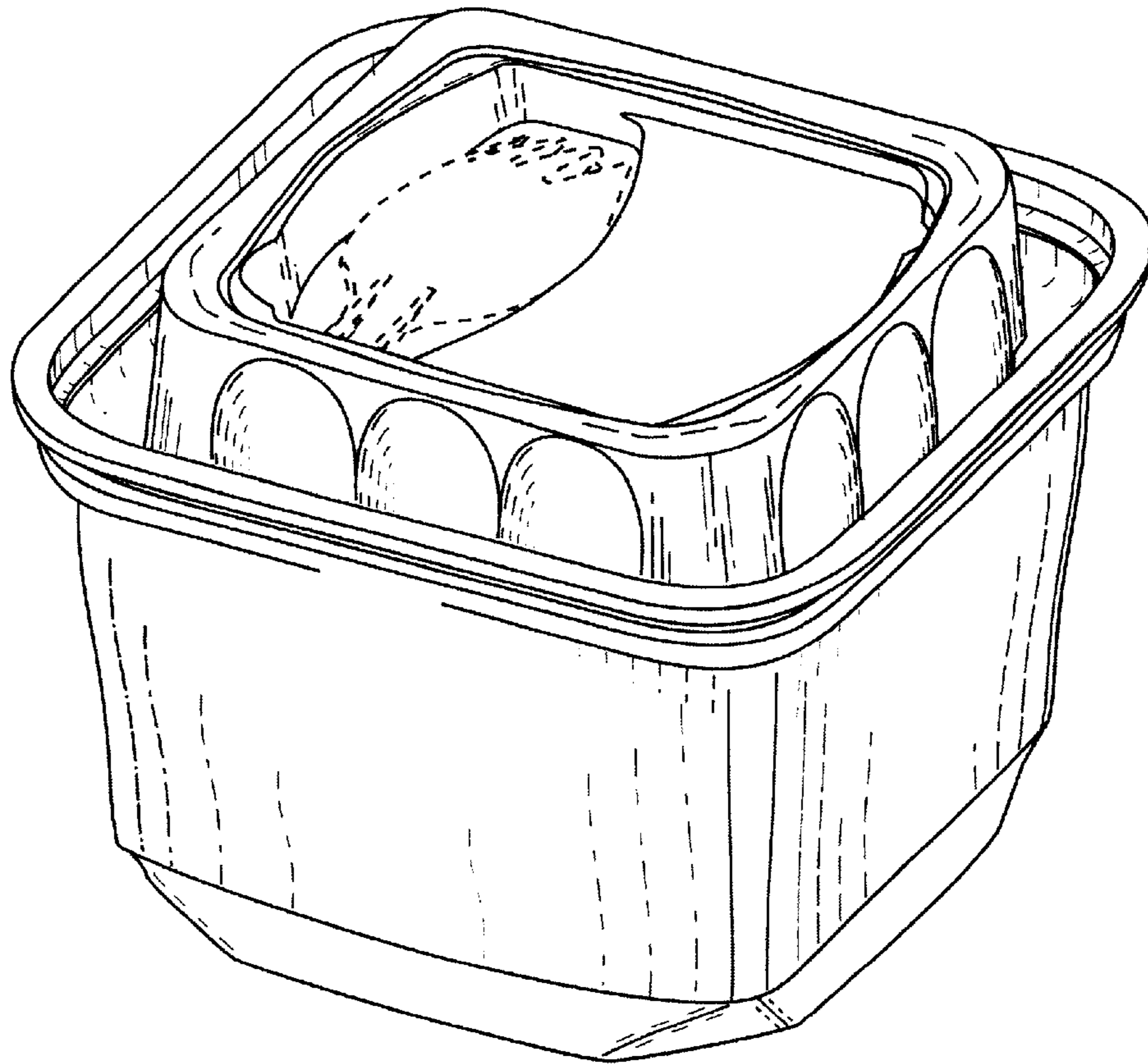

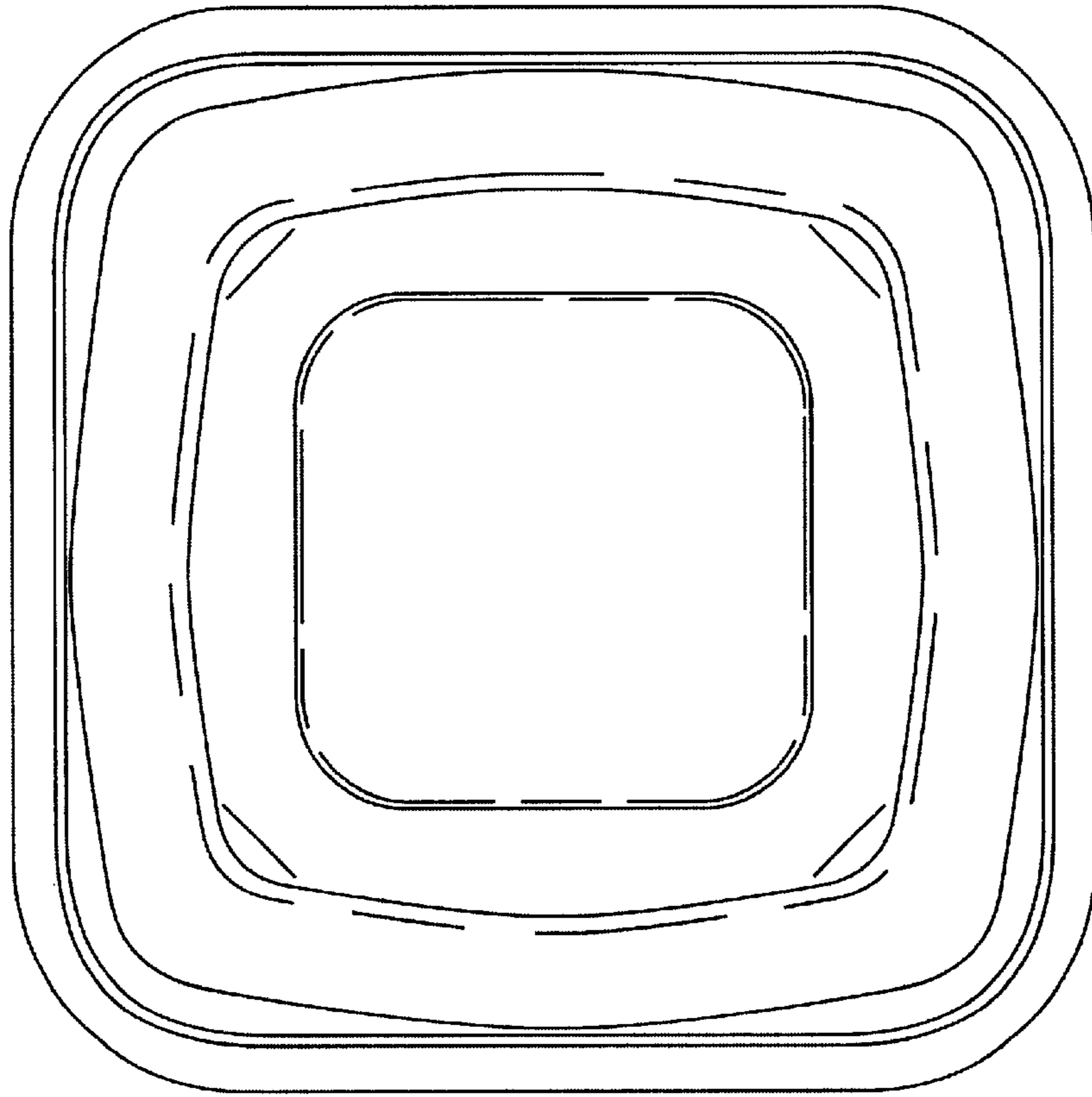

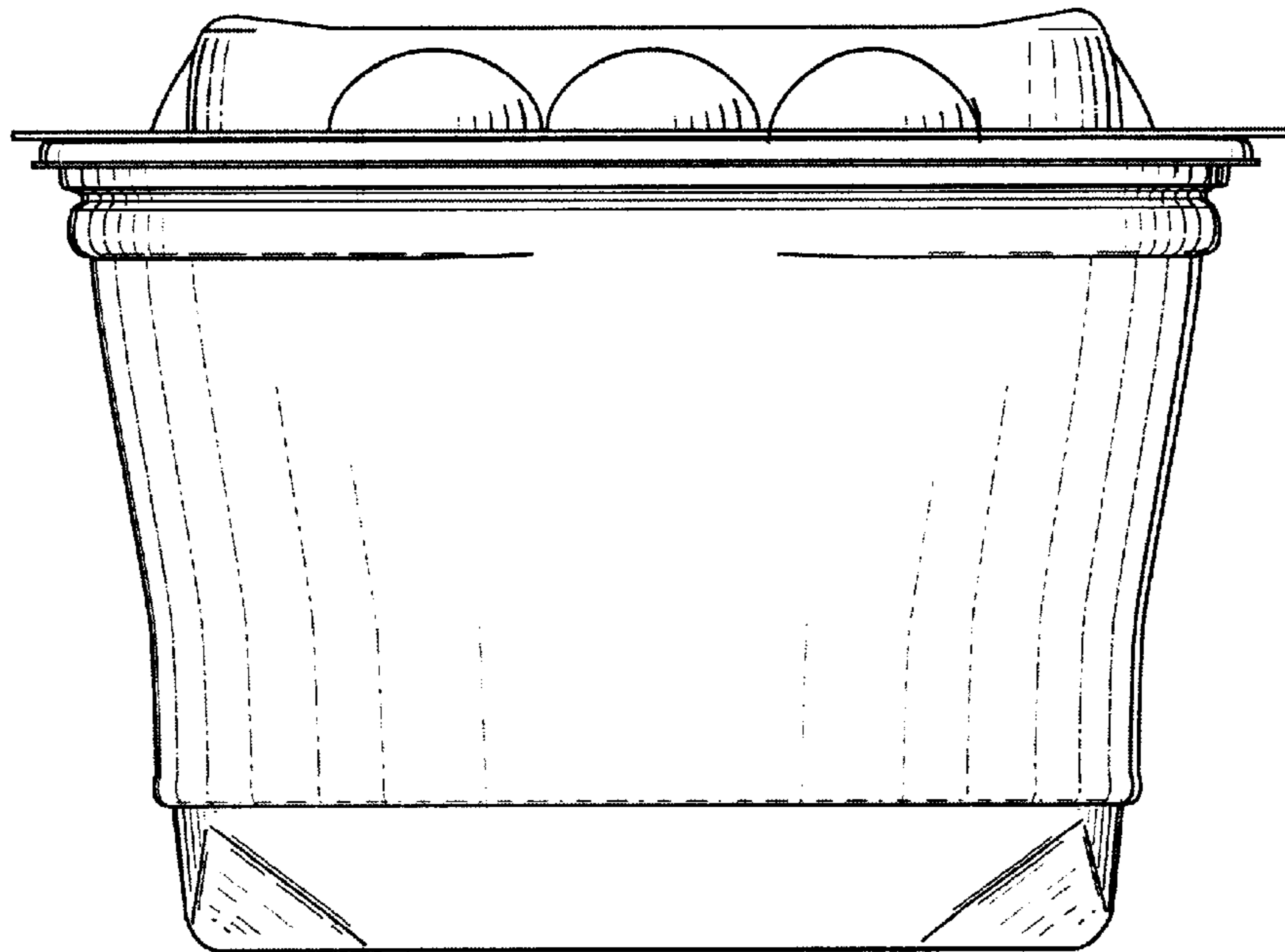
